The ornamental design for an electric connector, as shown
and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of an
electric connector showing my new design;
FIG. 2 is a top, rear and left side perspective view thereof;
FIG. 3 is a bottom, front and right side perspective view
thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a right side elevational view thereof;
FIG. 8 is a top plan view thereof;
FIG. 9 is a bottom plan view thereof;
FIG. 10 is a left side elevational view thereof, showing
unclaimed elements between 2 claimed surfaces taken away
to reveal the claimed body.
FIG. 11 is a cross sectional view taken along the line of XI-XI
of FIG. 10; and,
FIG. 12 is a cross sectional view taken along the line of
XII-XII of FIG. 10.
The broken lines depict environmental subject matter only
and form no part of the claimed design.

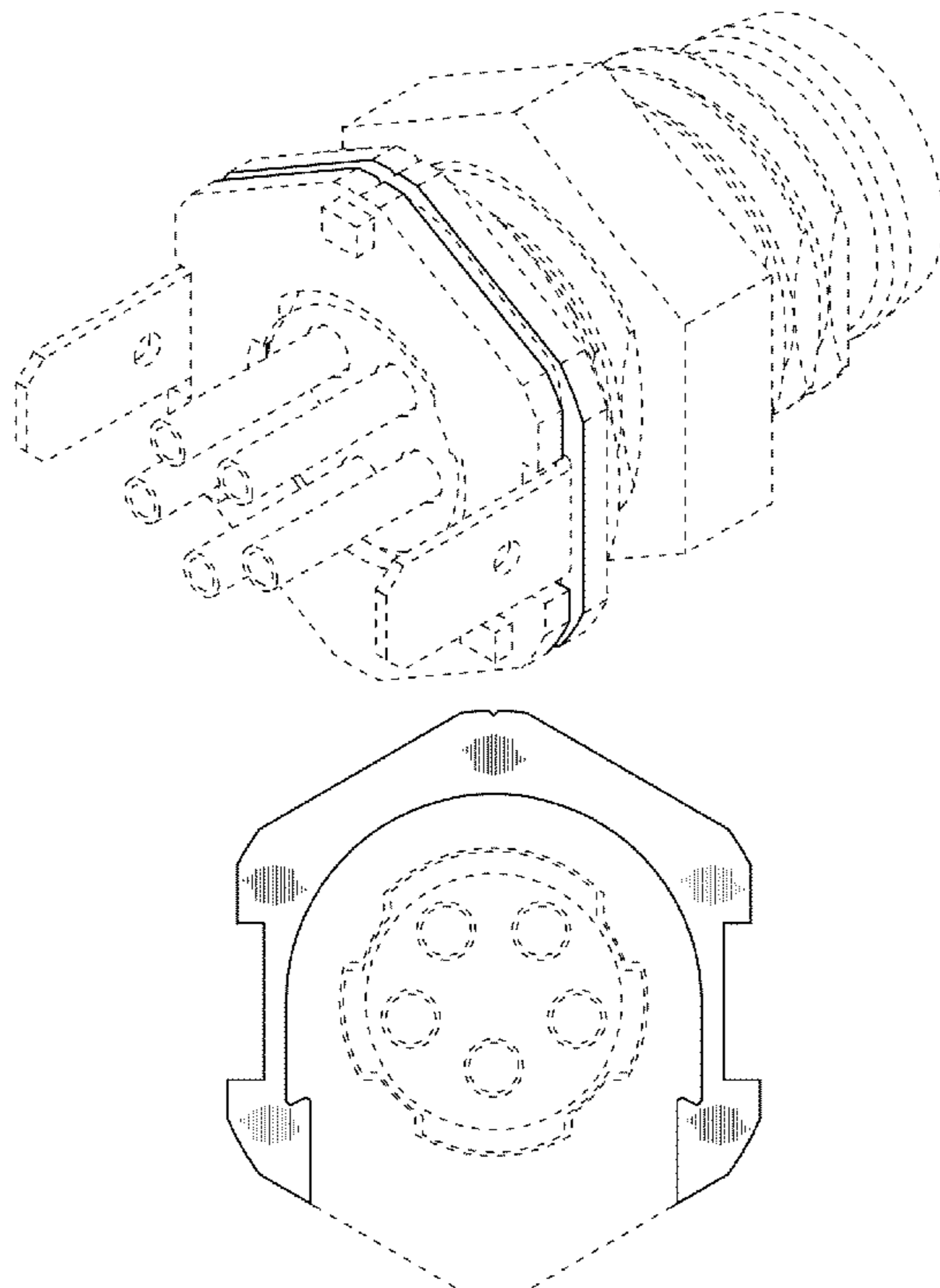

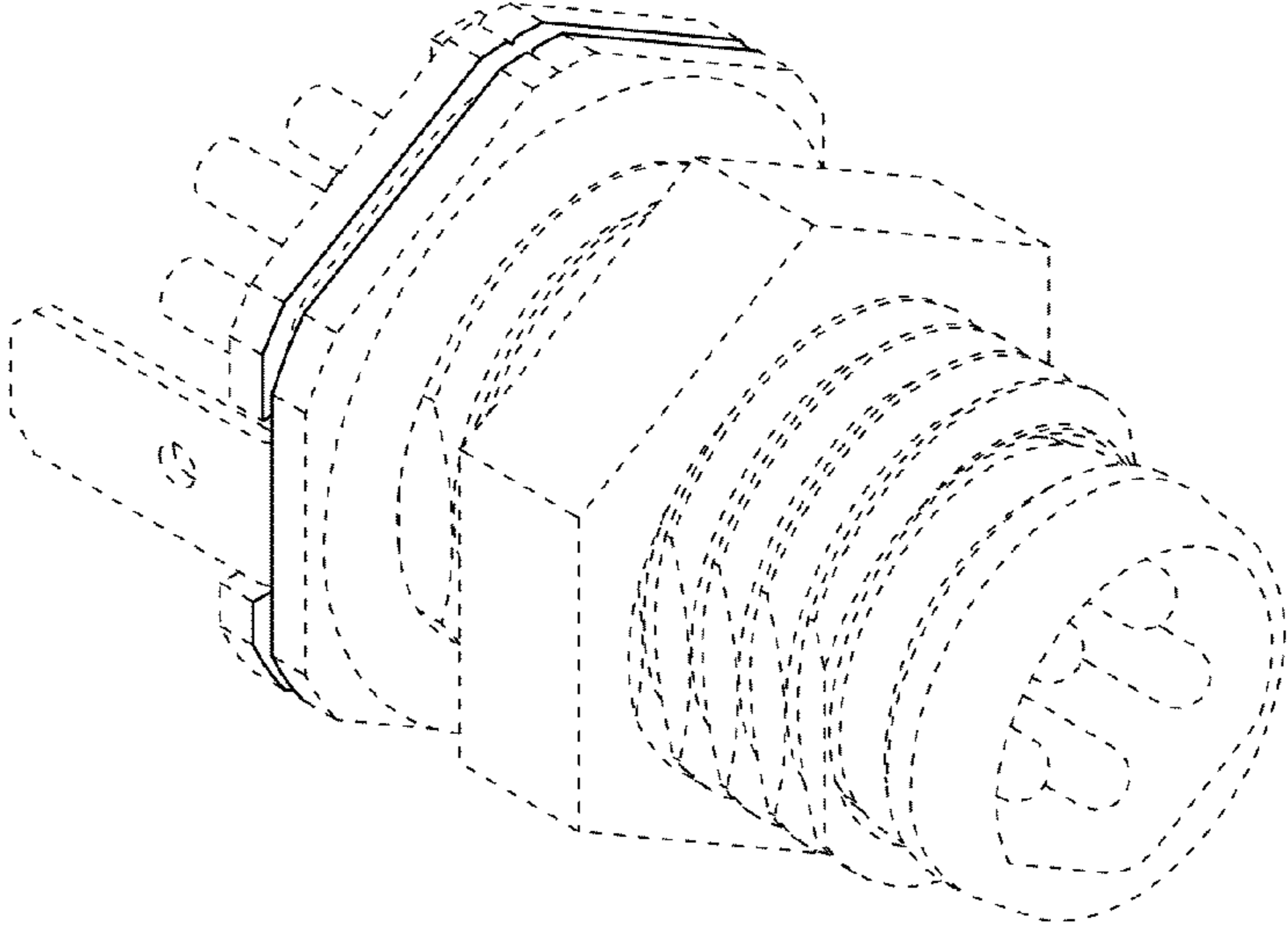

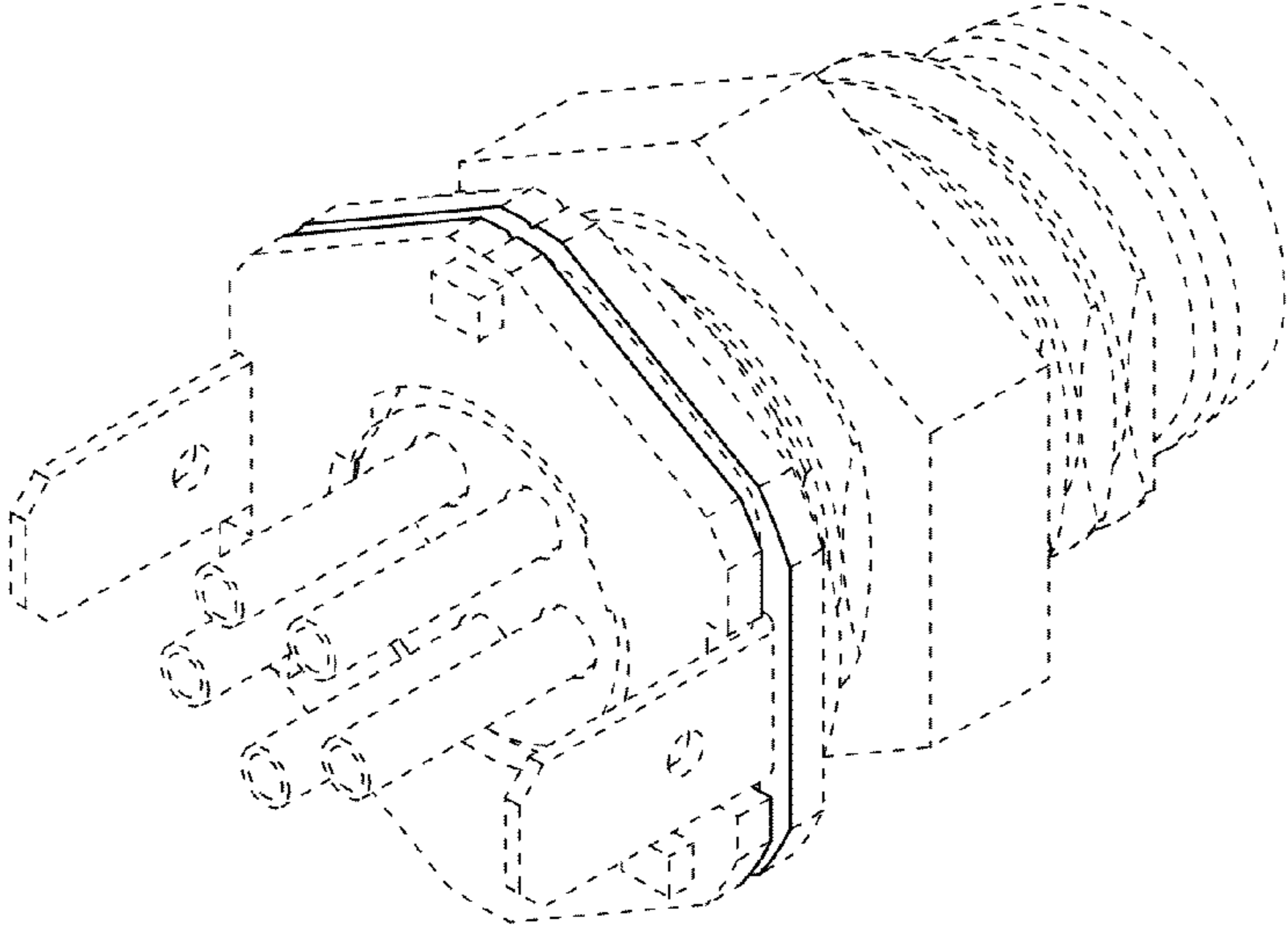

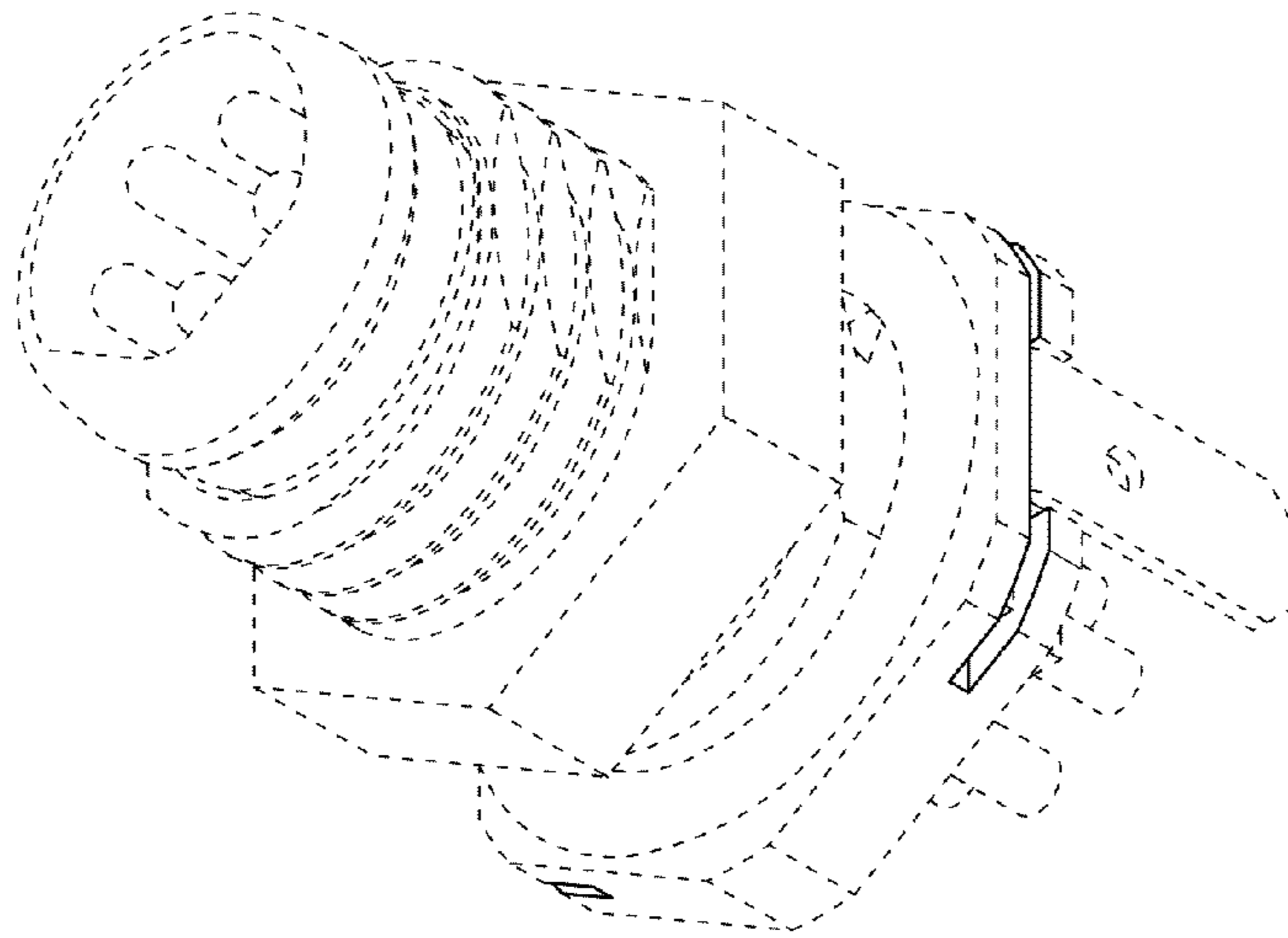

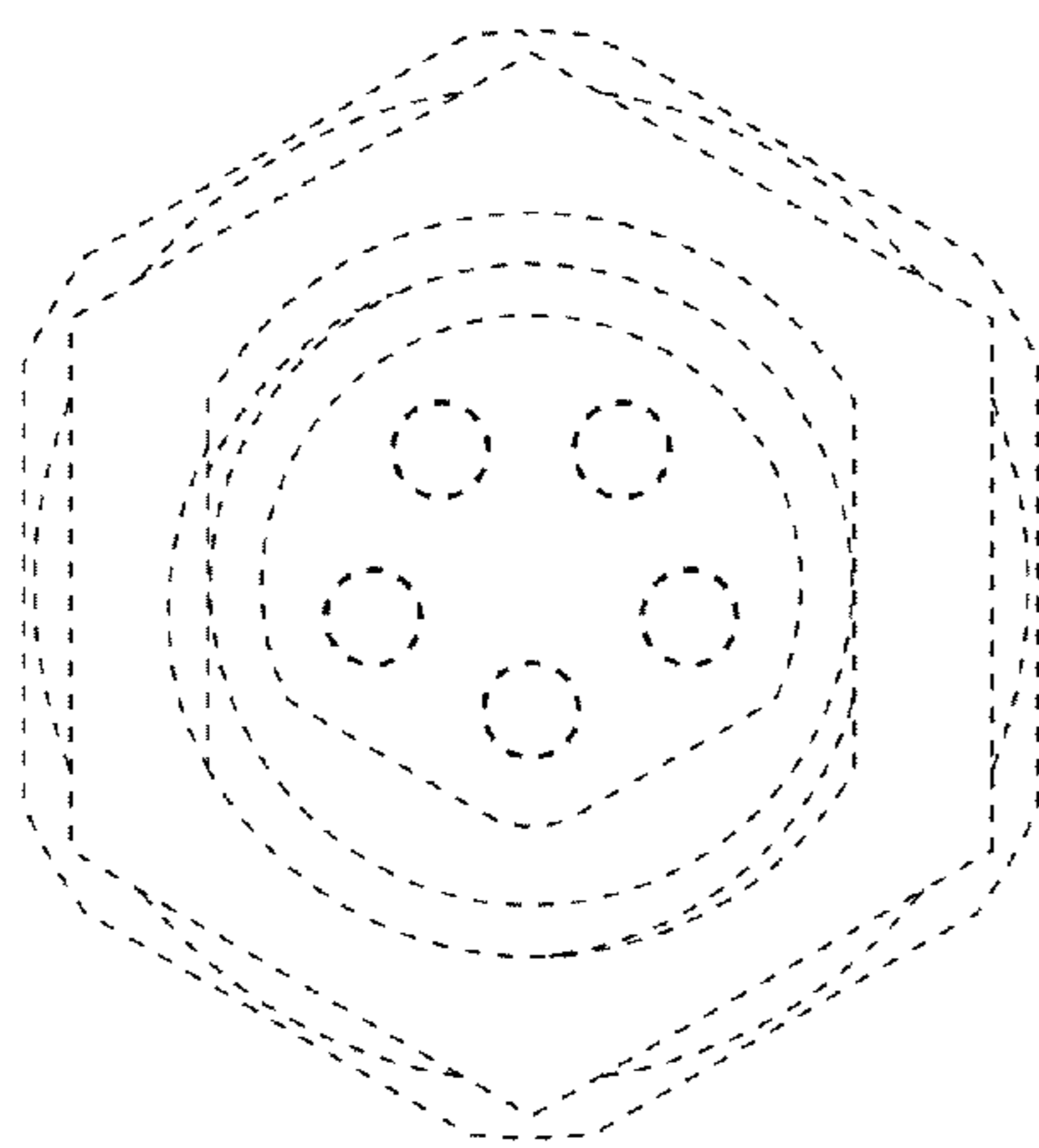

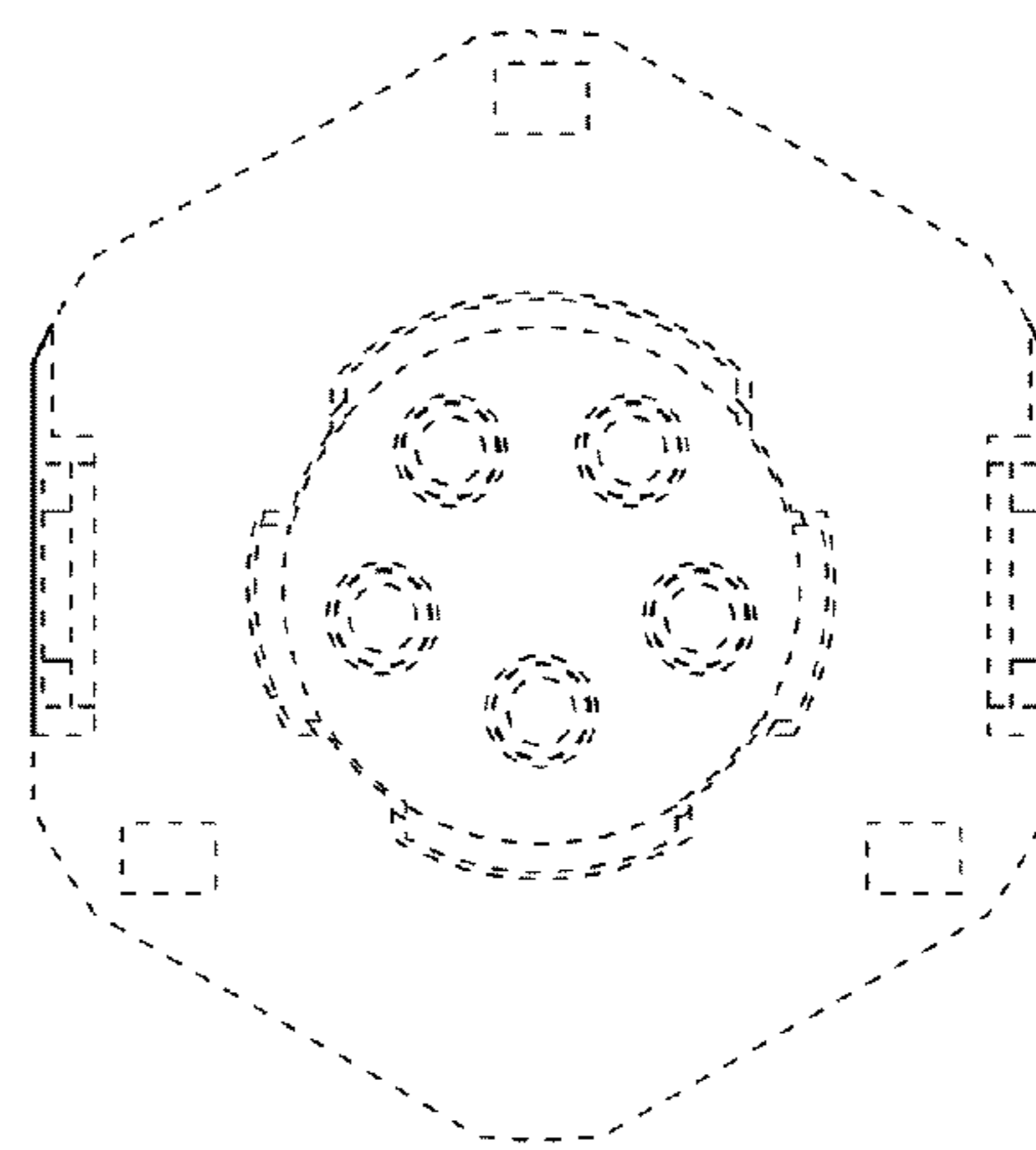

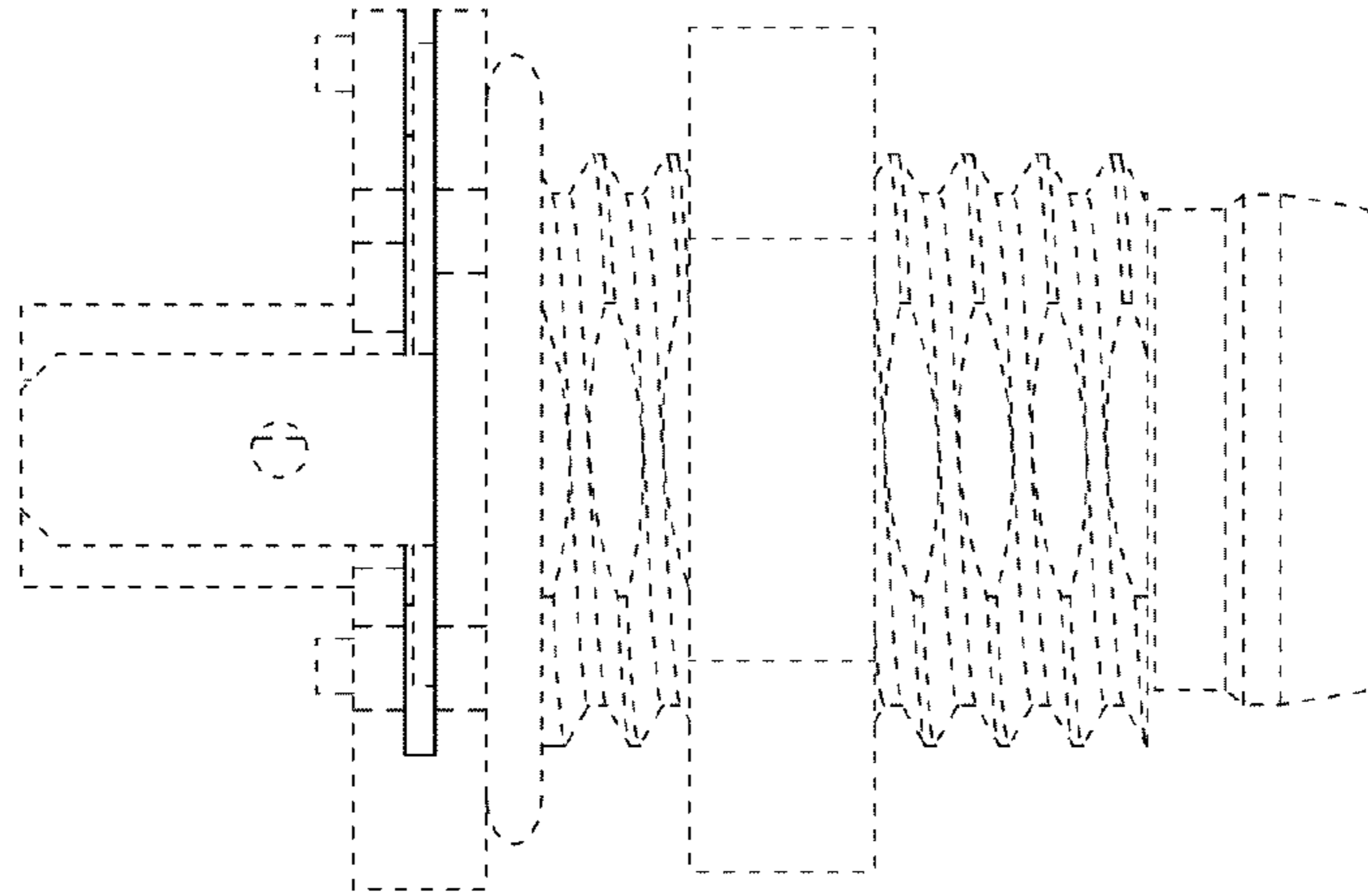

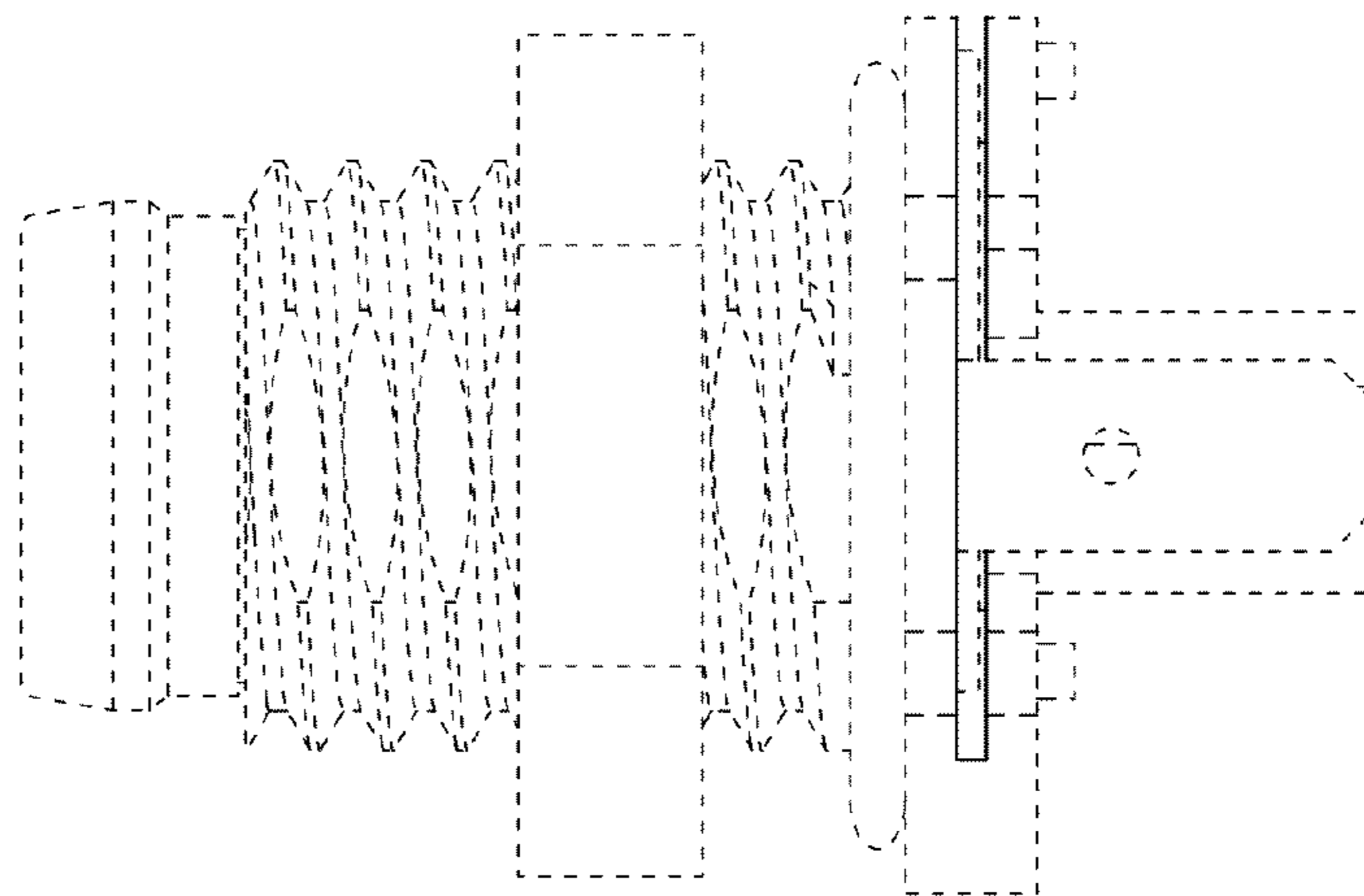

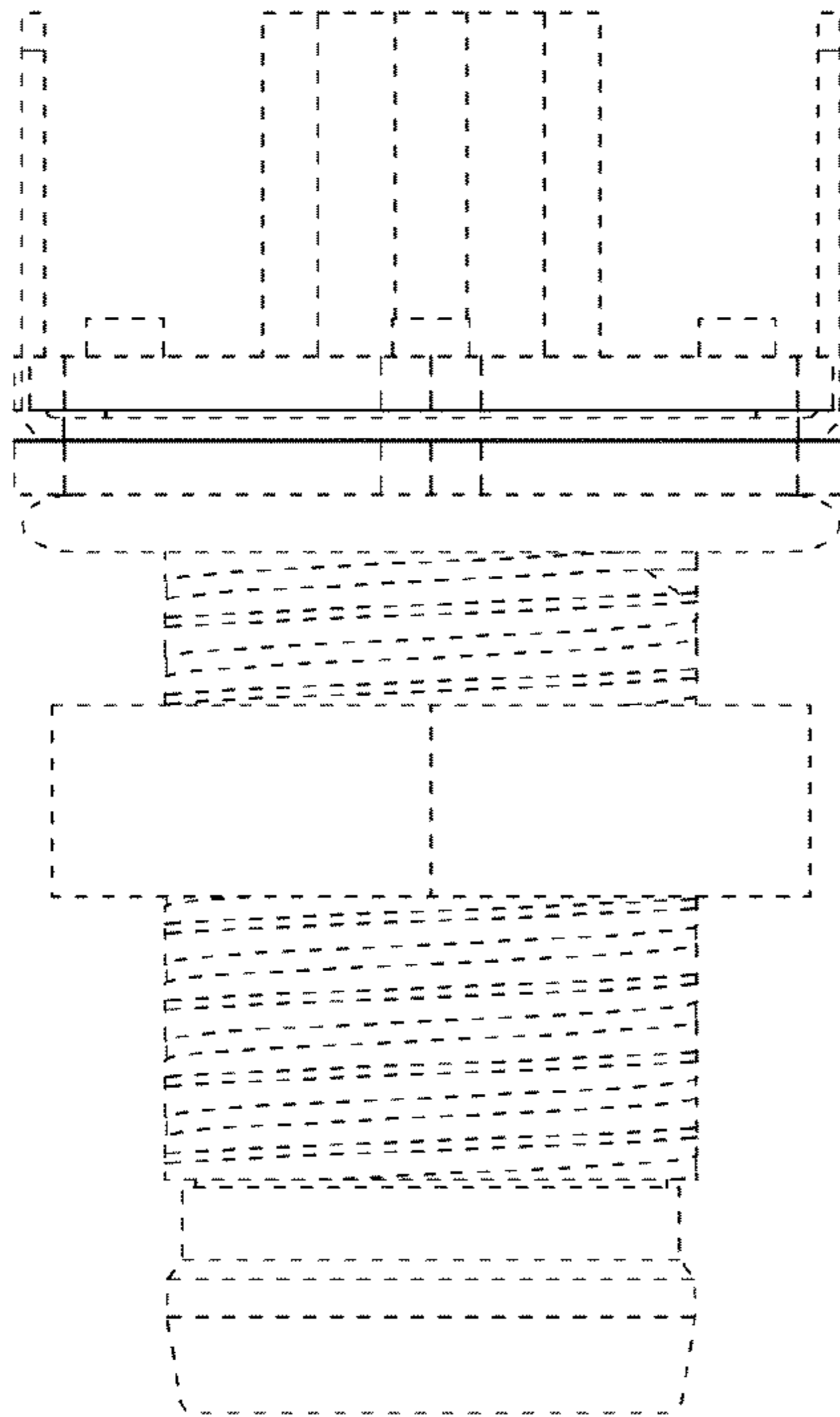

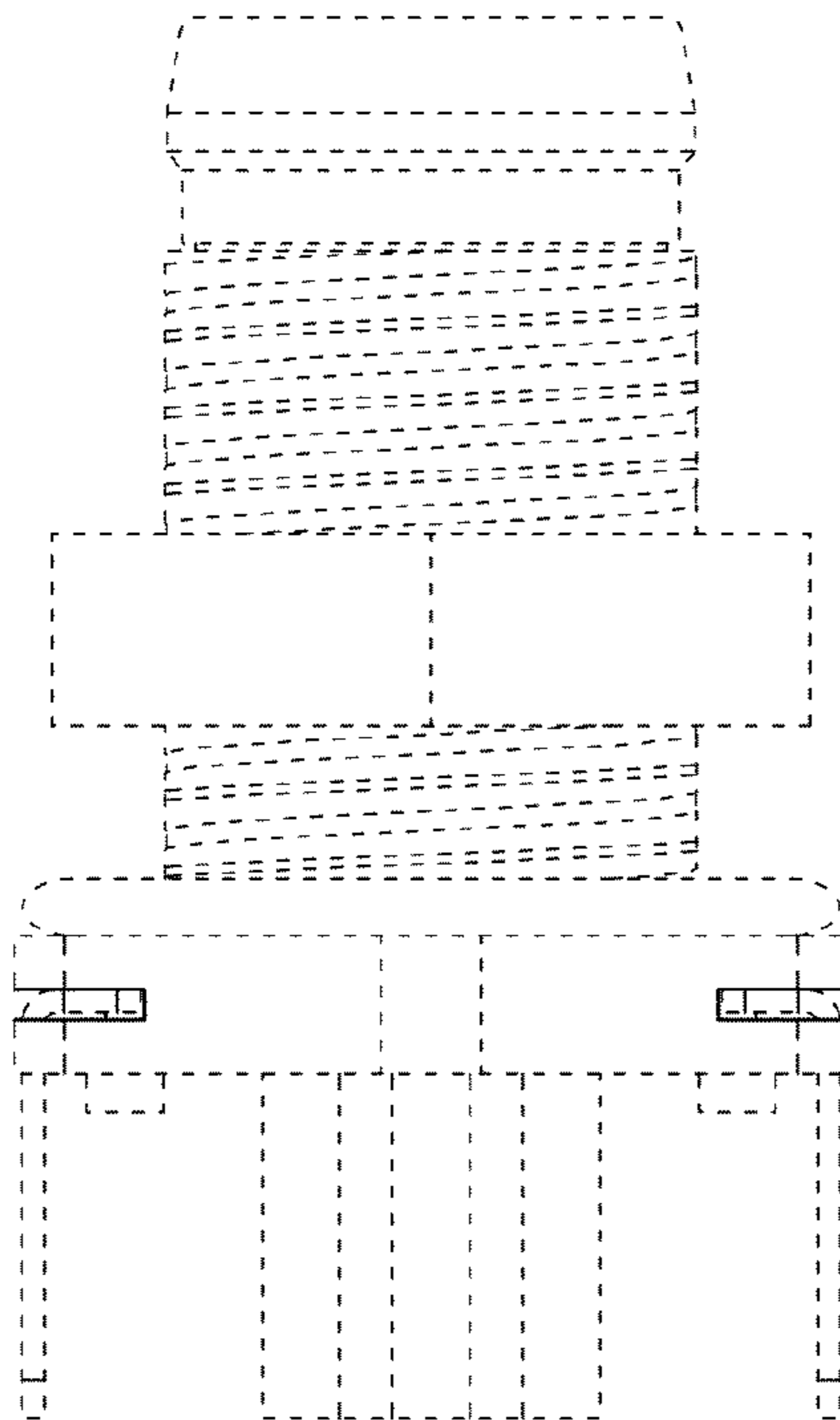

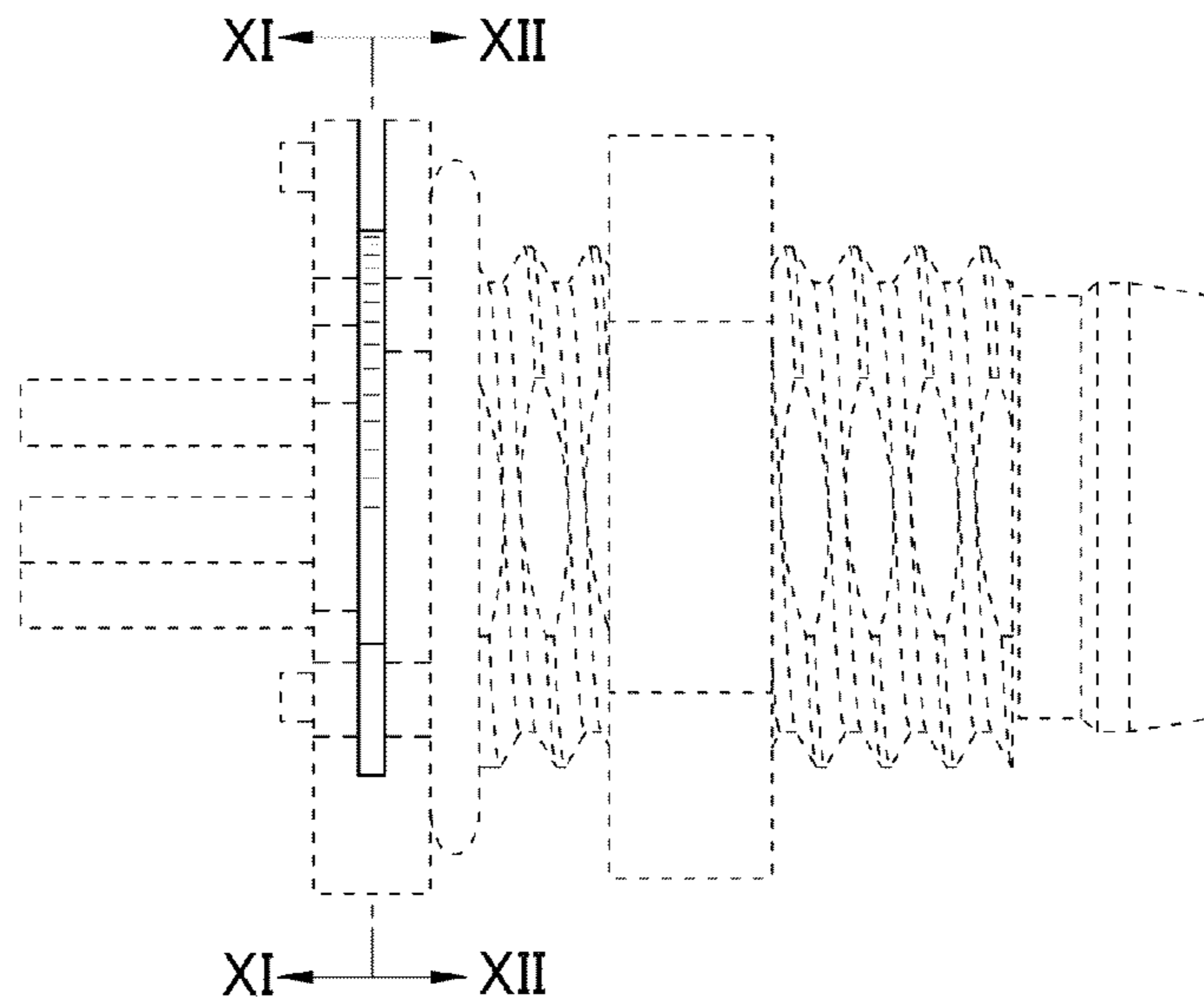

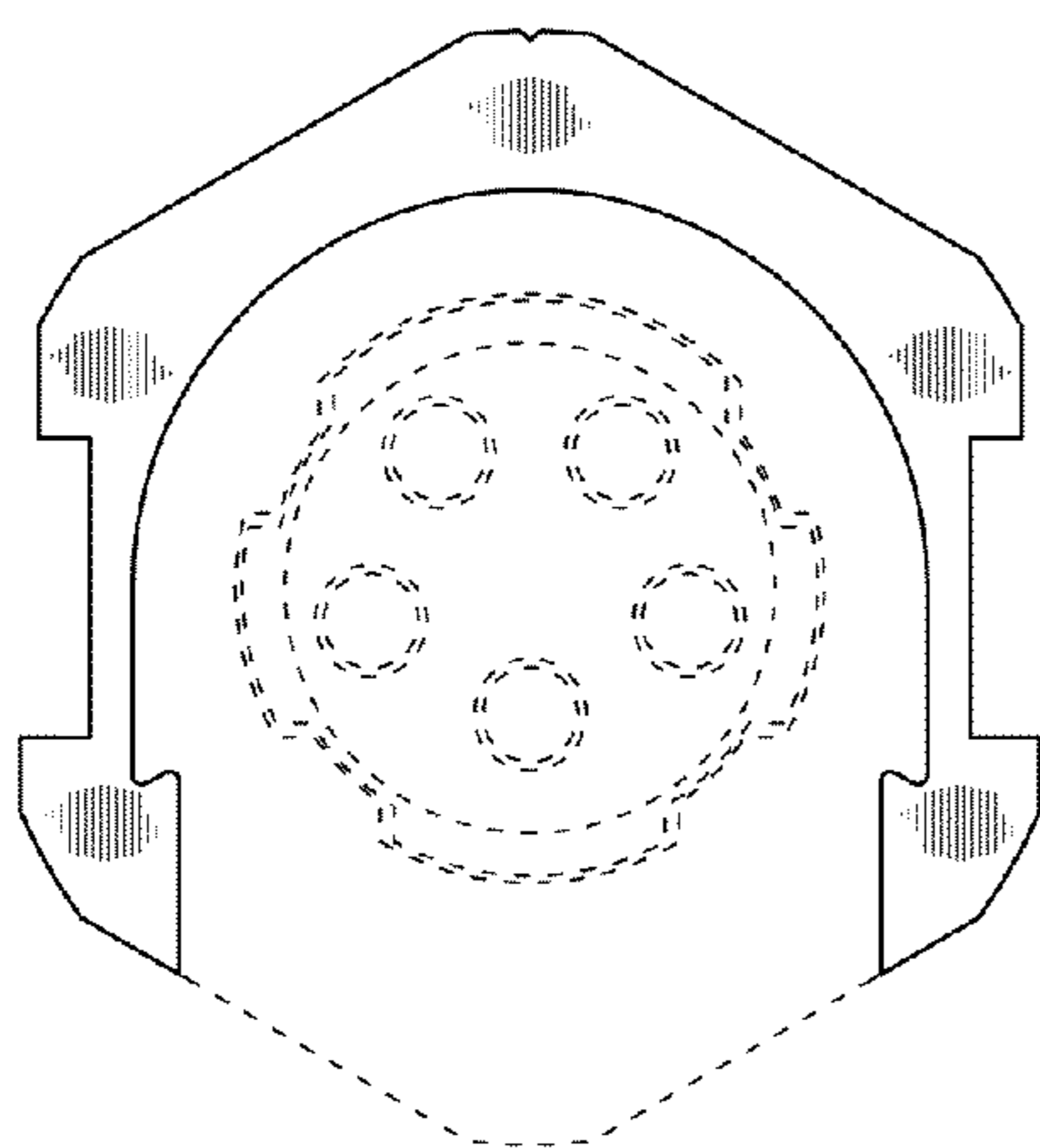
