The ornamental design for a set top box, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of a set top box showing our new design;
FIG. 2 is the front elevational view thereof;
FIG. 3 is the rear elevational view thereof;
FIG. 4 is the left-side elevational view thereof;
FIG. 5 is the right-side elevational view thereof;
FIG. 6 is the top-side plan view thereof;
FIG. 7 is the bottom-side plan view thereof;
FIG. 8 illustrates the server located on the set top box; and,
FIG. 9 is the rear/left-side/top perspective view thereof.
The broken lines shown in the drawings depict portions of the set top box that form no part of the claimed design.

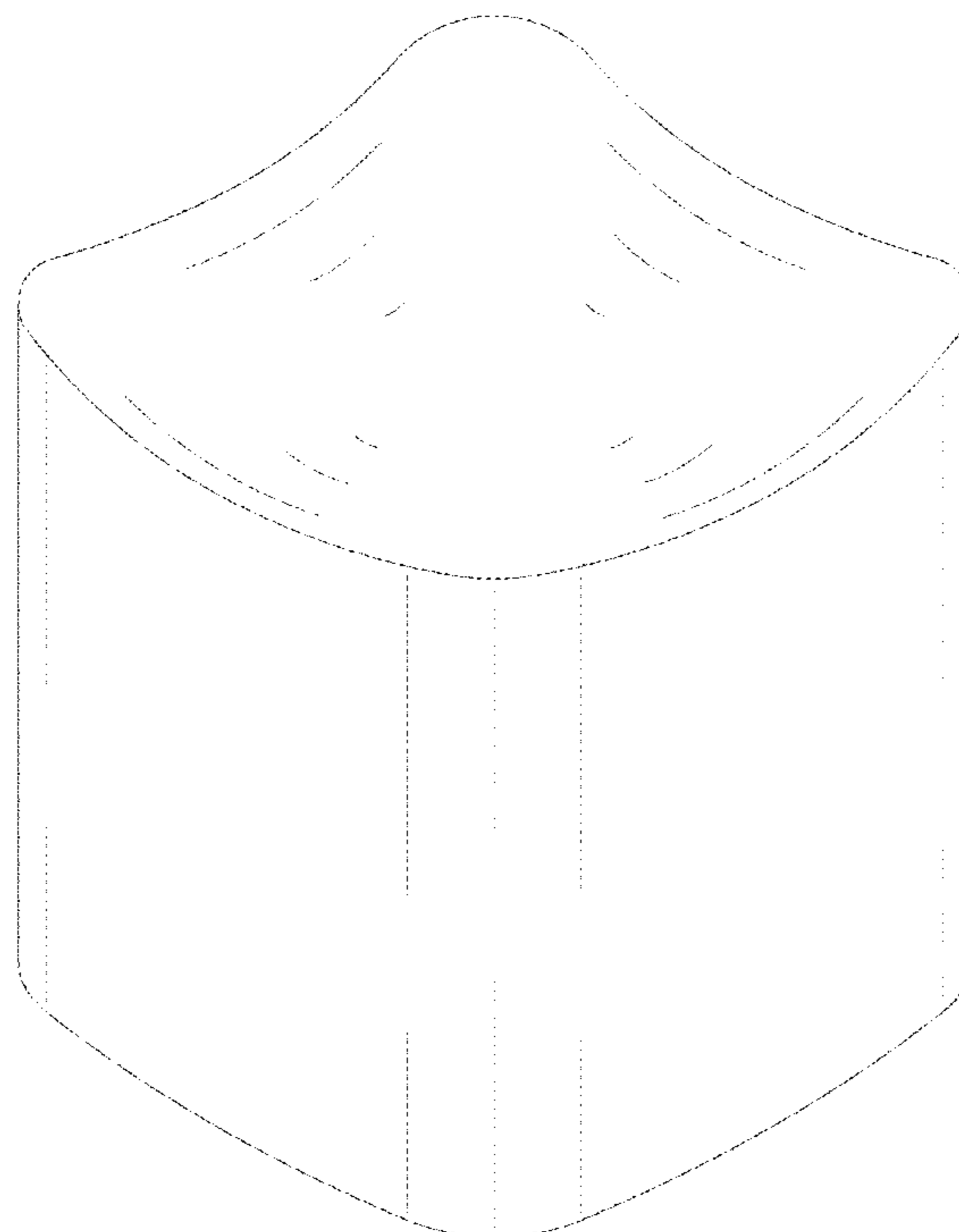

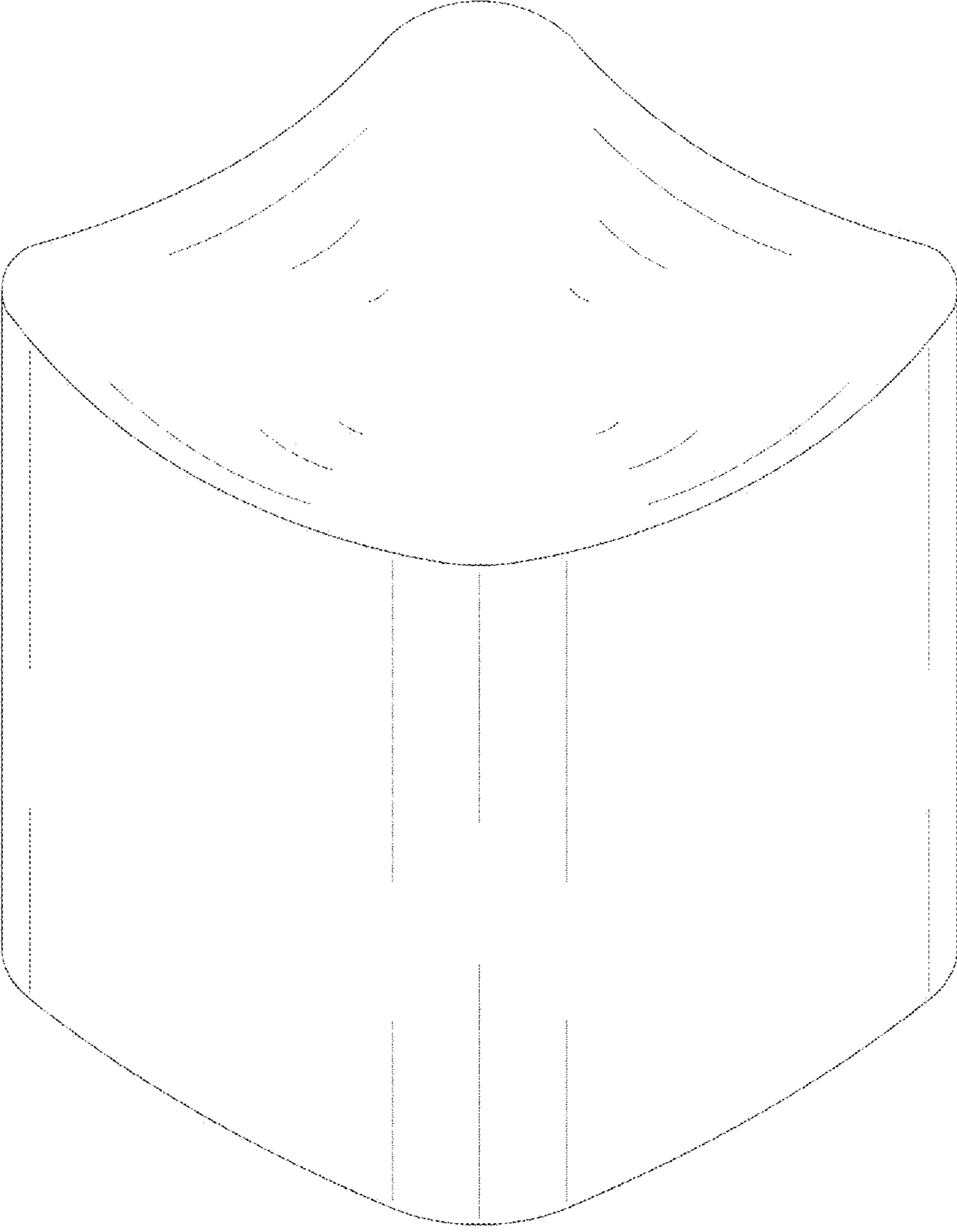

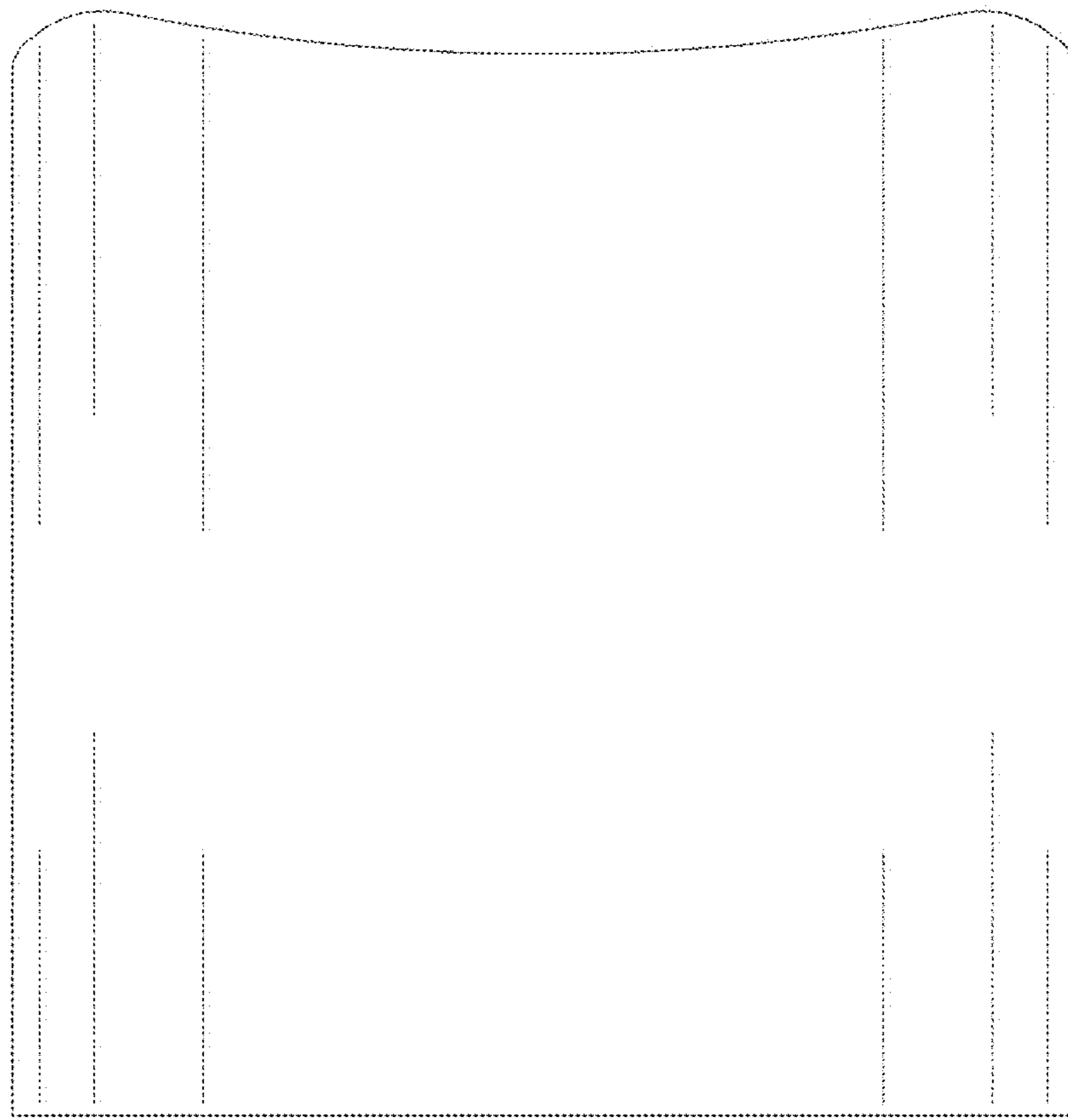

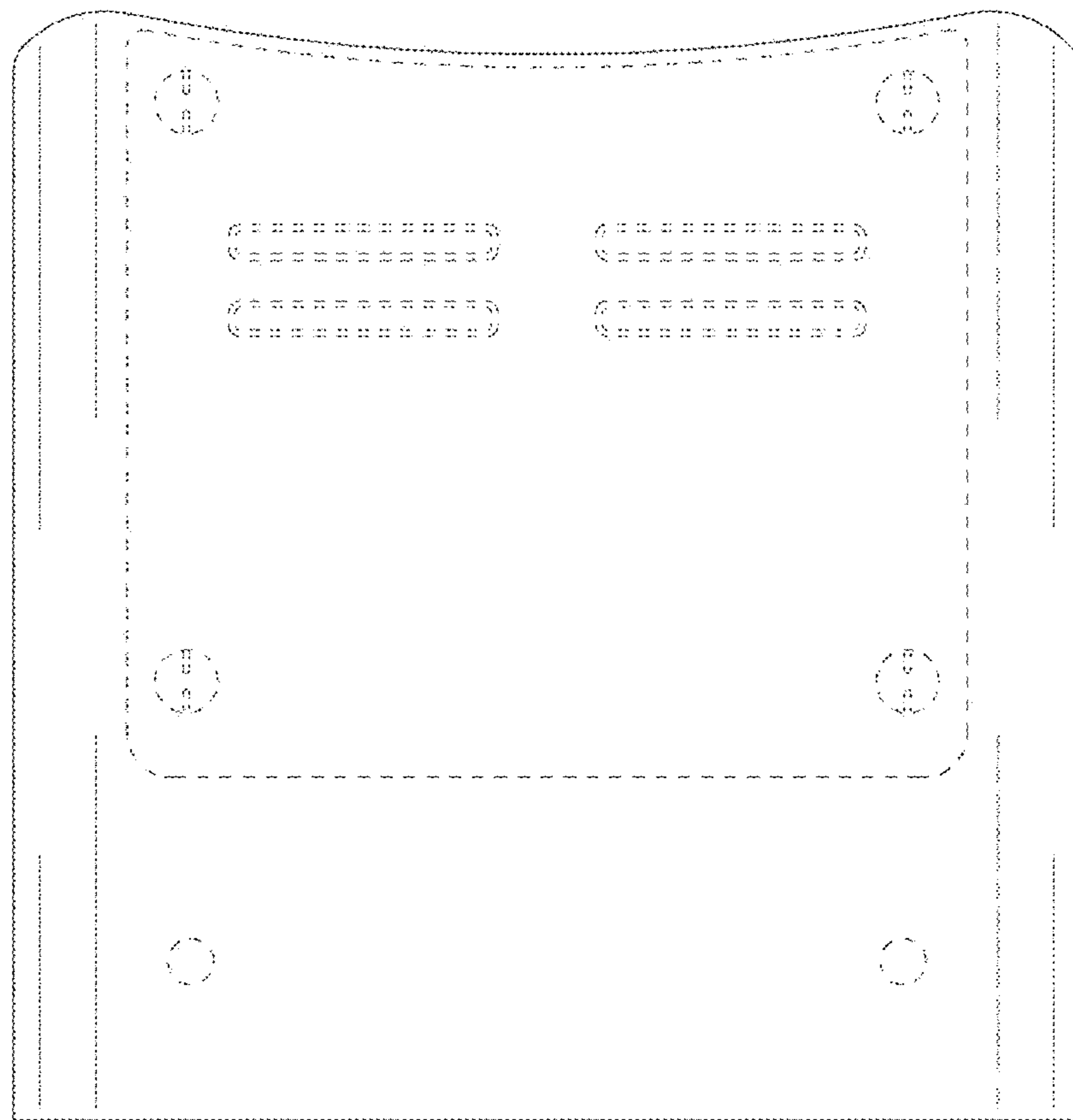

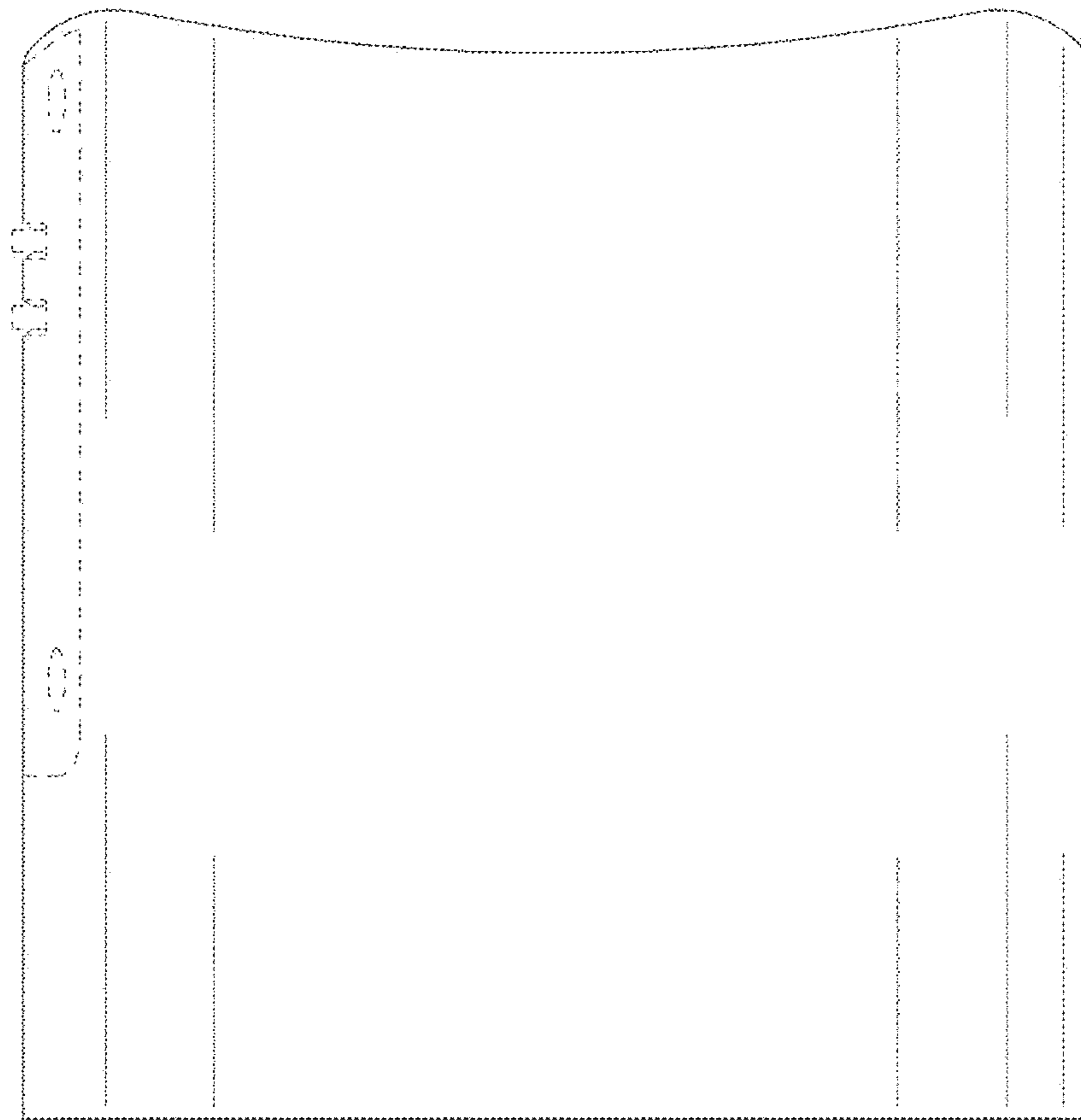

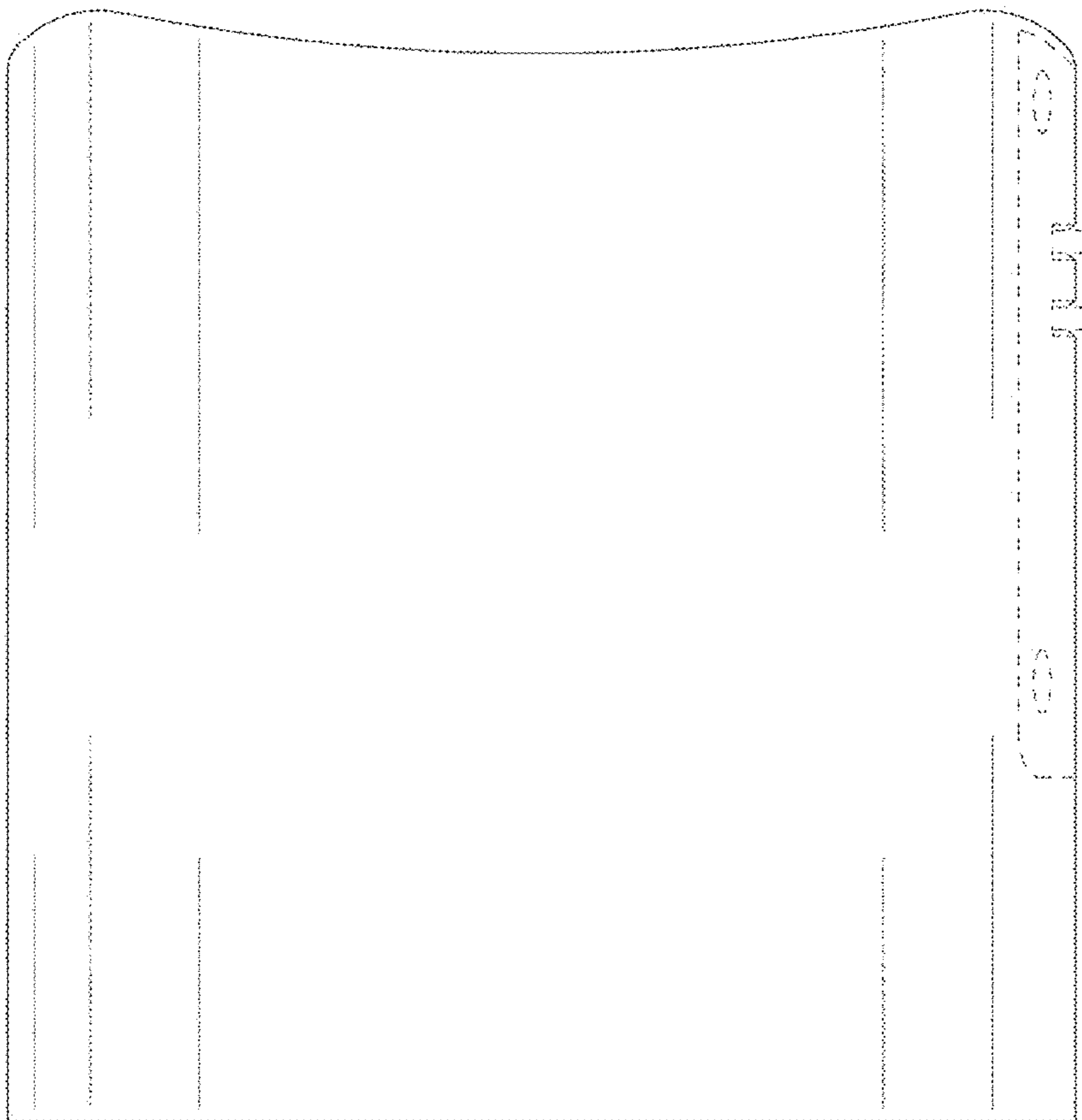

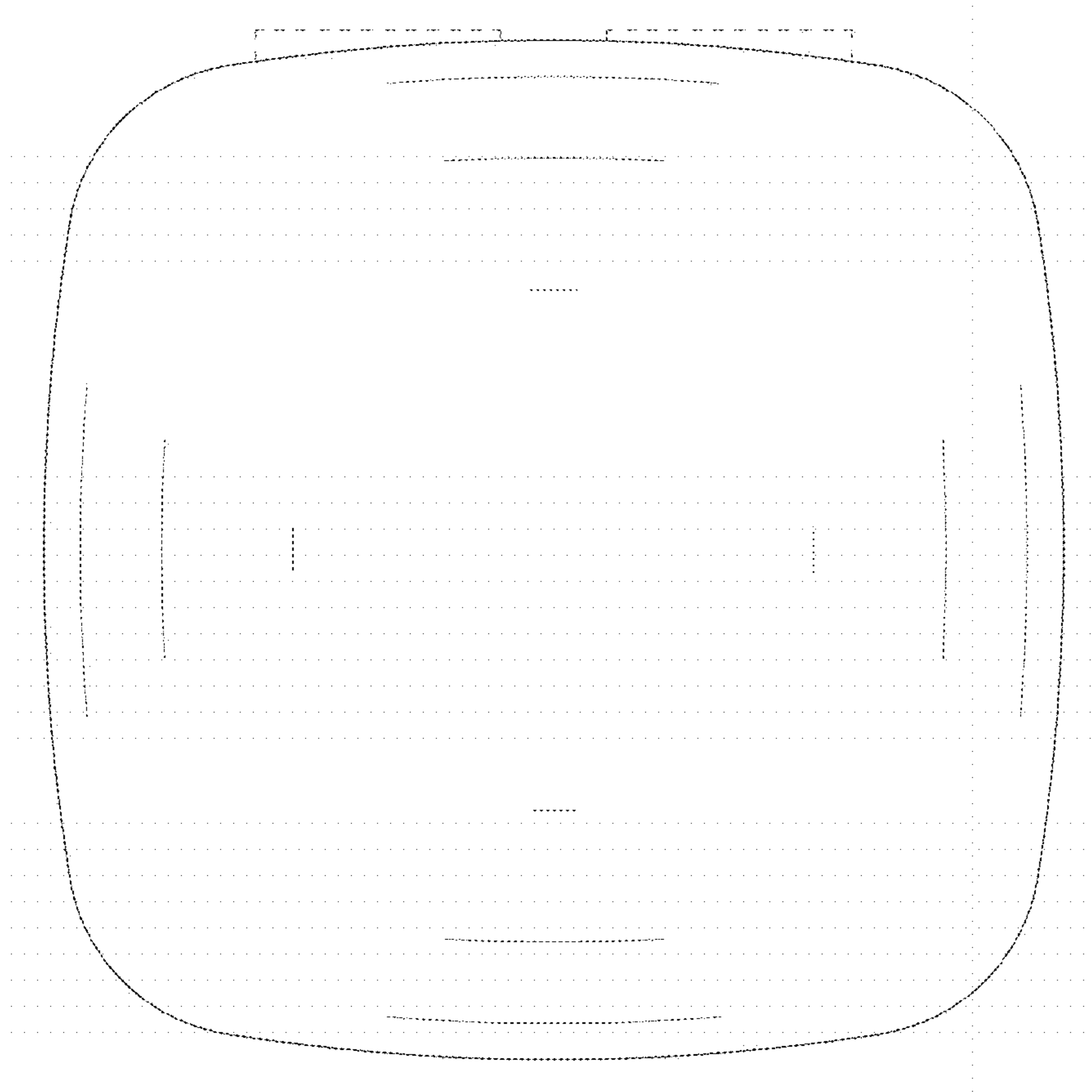

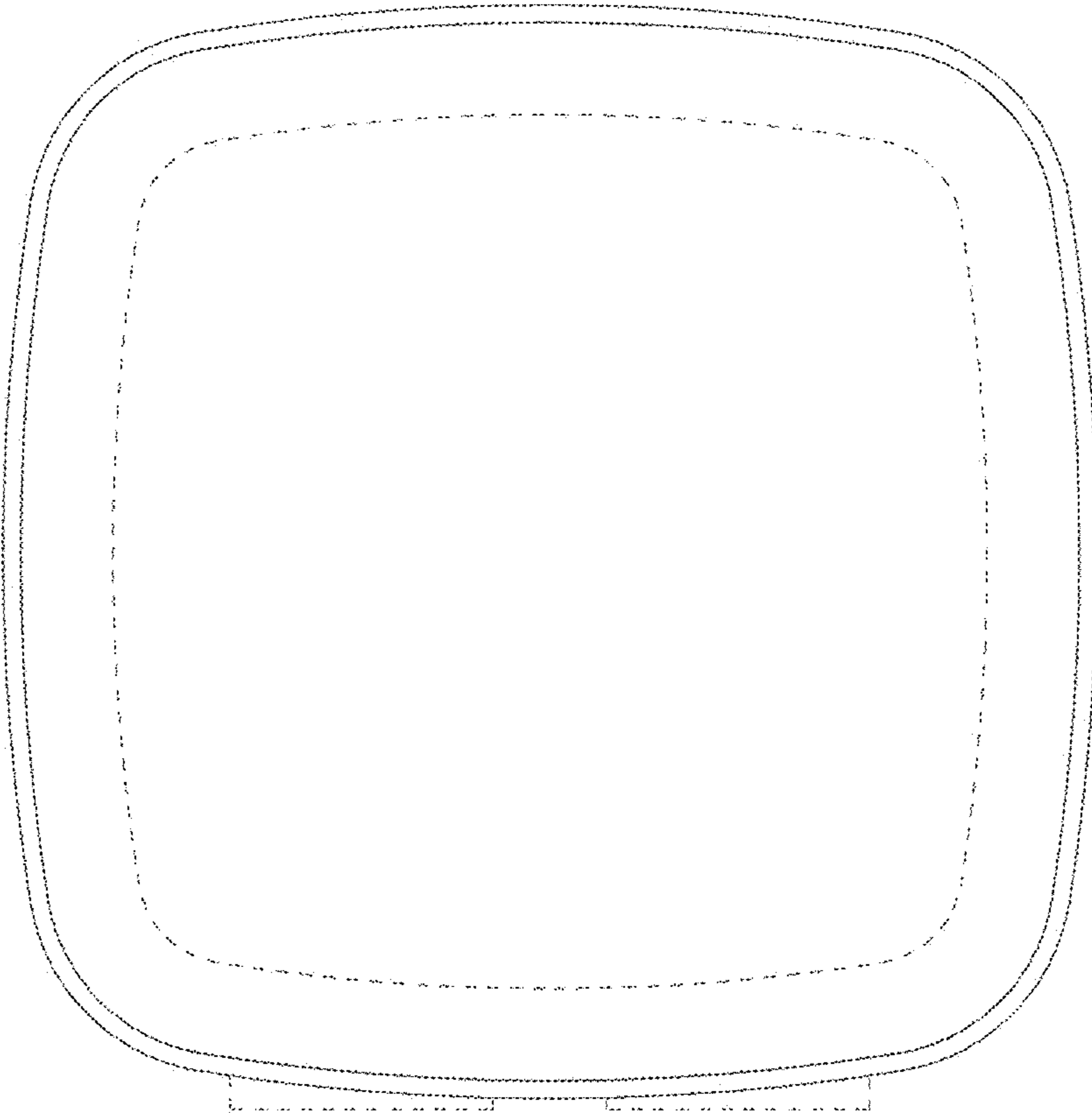

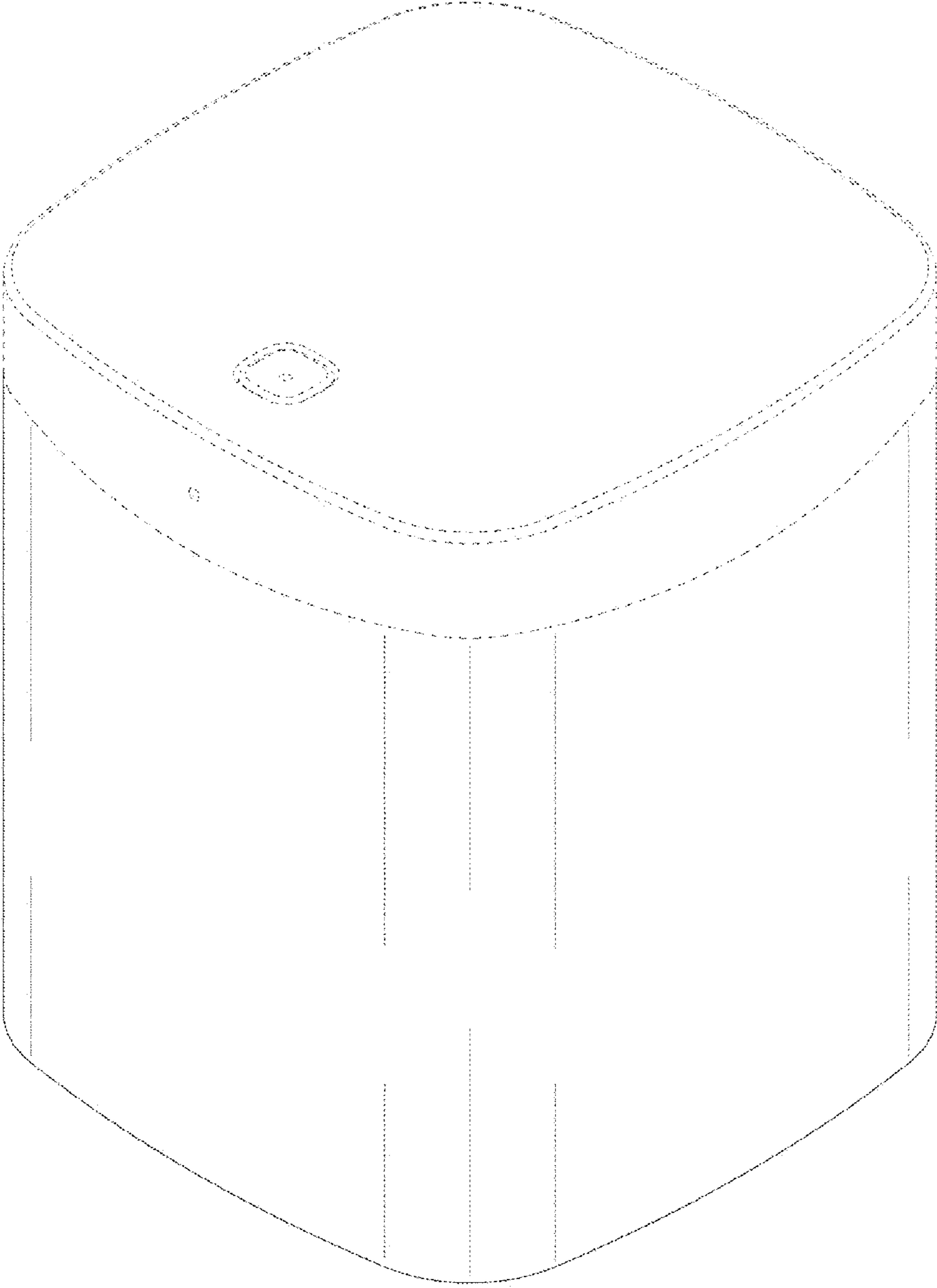
