FIG. 4 is another perspective view thereof.

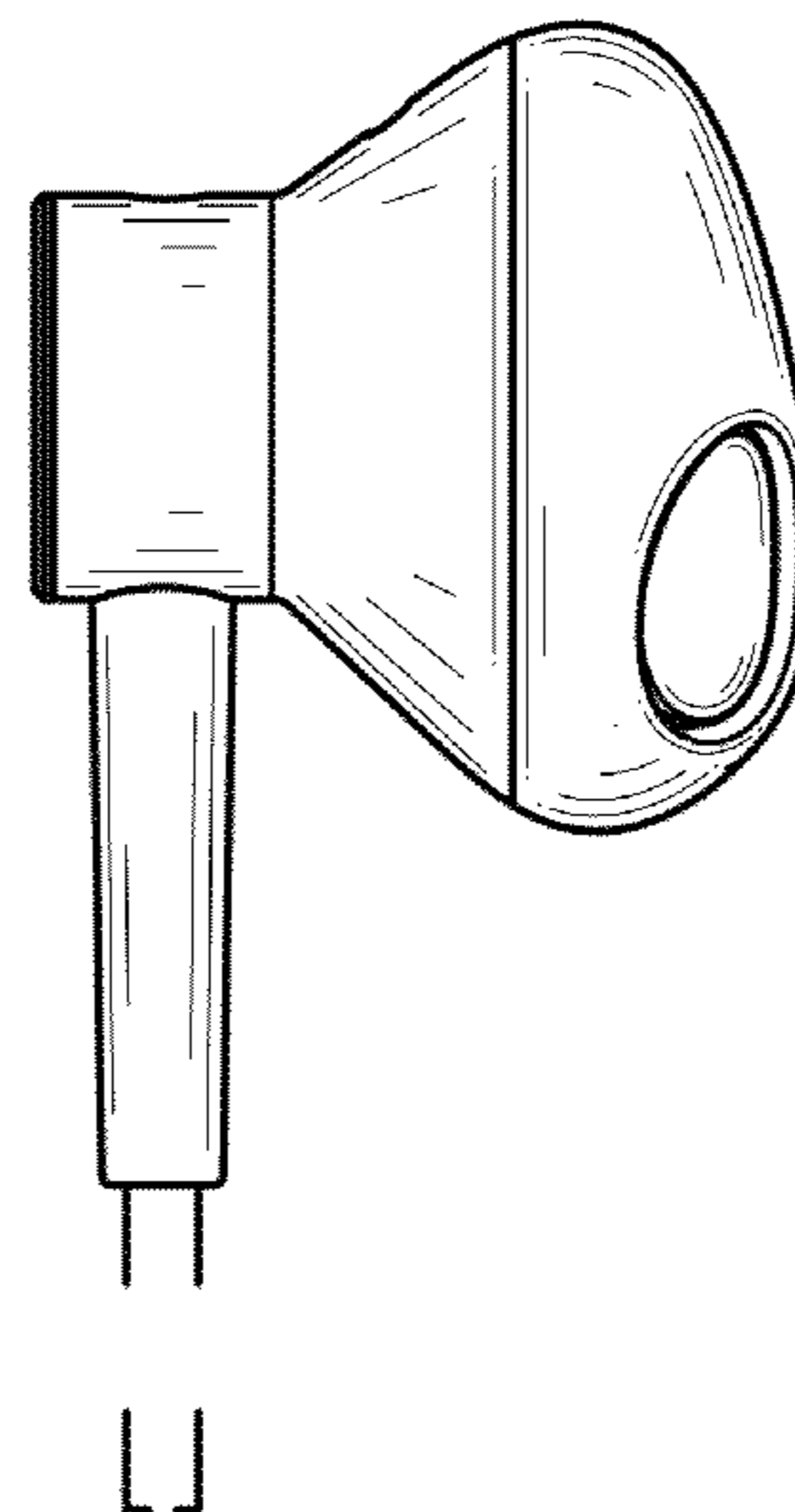
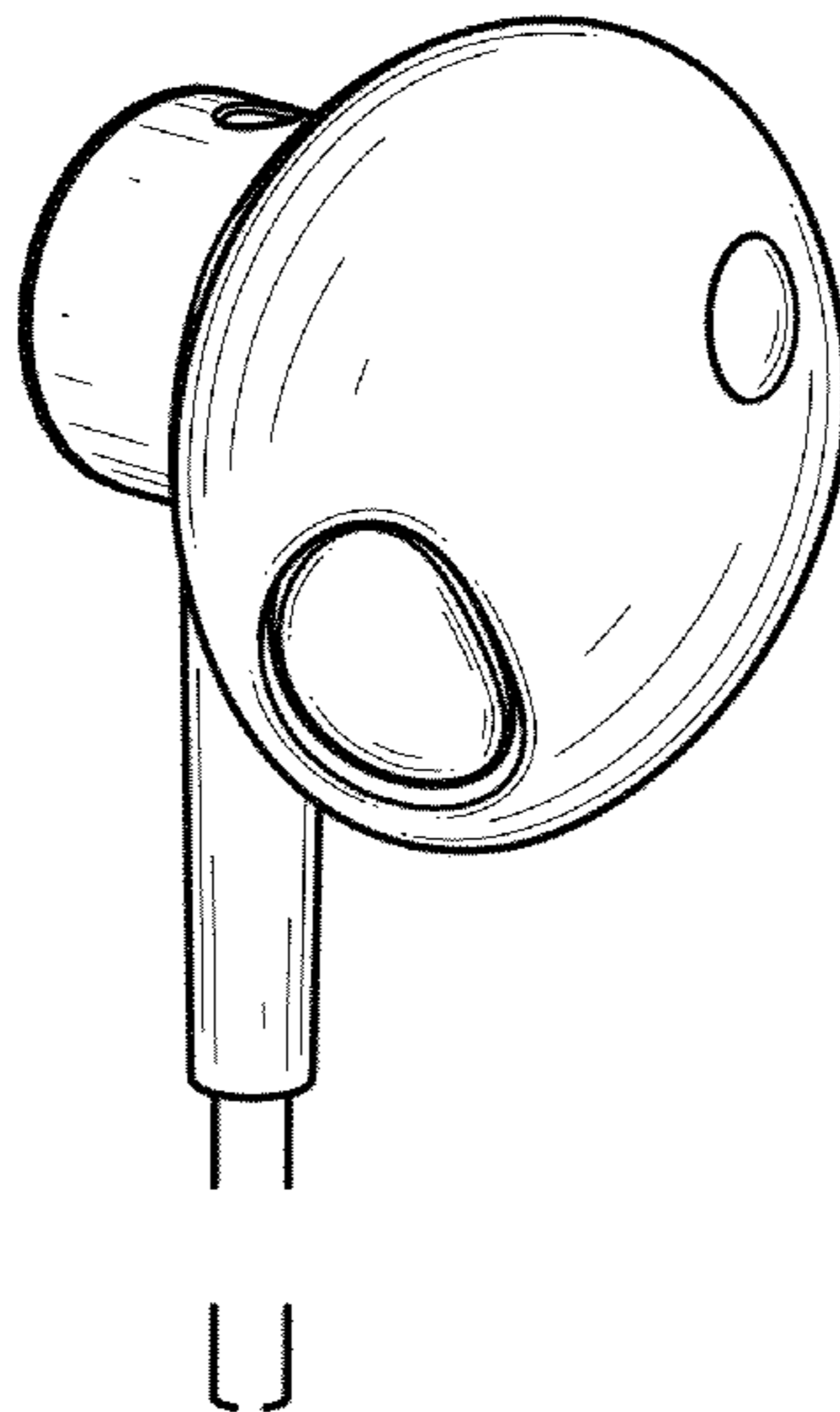
FIG. 5 is another perspective view thereof.

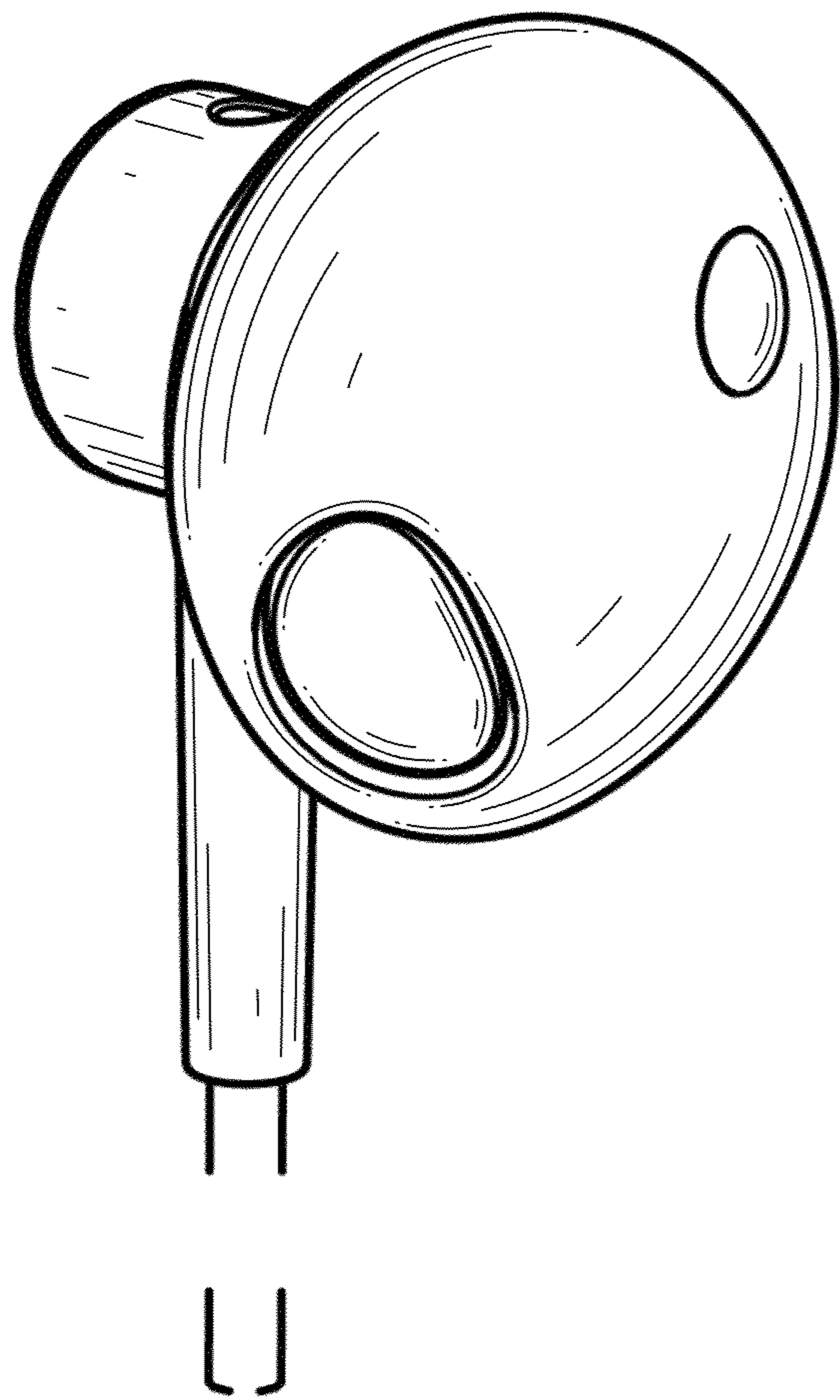

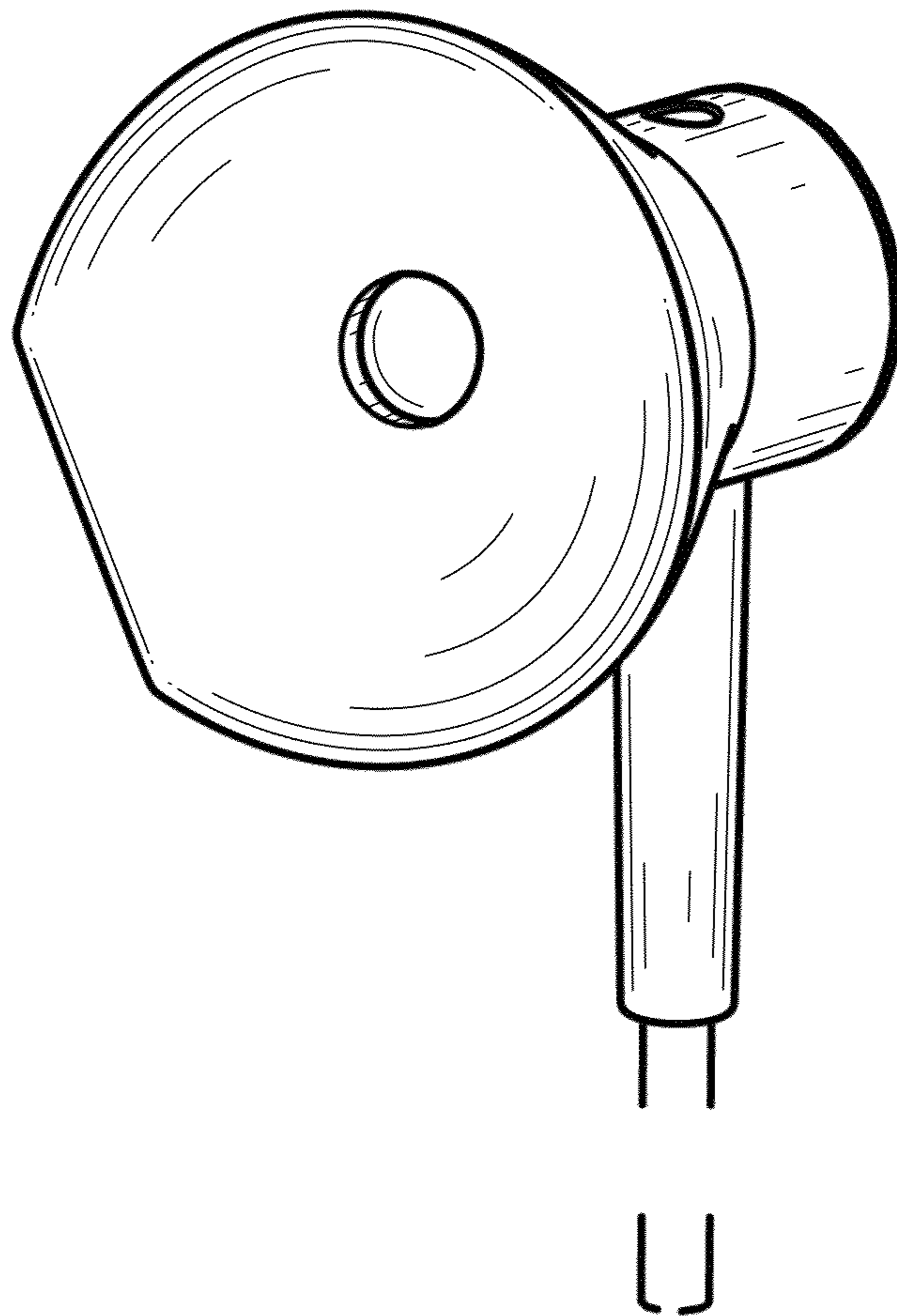

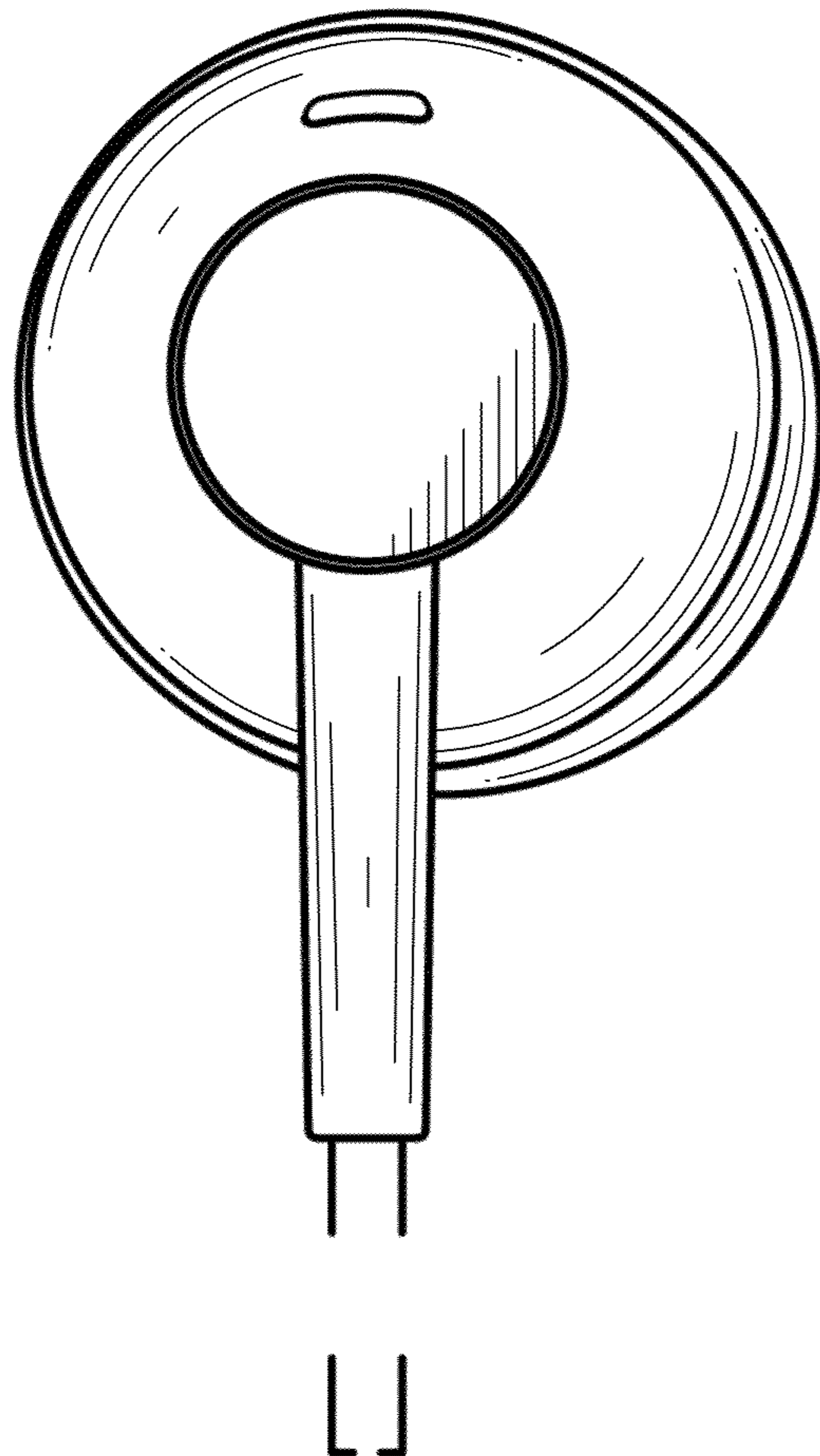

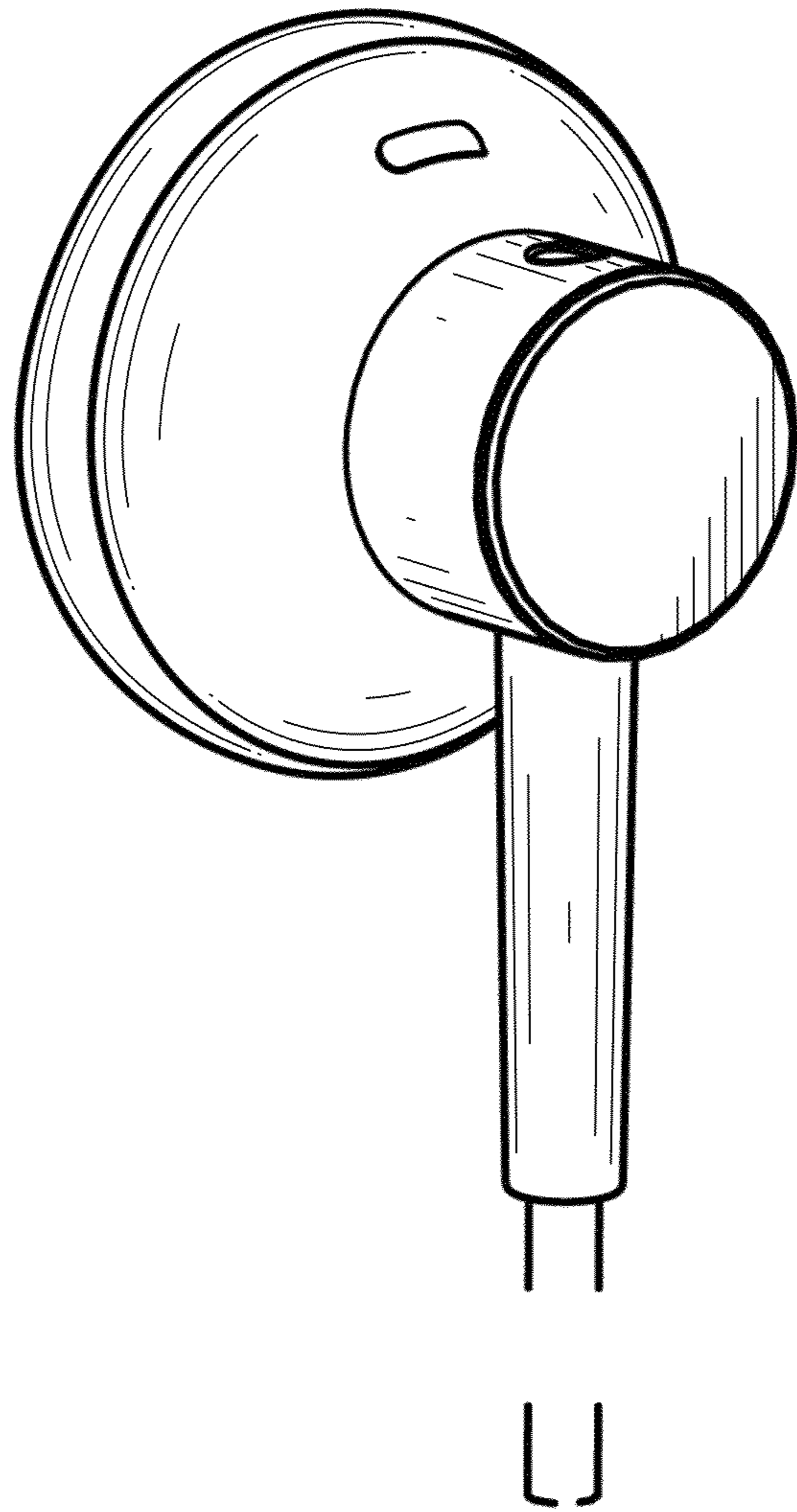

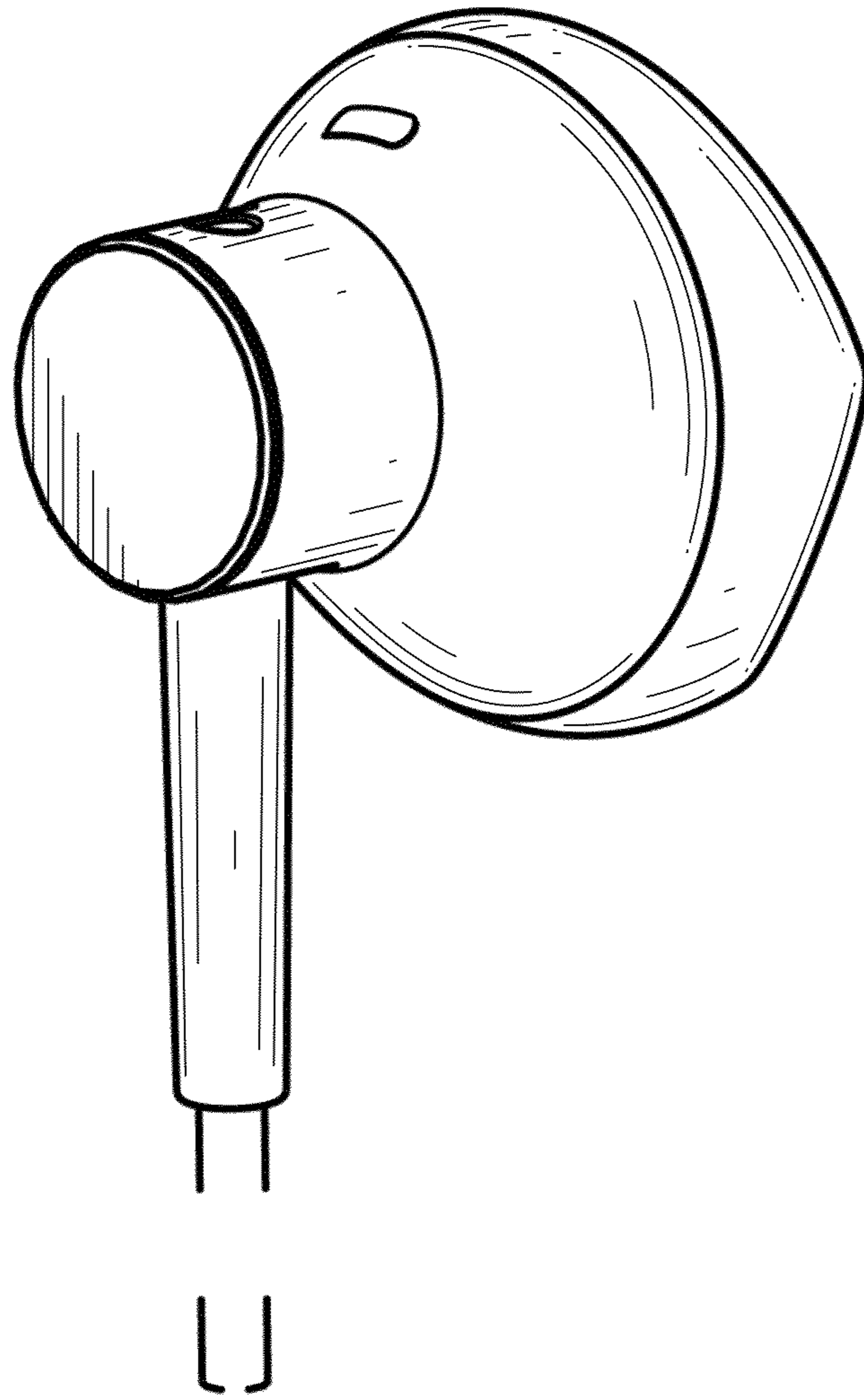

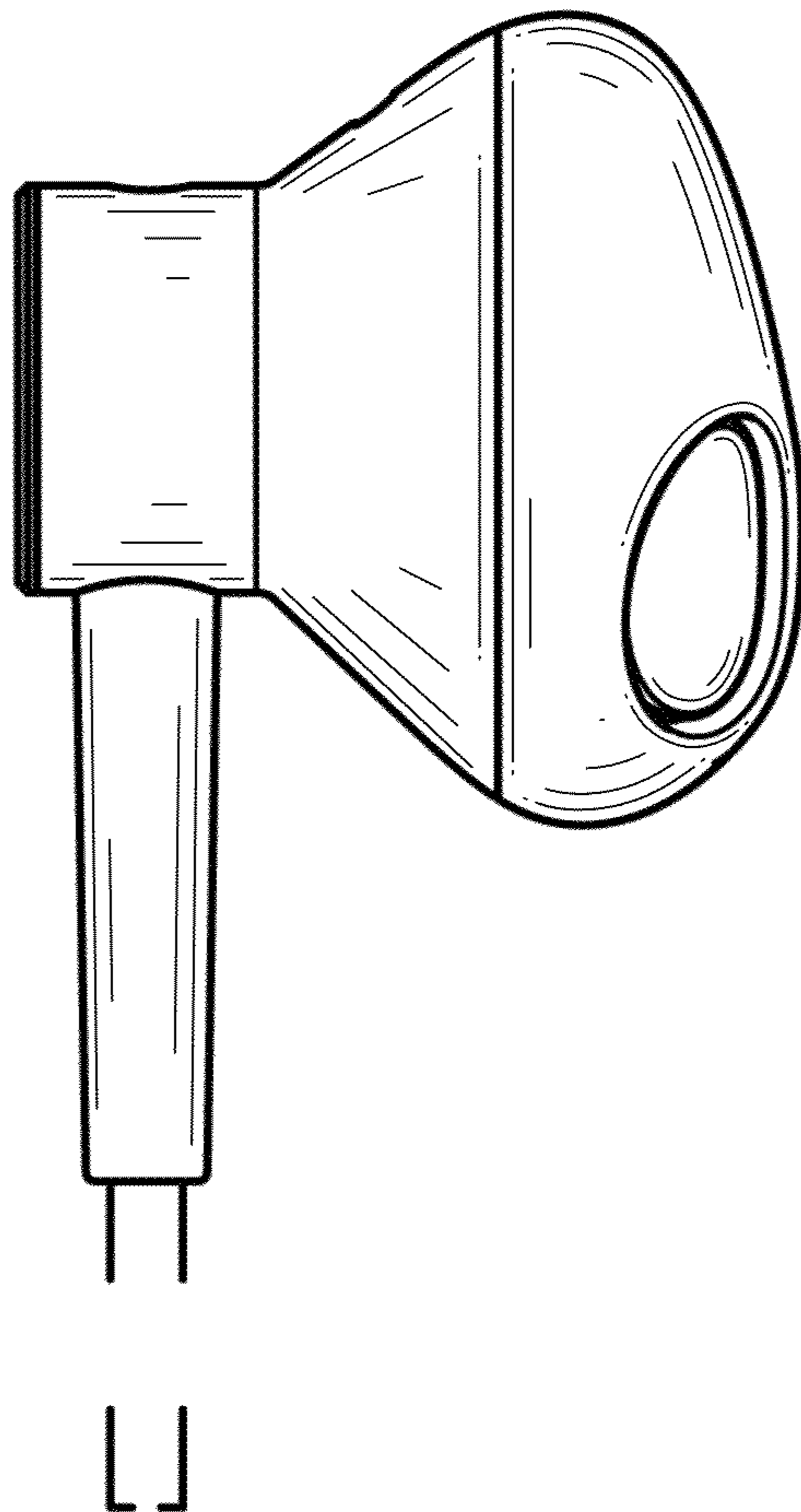

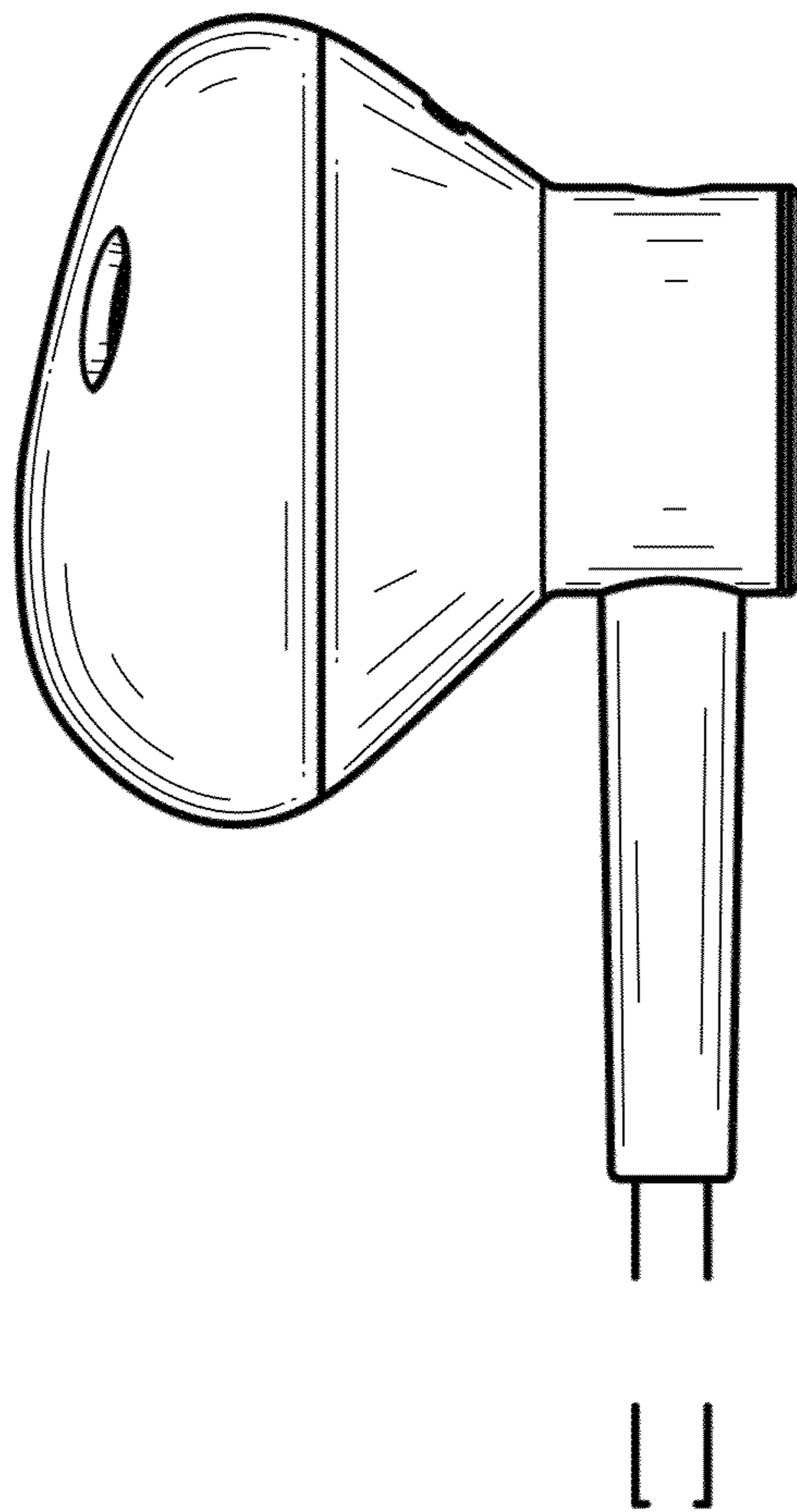
