The ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of a cellular phone showing our new design;

FIG. 2 is a front view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top view thereof; and,

The broken lines shown in the drawings represent portions of the cellular phone which form no part of the claimed design.














