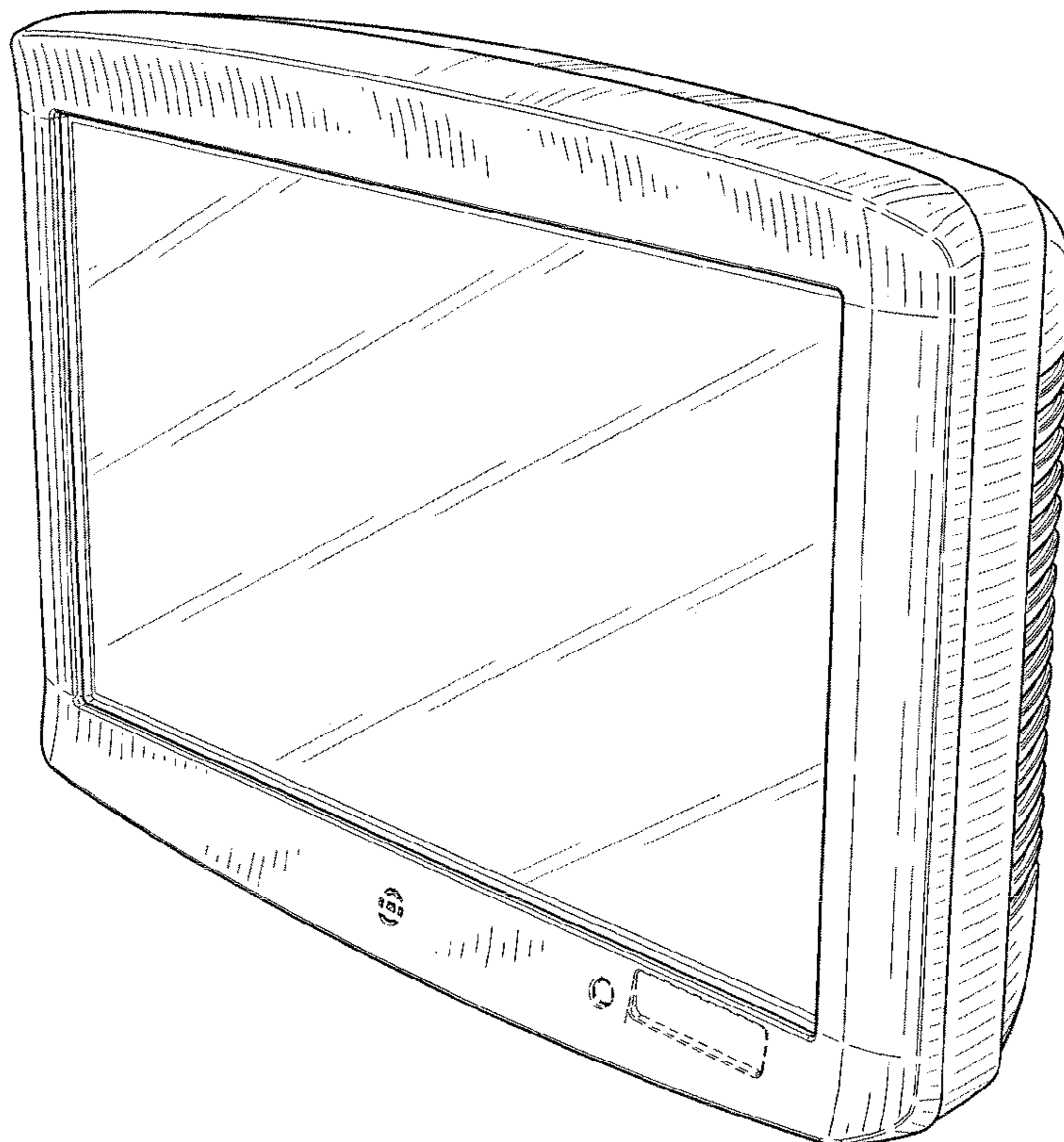
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a display unit in accordance with our new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,

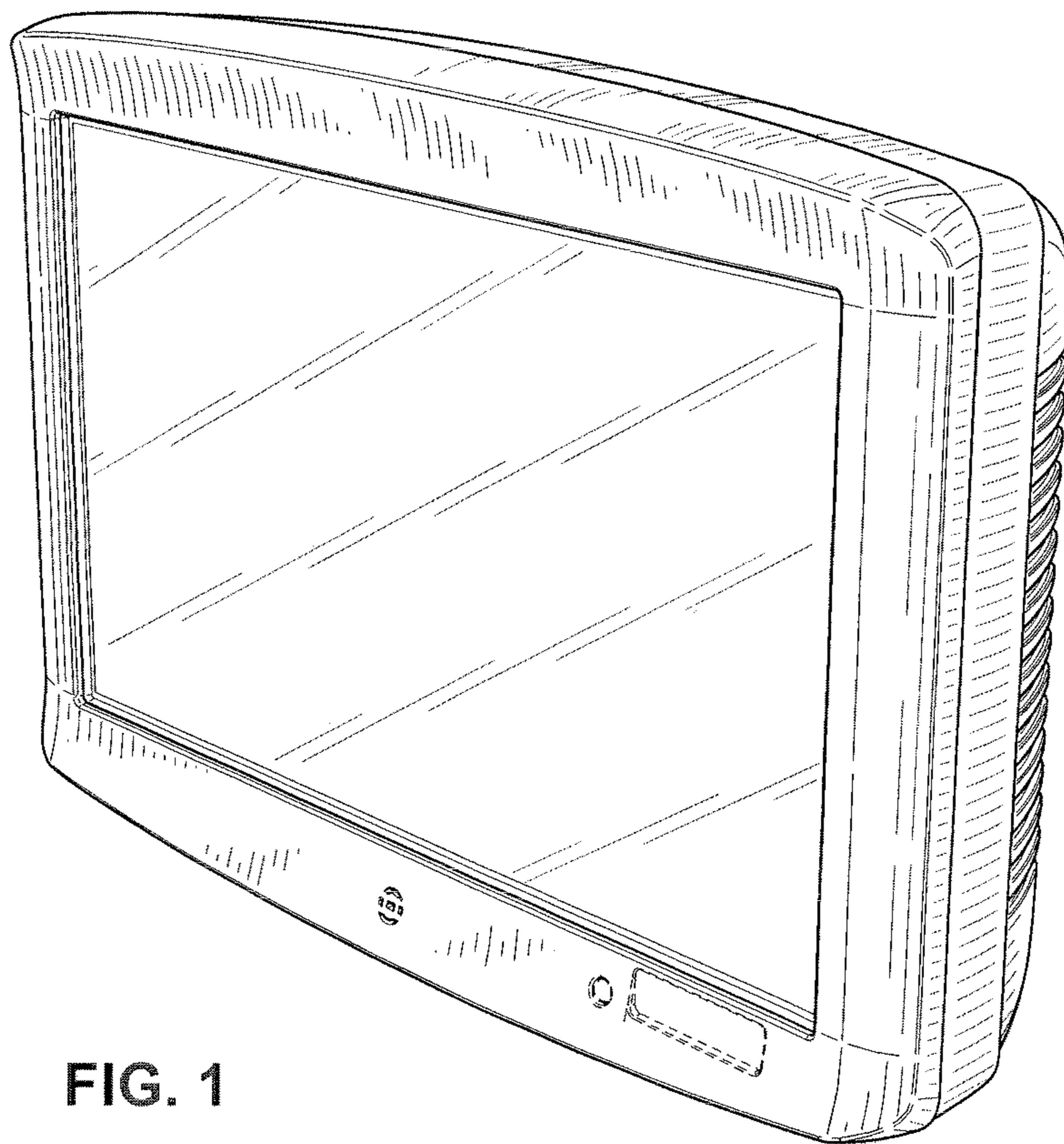

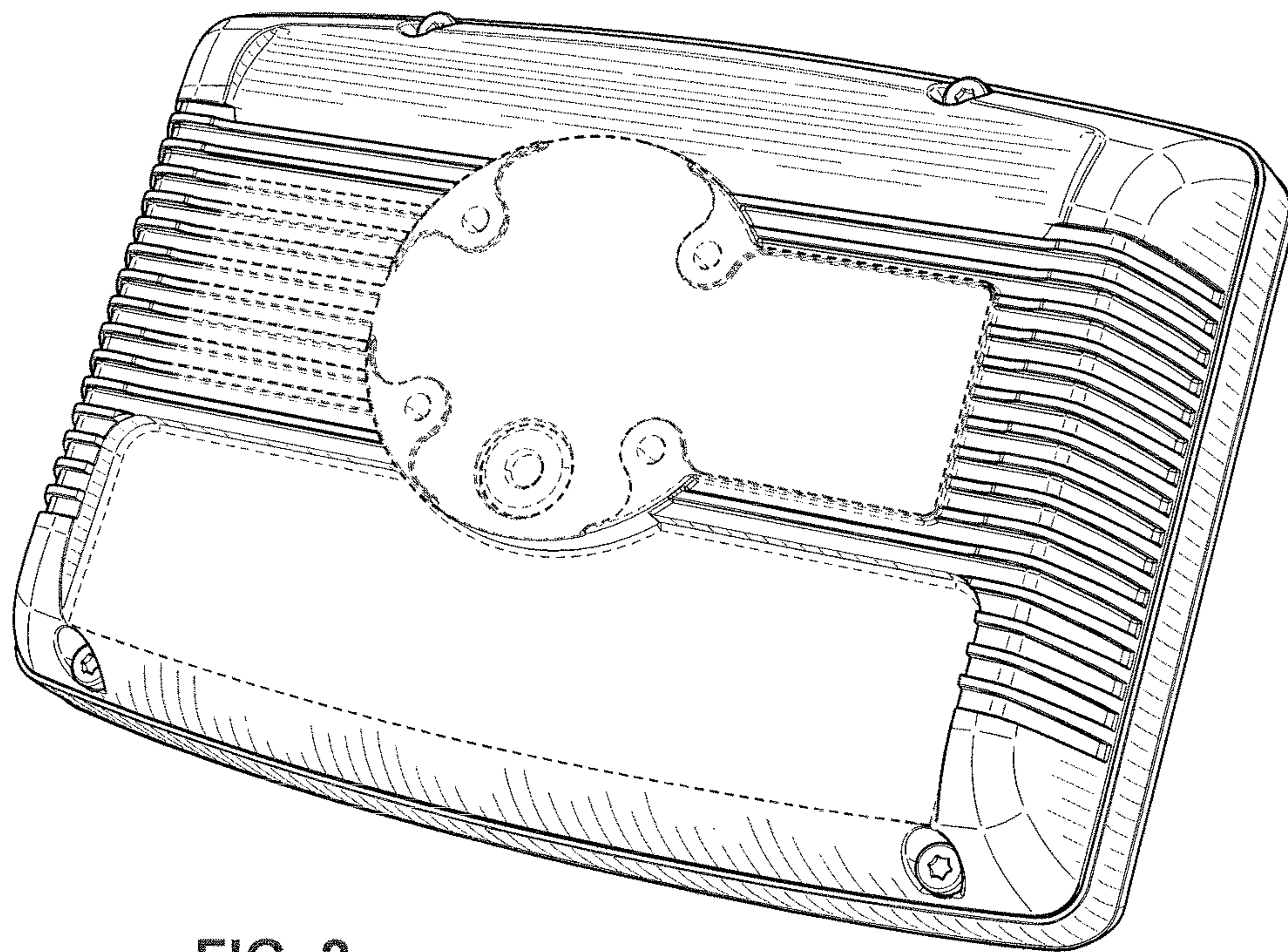

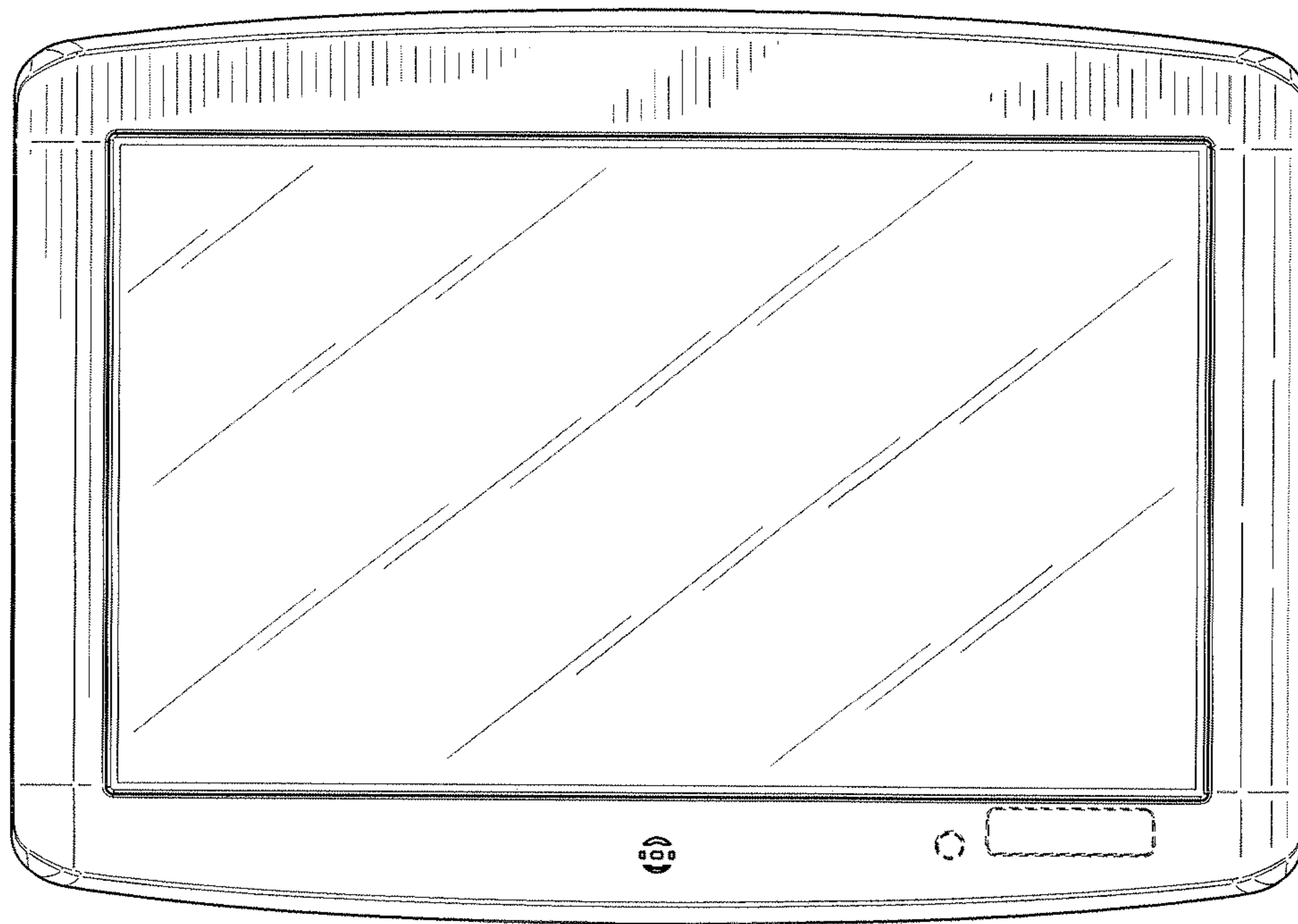

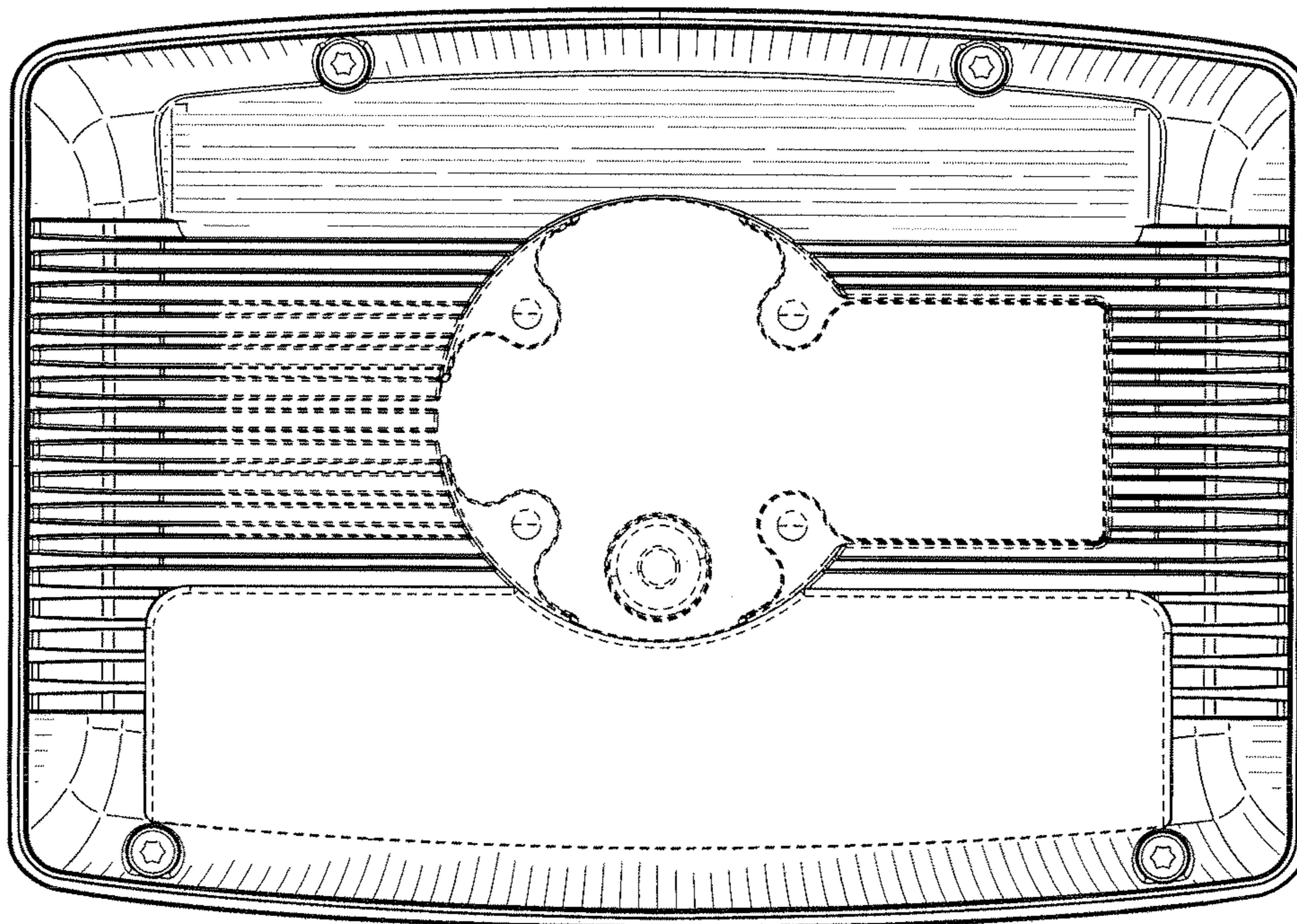

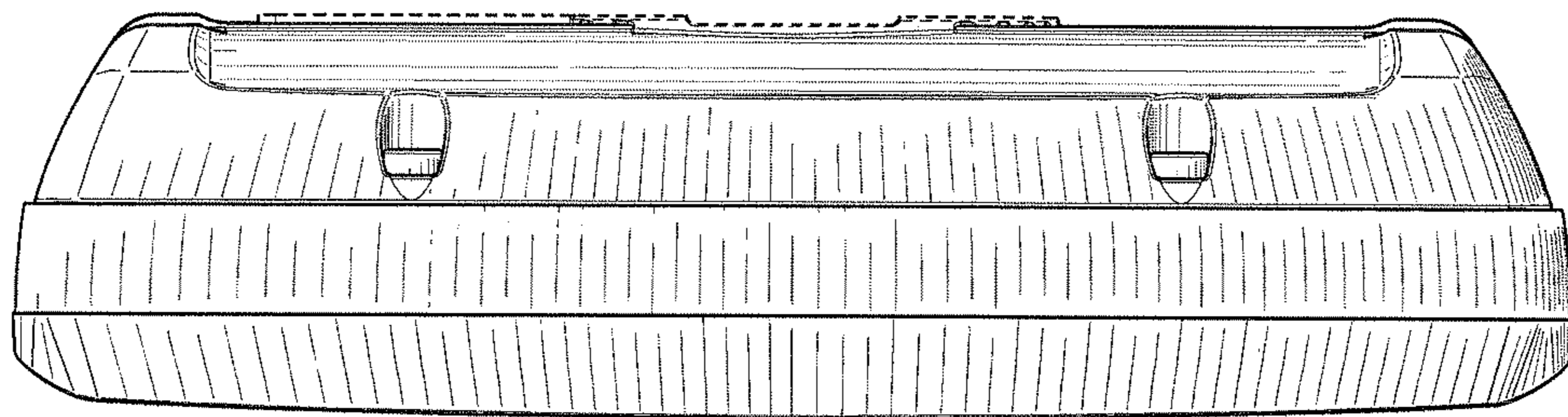

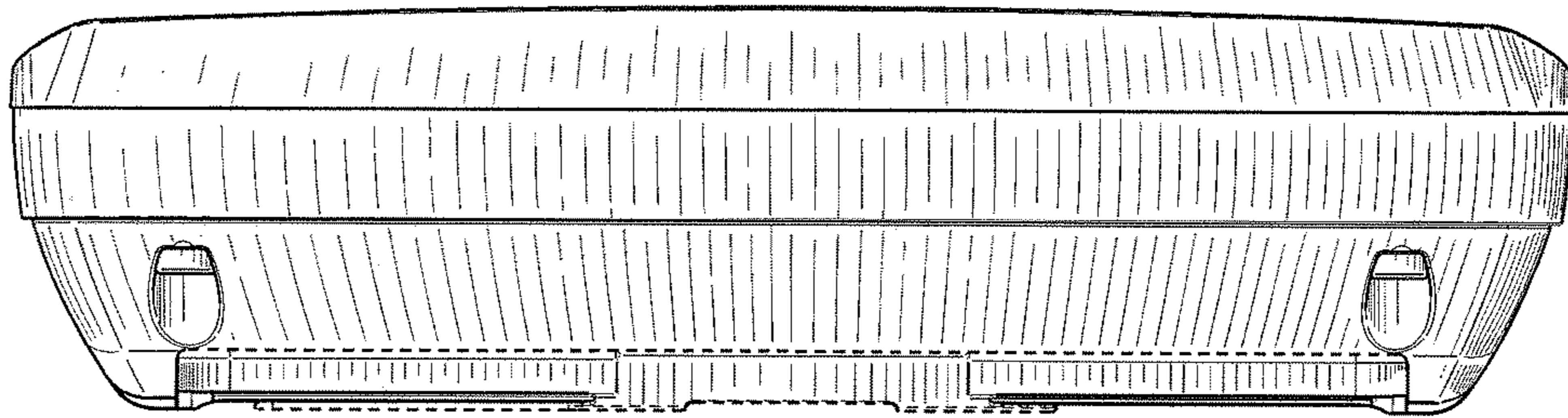

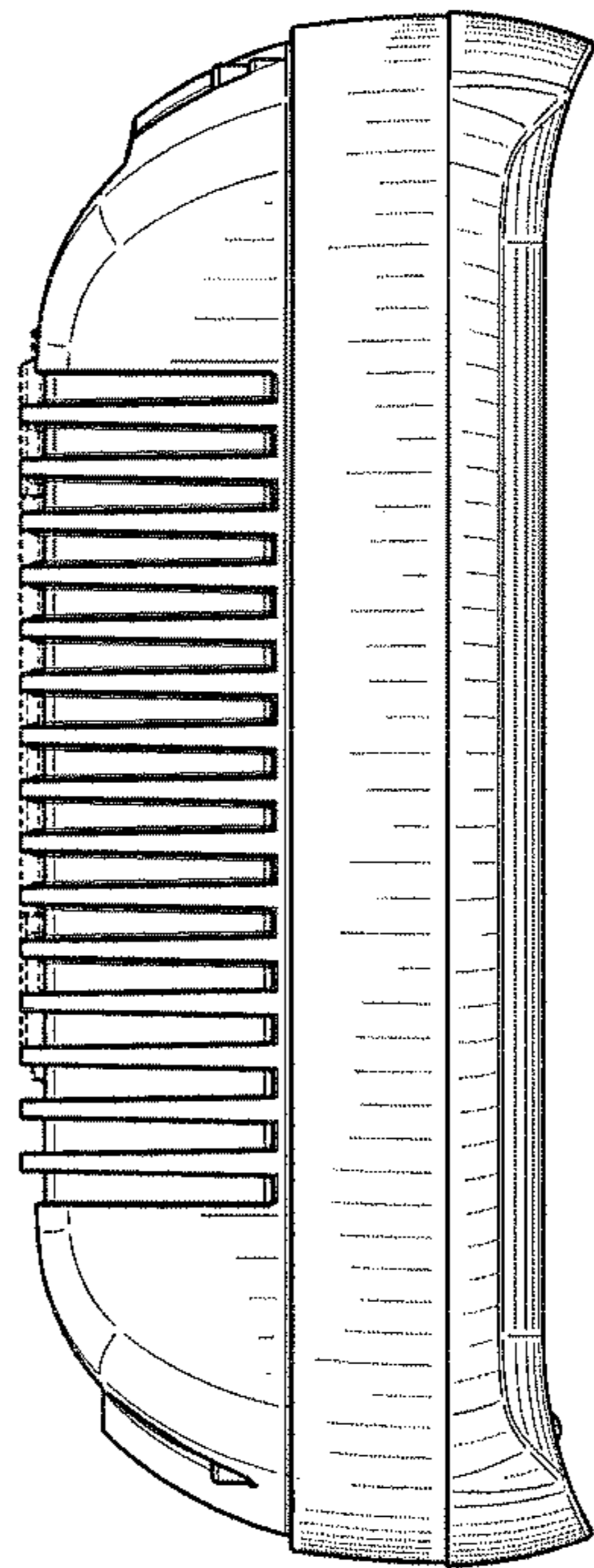
