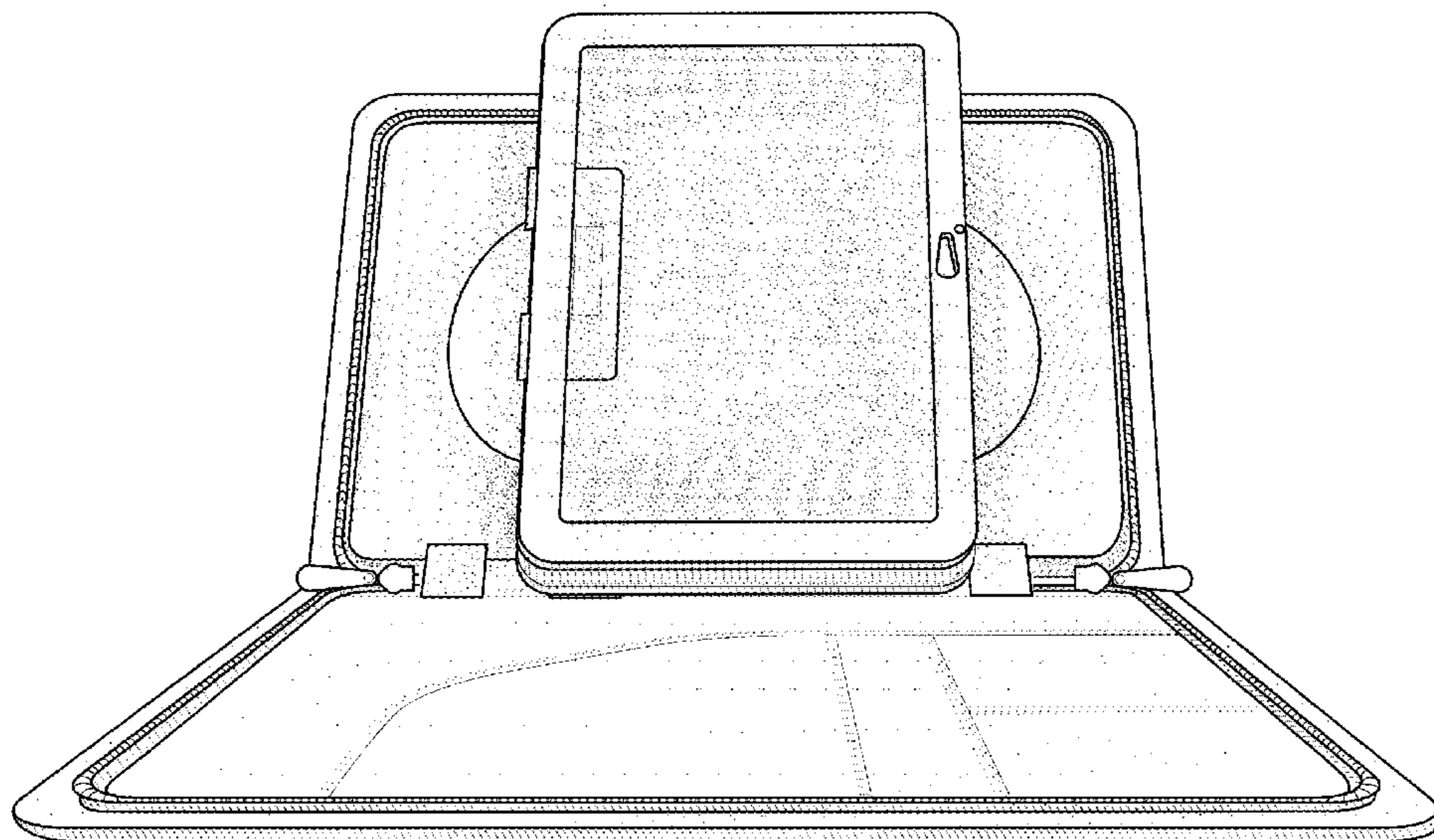
(57) **CLAIM**
The ornamental design for a tablet computer case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tablet computer case;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right-side elevational view thereof;
FIG. 5 is a left-side elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a front elevational view of the detachable case shown without the exterior cover;
FIG. 9 is a rear elevational view thereof;
FIG. 10 is a right-side elevational view thereof;
FIG. 11 is a left-side elevational view thereof;
FIG. 12 is a bottom plan view thereof; and,
FIG. 13 is a top plan view thereof.
FIG. 14 is a perspective view of the cover of the tablet computer cover shown with the detachable case removed.
FIG. 15 is a perspective view of the tablet computer case with the interior piece rotated perpendicularly to the cover; and,
FIG. 16 is a perspective view of the tablet computer case and cover in another alternate position.
The broken lines shown on the tablet computer case in FIG. 6 illustrate unclaimed features.

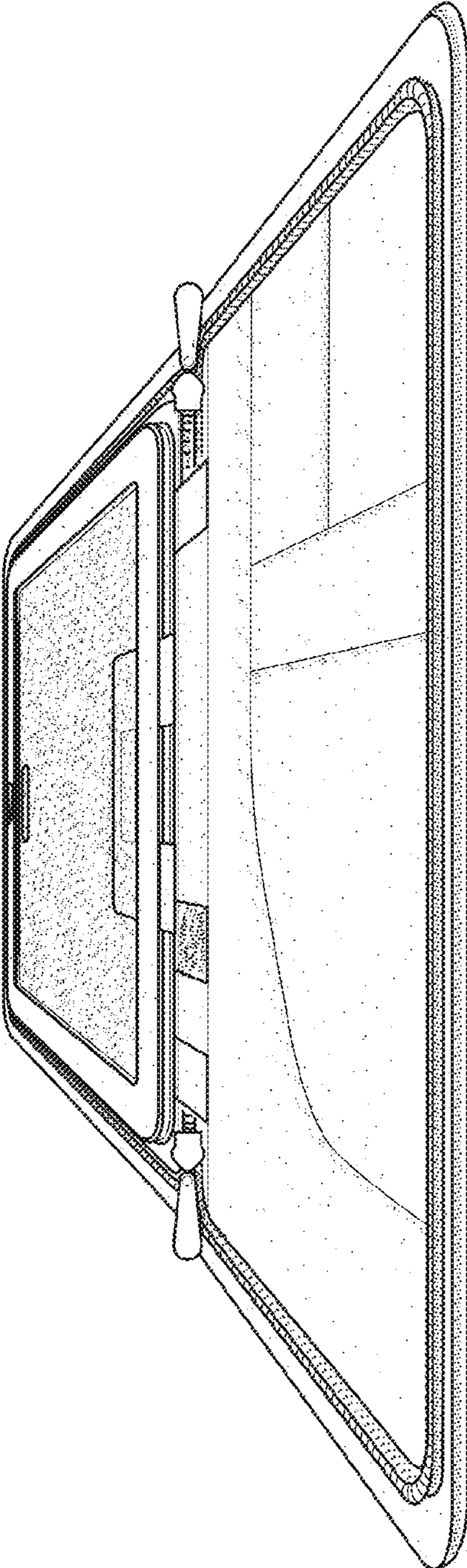

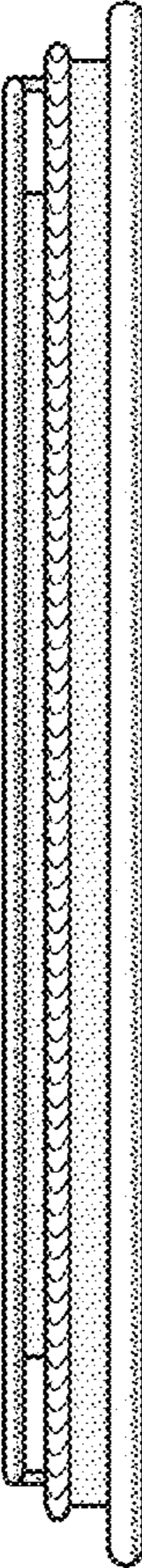

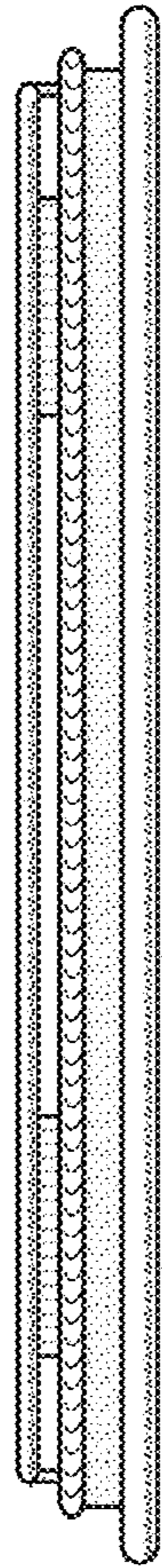

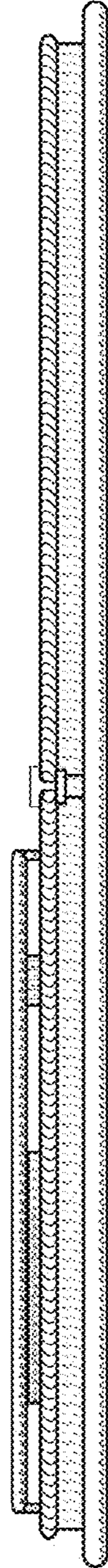

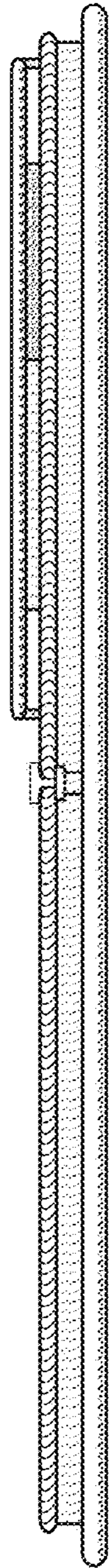

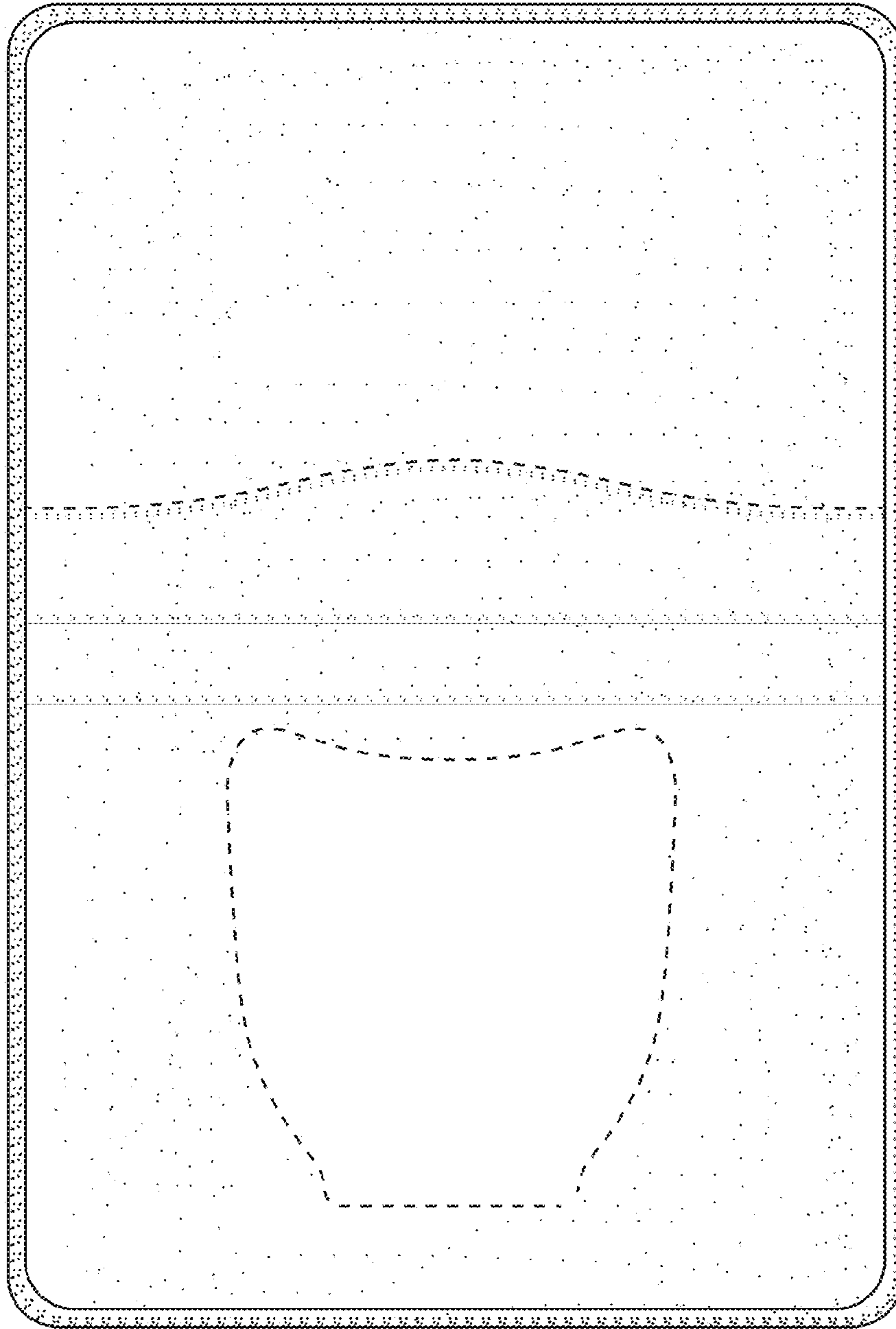

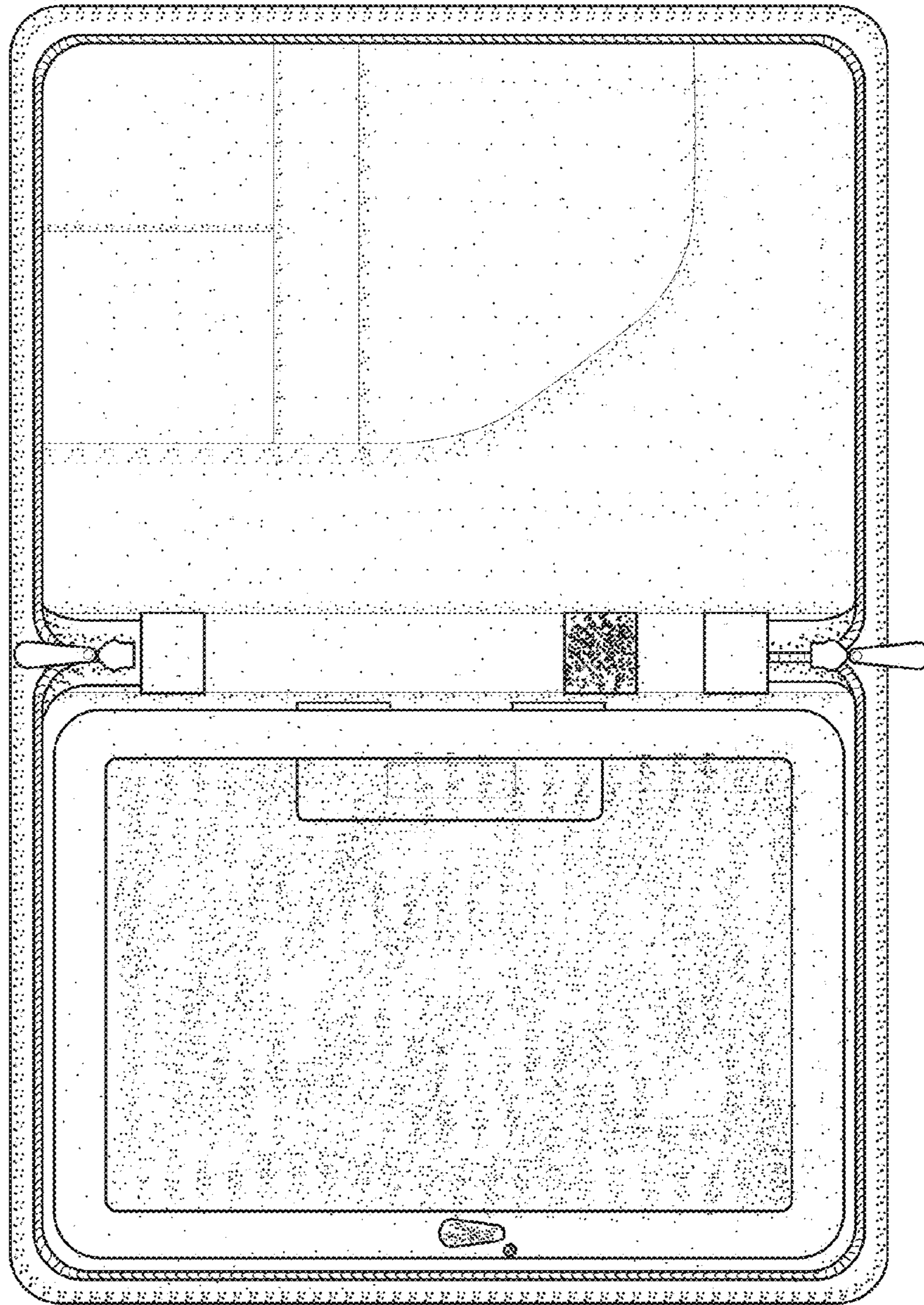

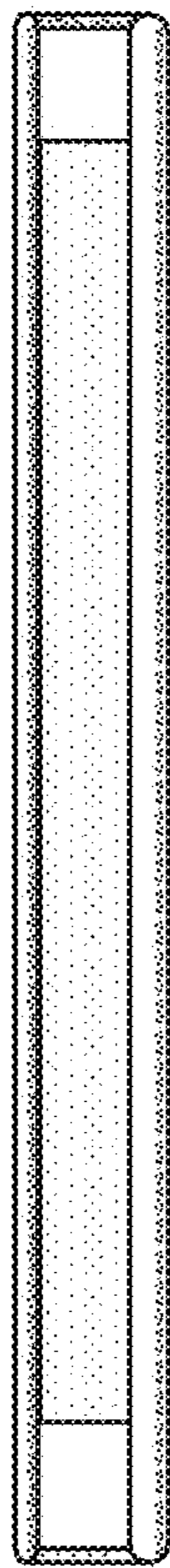

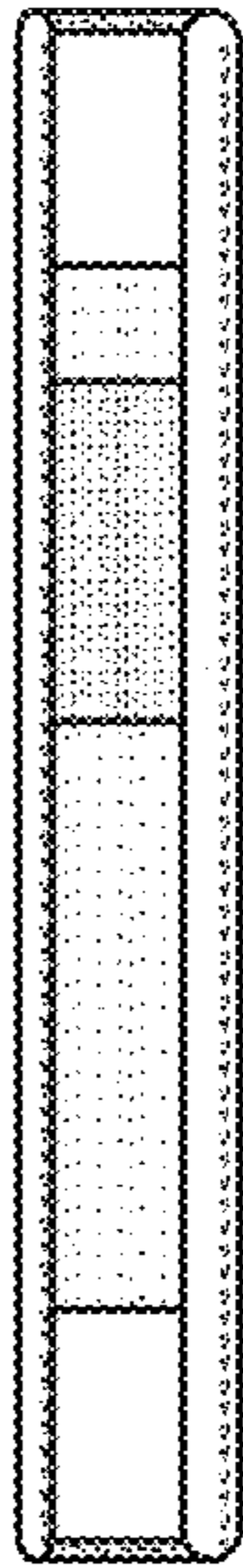

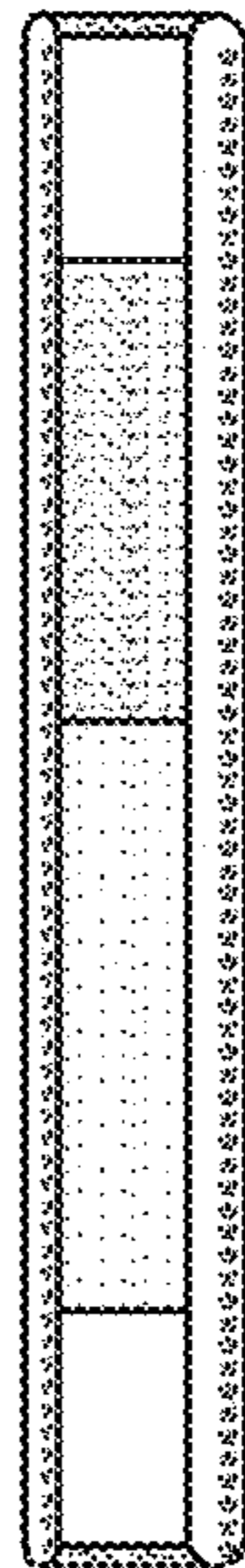

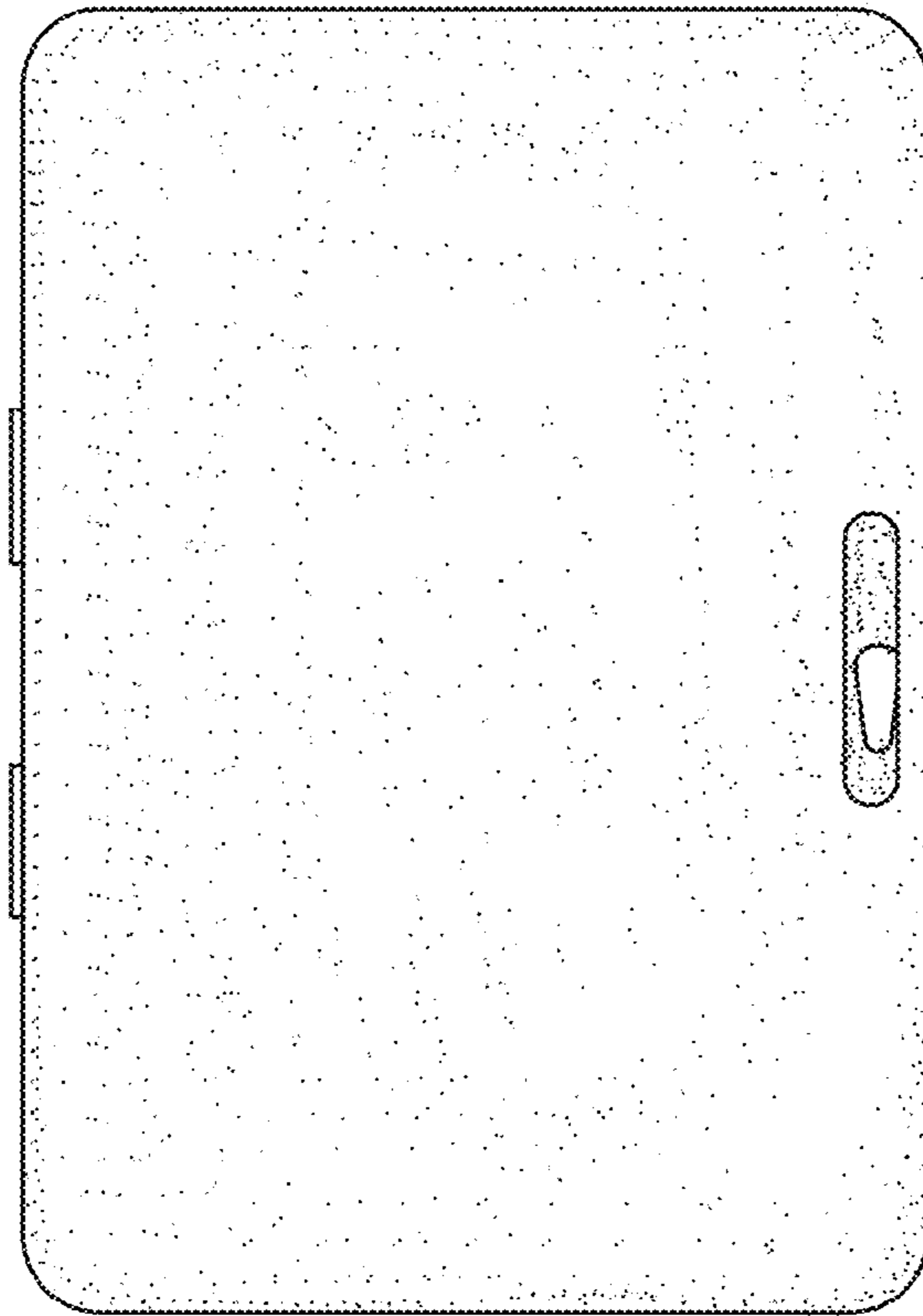

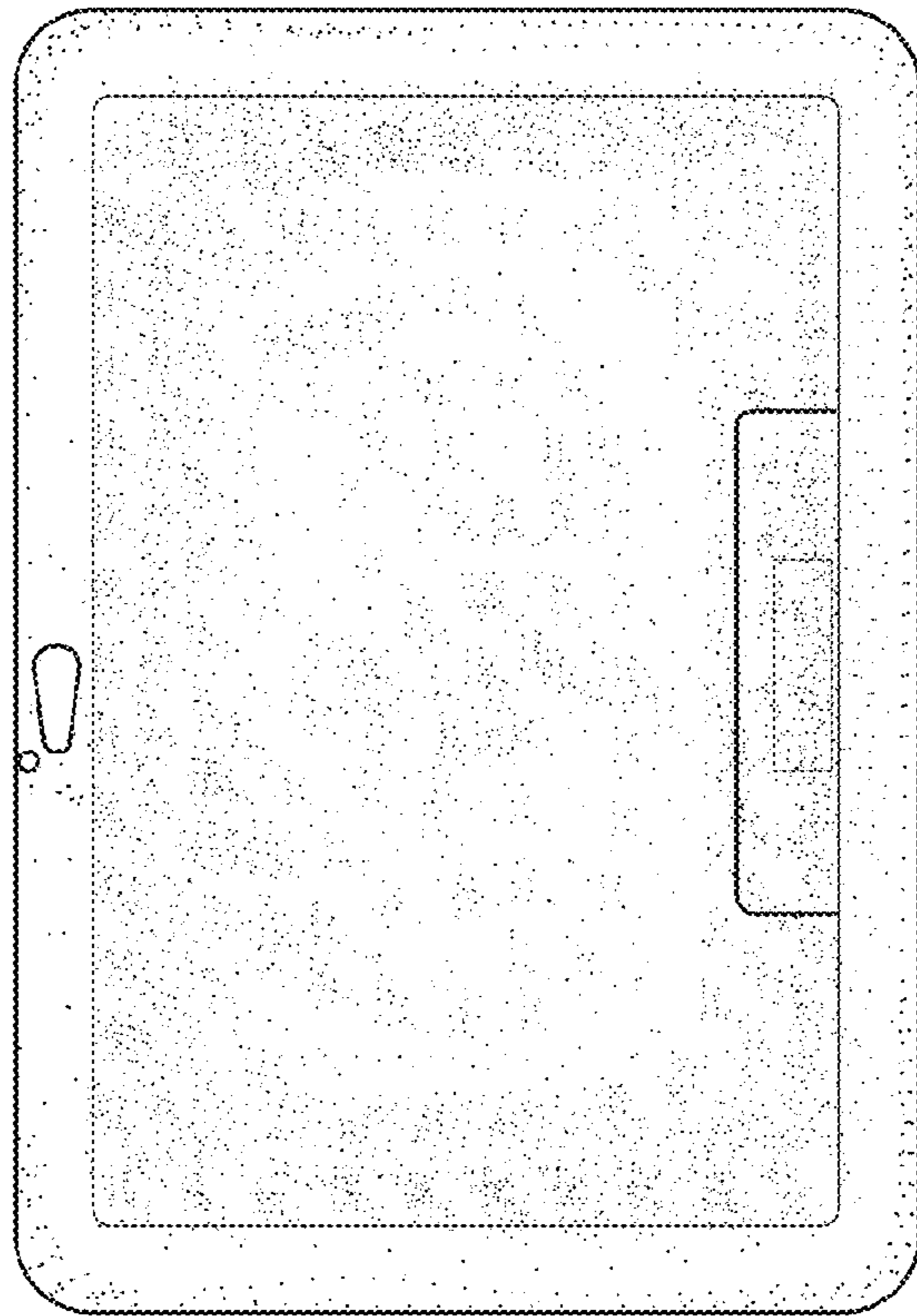

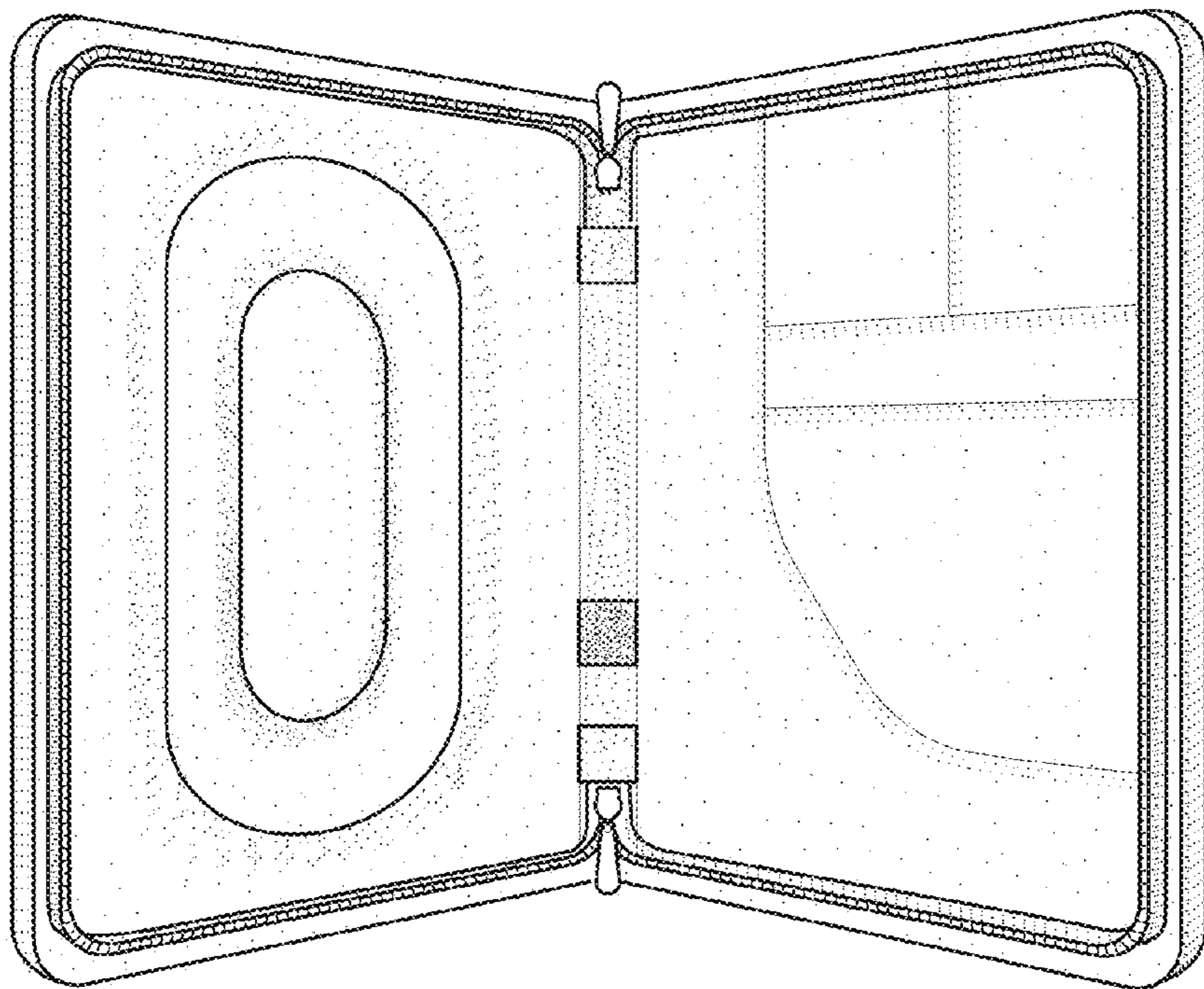

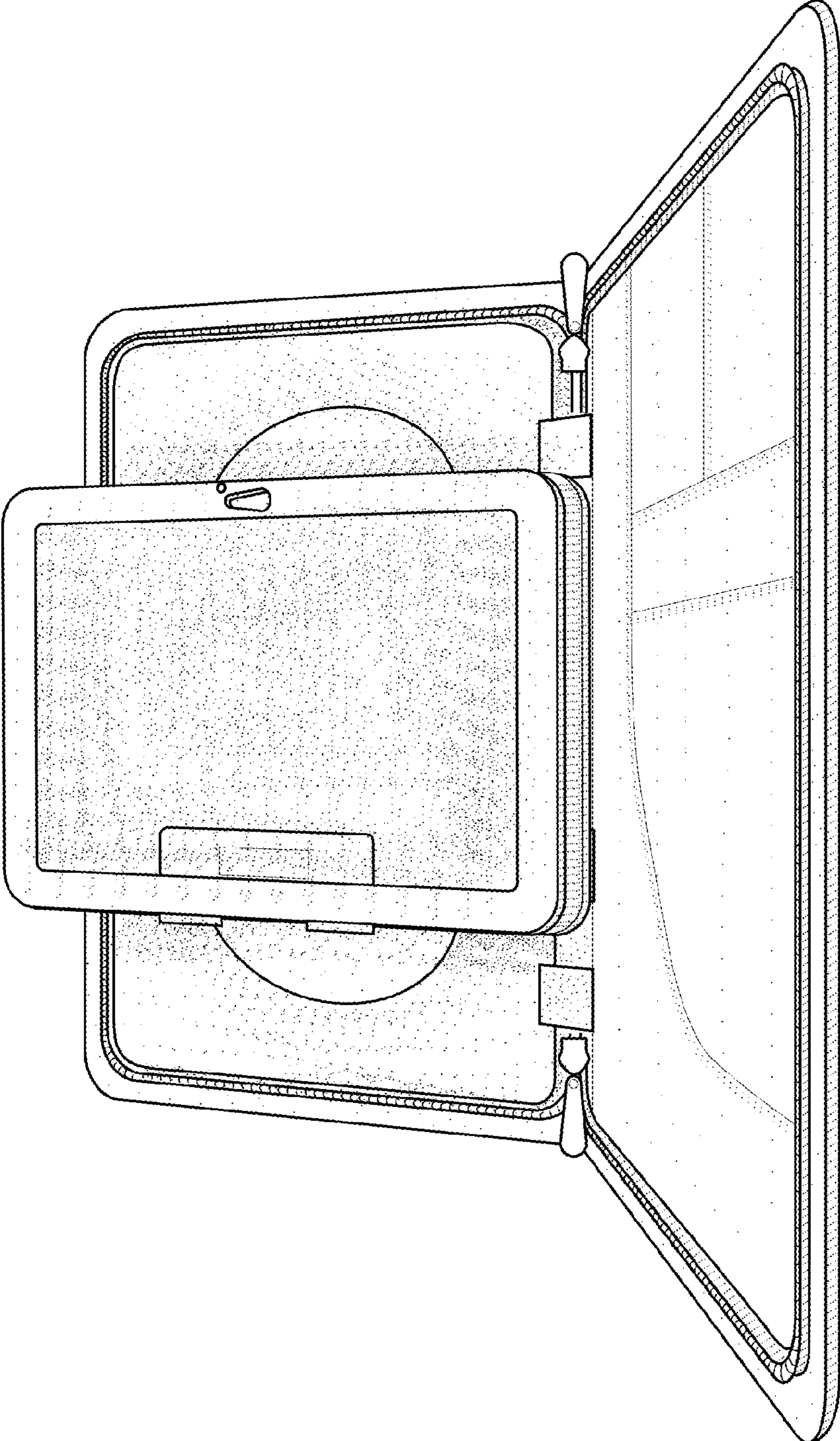

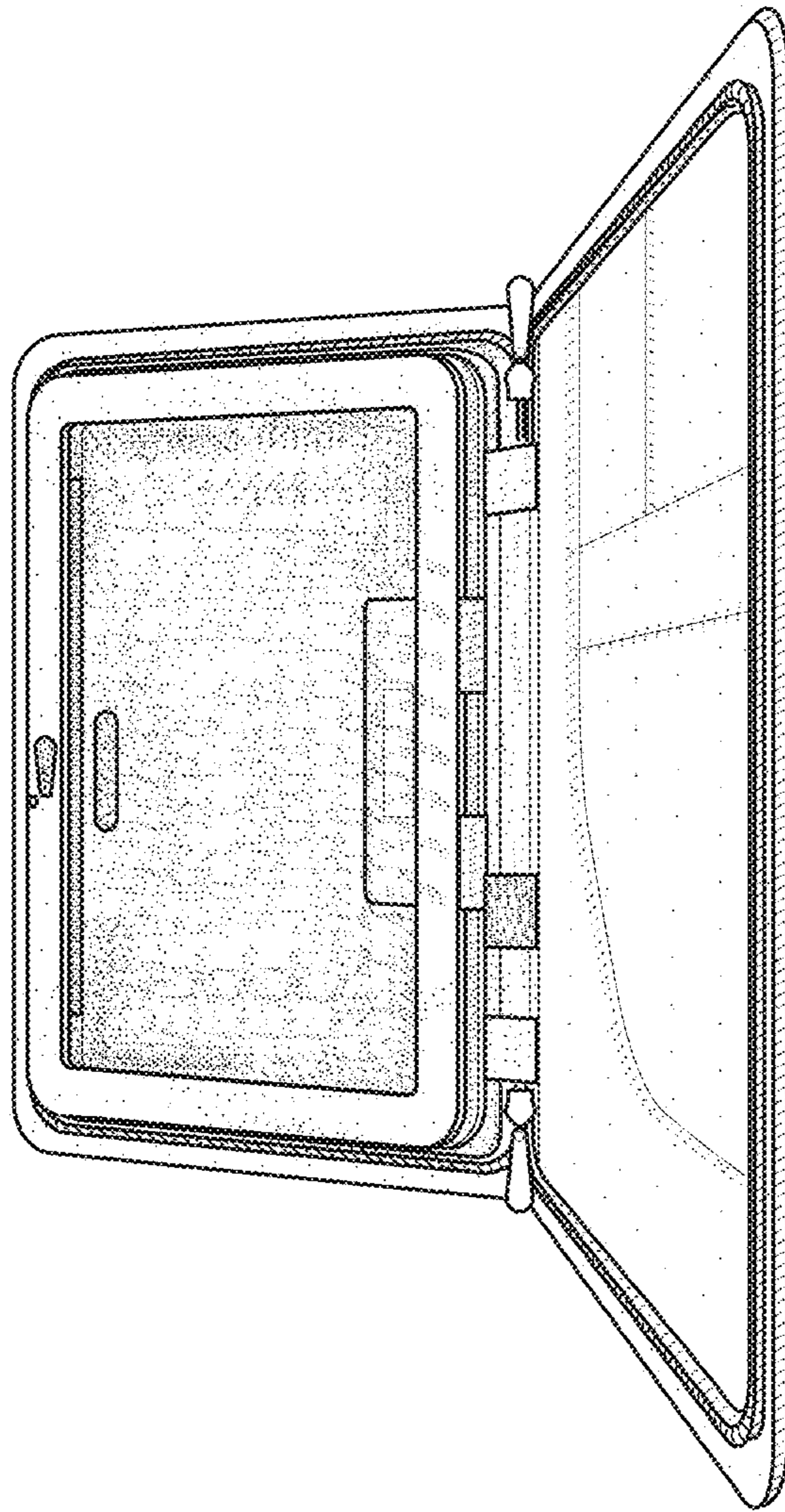
