FIG. 5 is a right-side view of the bookmark with ribbons of FIG. 1;

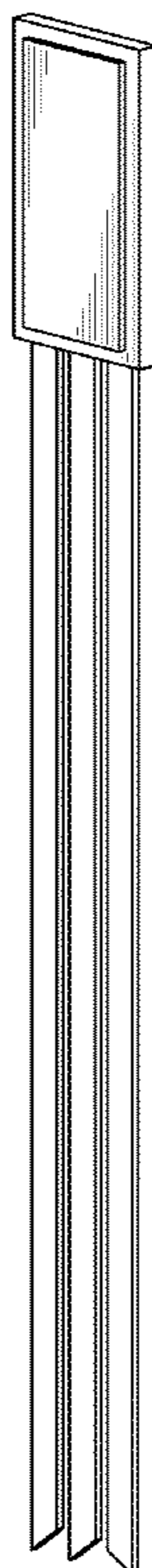
FIG. 6 is a top view of the bookmark with ribbons of FIG. 1;

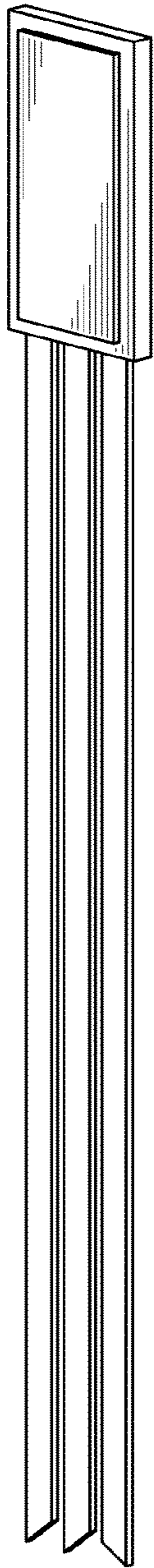

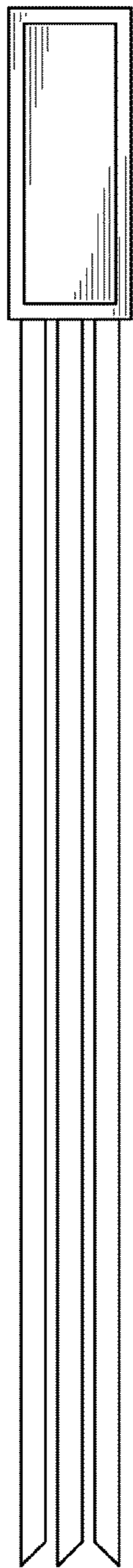

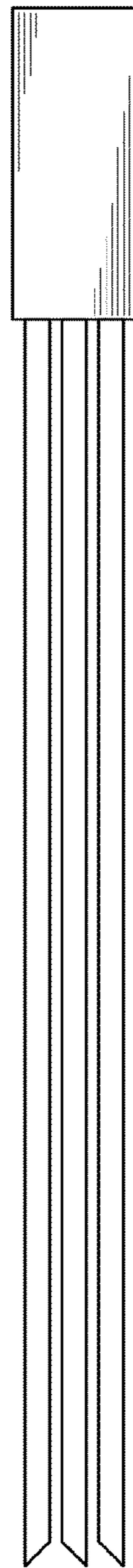

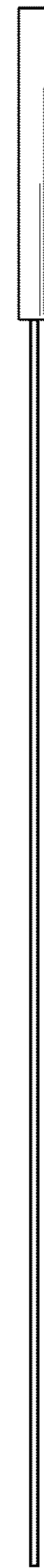

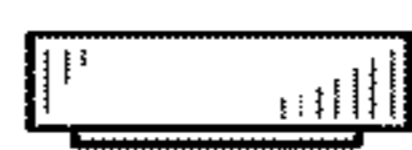
