**DESCRIPTION**

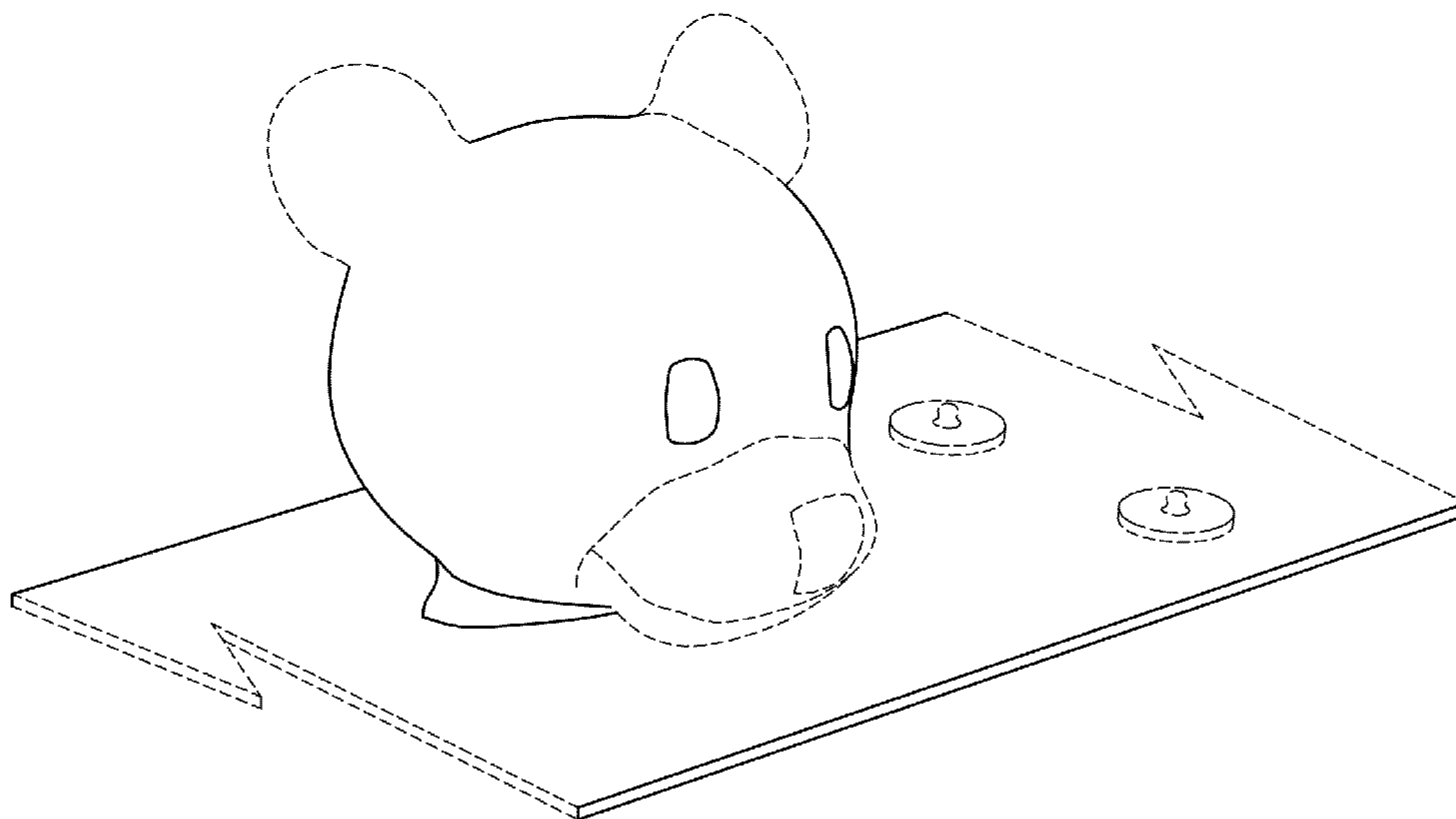
FIG. 1 is a perspective view of the pet head accessory kit showing our new design;

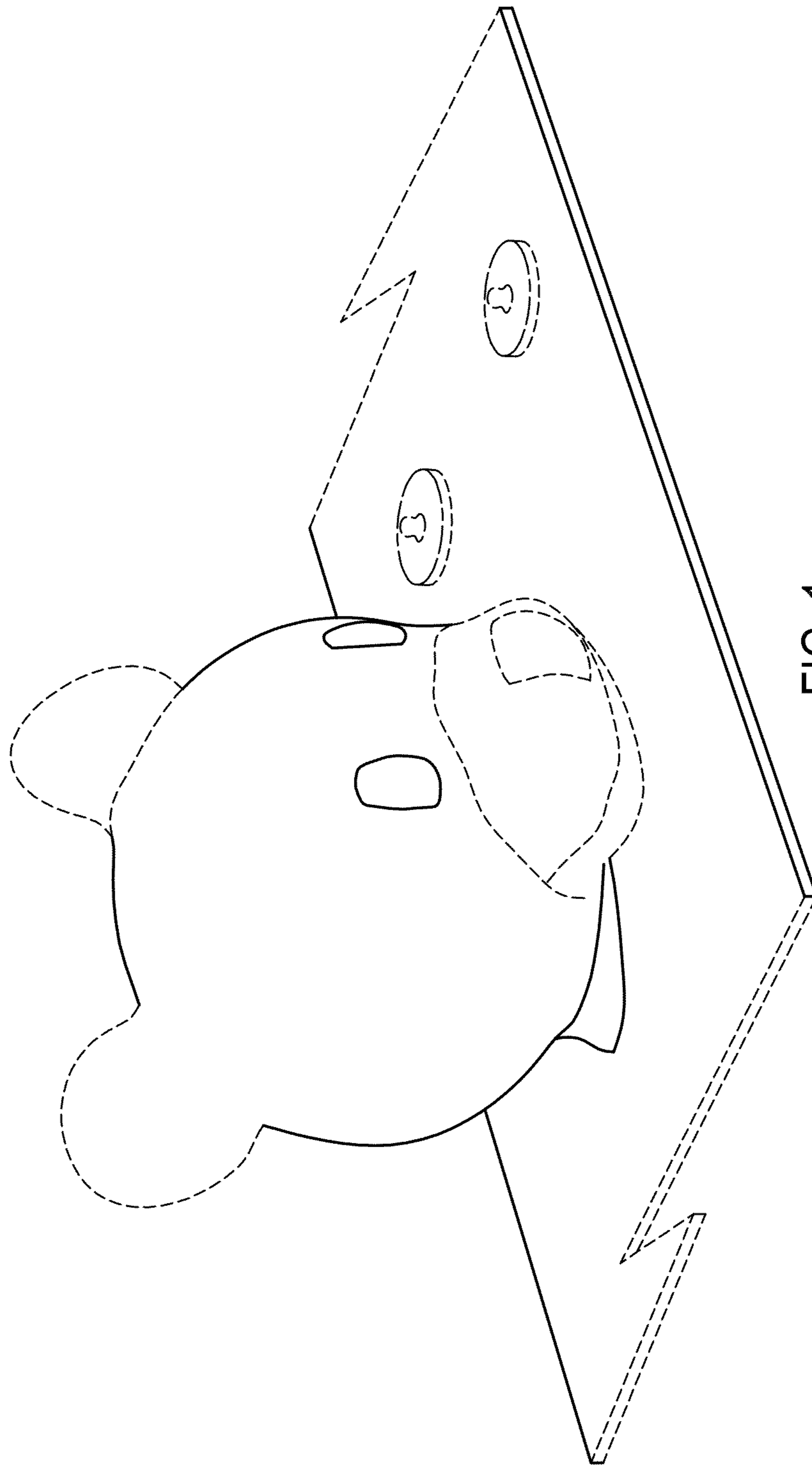

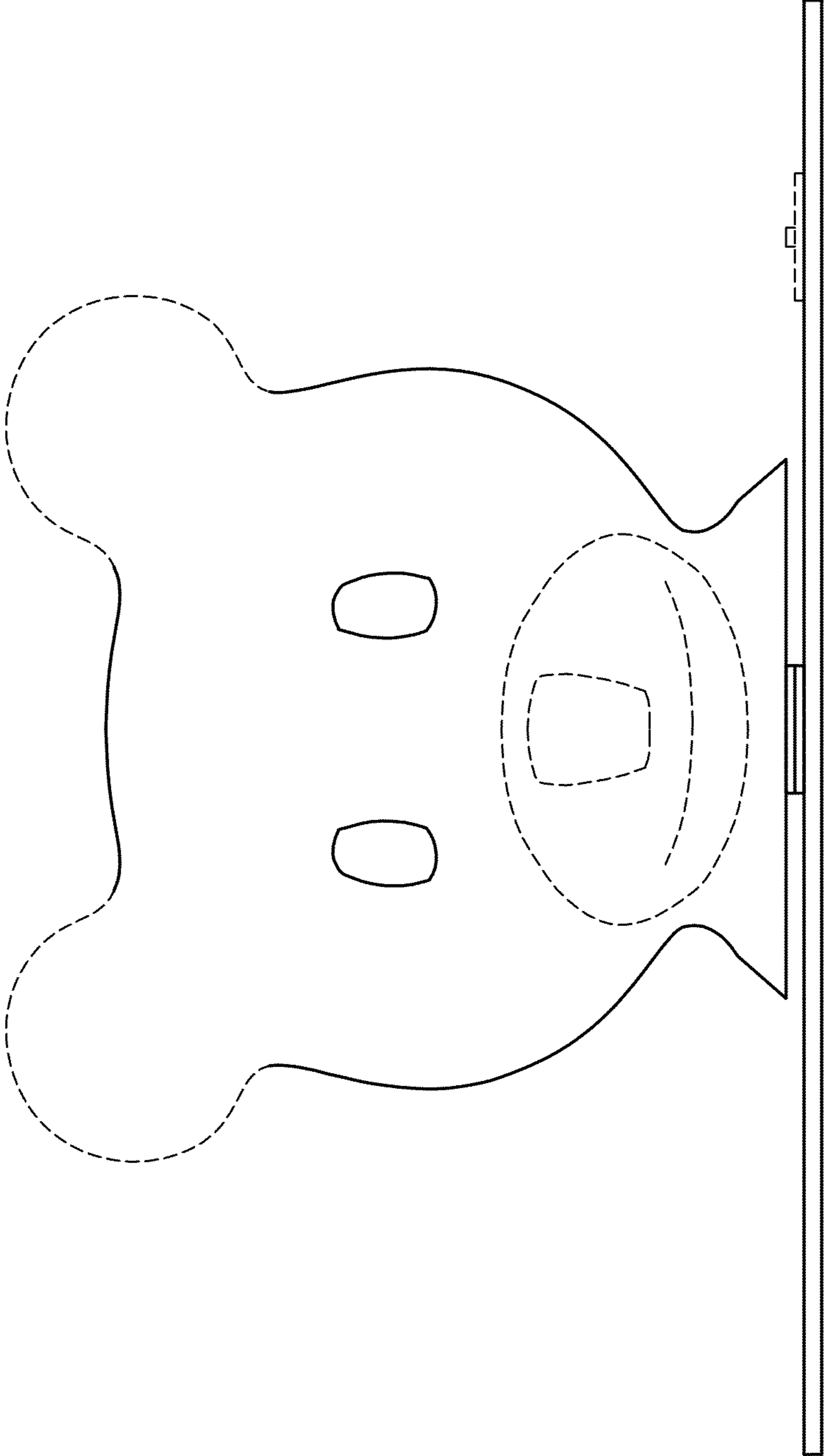

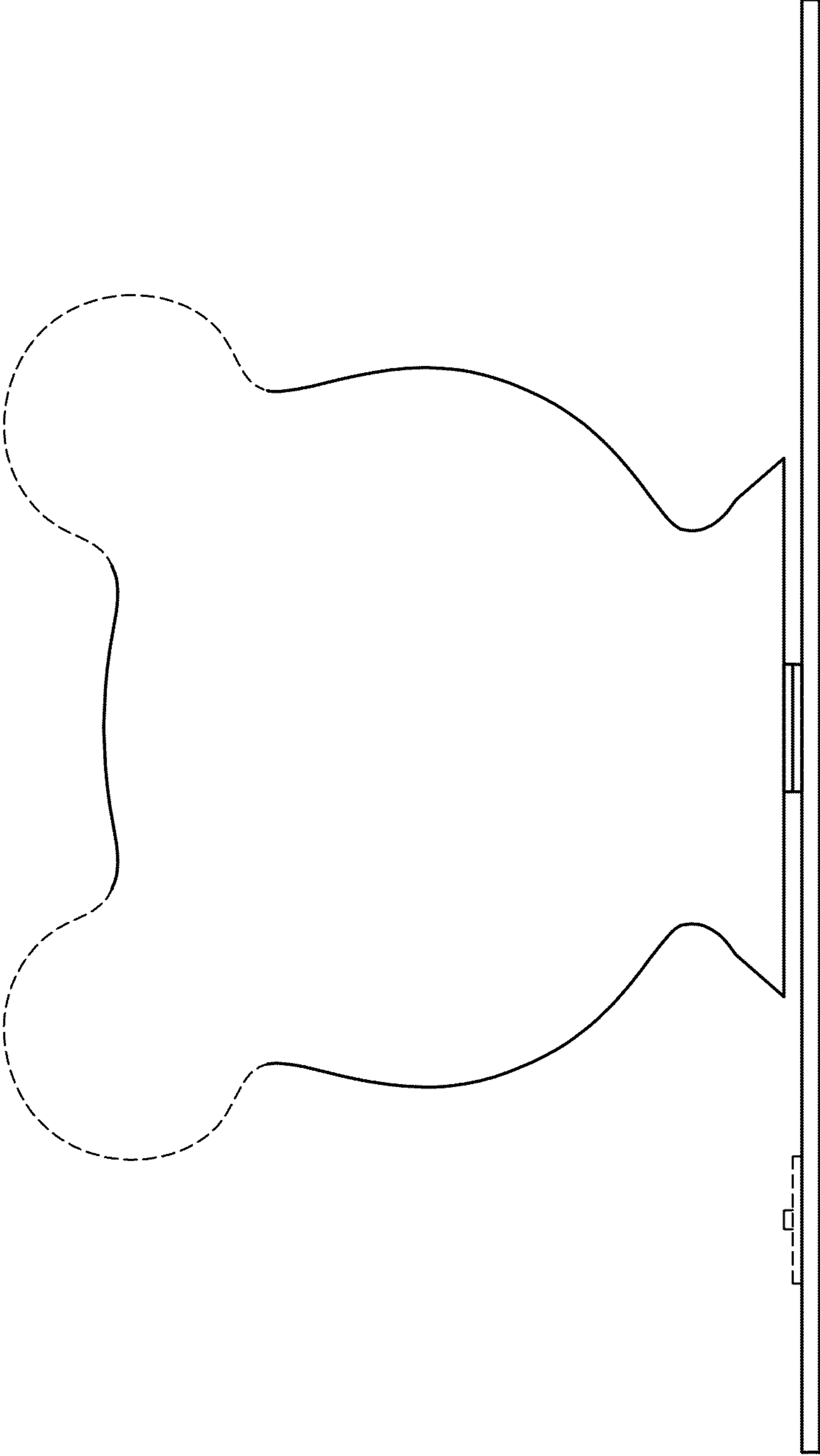

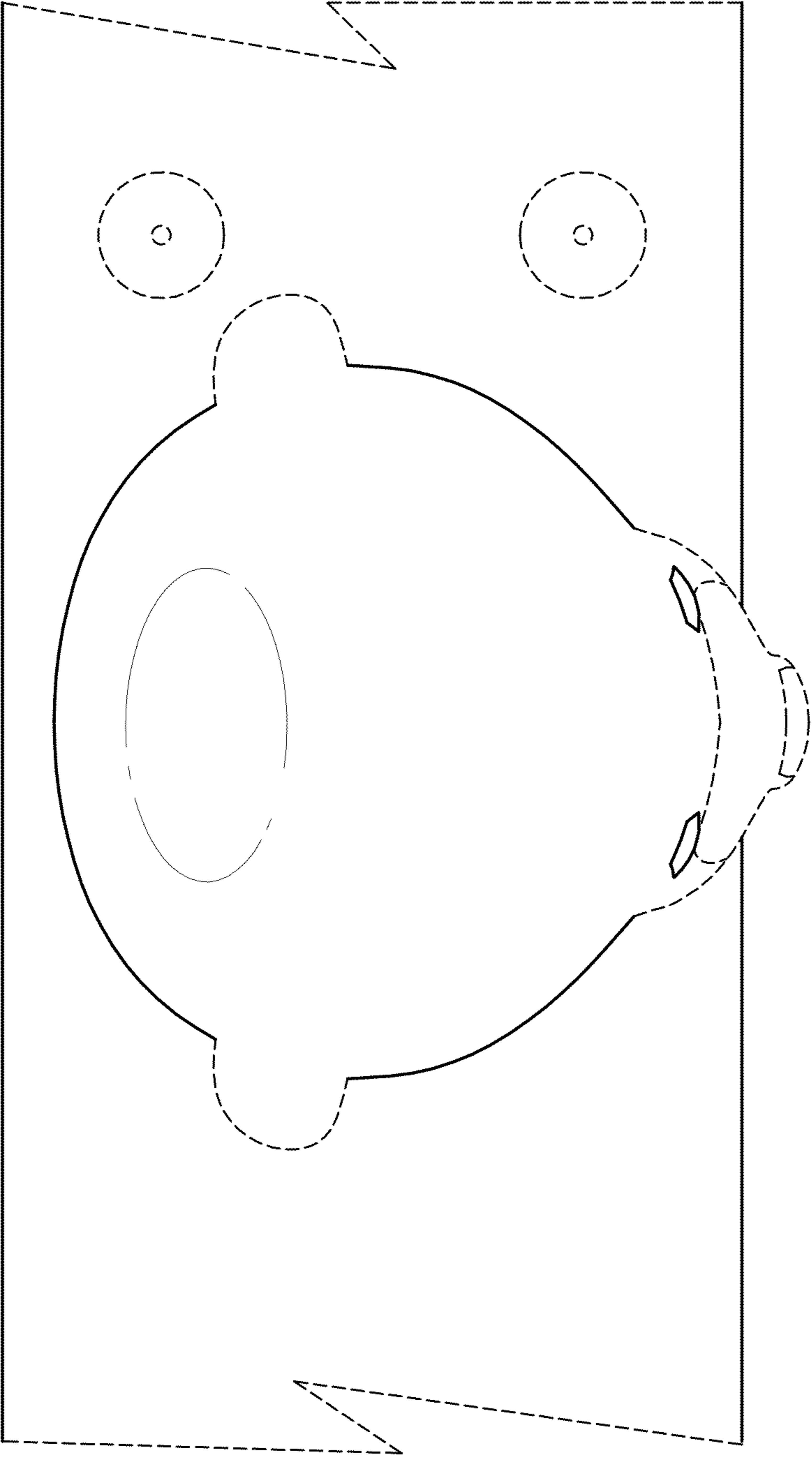

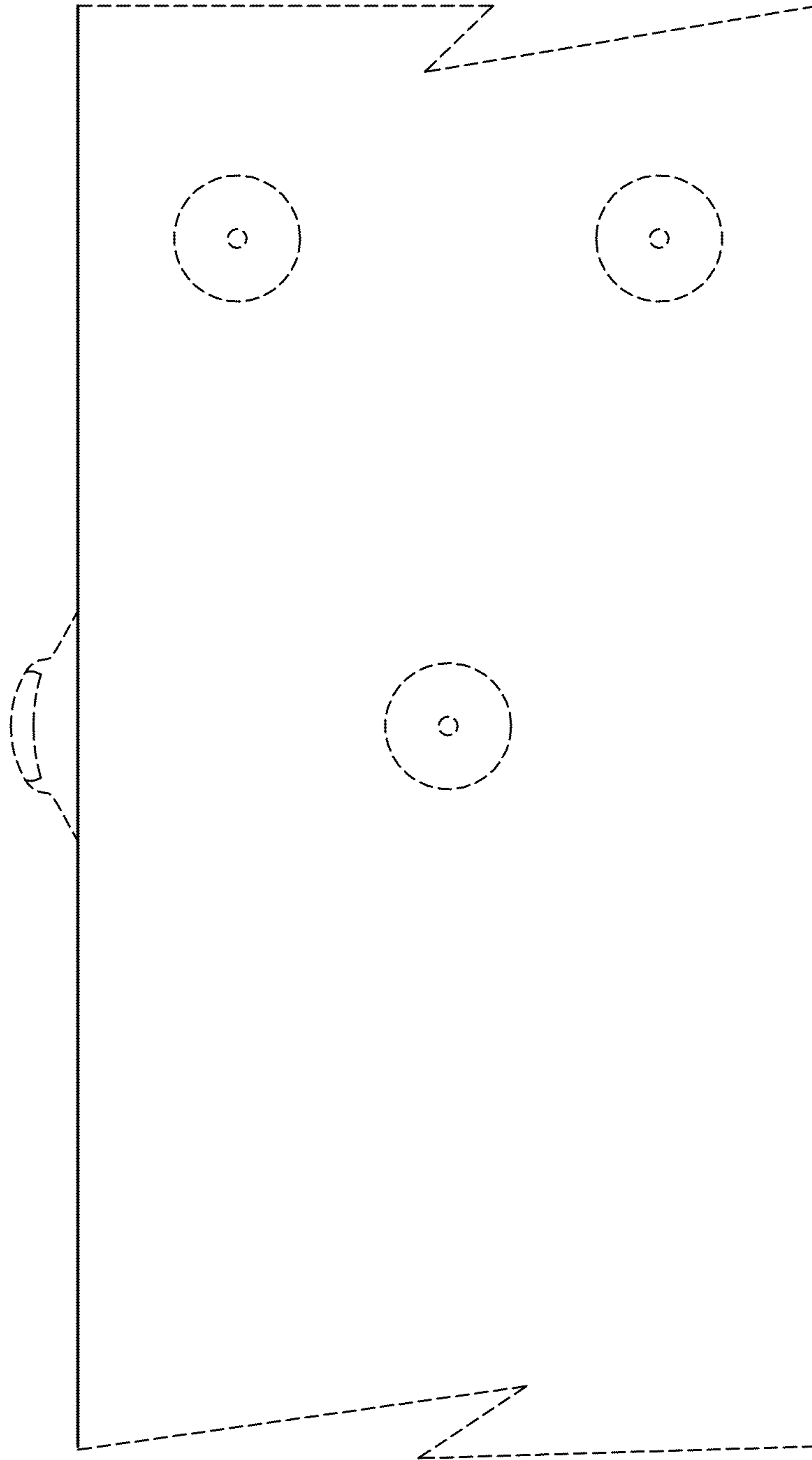

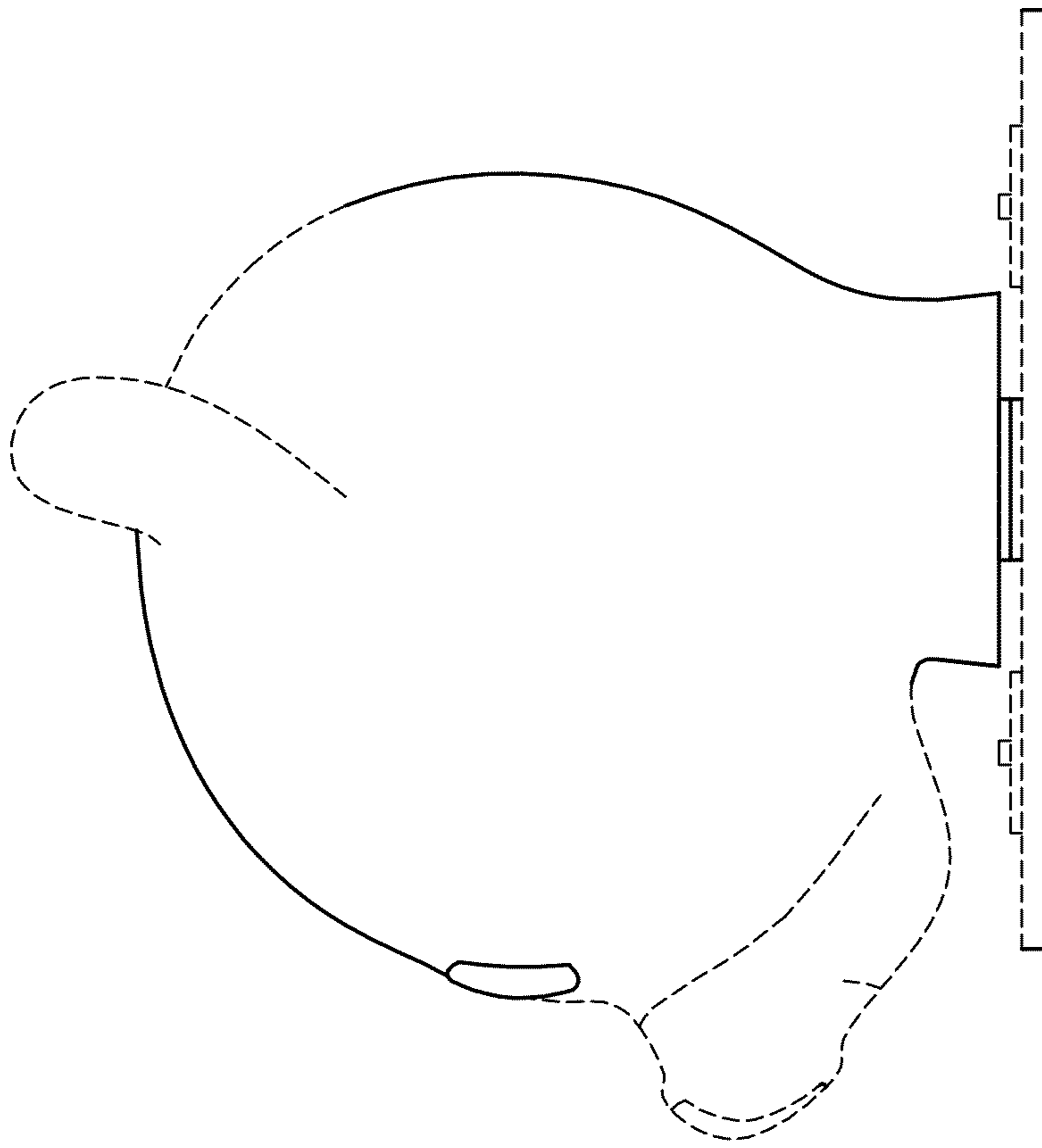

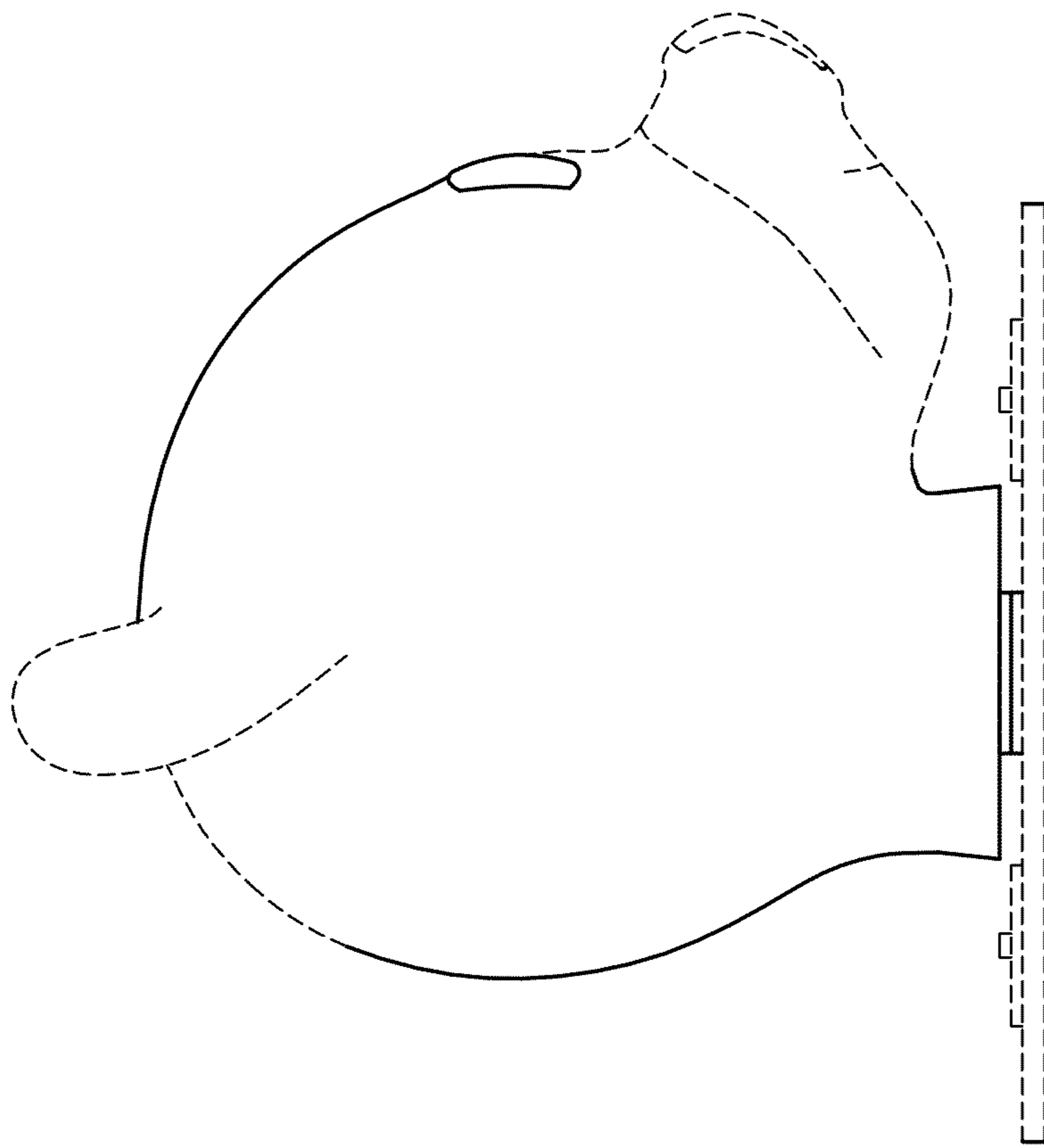

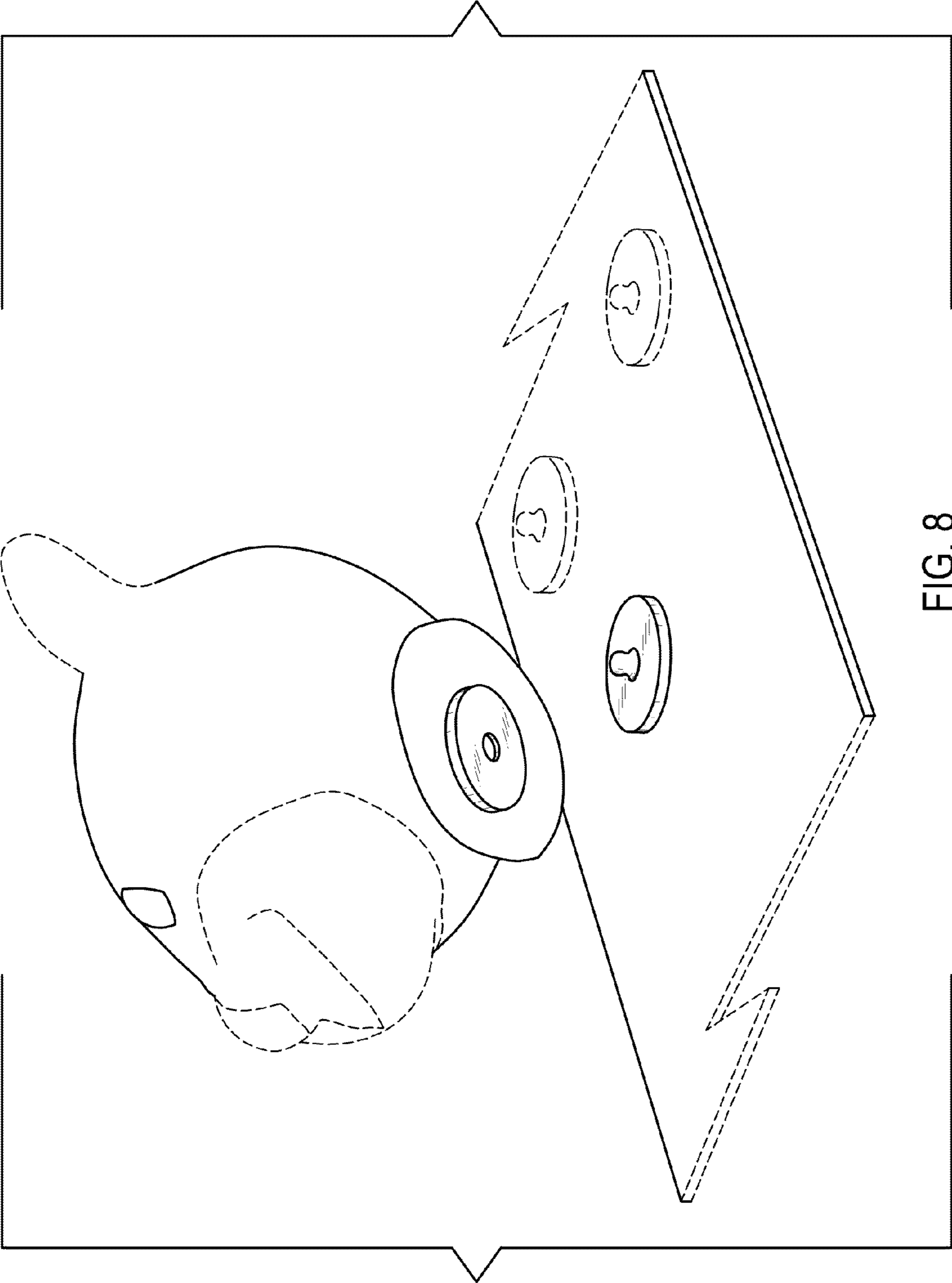
