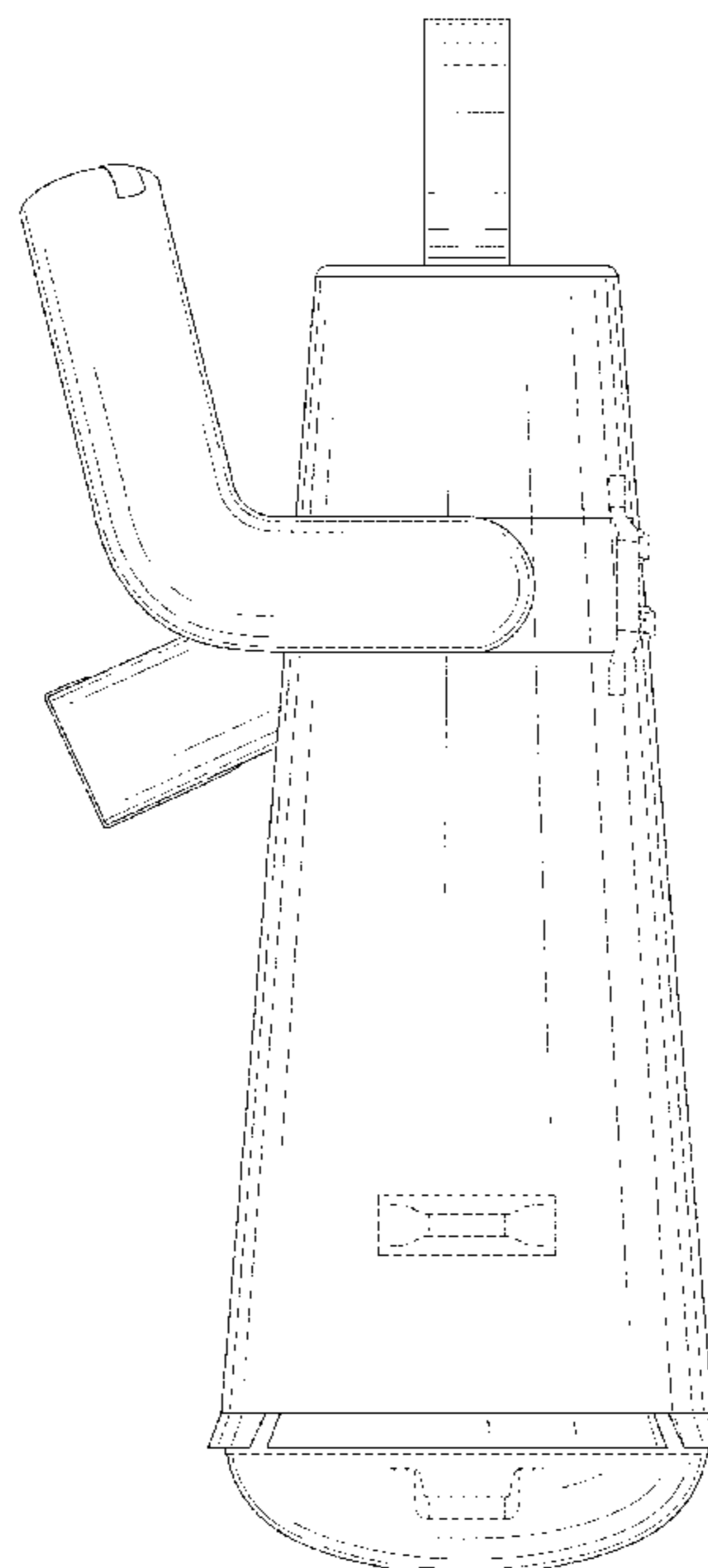
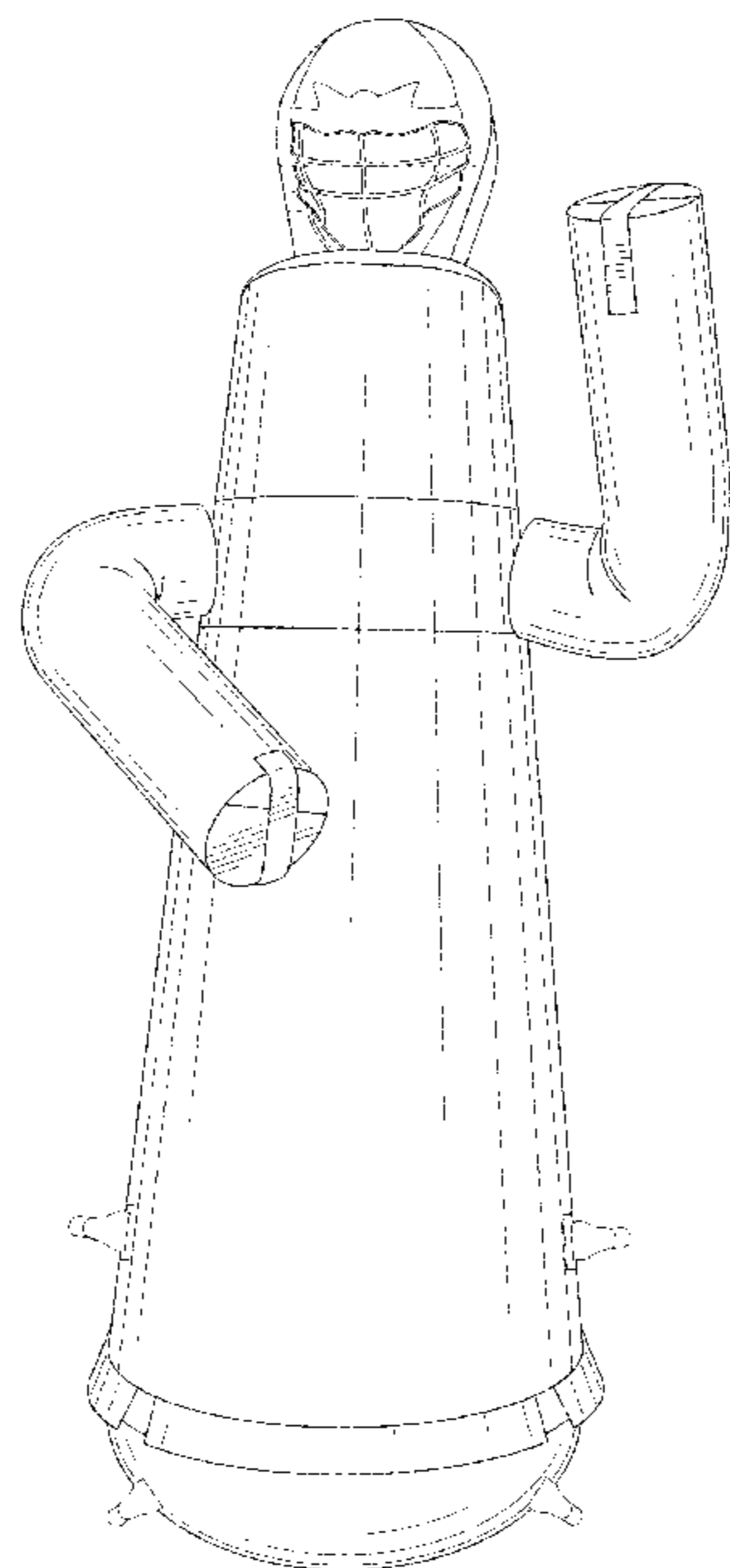
The ornamental design for a checking dummy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the checking dummy showing our new design;
FIG. 2 is a front elevation view thereof;

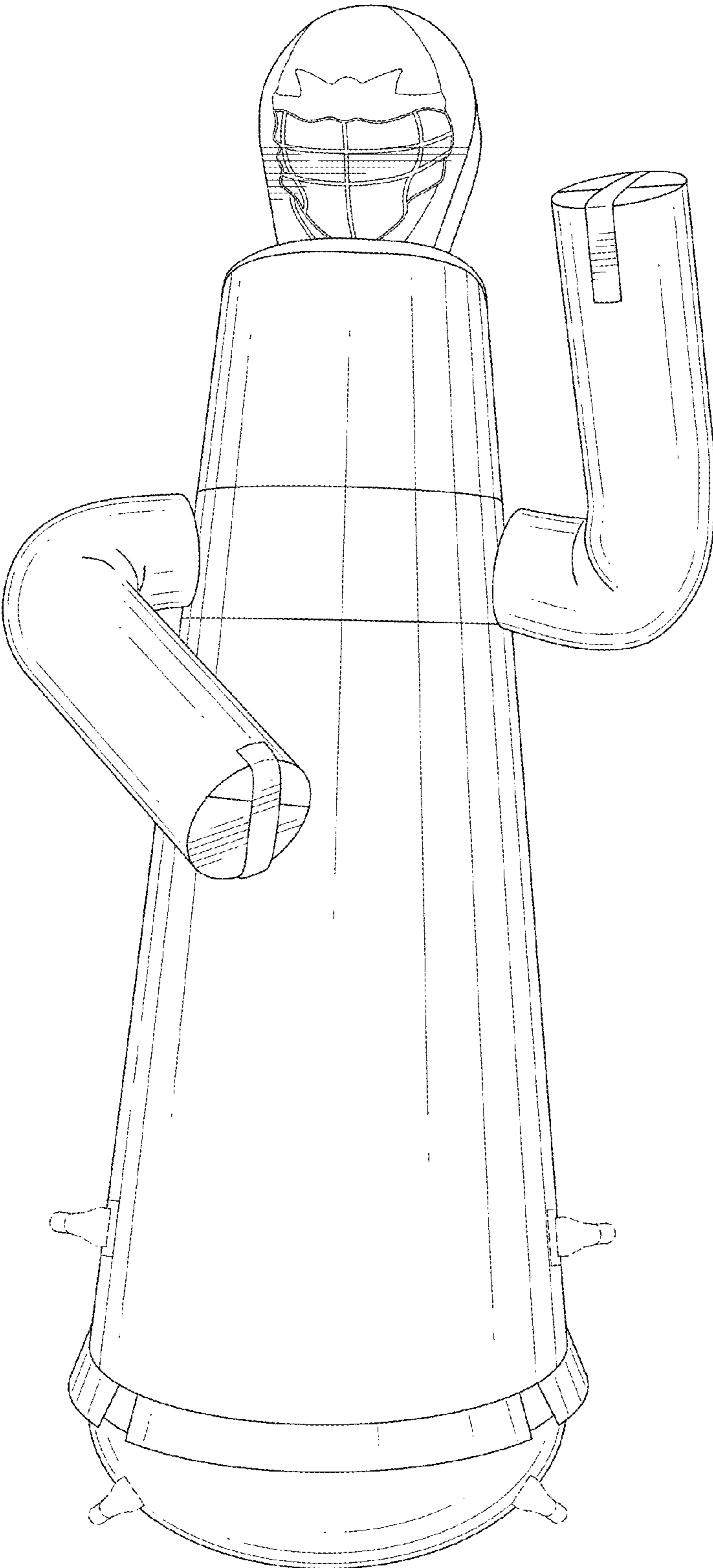

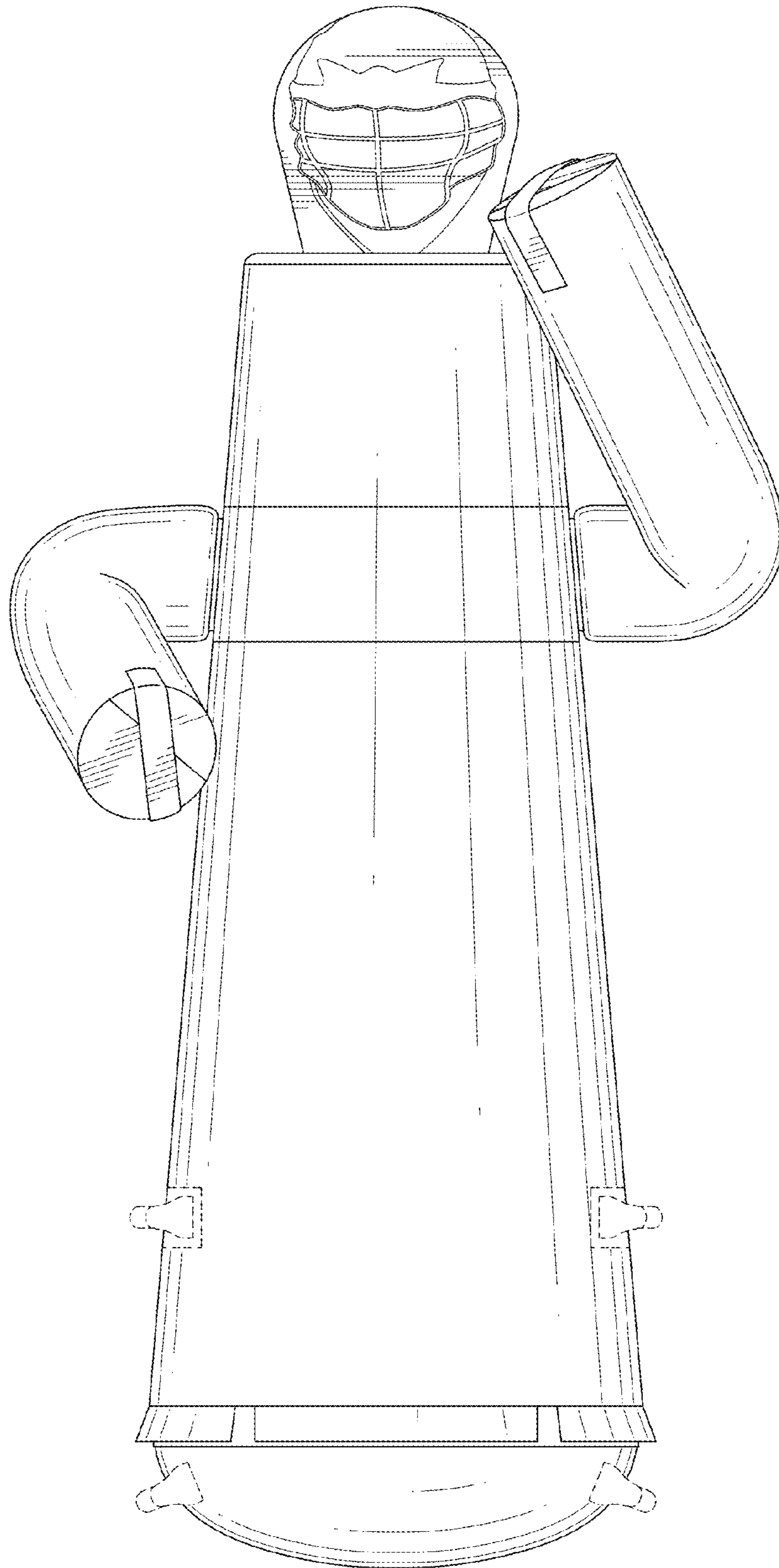

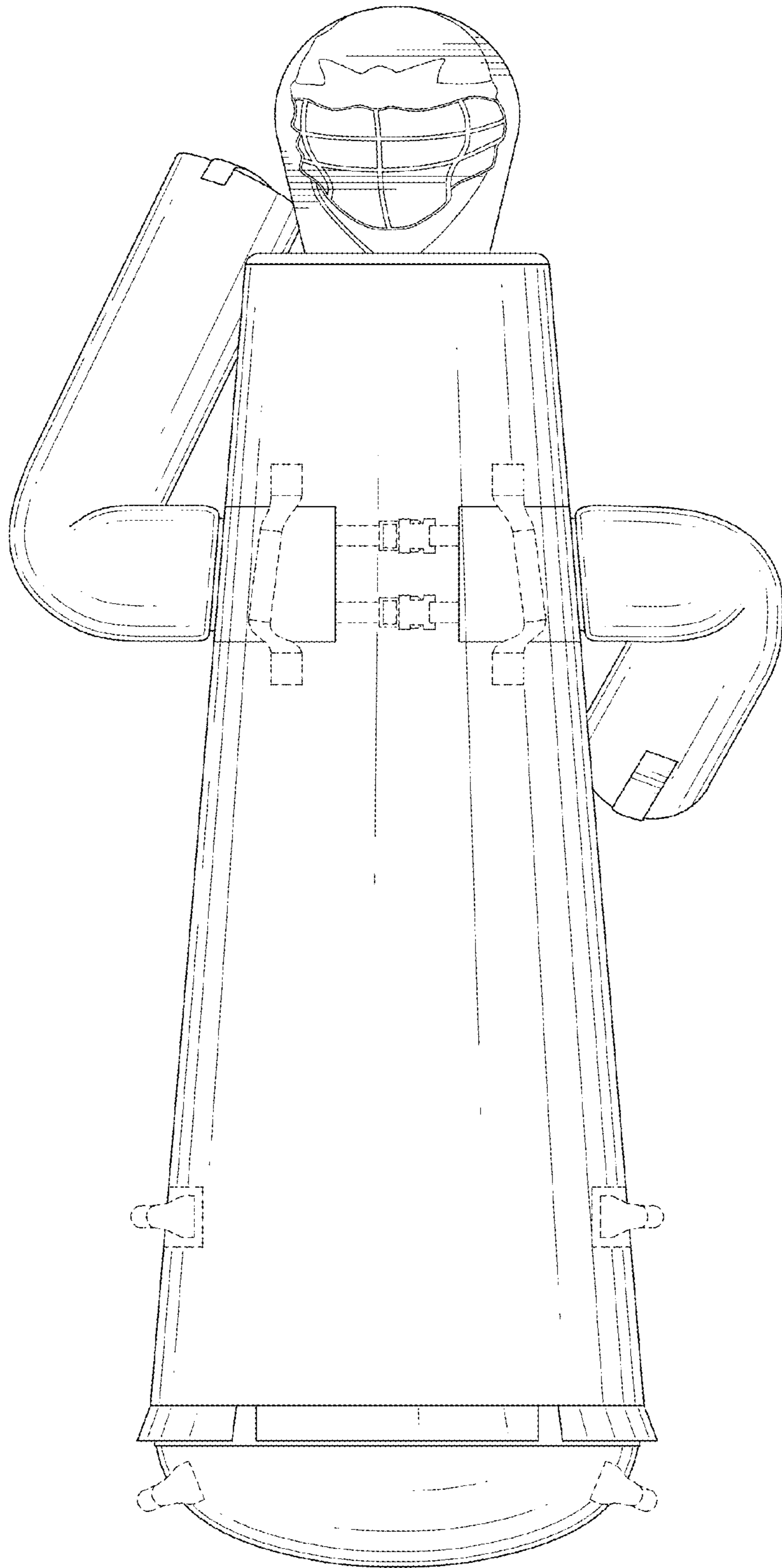

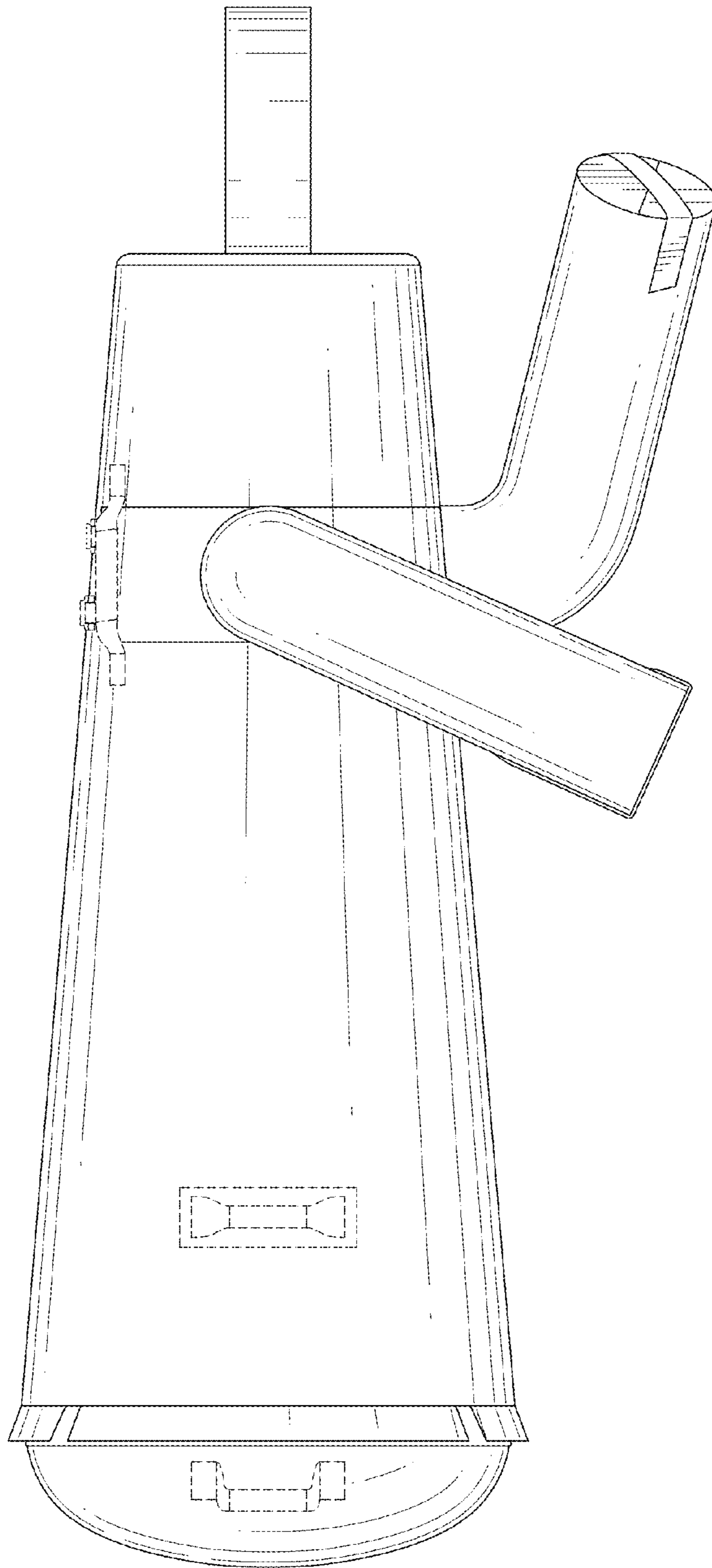

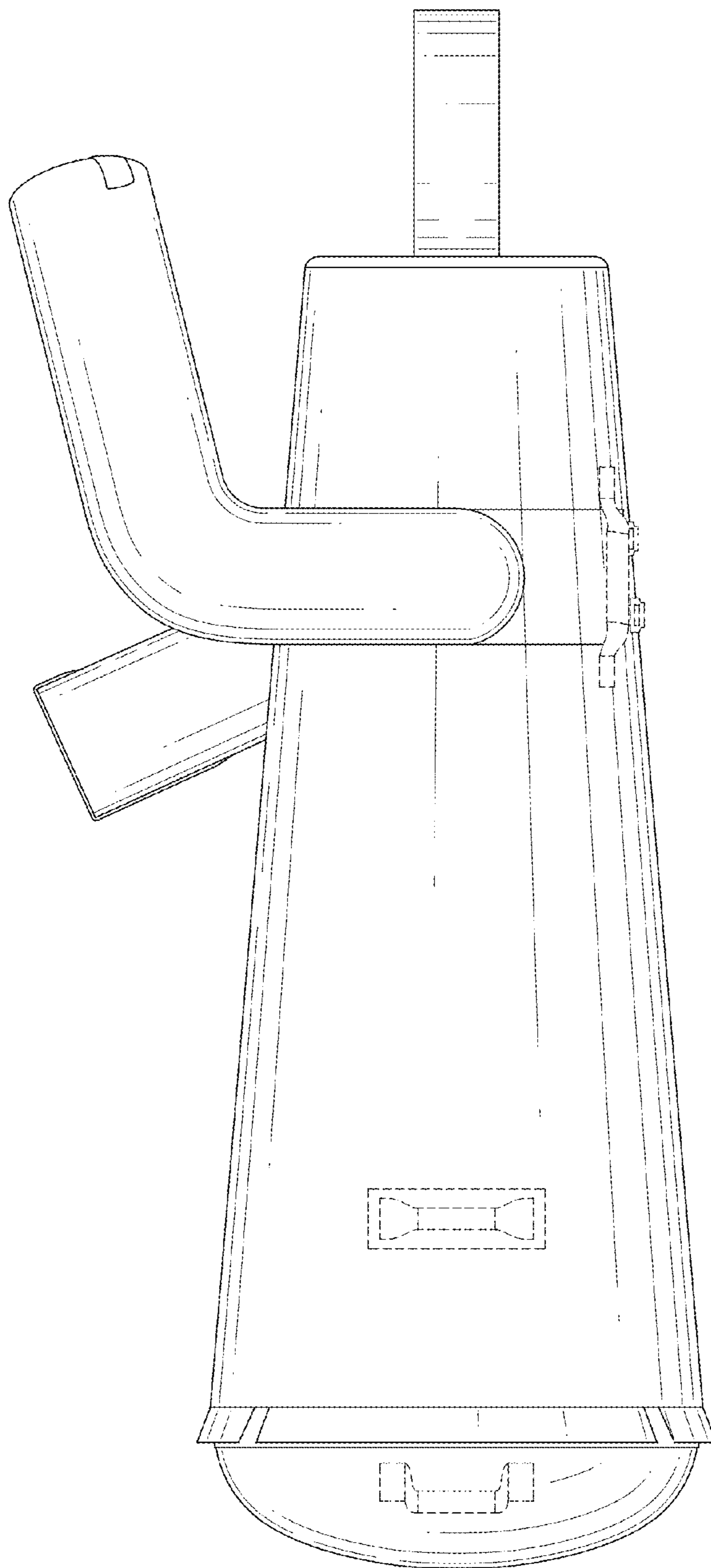

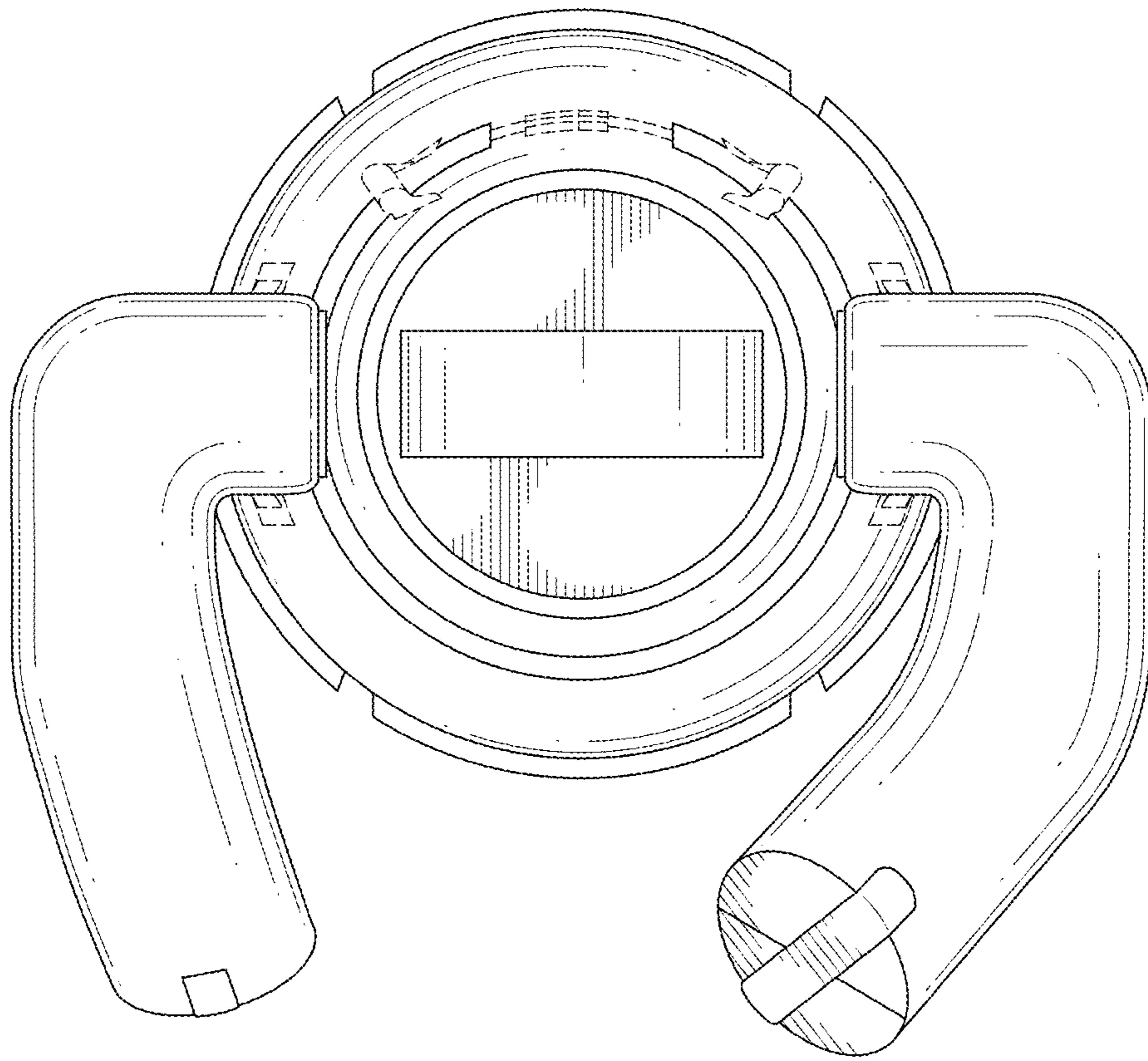

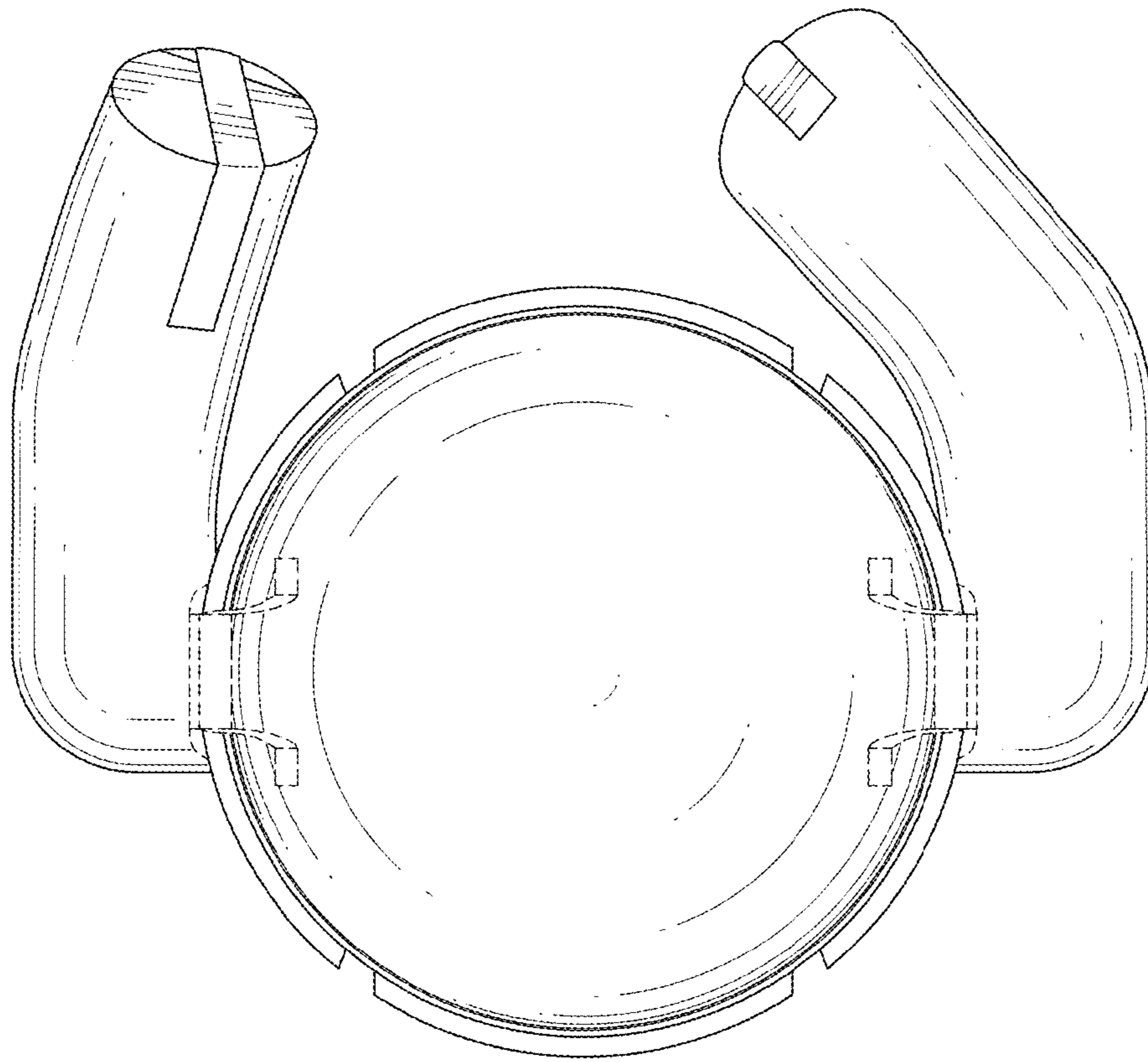
