(57) **CLAIM**

The ornamental design for a gutter outlet for downspout, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a gutter outlet for downspout, the opposite side being a mirror image thereof;

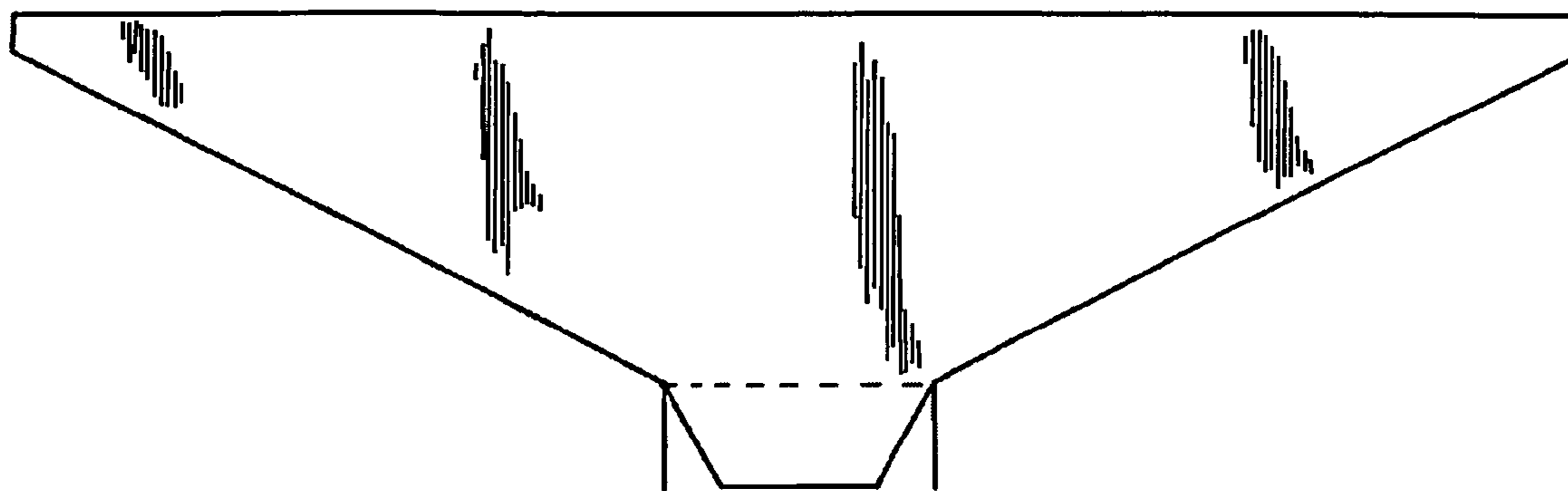
FIG. 2 is a top plan view thereof;

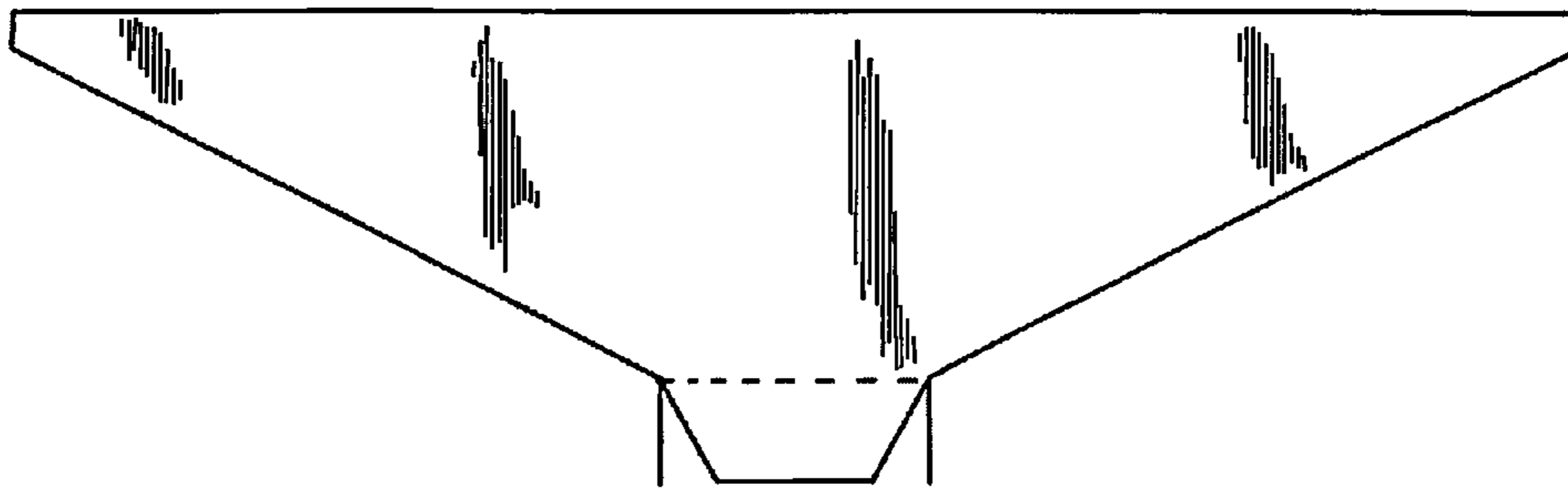

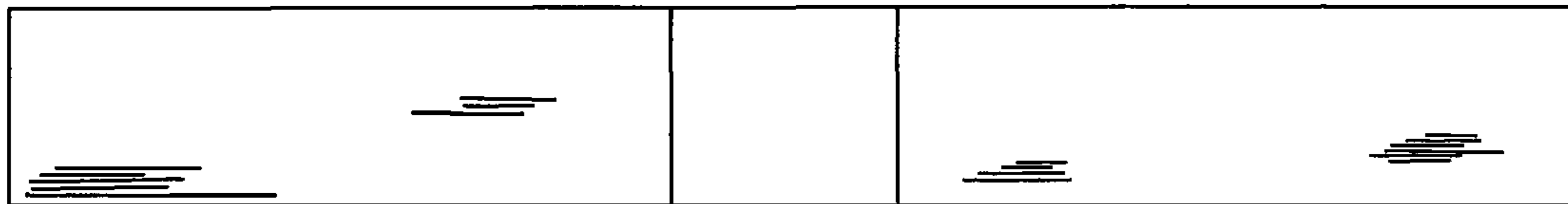

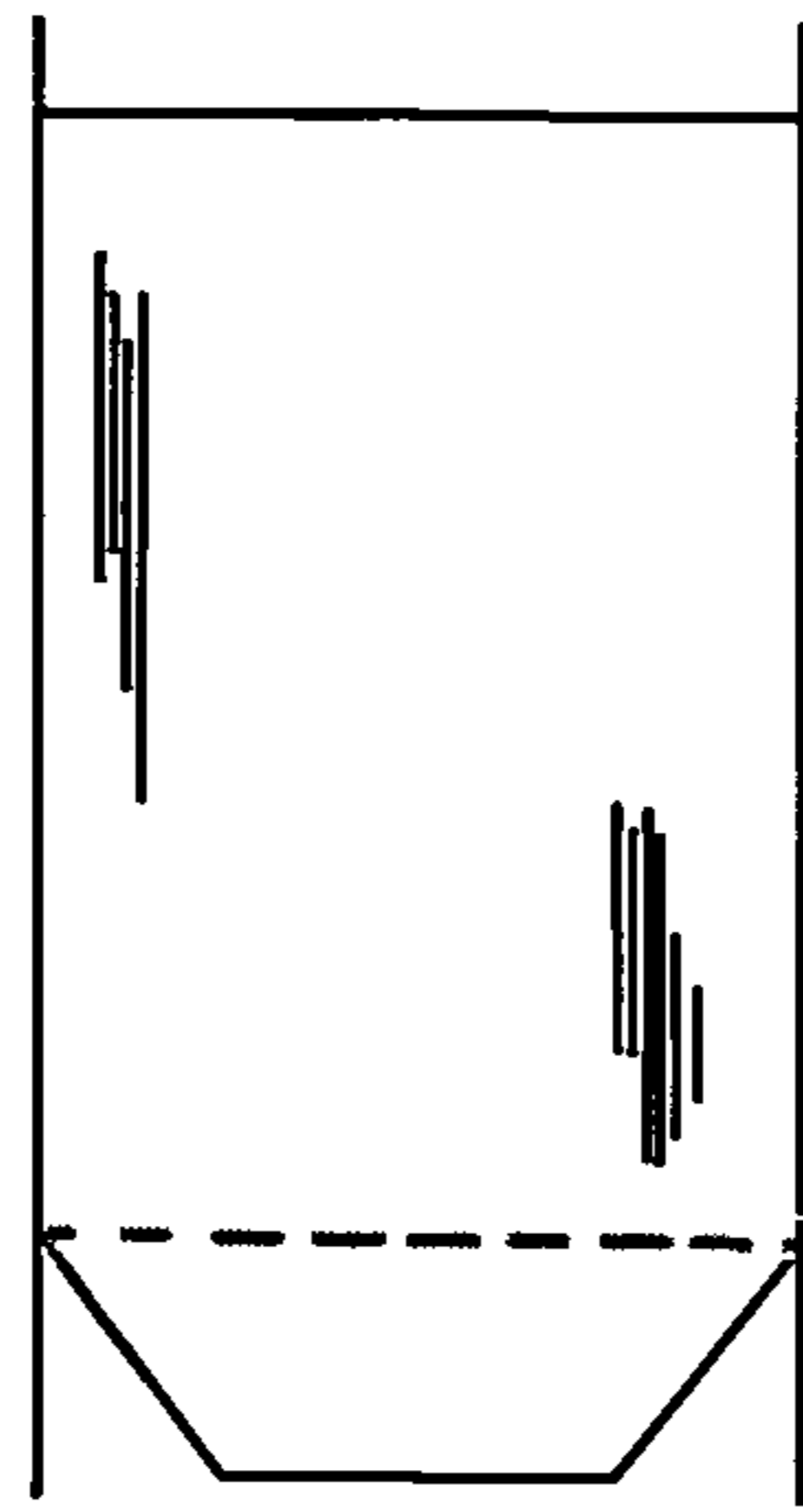
