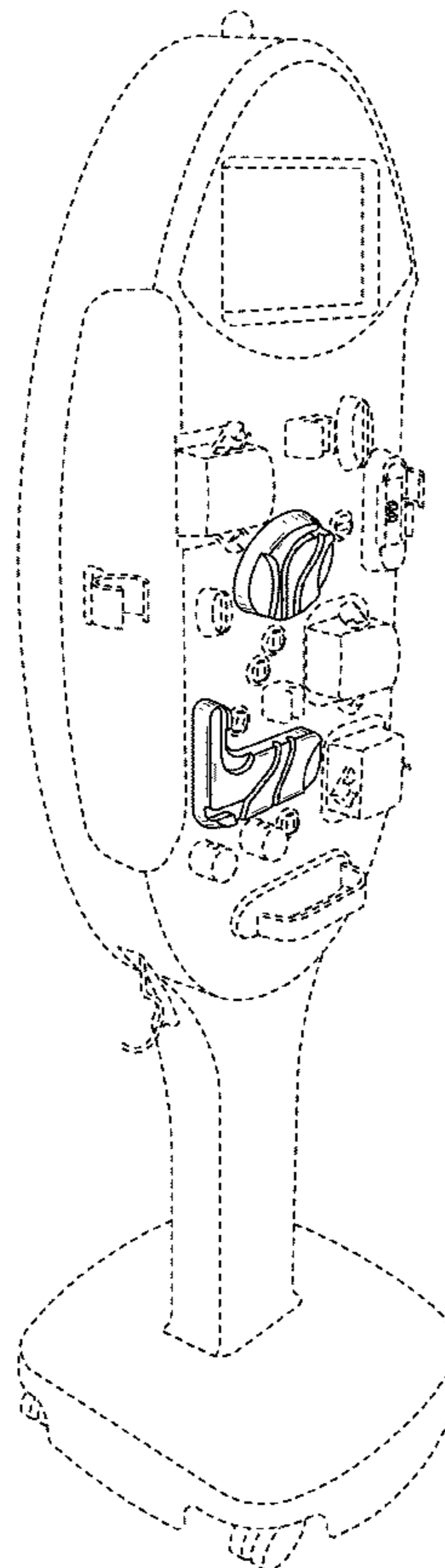
The ornamental design for a therapeutic apheresis system, as

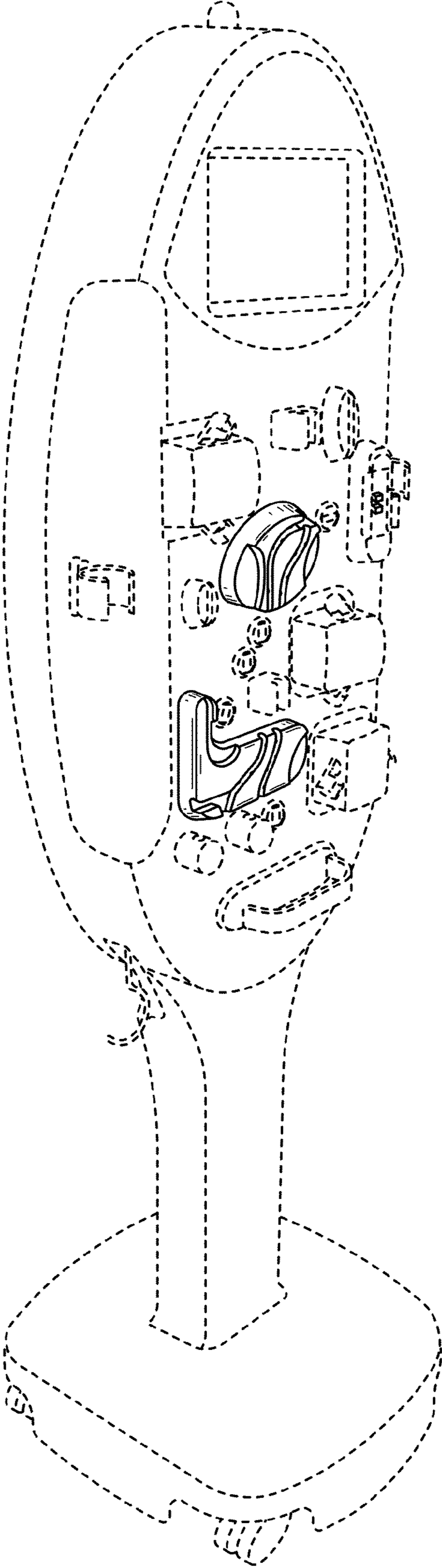

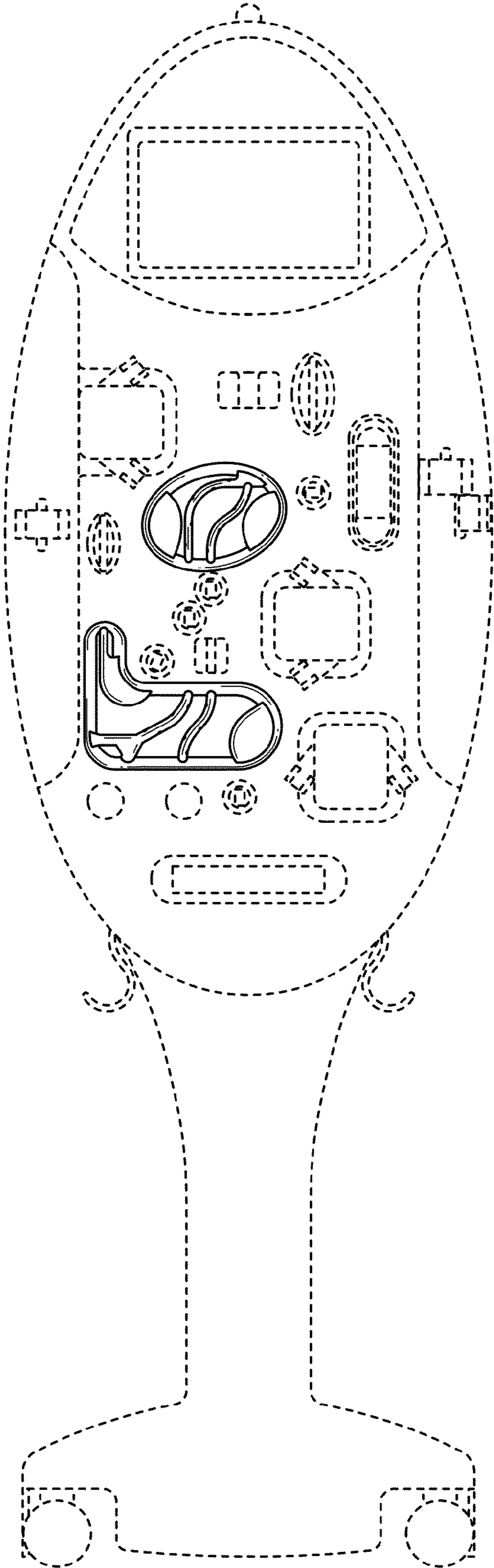

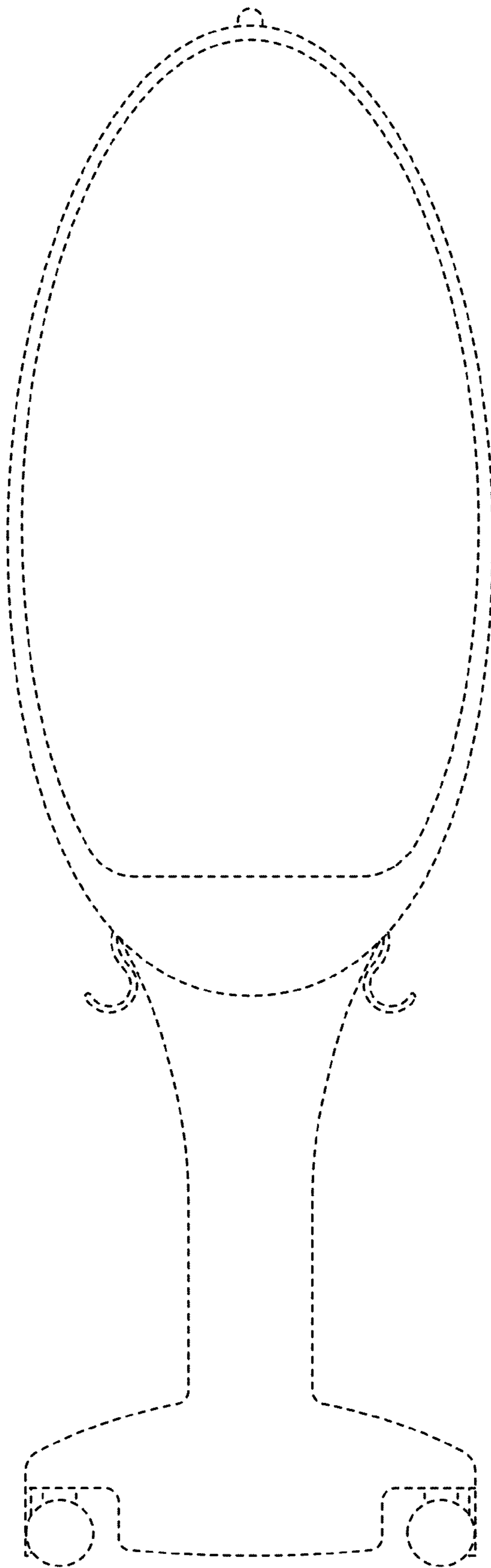

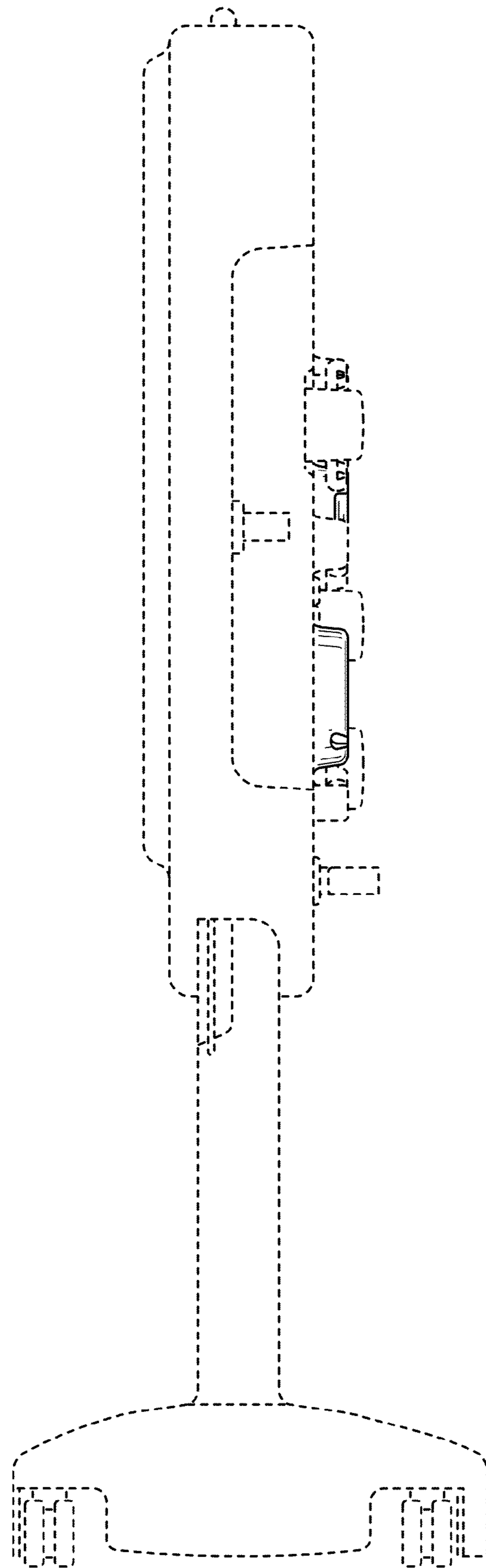

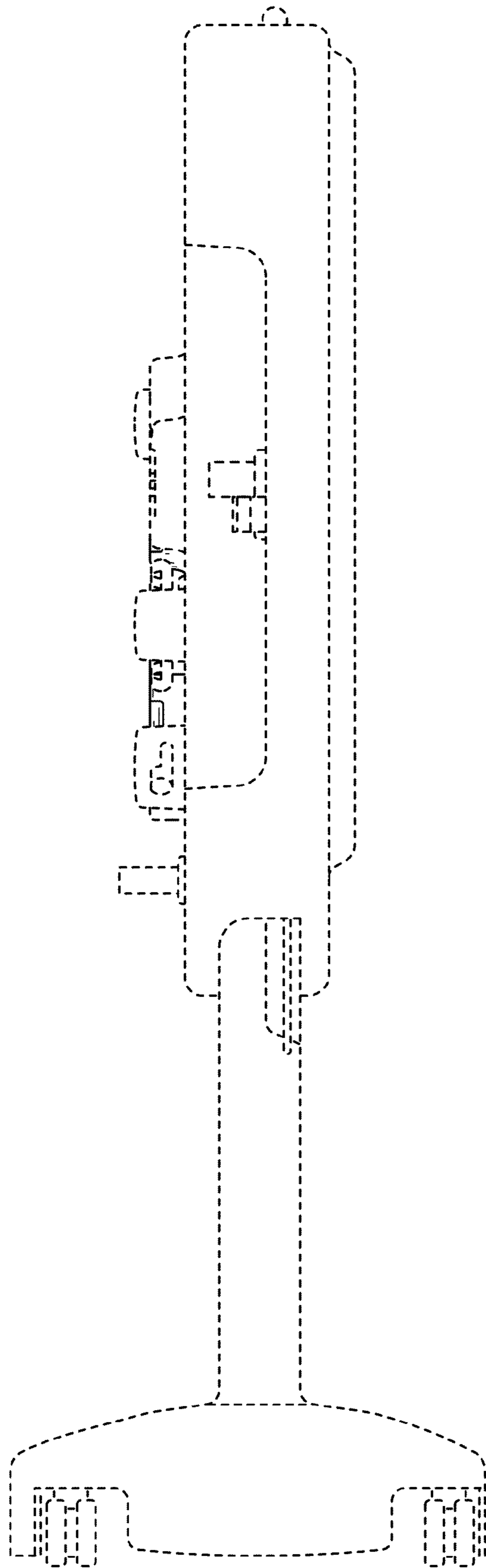

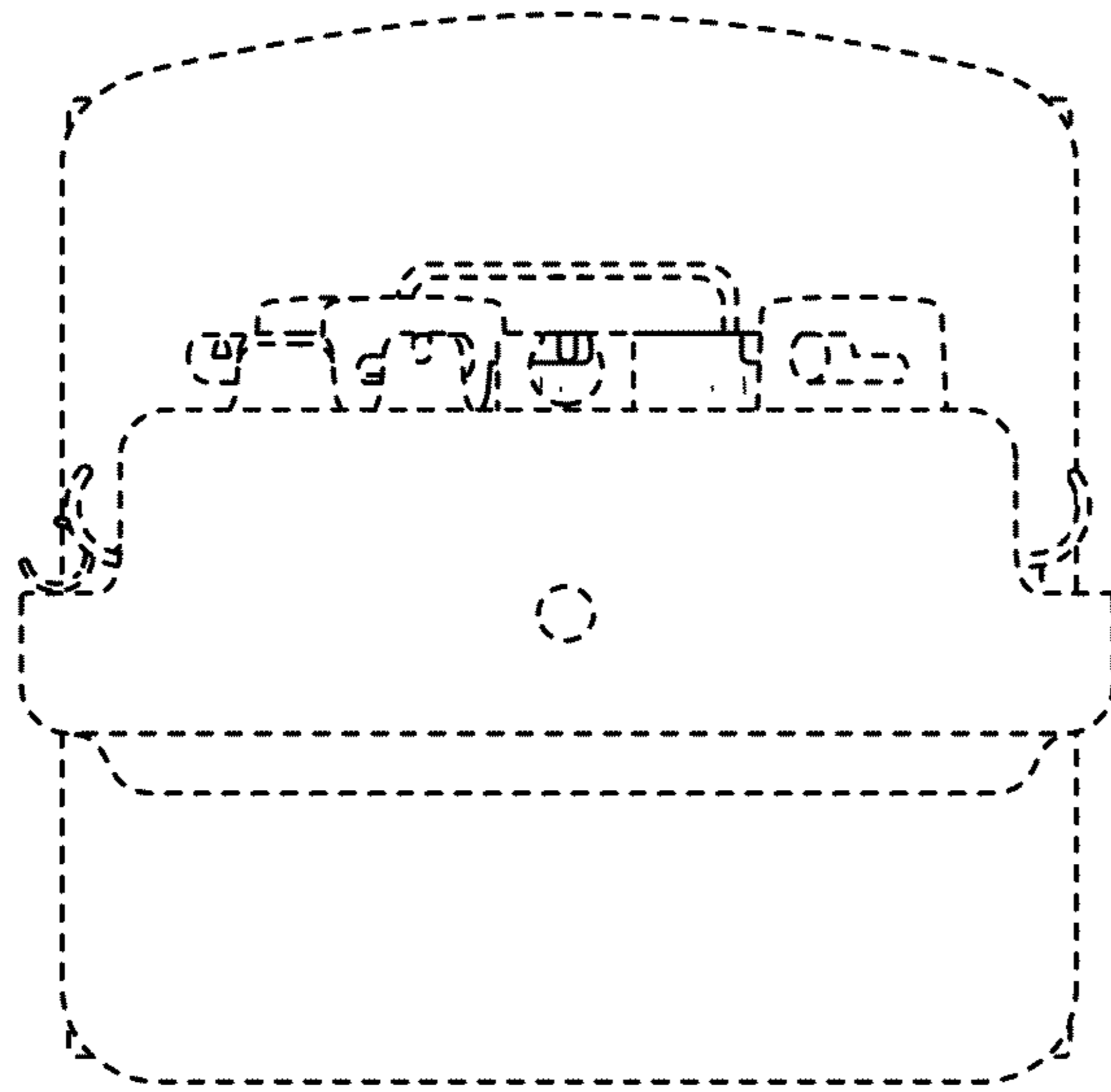

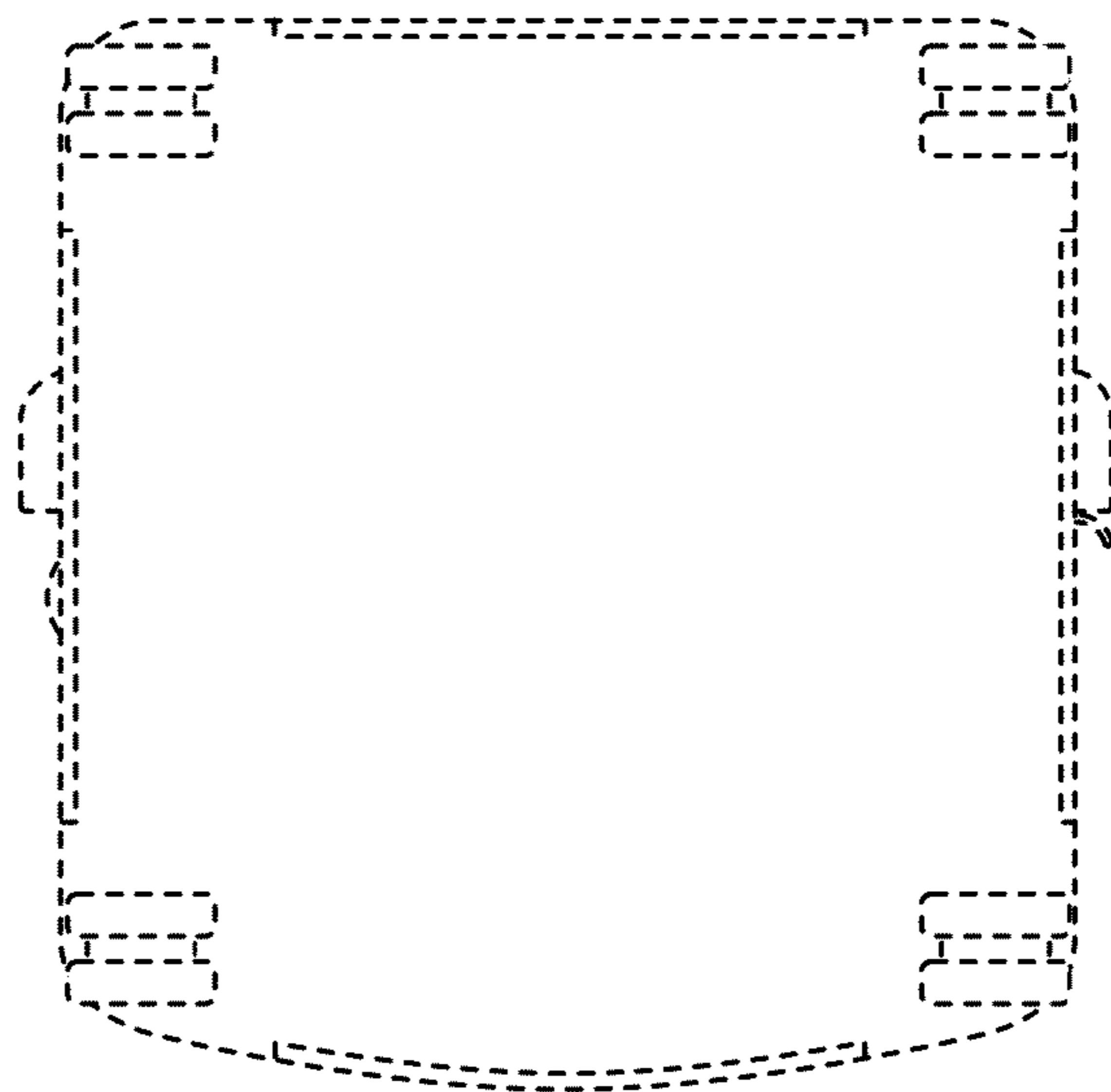
