(57) **CLAIM**

The ornamental design for a pair of eyelash stickers, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a pair of eyelash stickers showing my new design.

FIG. 2 is a top plan view of a second embodiment of a pair of eyelash stickers.

FIG. 3 is a front elevation view showing an environmental application of one of the pair of eyelash stickers from the first embodiment.

FIG. 4 is a front elevation view showing an environmental application of one of the pair of eyelash stickers from the second embodiment and one of a pair of eyelash stickers from a third embodiment.

FIG. 5 is a top plan view showing the first embodiment on a sheet.

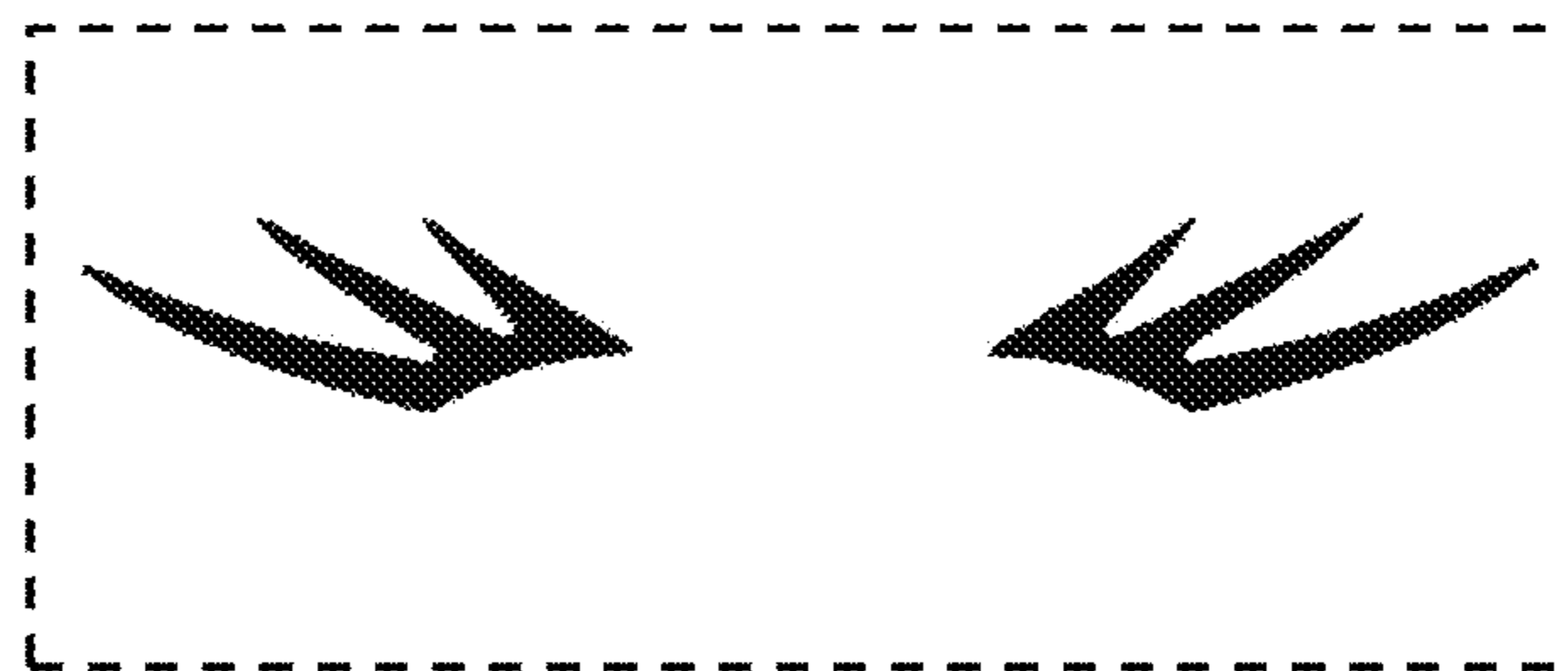
FIG. 6 is a top plan view showing the second embodiment on a sheet.

FIG. 7 is a top plan view showing the third embodiment on a sheet; and,

FIG. 8 is another top plan view showing the first embodiment on a sheet.

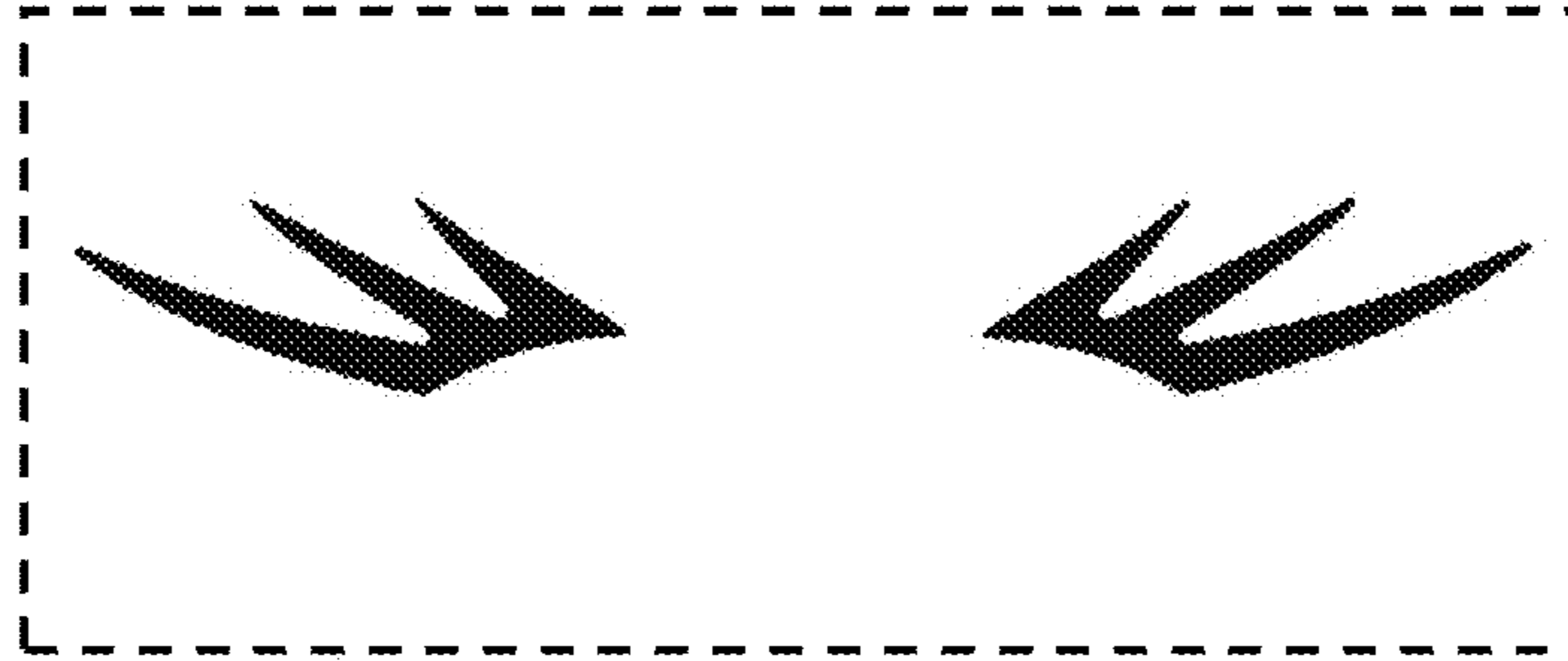

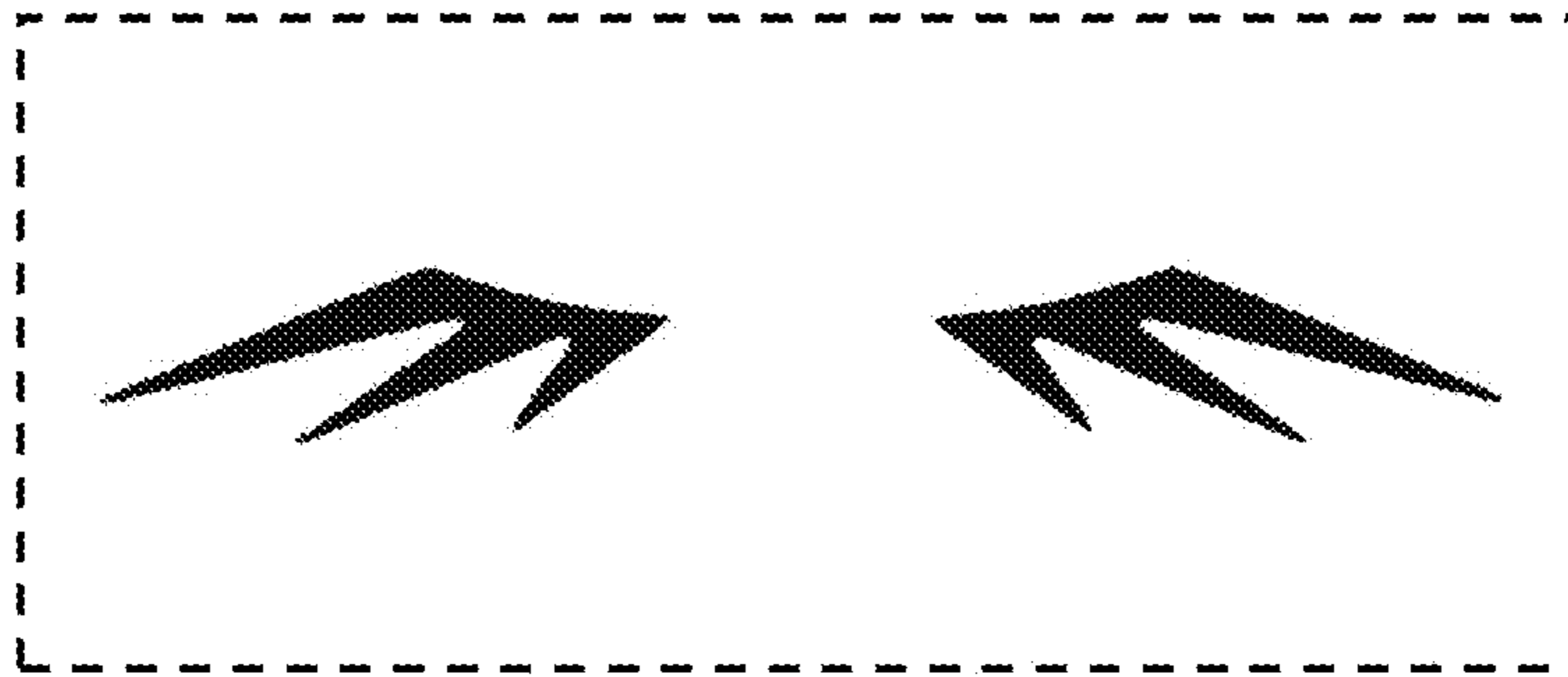

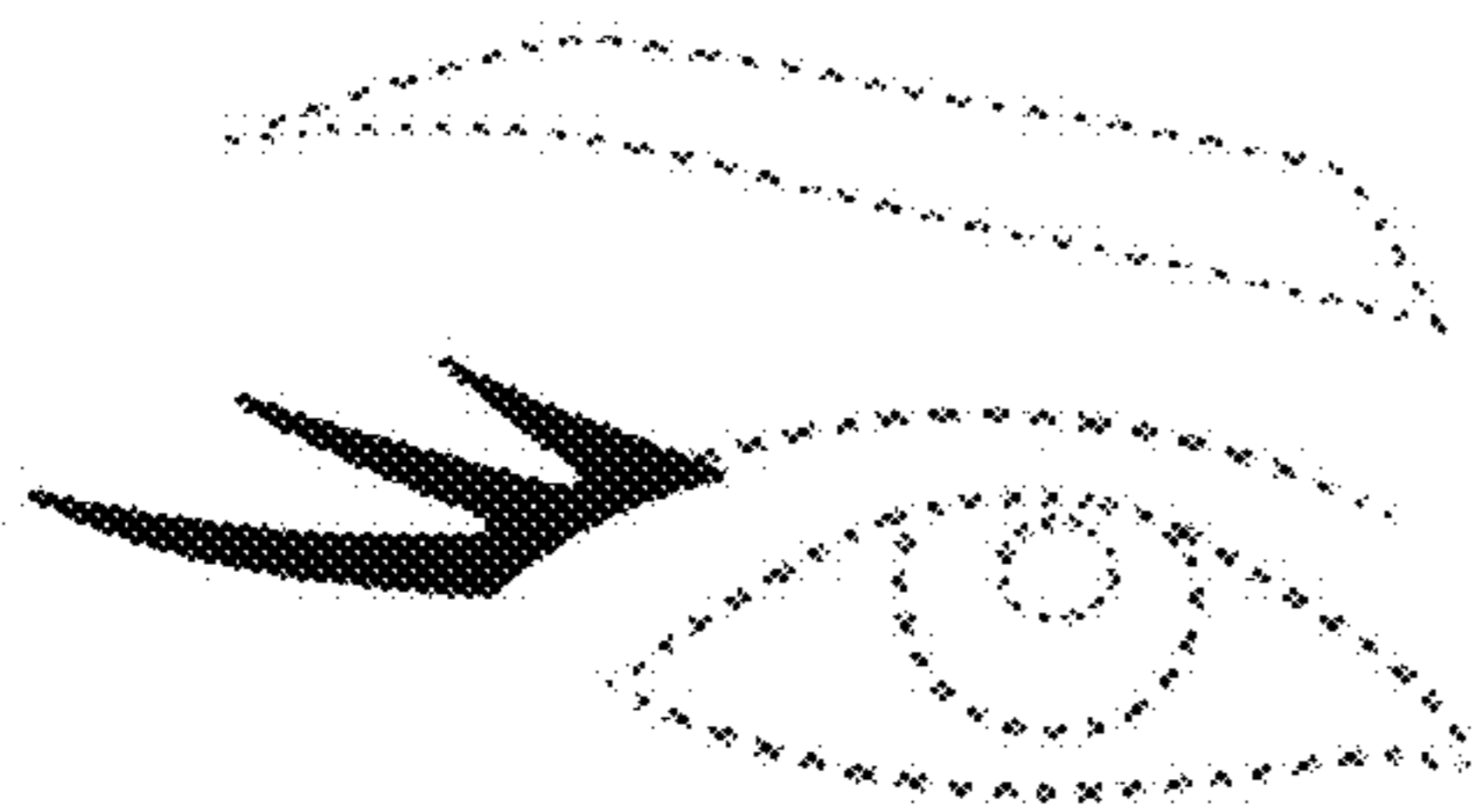

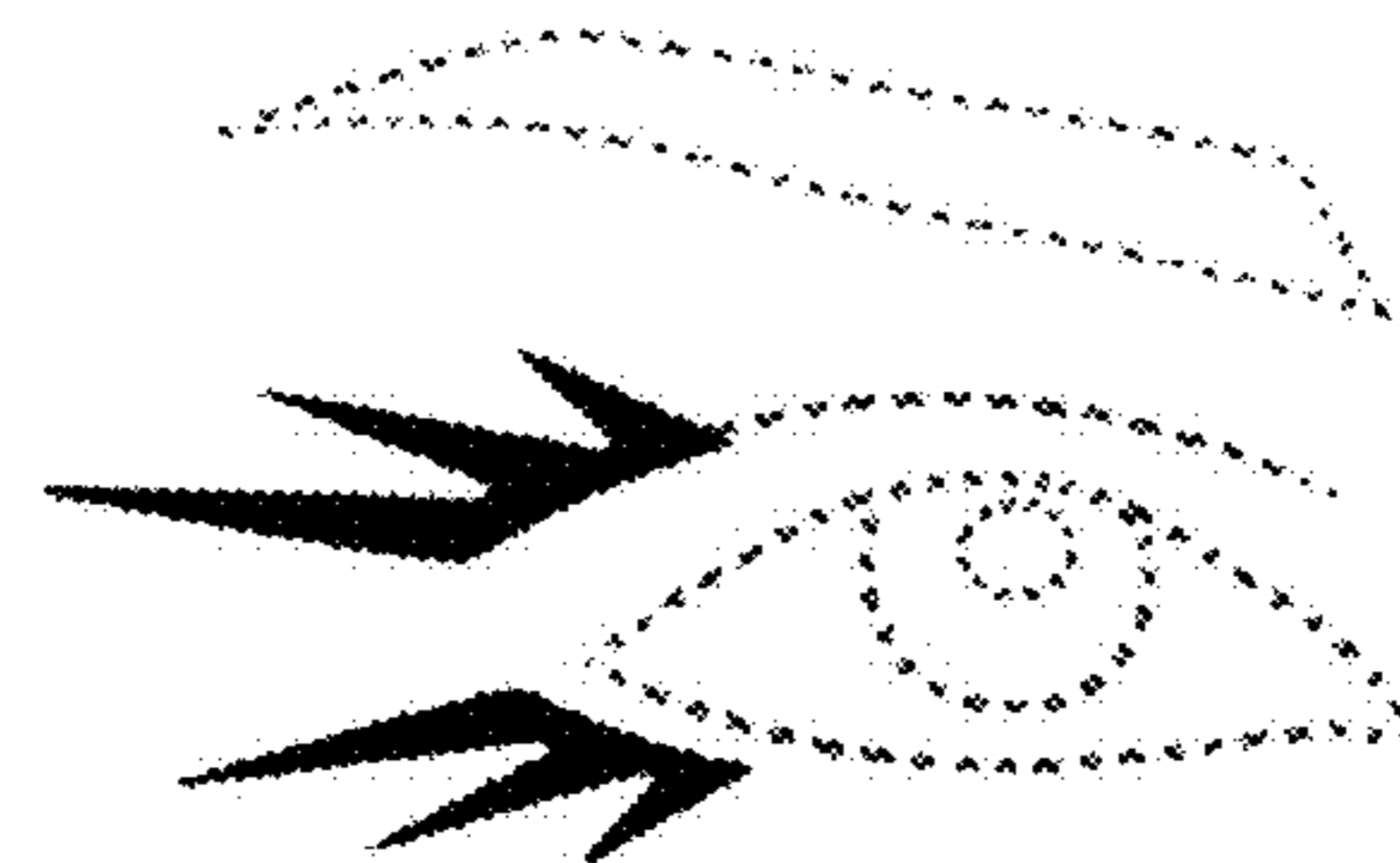

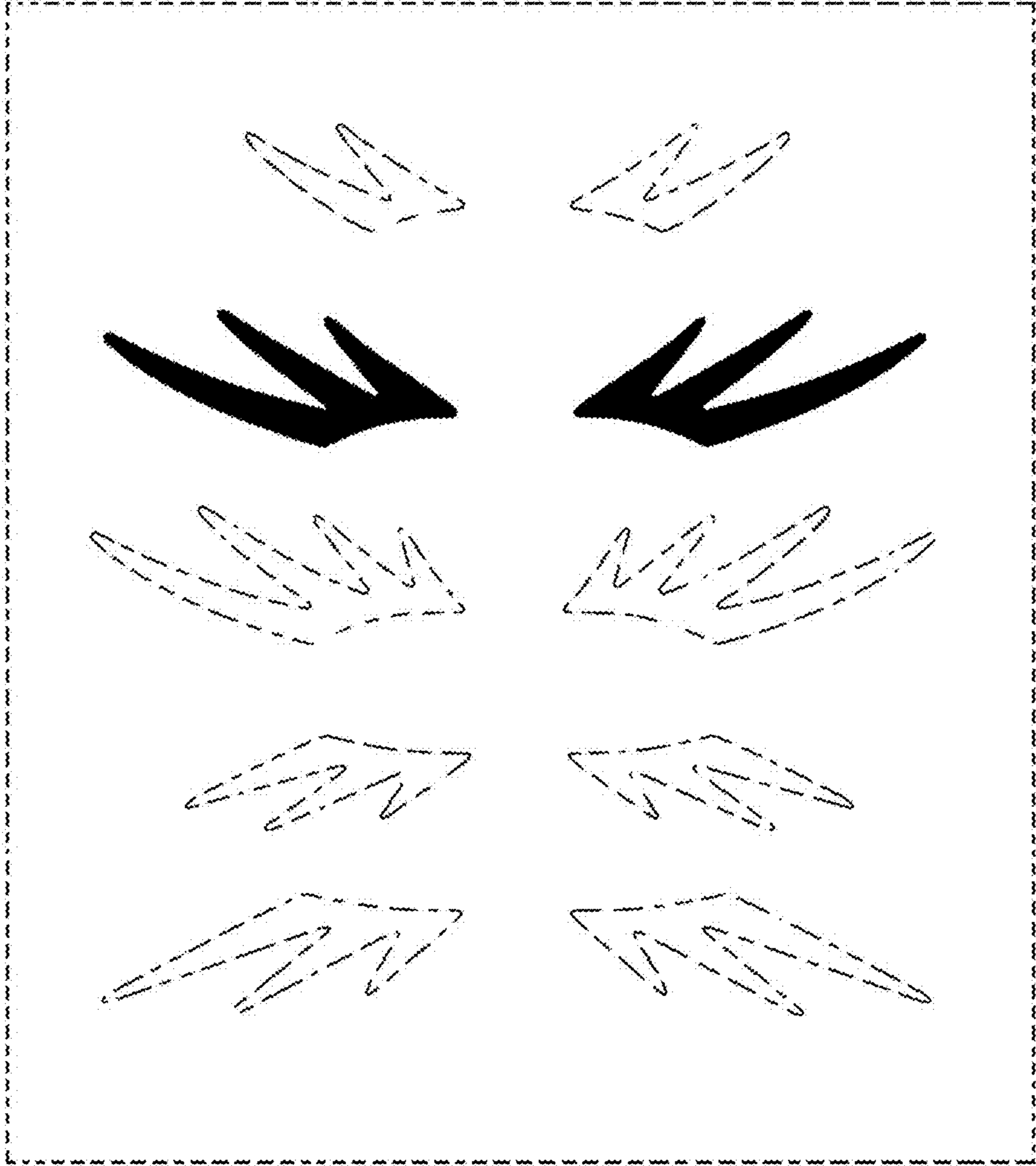

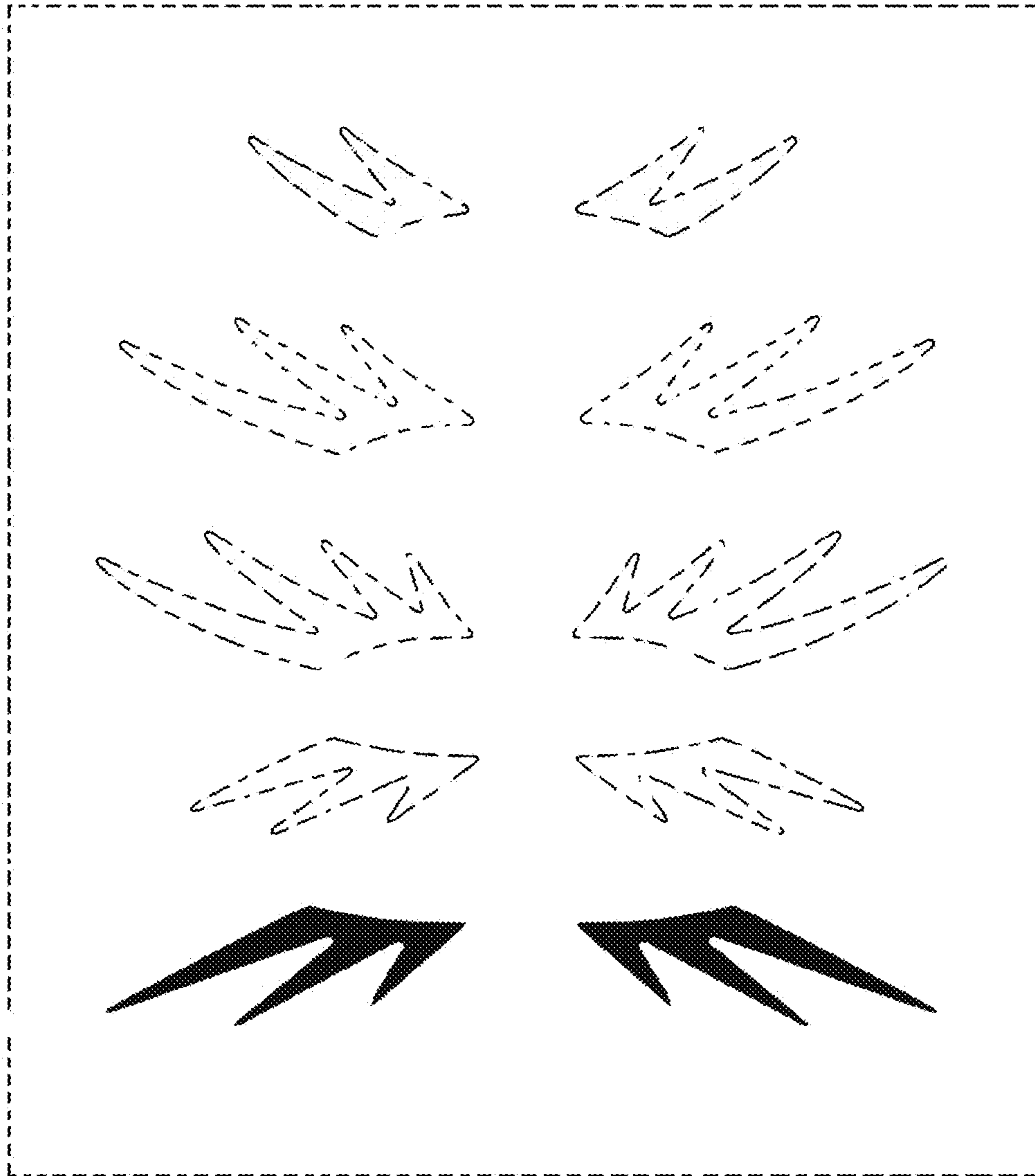

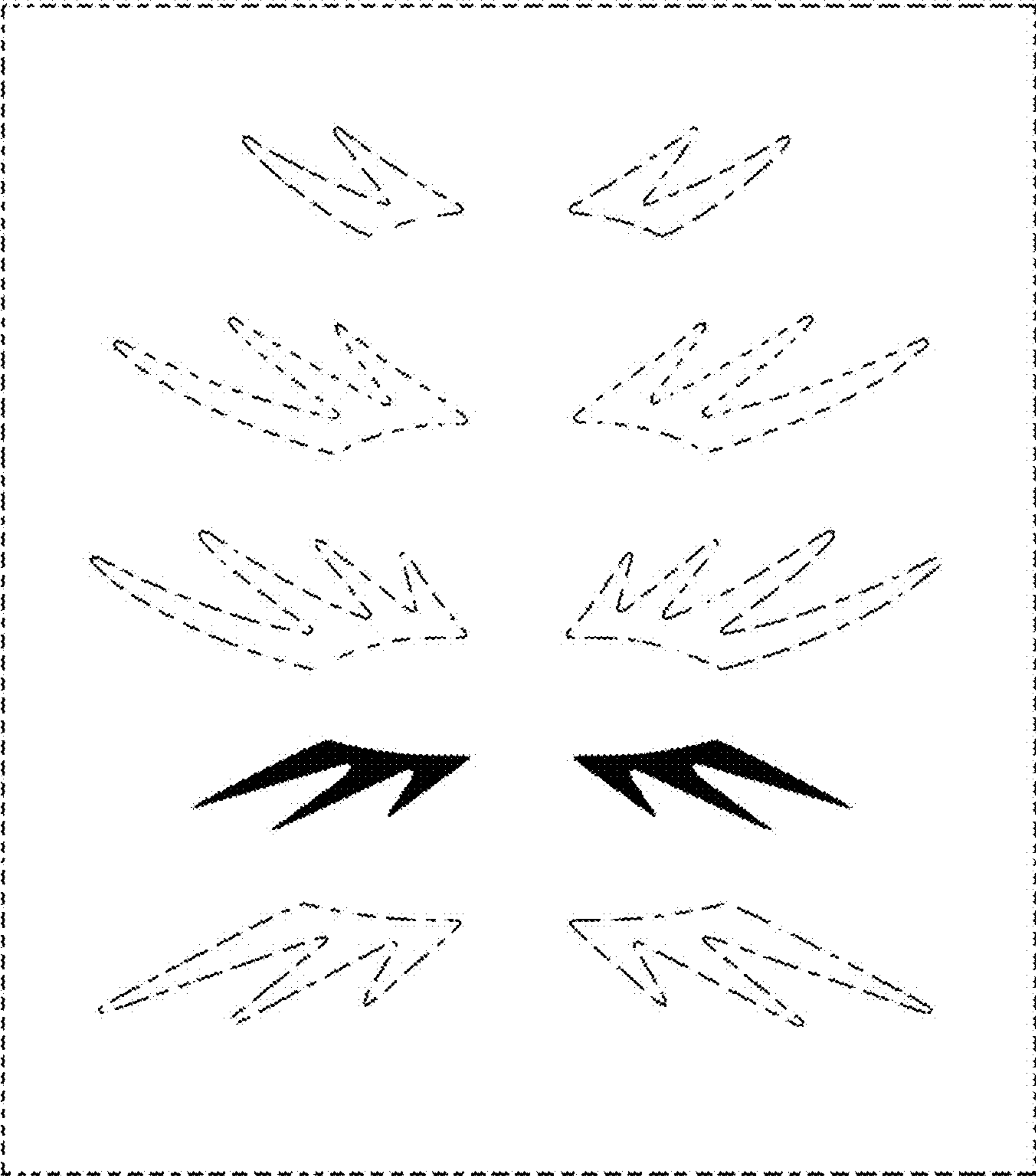

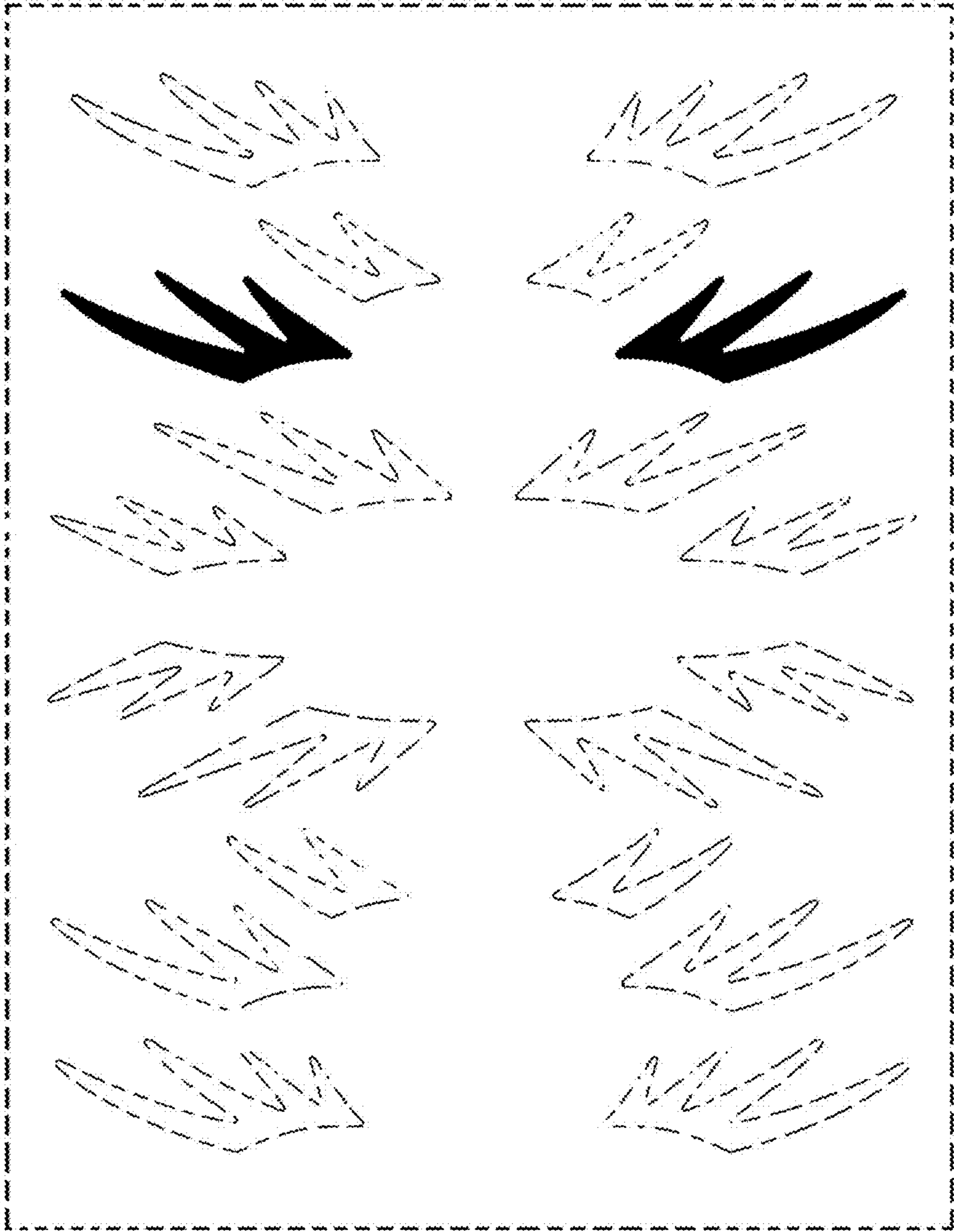
