I claim, the ornamental design for an undergarment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the invention;

FIG. 8 is a perspective view of a second embodiment of the invention;

FIG. 11 is a first side view of the embodiment of FIG. 8;

FIG. 12 is a second side view of the embodiment of FIG. 8;

FIG. 13 is a top view of the embodiment of FIG. 8; and,

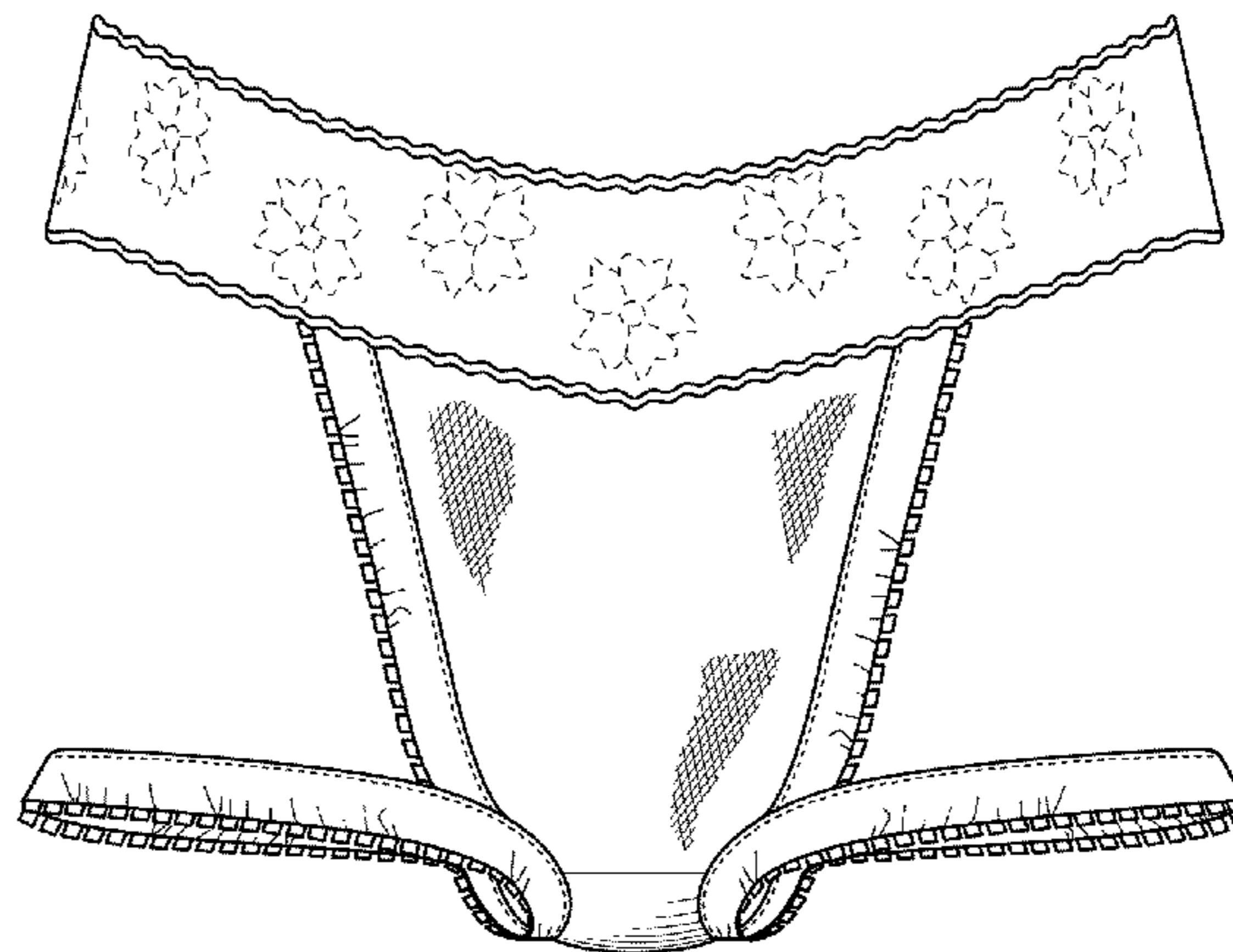
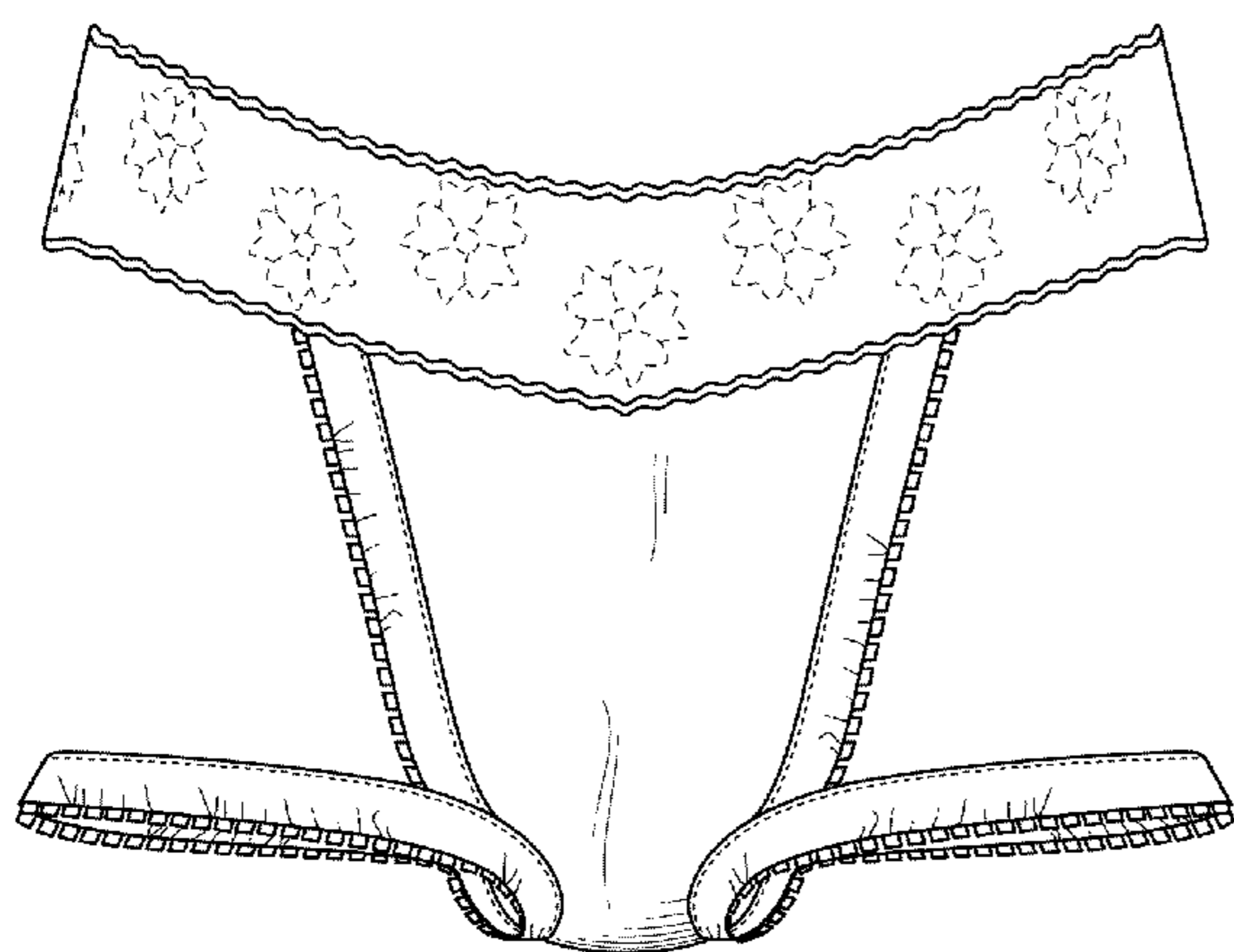
FIG. 14 is a bottom view of the embodiment of FIG. 8.

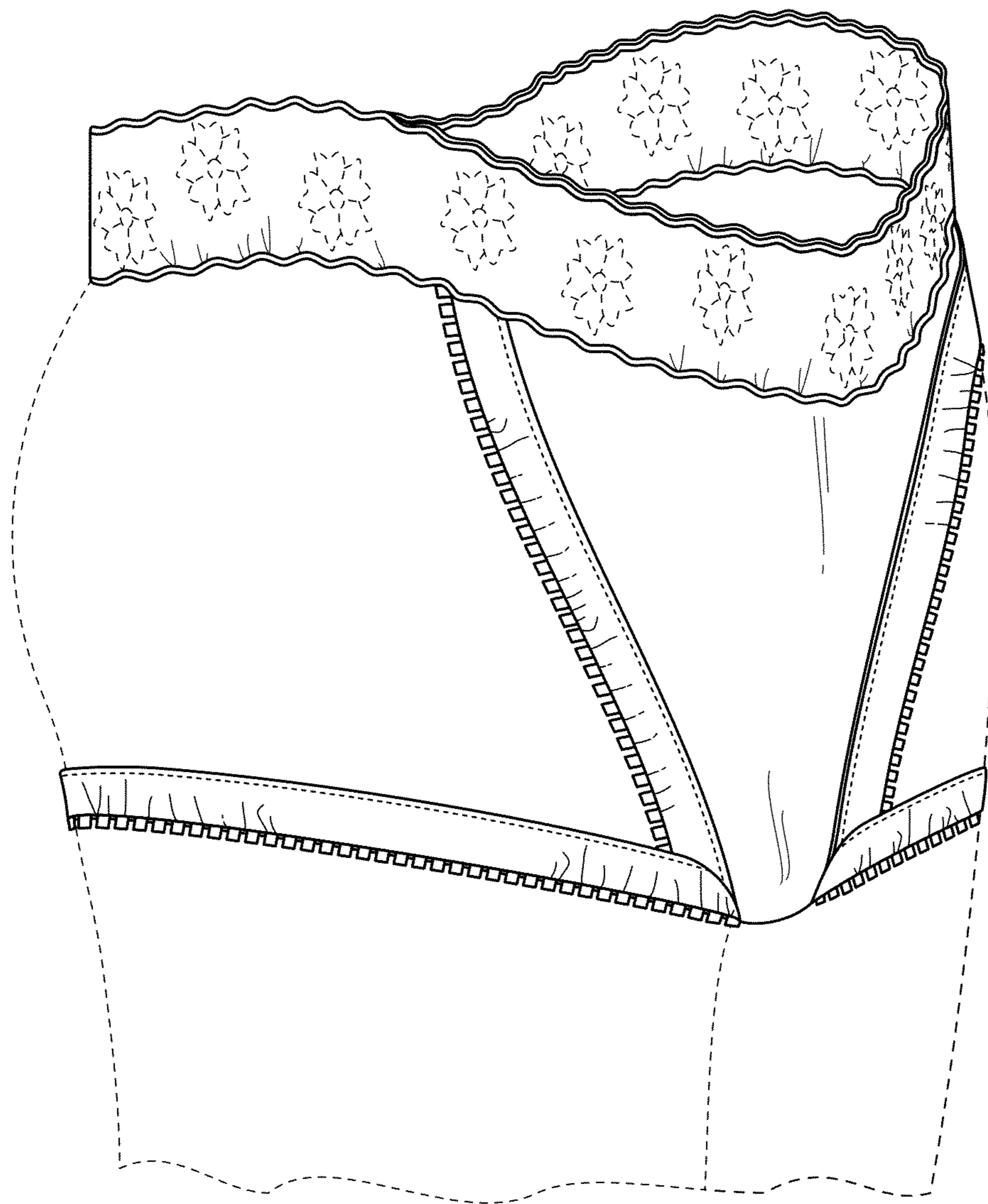

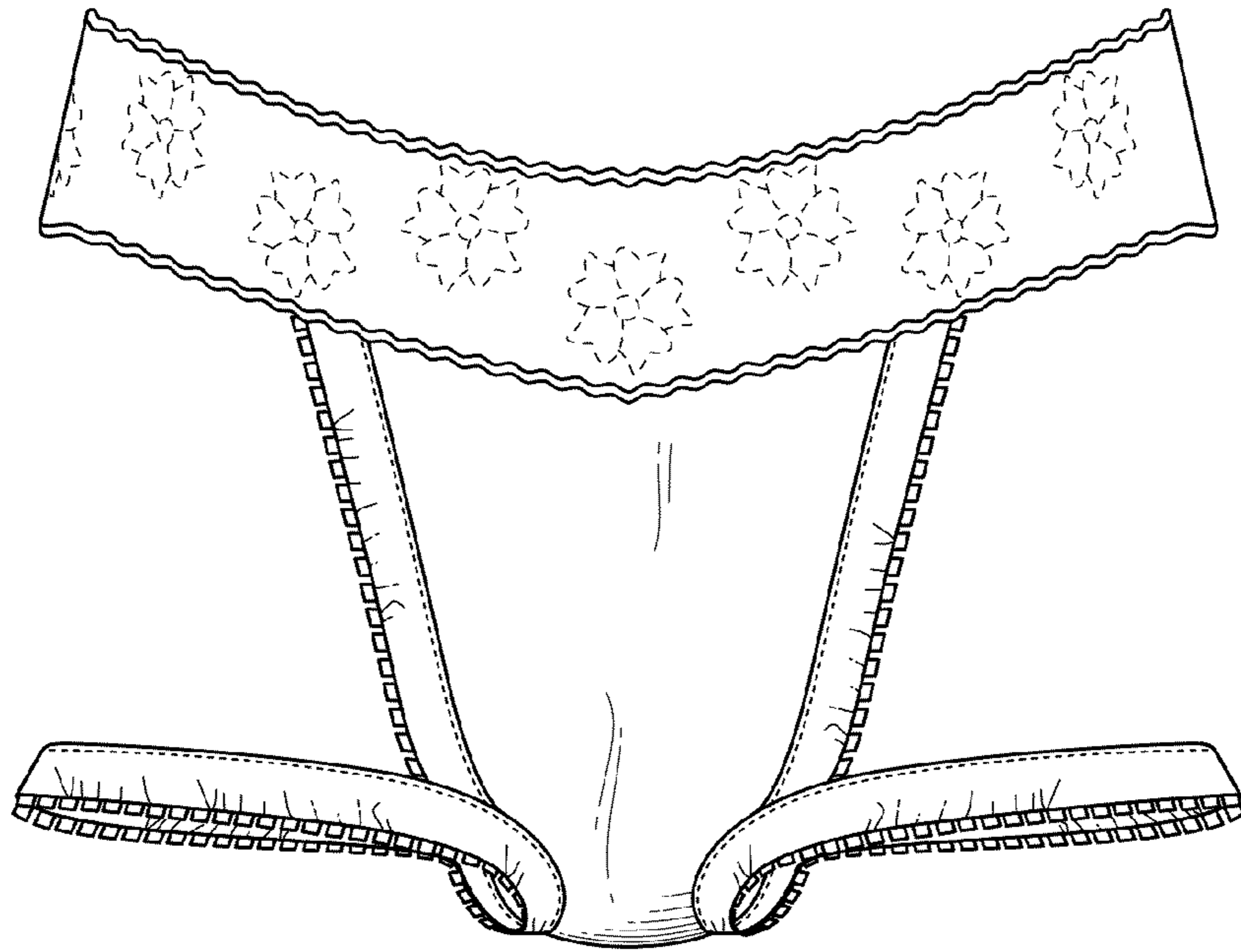

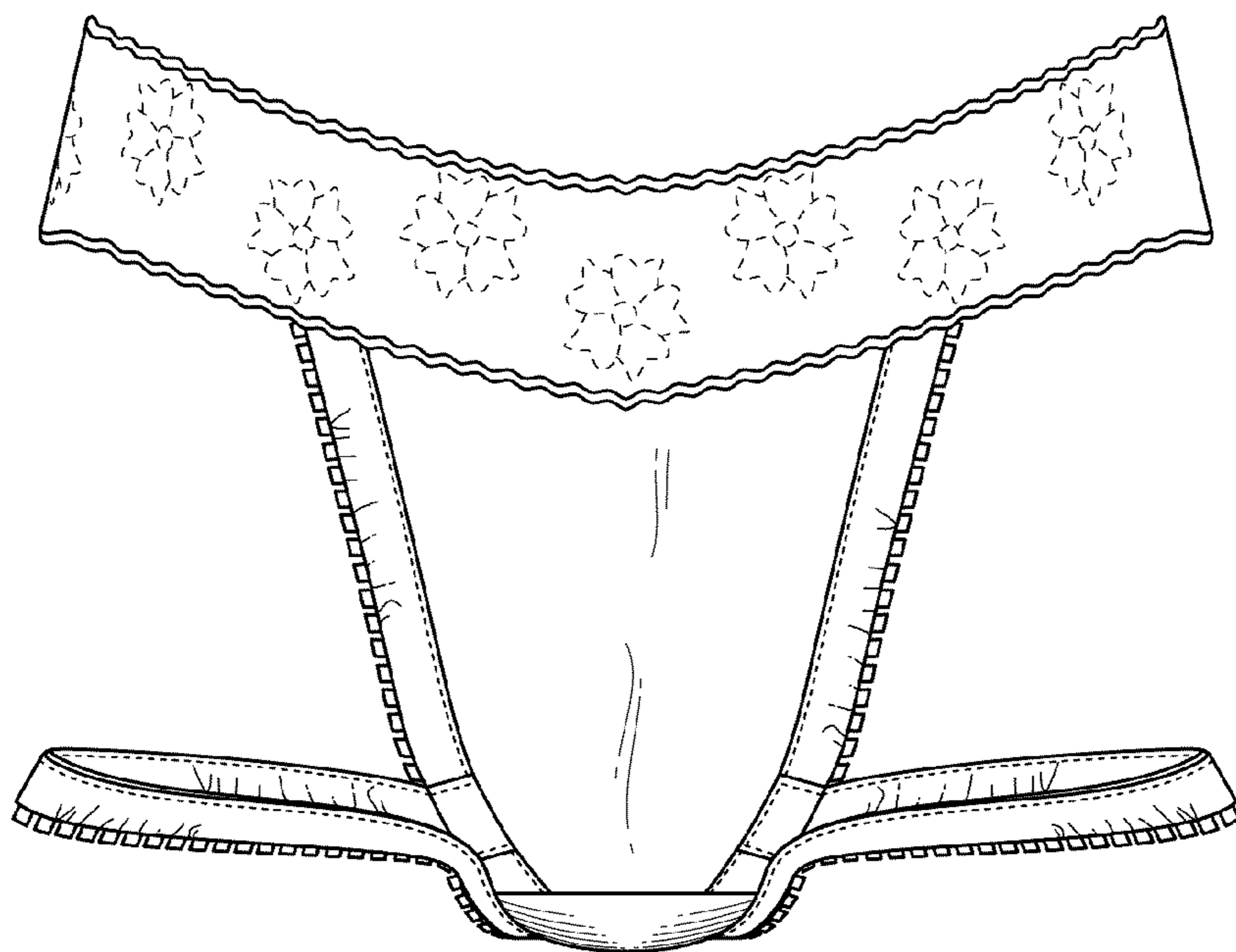

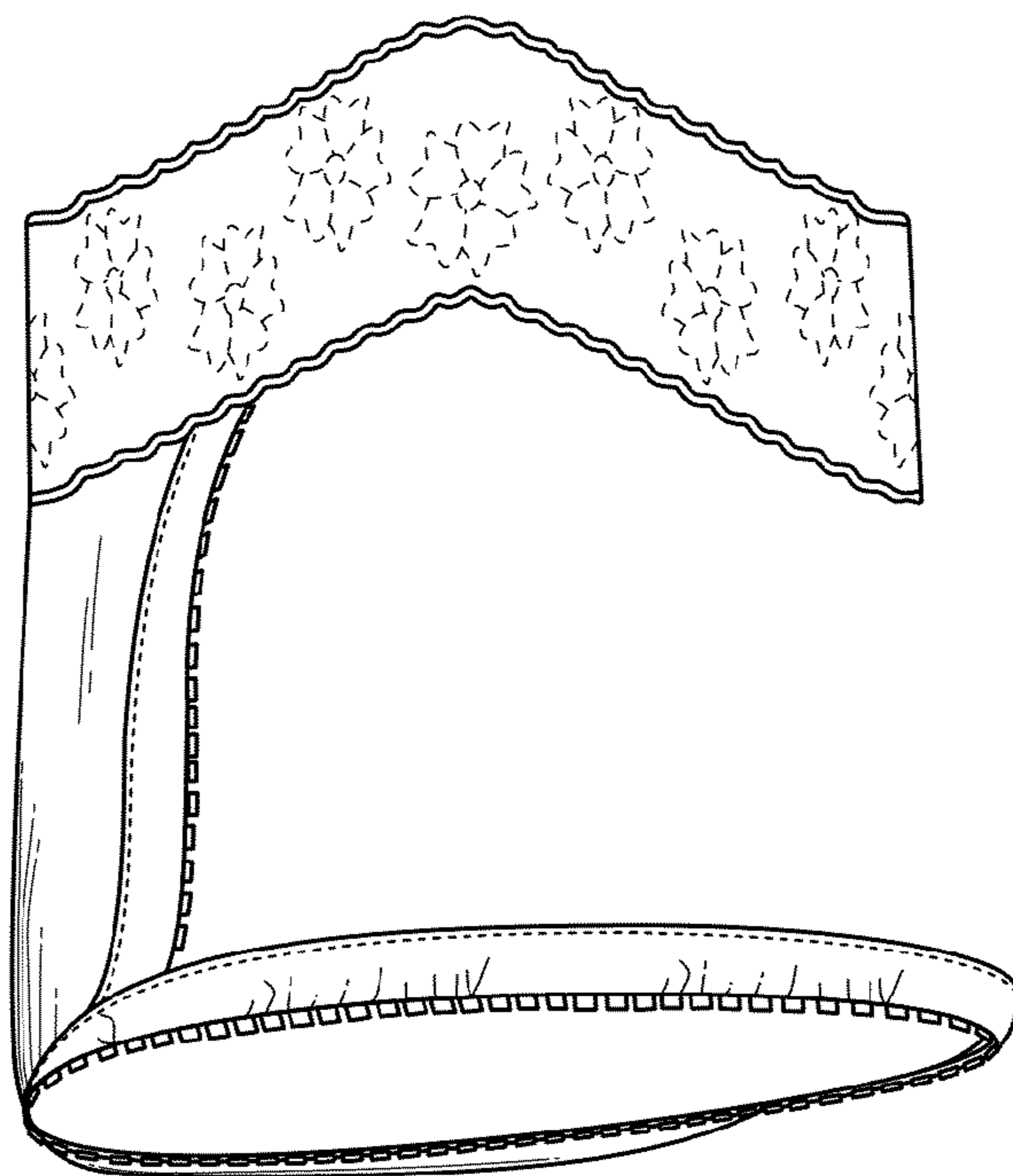

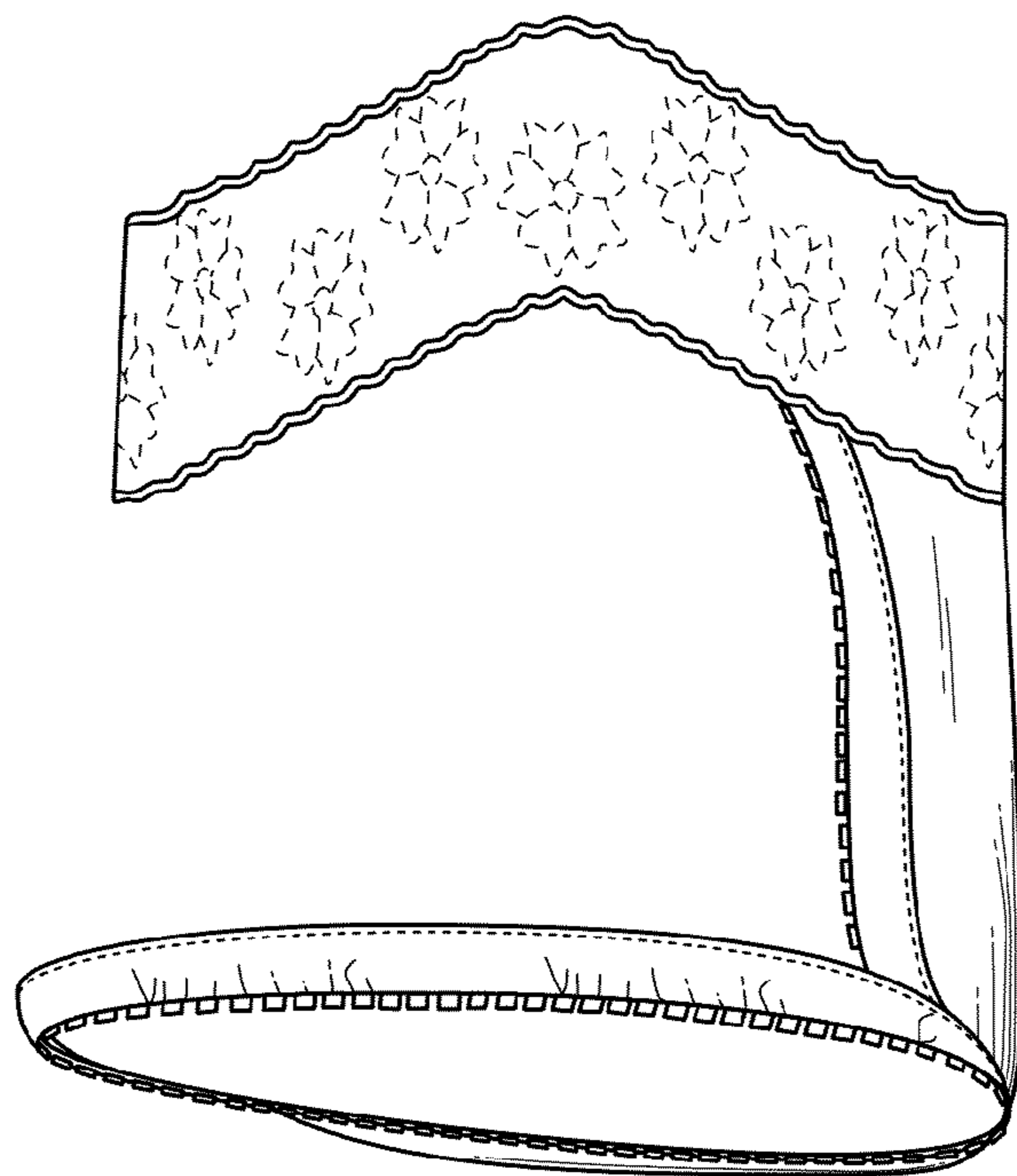

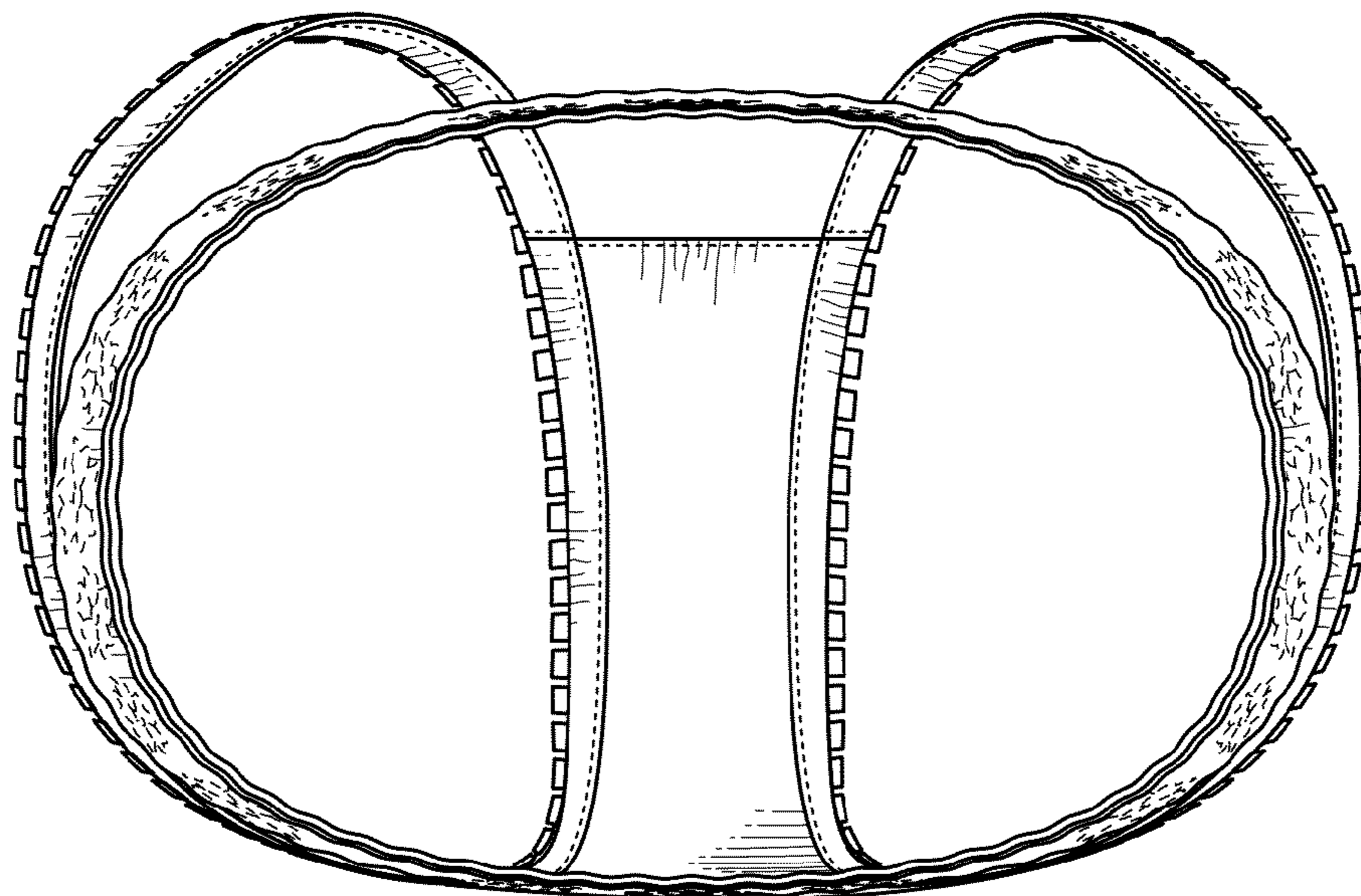

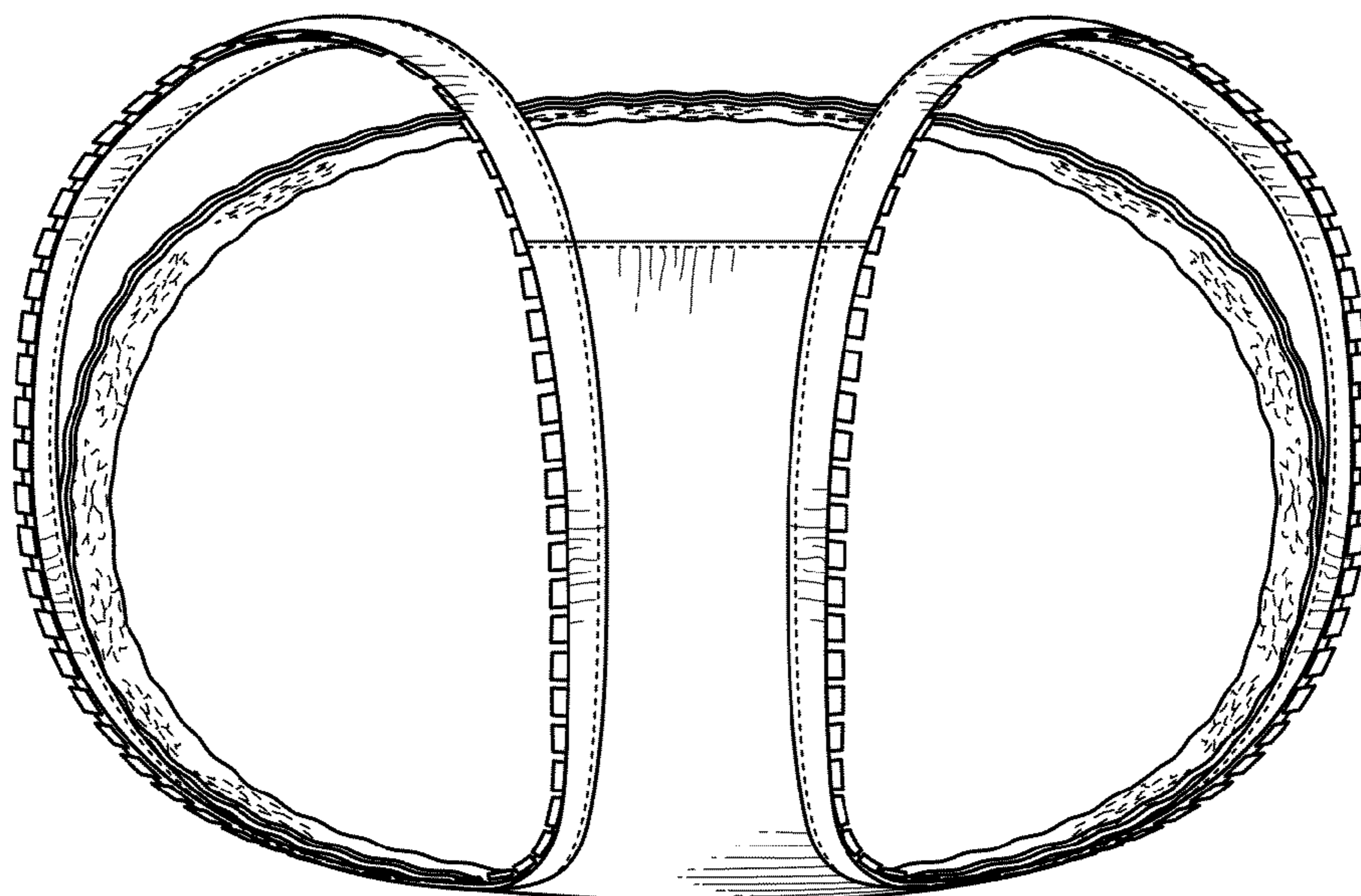

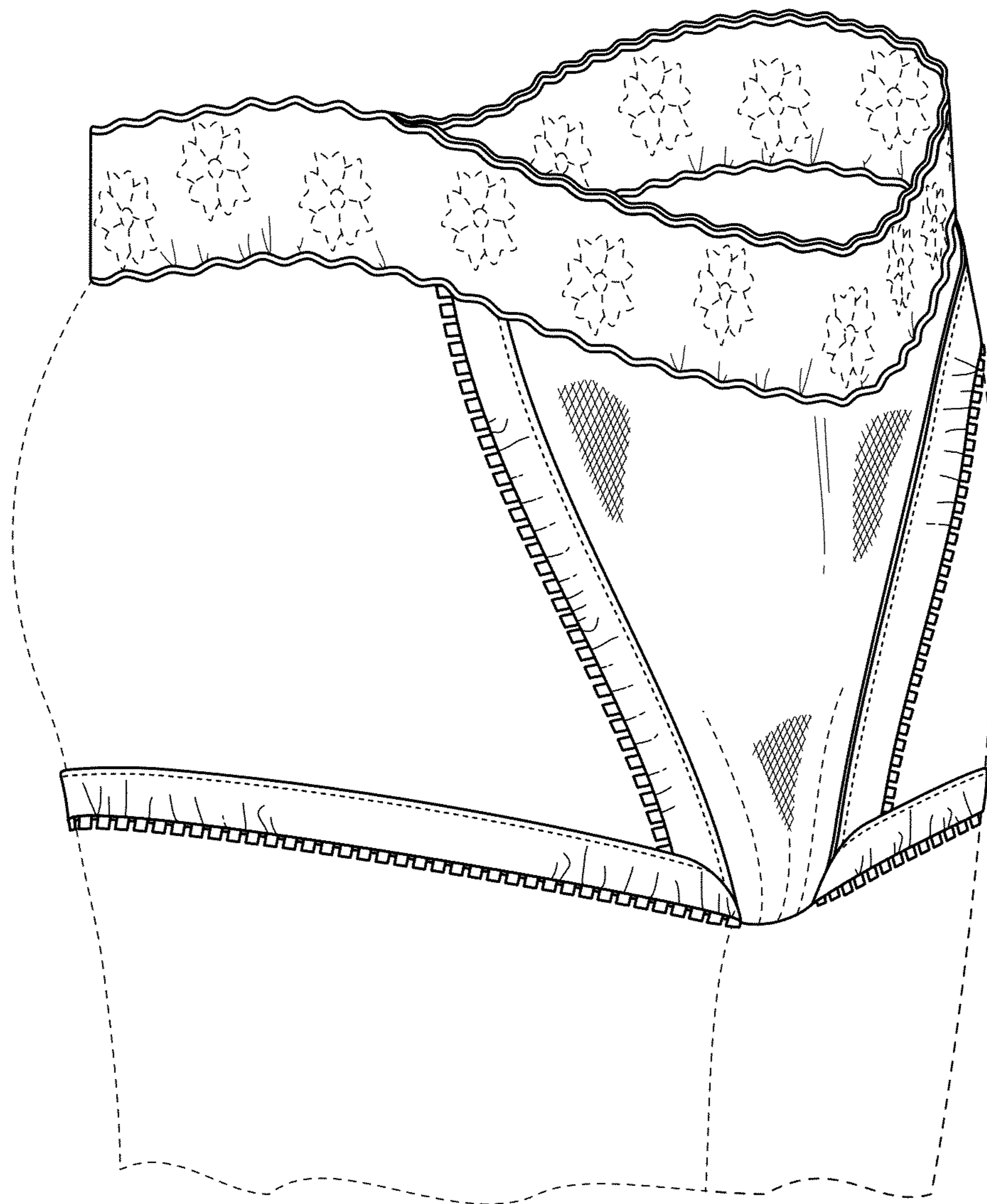

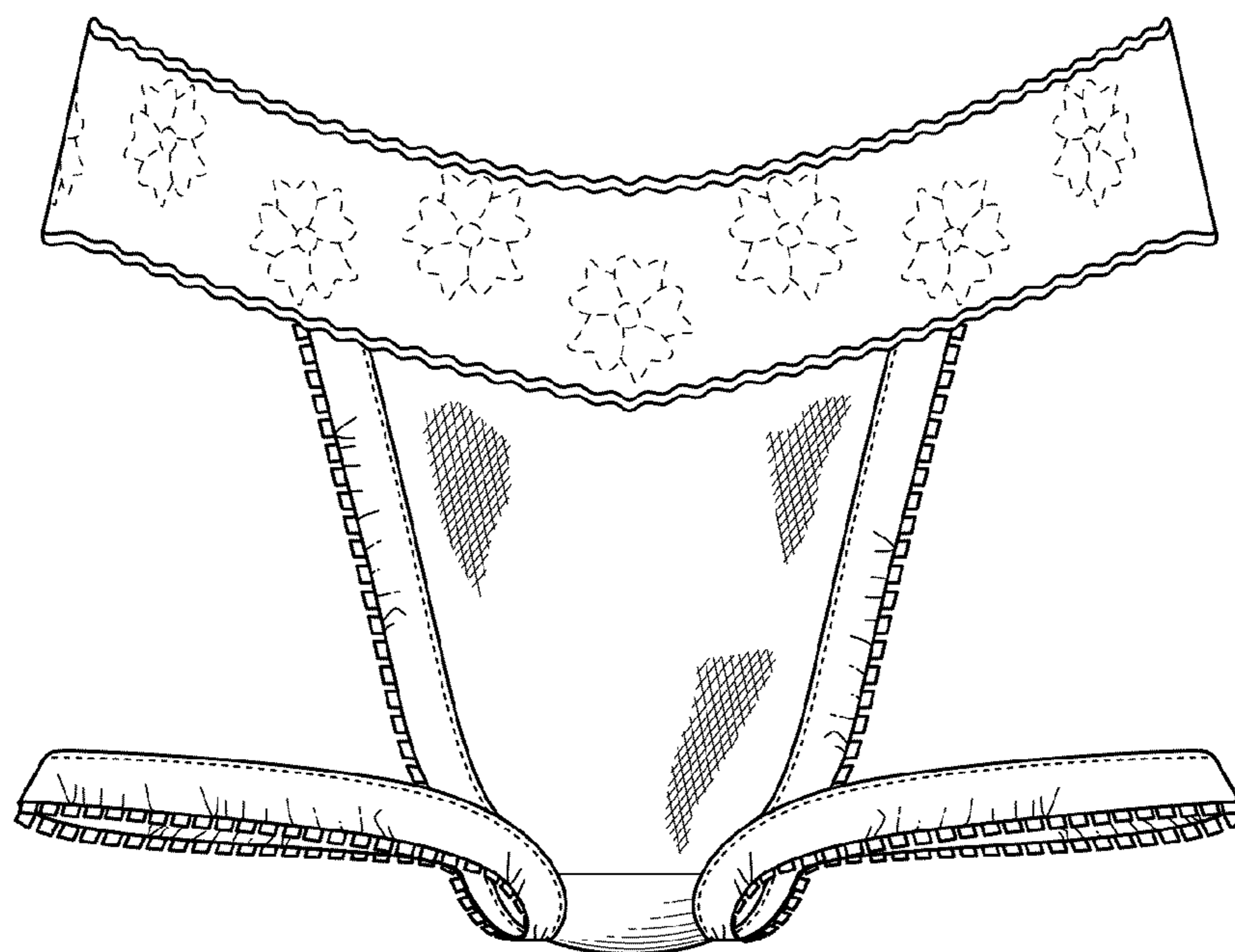

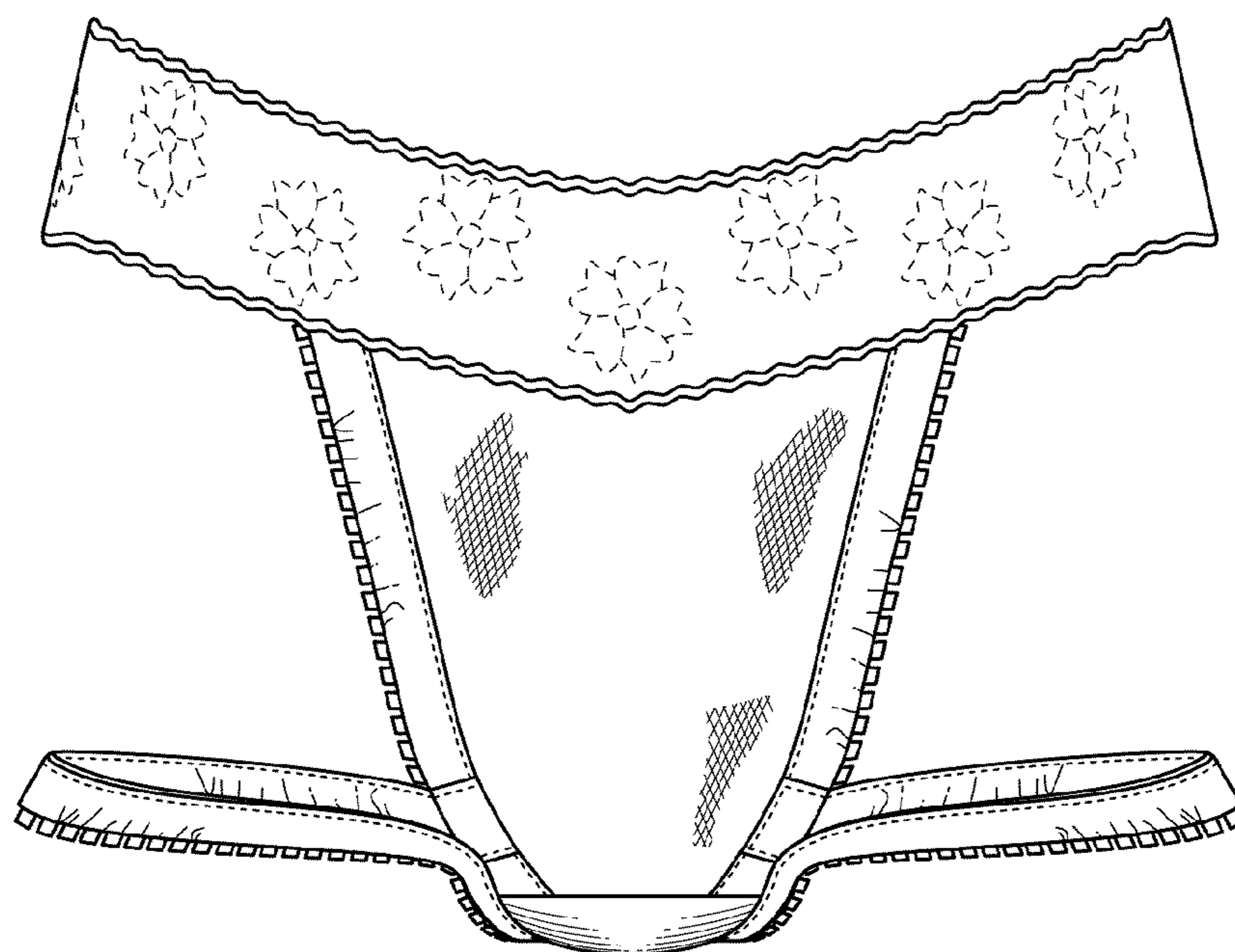

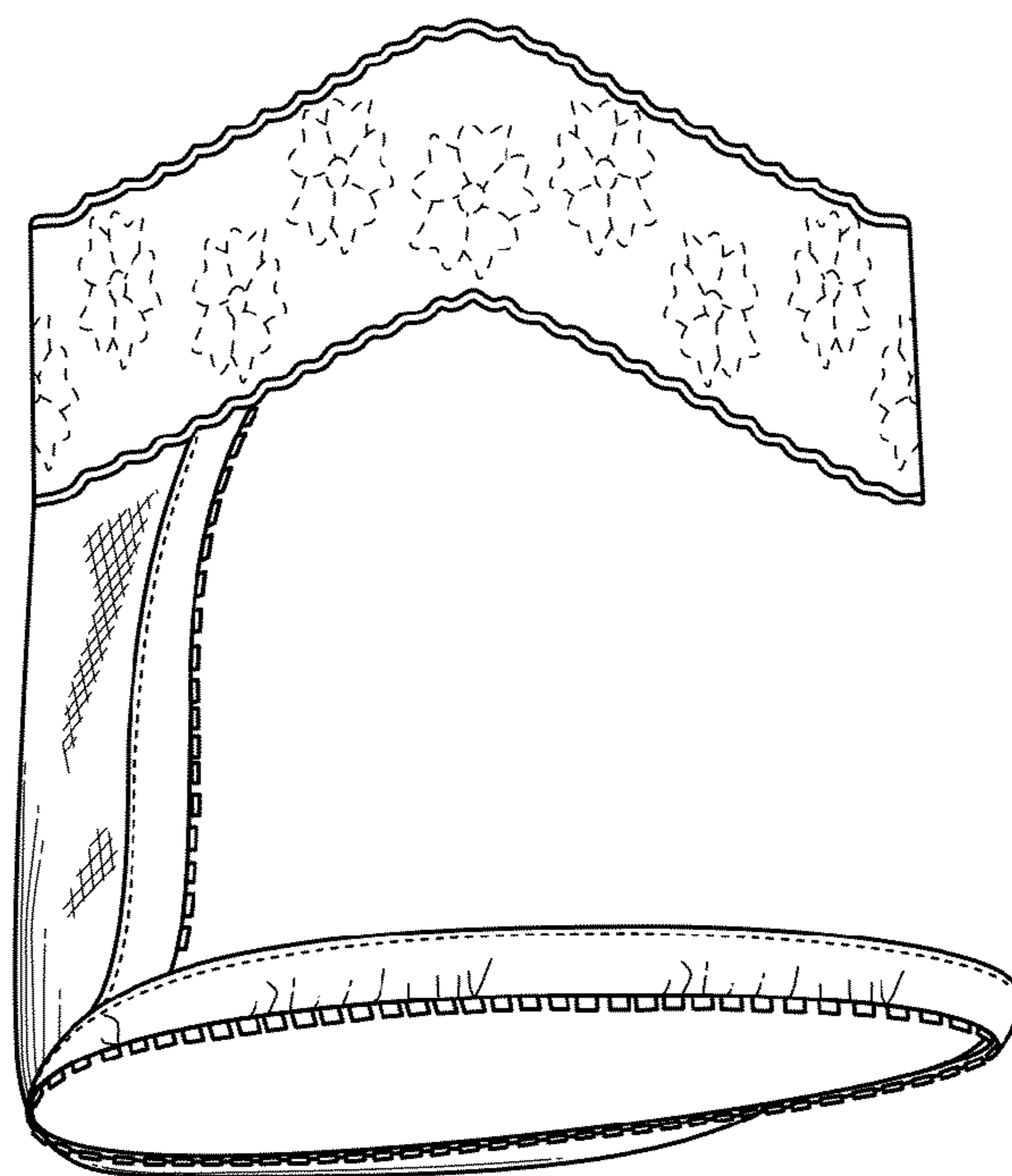

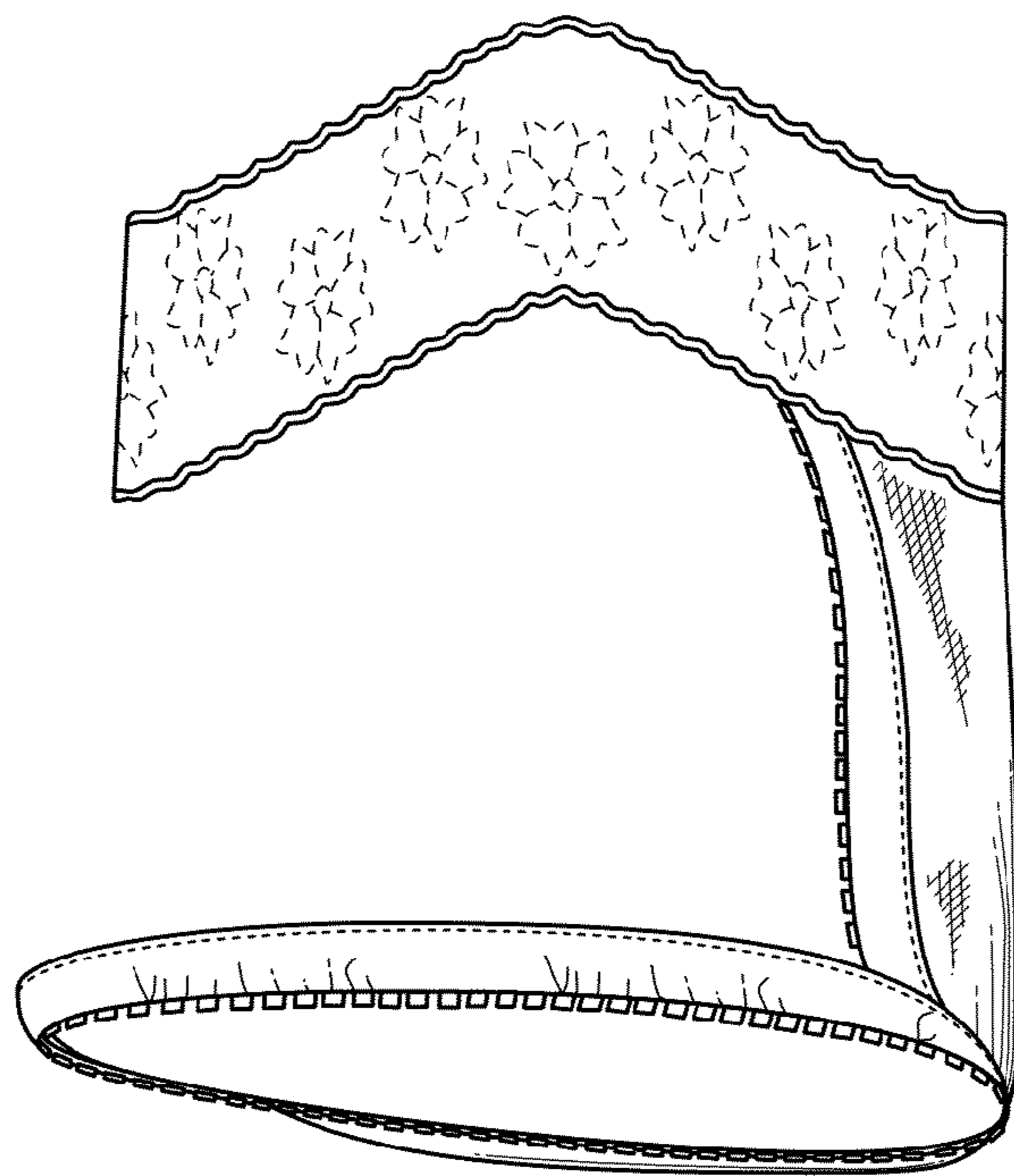

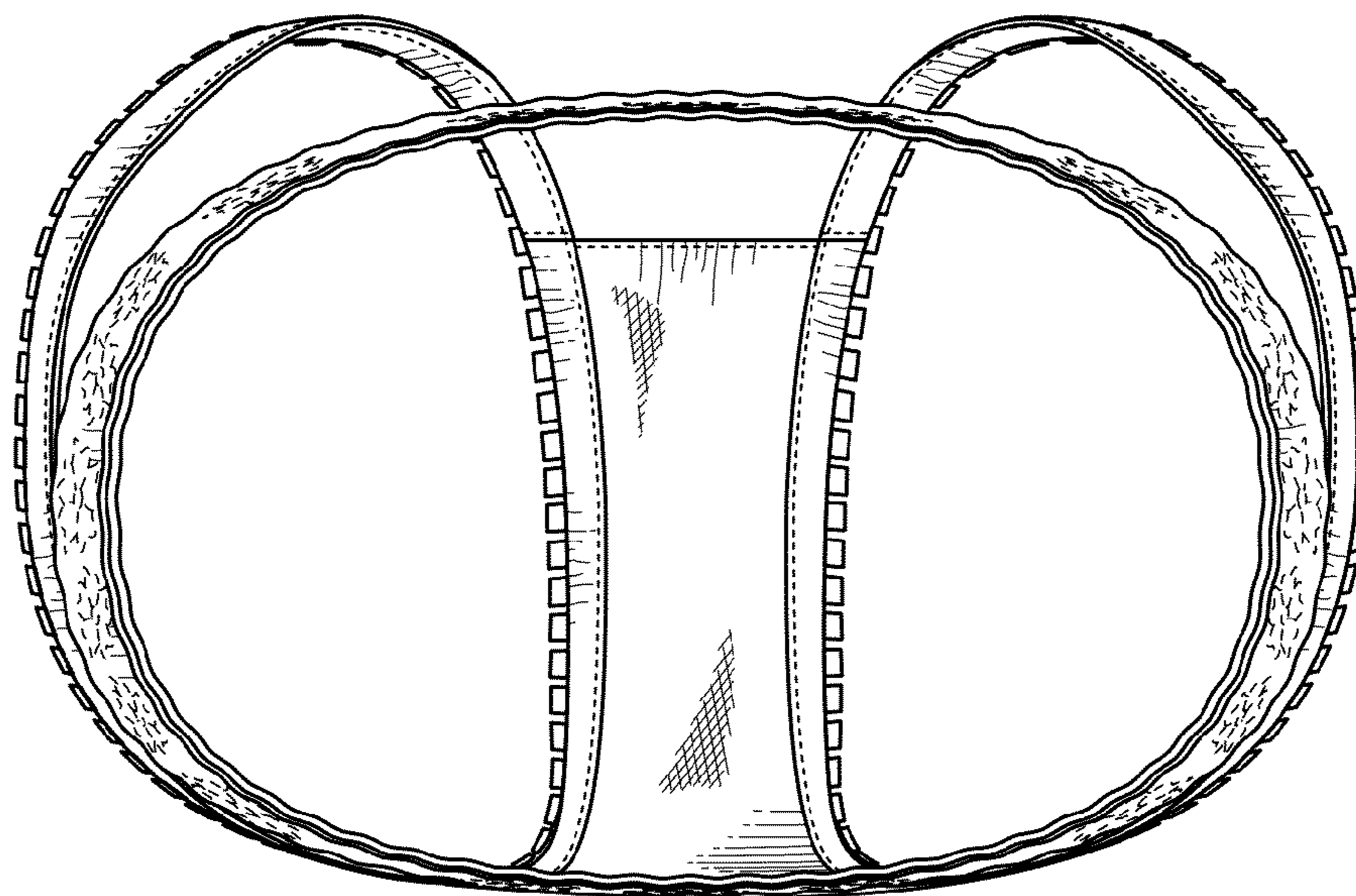

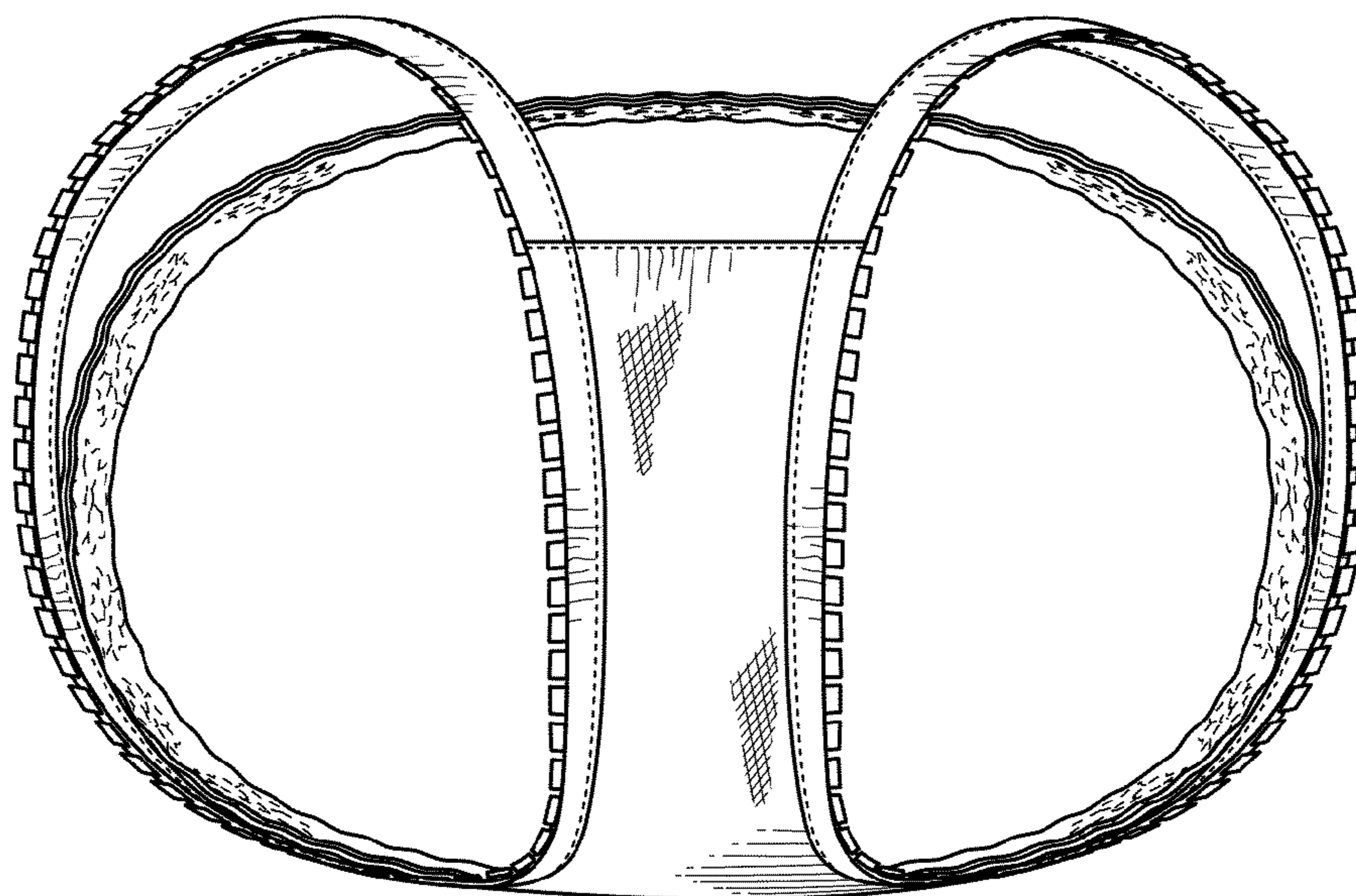
