I claim the ornamental design for a swimsuit top, as shown and described.

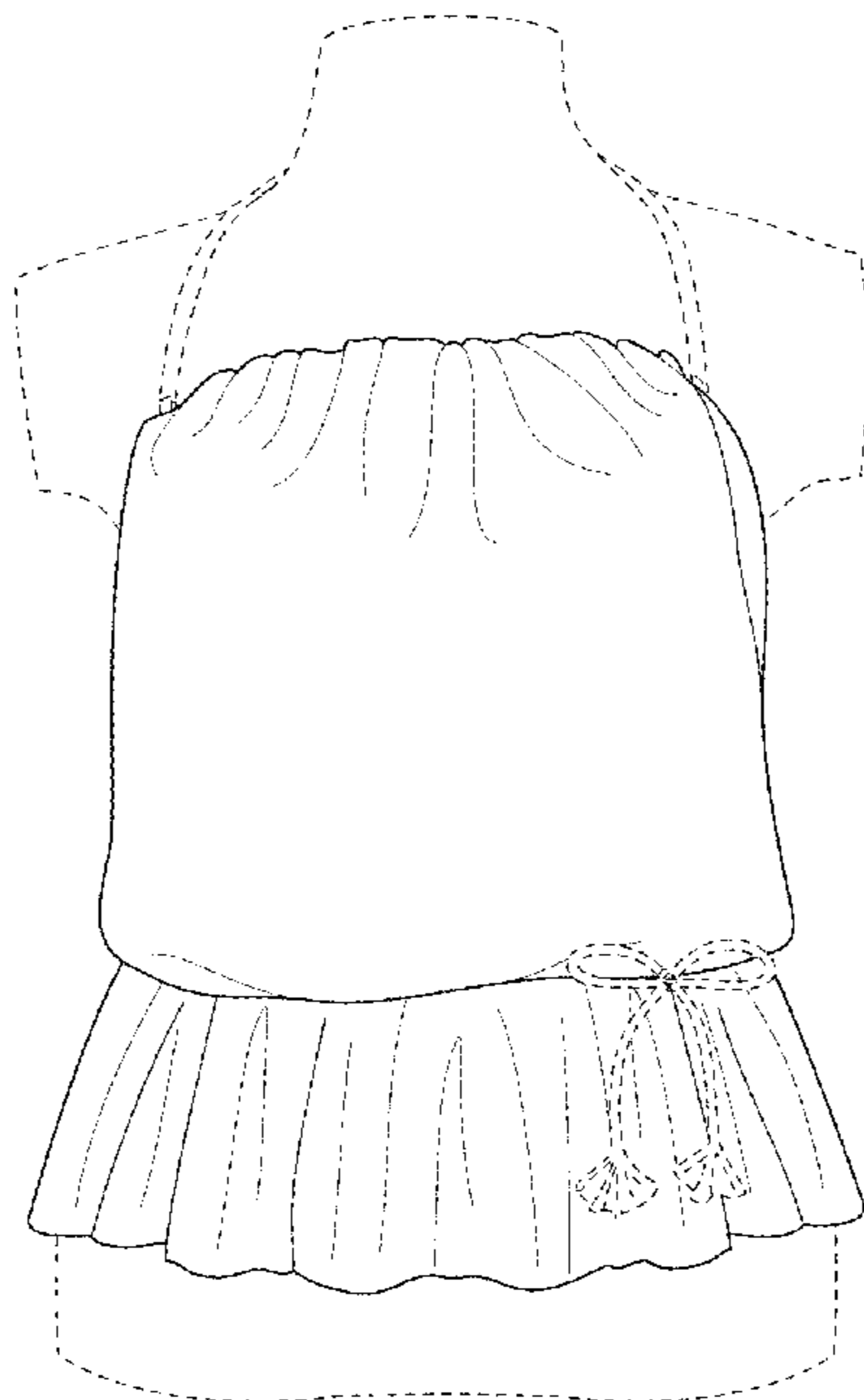
**DESCRIPTION**

FIG. 1 is a front view of a swimsuit top on a model showing my new design.

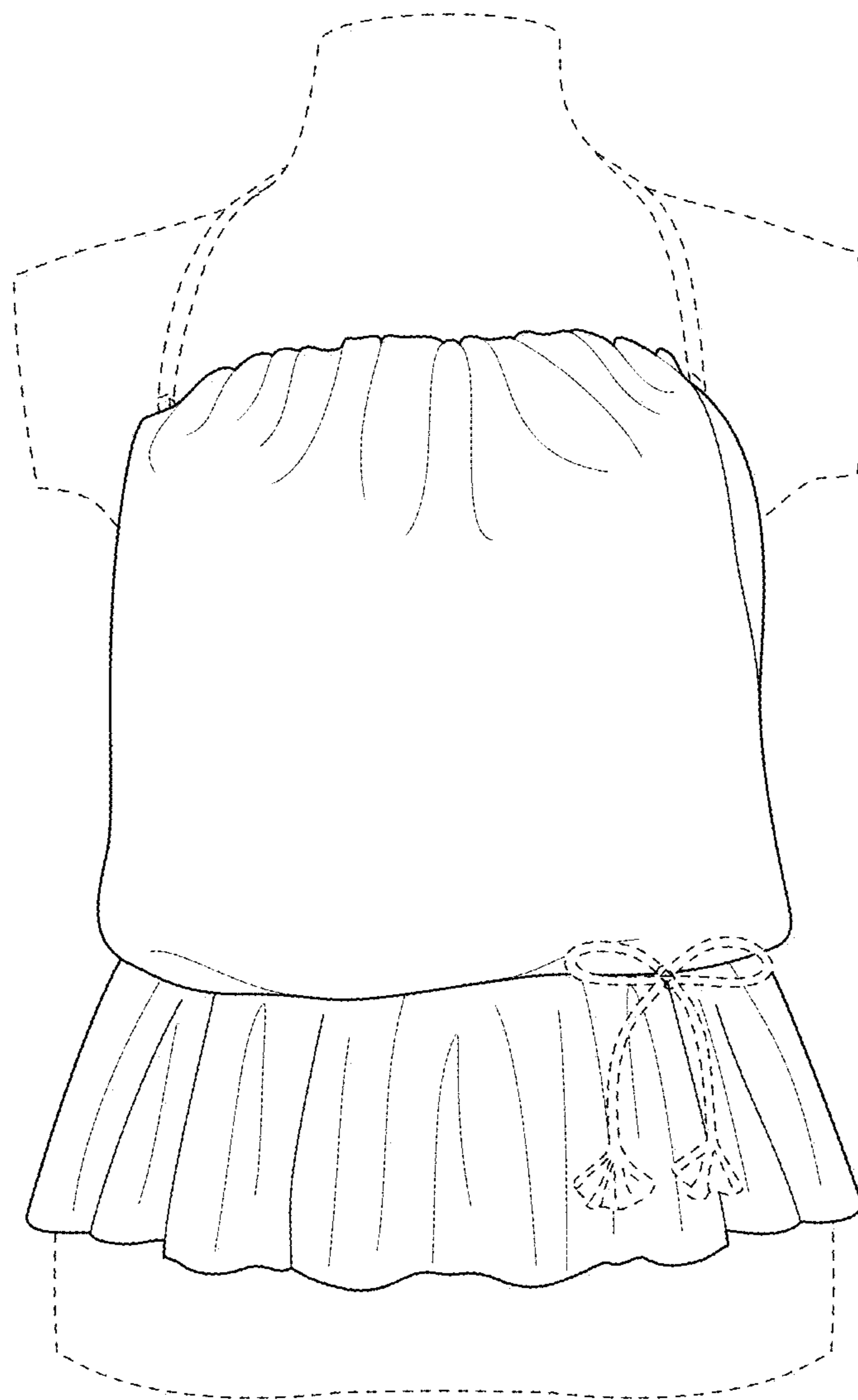

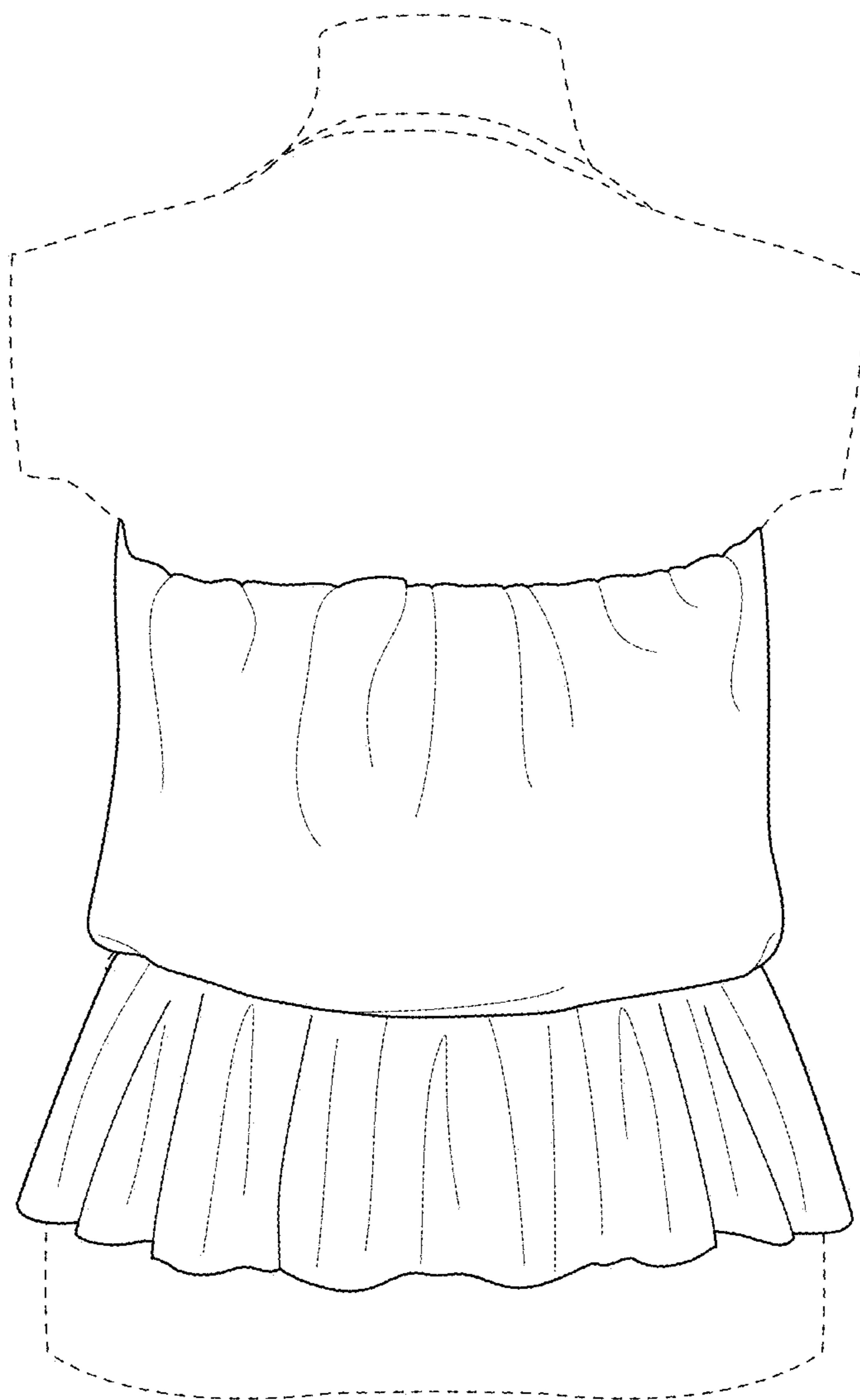

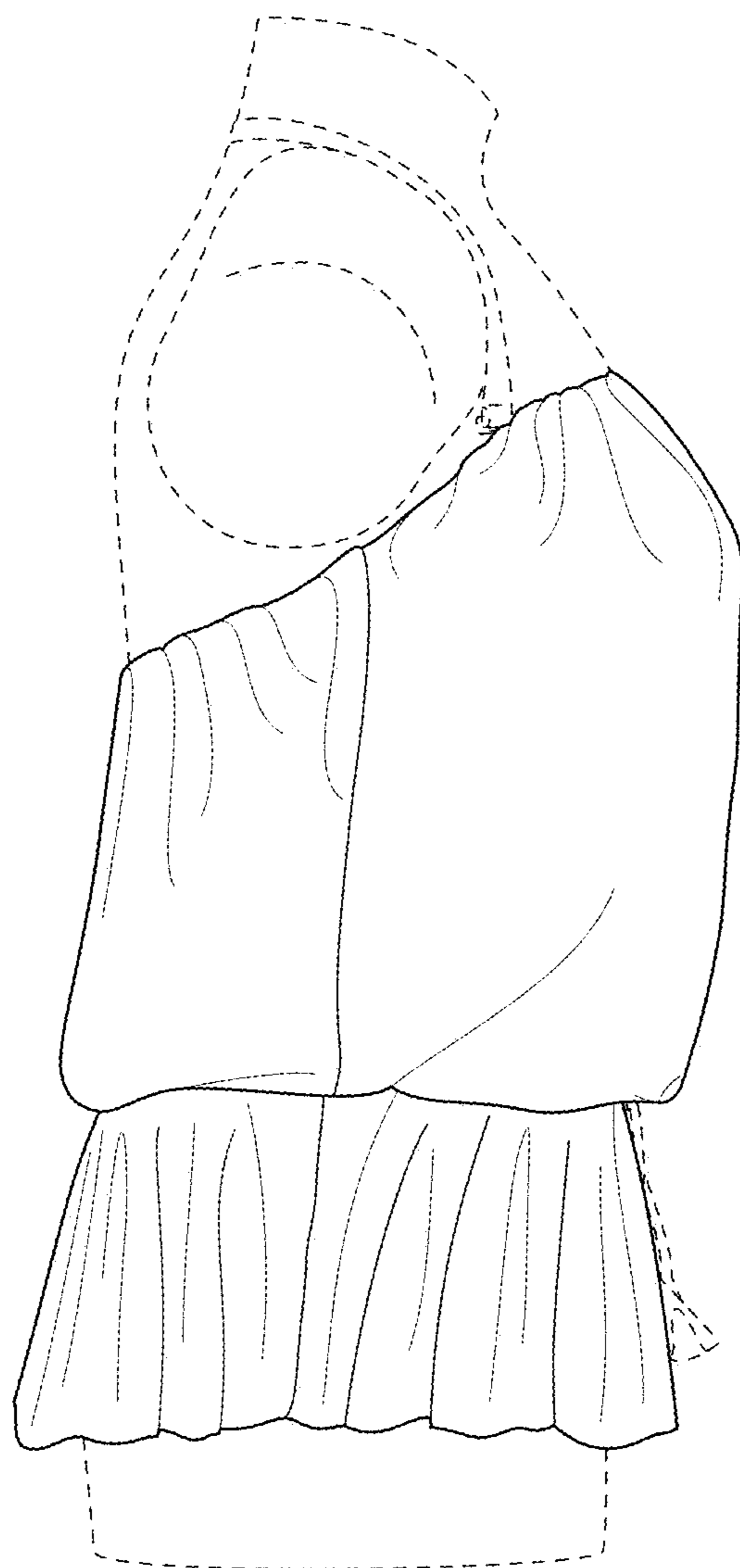

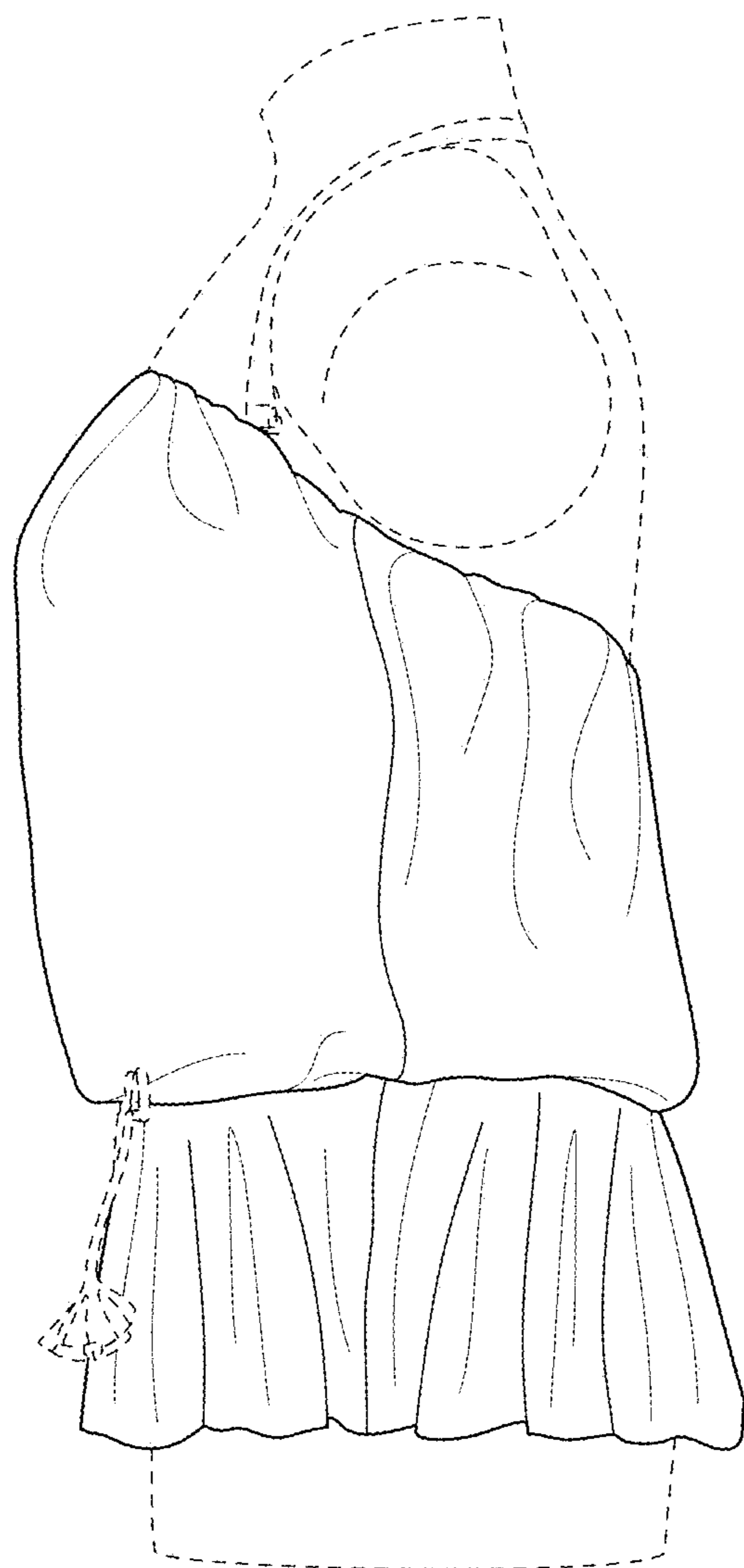
