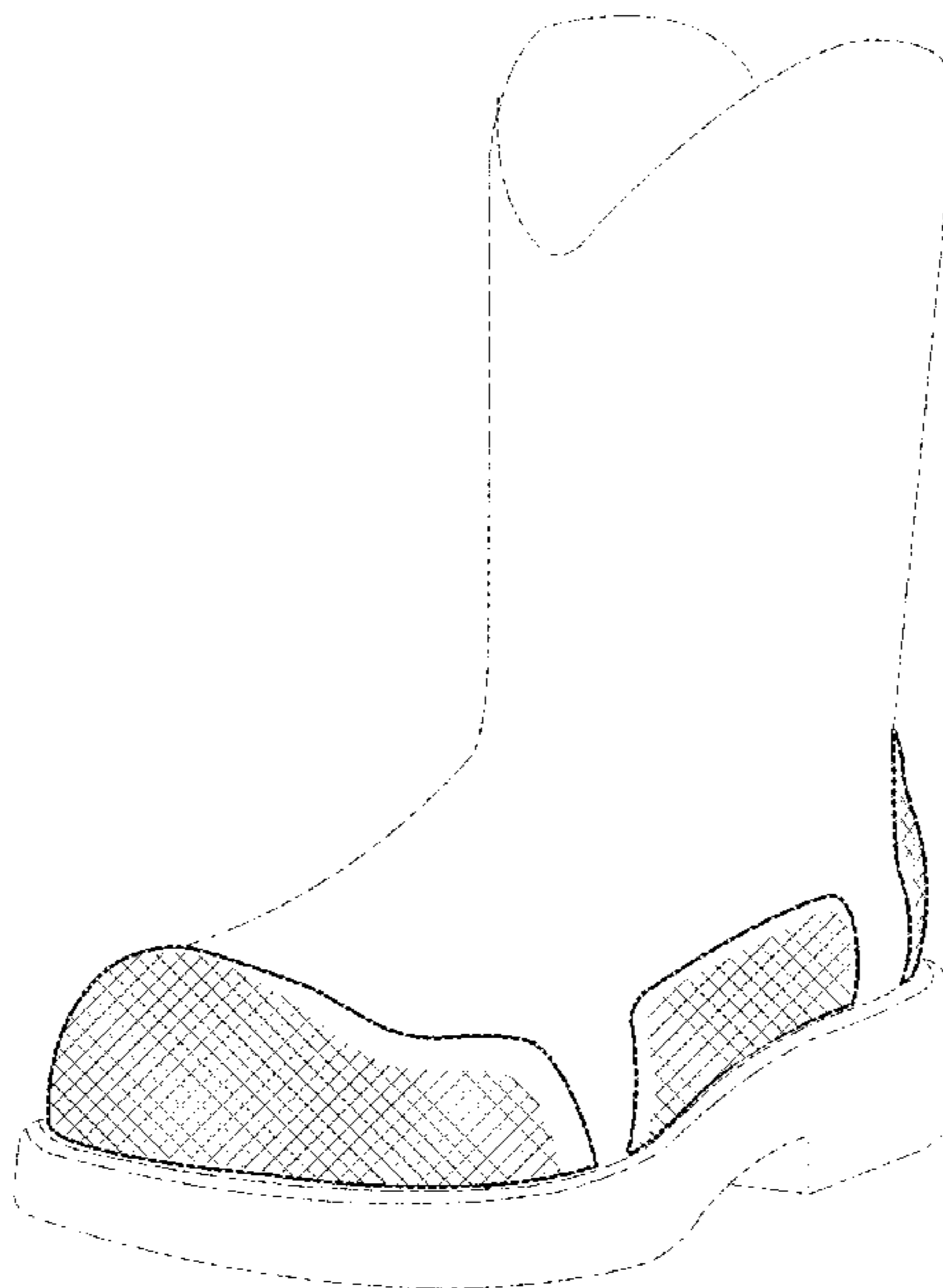
(57) **CLAIM**

The ornamental design for a footwear with large rubberized patches, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a footwear with large rubberized patches showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a lateral side elevational view thereof; FIG. 4 is a medial side elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a front elevational view thereof. The broken line showing on the drawing disclosure is for illustrative purposes only and forms no part of the claimed design.

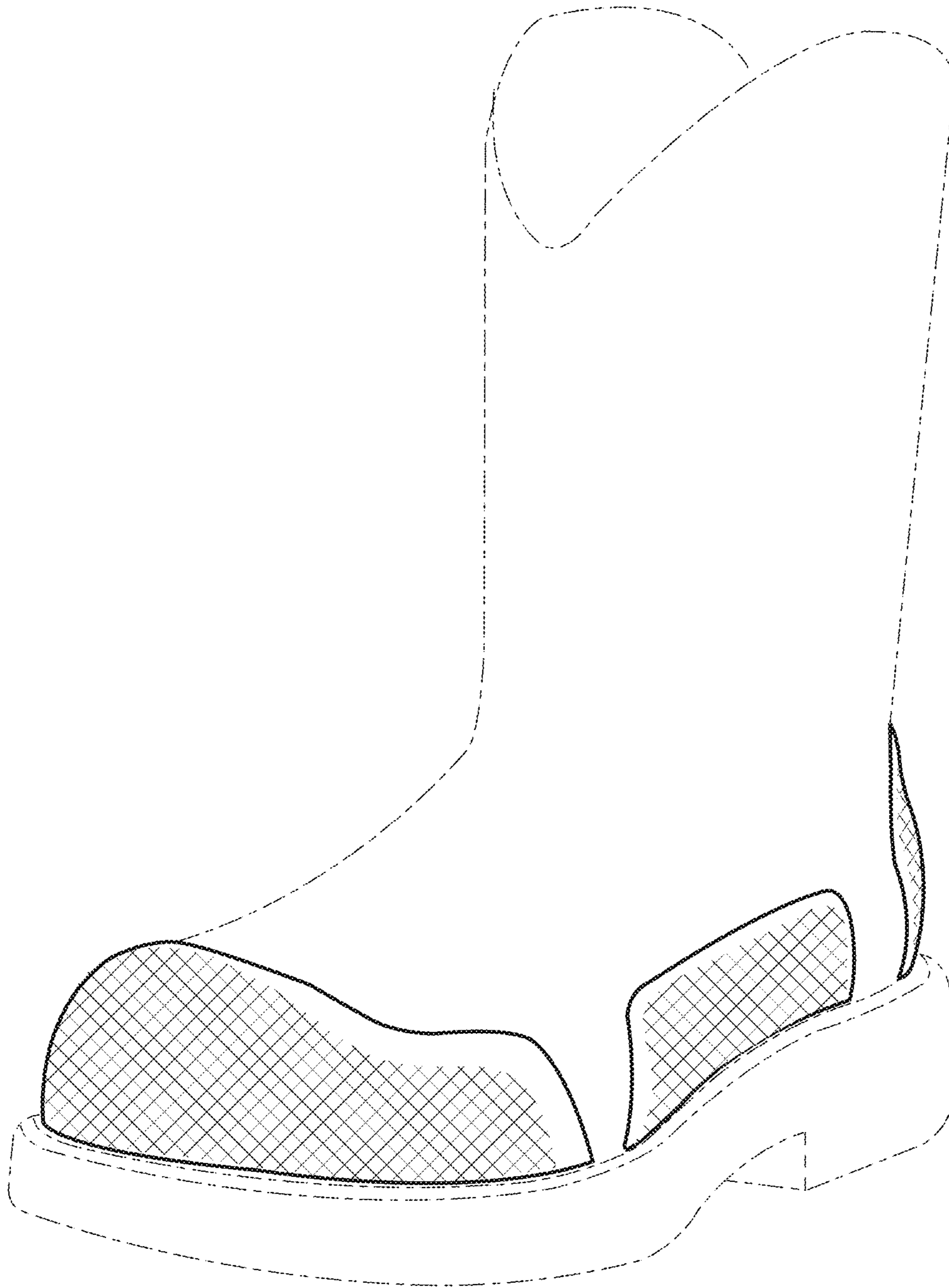

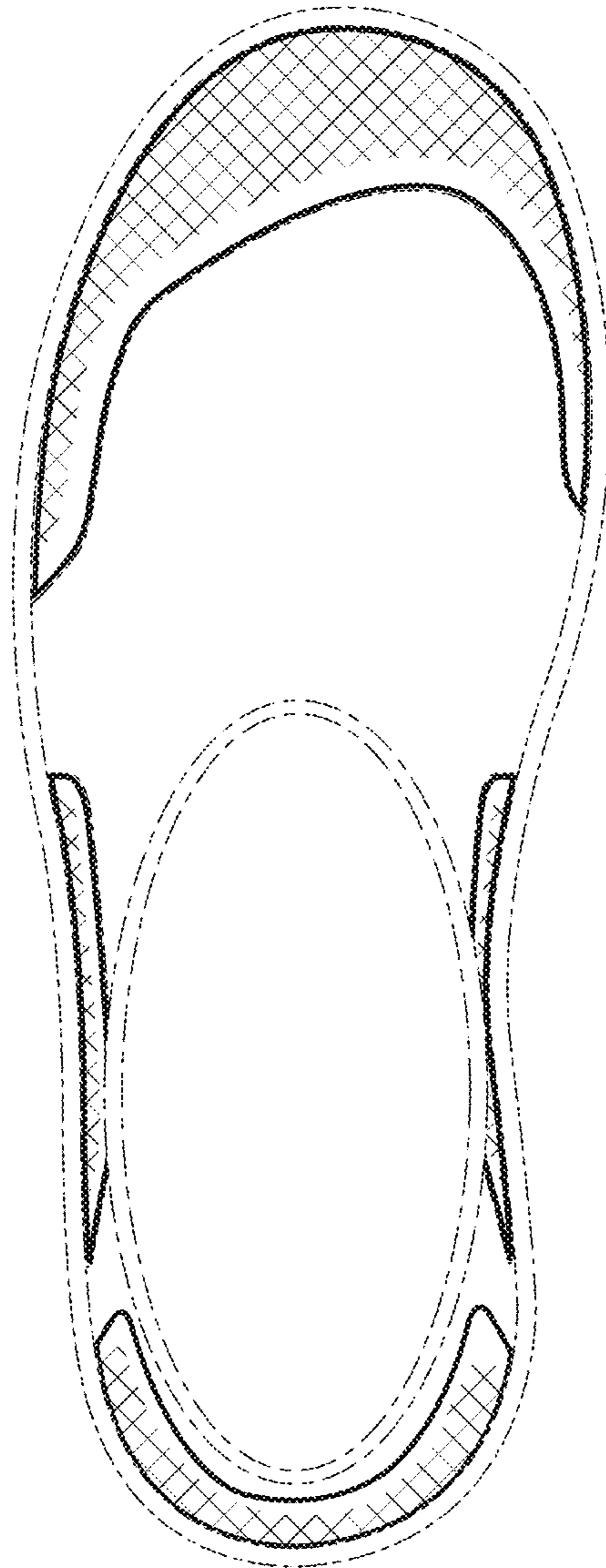

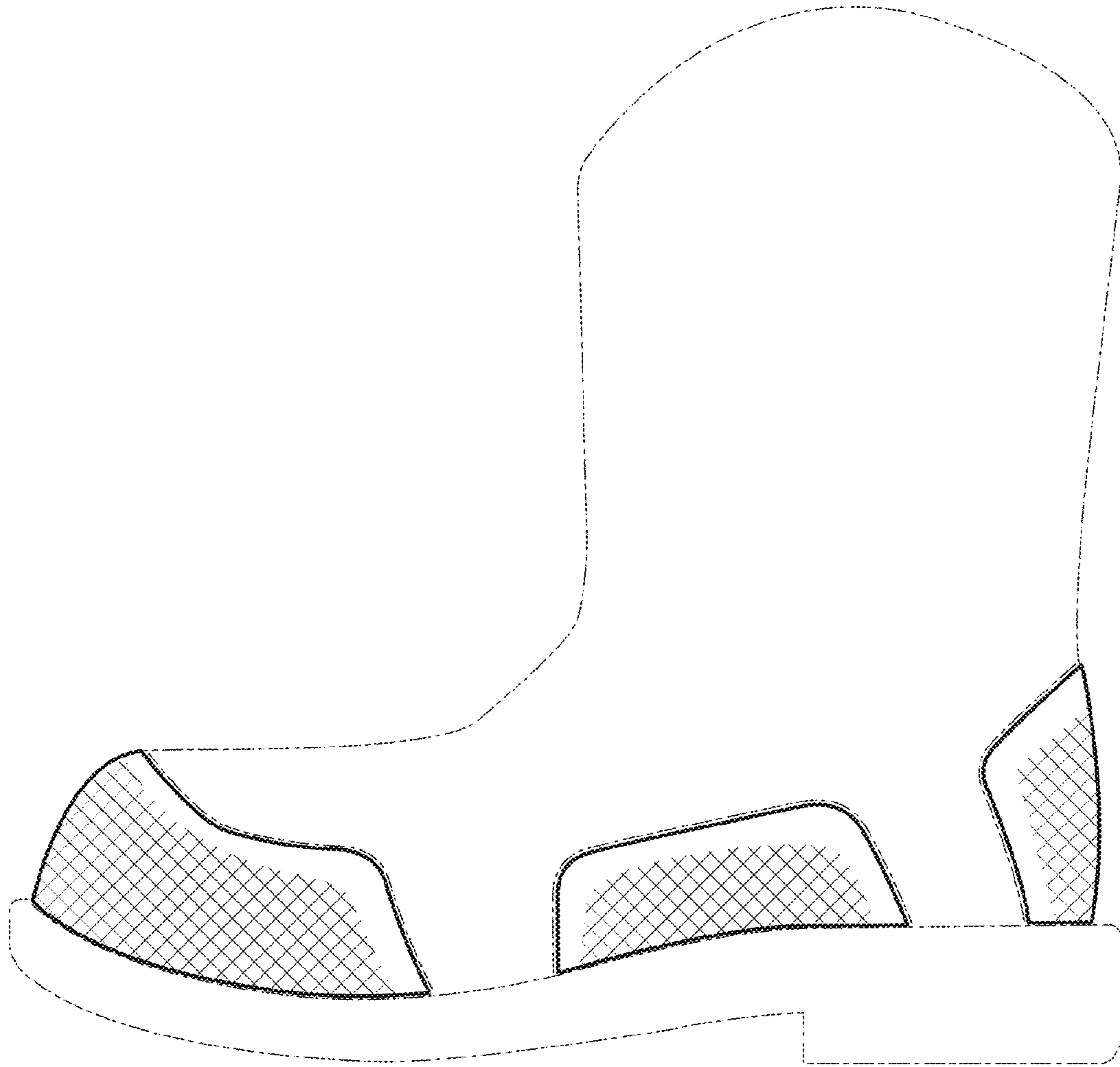

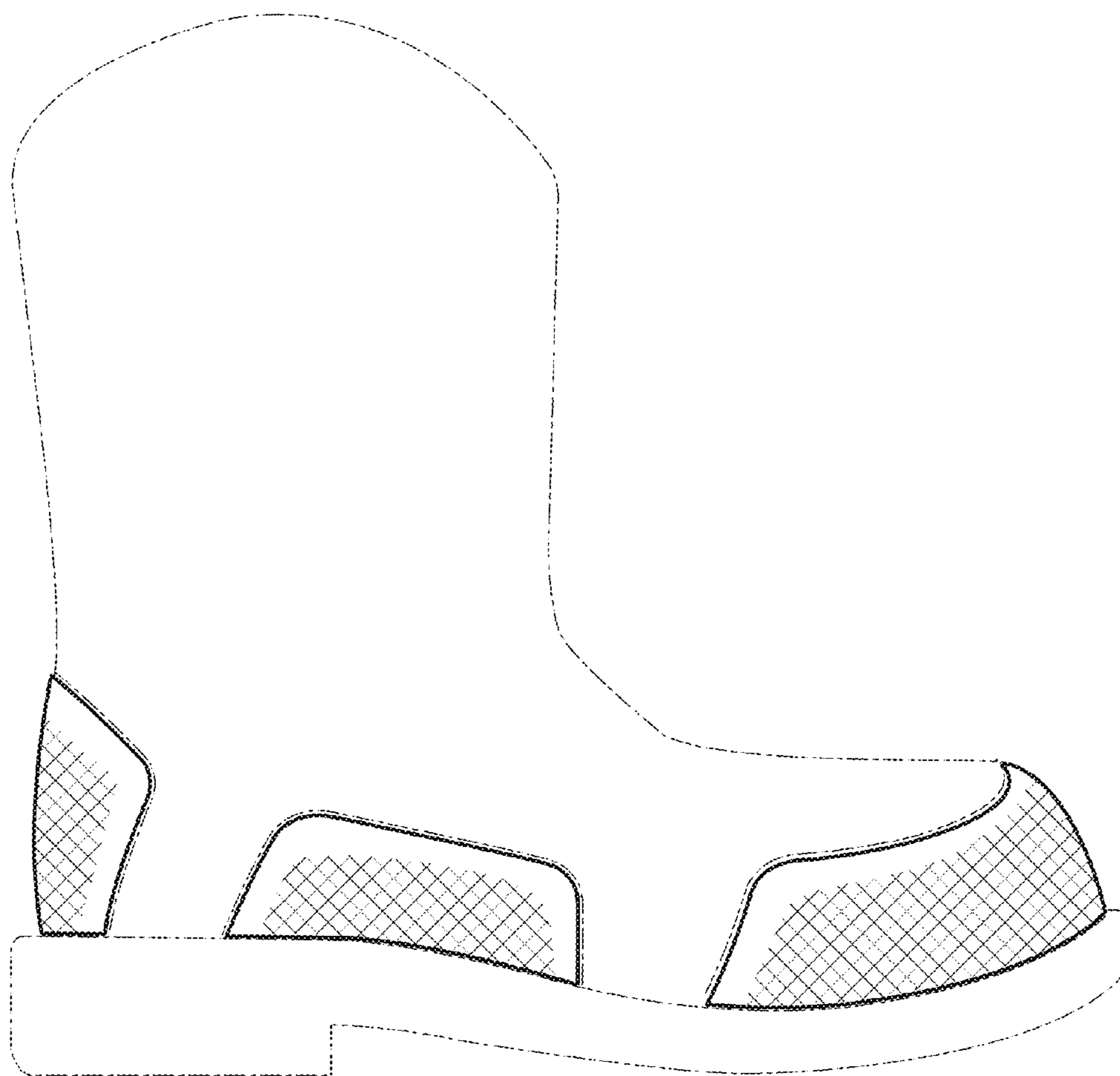

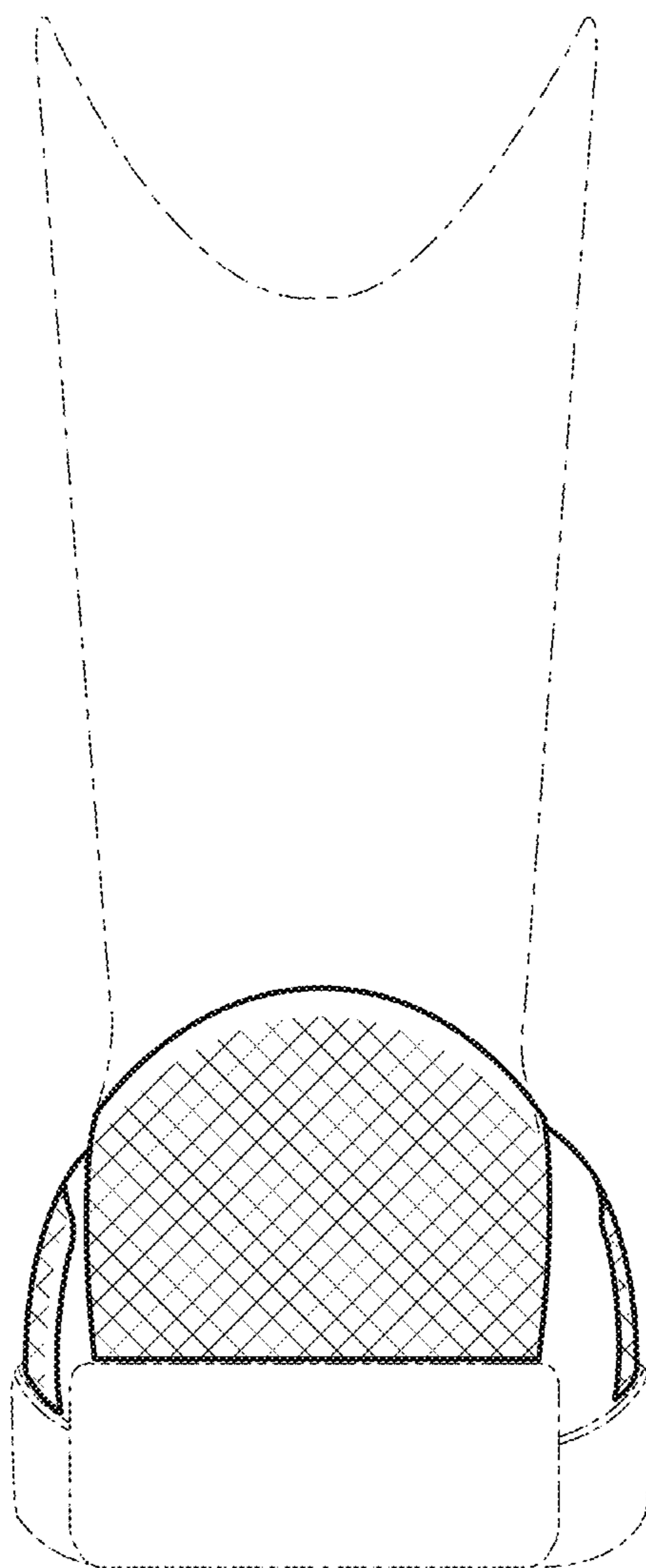

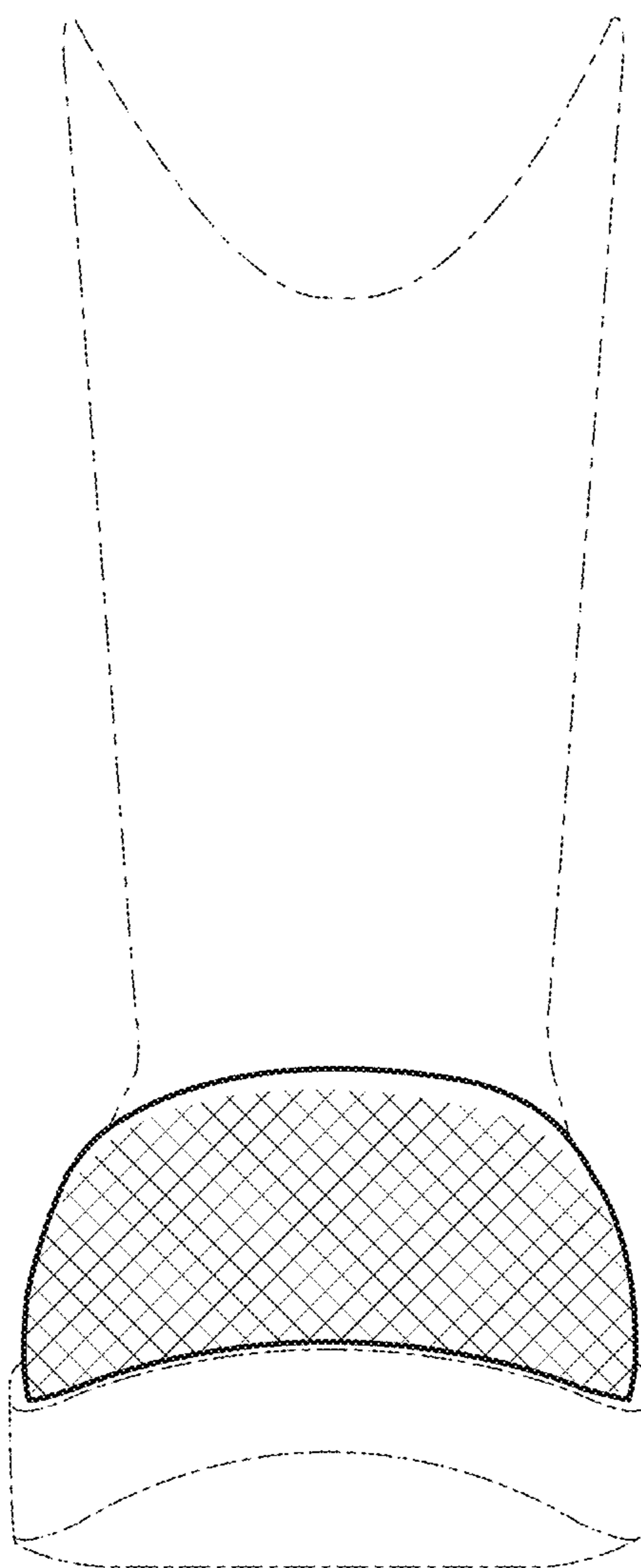
