The ornamental design for an item holder sleeve, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of an item holder sleeve in an embodiment of the present invention;

 FIG. 8 is a perspective view of an item holder sleeve of FIG. 1 in a rolled configuration.

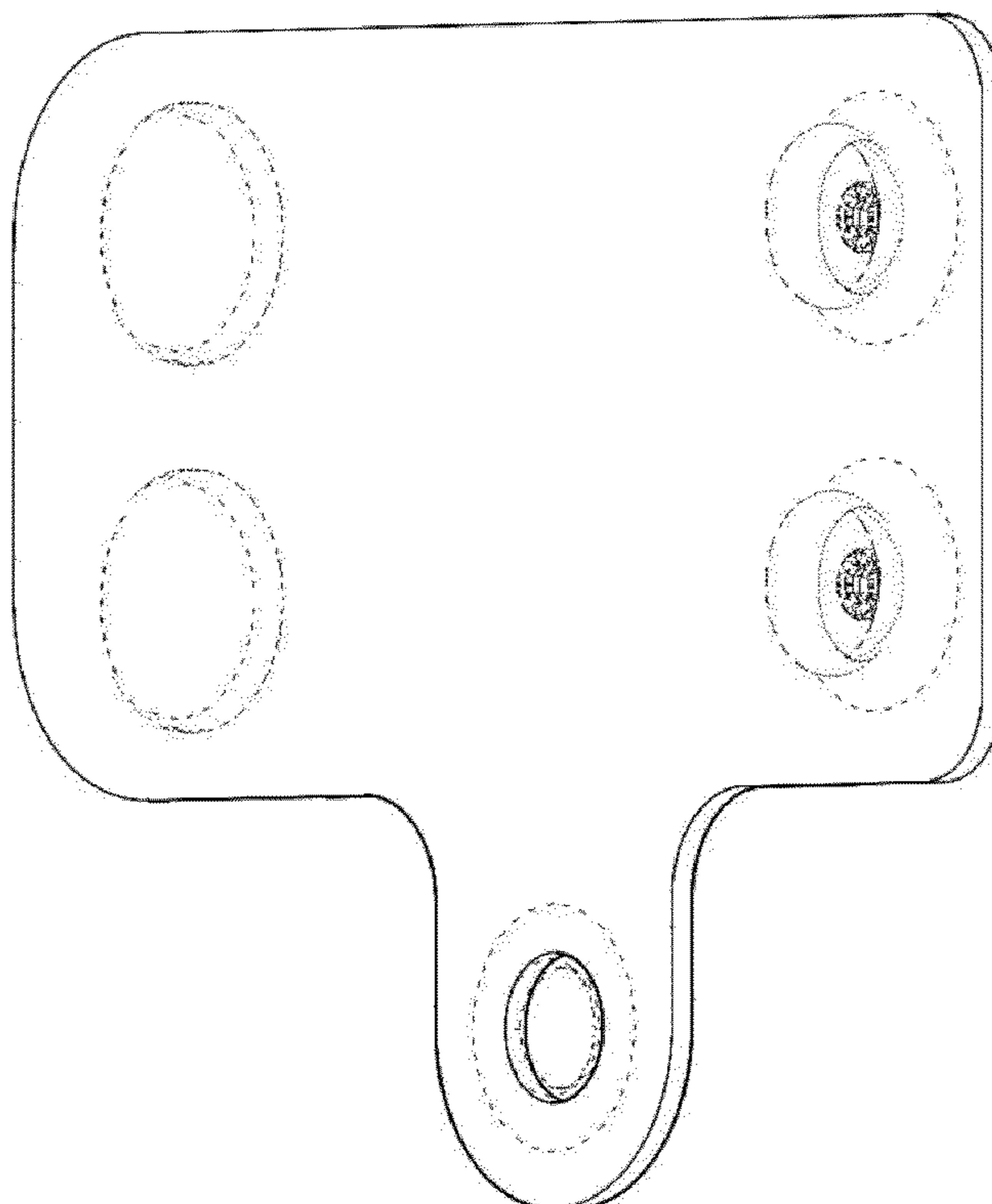

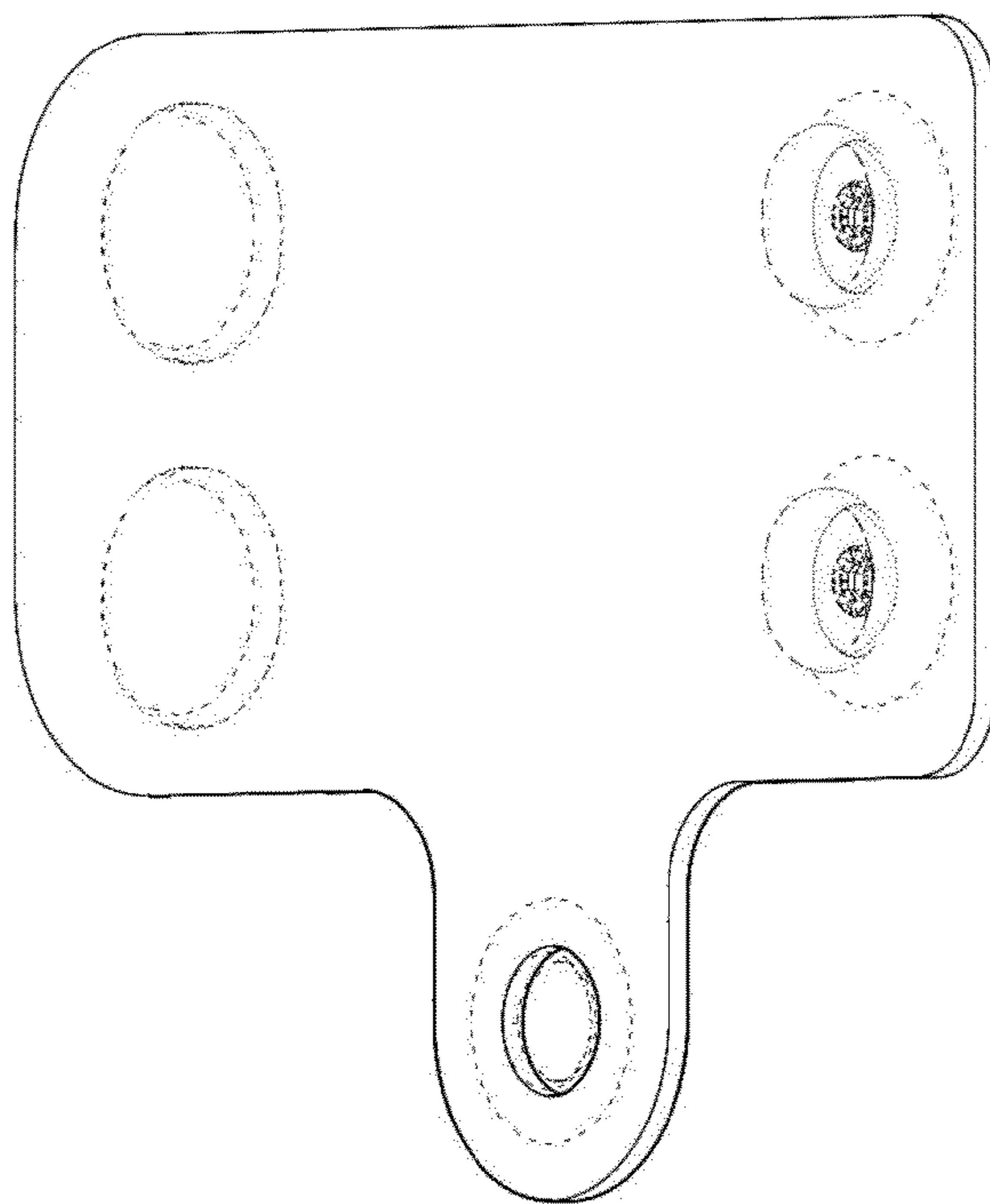

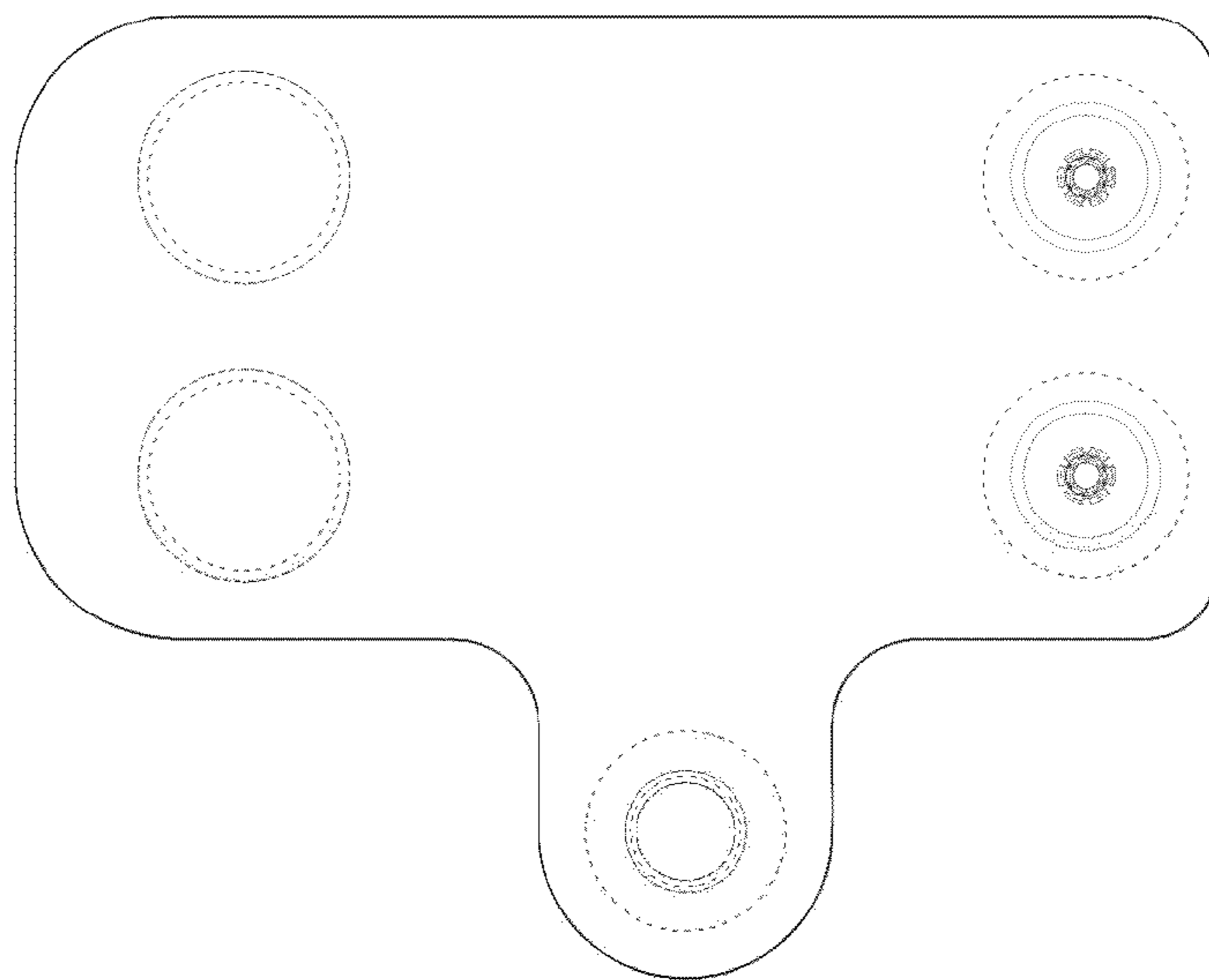

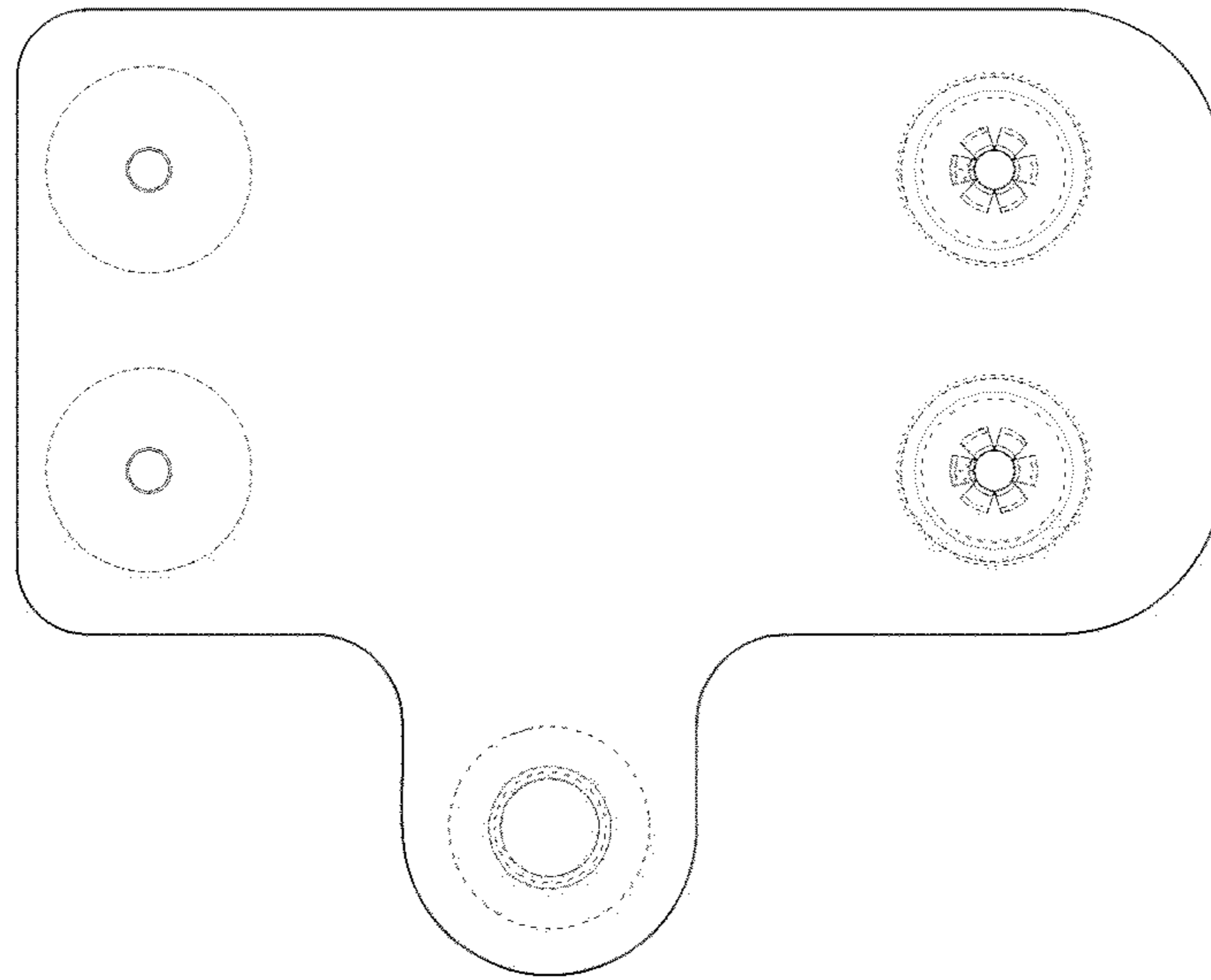

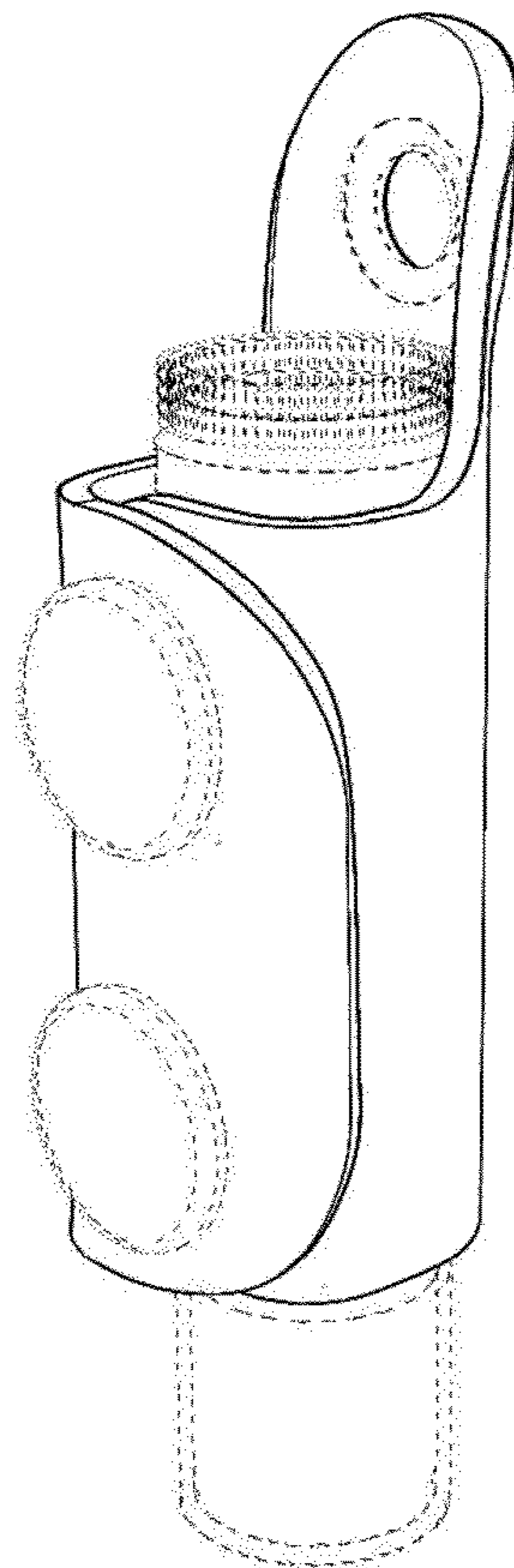

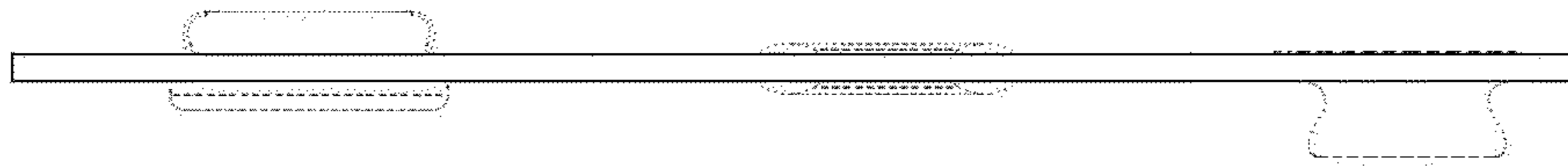

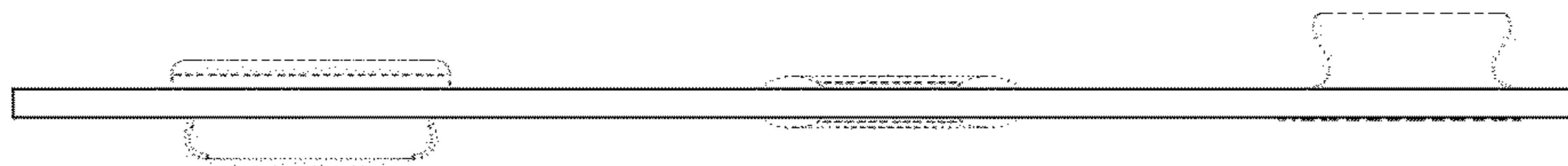

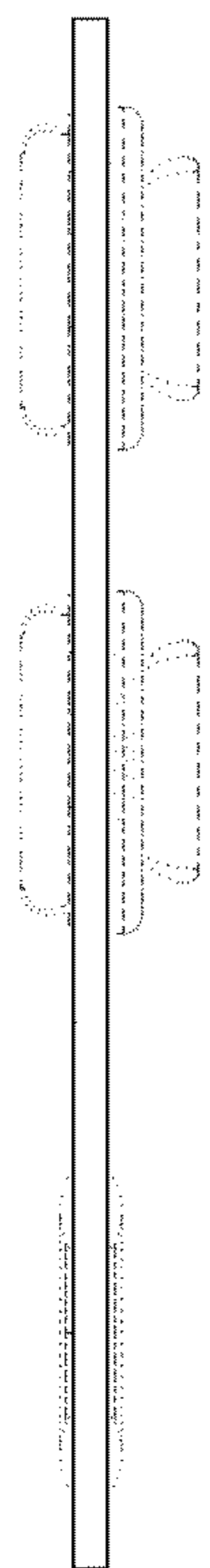
