The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a handbag, showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof; opposite that shown in FIG. 2;
 FIG. 4 is a side view thereof;
 FIG. 5 is a side view thereof, opposite that shown in FIG. 4;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a top, front perspective view of the handbag of FIGS. 1-6 with the top in an open condition;
 FIG. 8 is a top, front perspective view of another embodiment of a handbag, showing my new design;
 FIG. 9 is a front view thereof;
 FIG. 10 is a rear view thereof, opposite that shown in FIG. 9;
 FIG. 11 is a side view thereof;
 FIG. 12 is a side view thereof, opposite that shown in FIG. 11;
 FIG. 13 is a top plan view thereof; and,
 FIG. 14 is a top, front perspective view of the handbag of FIGS. 8-13 with the top in an open condition.
 The broken lines showing portions of the bag interior, snap, handle, buckle and stitching are for the purposes of illustrating environment and form no part of the claimed design.

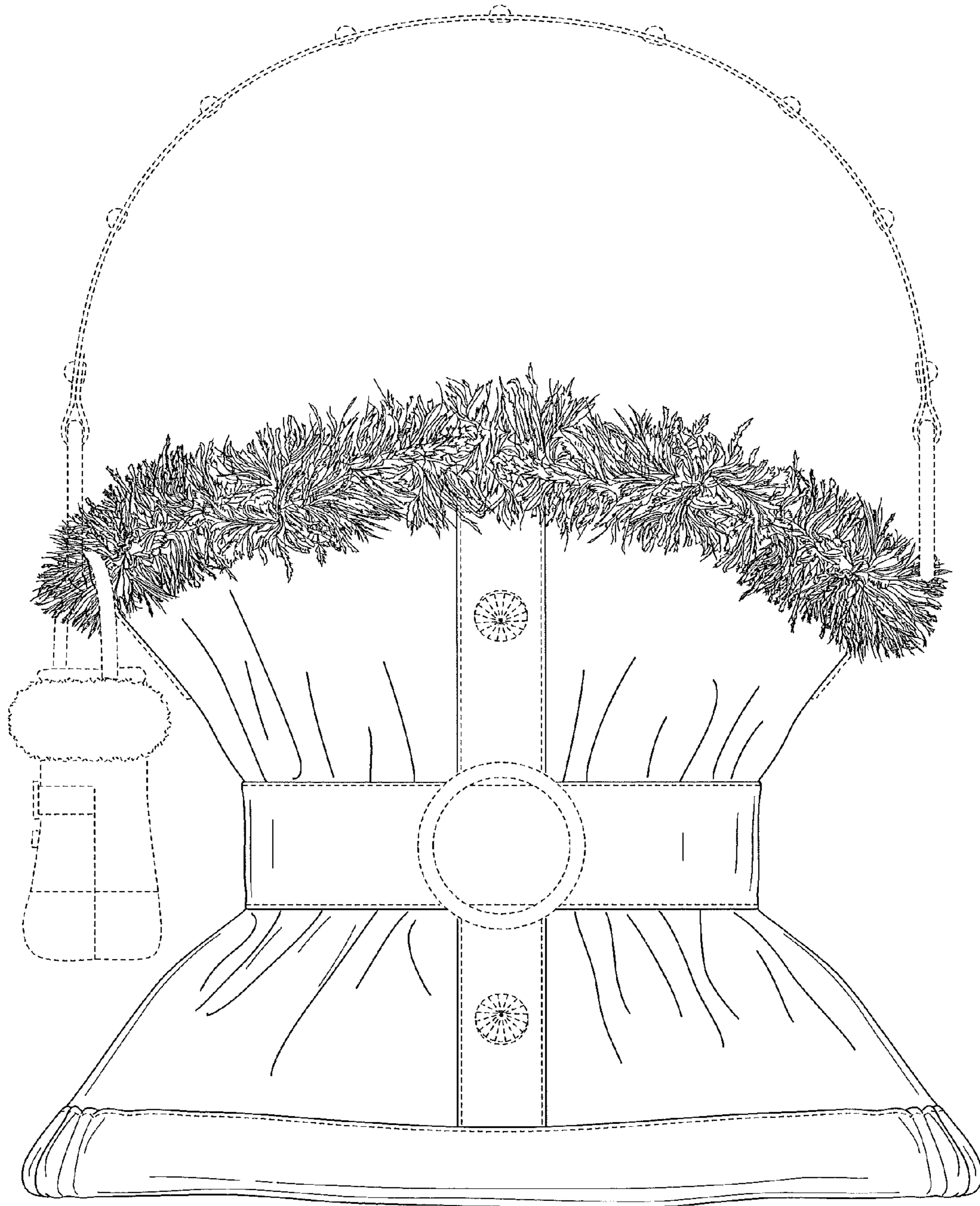

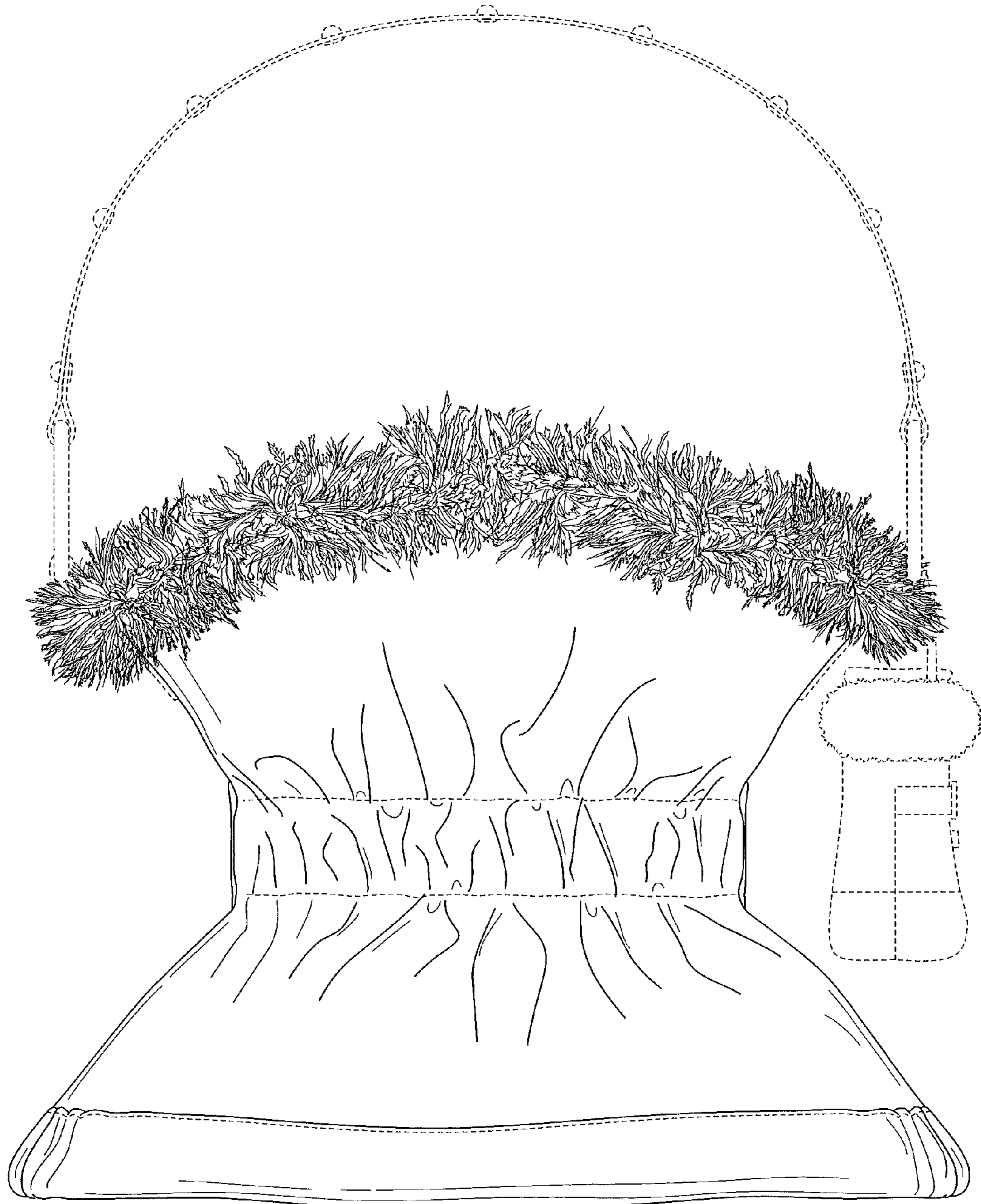

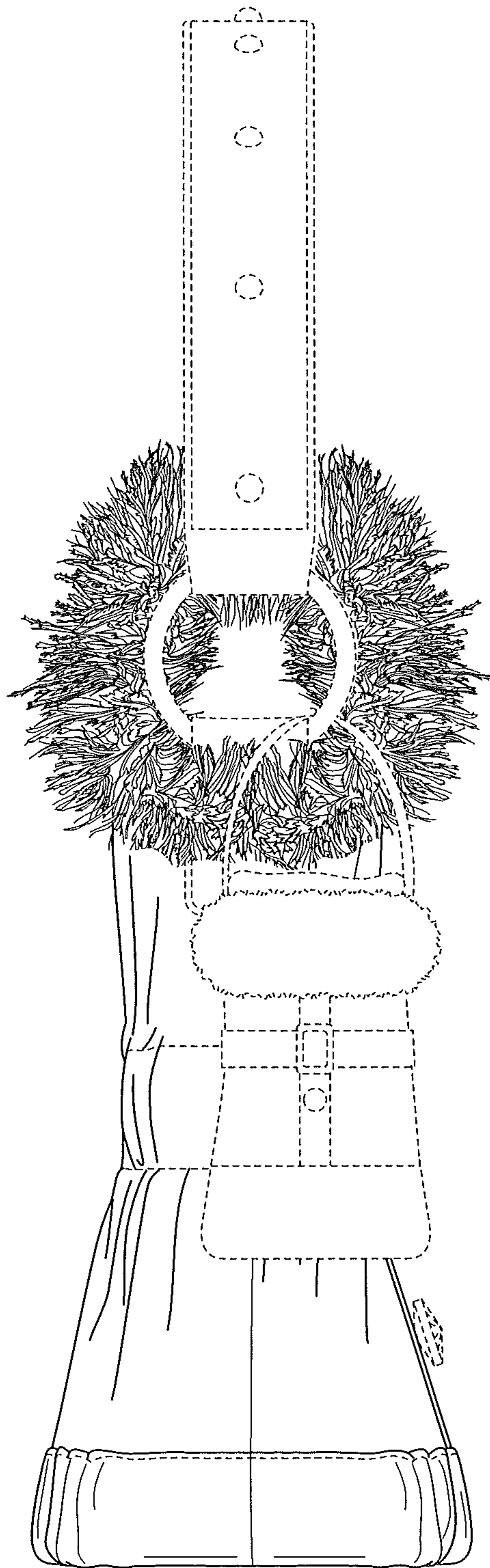

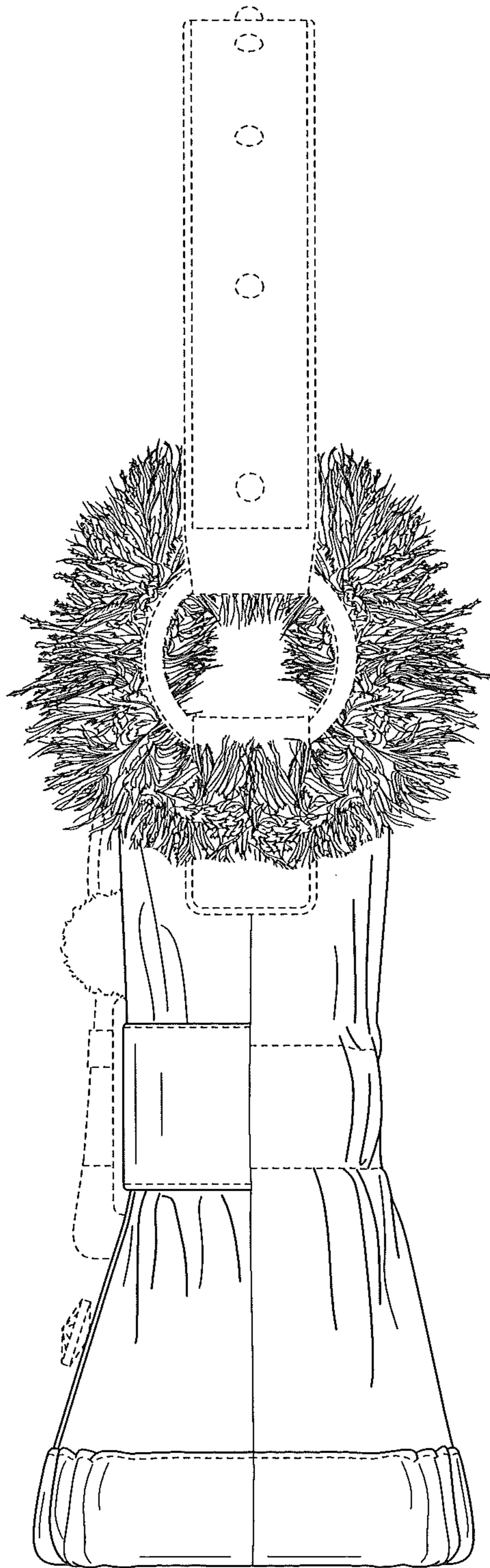

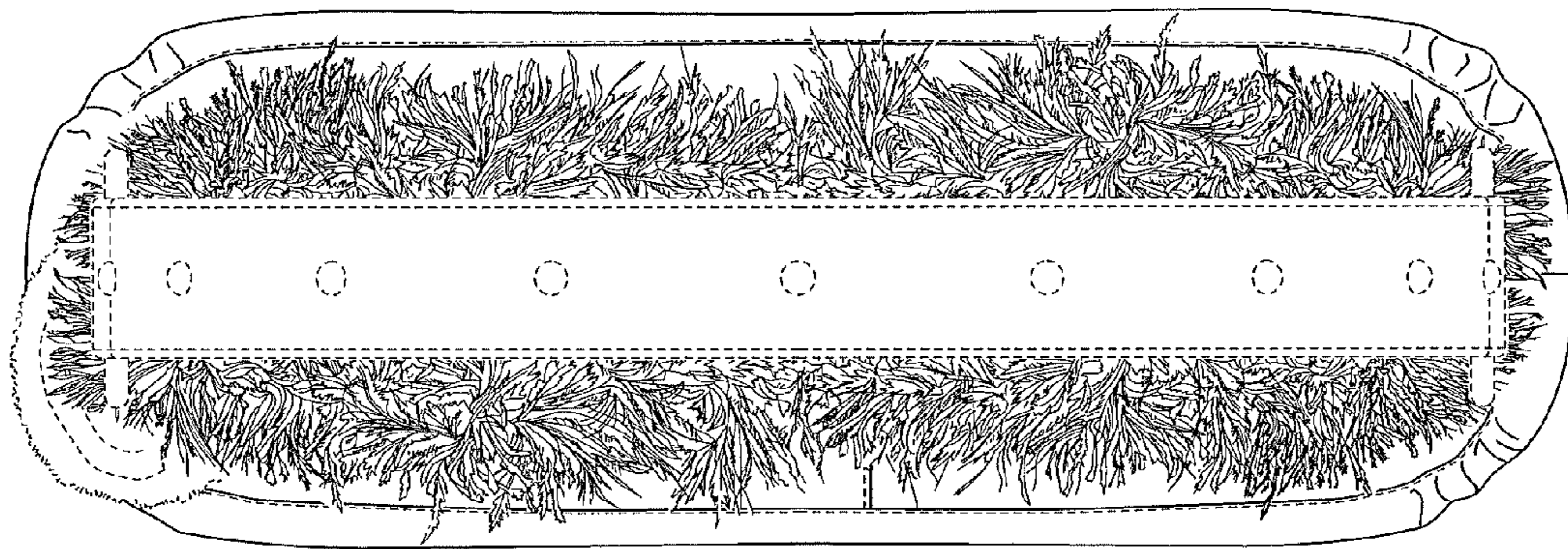

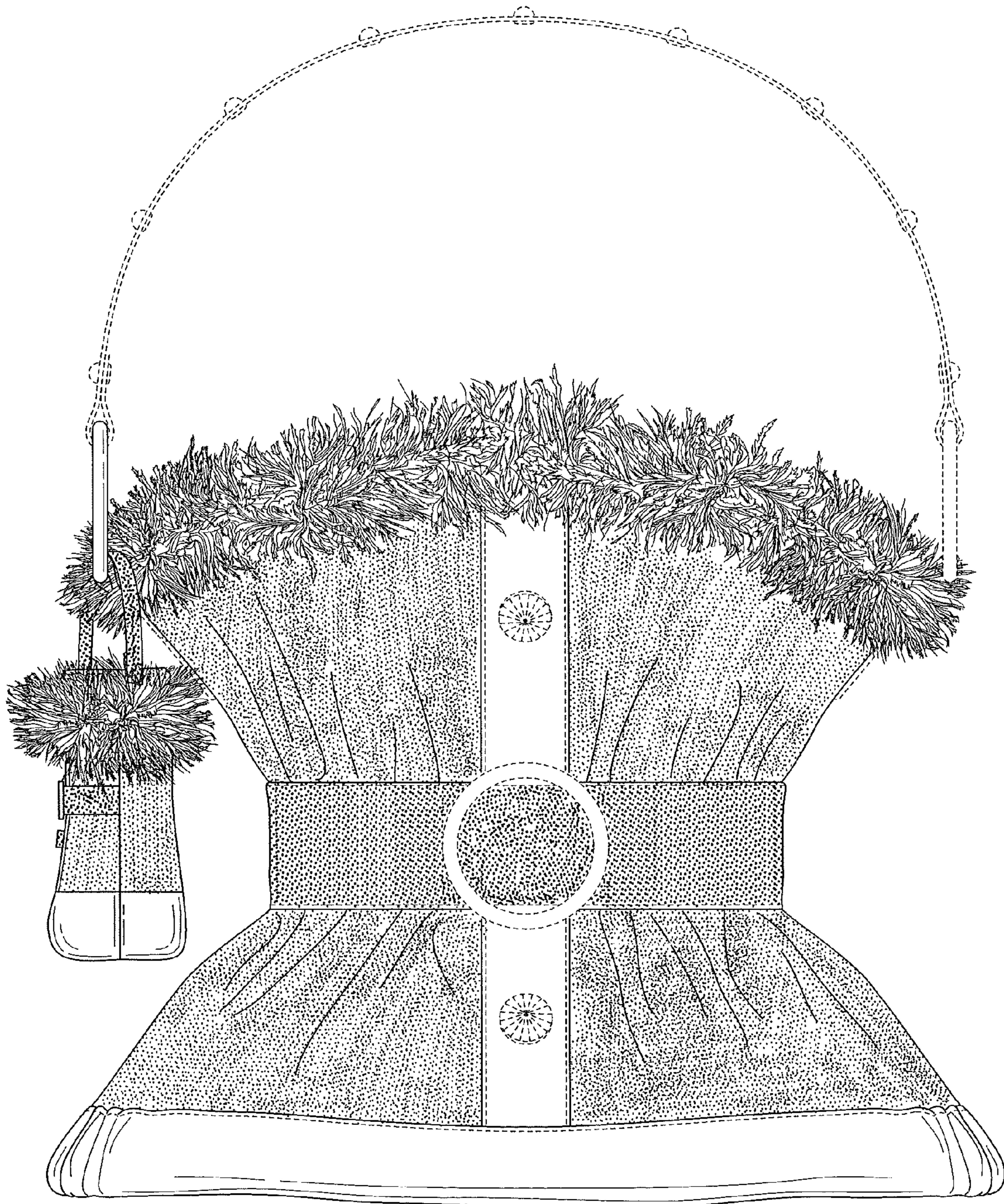

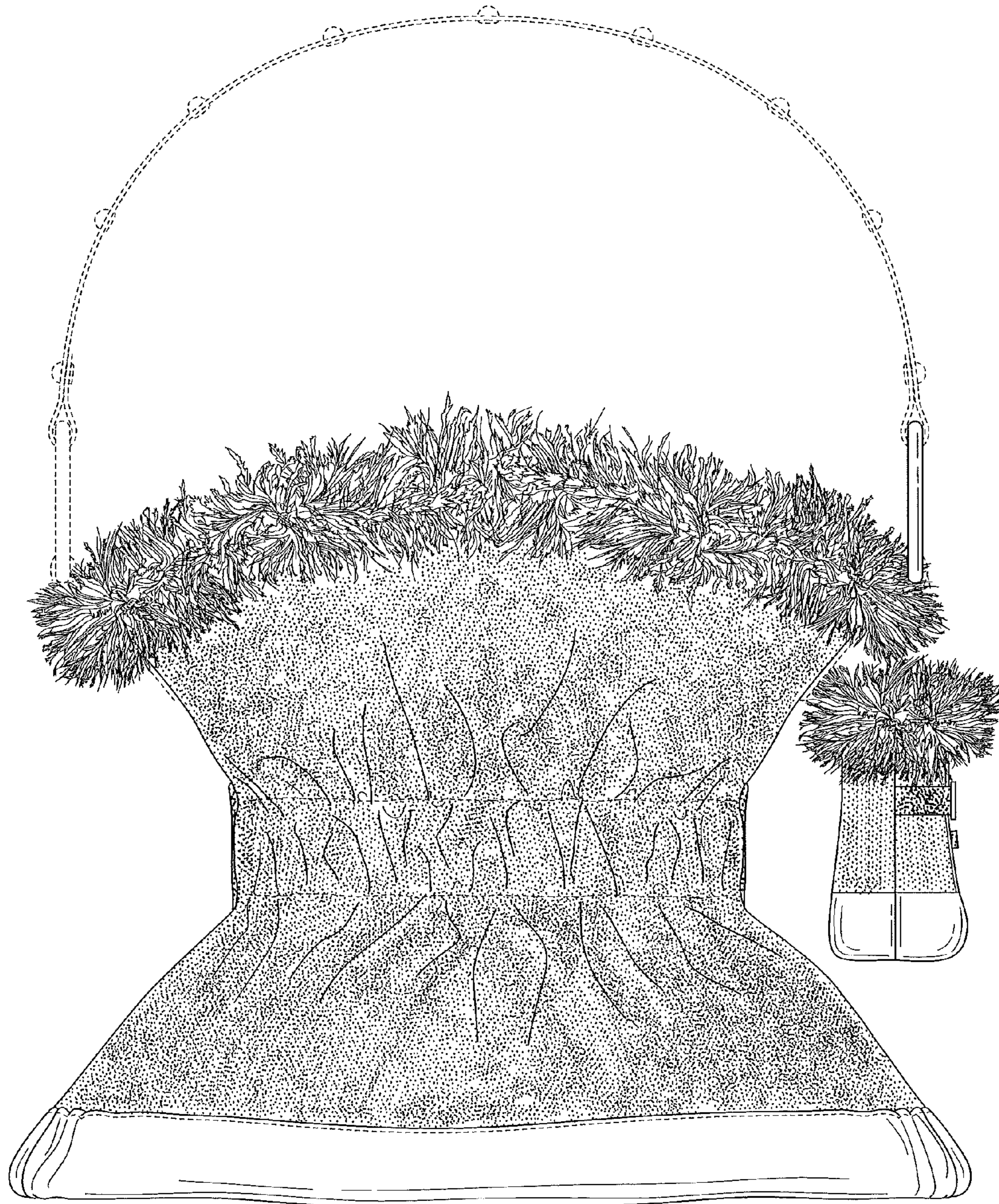

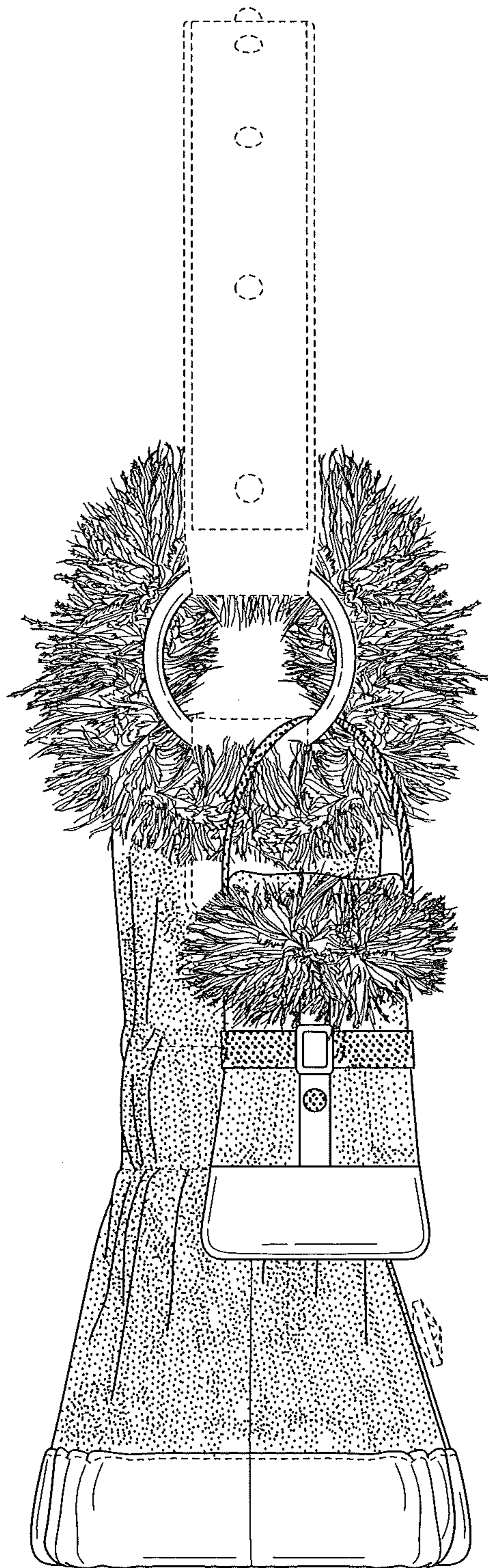

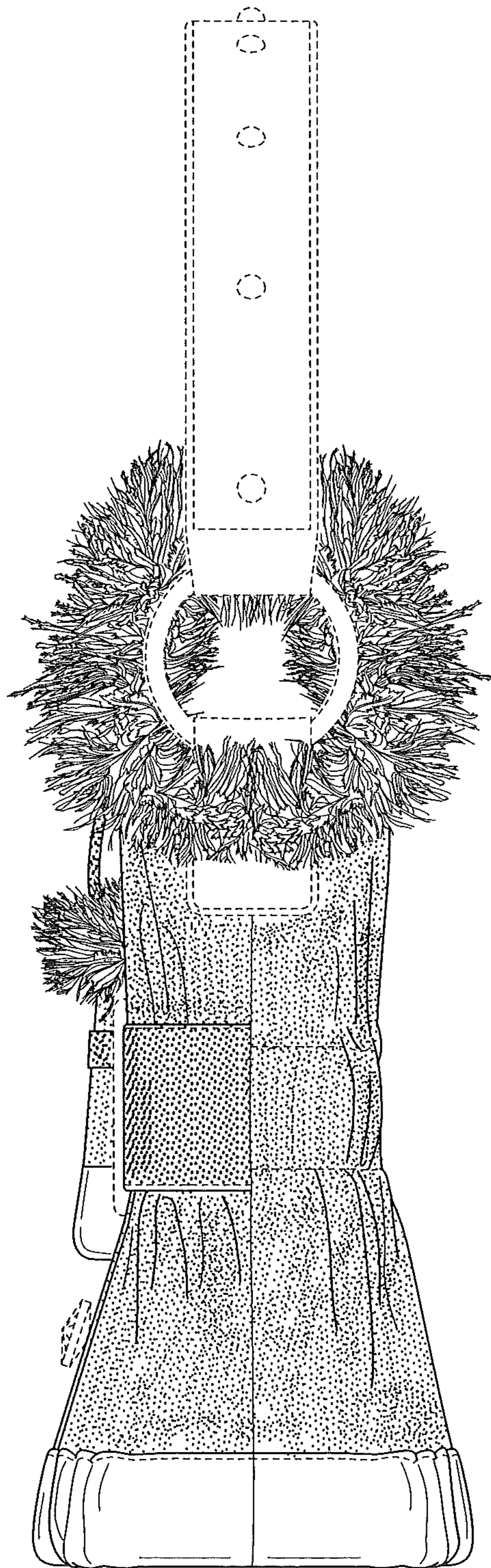

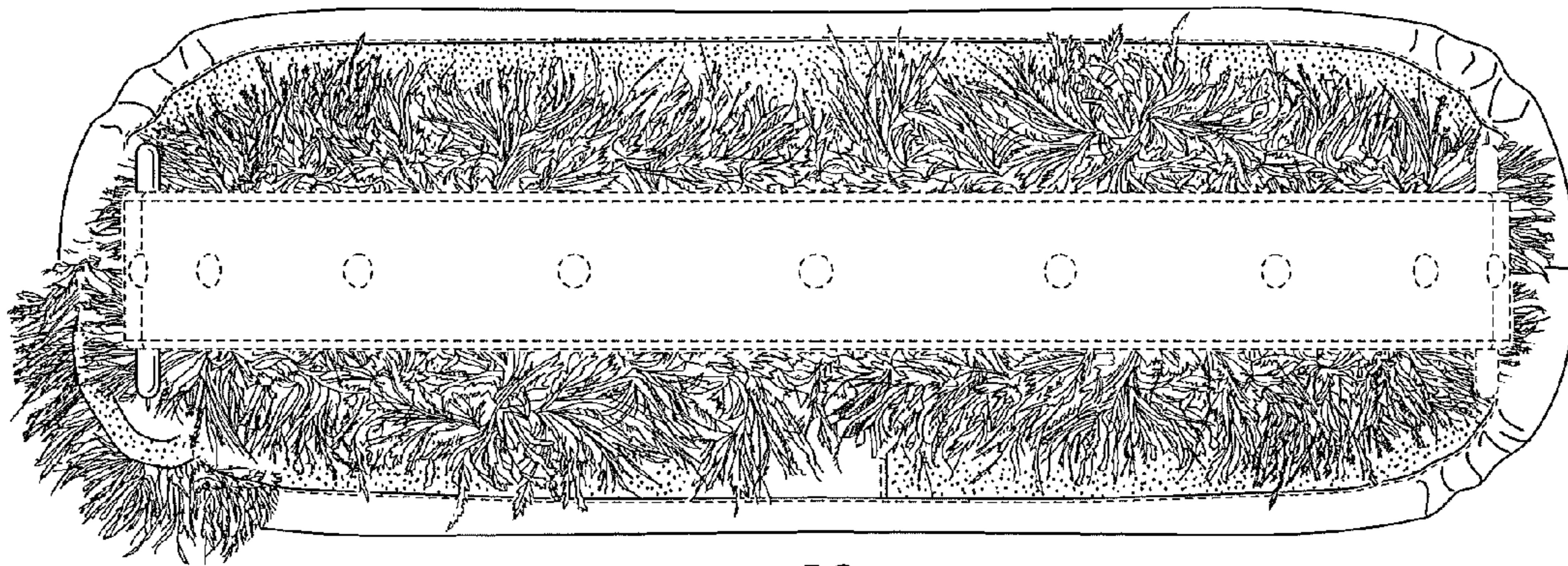
