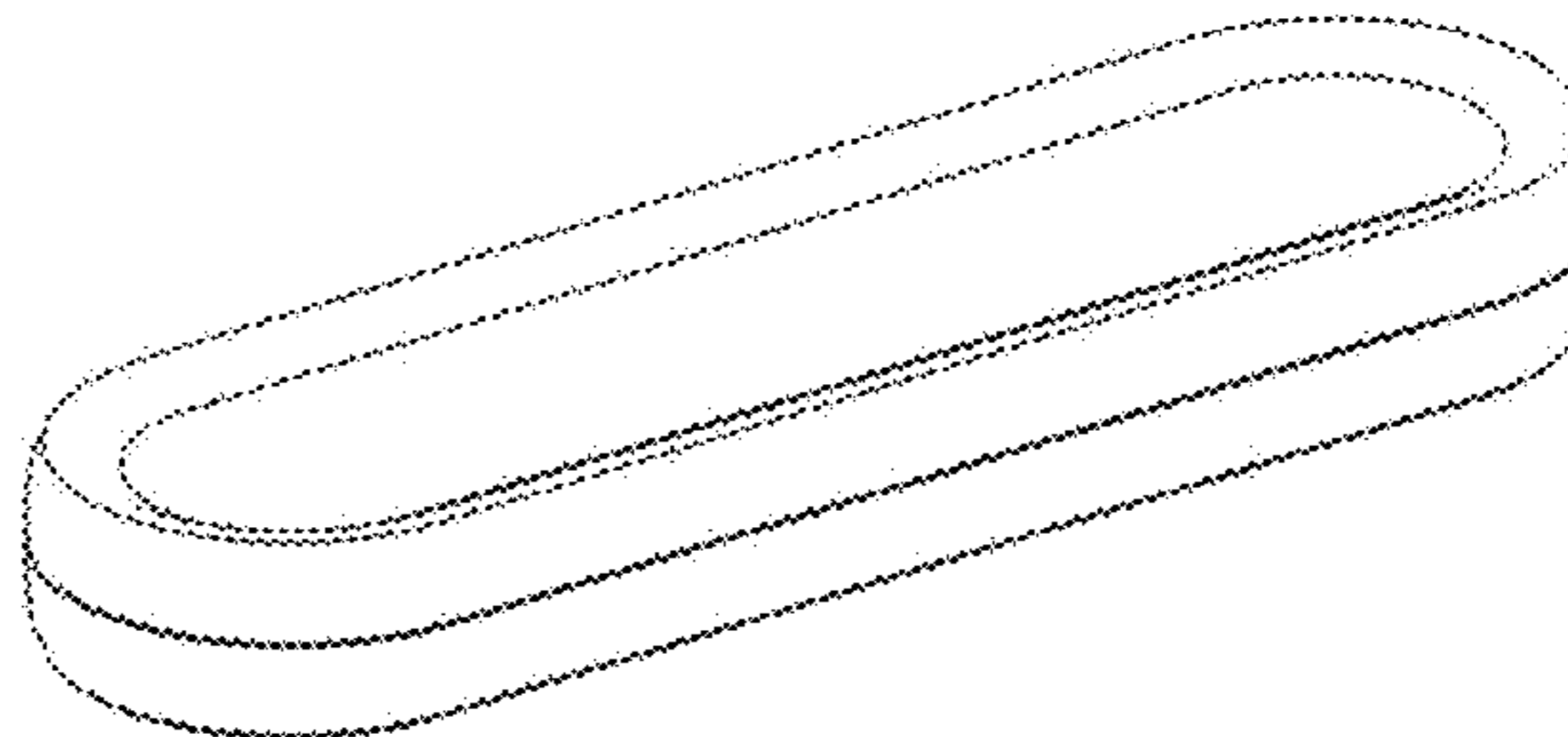
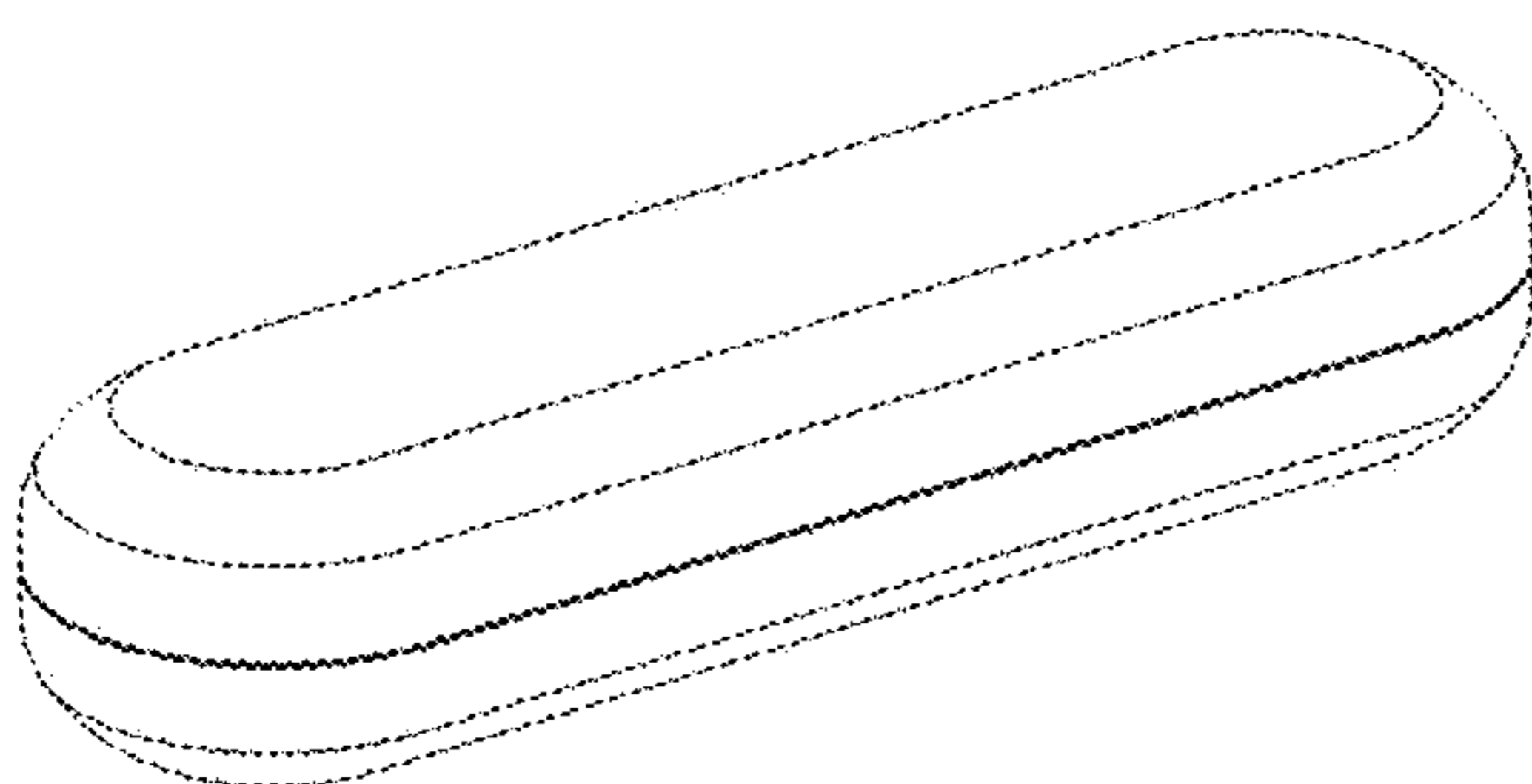
(57) **CLAIM**

The ornamental design for a extendable spectacle case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of the extendable spectacle case in extended form illustrating the novel design. FIG. 2 is a front left perspective view of the extendable spectacle case in extended form of FIG. 1, when open. FIG. 3 is a front left perspective view of the extendable spectacle case in non-extended, collapsed form of FIG. 1. FIG. 4 is a front left perspective view of the extendable spectacle case in non-extended form of FIG. 3, when open. FIG. 5 is a top view of the extendable spectacle case in extended form of FIG. 1, a bottom view is the same as the top view. FIG. 6 is a front view of the extendable spectacle case in extended form of FIG. 1. FIG. 7 is a middle cross section view of the extendable spectacle case in extended form of FIG. 1. FIG. 8 is a rear view of the extendable spectacle case in extended form of FIG. 1. FIG. 9 is a right side view of the extendable spectacle case in extended form, with the front at the bottom and the rear at the top, of FIG. 1; a left side view is the same as the right side view. FIG. 10 is a top view of the extendable spectacle case in non-extended, collapsed form of FIG. 3; a bottom view is the same as the top view. FIG. 11 is a front view of the extendable spectacle case in non-extended form of FIG. 3. FIG. 12 is a middle cross section view of the extendable spectacle case in non-extended form of FIG. 3. FIG. 13 is a rear view of the extendable spectacle case in extended form of FIG. 3; and, FIG. 14 is a right side view of the extendable spectacle case in non-extended form, with the front at the bottom and the rear at the top, of FIG. 3; a left side view is the same as the right side view.

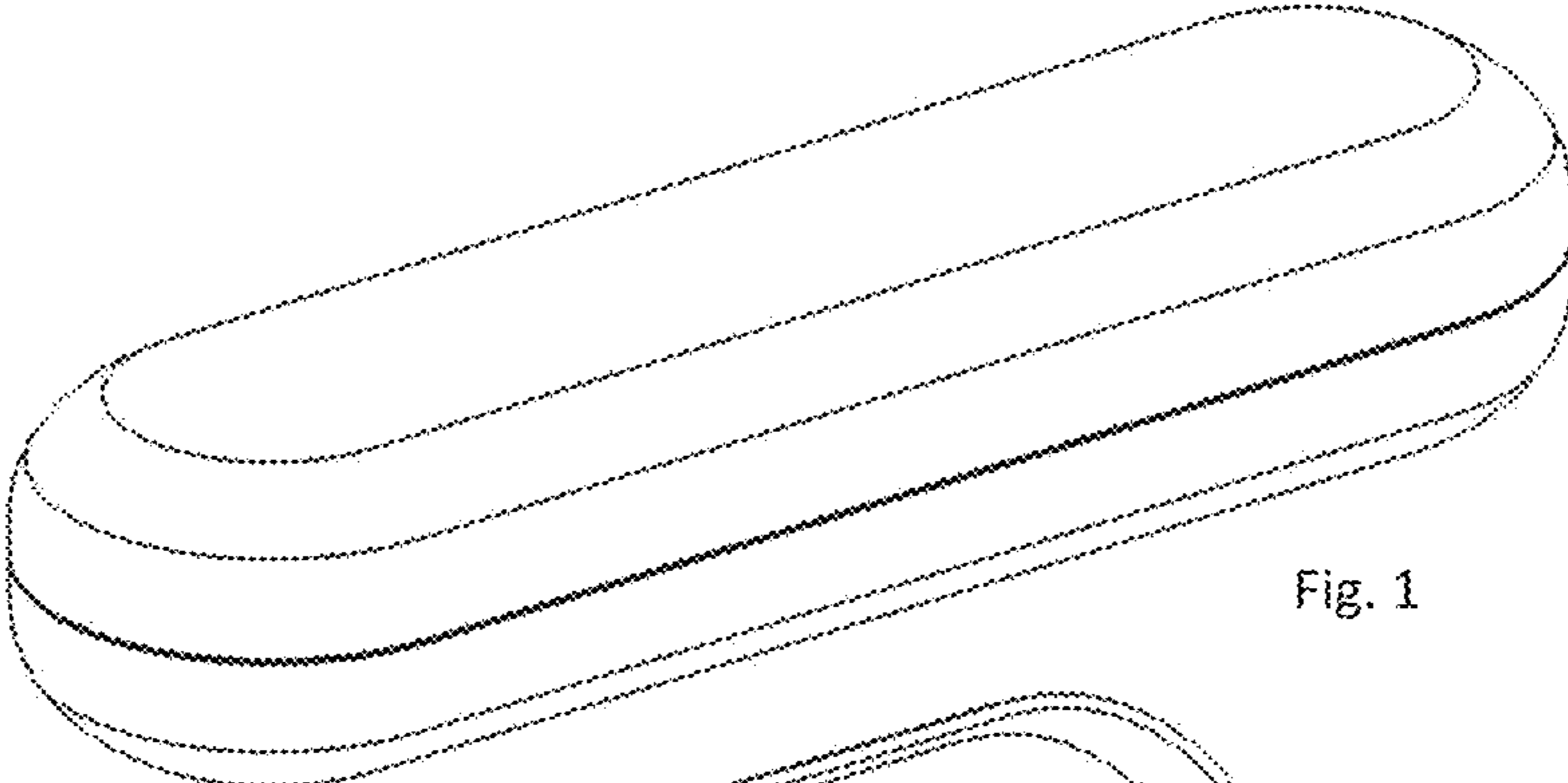

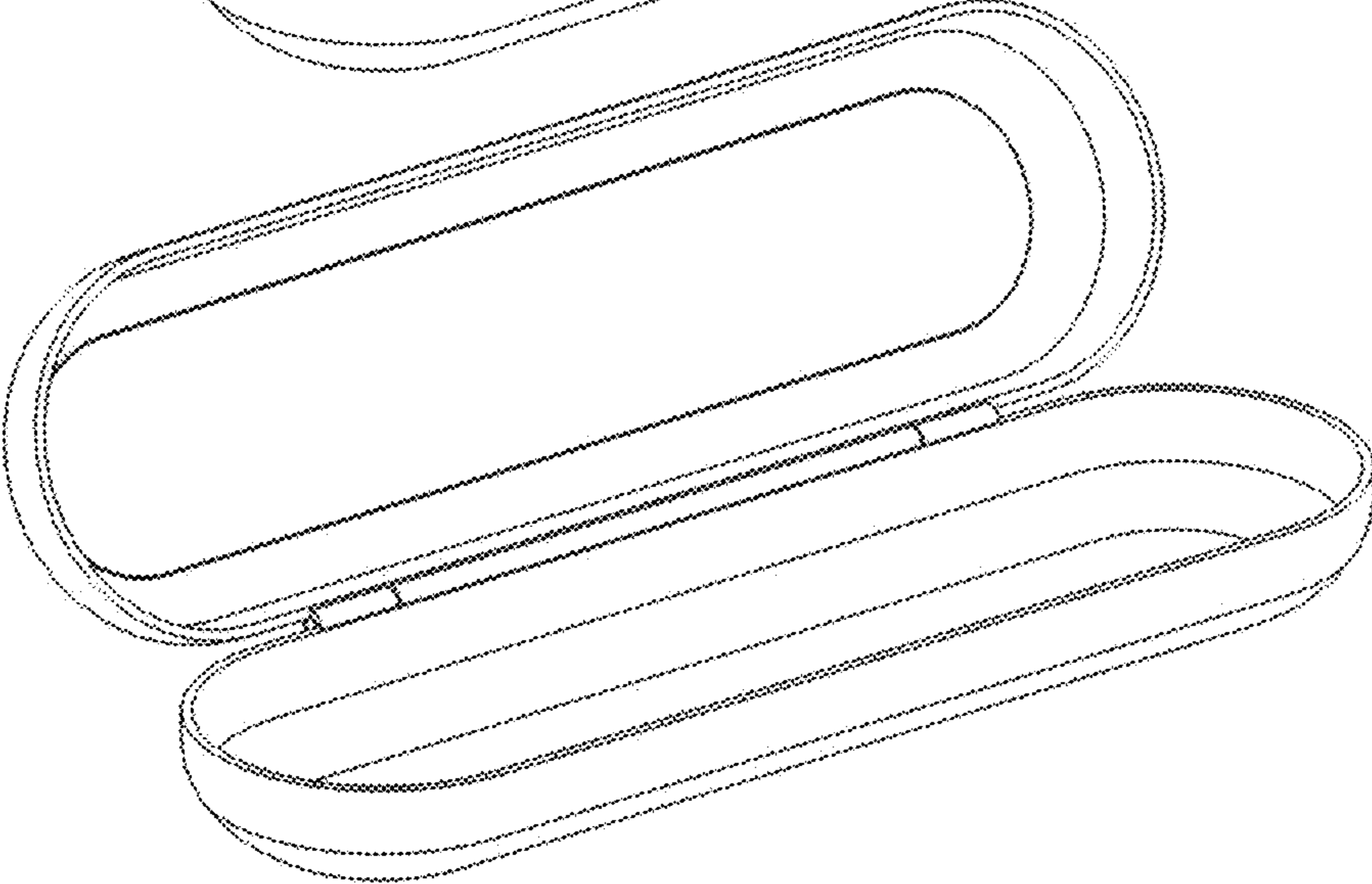

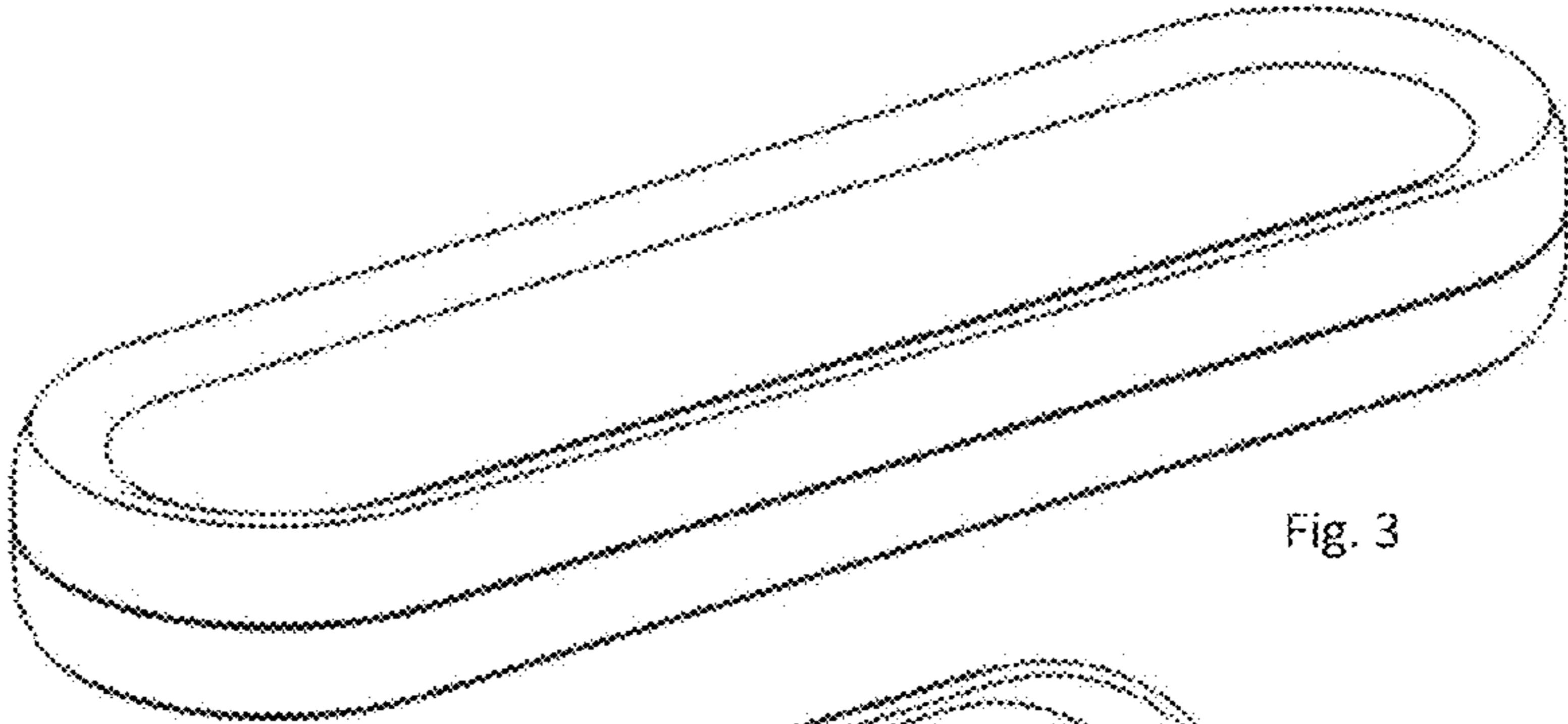

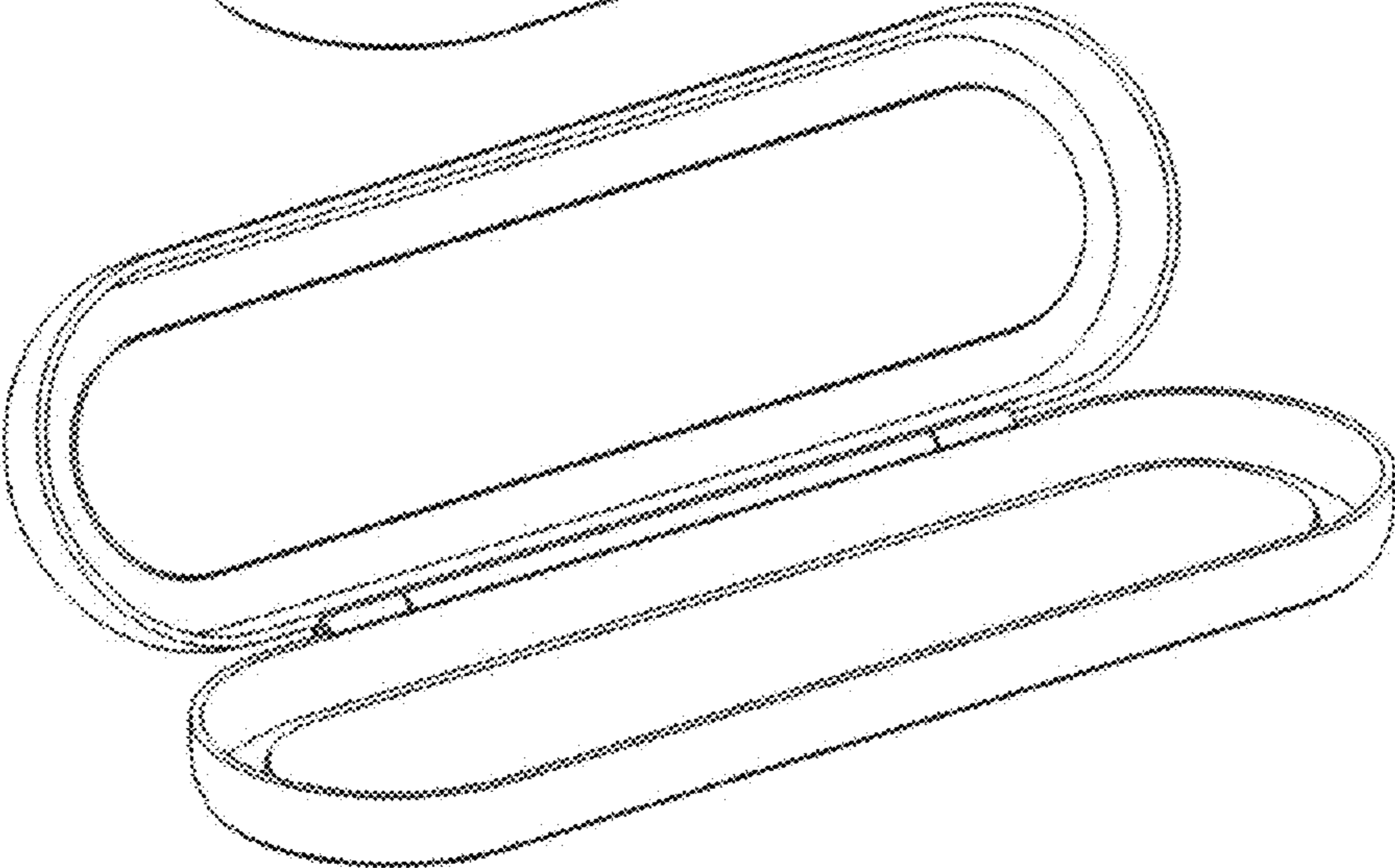

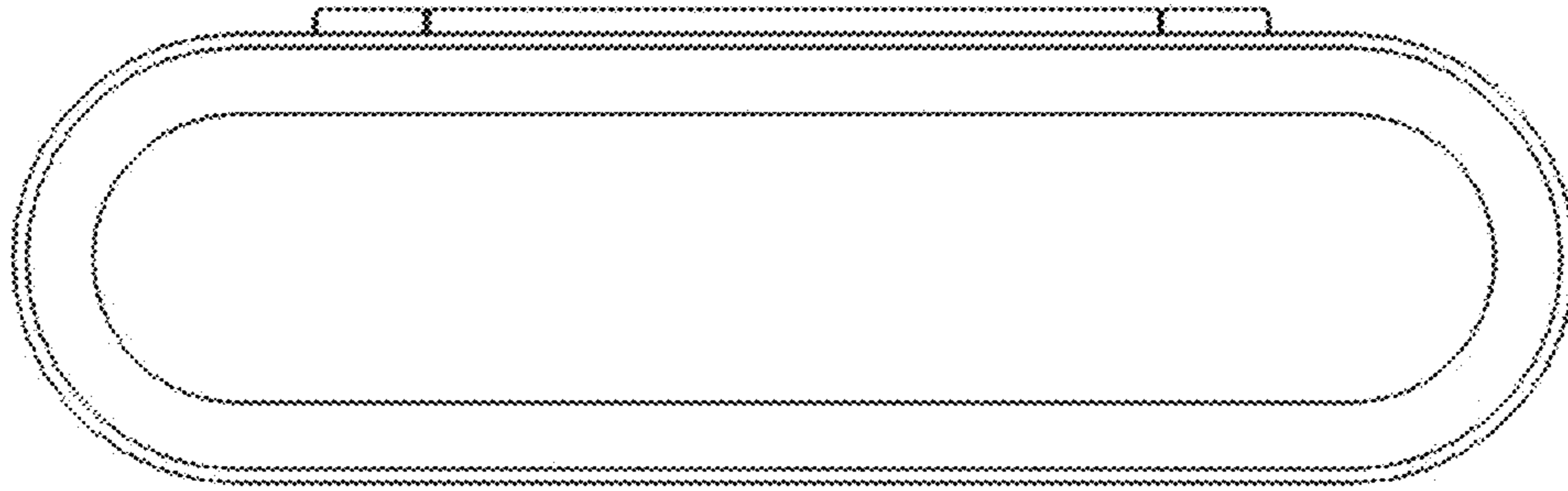

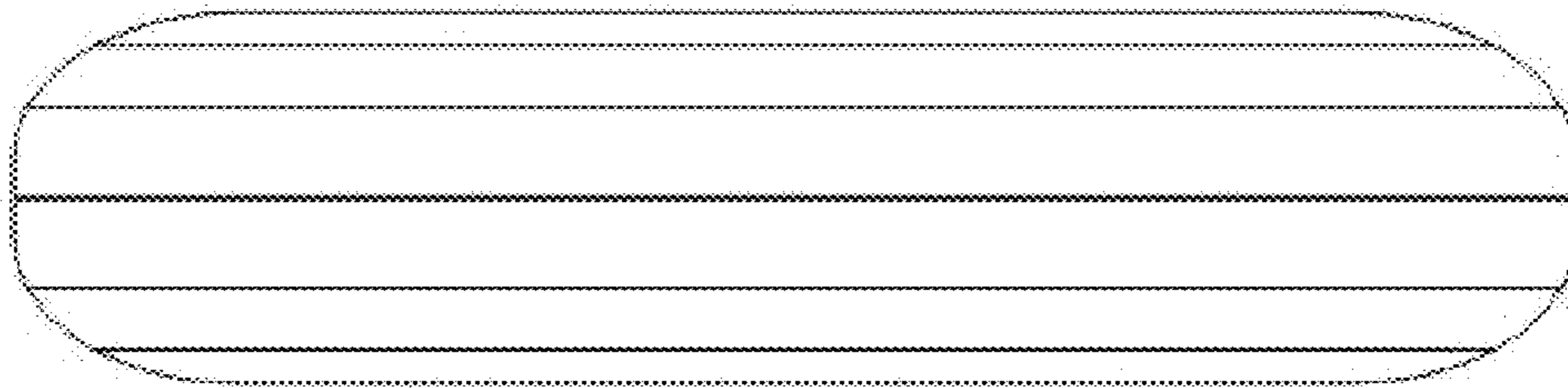

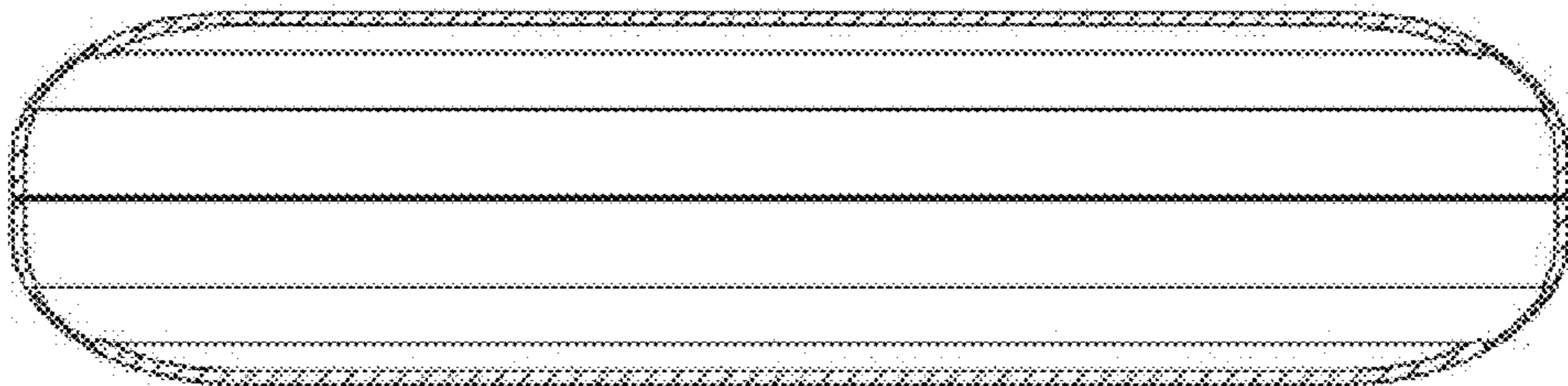

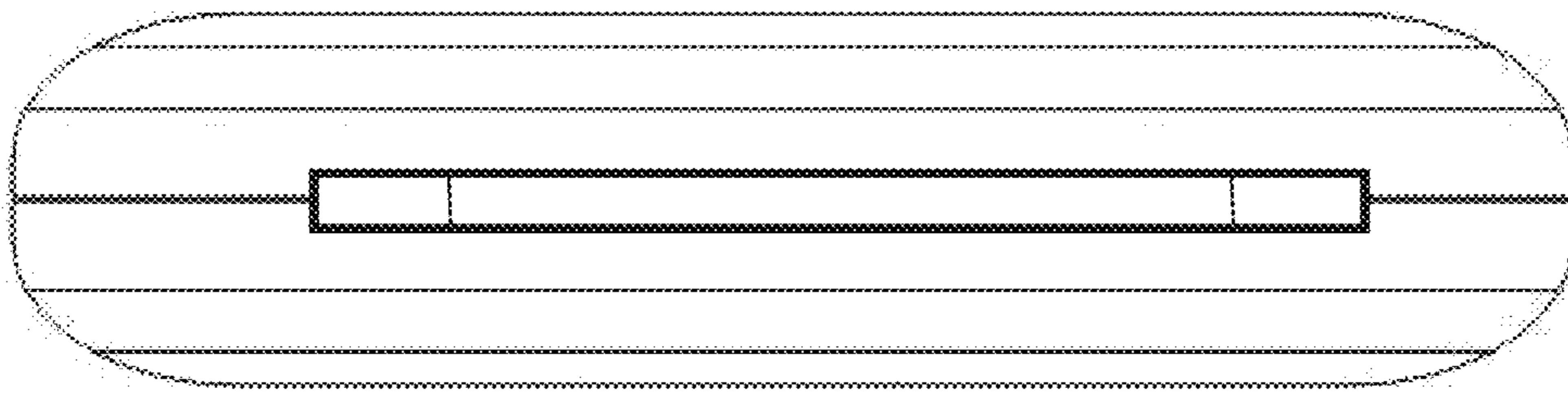

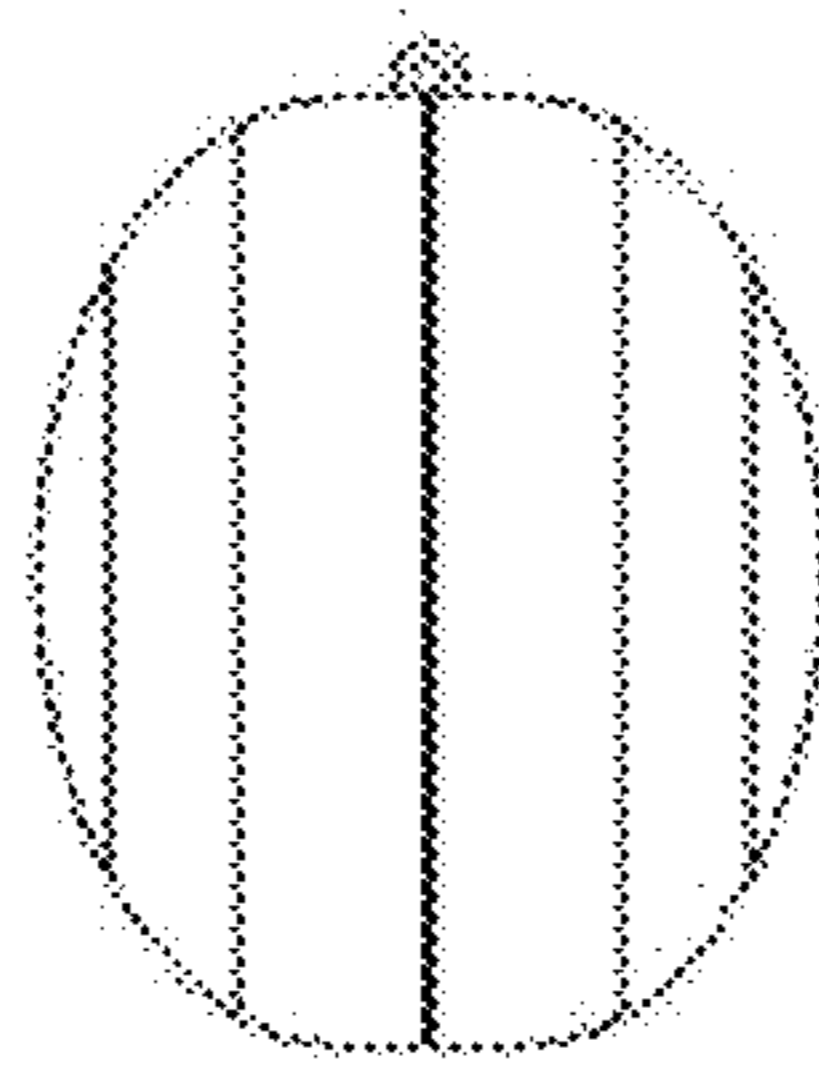

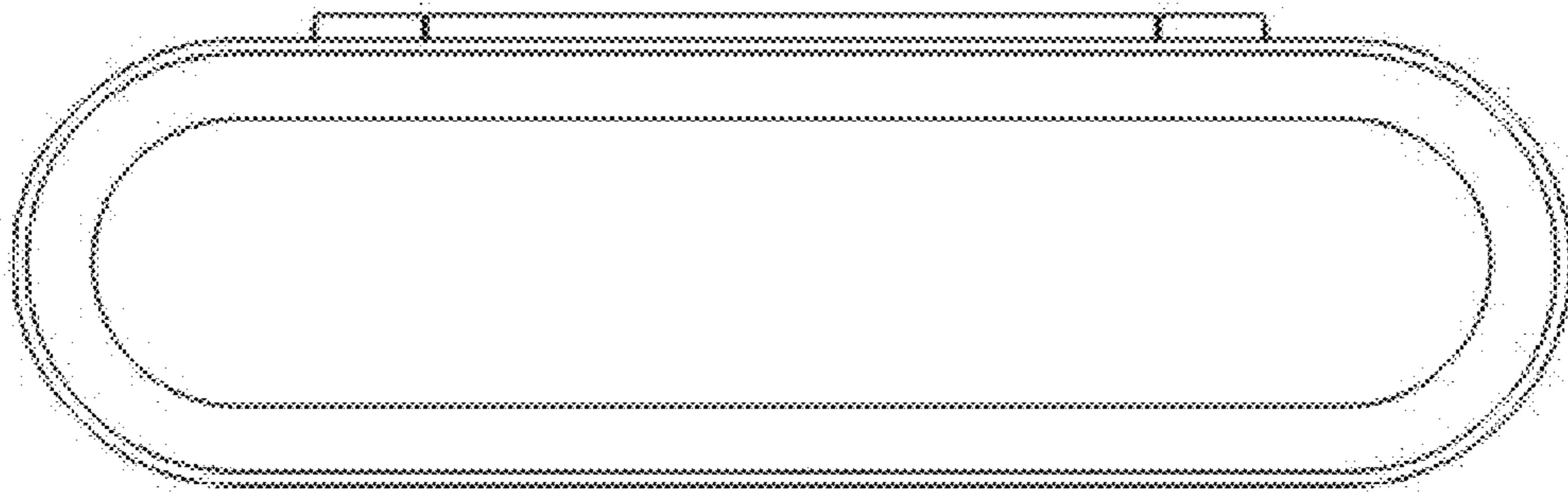

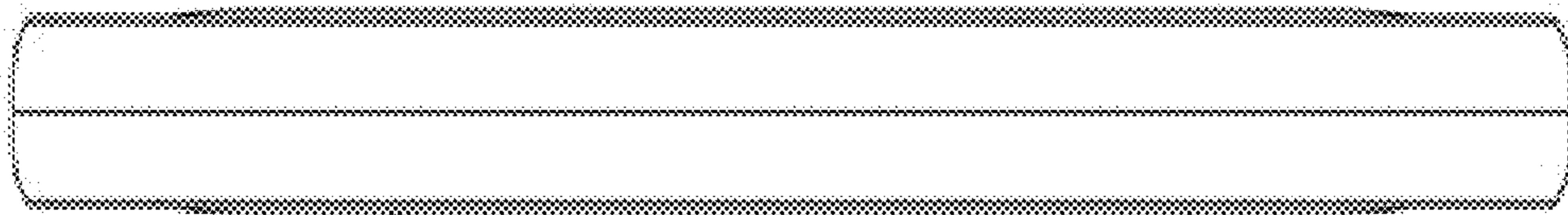

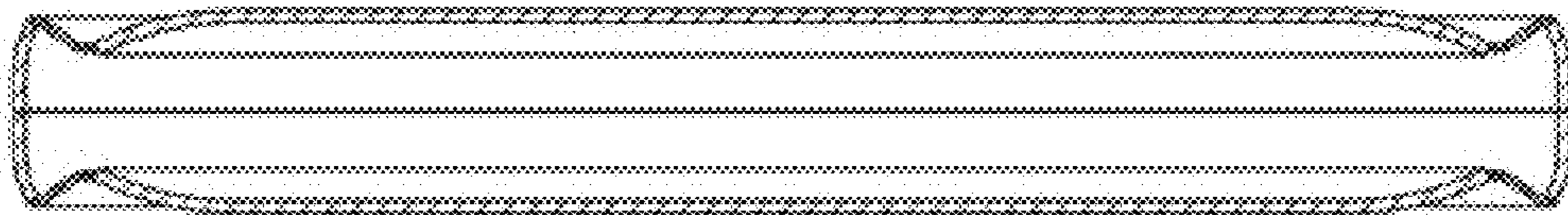

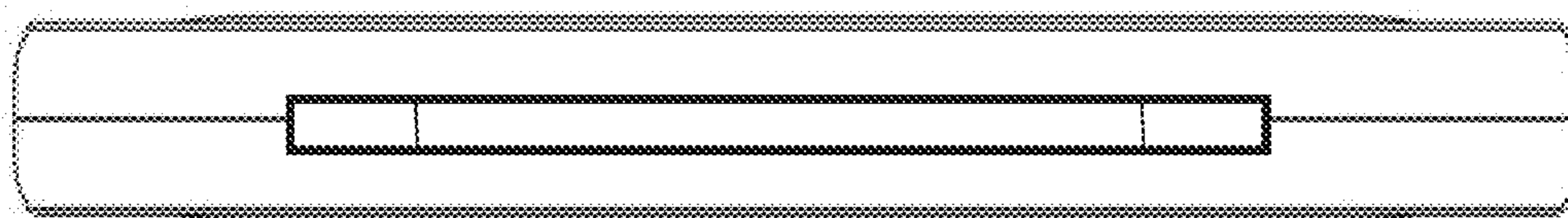

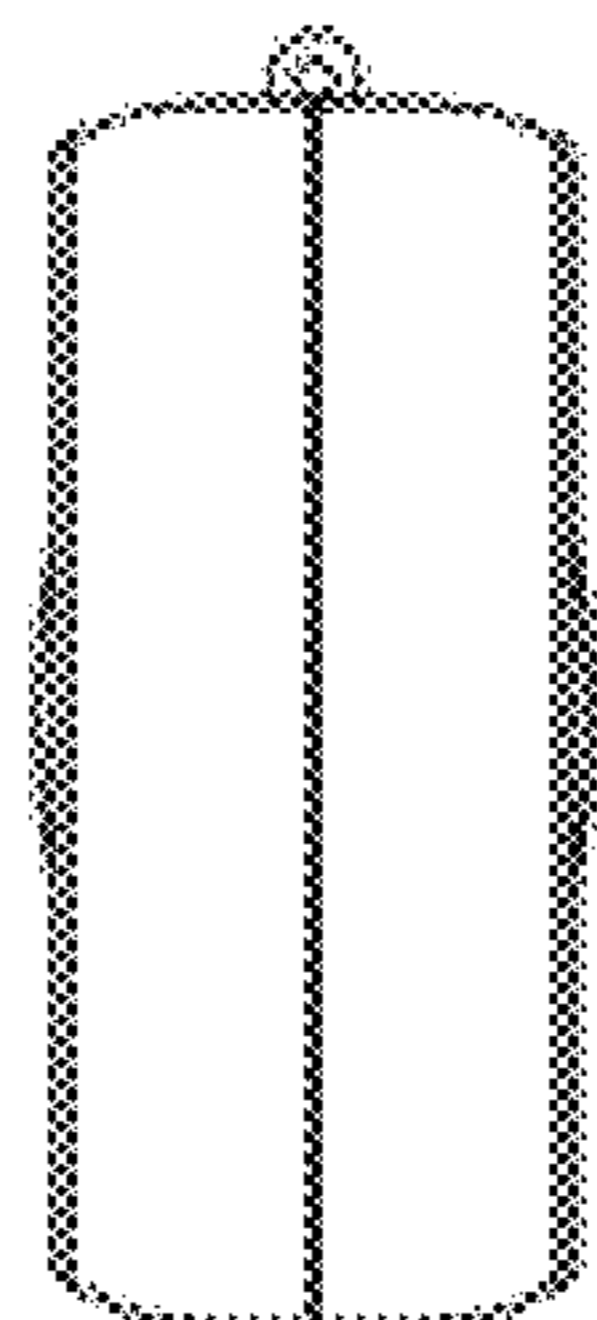
