(57) **CLAIM**

I claim the ornamental design for a toilet roll holder, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a toilet roll holder showing my new design;
FIG. 2 is a front view of the toilet roll holder of FIG. 1;
FIG. 3 is a rear view of the toilet roll holder of FIG. 1;
FIG. 4 is a left side view of the toilet roll holder of FIG. 1;
