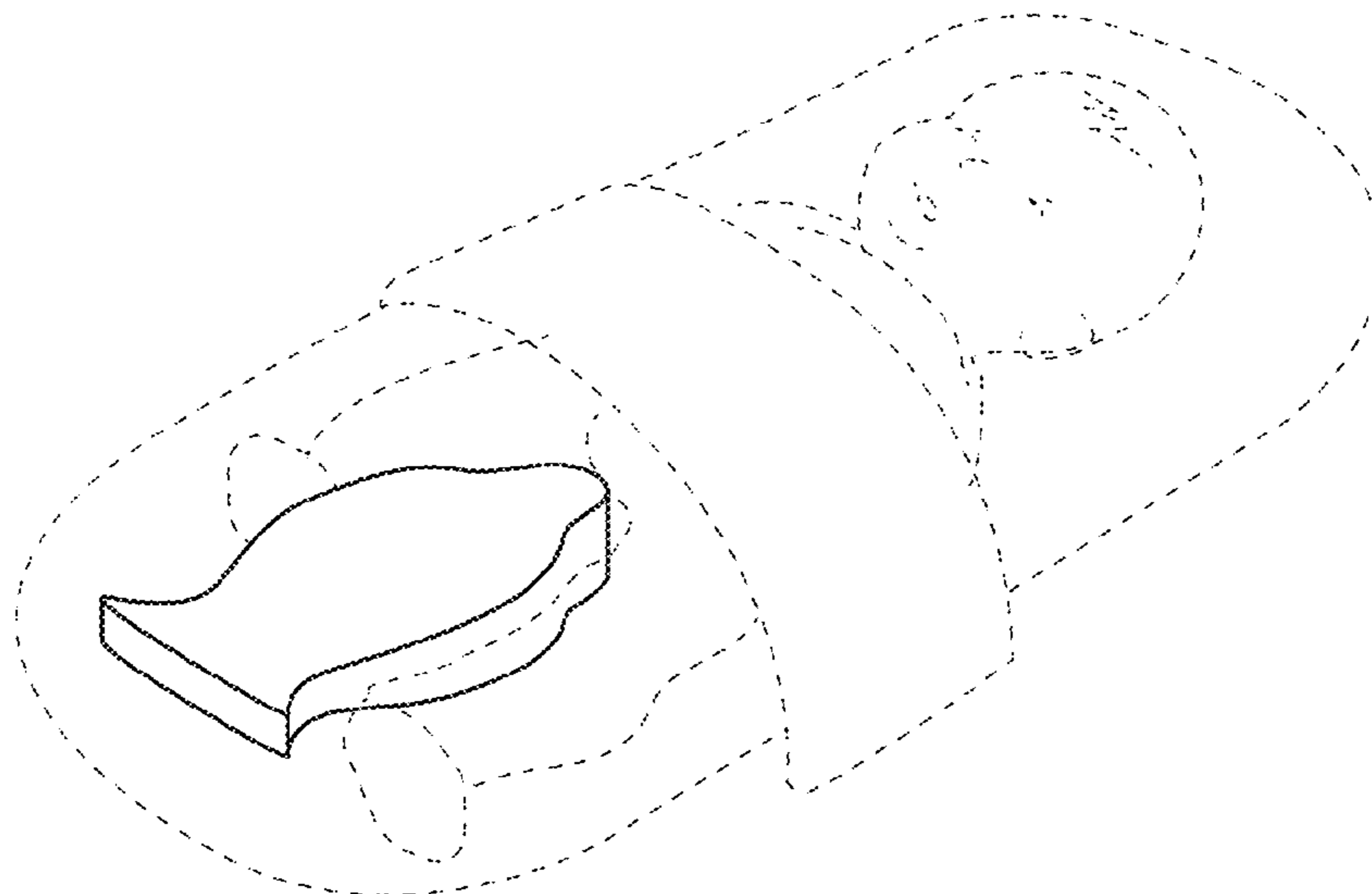
(57) **CLAIM**

The ornamental design for an infant mattress leg divider, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an infant mattress leg divider showing our new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left side view thereof with the right side being a mirror image thereof;  
 FIG. 5 is a top view thereof with the bottom being a mirror image thereof; and,  
 FIG. 6 is a perspective view of the leg divider with environment and its intended use shown in broken lines.  
 The broken lines shown are environmental only and form no part of the claimed design.

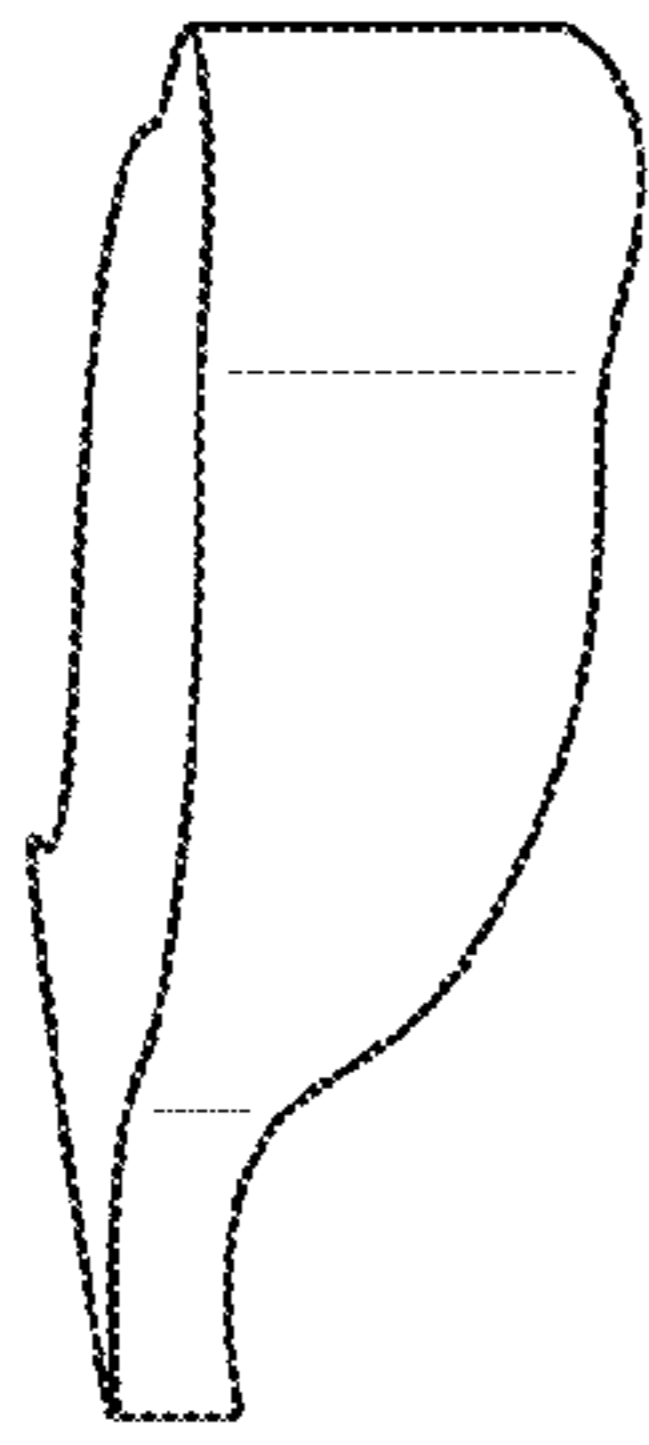

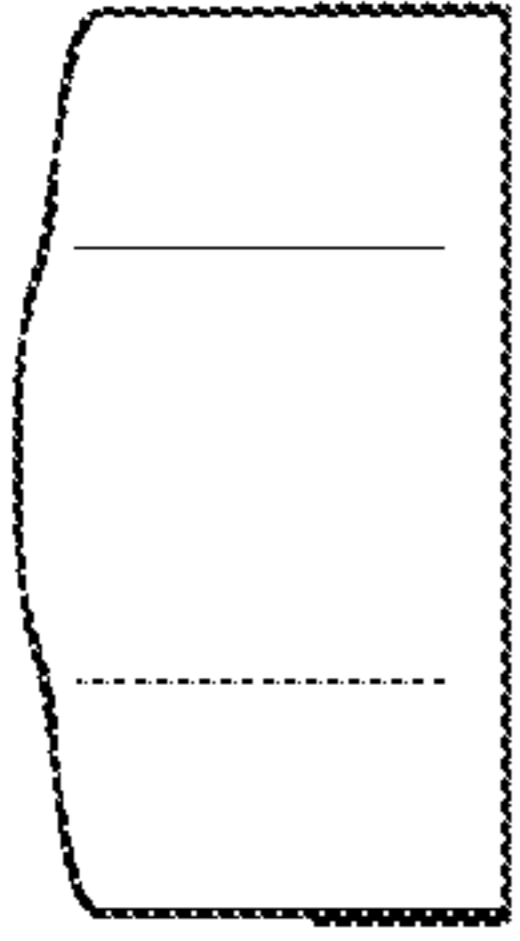

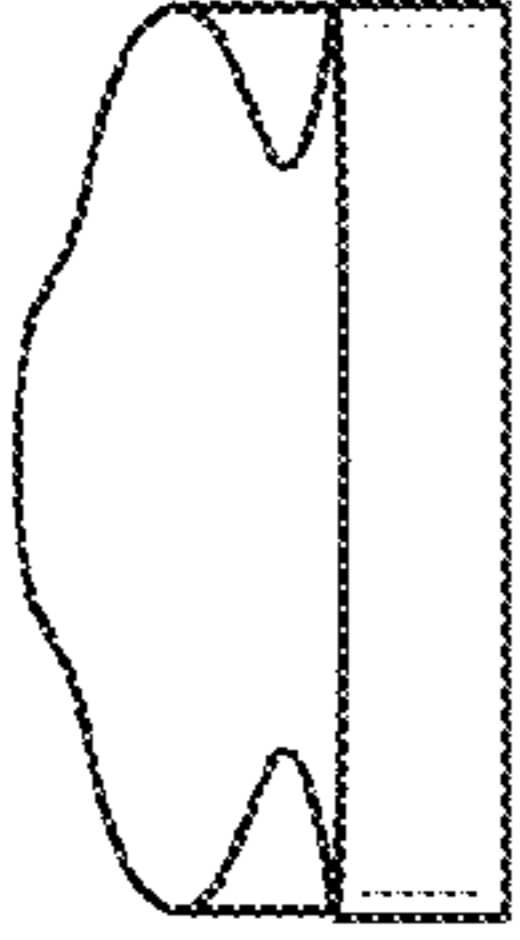

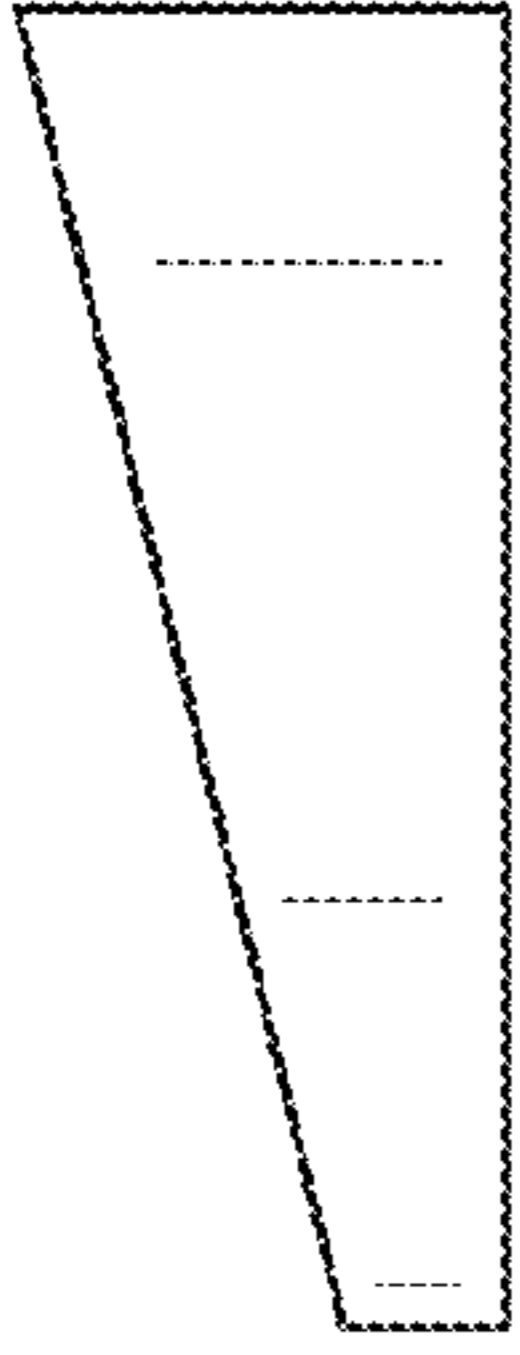

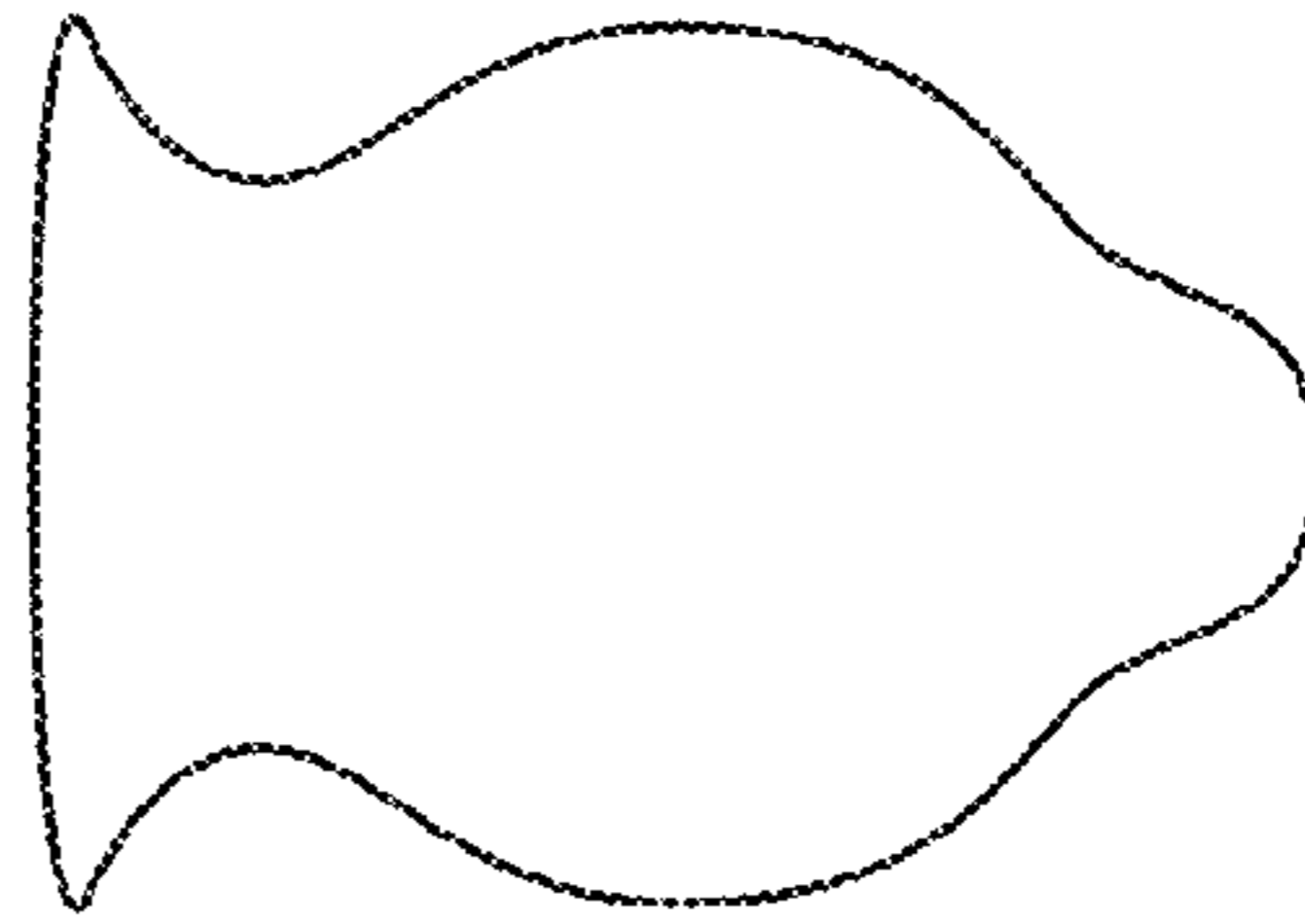

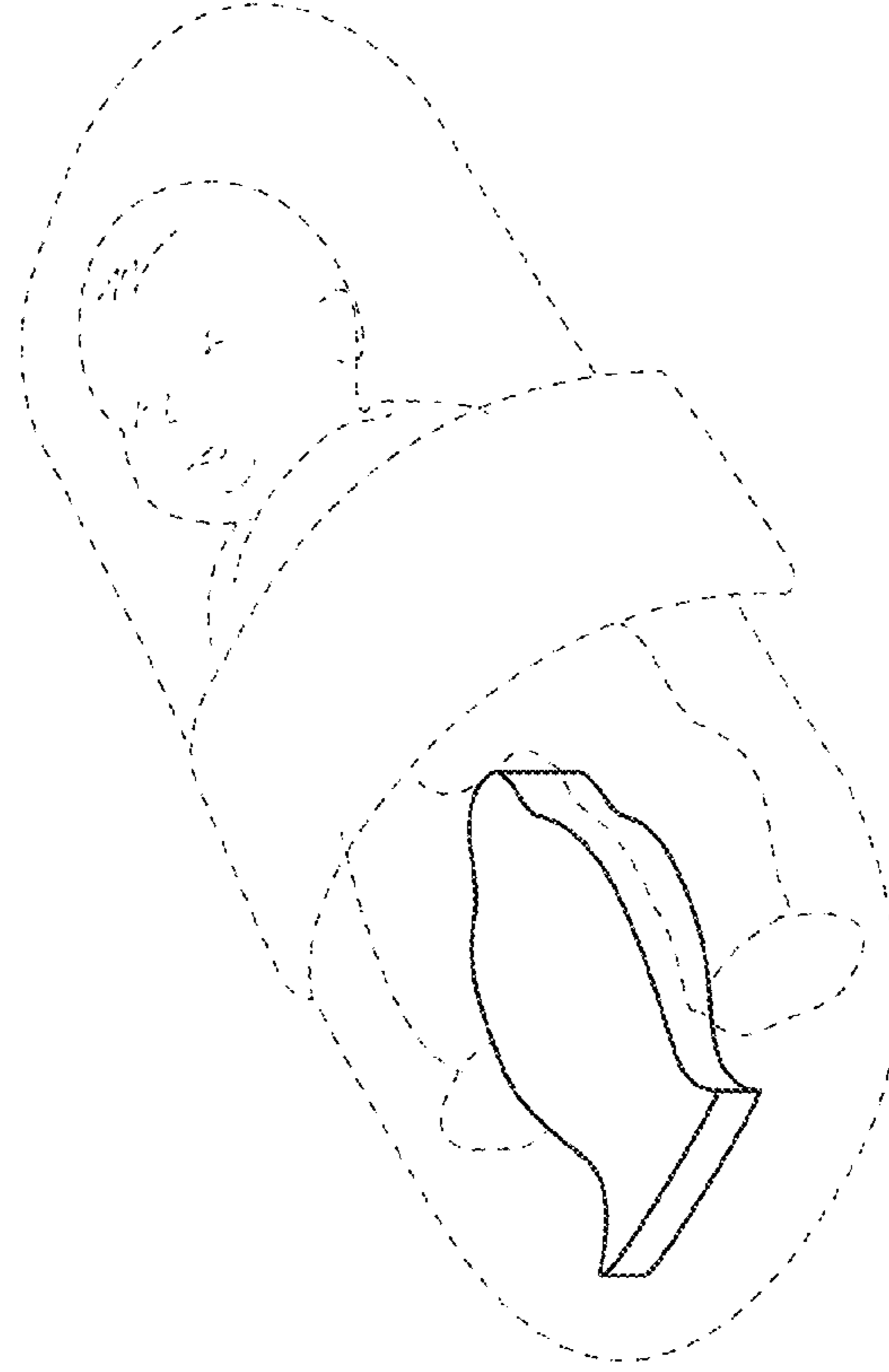
