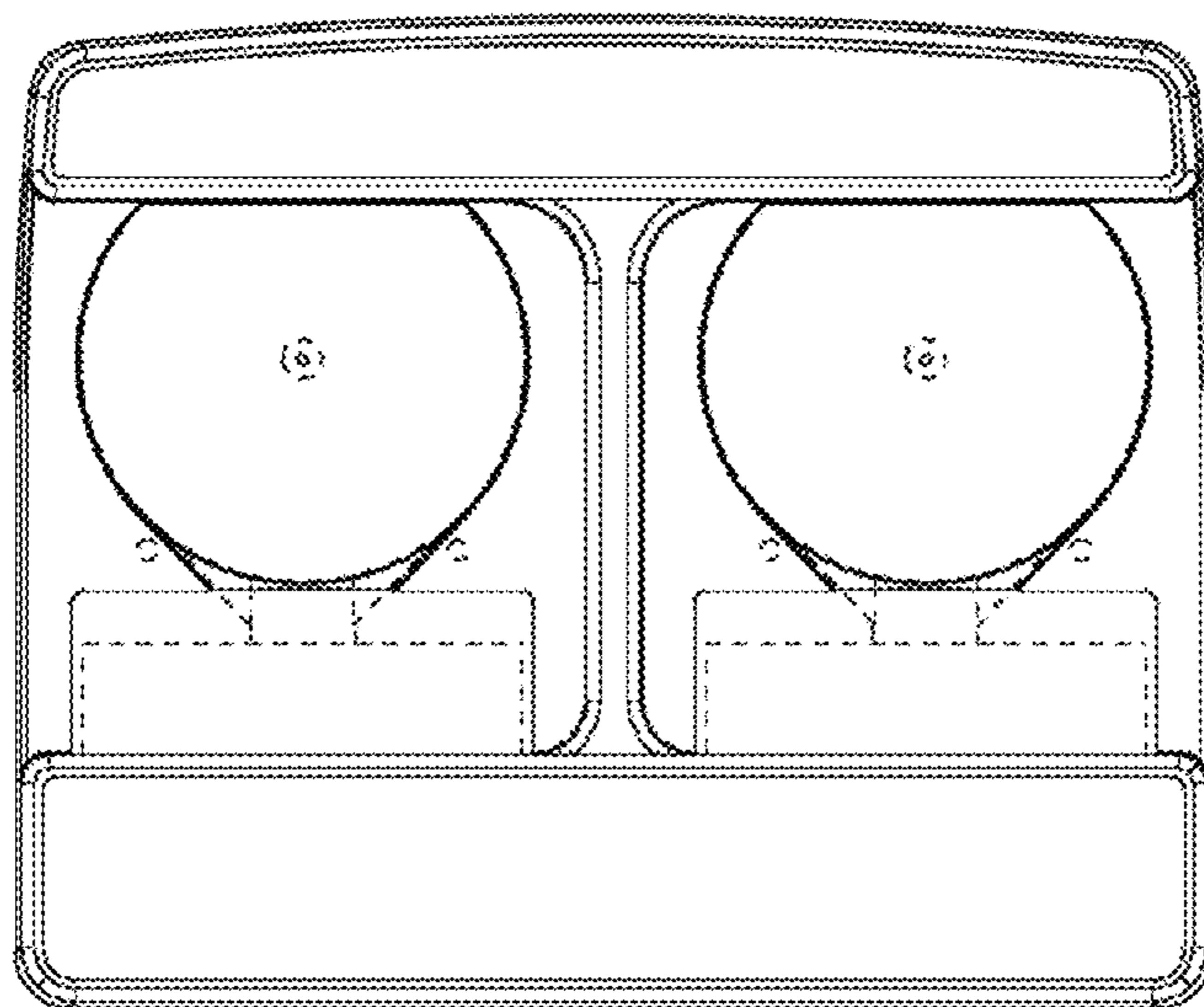
(57) **CLAIM**

The ornamental design for merchandising containers for vehicle lights, as shown and described.

DESCRIPTION

FIG. 1 is a front-side view of a merchandising container for vehicle lights showing the new design;

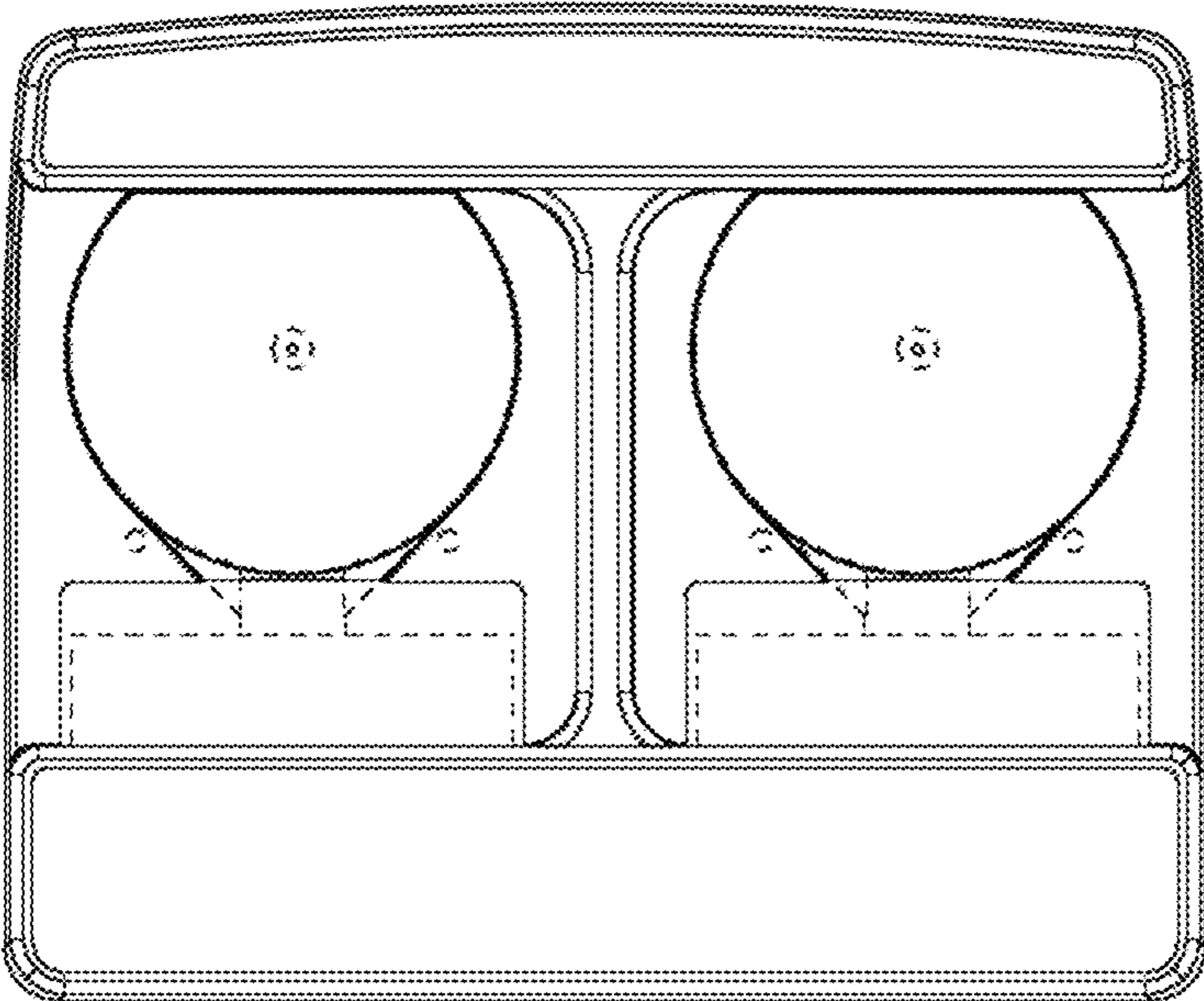

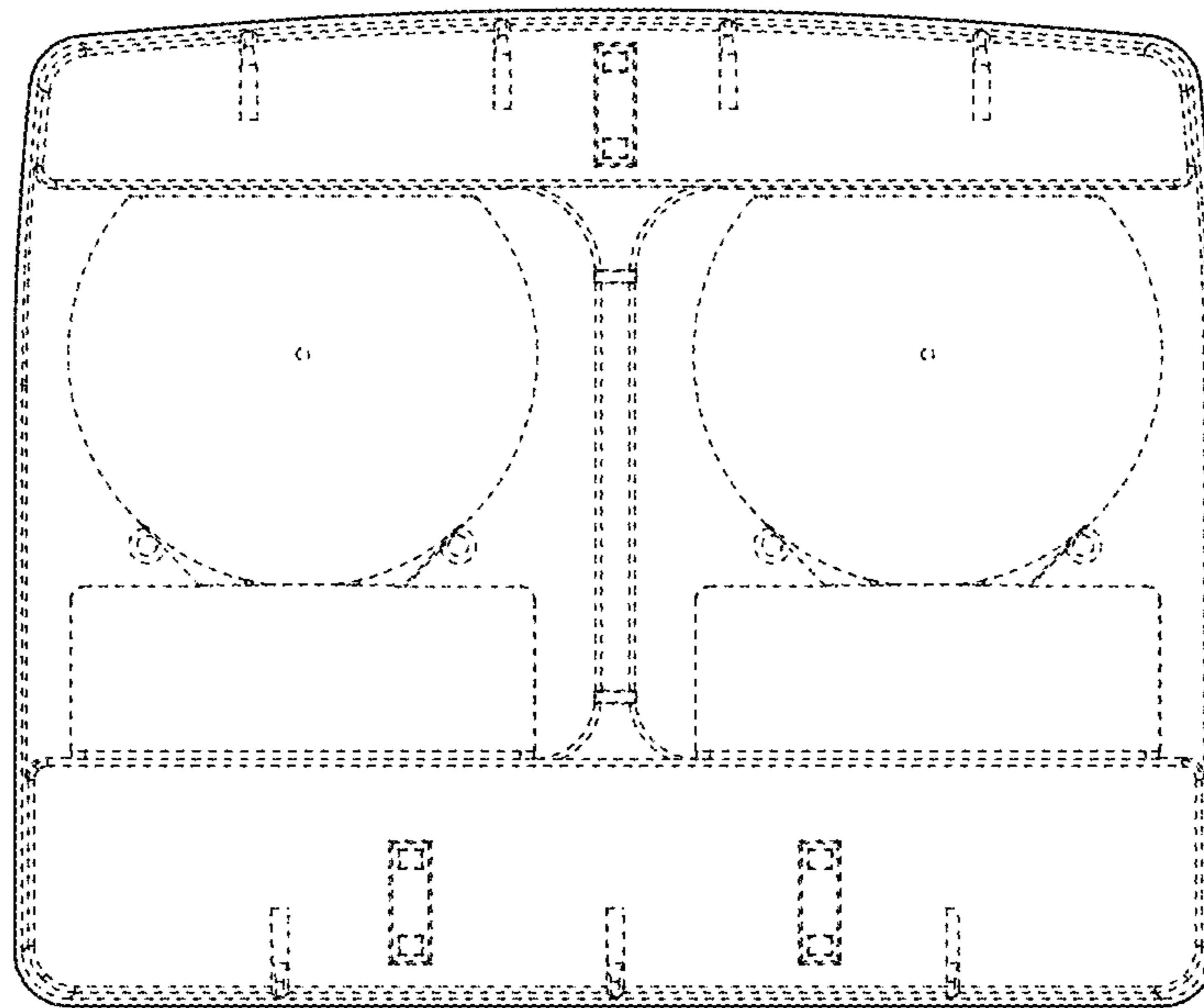

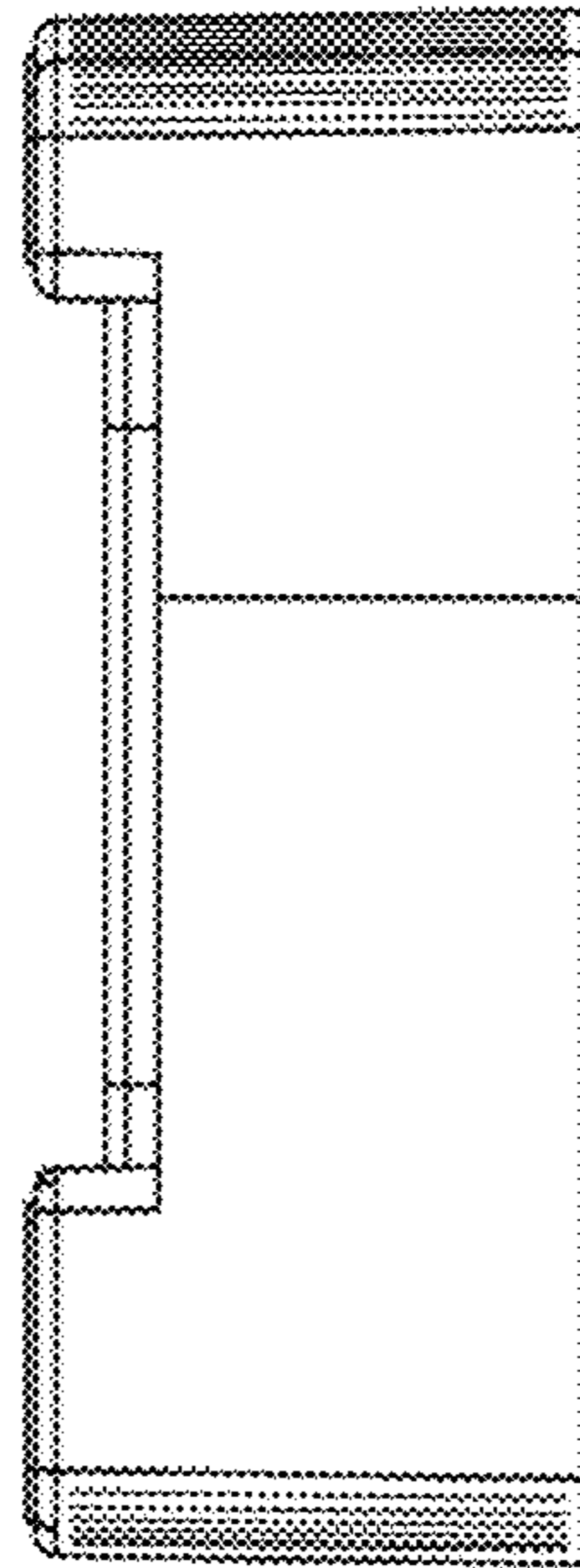

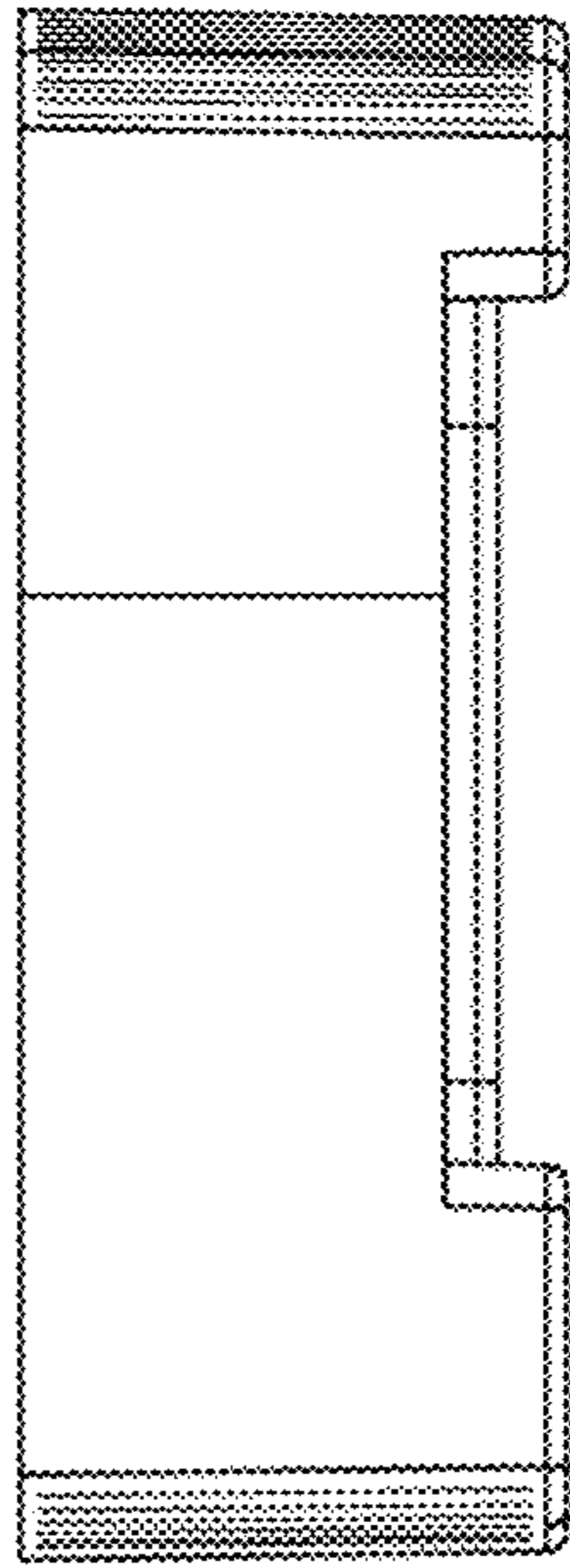

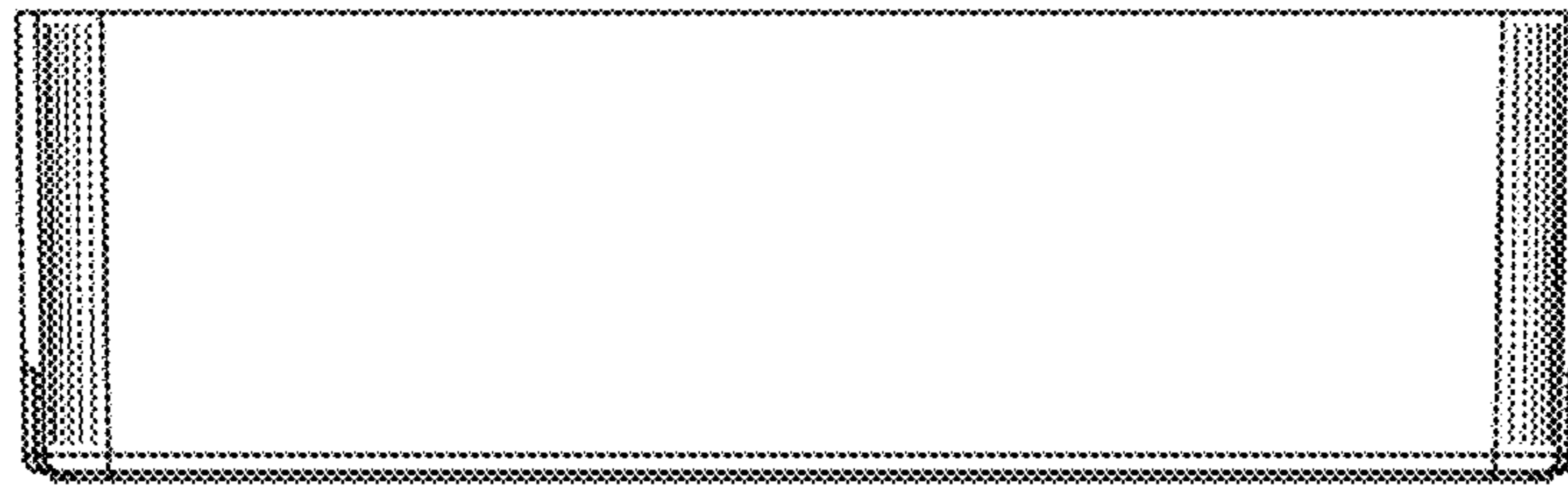

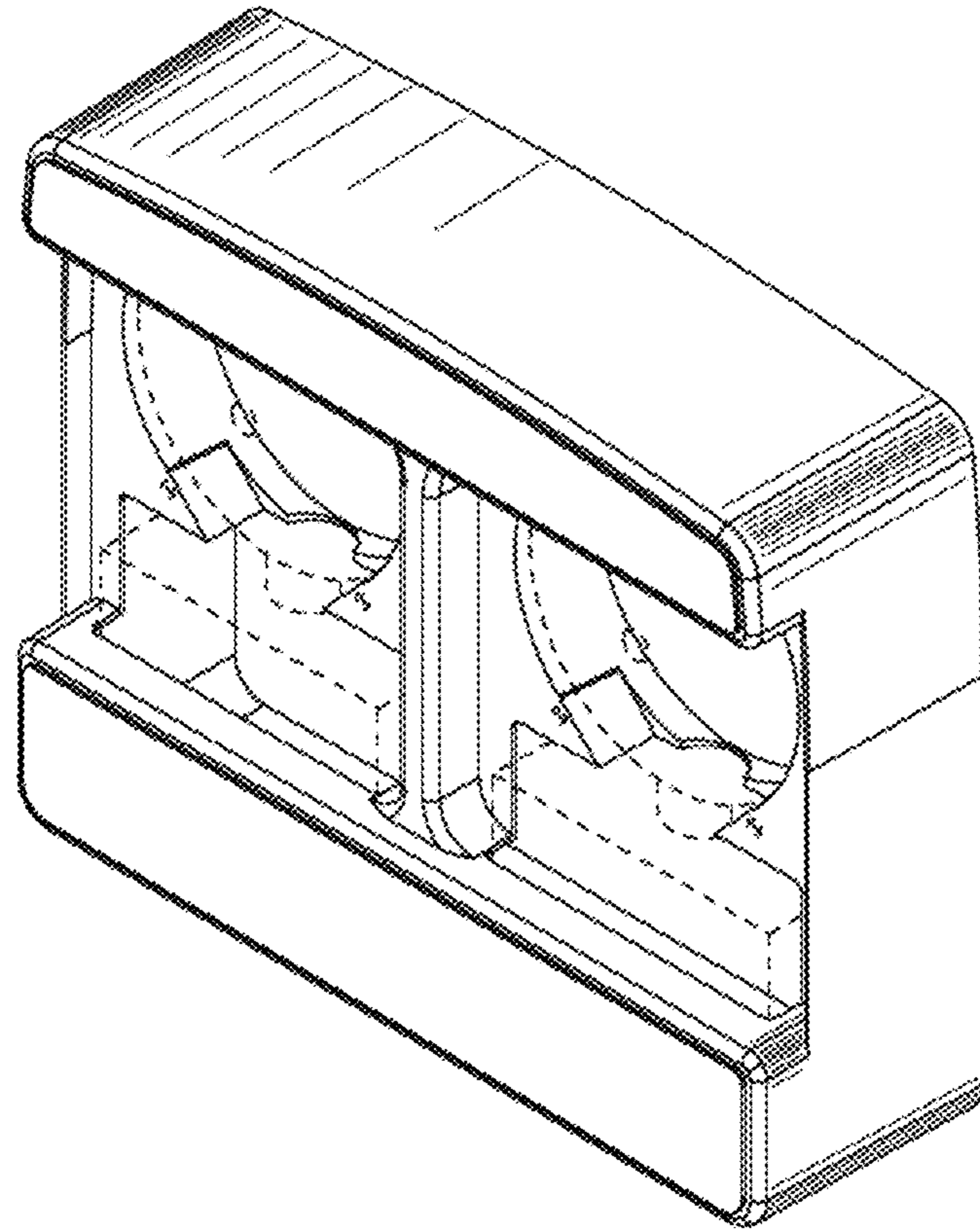
