(57) **CLAIM**

The ornamental design for a thermomixer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a thermomixer showing the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side view thereof; and

FIG. 4 is a right side view thereof.

FIG. 5 is a front perspective view of the thermomixer shown in FIG. 1 with a retainer element affixed to the top of the thermomixer.

FIG. 6 is a front perspective view of the thermomixer shown in FIG. 5 having a first embodiment of a thermoblock installed in the retainer element;

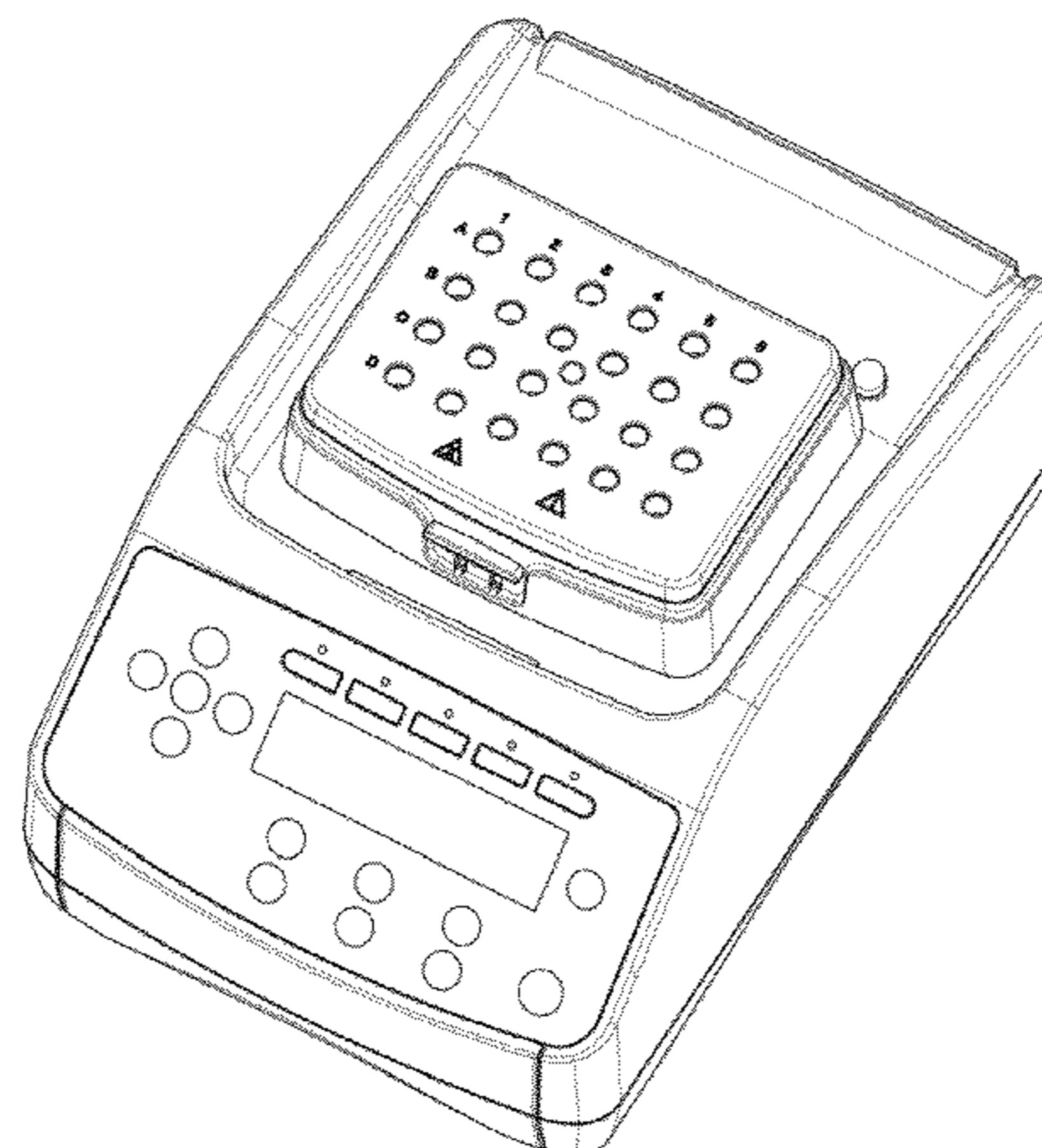
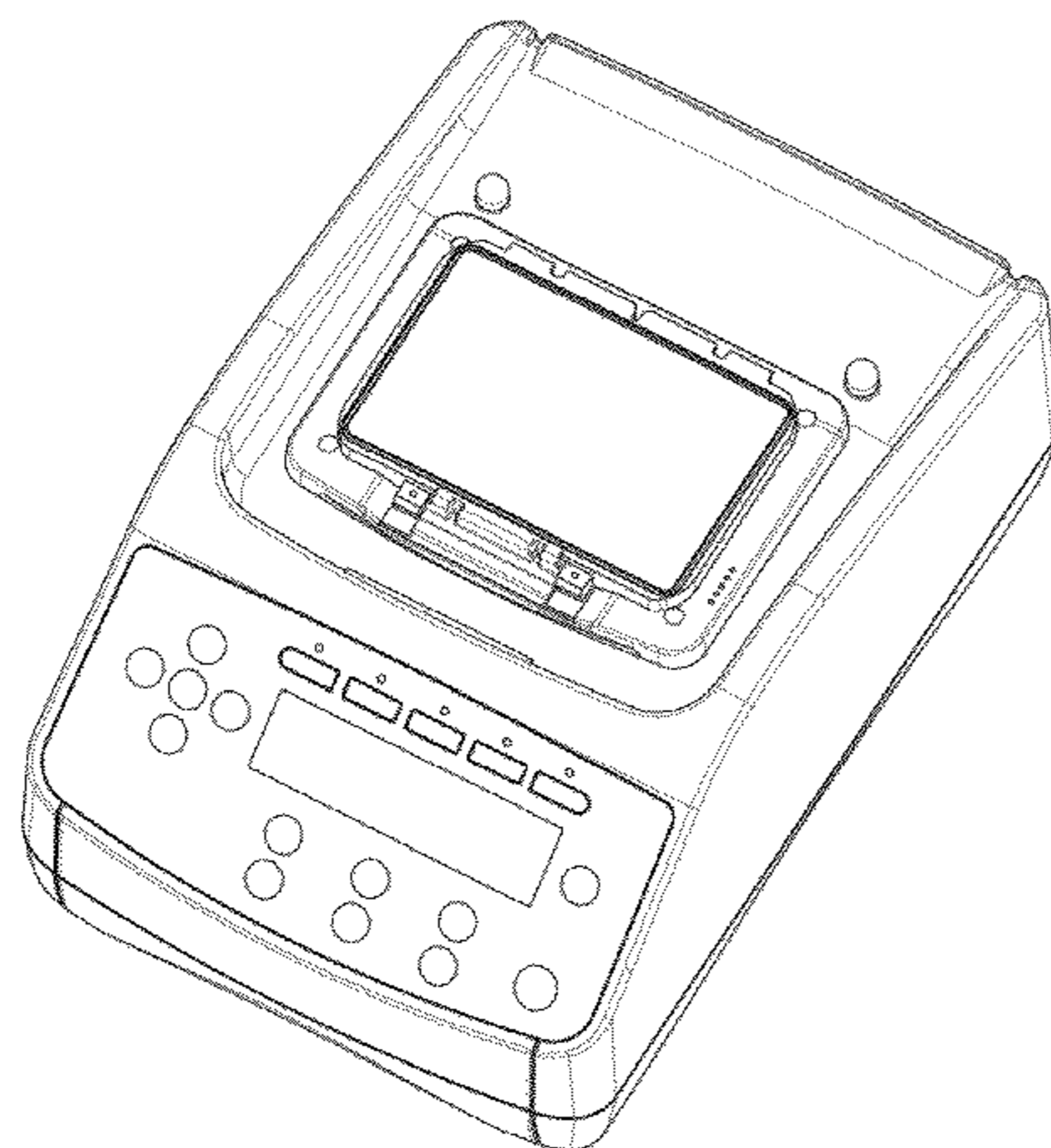
FIG. 7 is a top plan view of the thermomixer shown in FIG. 6;

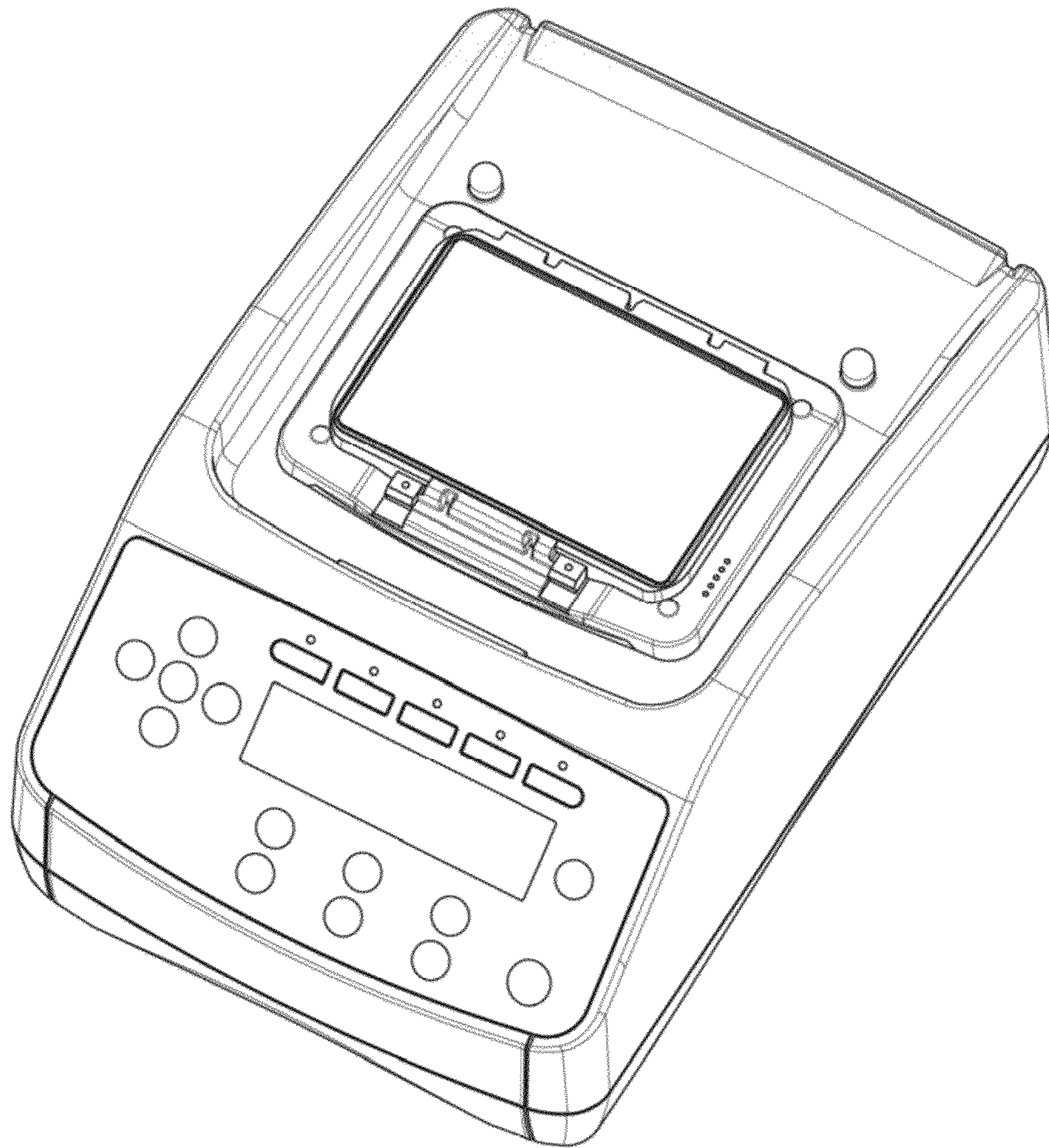

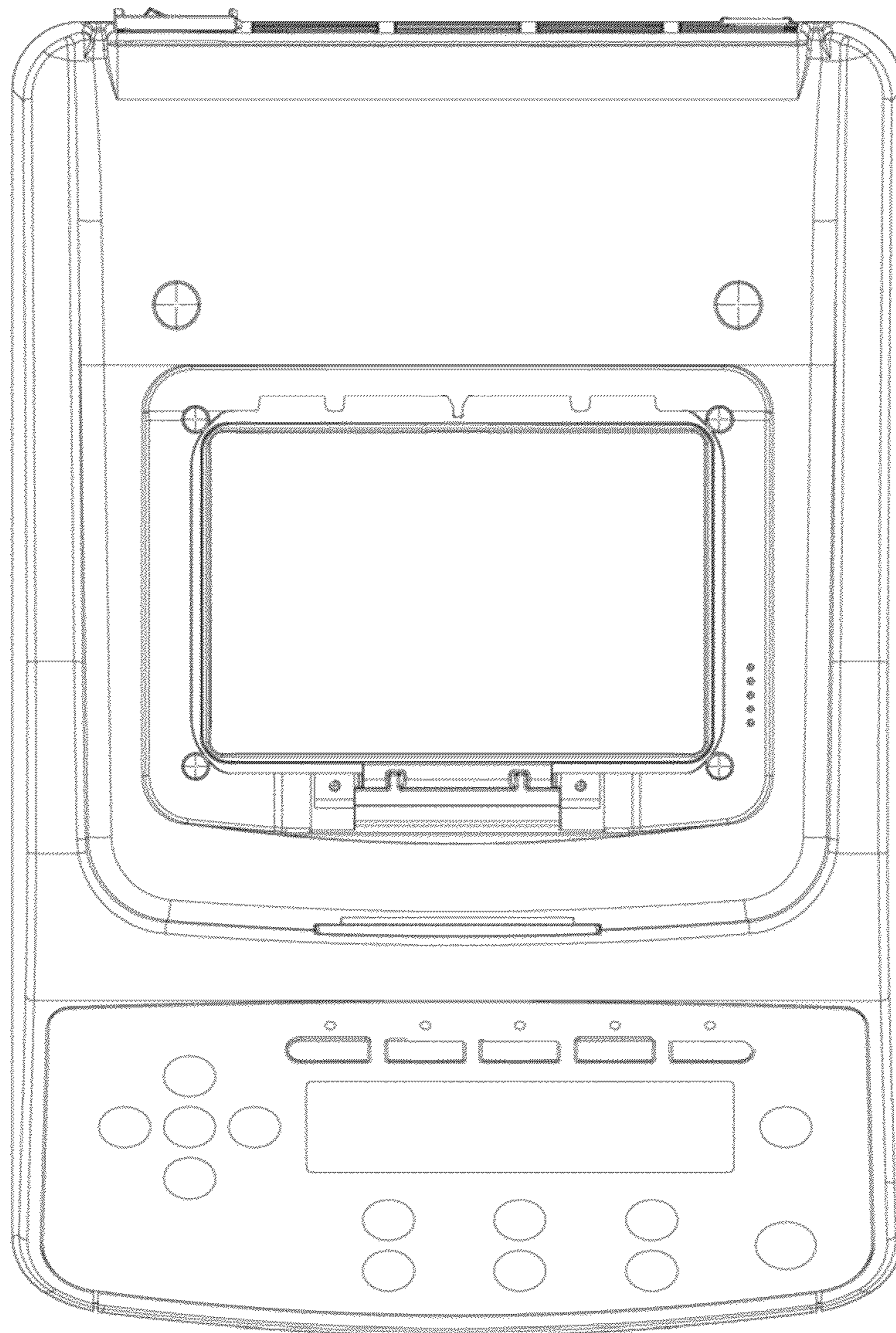

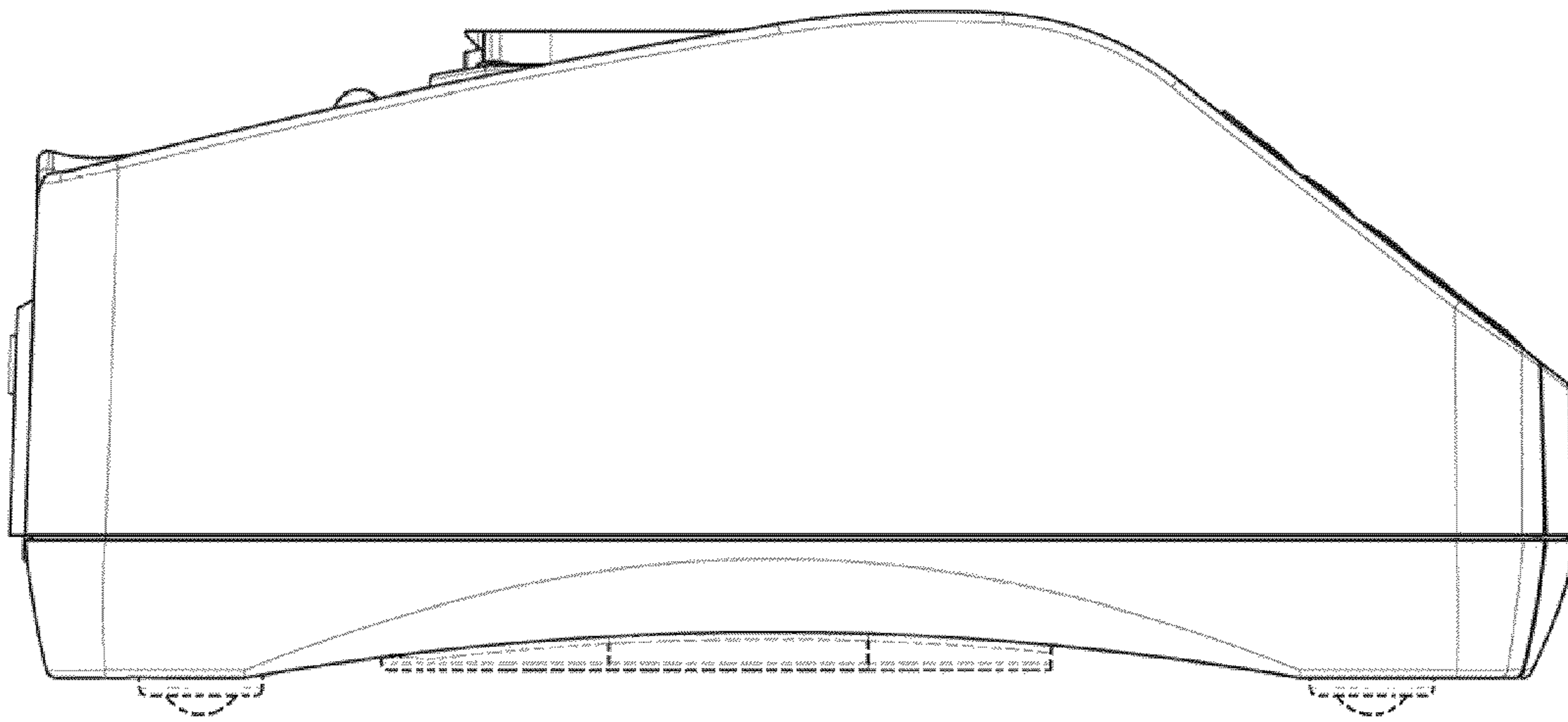

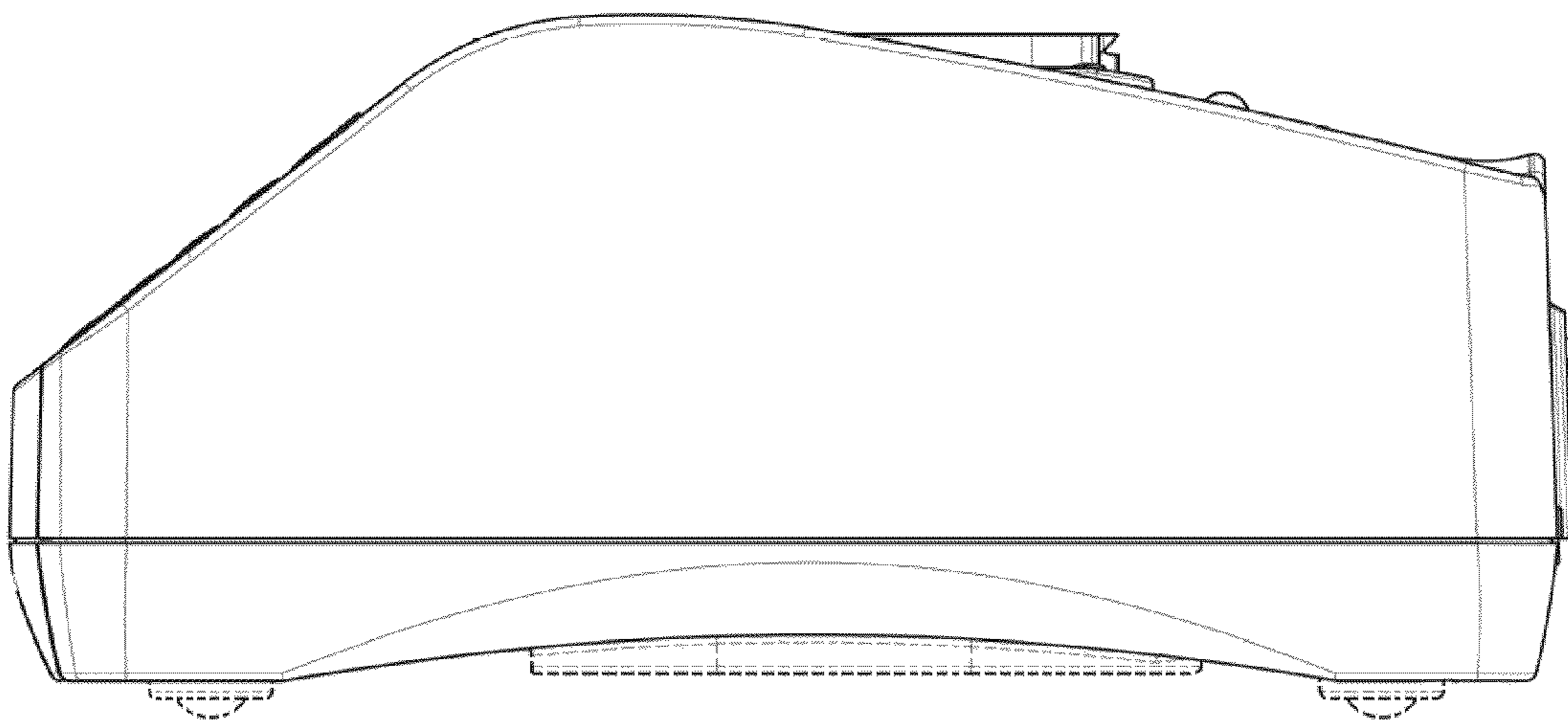

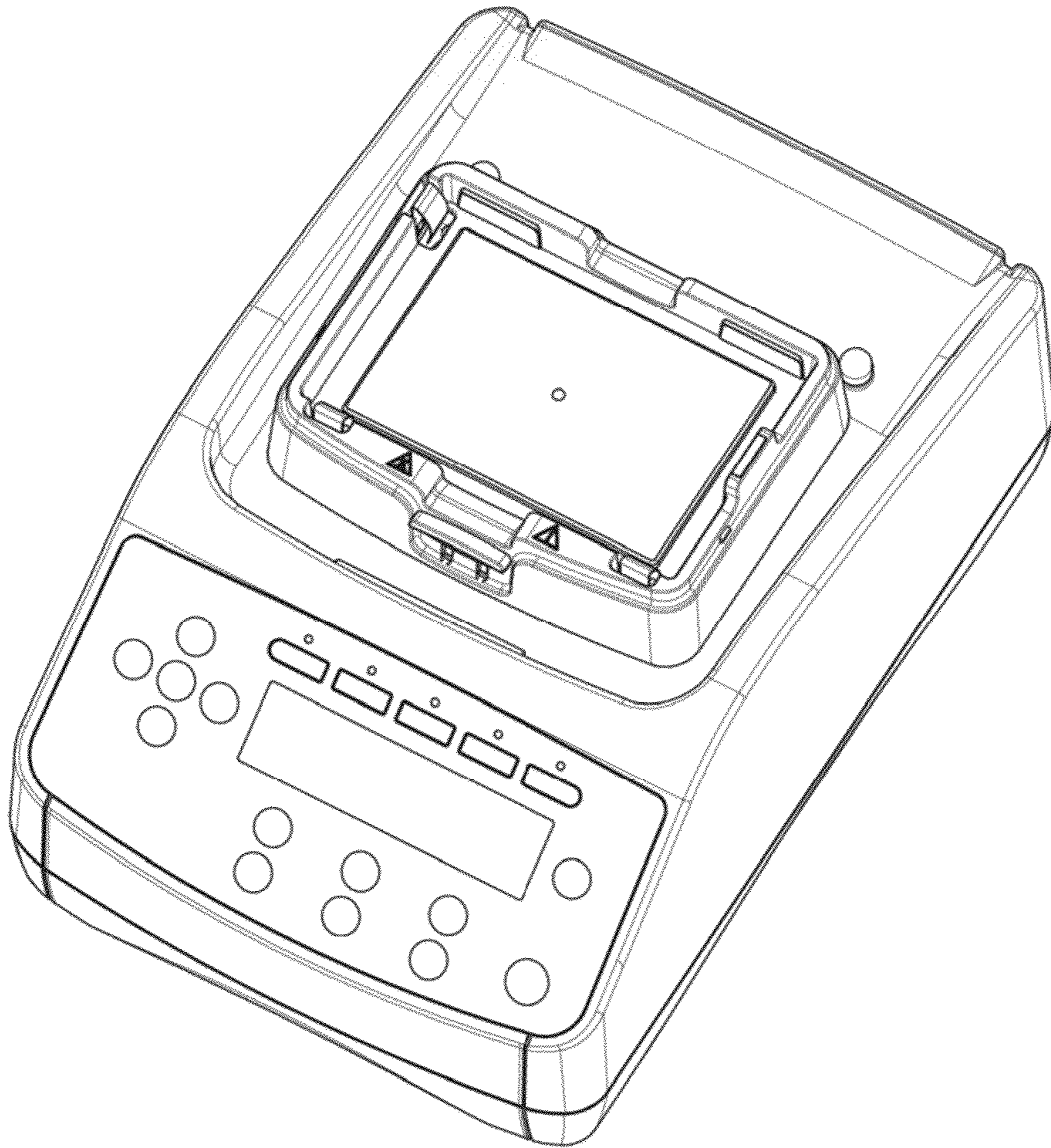

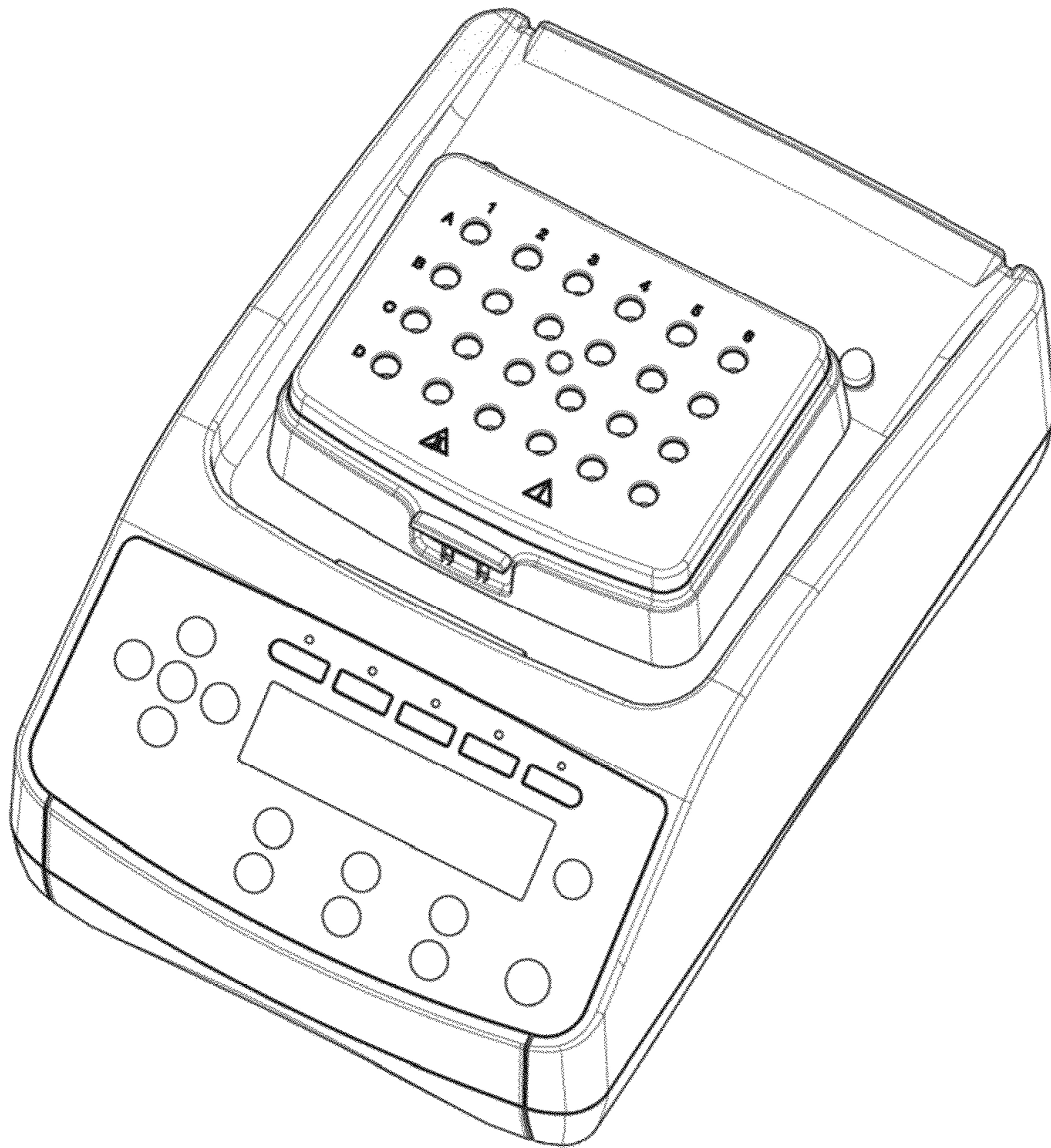

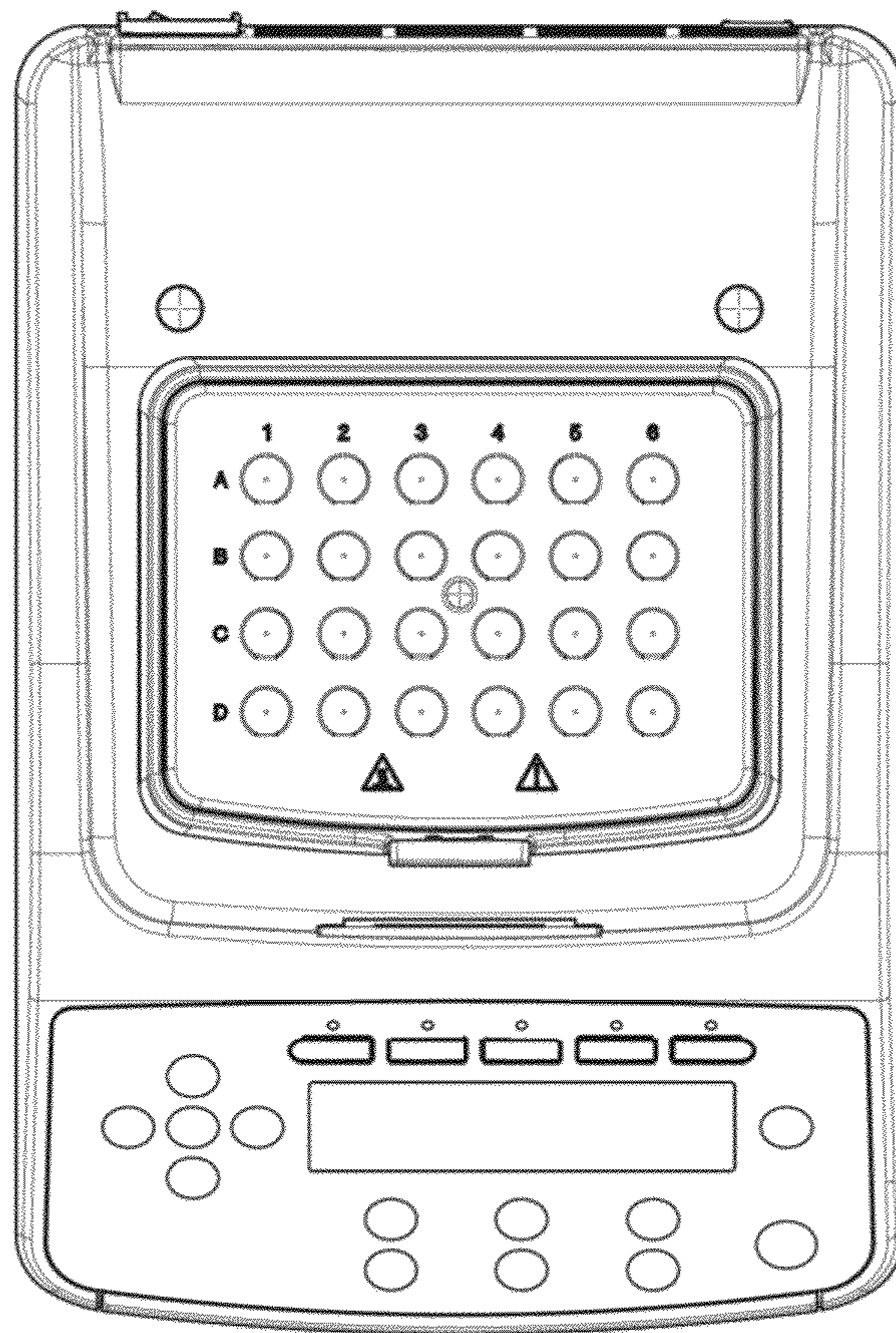

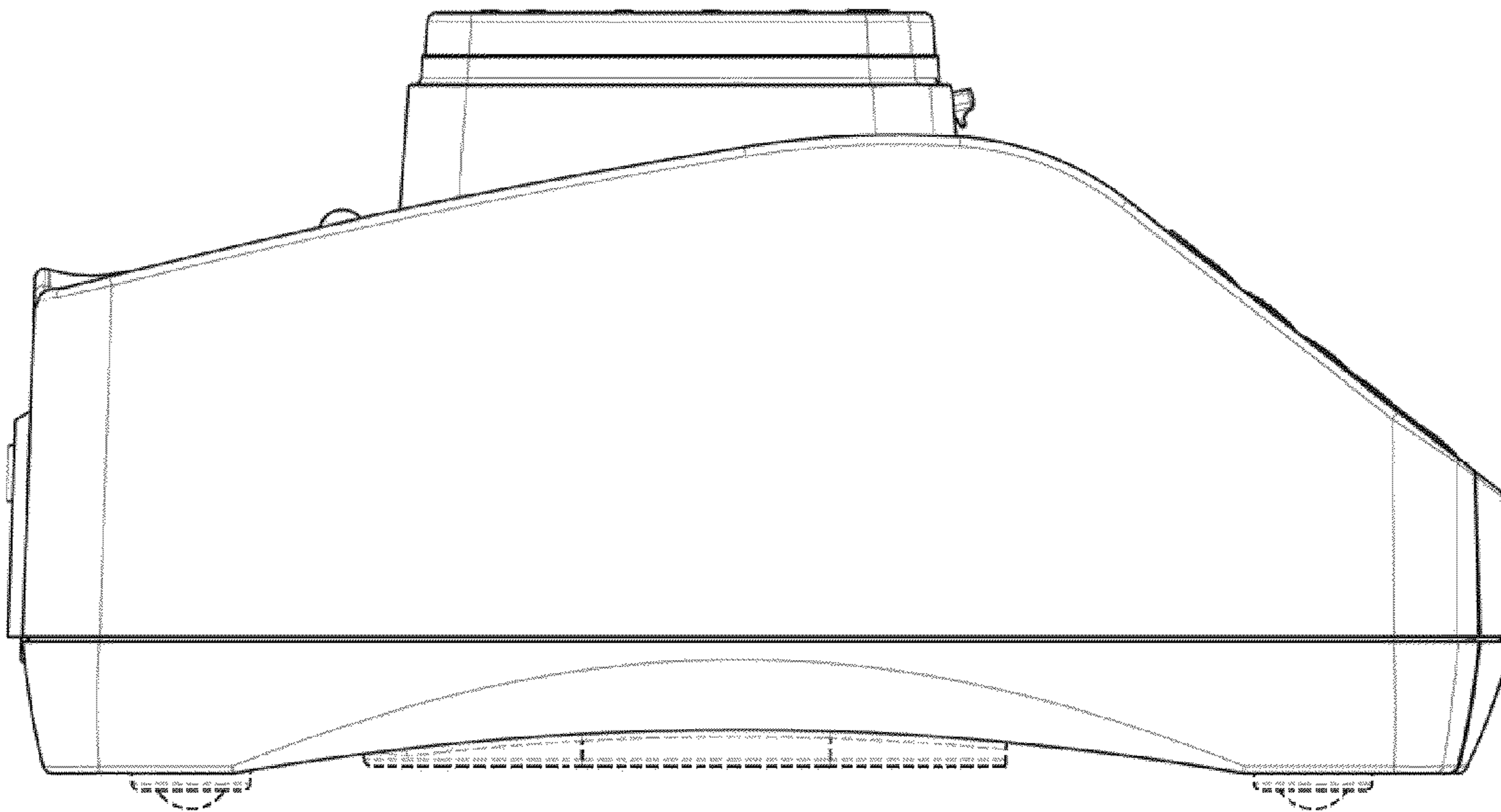
