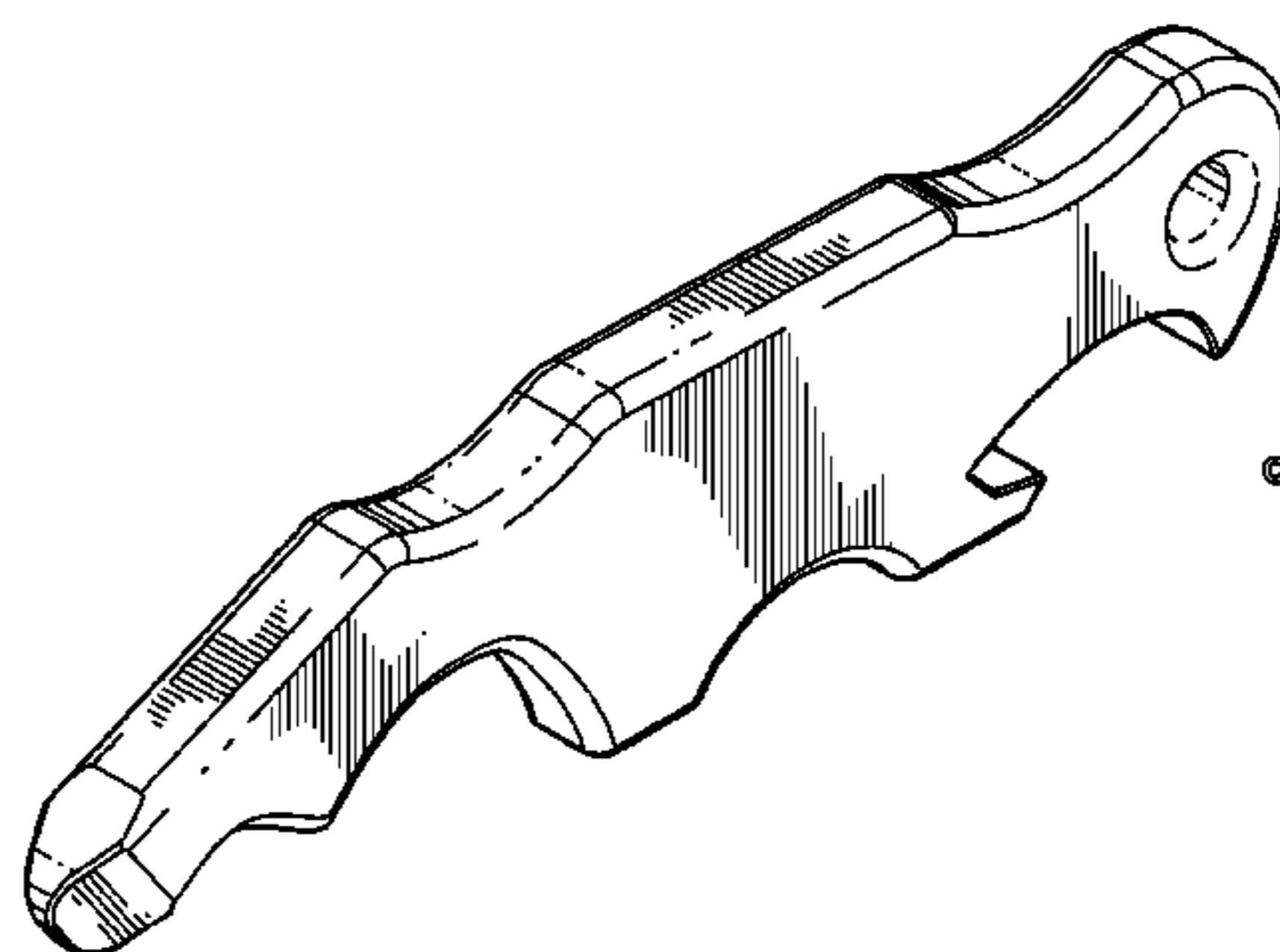

The ornamental design for a scratch card and bottle opener, as shown and described.

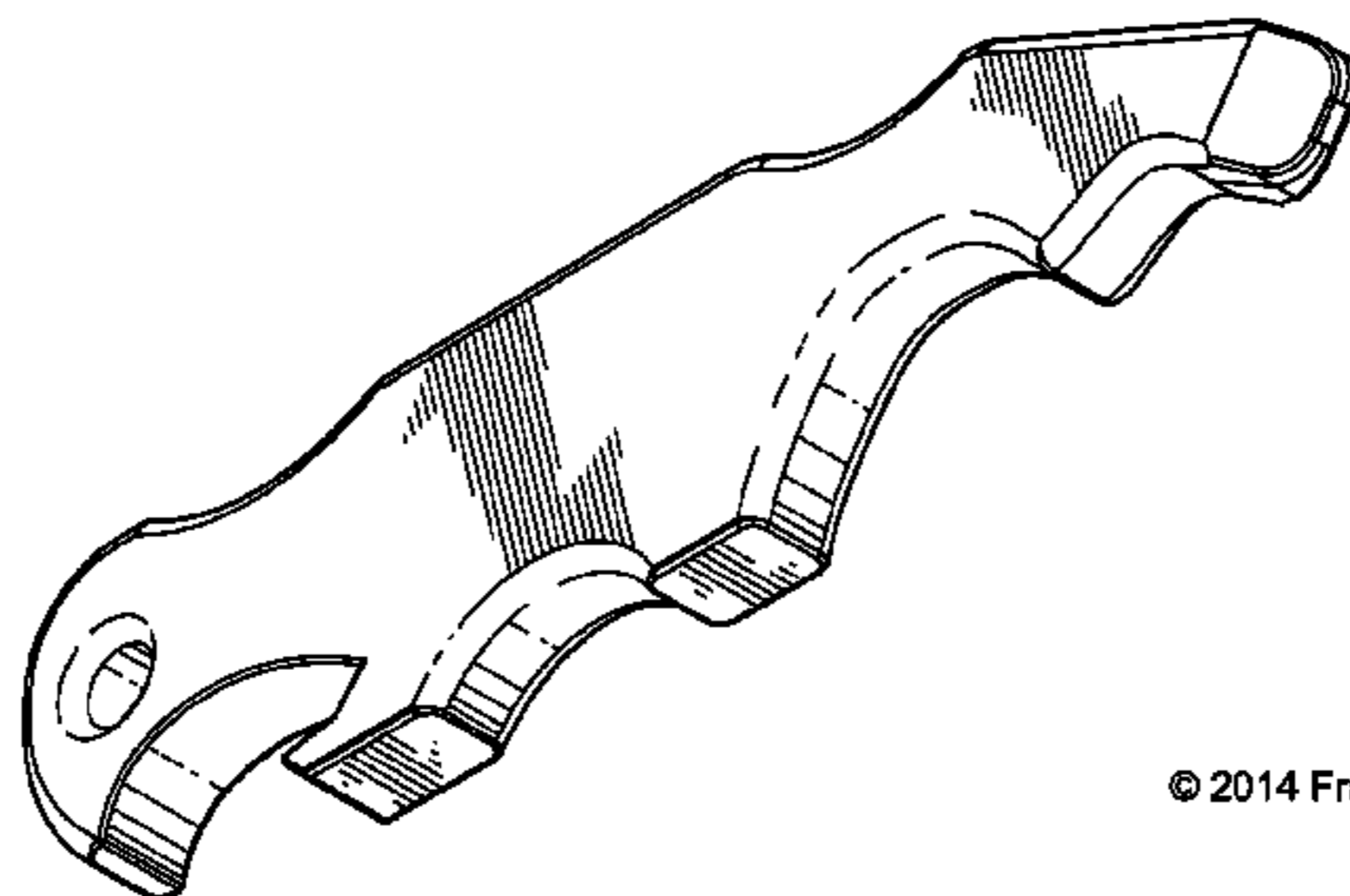
DESCRIPTION

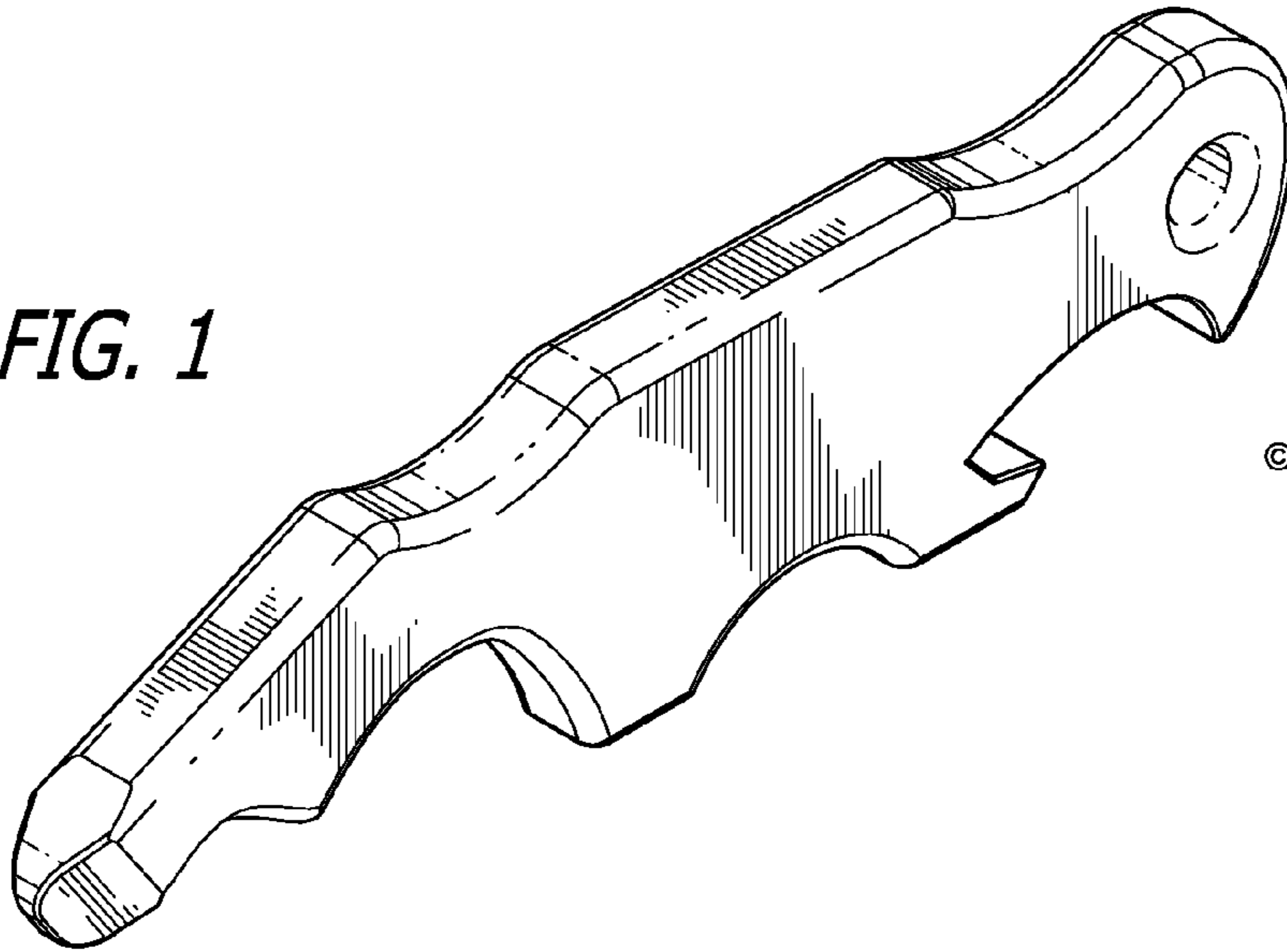

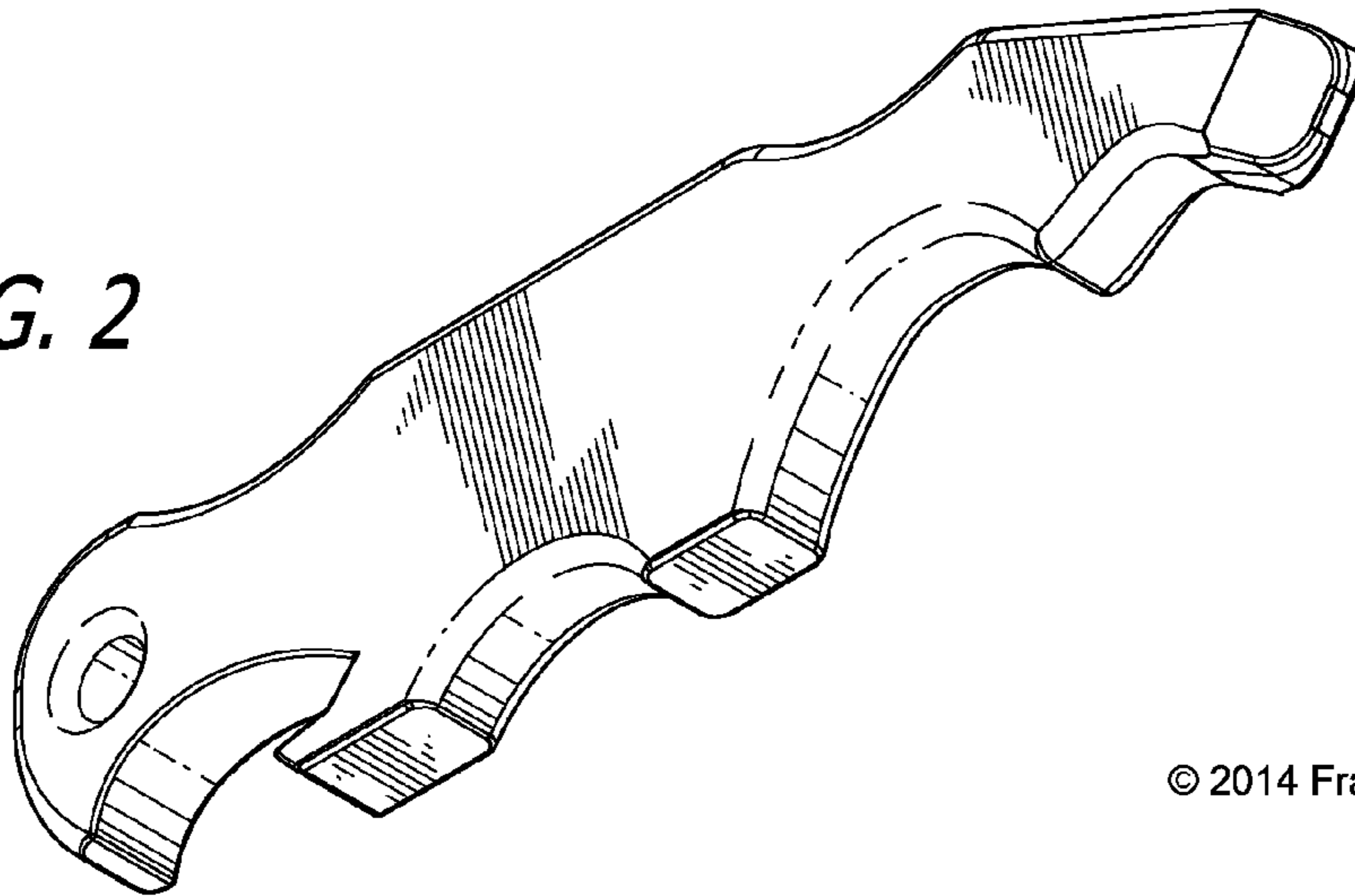

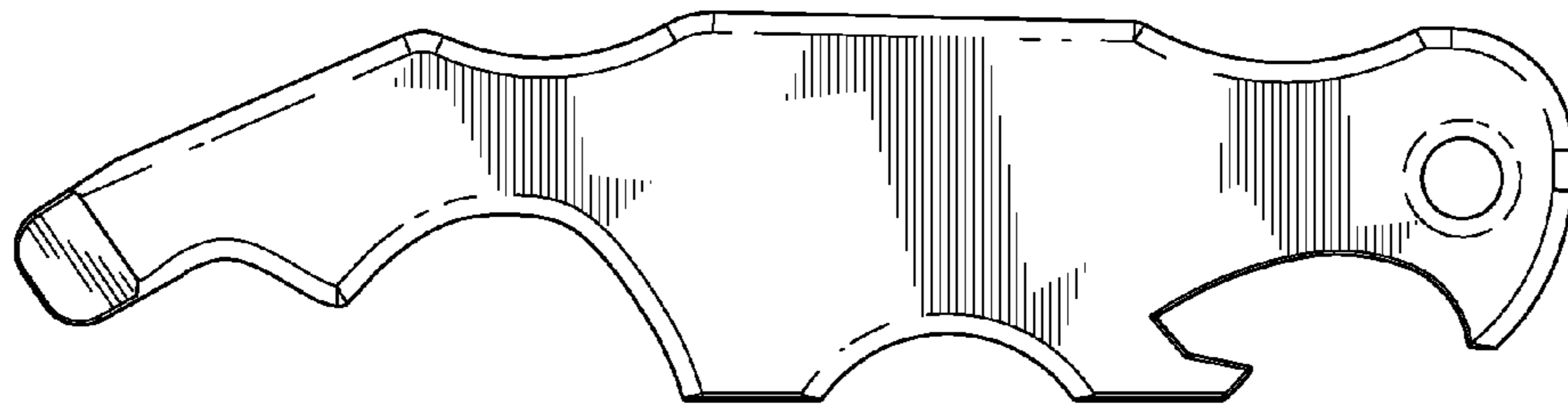

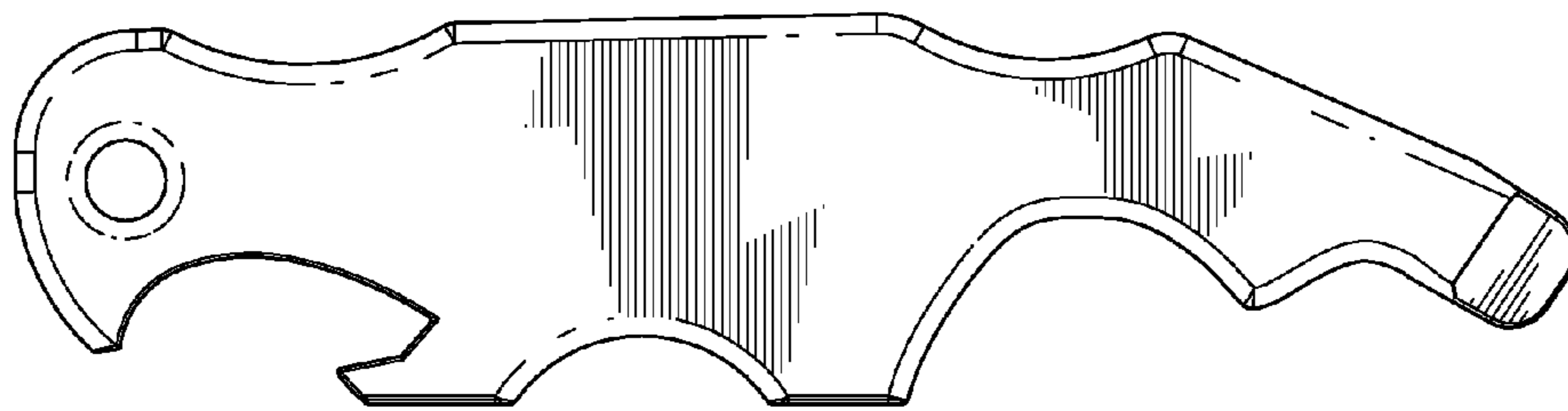

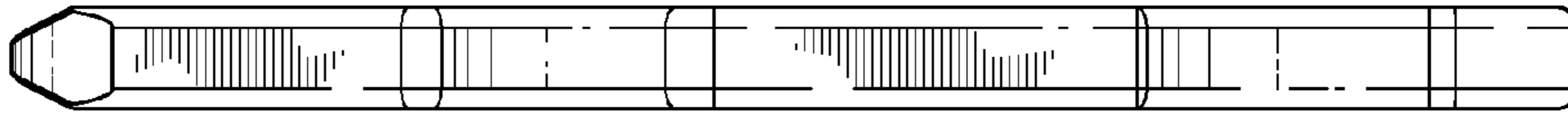

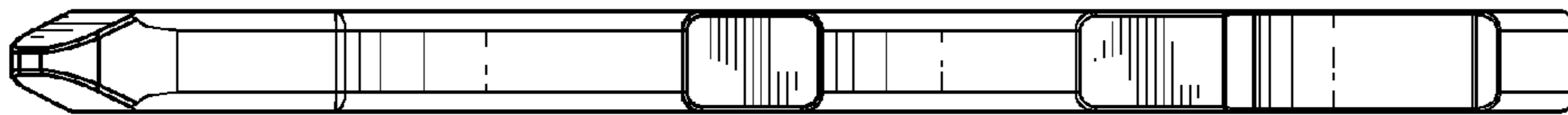

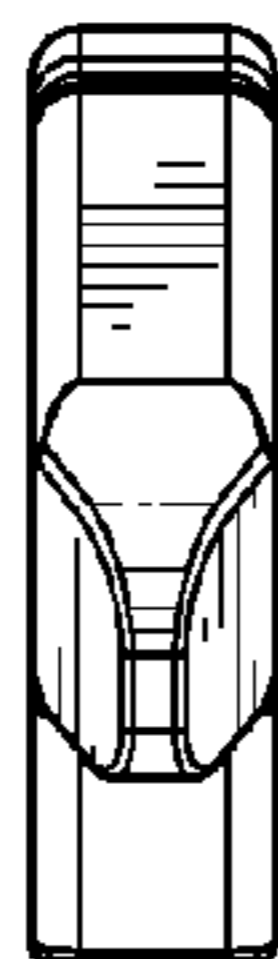

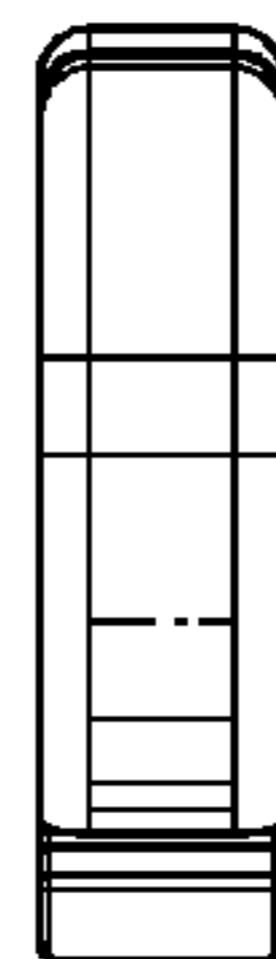
