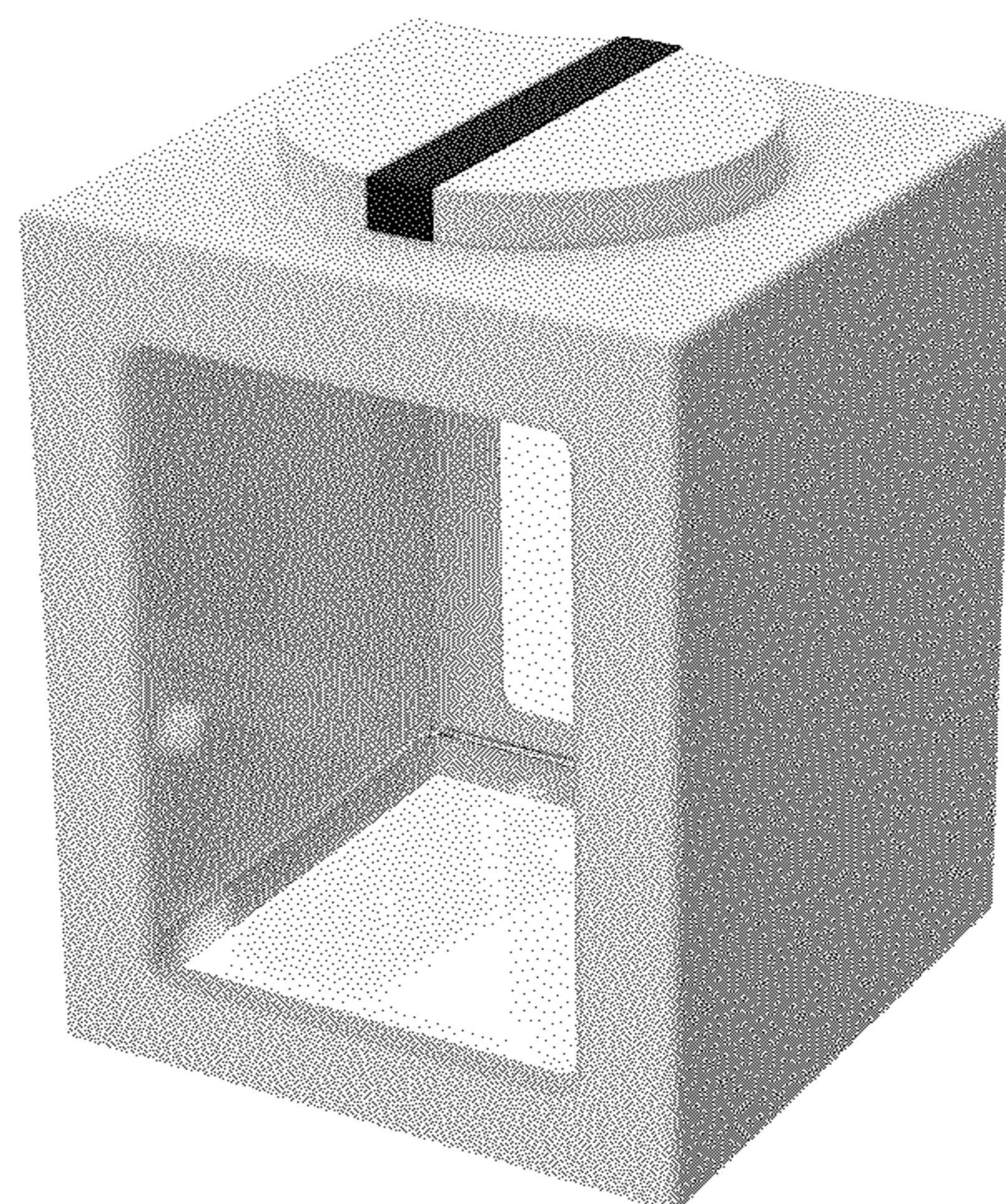
(57) **CLAIM**
The ornamental design for a package, as shown and
described.

DESCRIPTION

FIG. 1 is a front, top, and right-side perspective view of a
package that has the design.
FIG. 1A is the same view, with a top piece moved to a
different position.
FIG. 2 is a front and left-side view of the package.
FIG. 3 is a front view of the package. The rear view is iden-
tical.
FIG. 3A is the same view, with the top piece moved.
FIG. 4 is a bottom view of the package; and,
FIG. 4A is the same view, with the top piece moved.
The front and back have transparent windows. The package
has a transparent bottom.

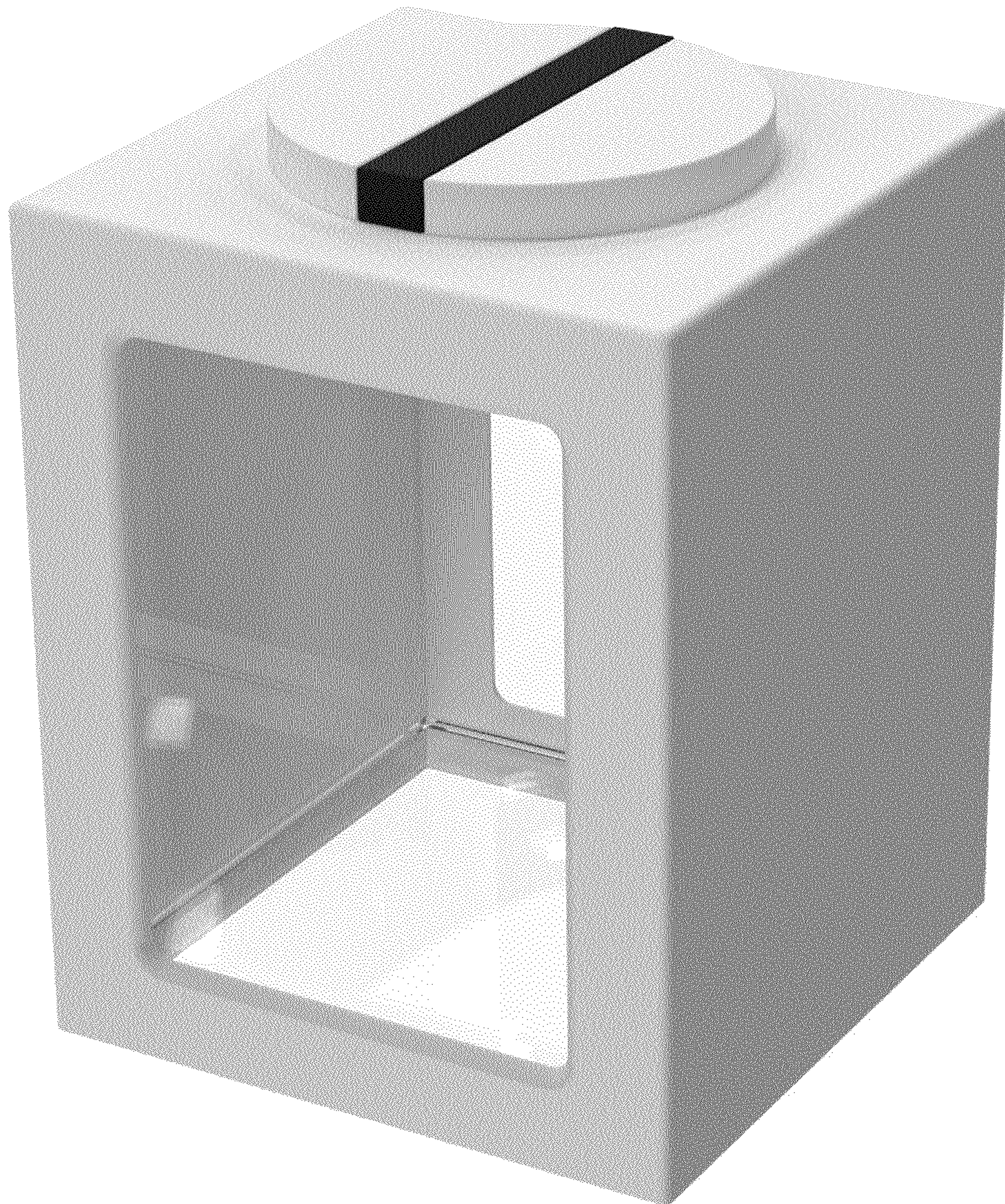

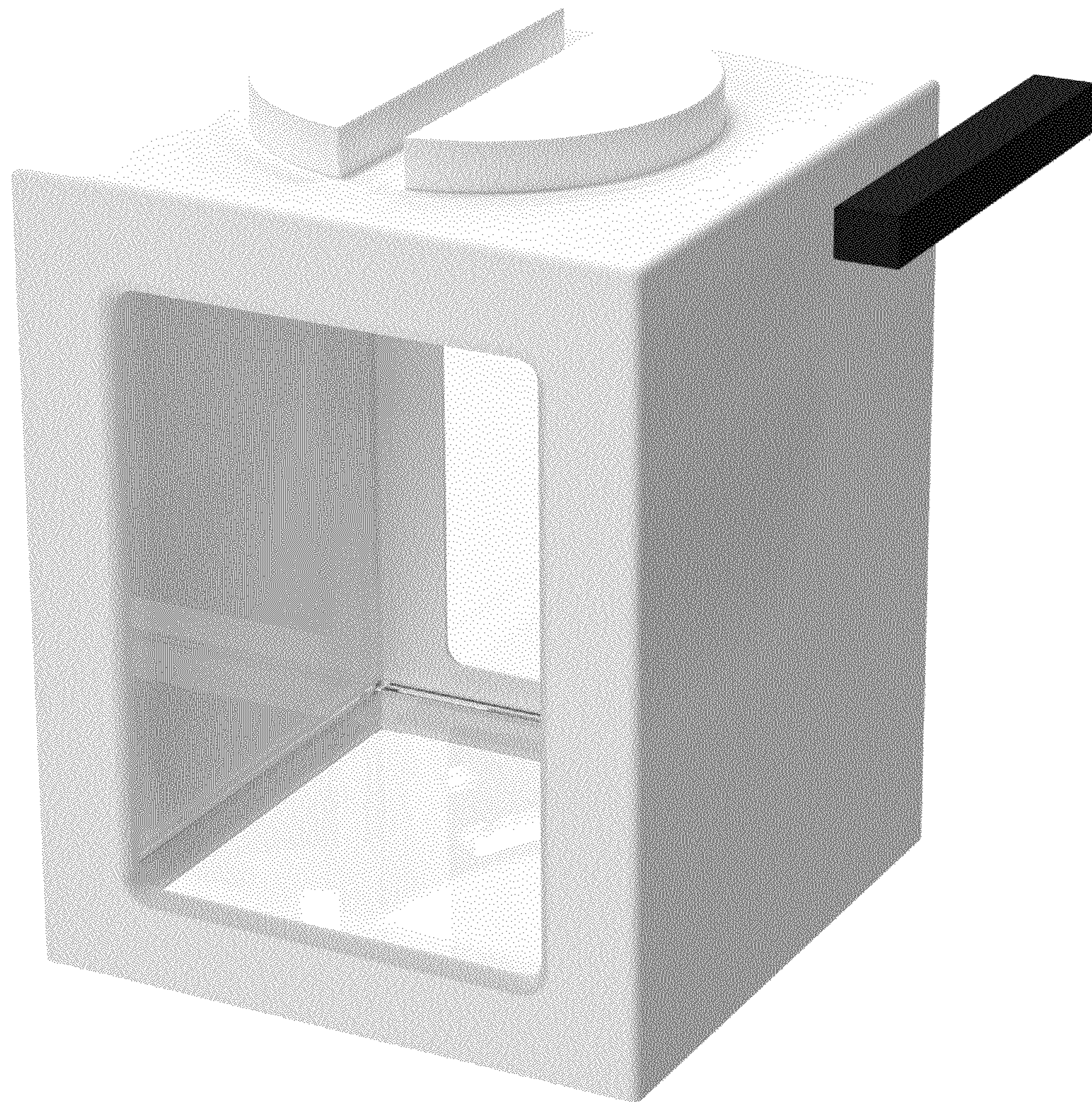

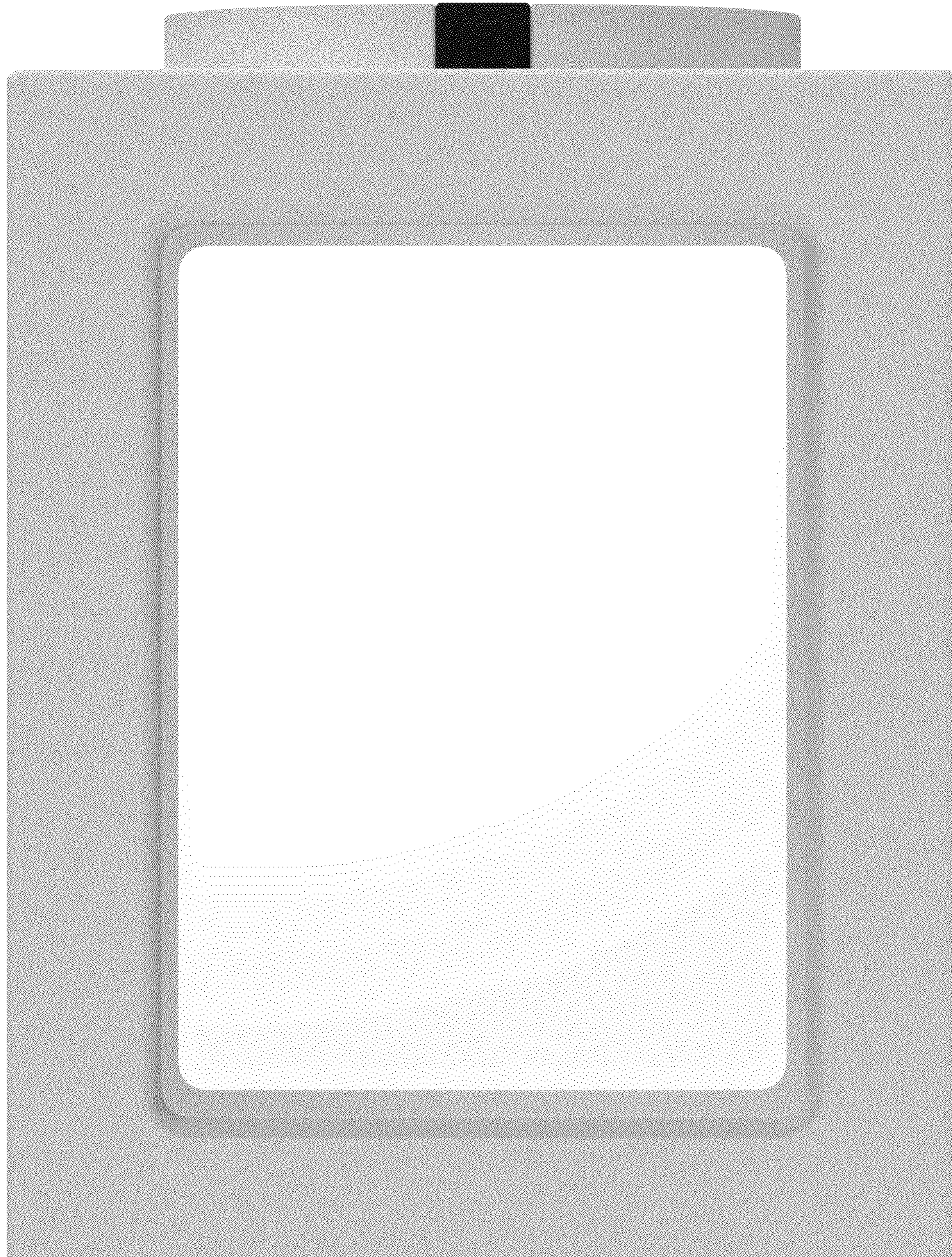

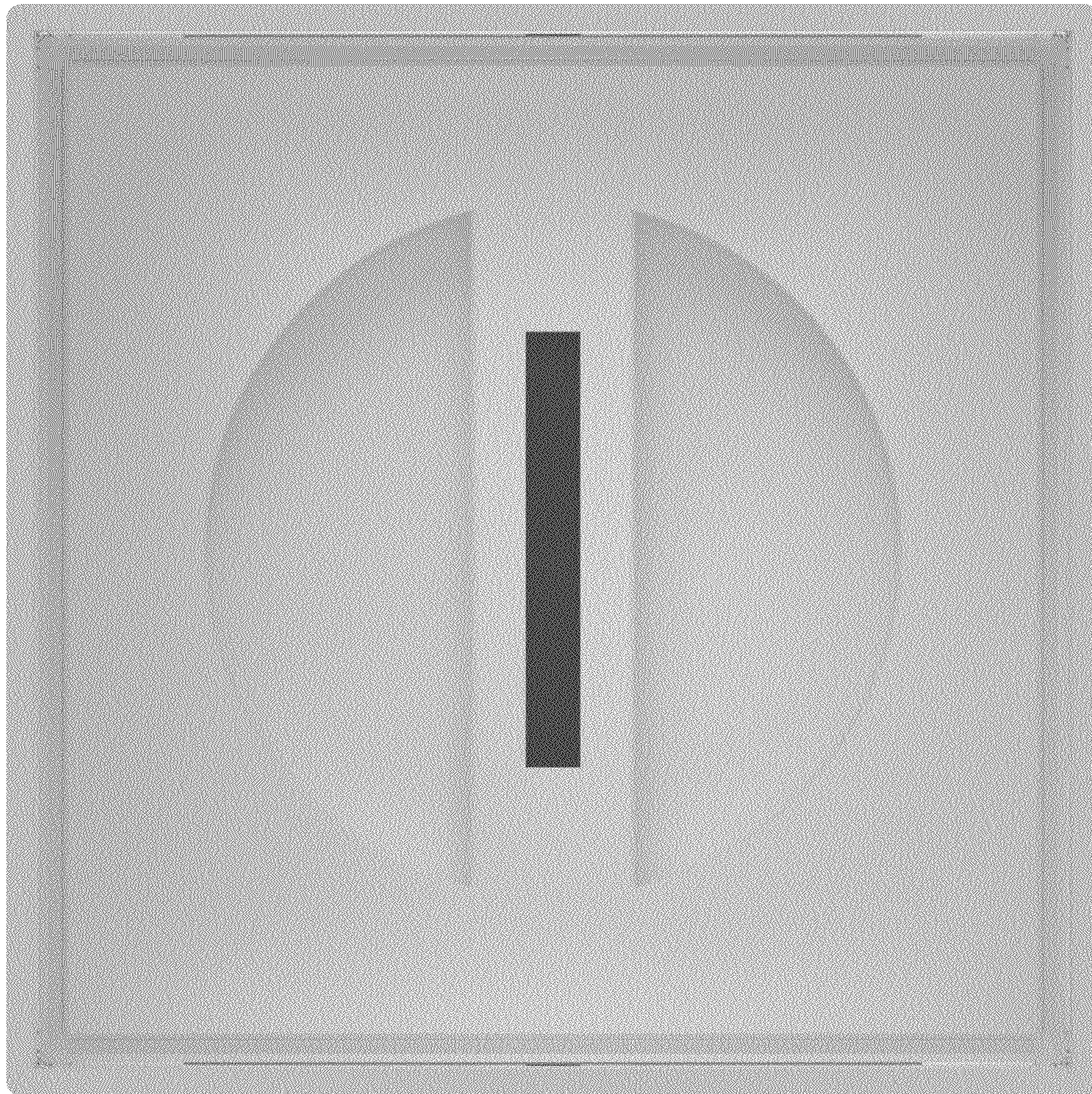

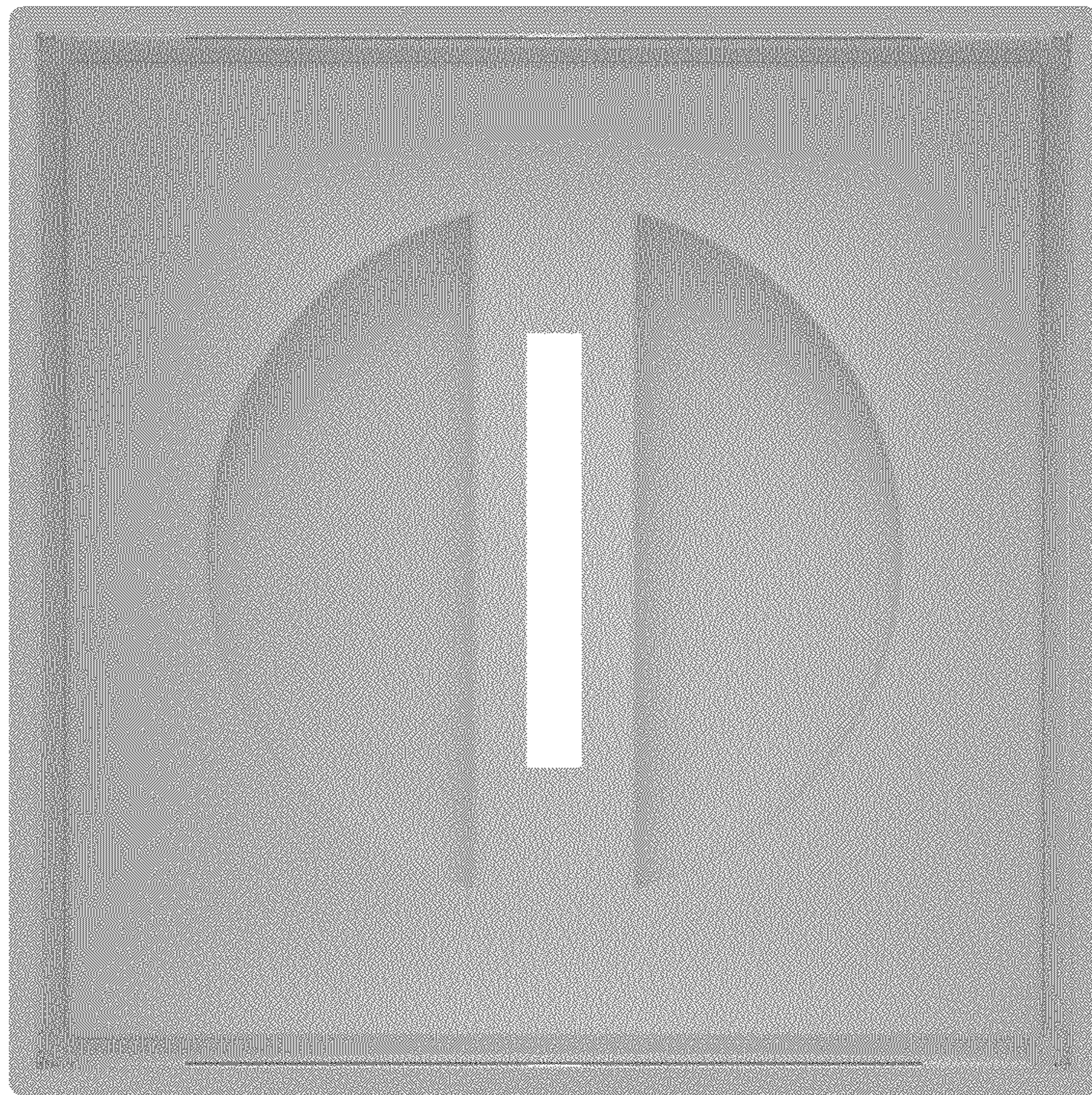
