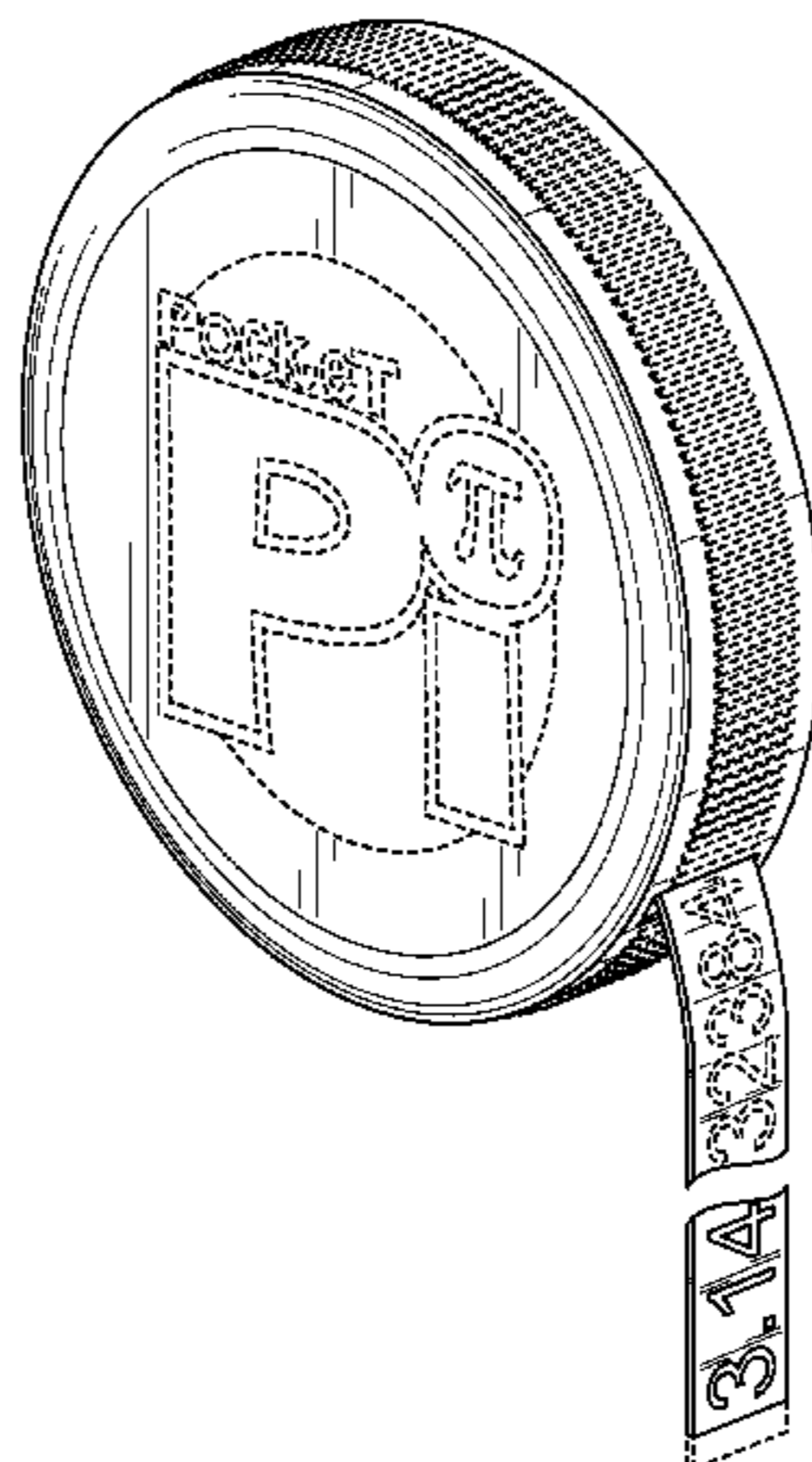
The ornamental design for measuring tape, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a measuring tape according to a second embodiment of the claimed design;

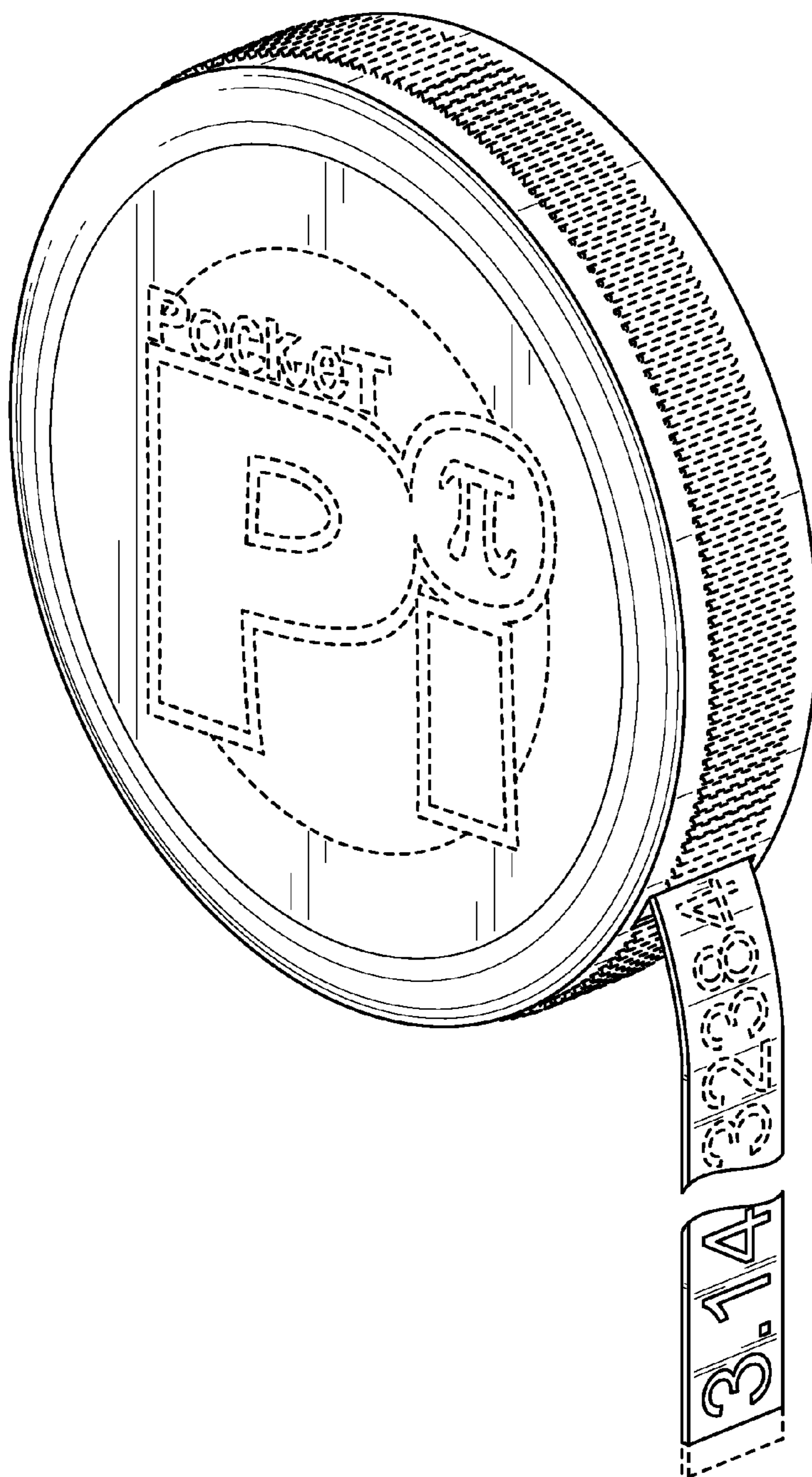

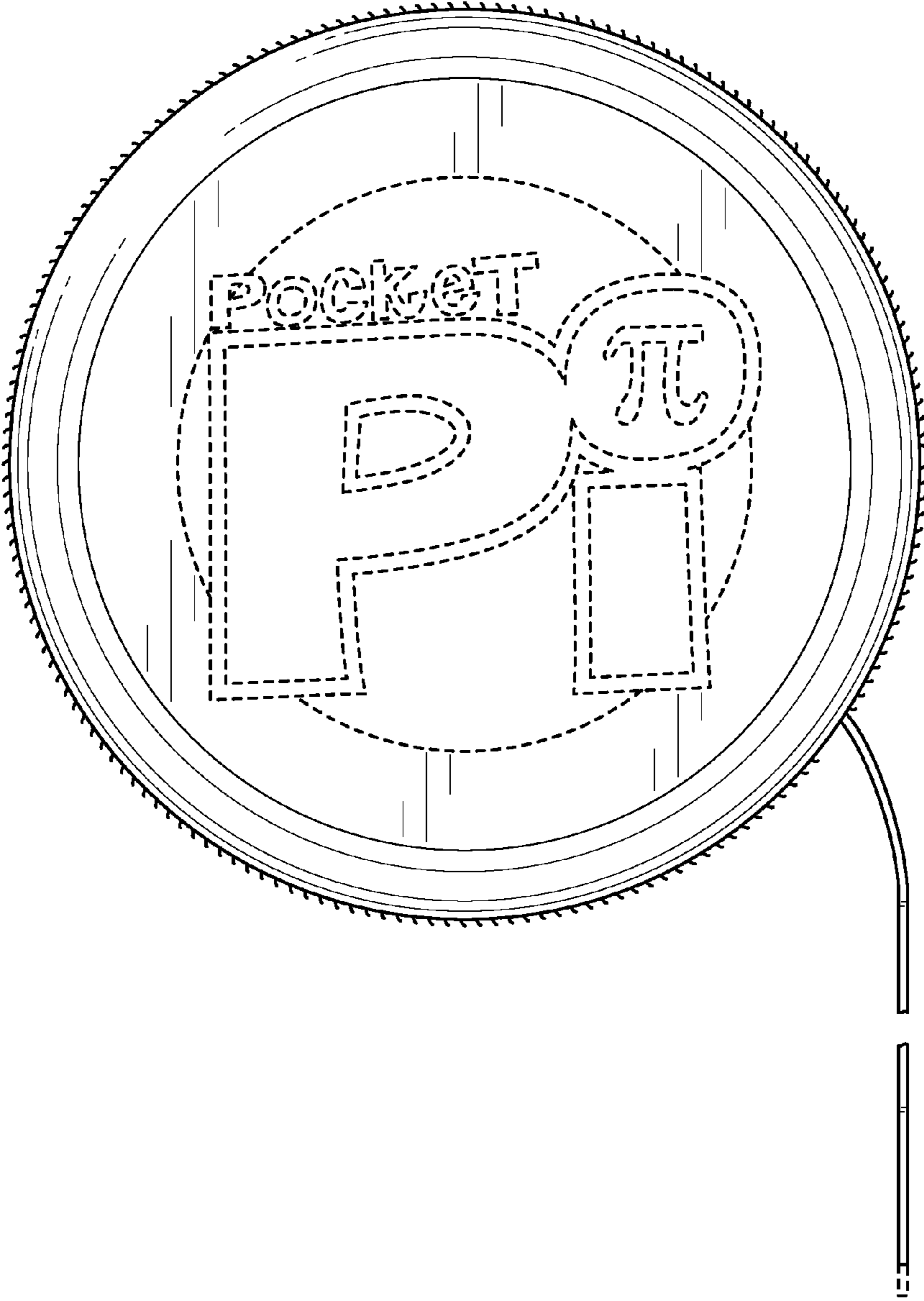

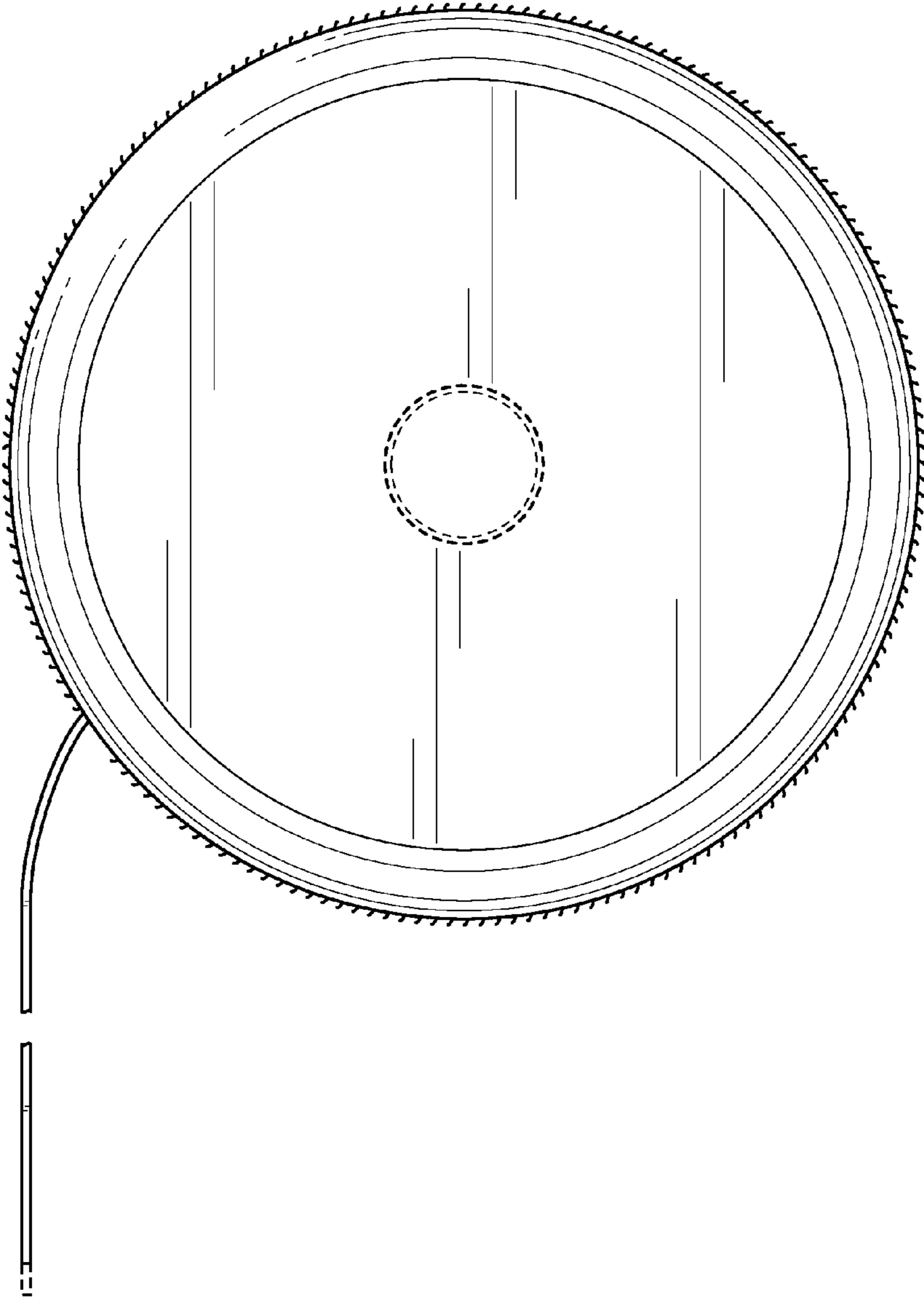

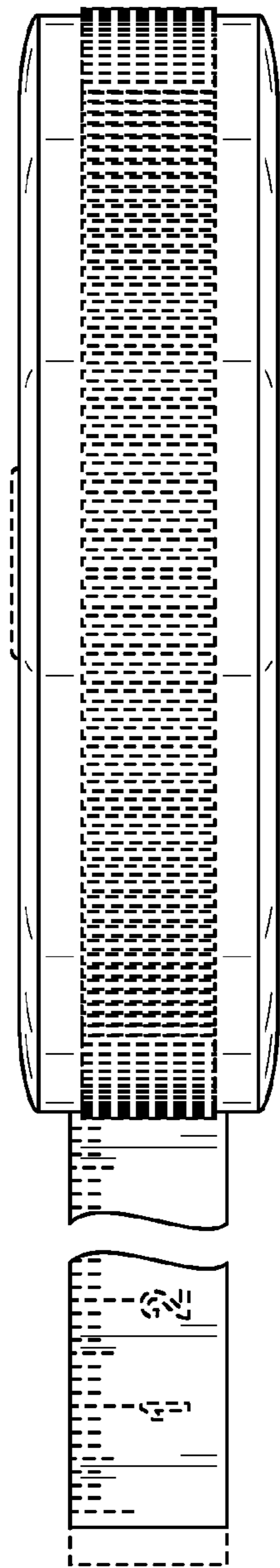

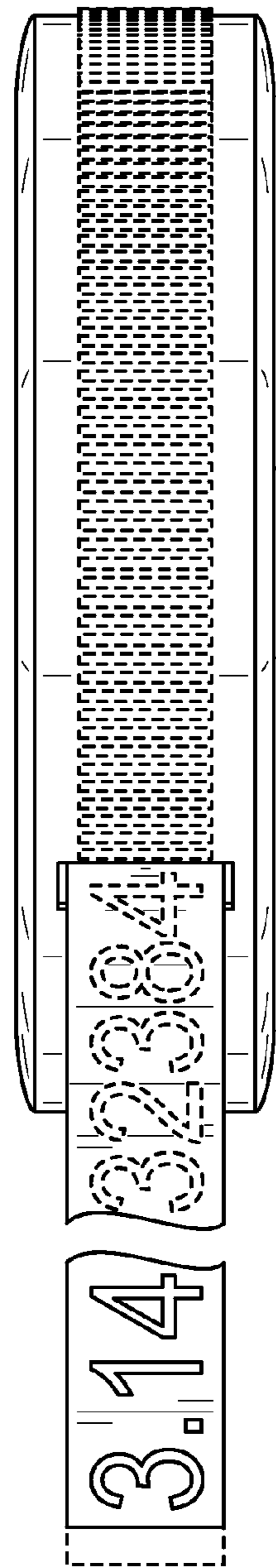

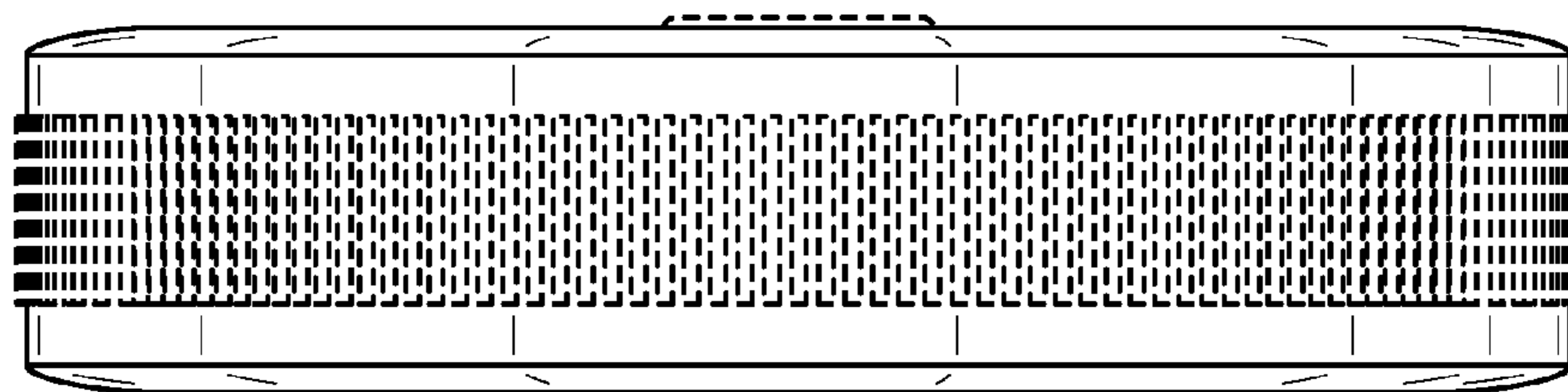

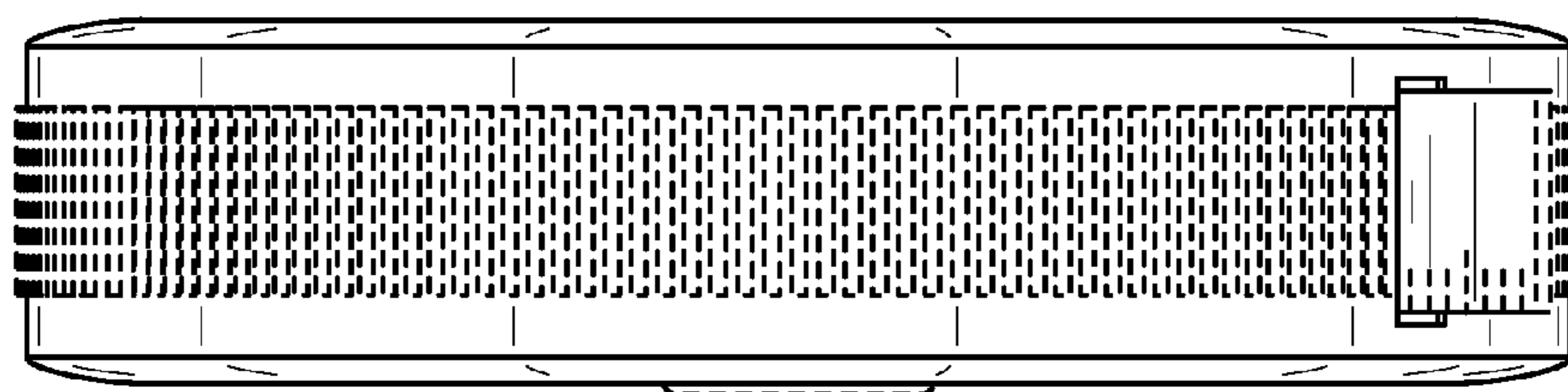

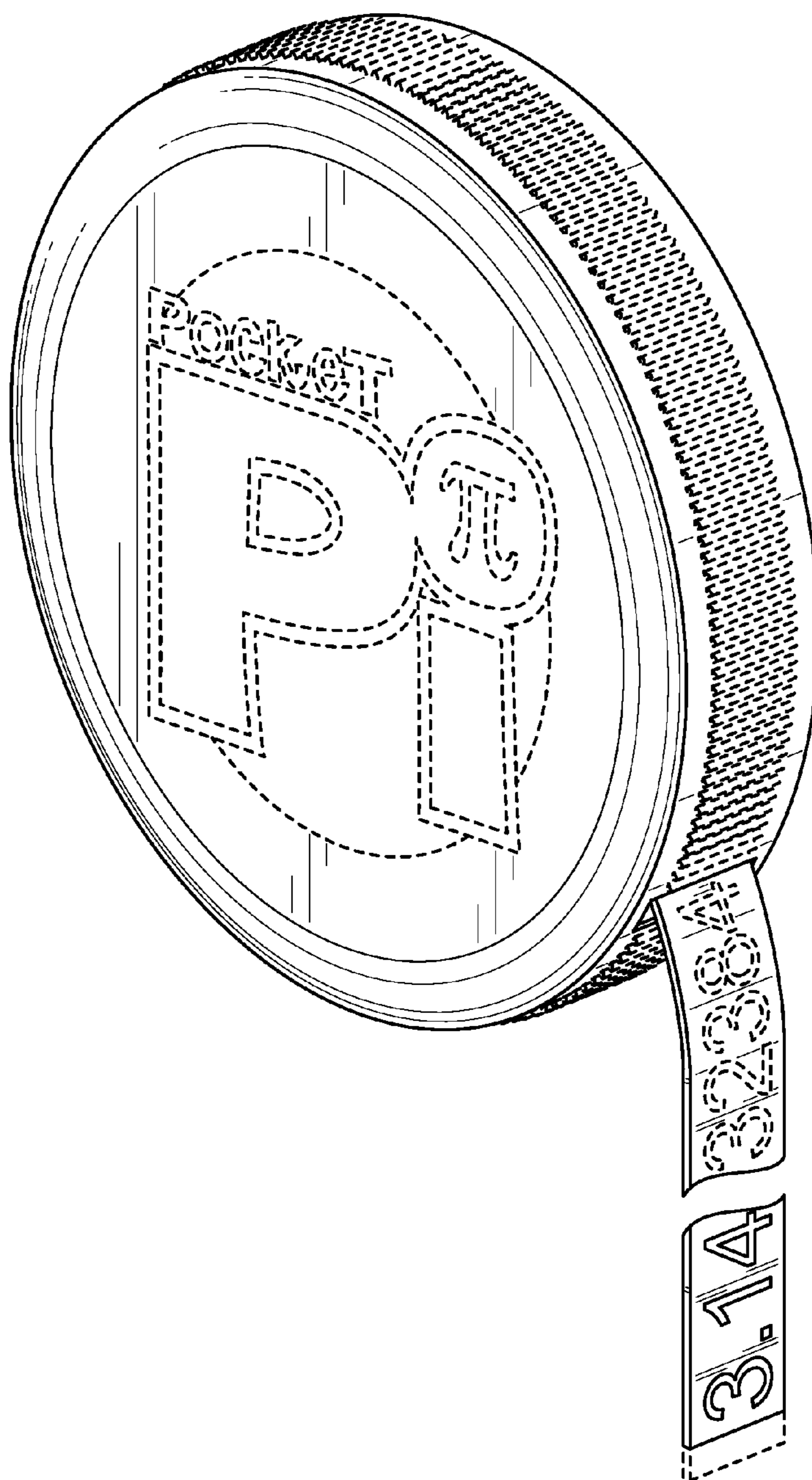

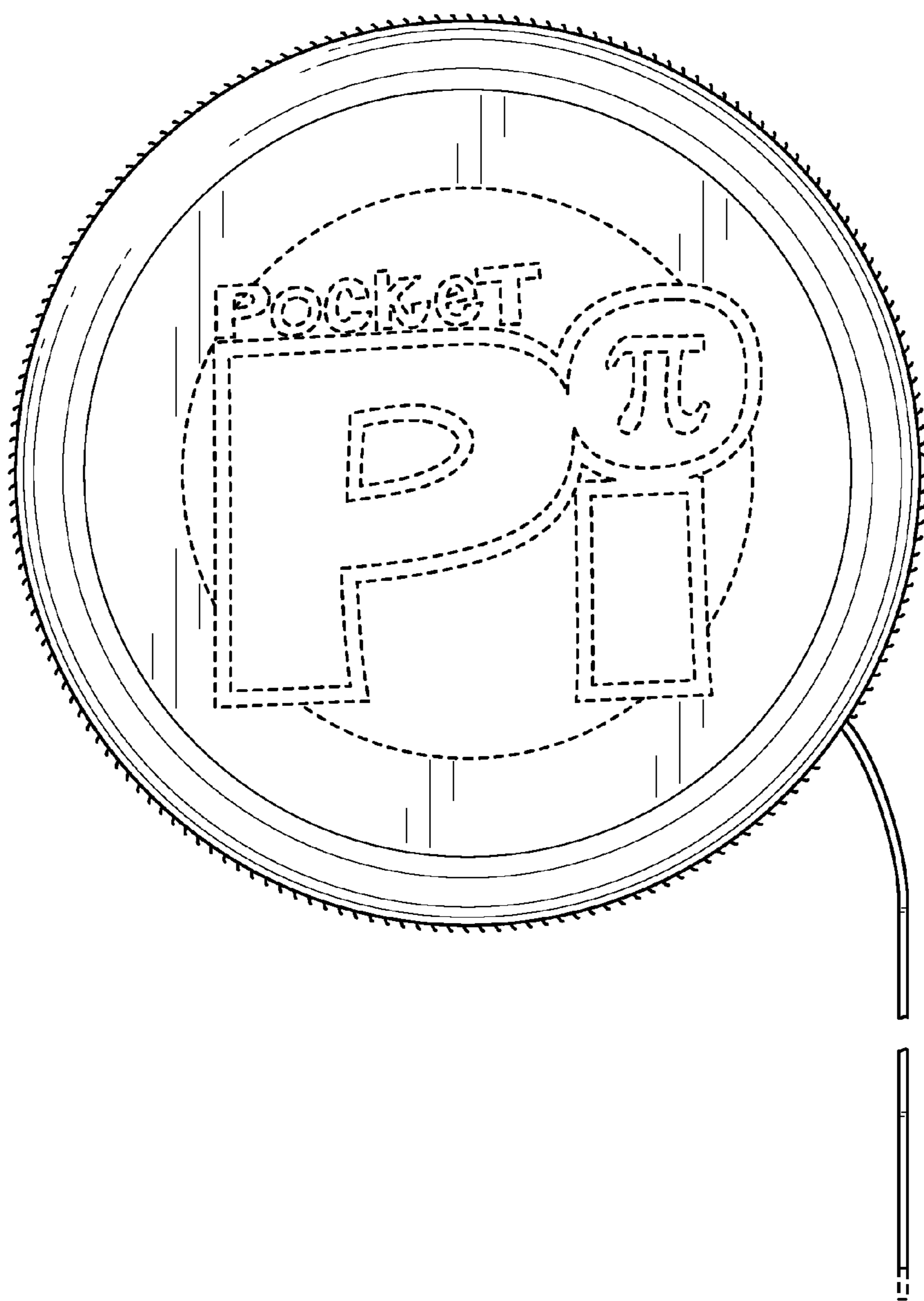

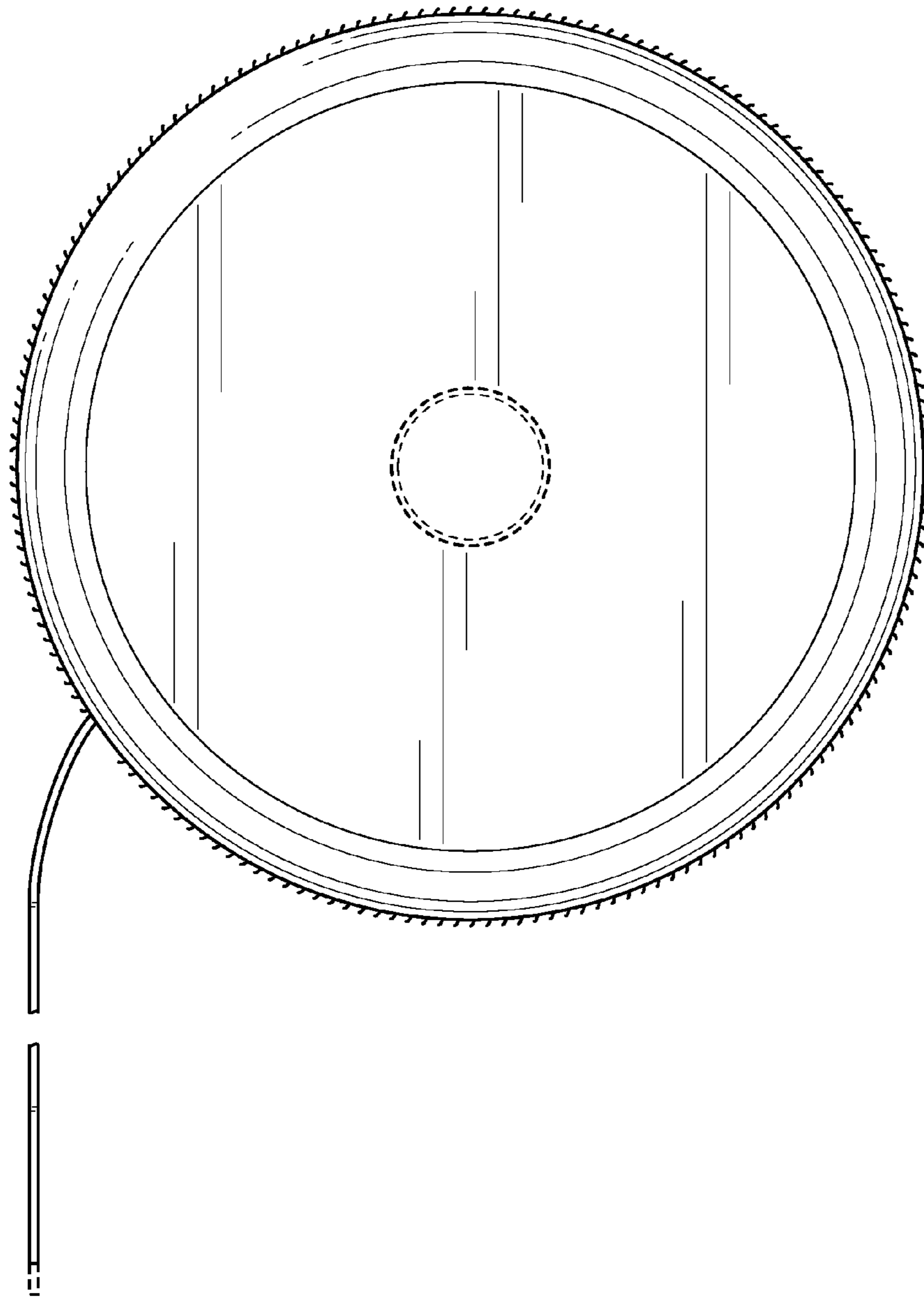

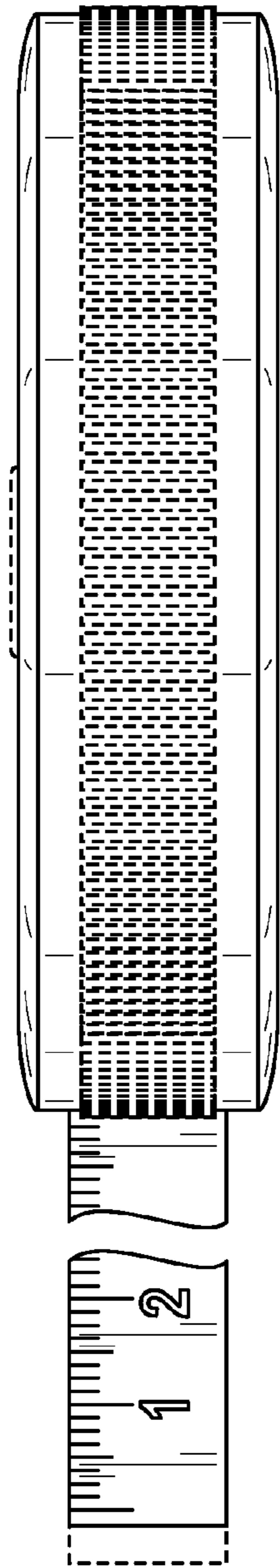

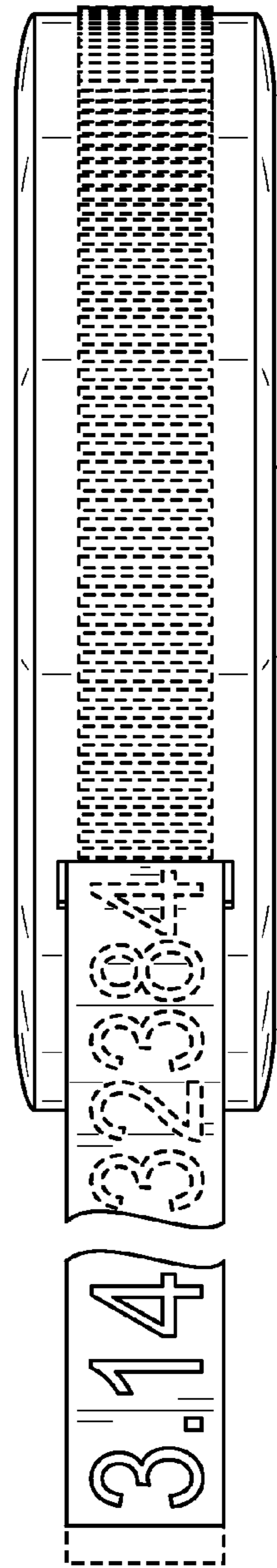

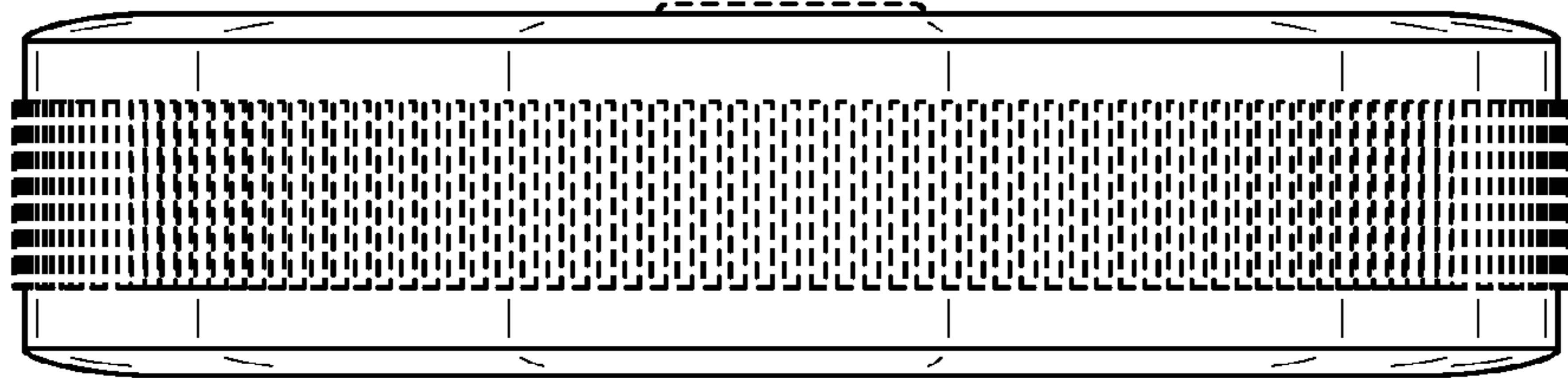

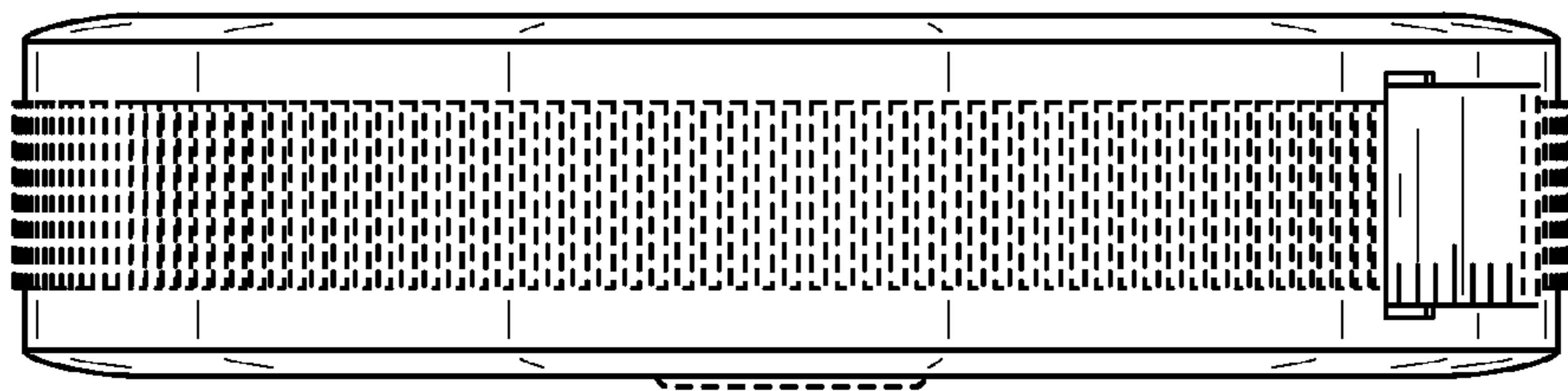

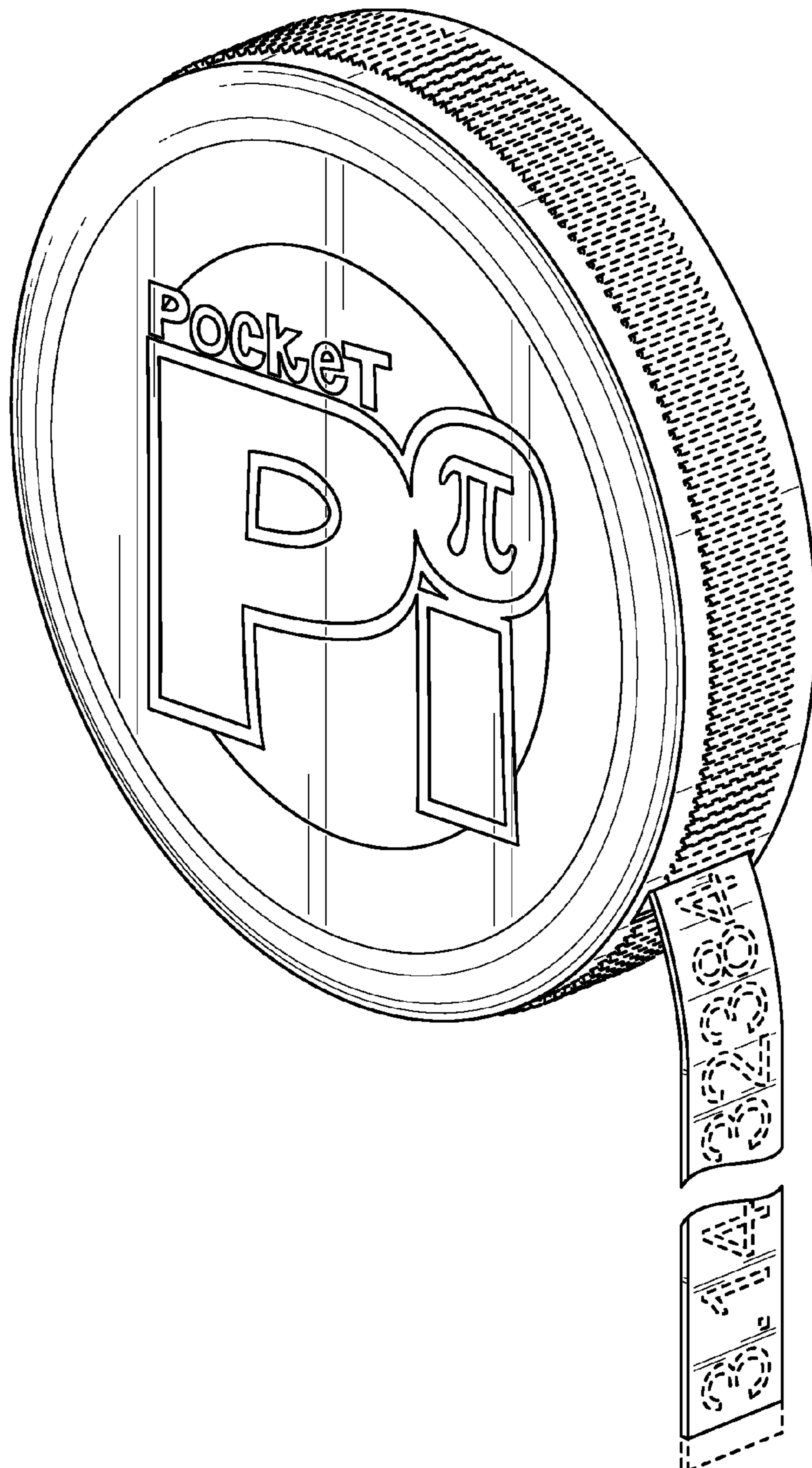

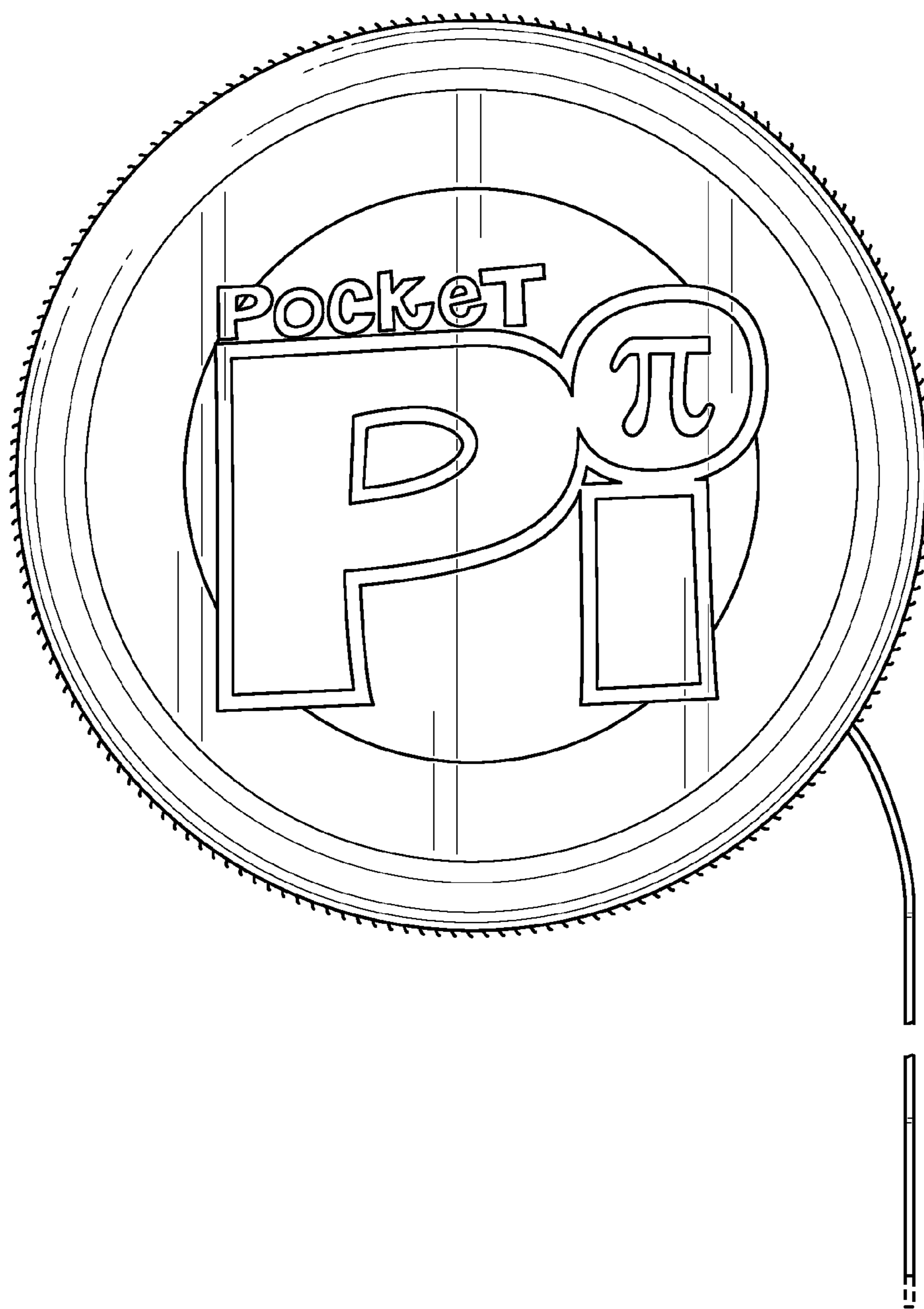

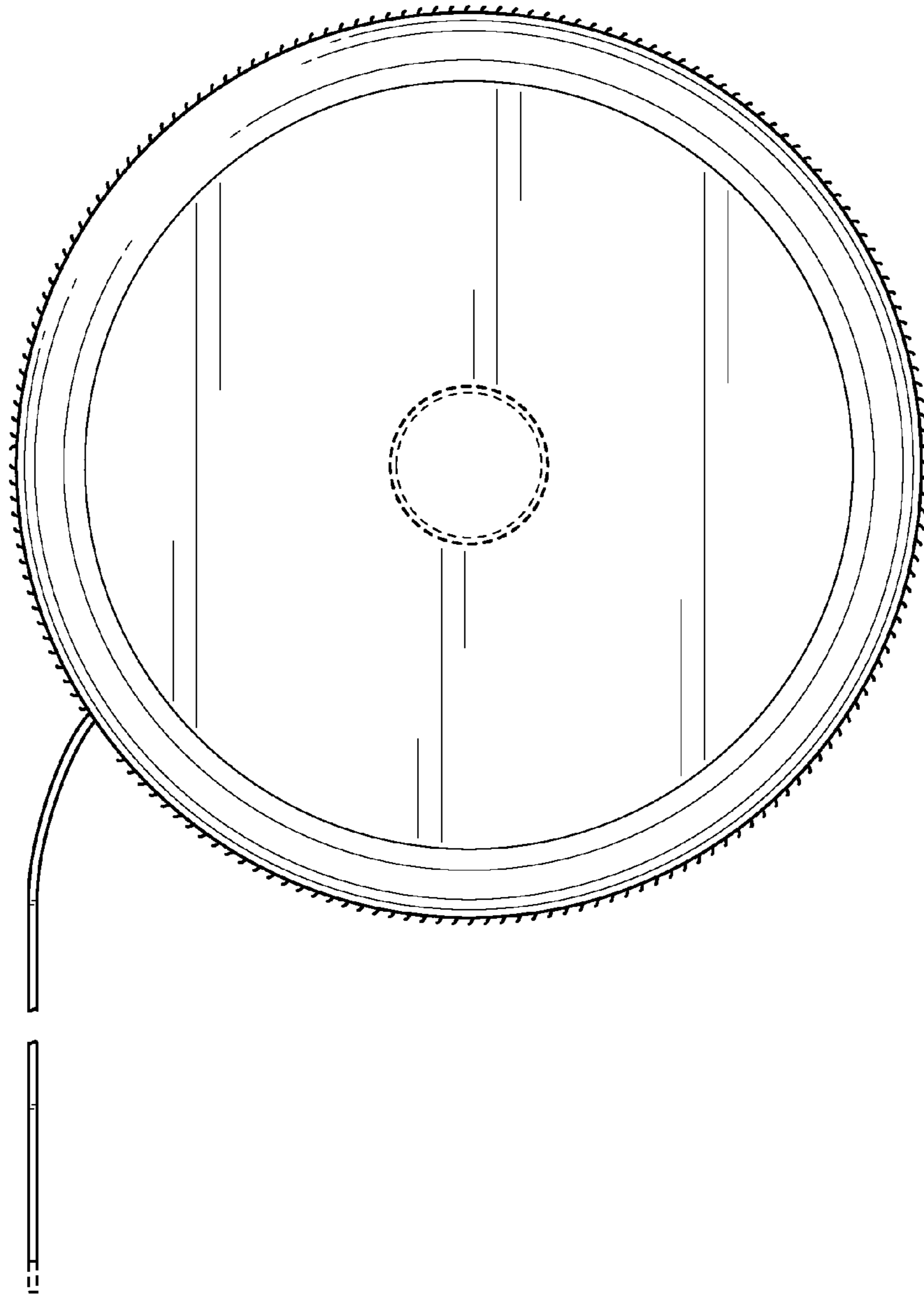

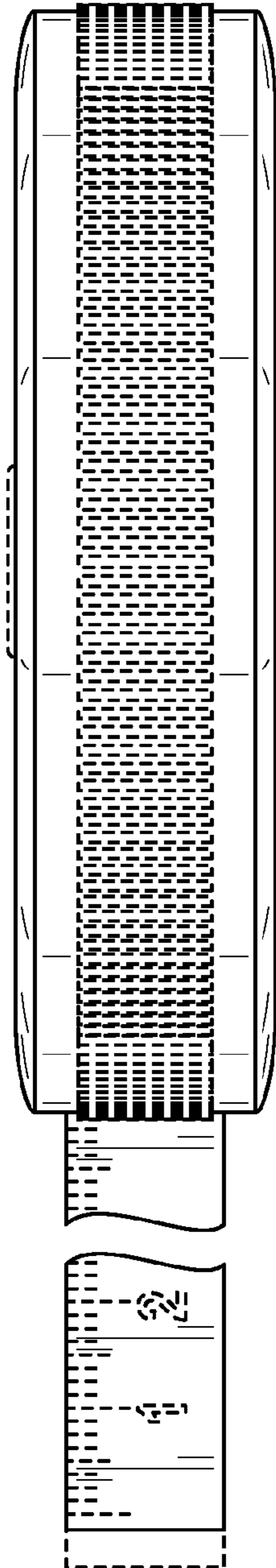

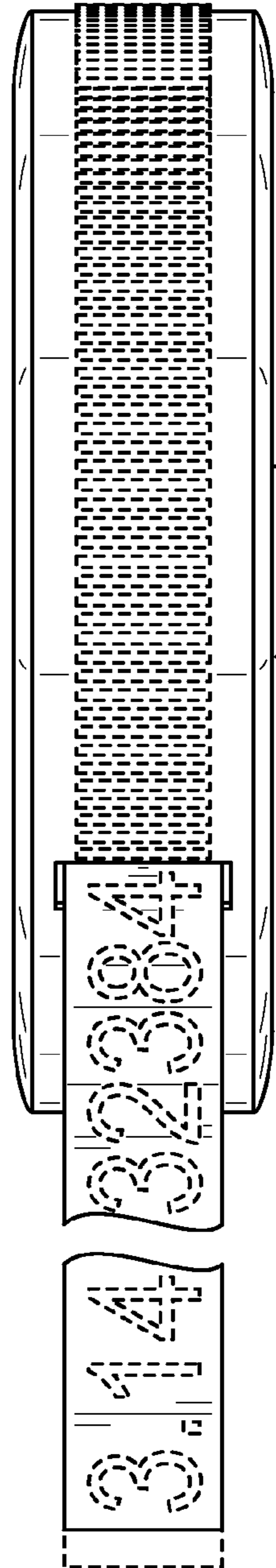

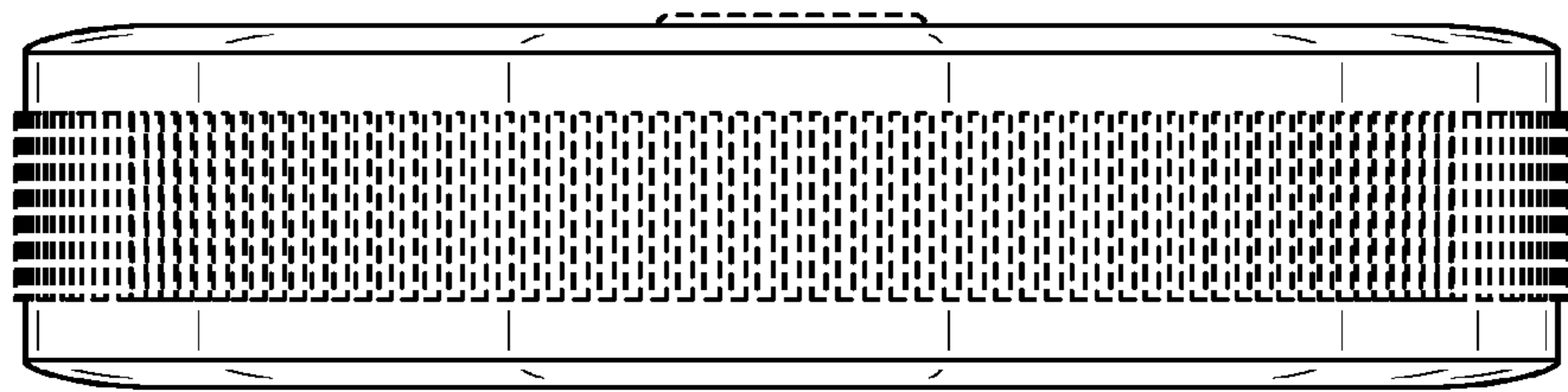

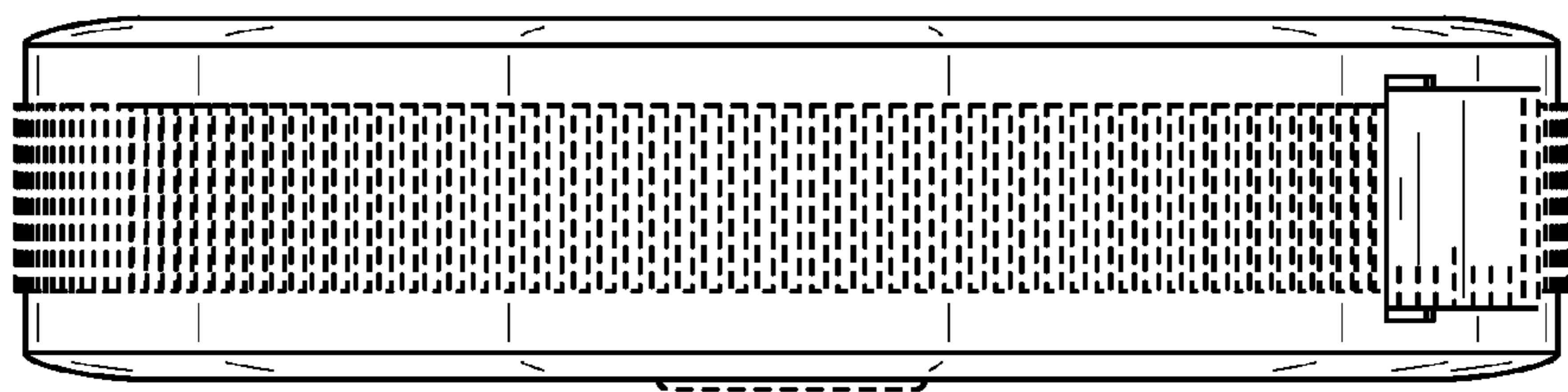

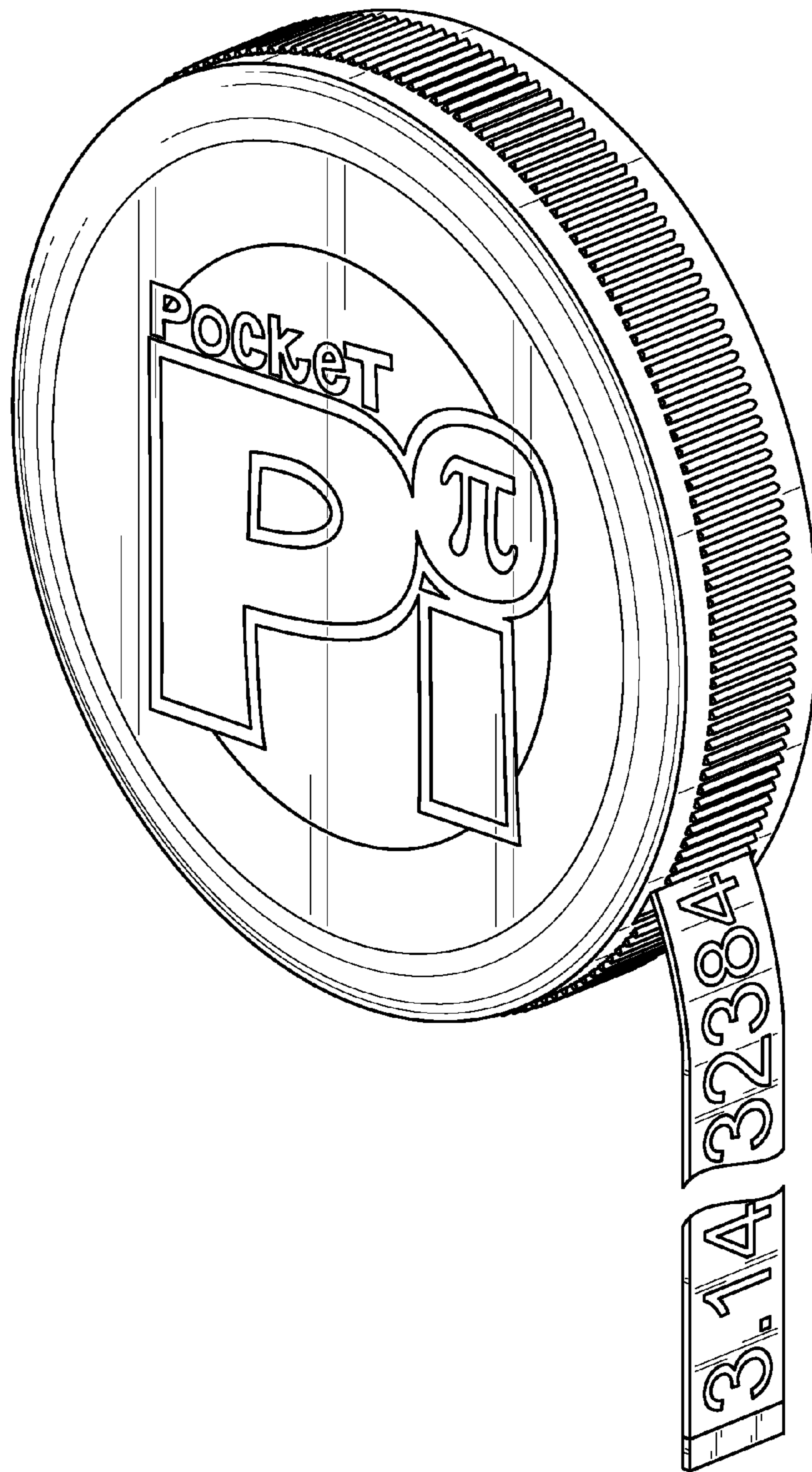

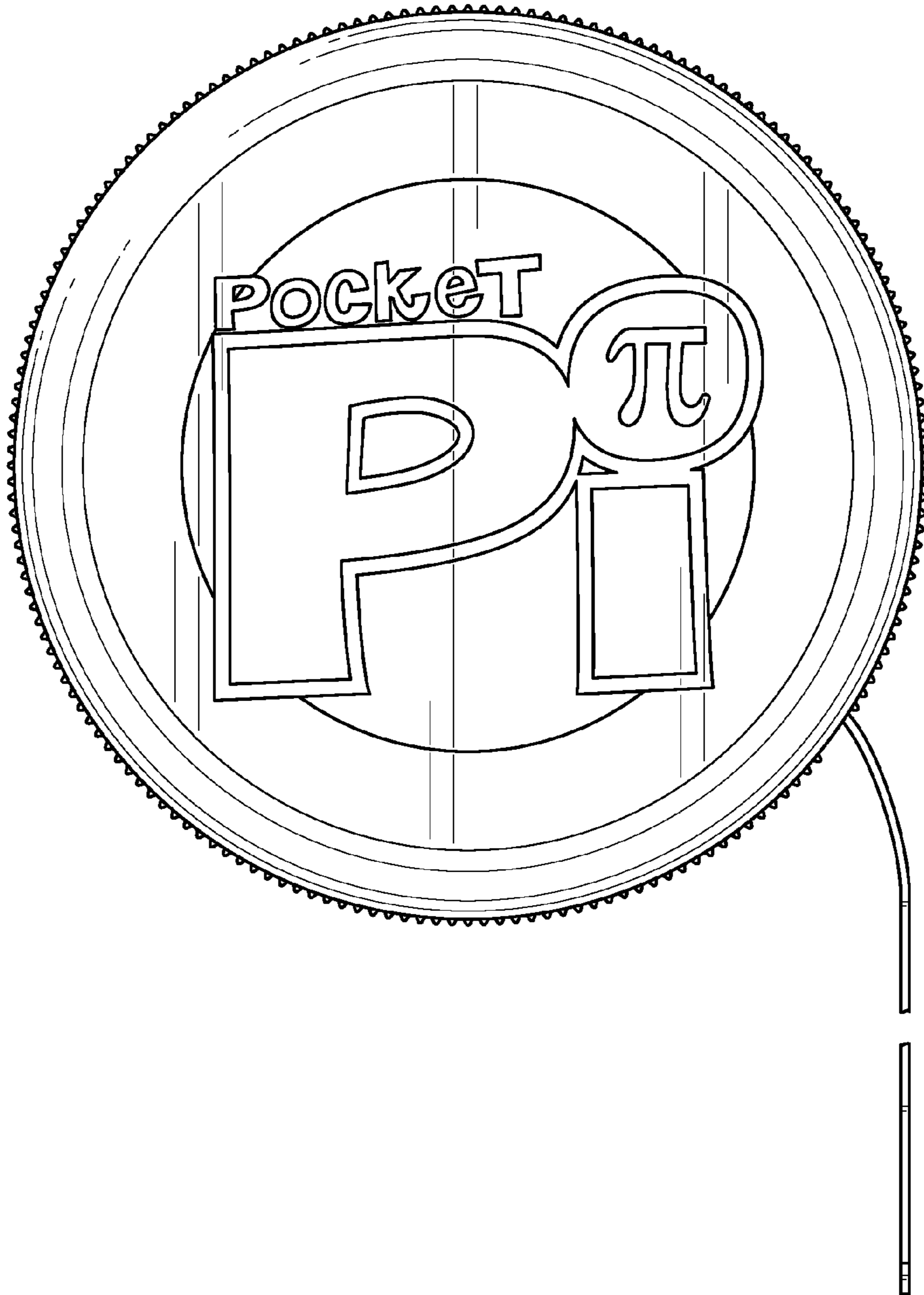

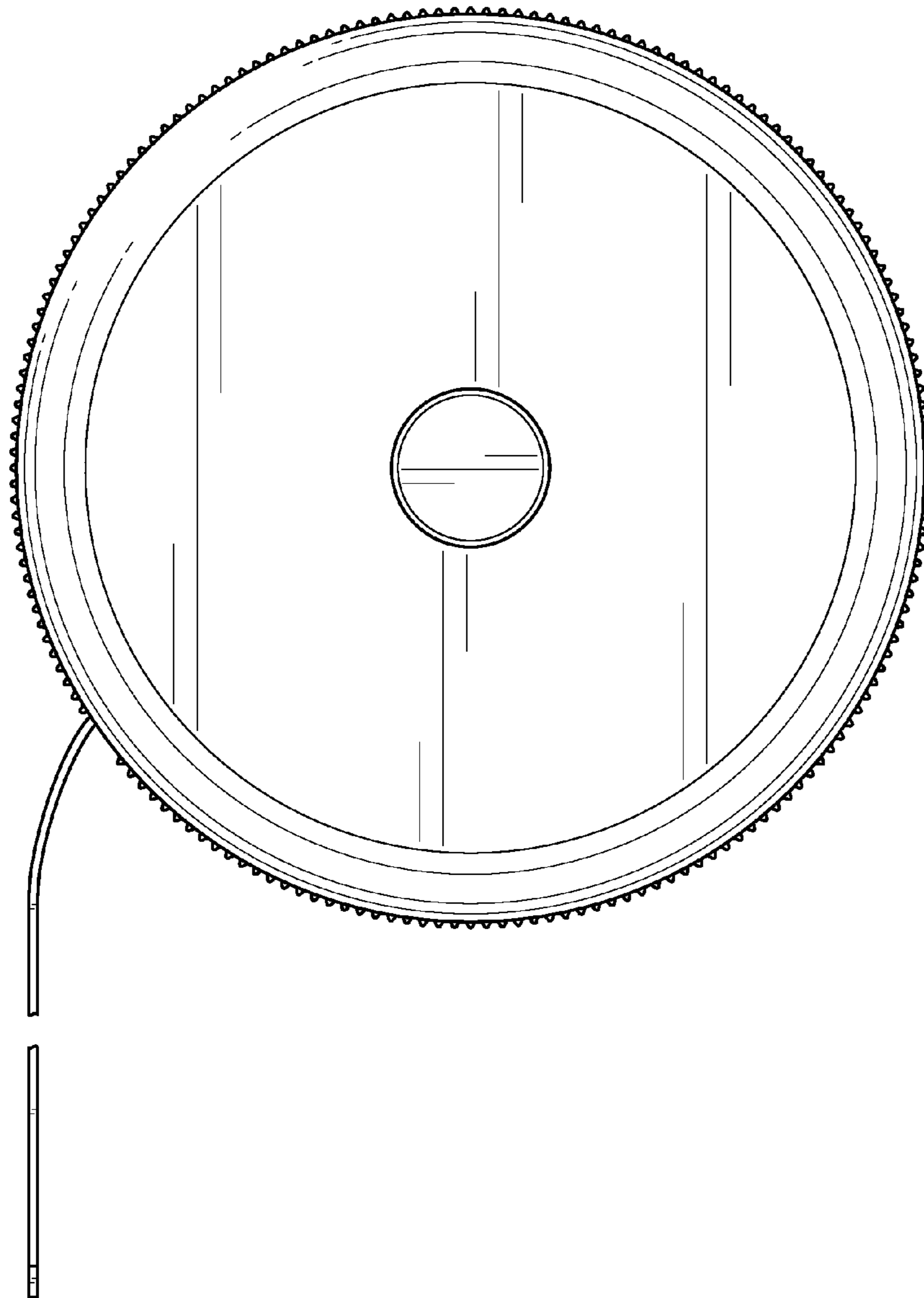

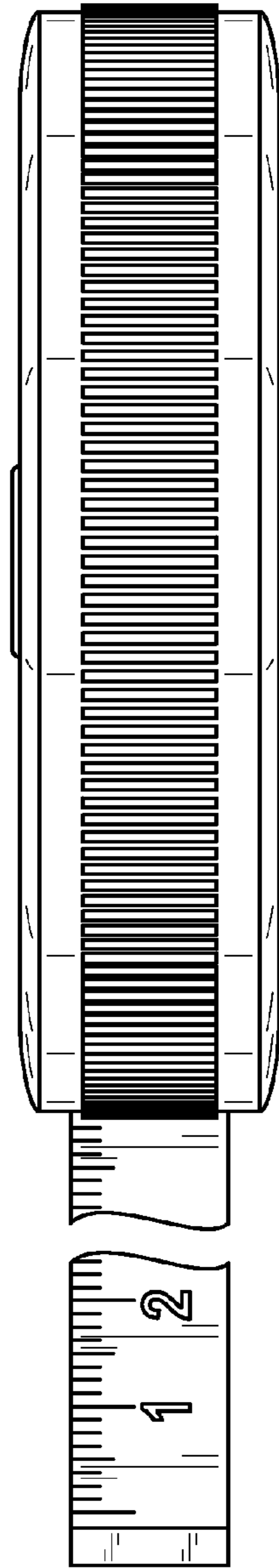

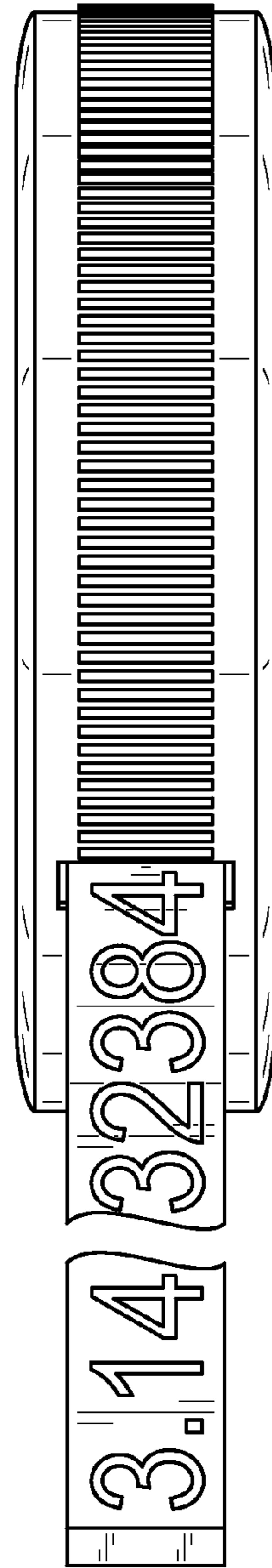

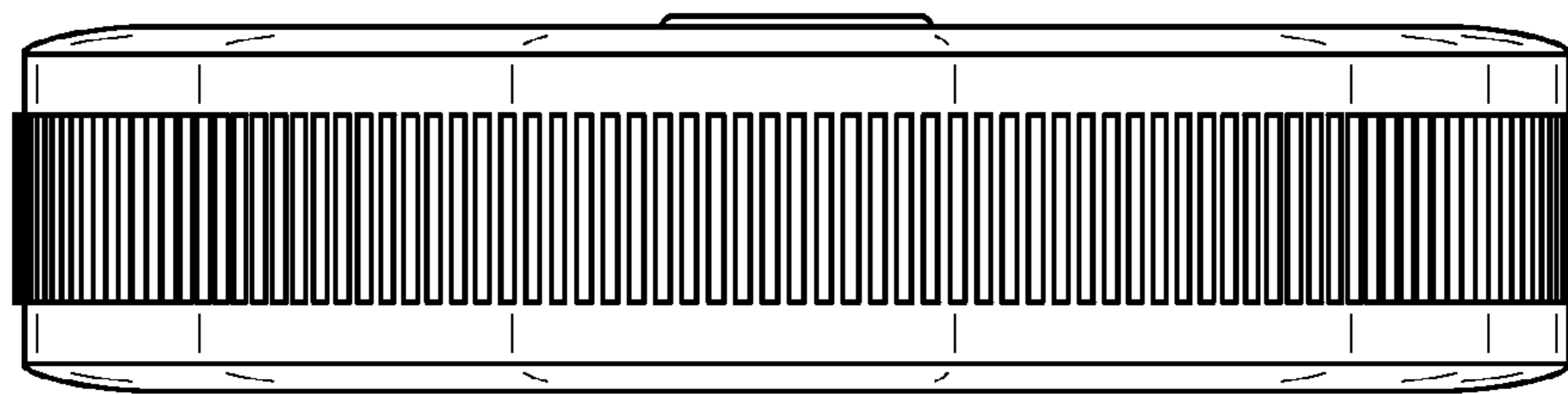

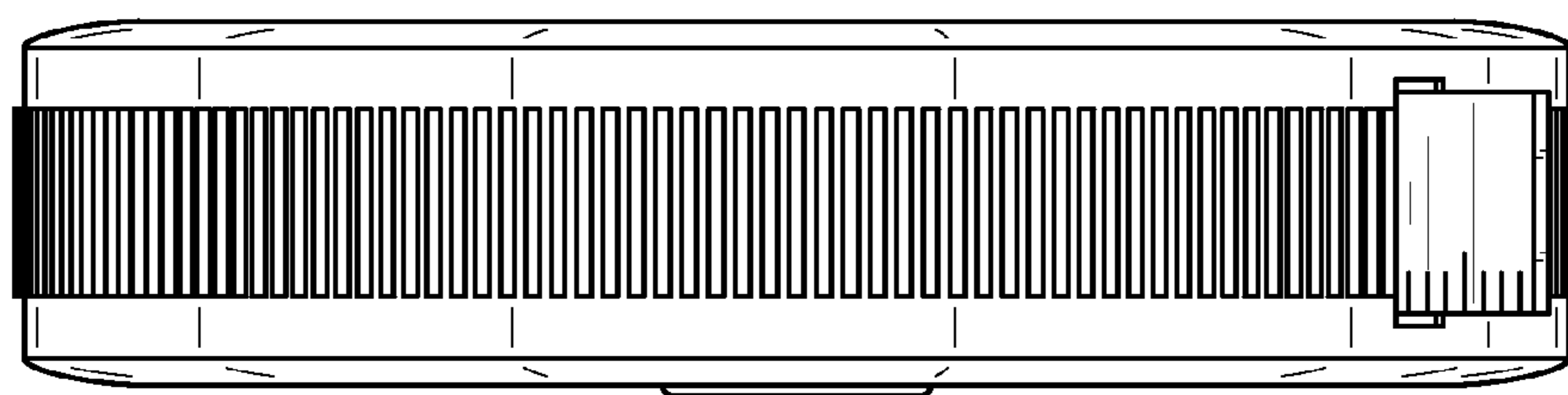
