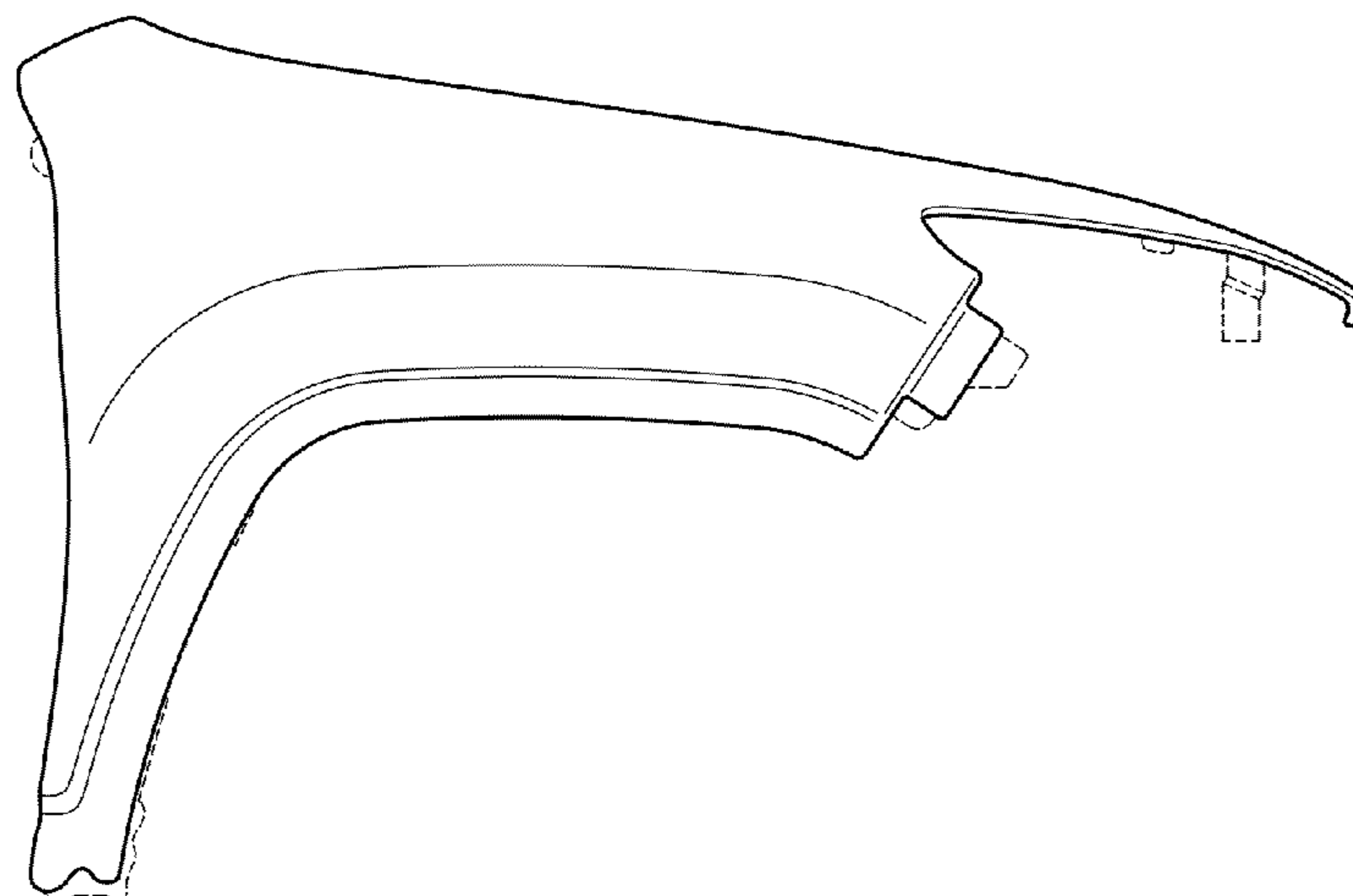
FIG. 1 is a side perspective view of a vehicle front fender showing the right side fender of our new design;

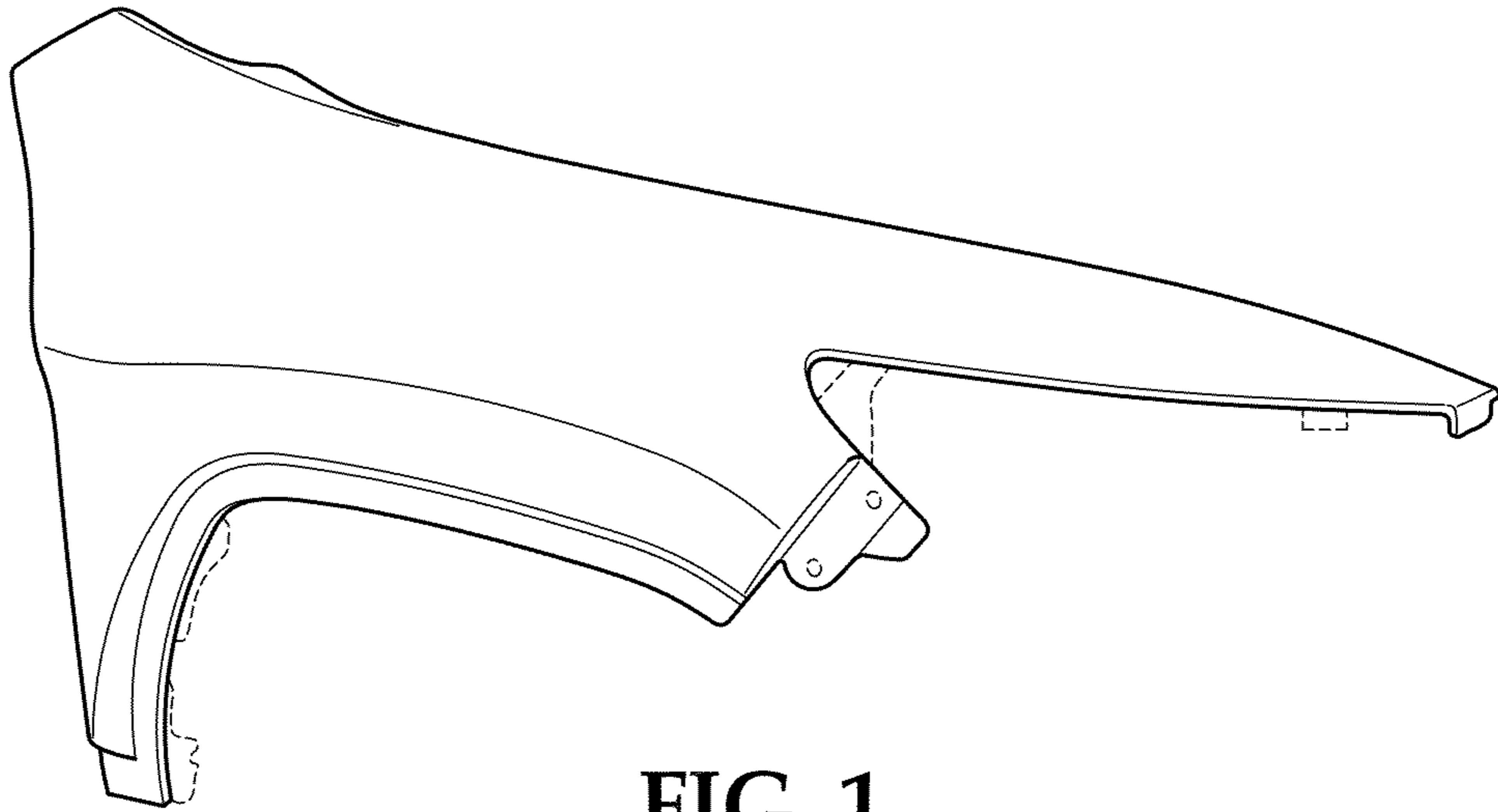

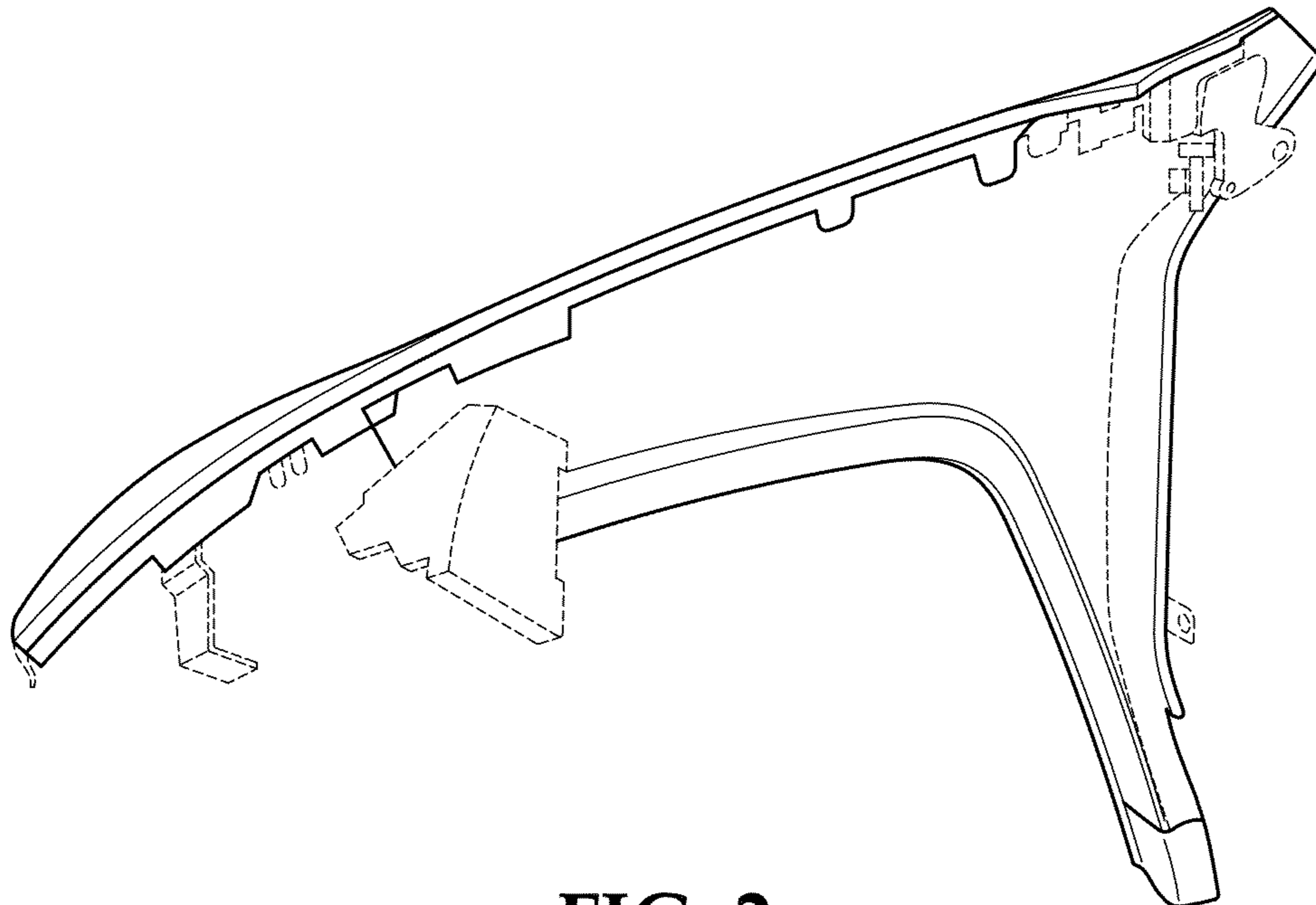

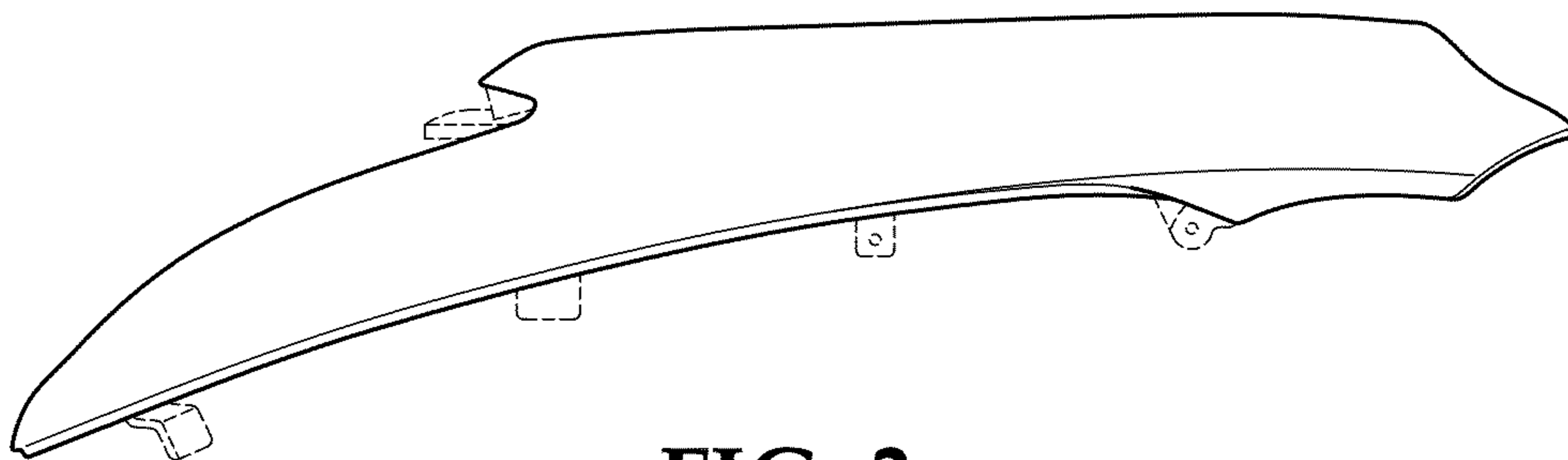

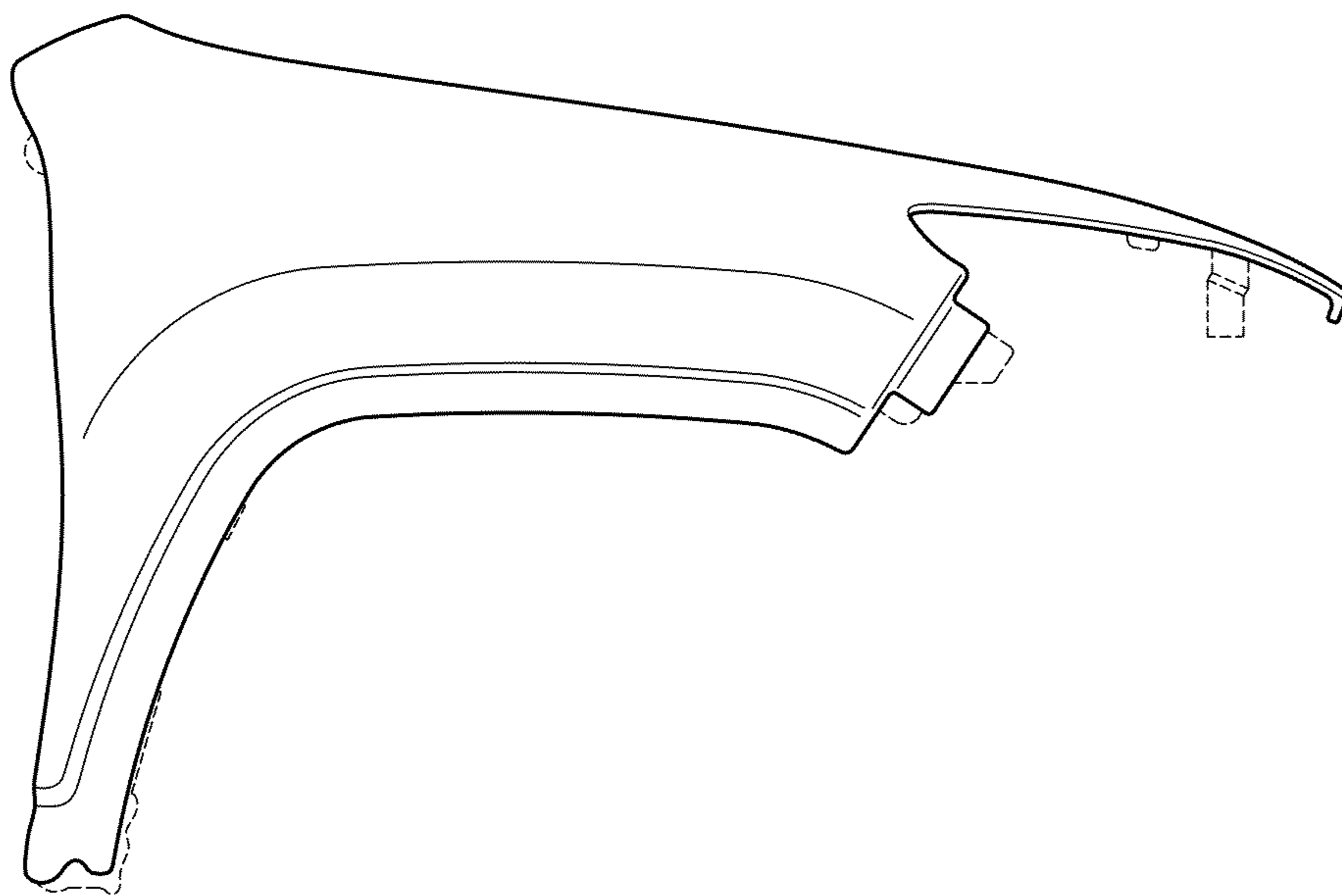

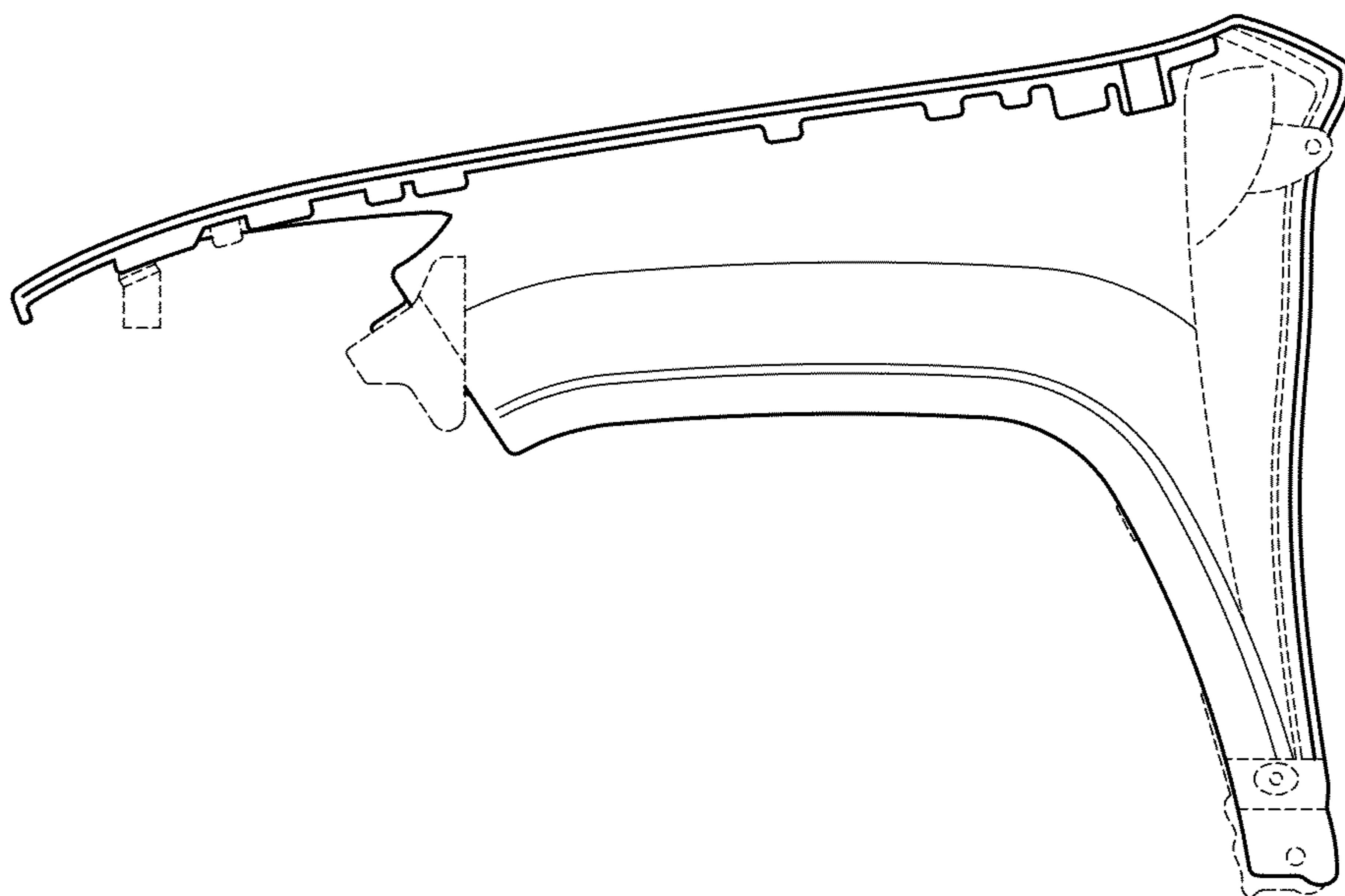

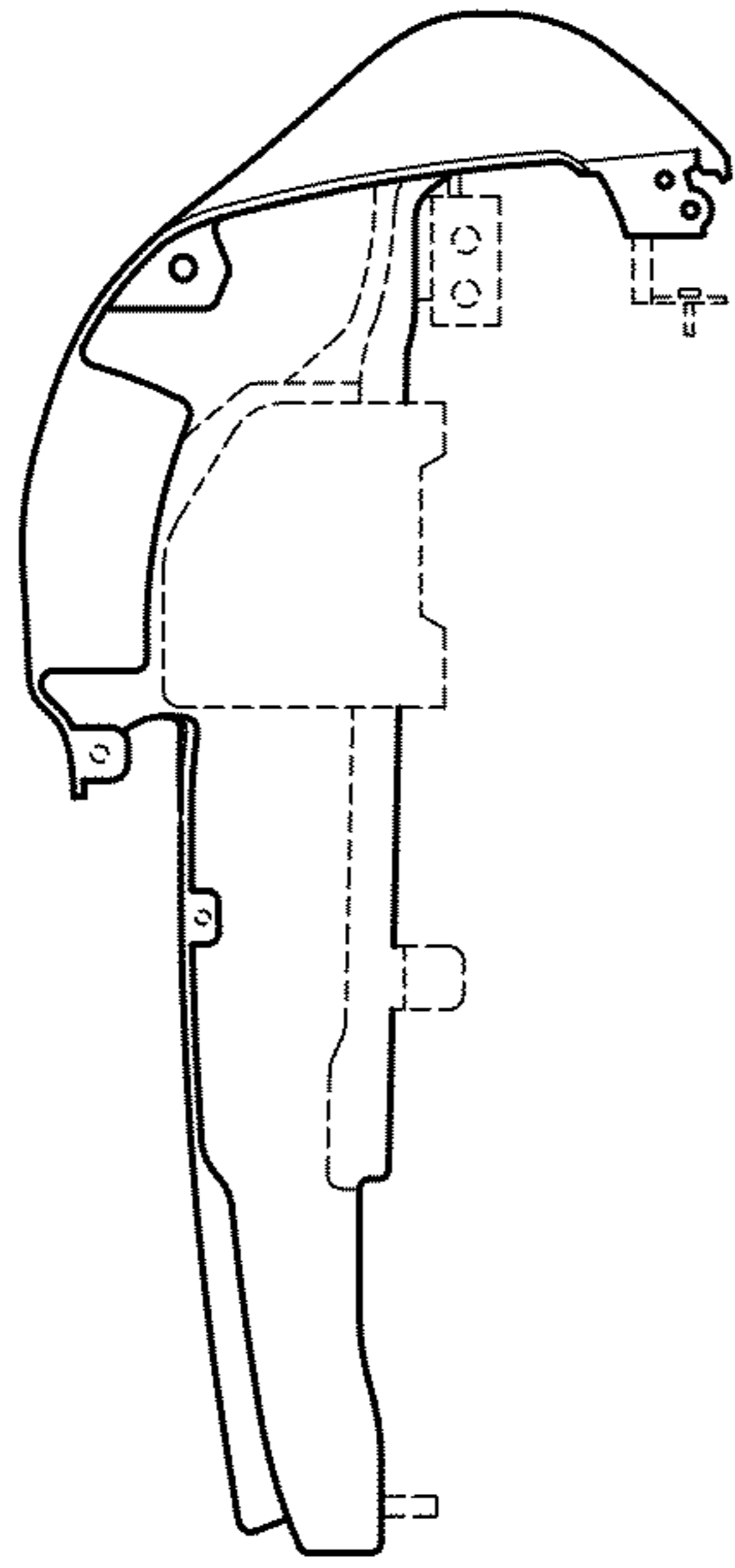

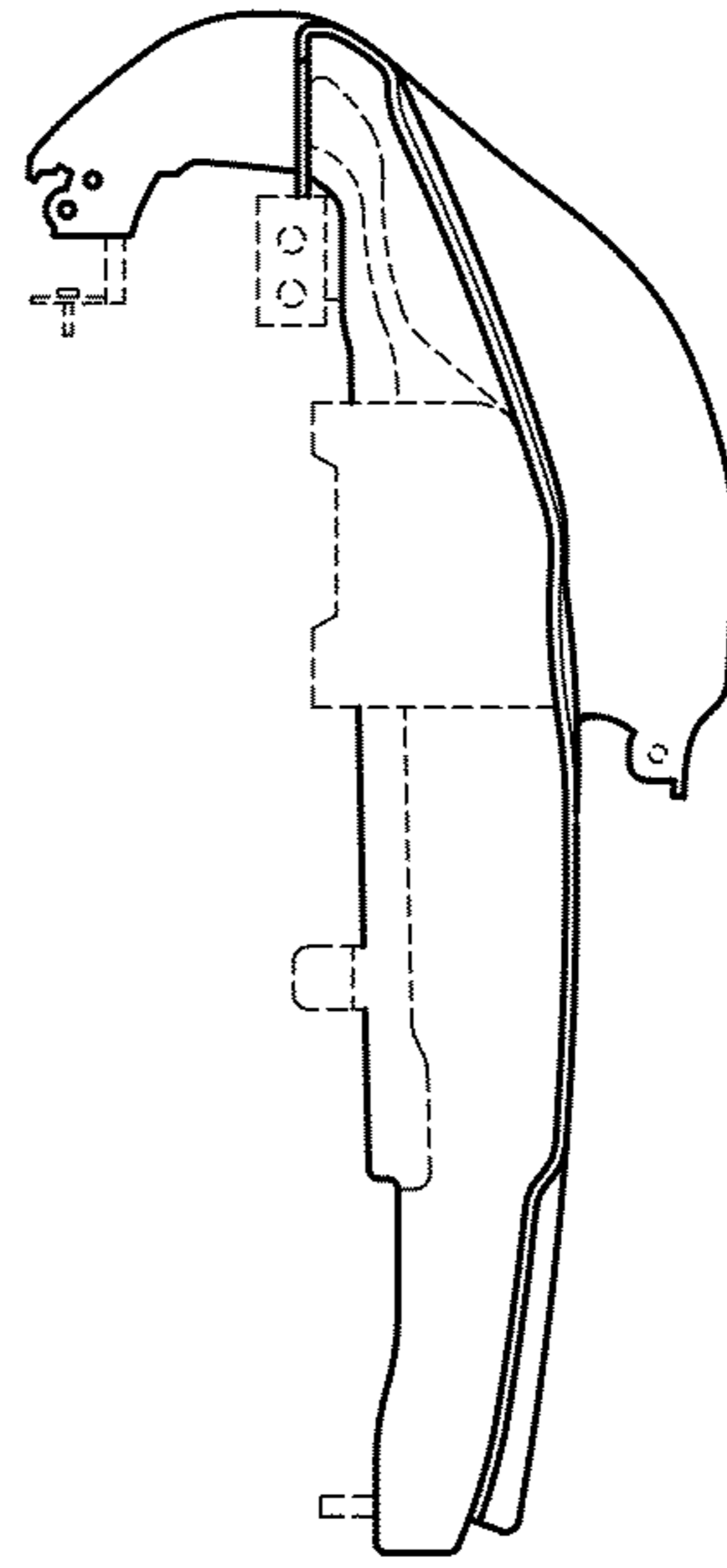

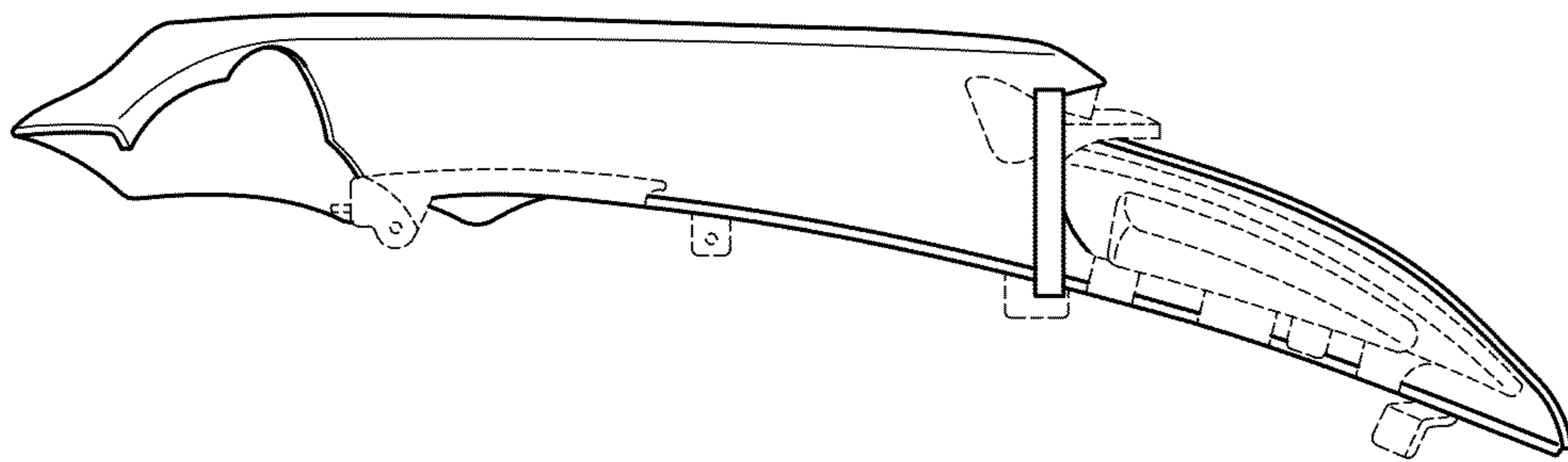

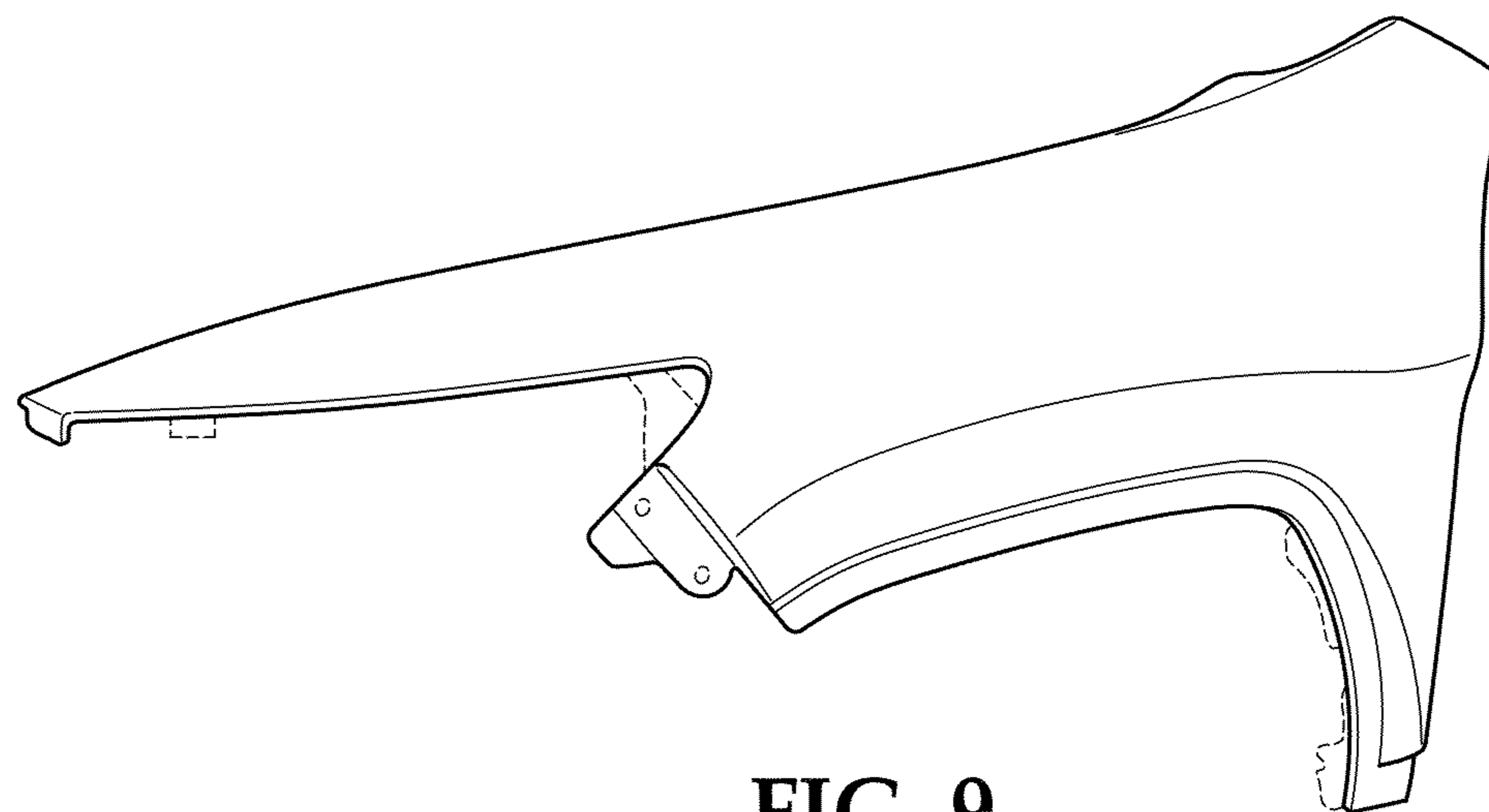

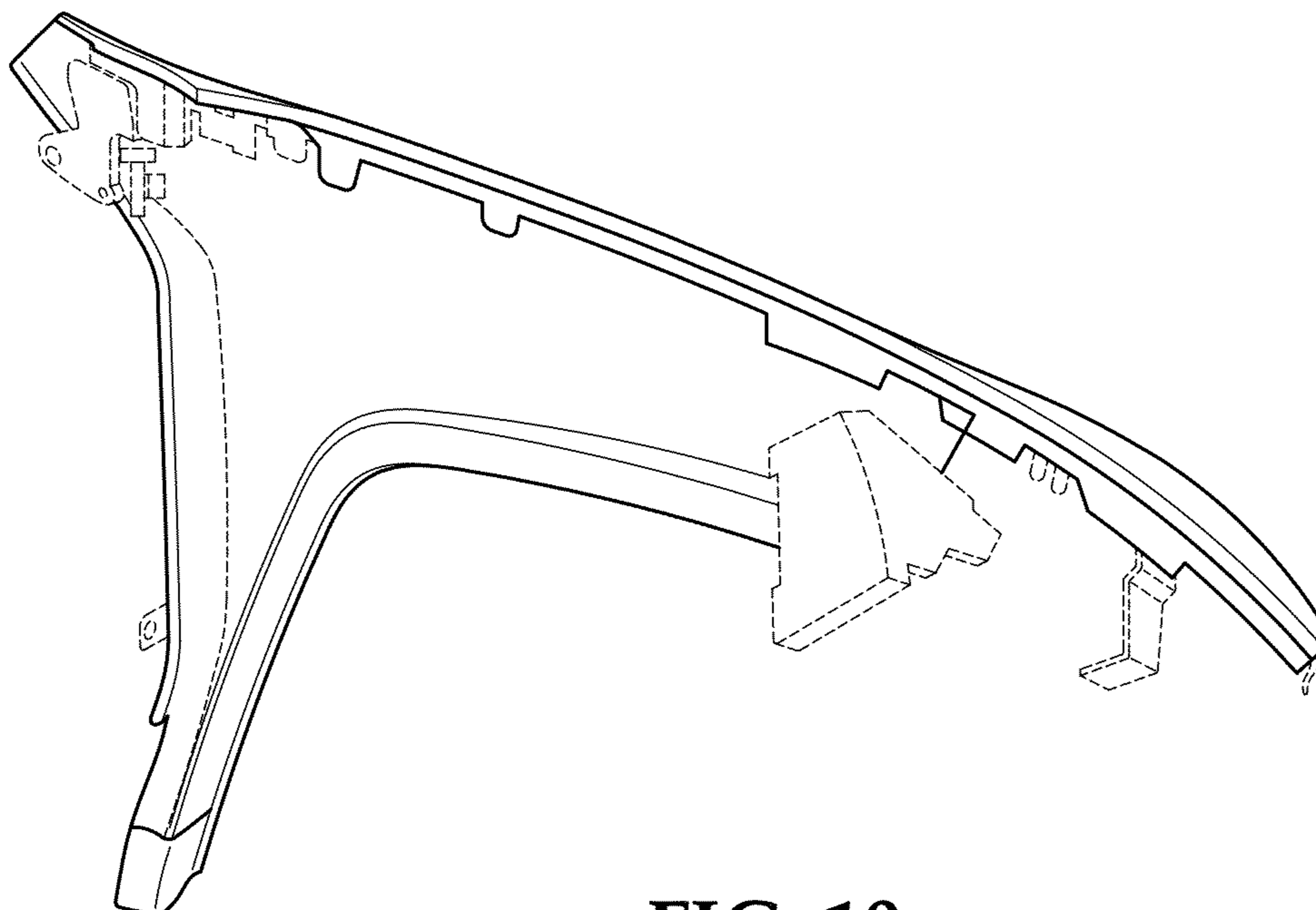

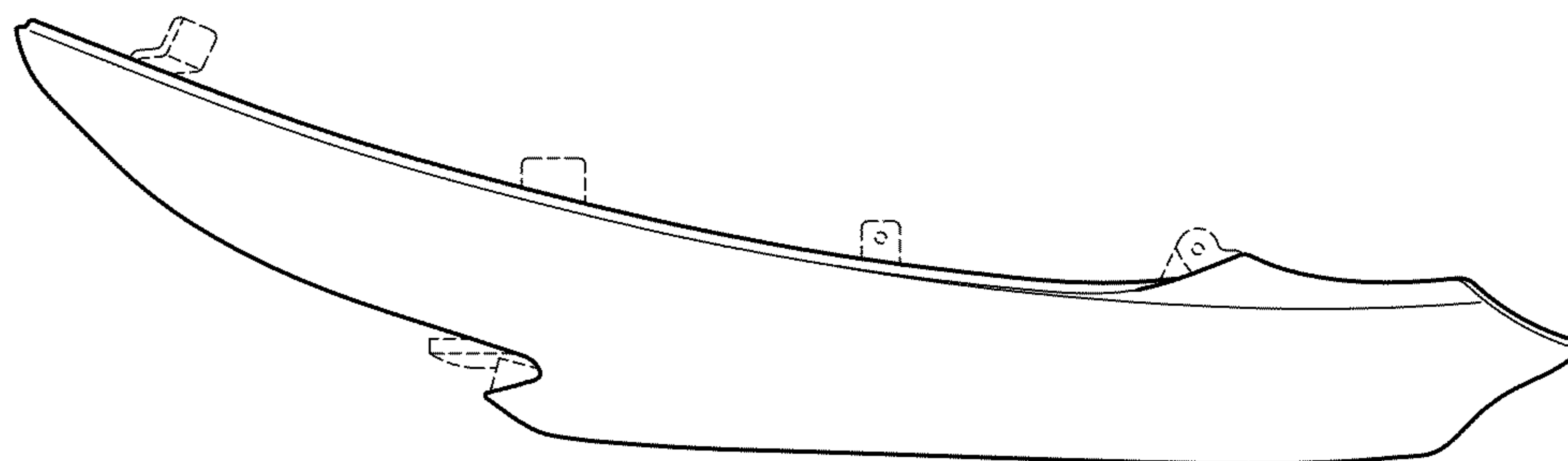

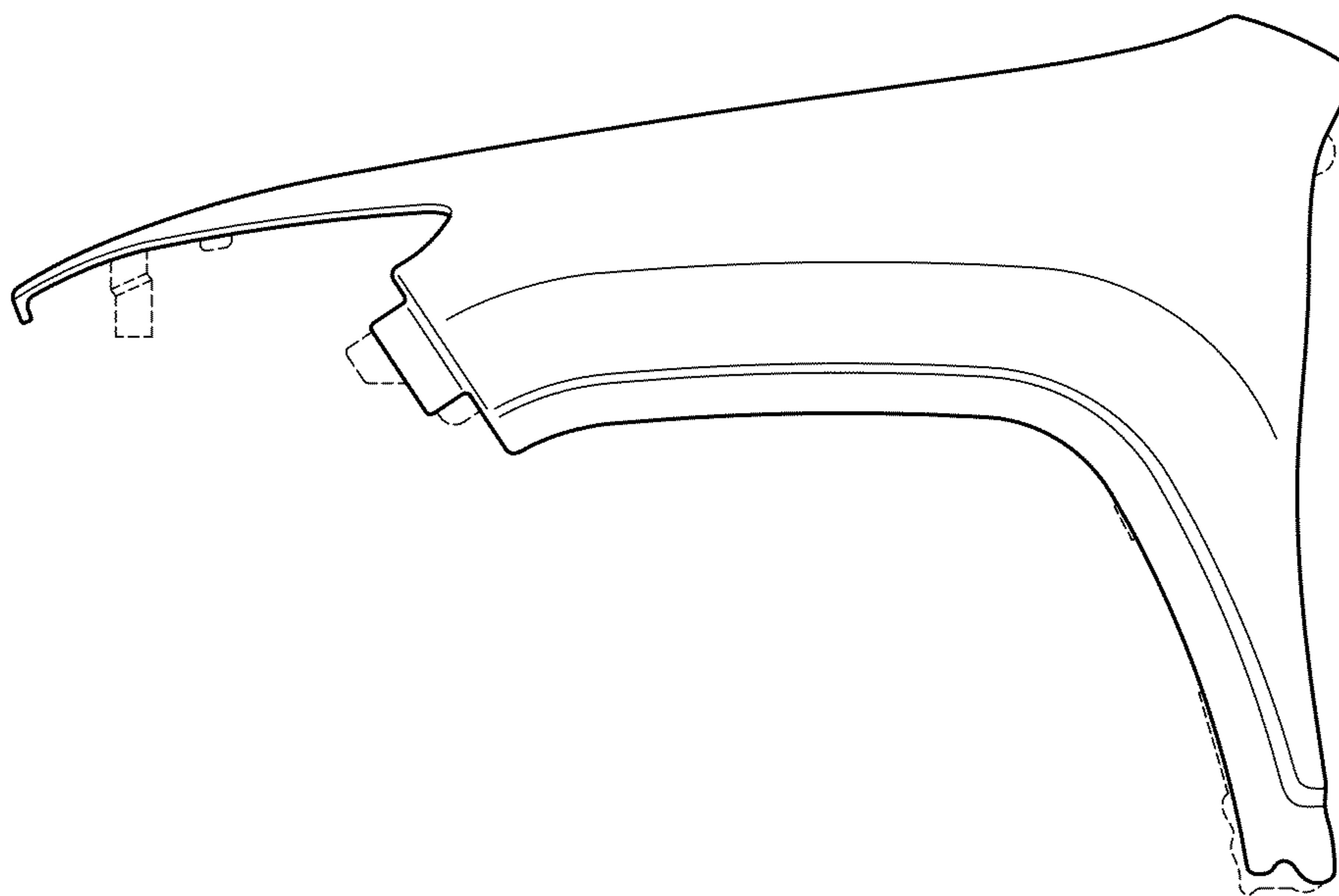

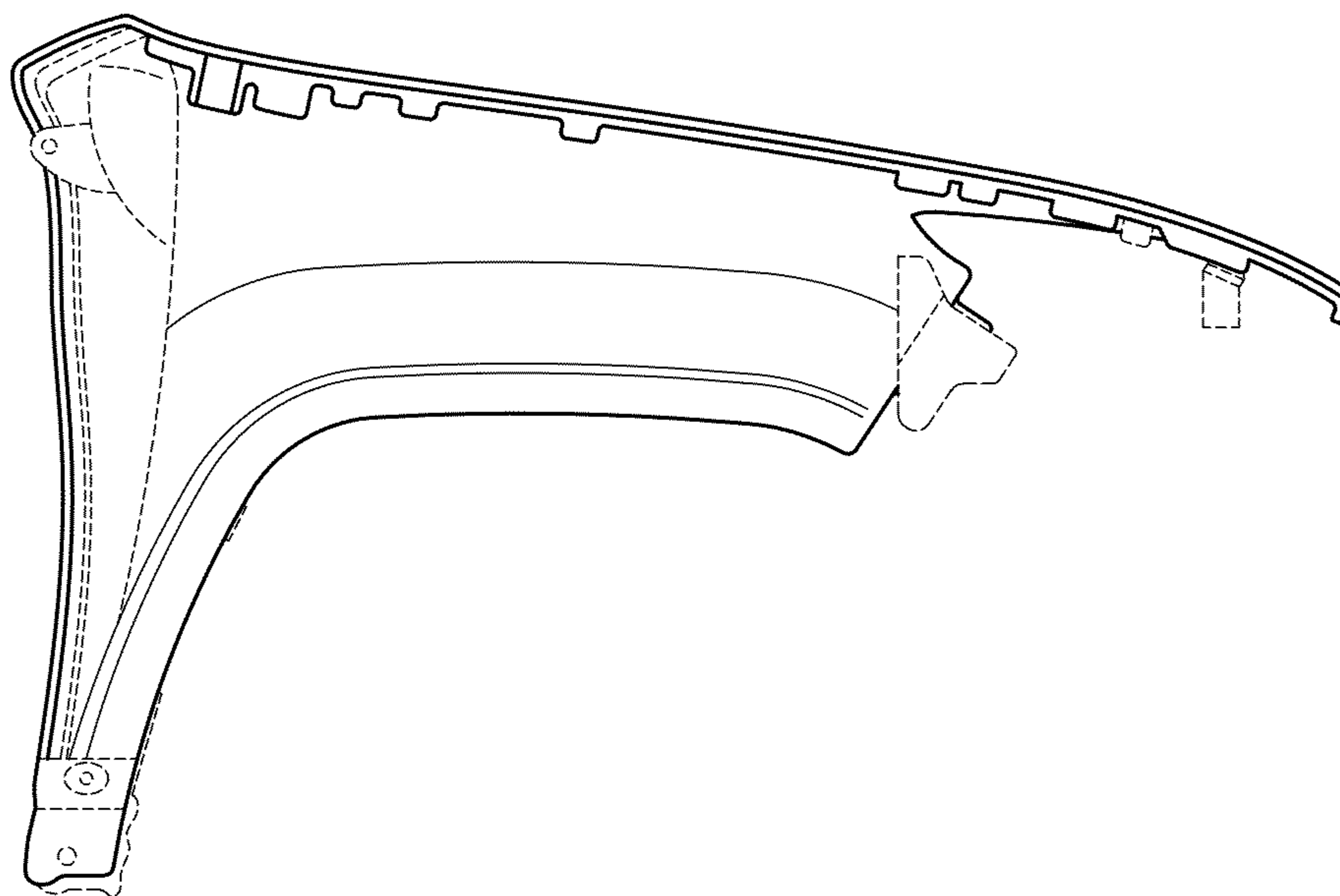

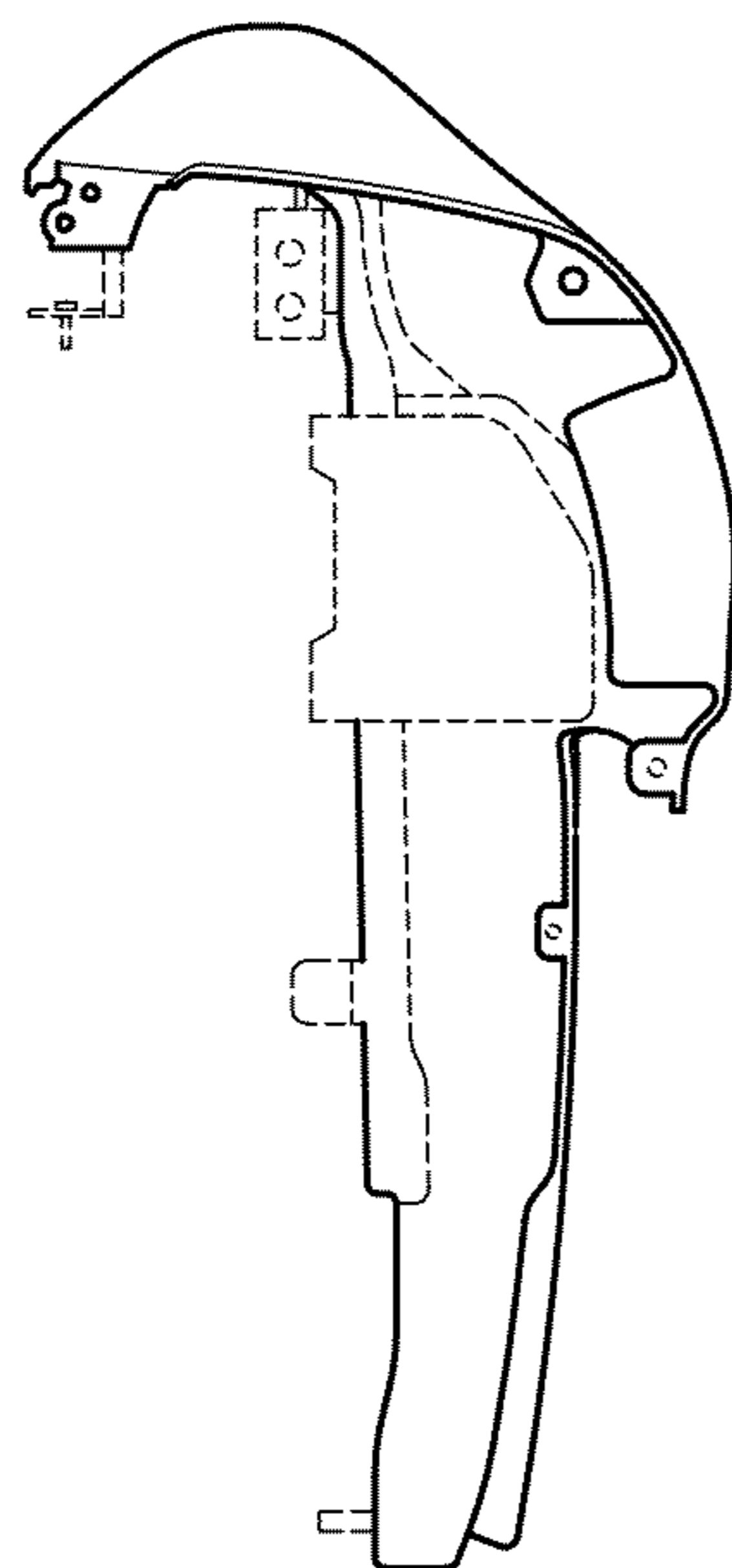

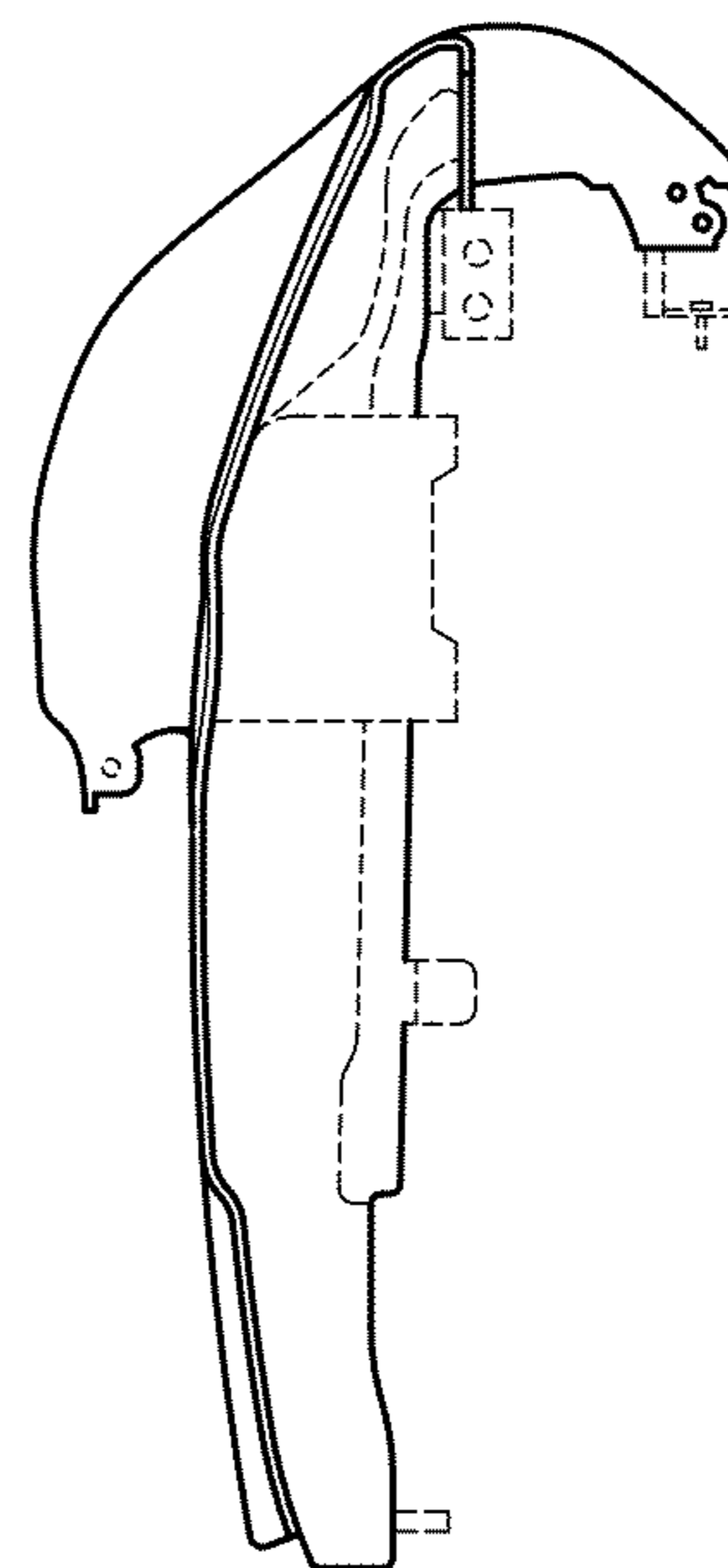

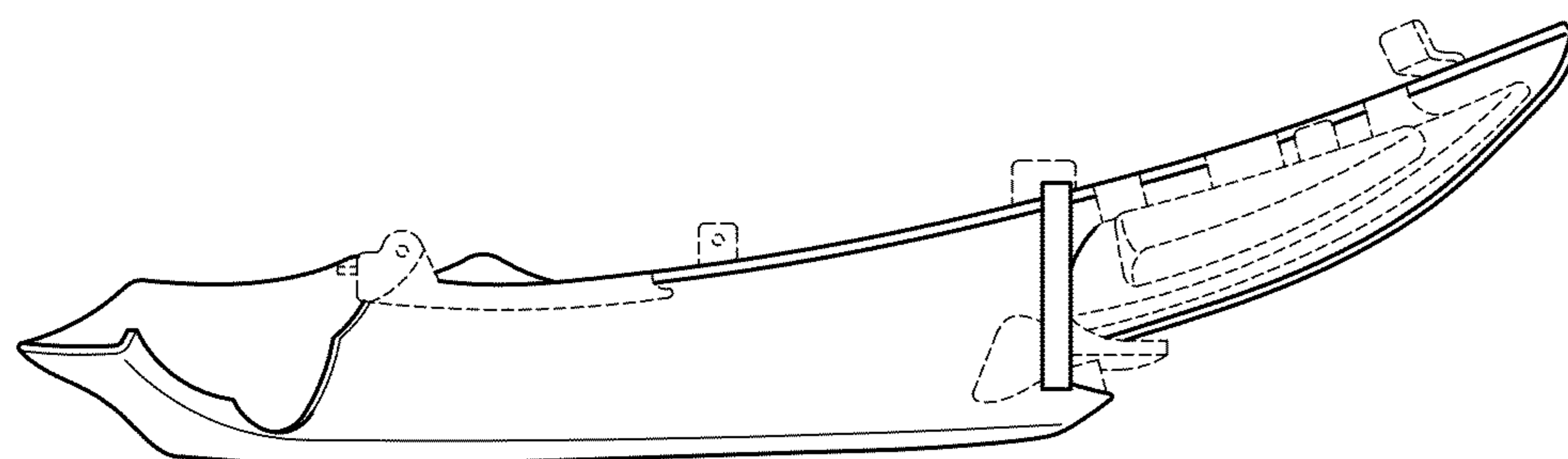
