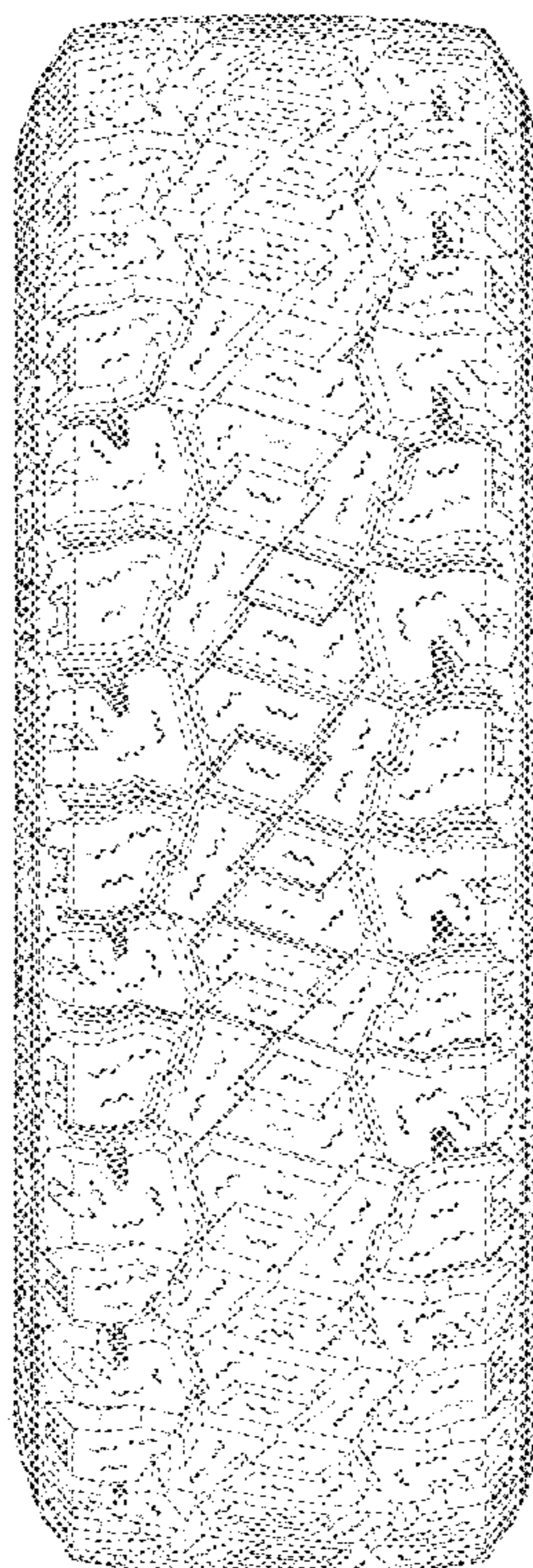
(57) **CLAIM**

The ornamental design for a pneumatic tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pneumatic tire in accordance with the invention;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a partial side elevation view thereof, shown at an enlarged scale; and,
FIG. 5 is a partial front elevation view thereof, shown at an enlarged scale.

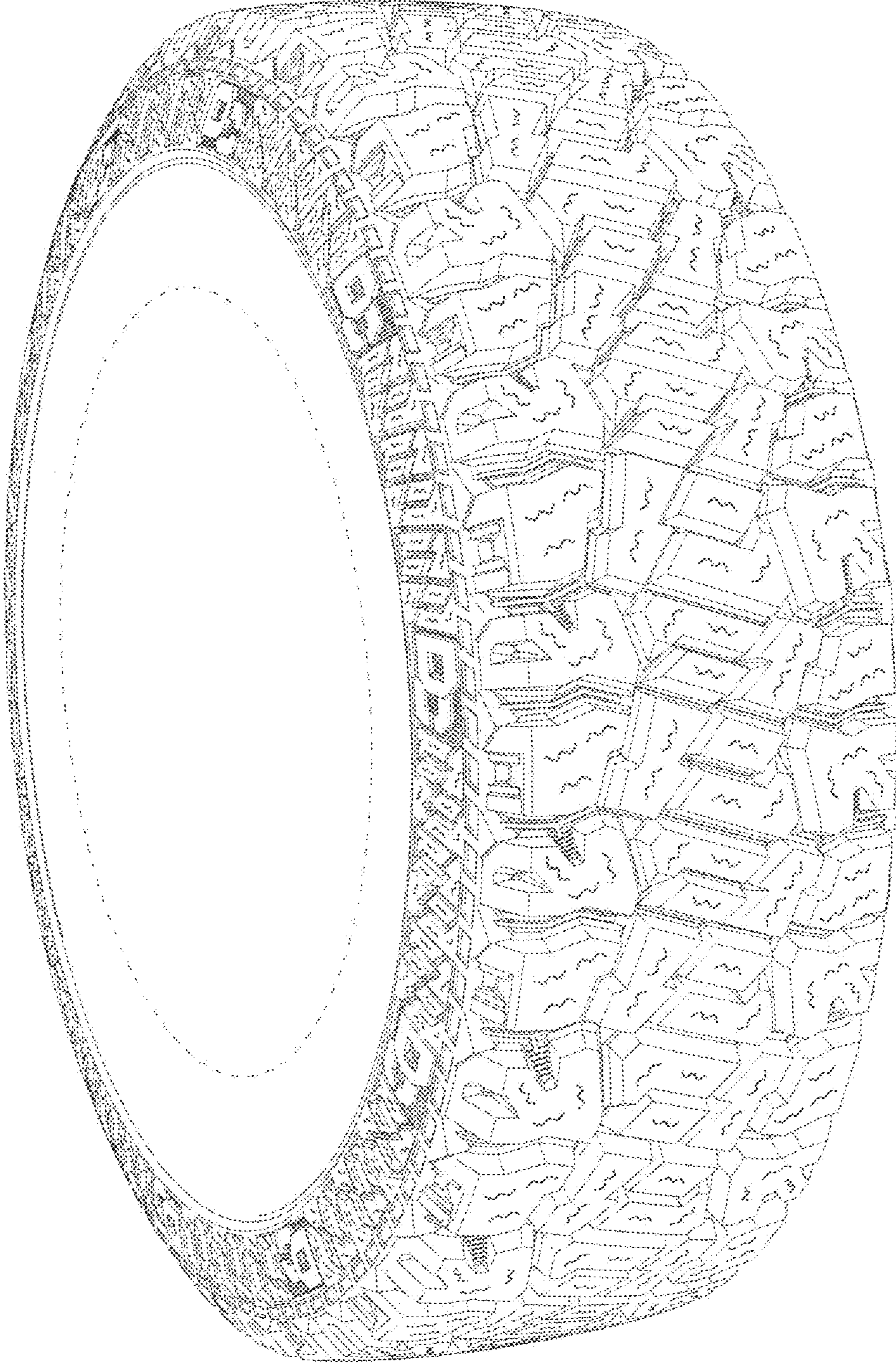

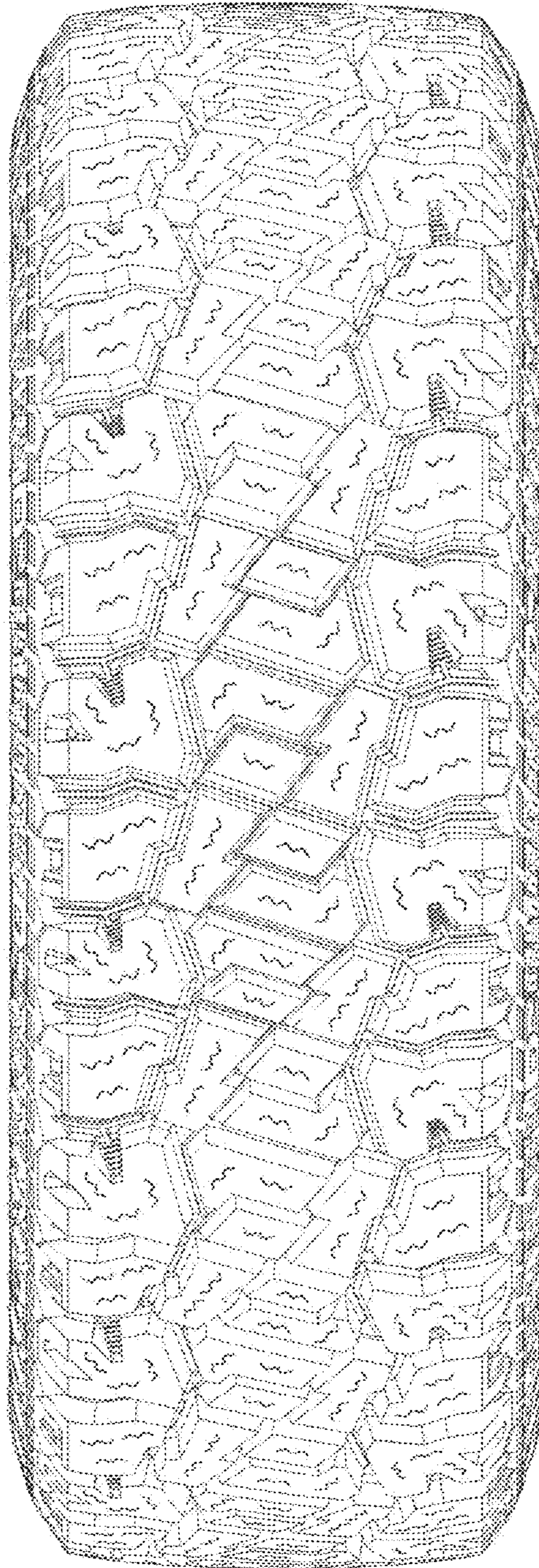

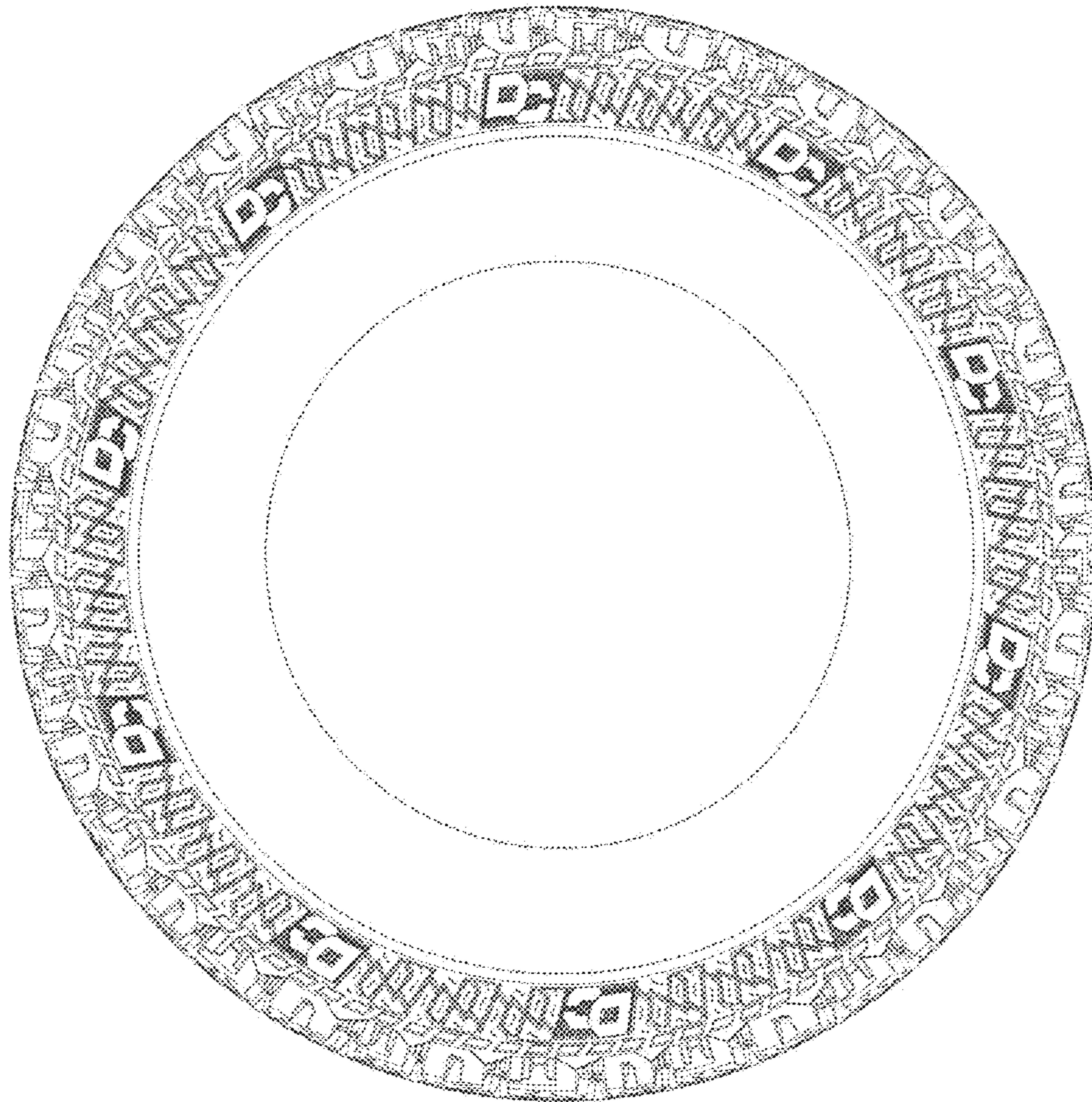

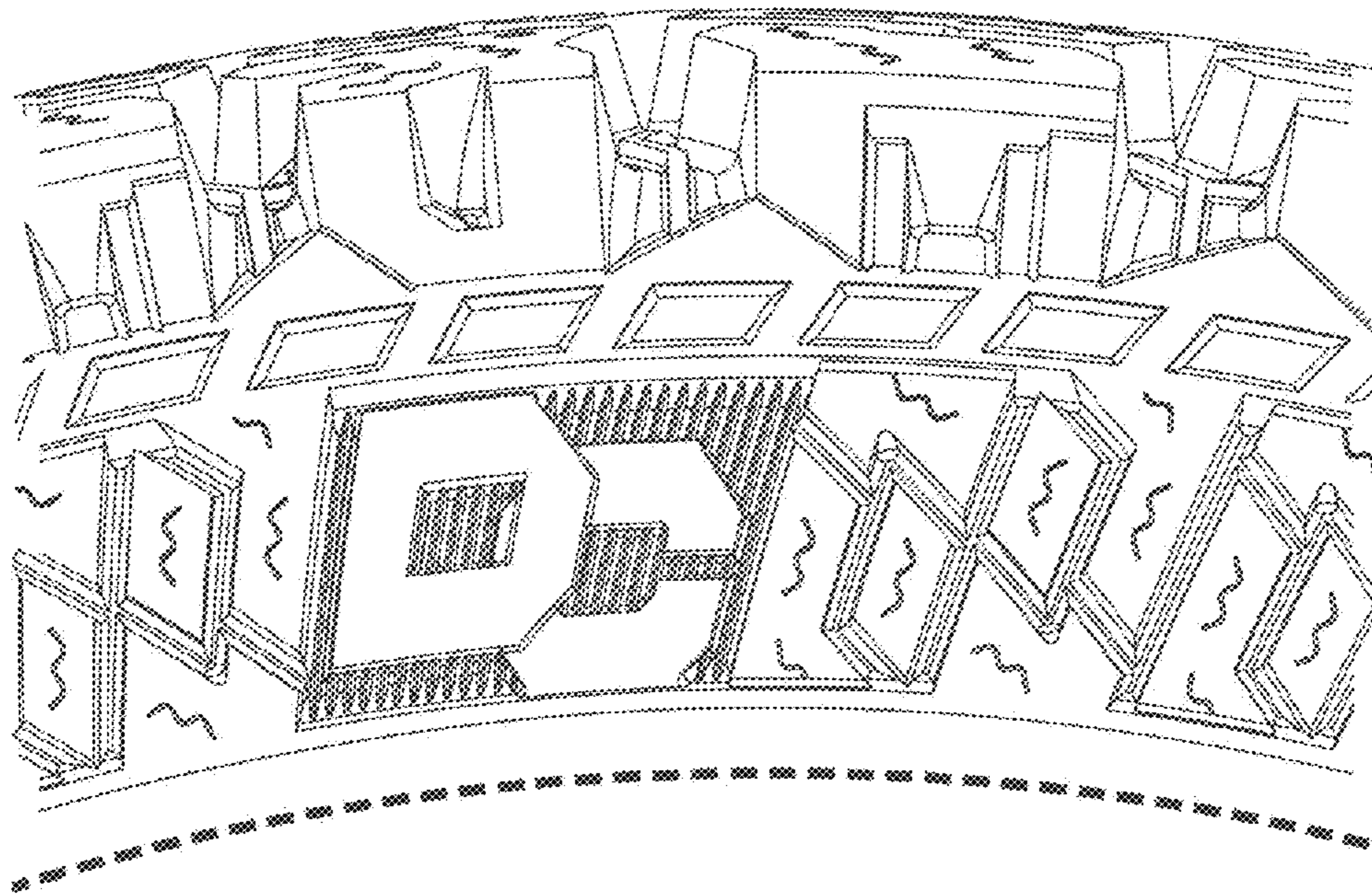

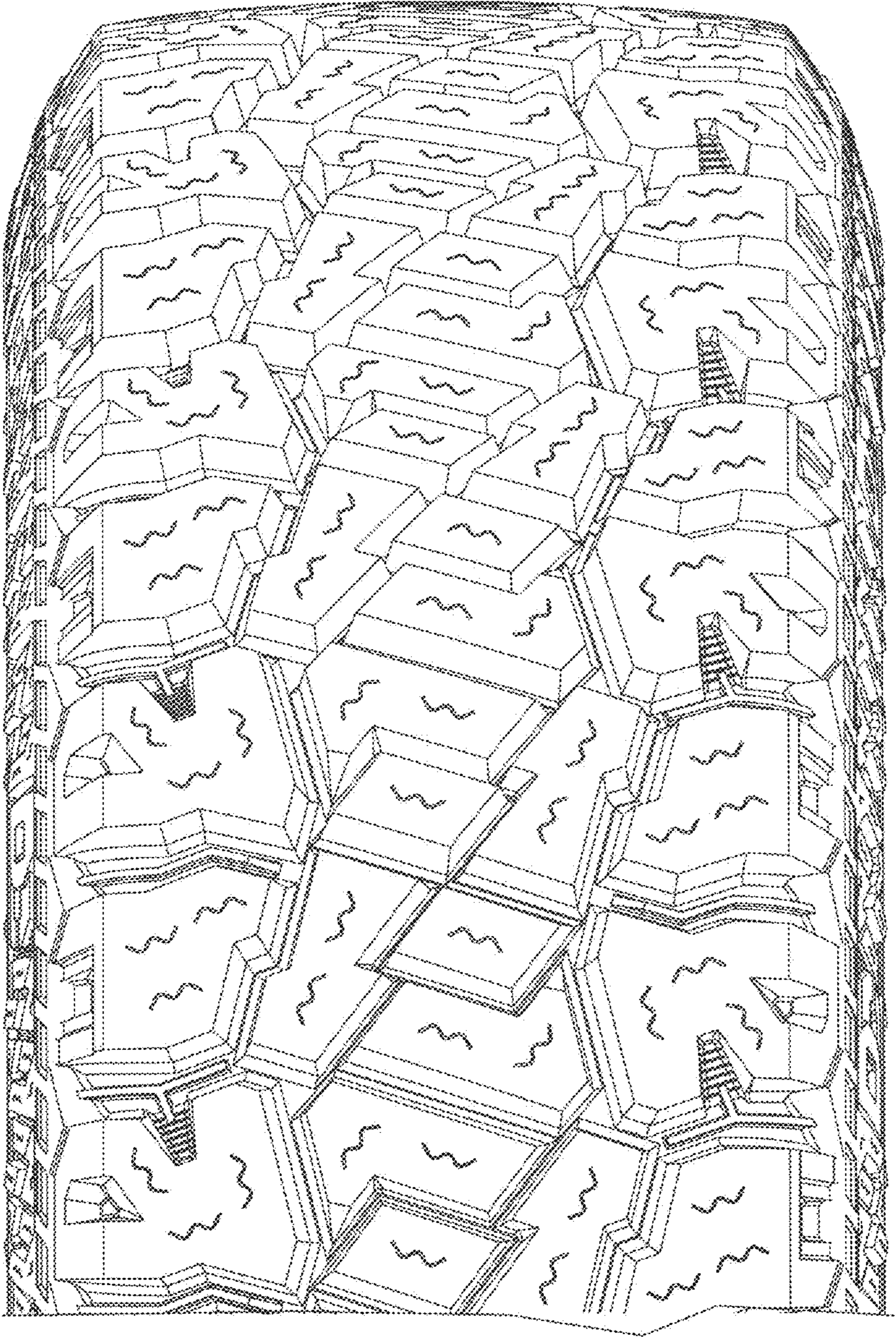
