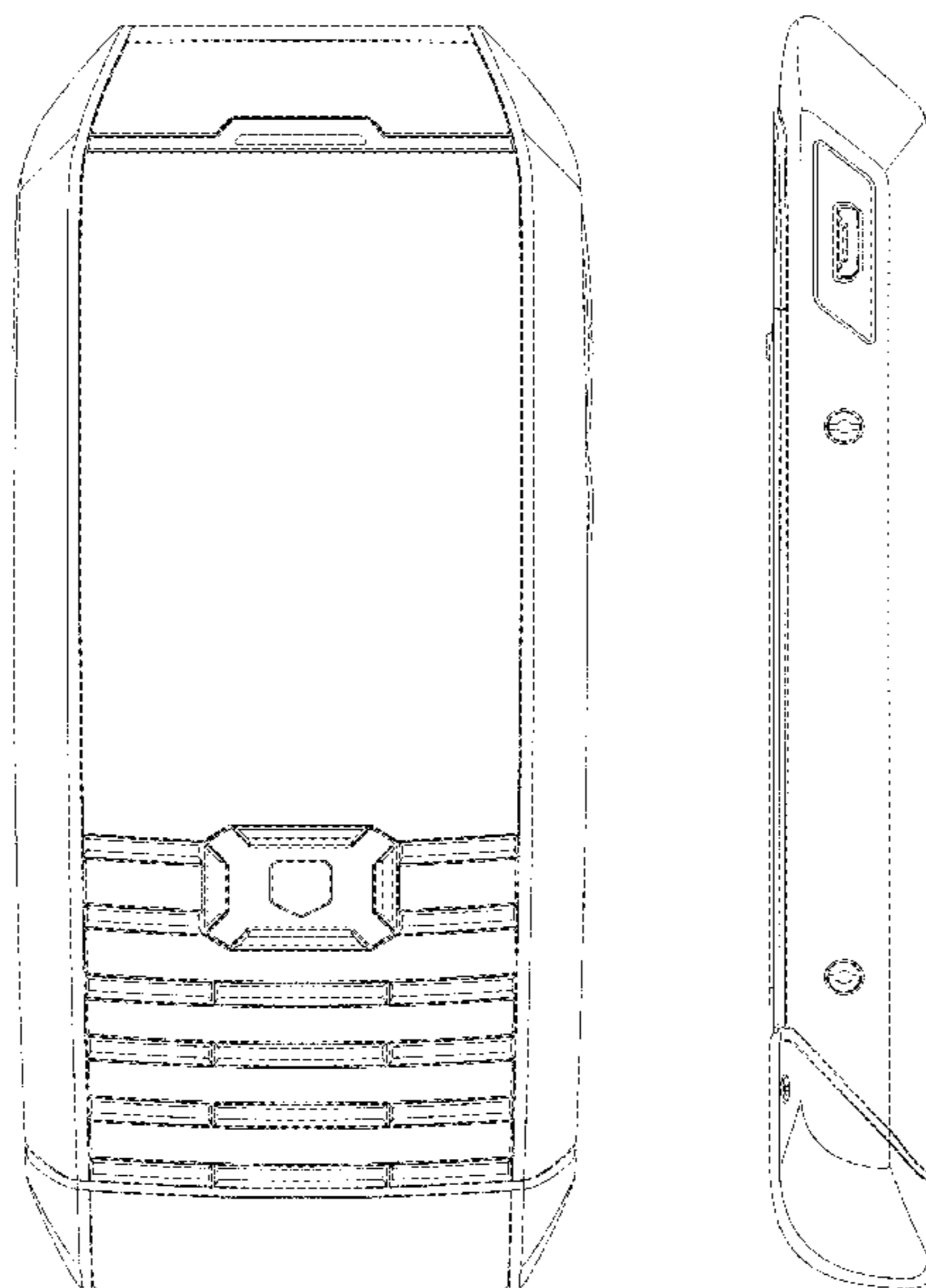
The ornamental design for a mobile phone, as shown and

employing an ornamental design in accordance with the
present invention;

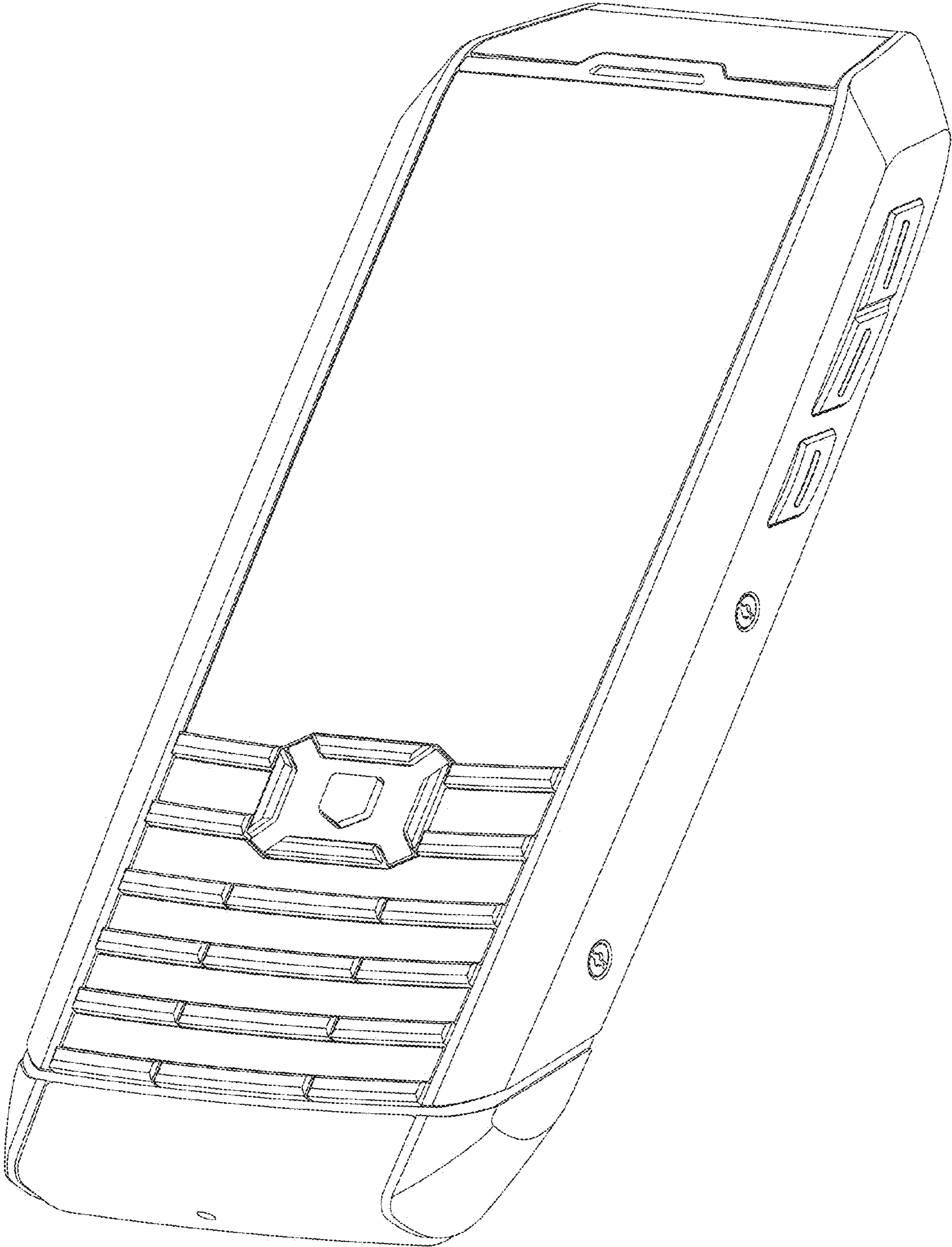

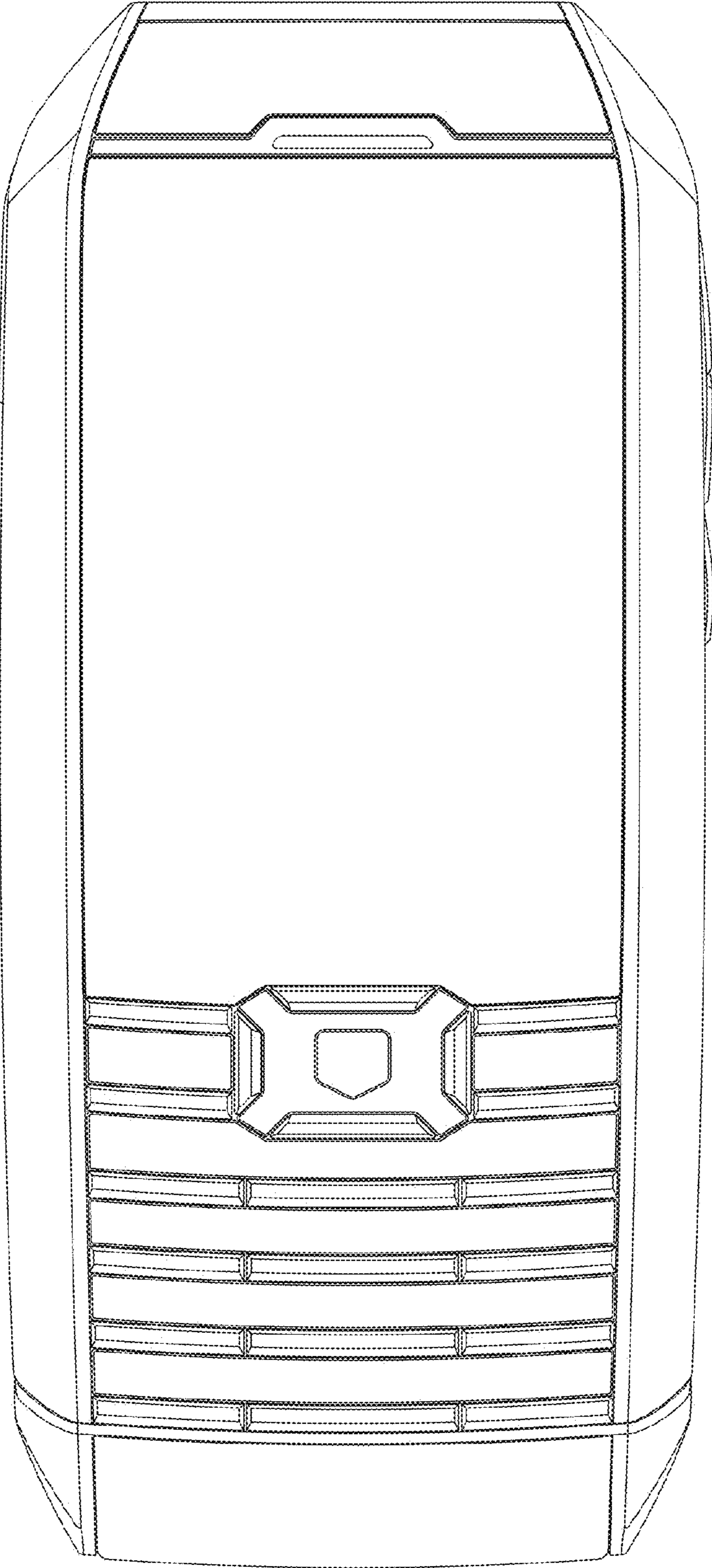

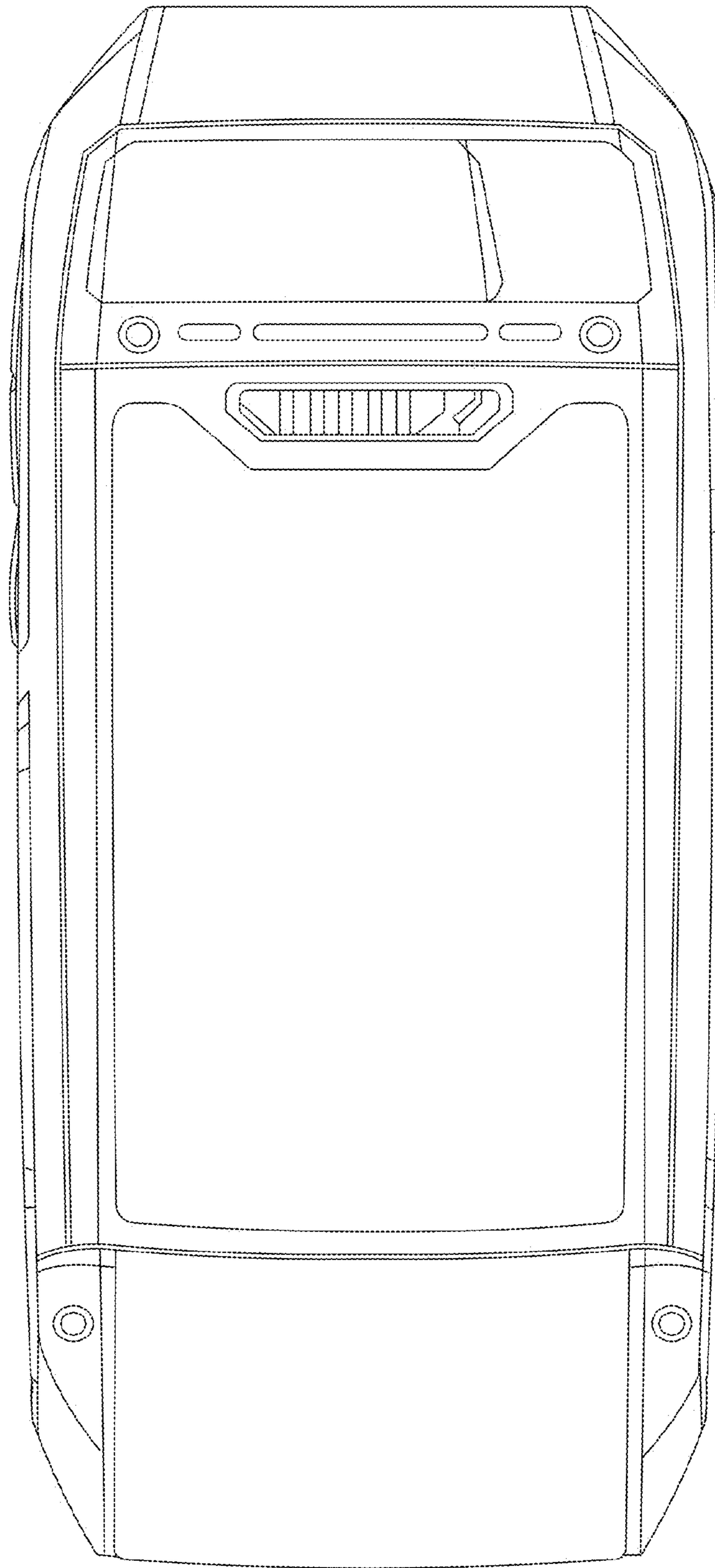

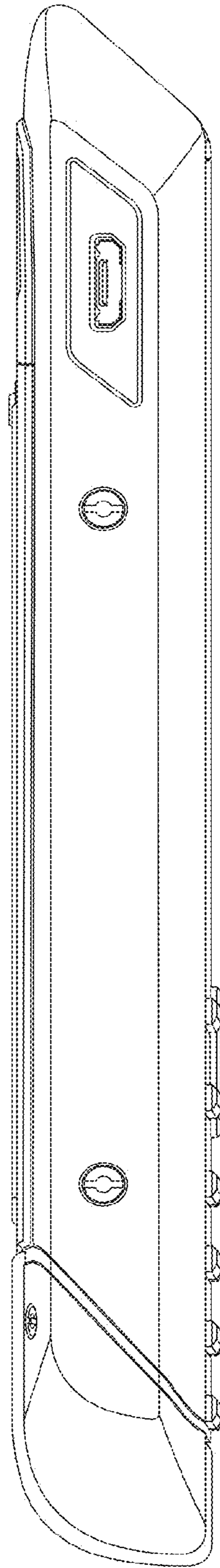

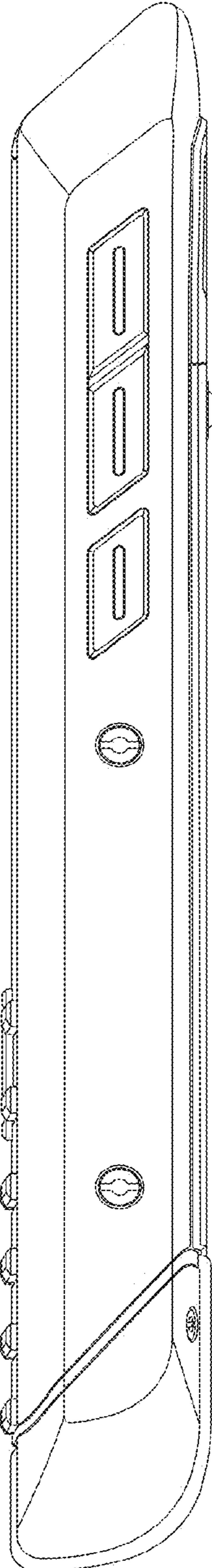

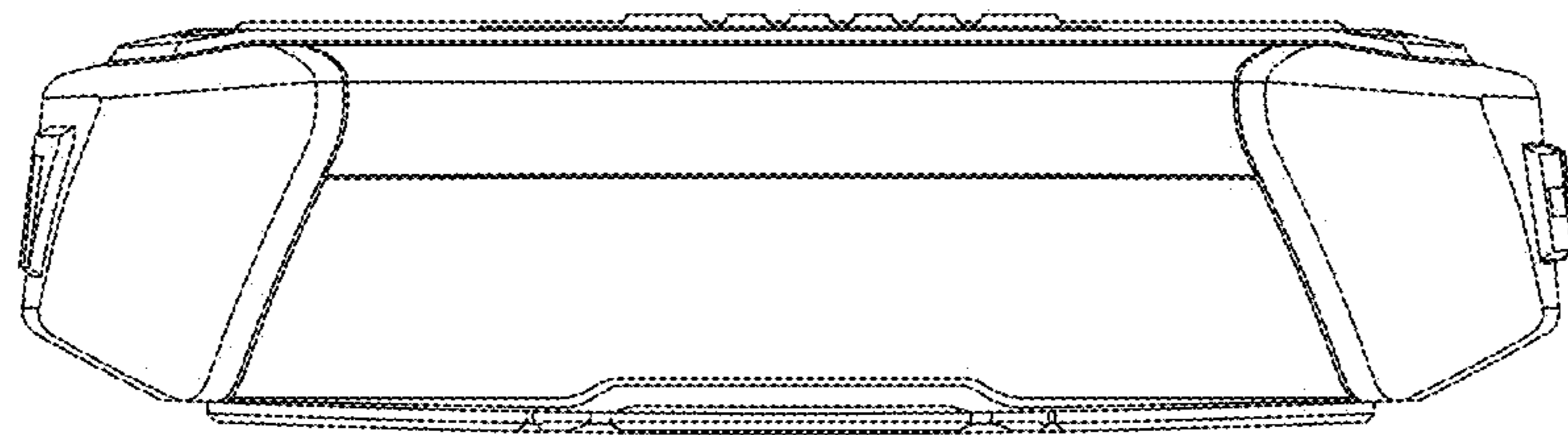

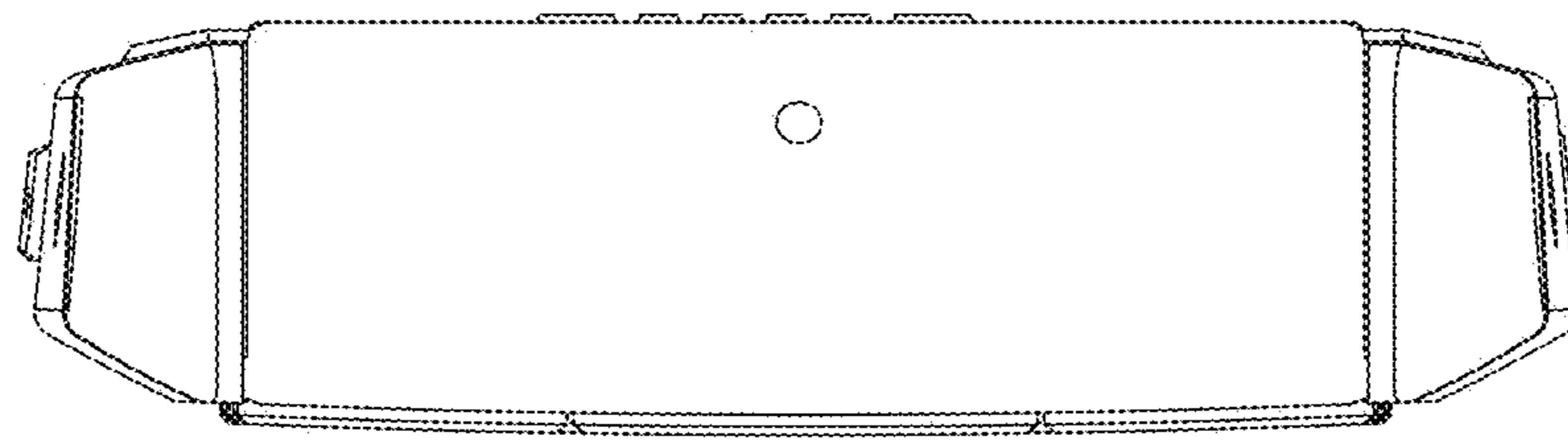
