The broken lines around the Figures show a display screen or portion thereof, and form no part of the claimed design.

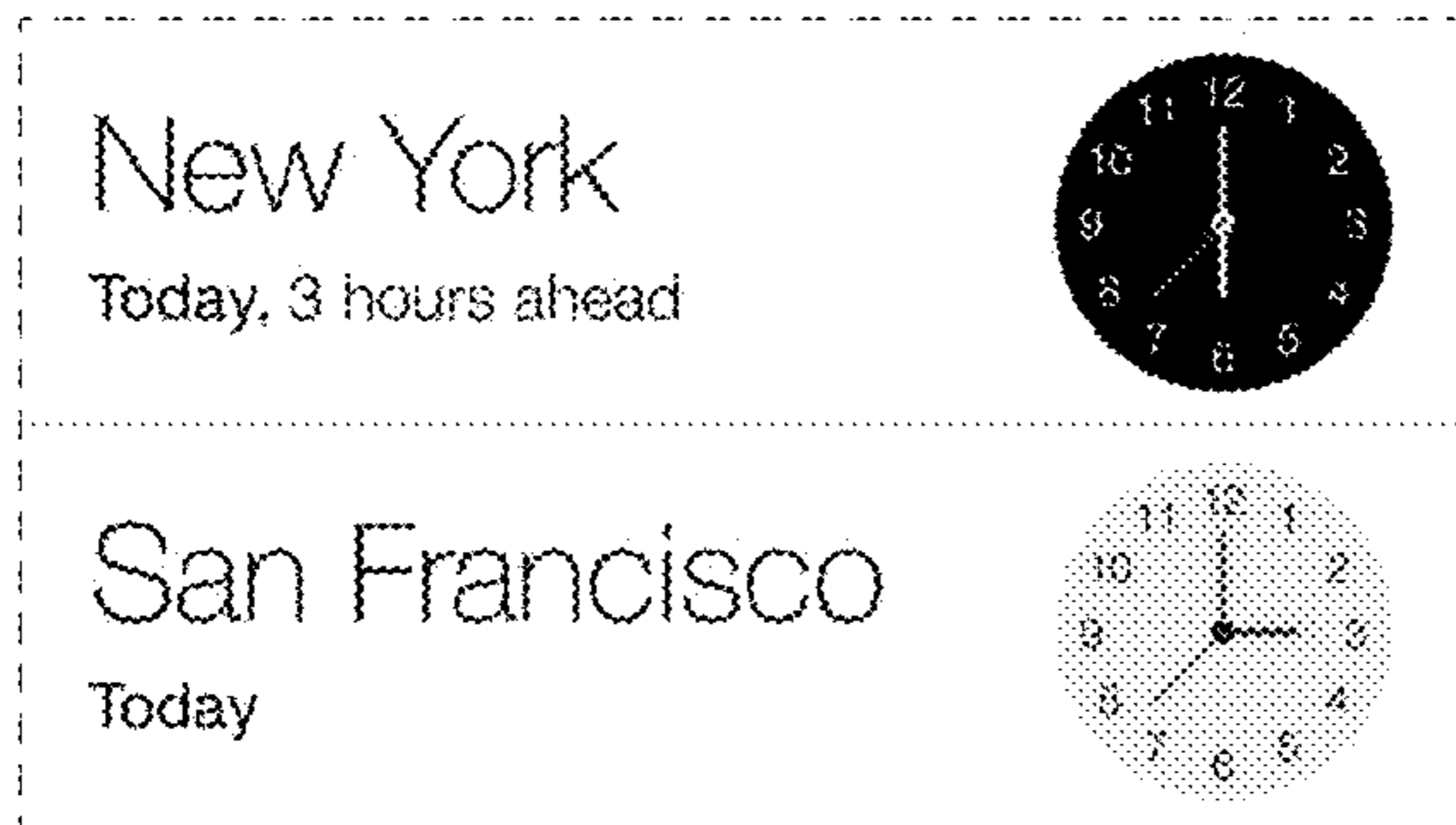

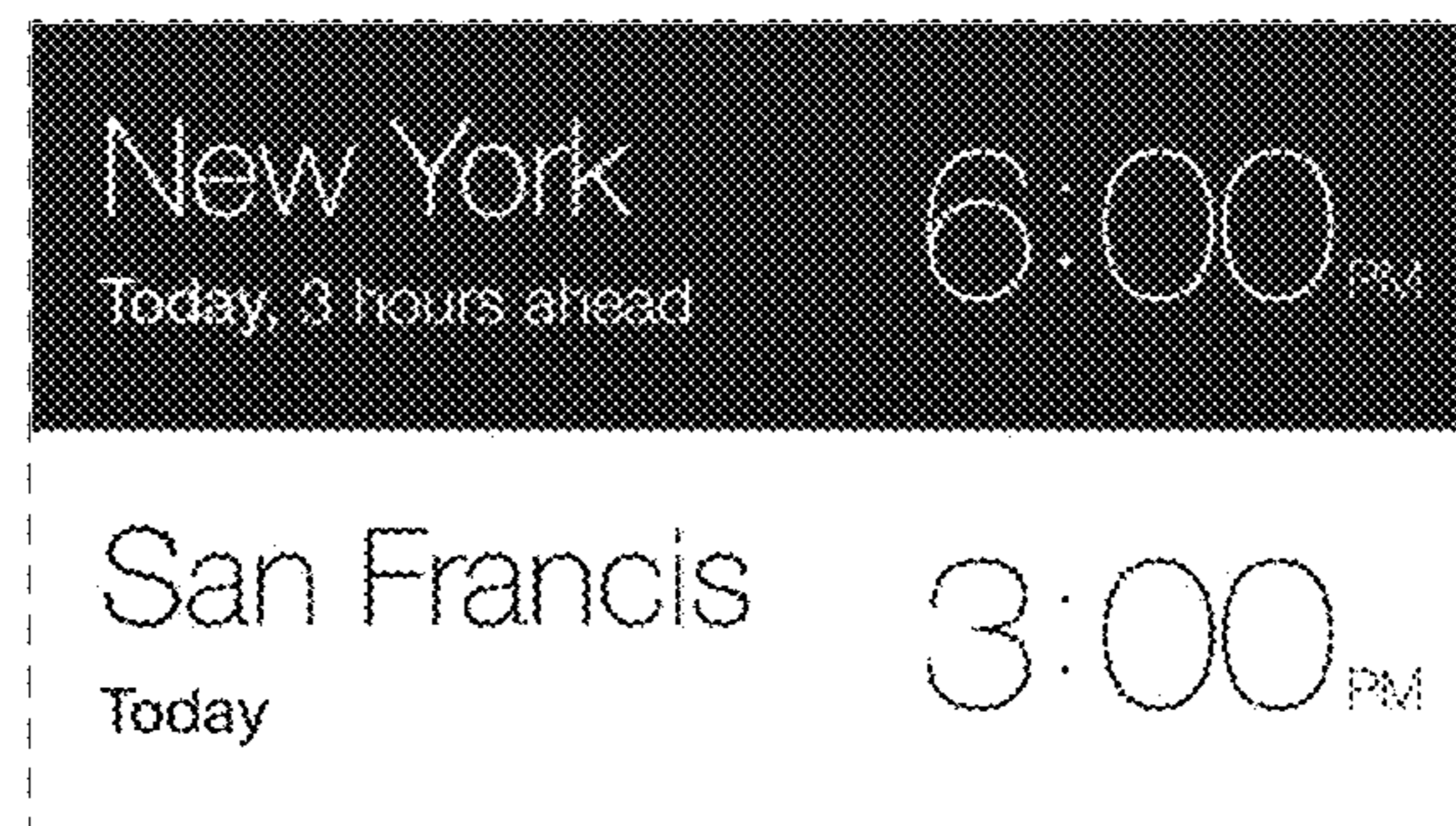

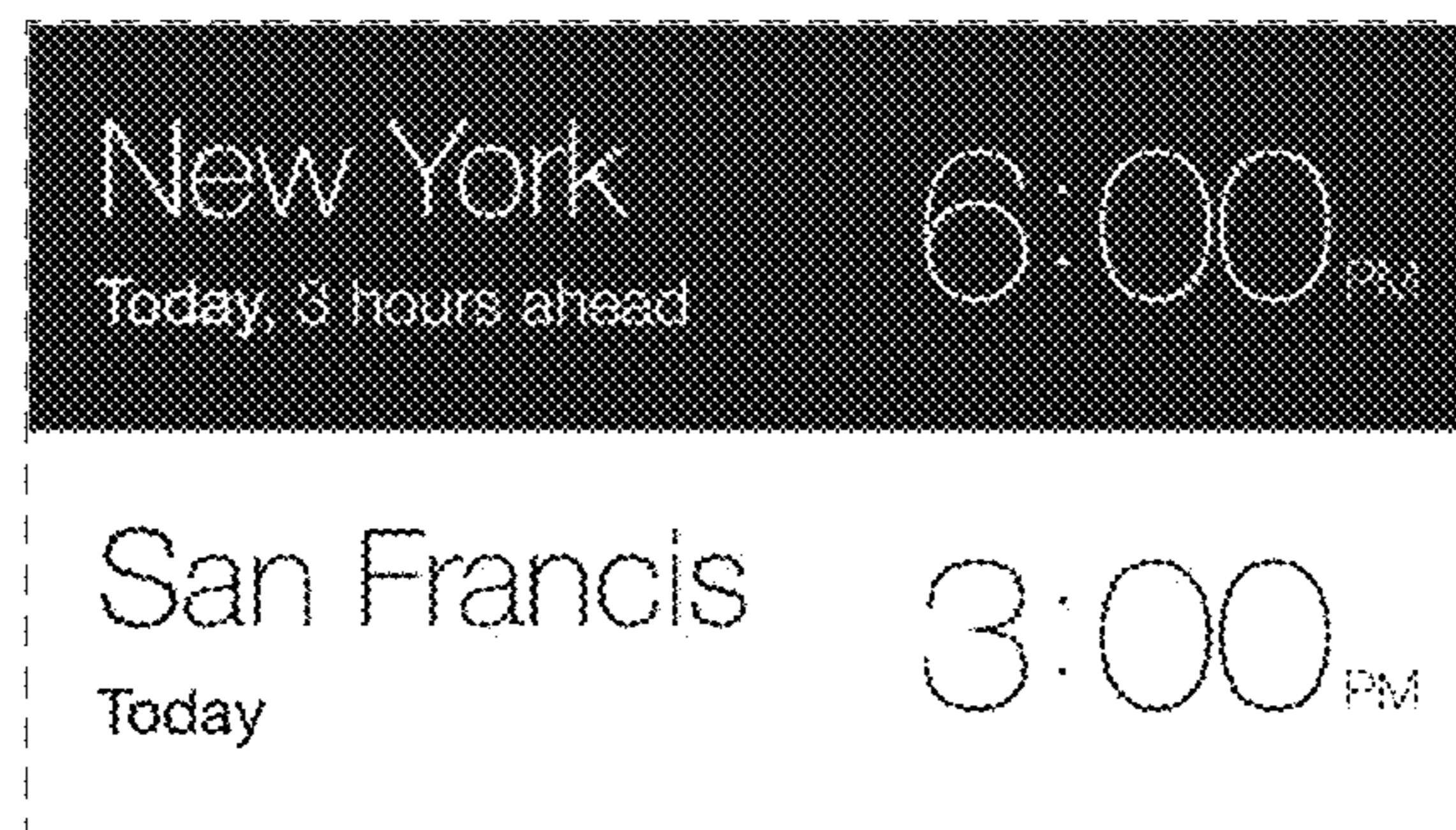
