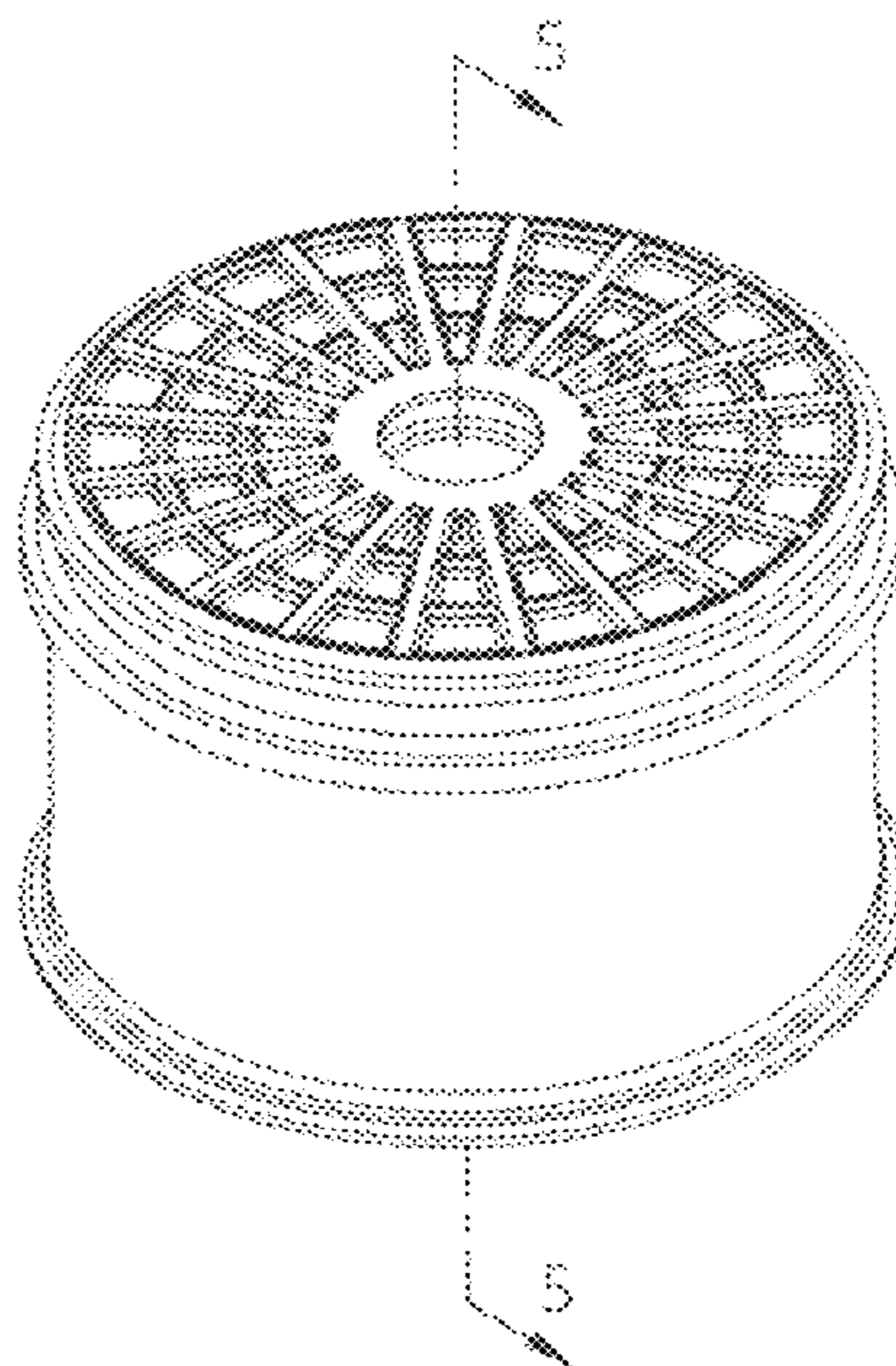
FIG. 7 is an elevational view thereof from the front, the elevational views from the right, left, and rear thereof being identical;

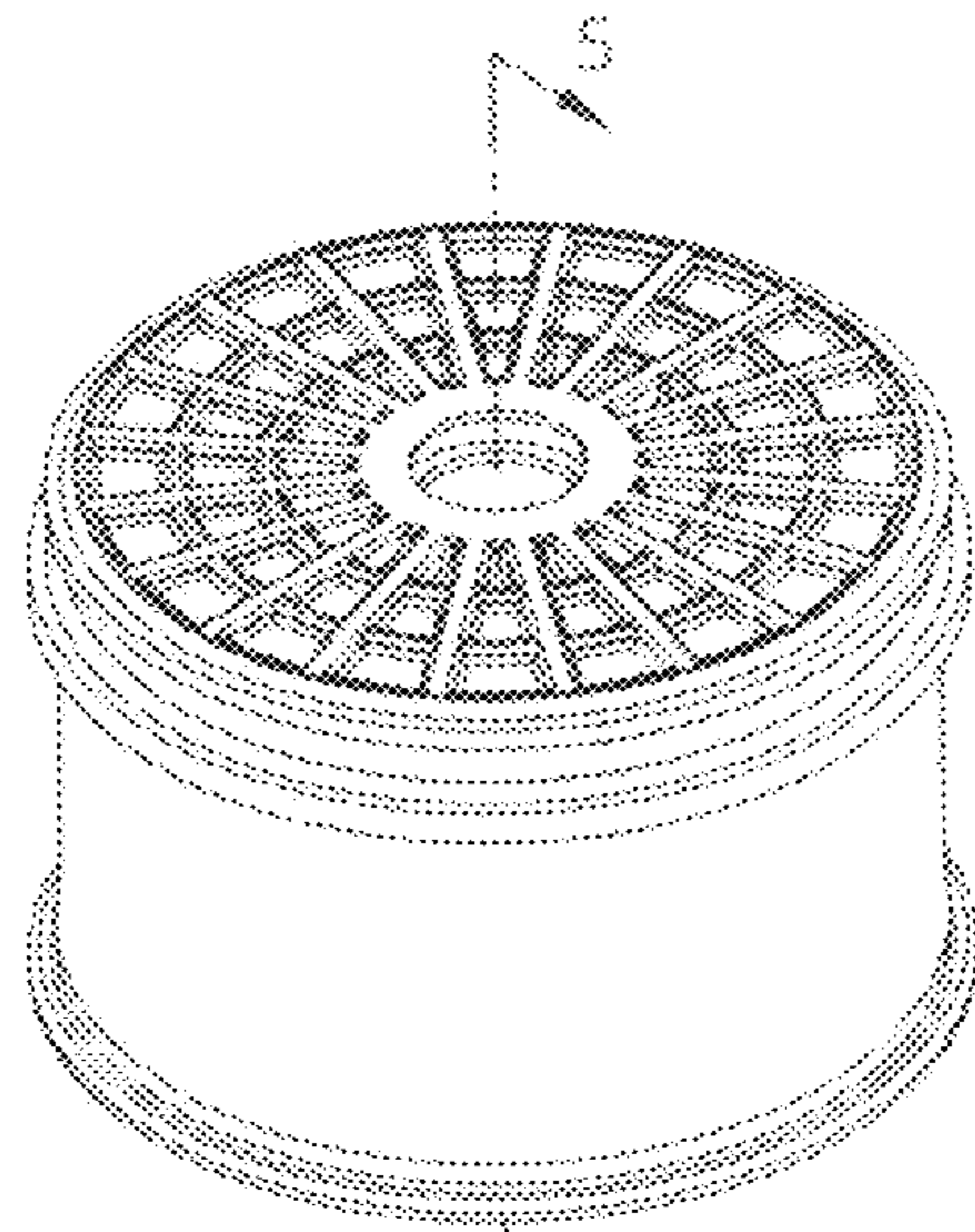

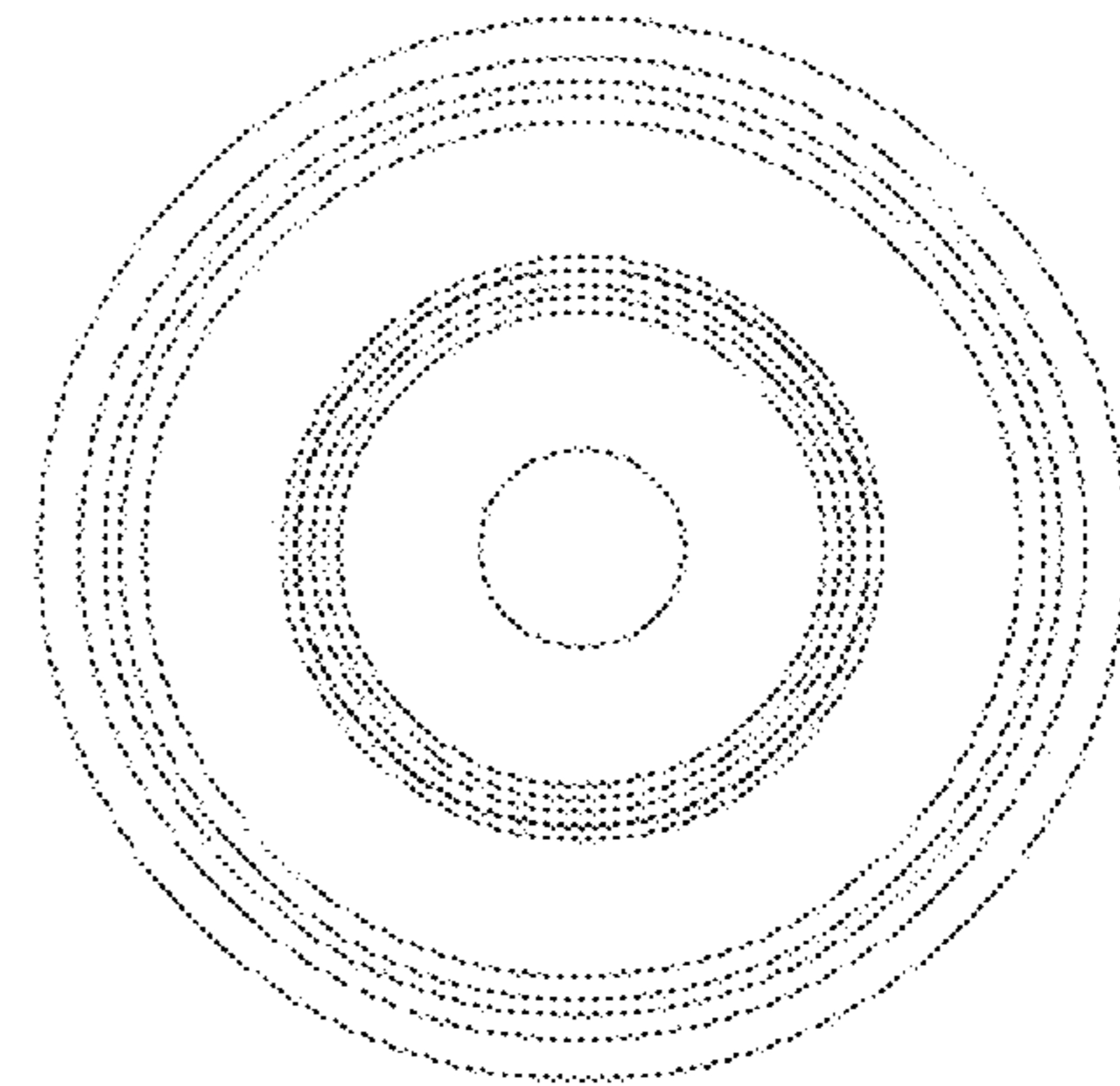

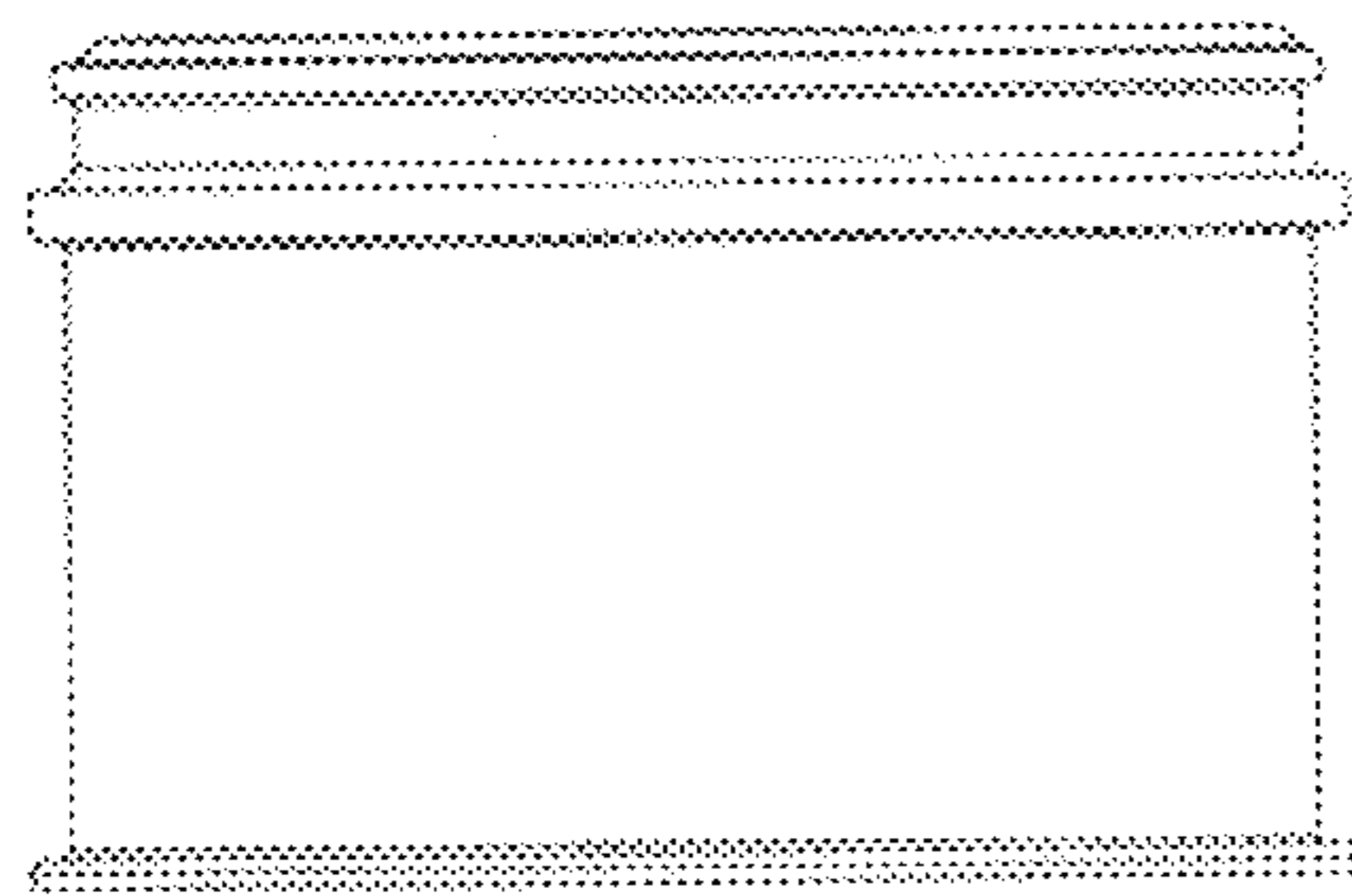

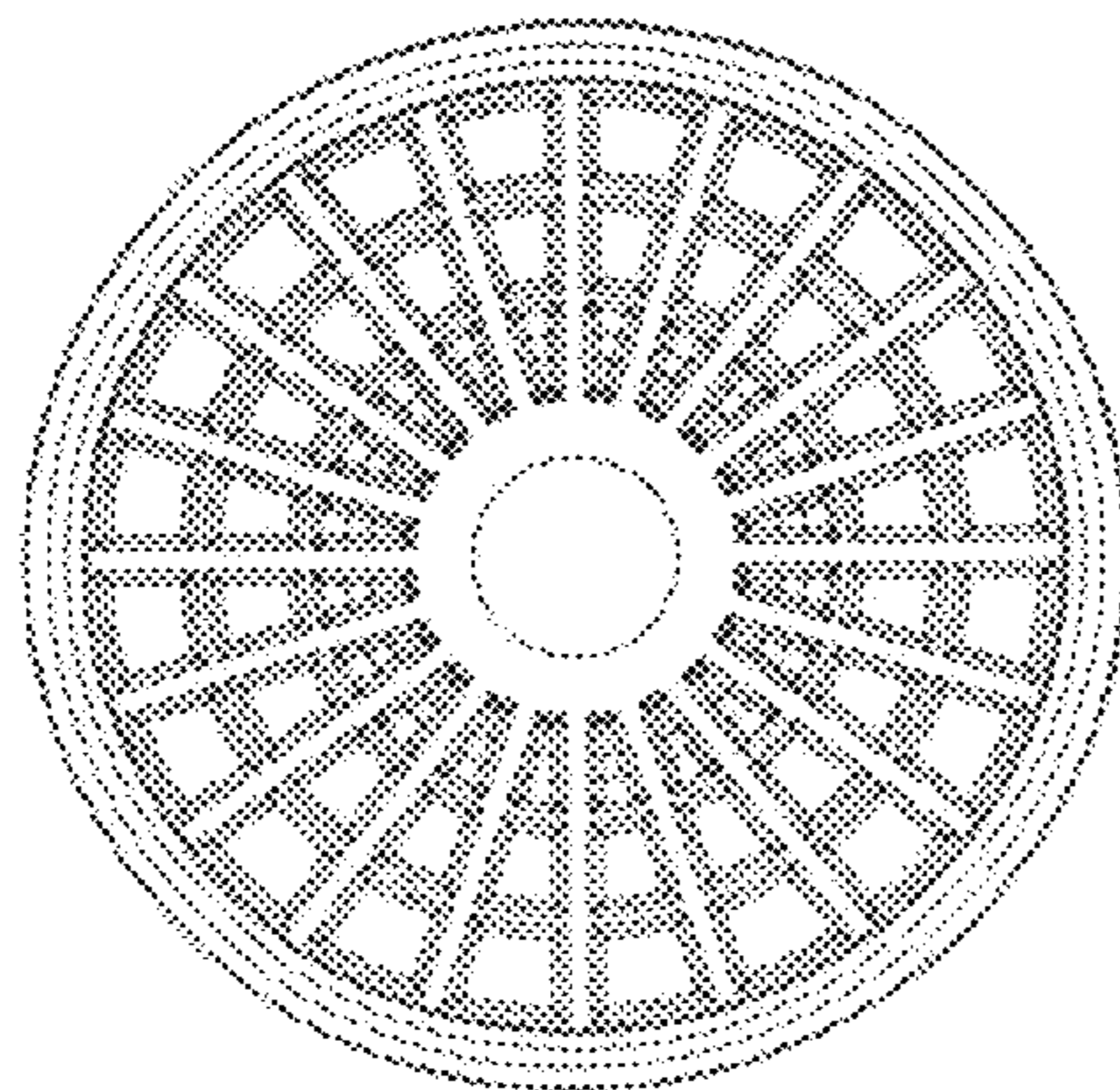

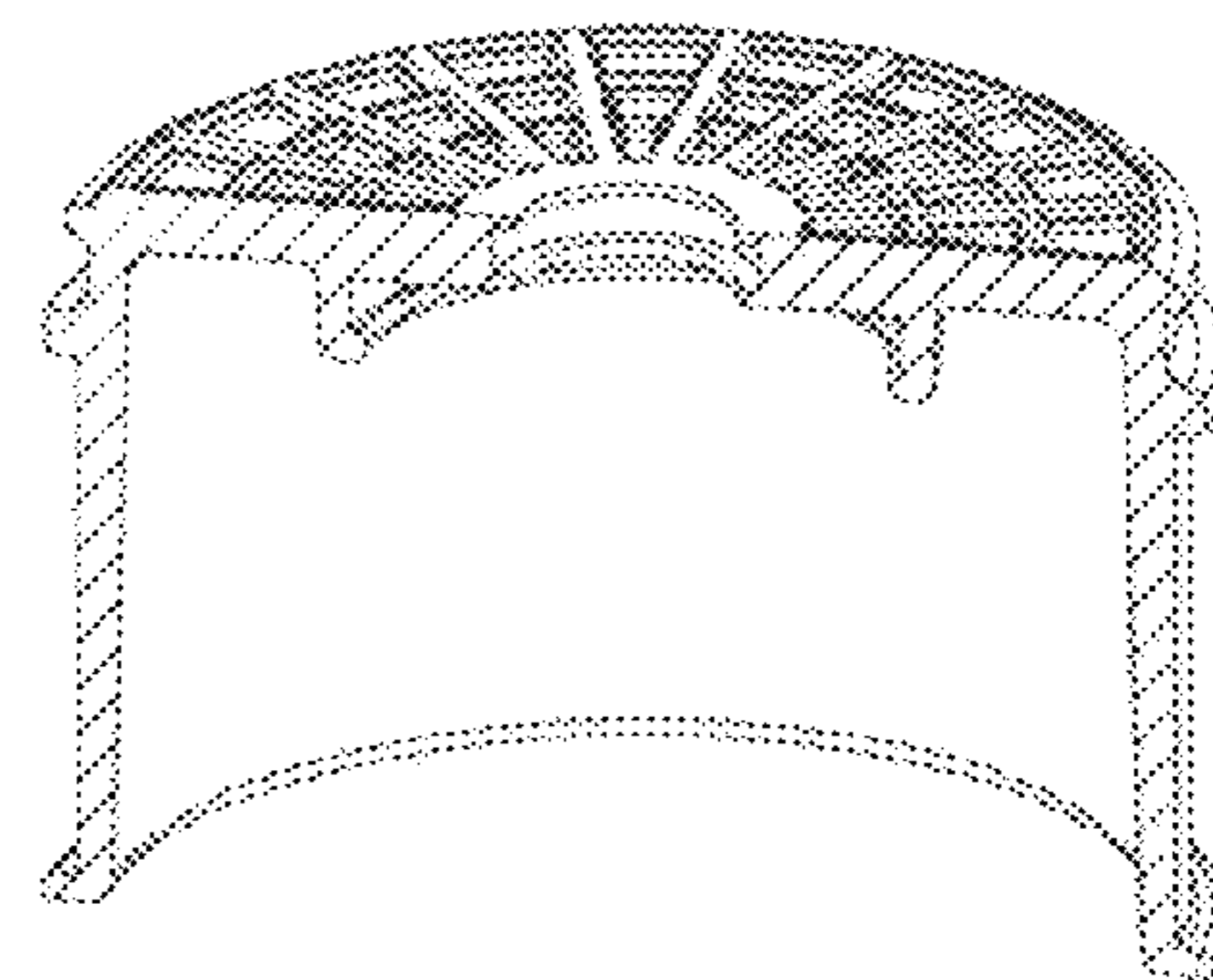

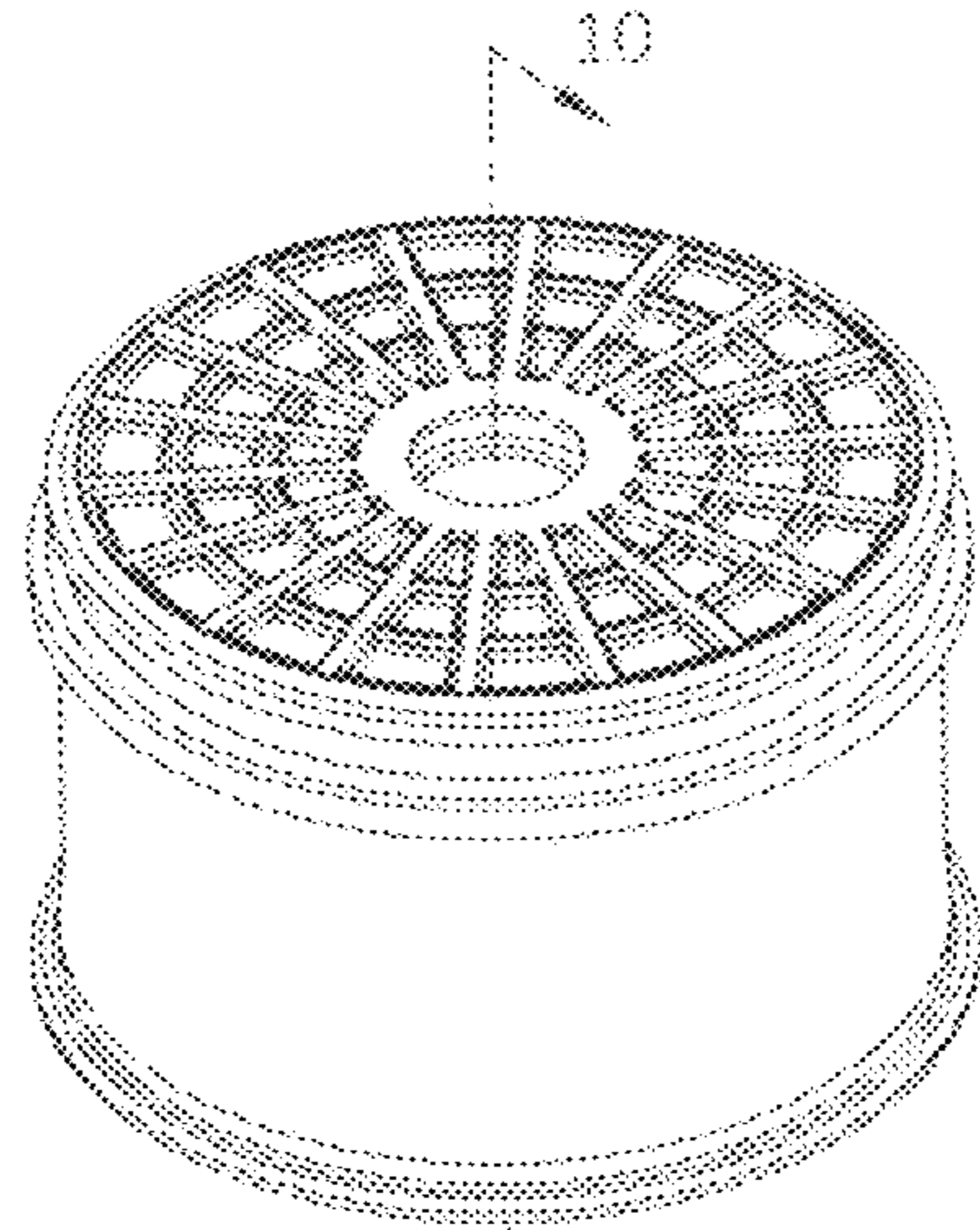

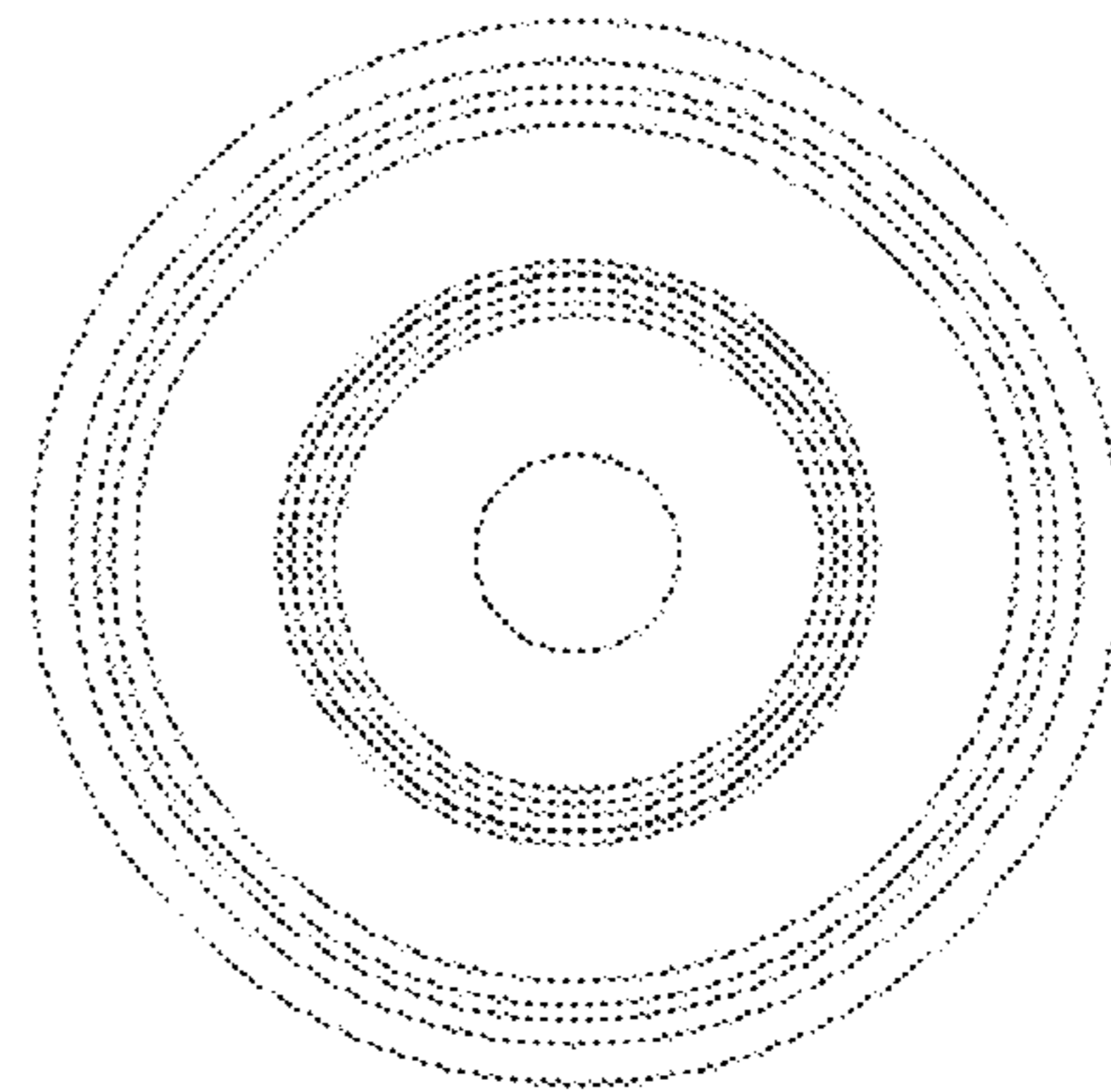

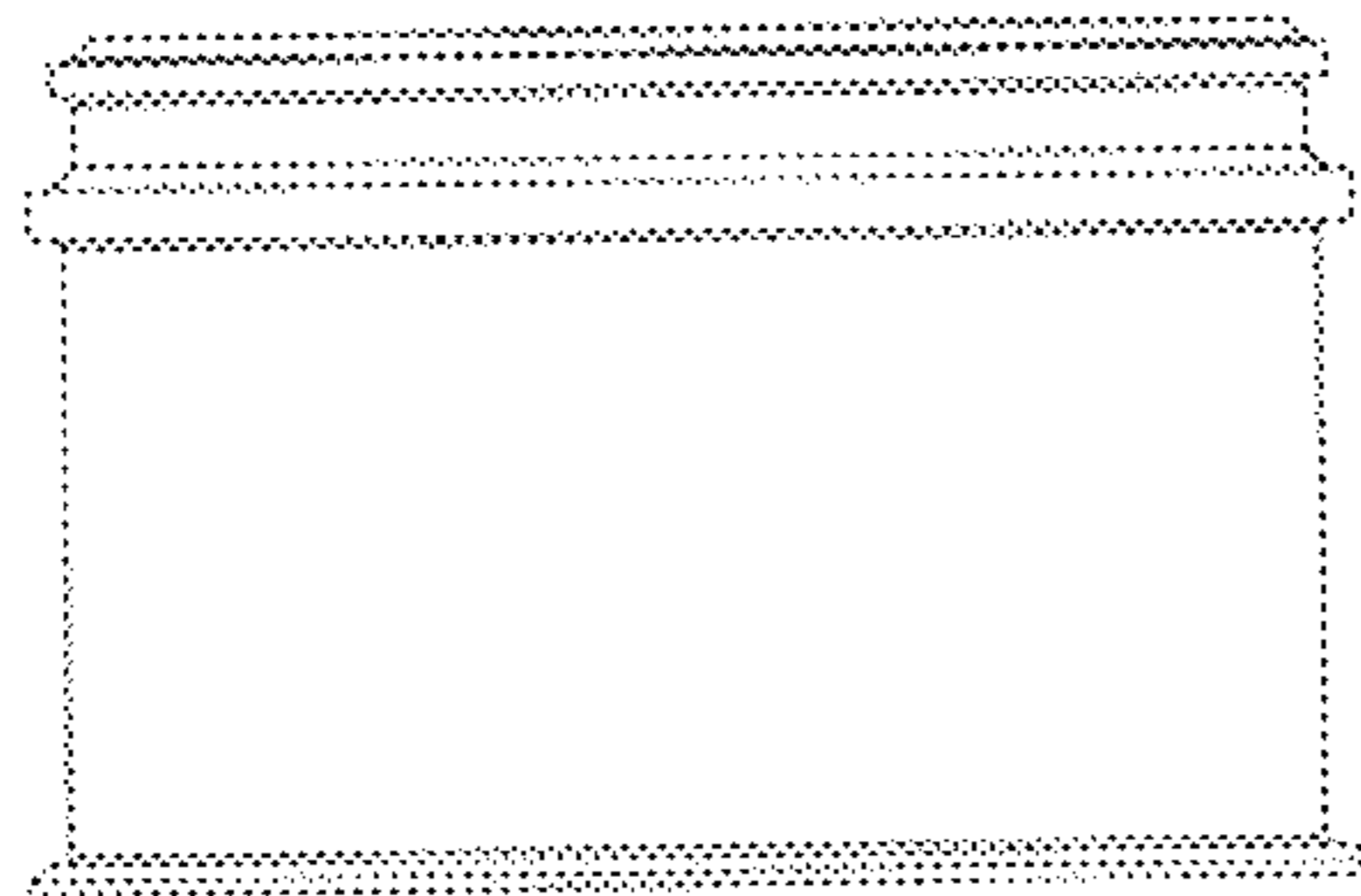

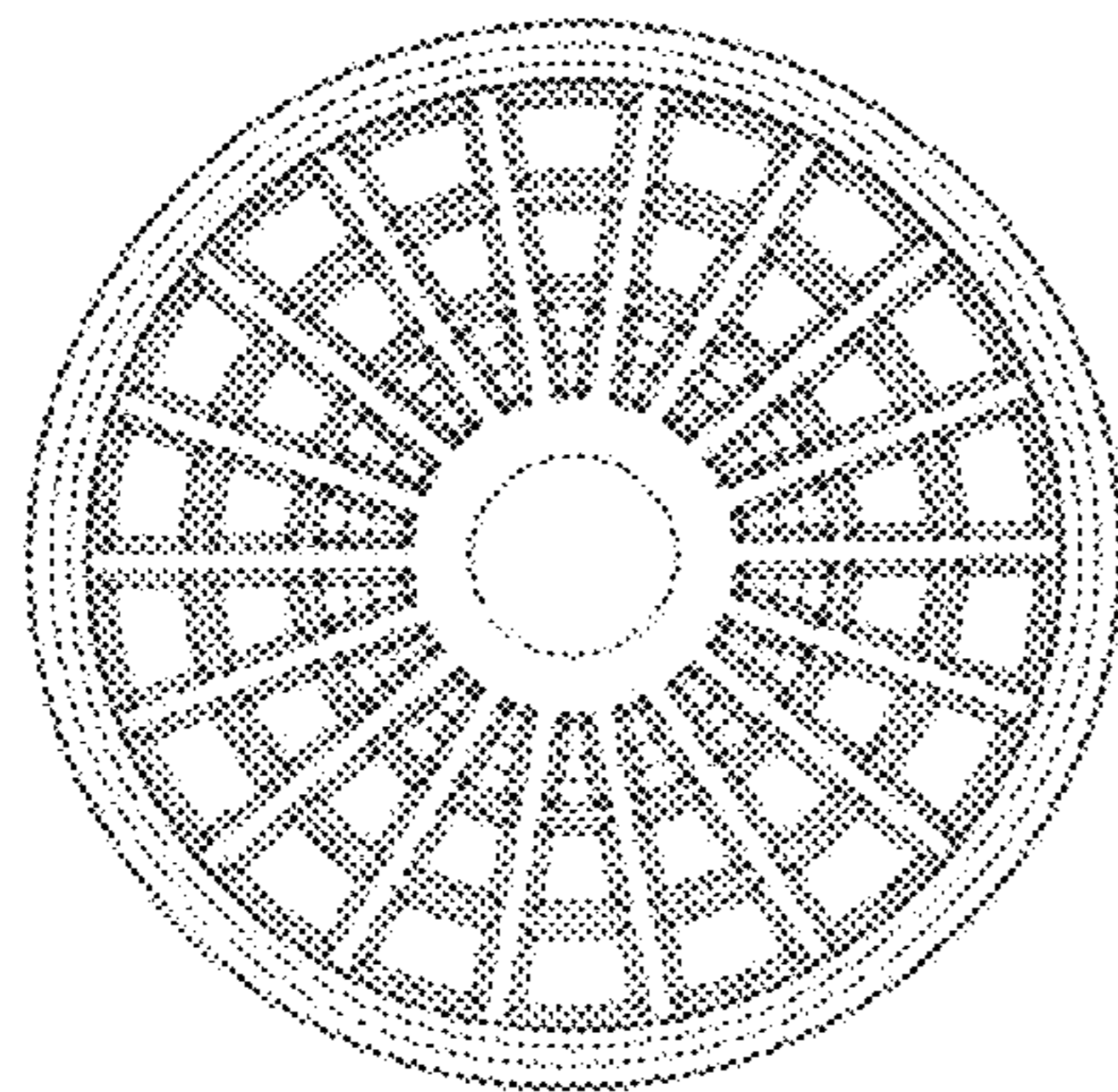

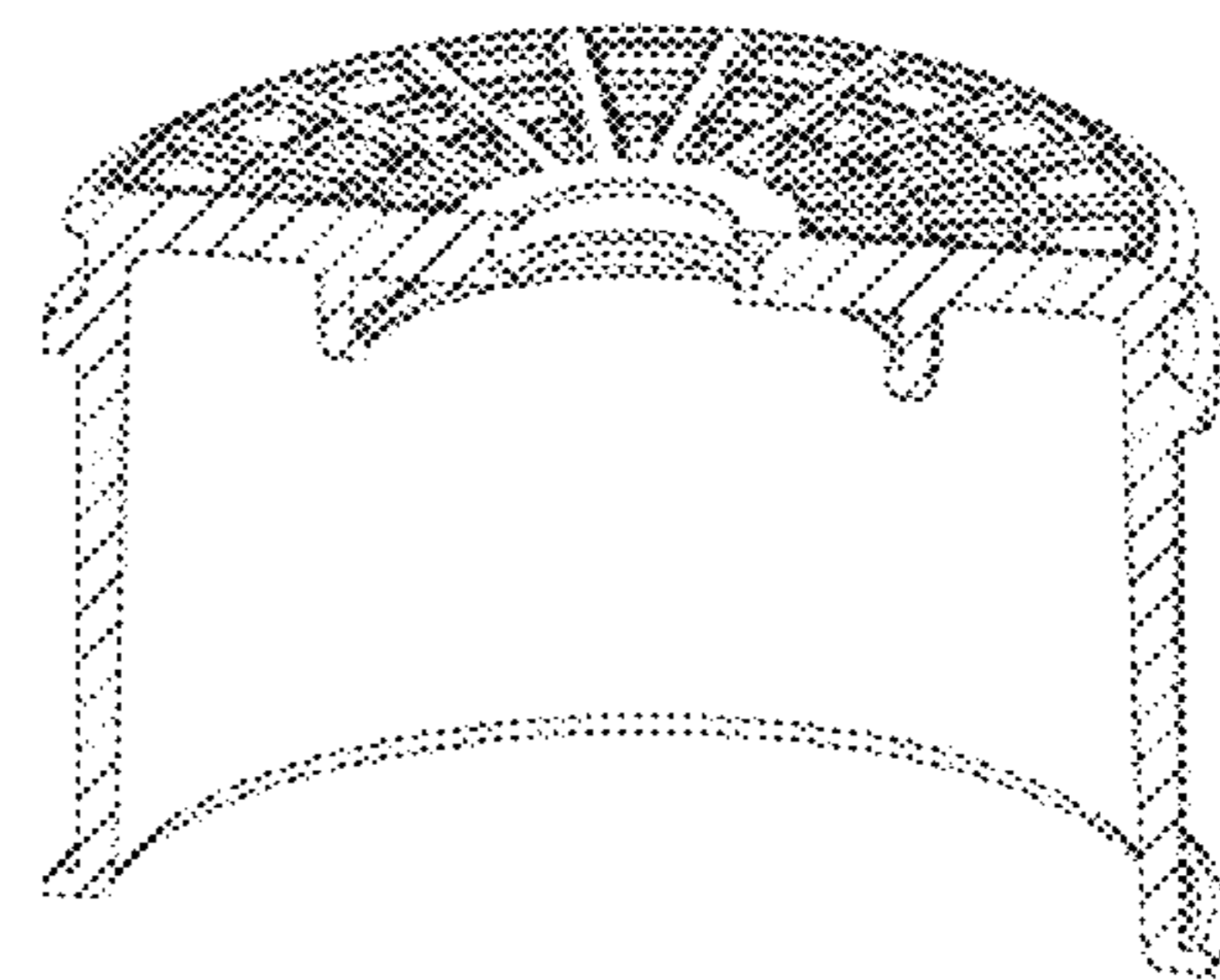
