DESCRIPTION

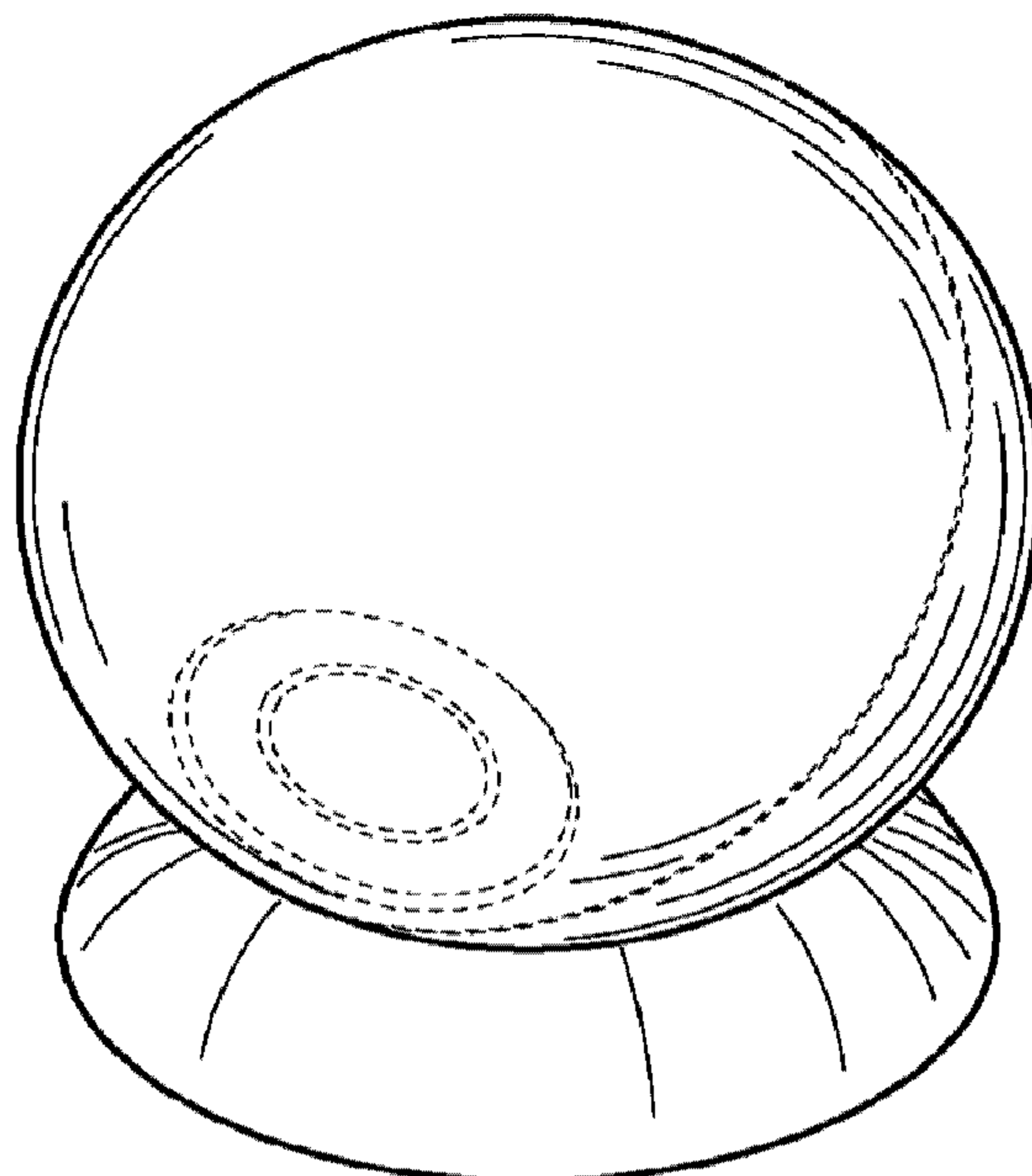
FIG. 1 is a perspective view of a remote camera showing our new design;

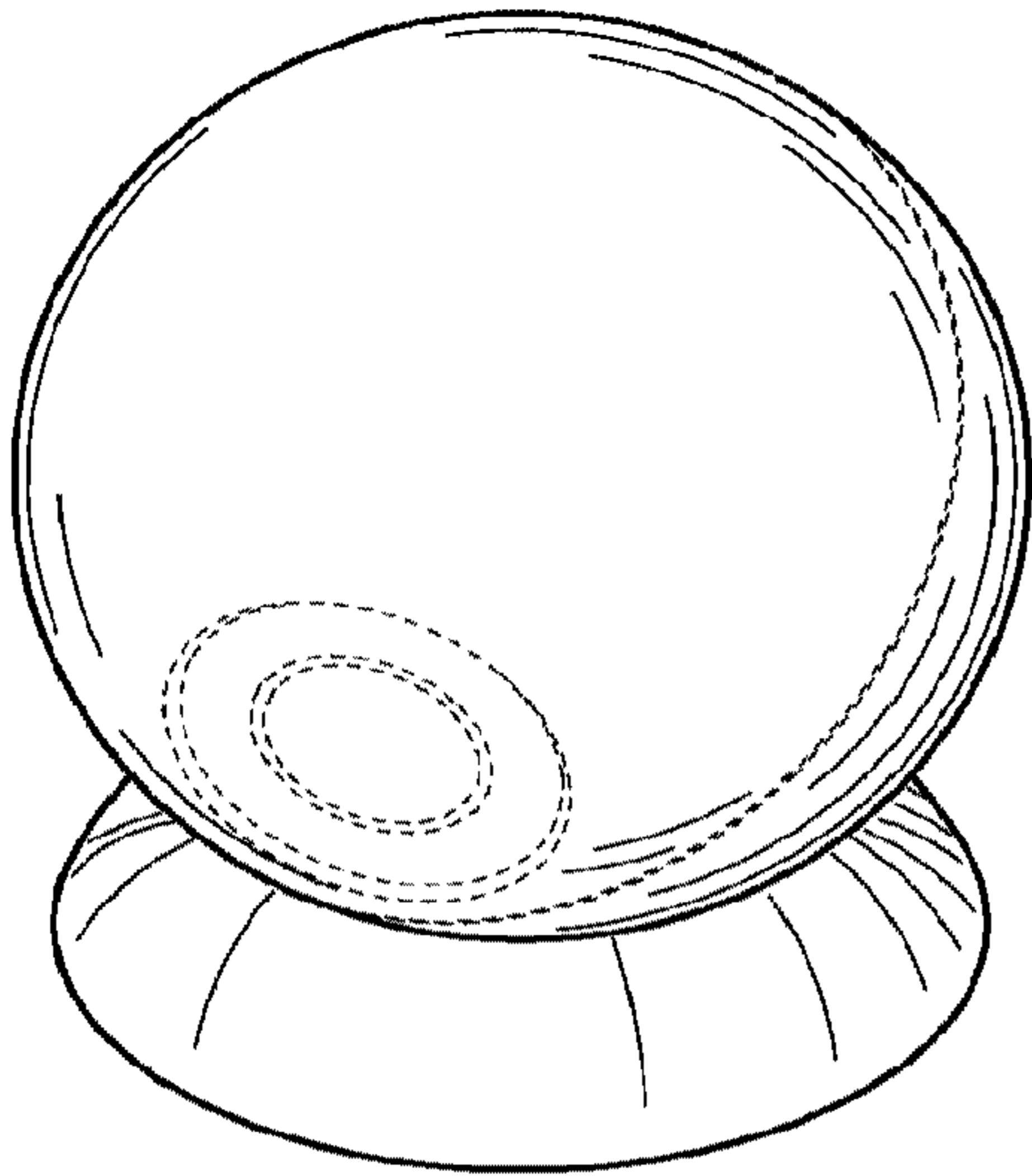

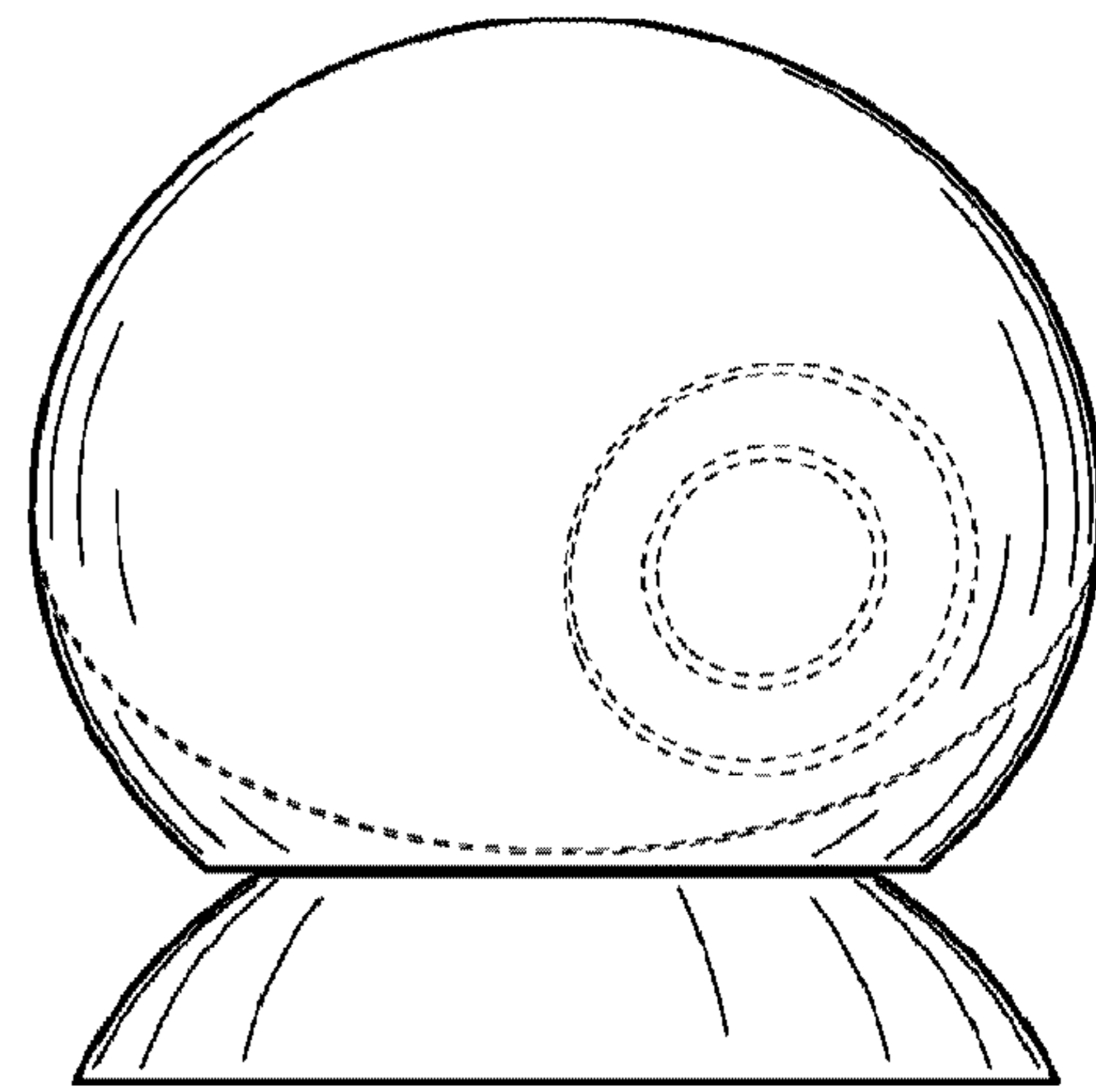

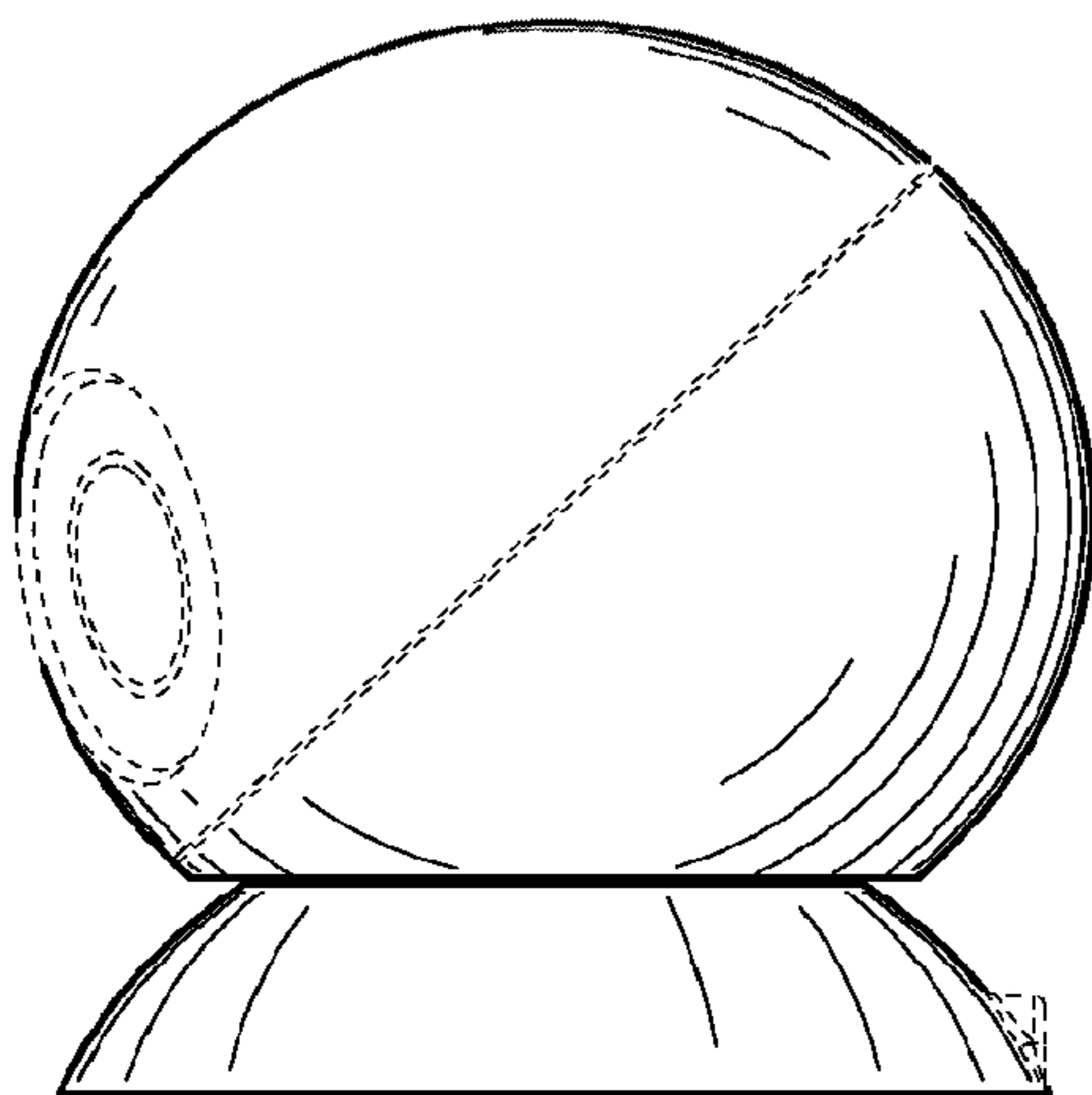

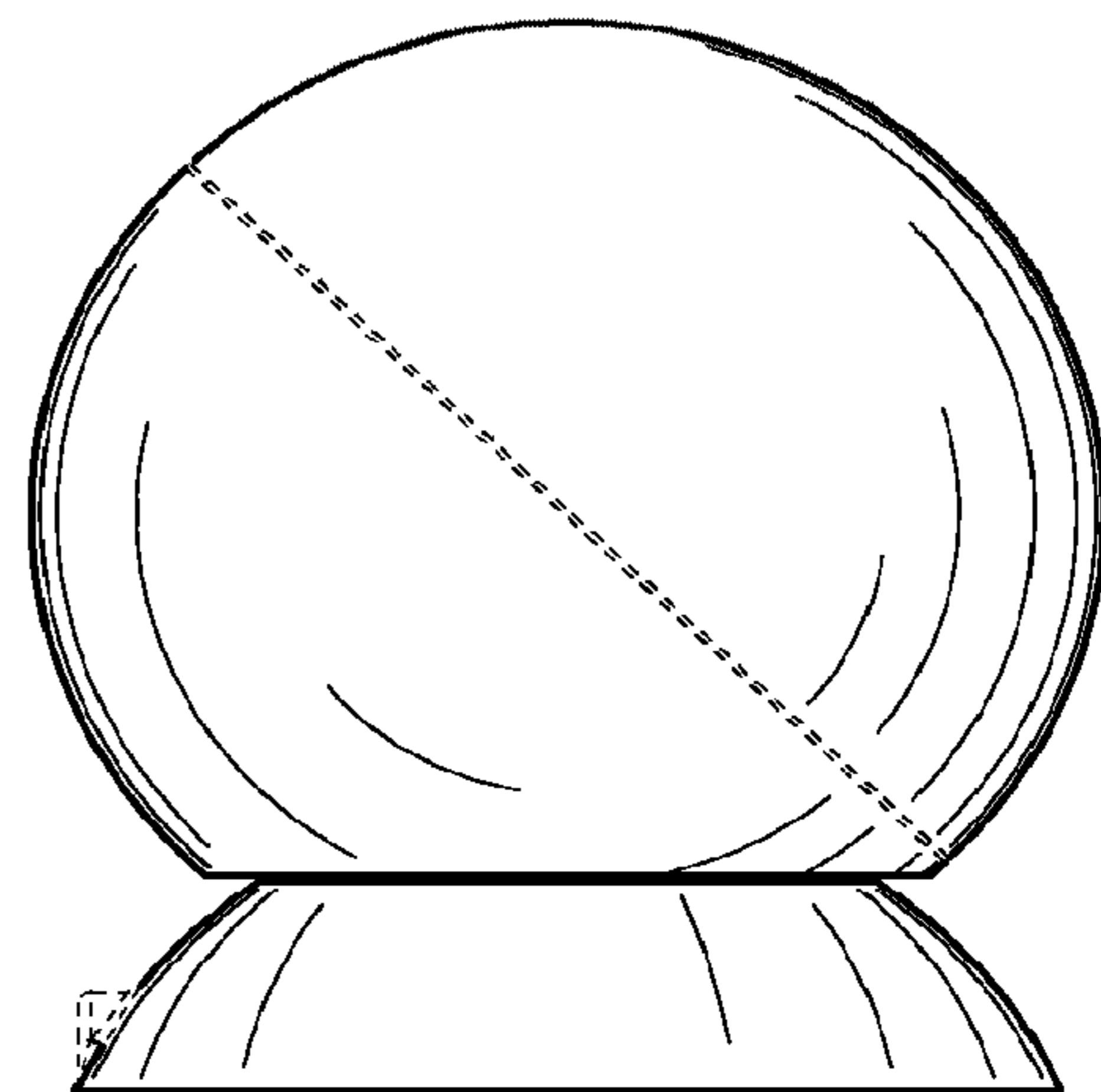

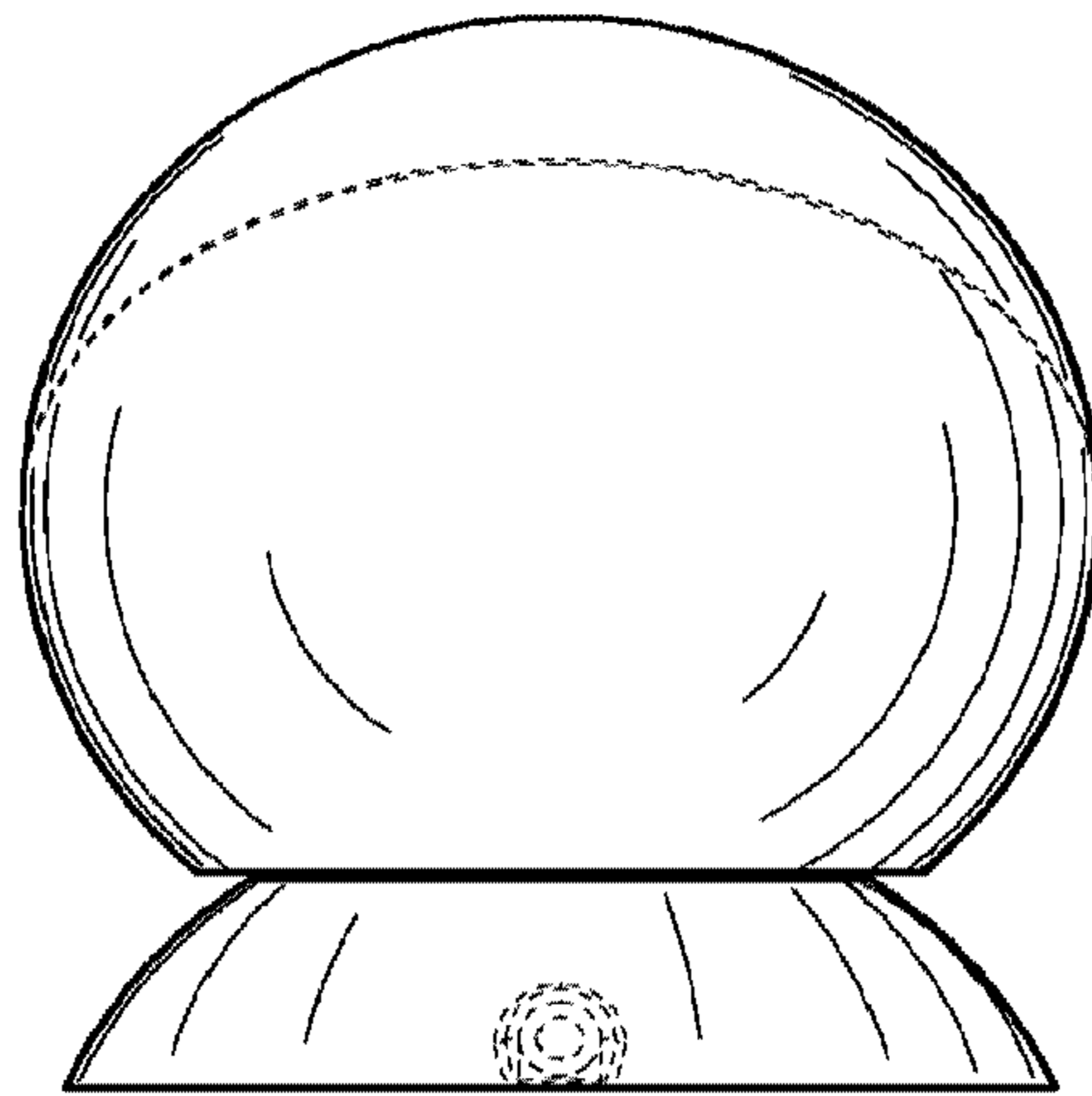

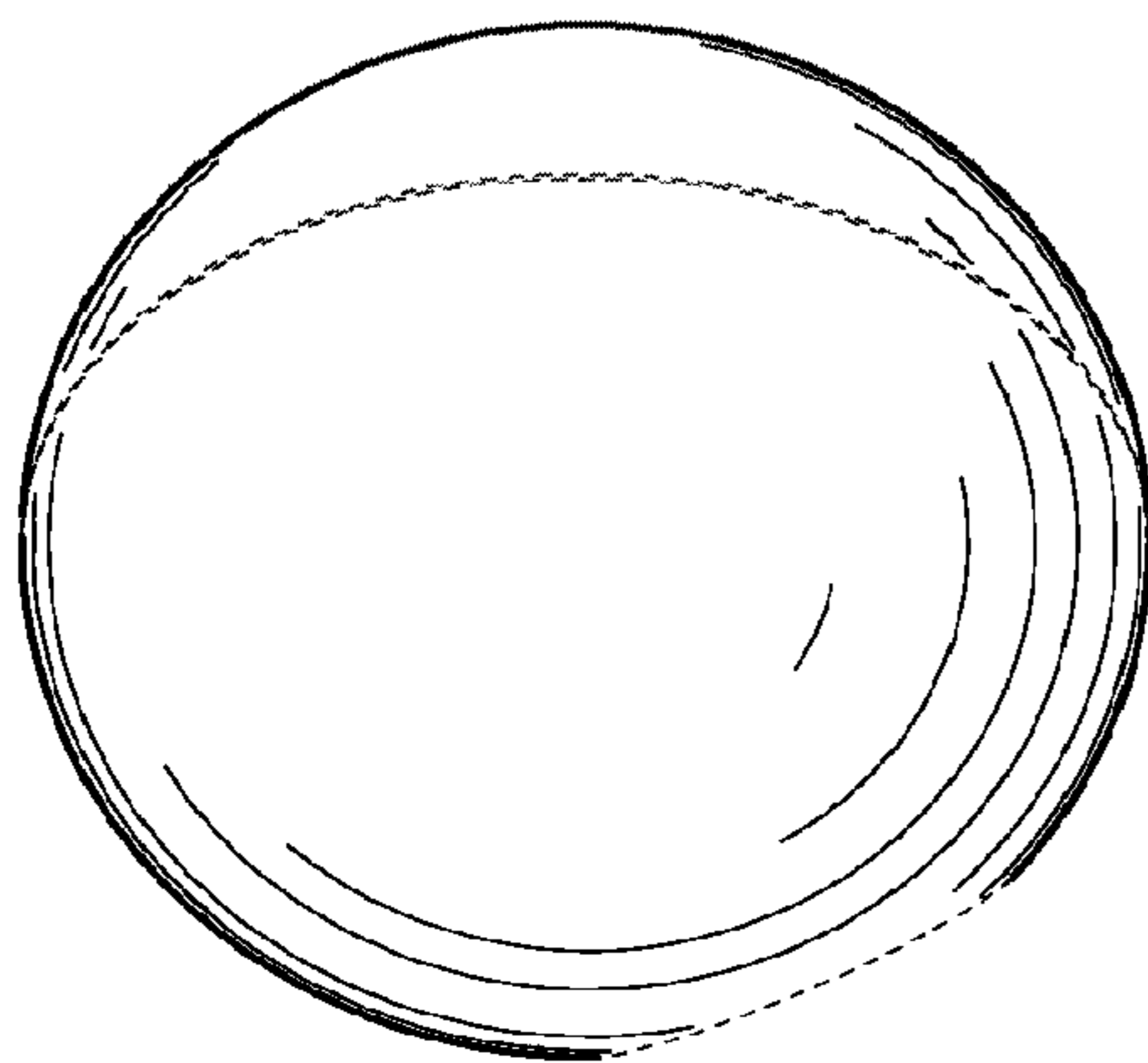

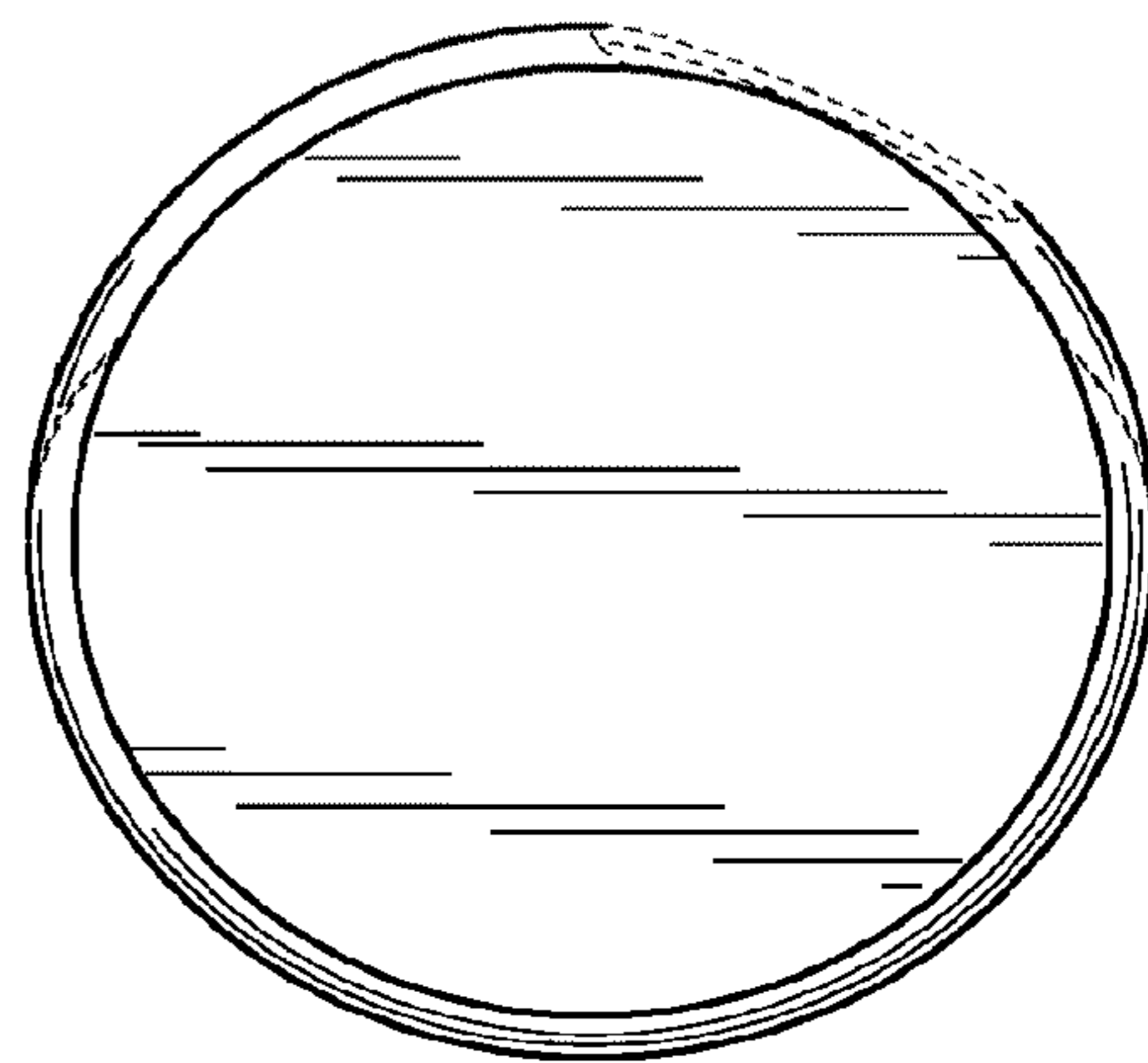
