FIG. 6 is a bottom view of the apparatus that holds multiple portable electronic devices.

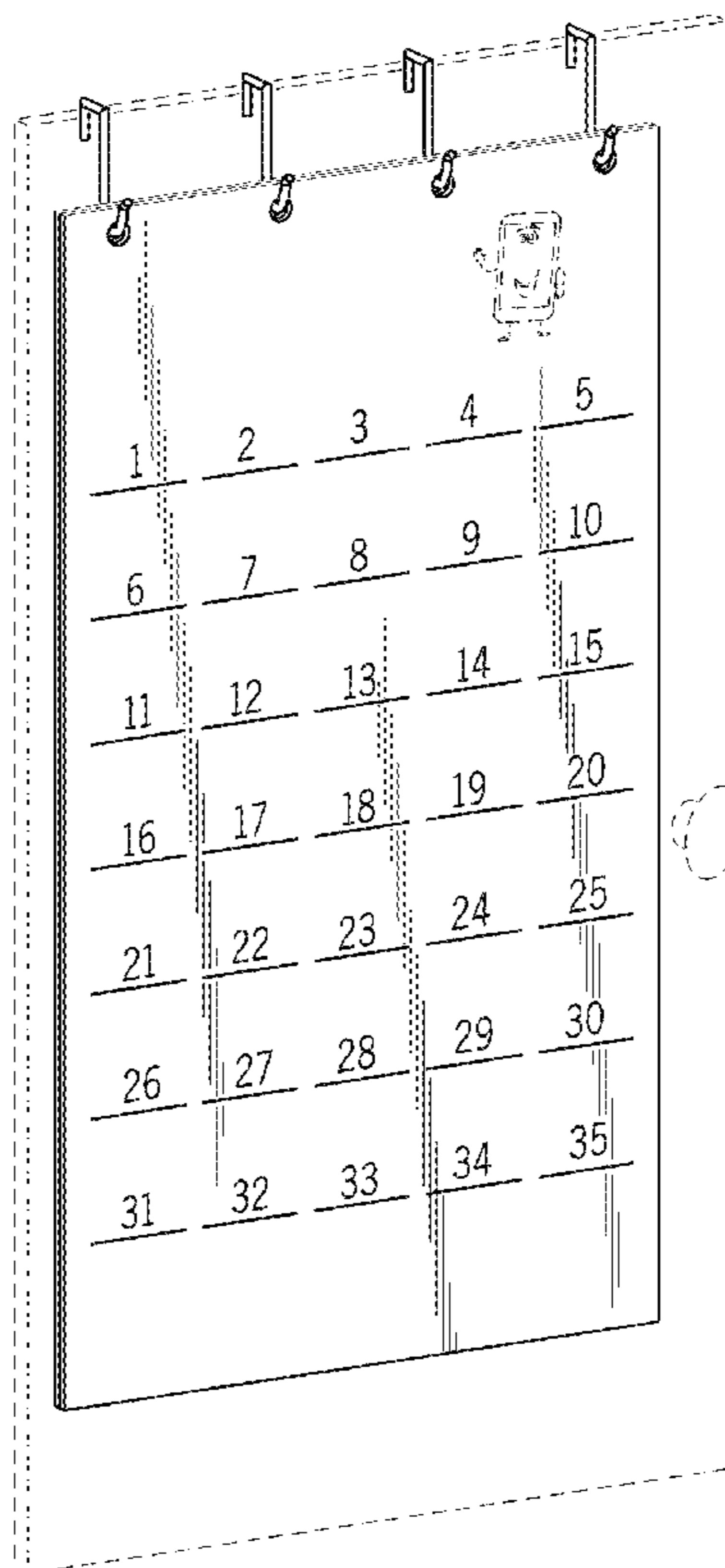
The broken lines depict the environment of and indicia on the apparatus that holds multiple portable electronic devices that form no part of the claimed design.

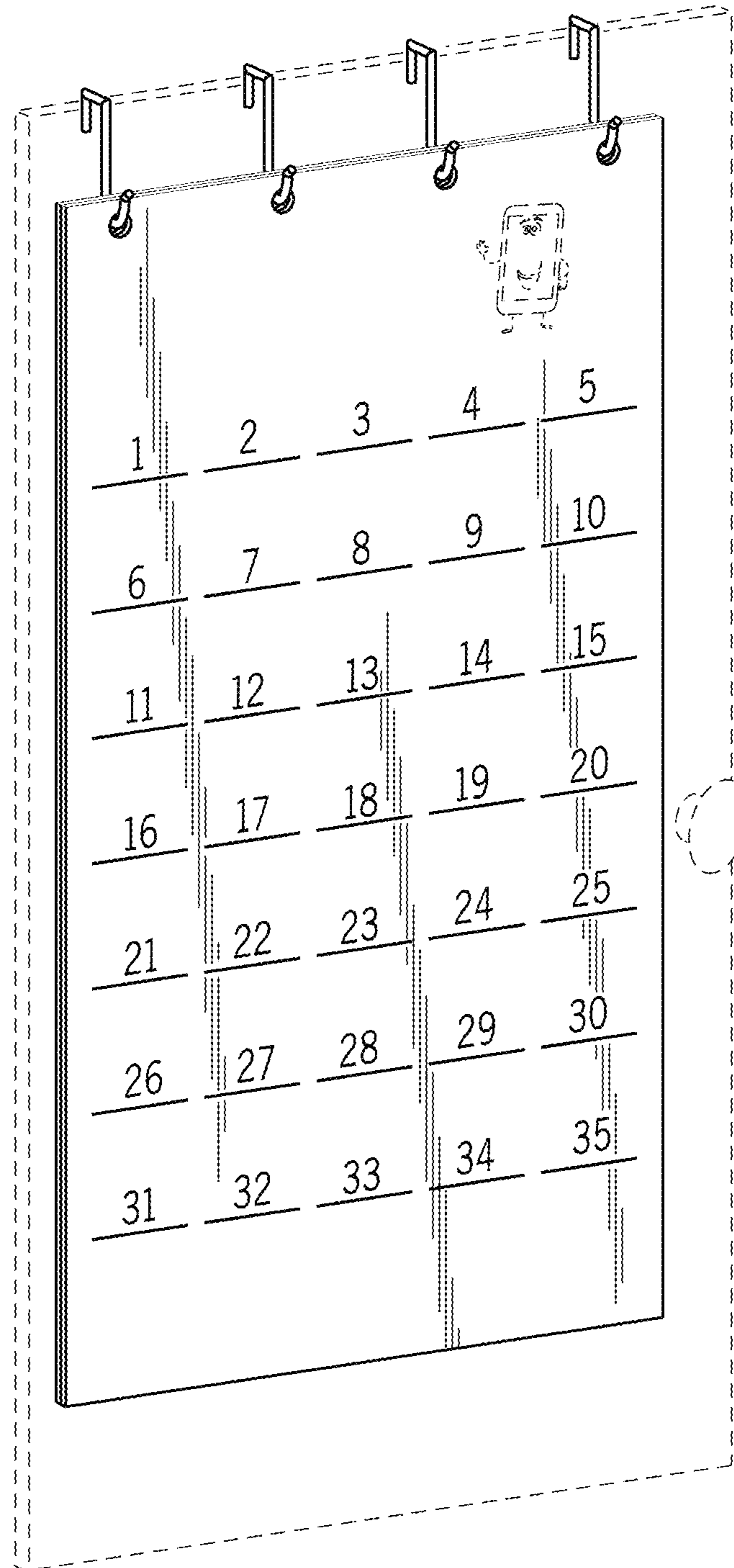

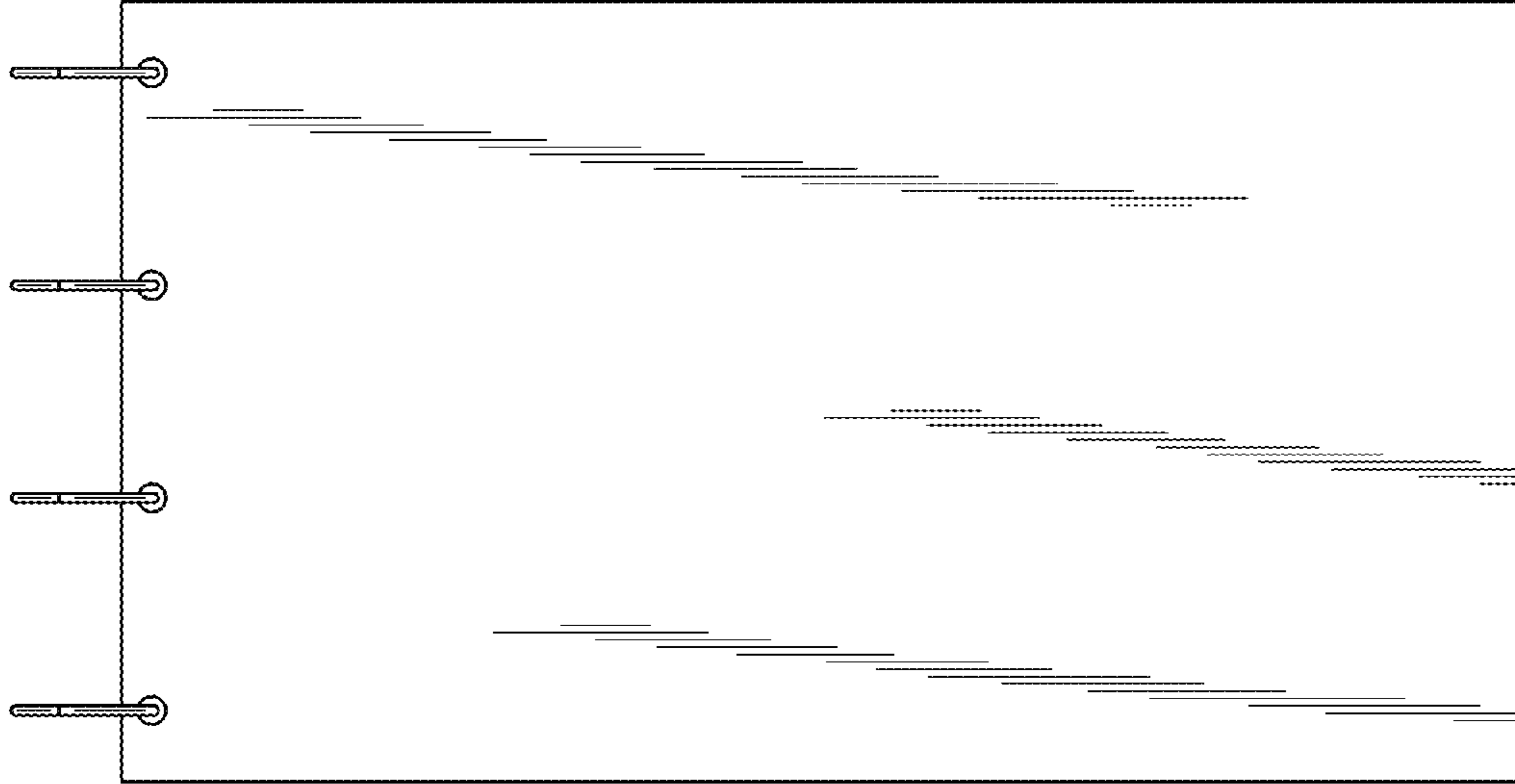

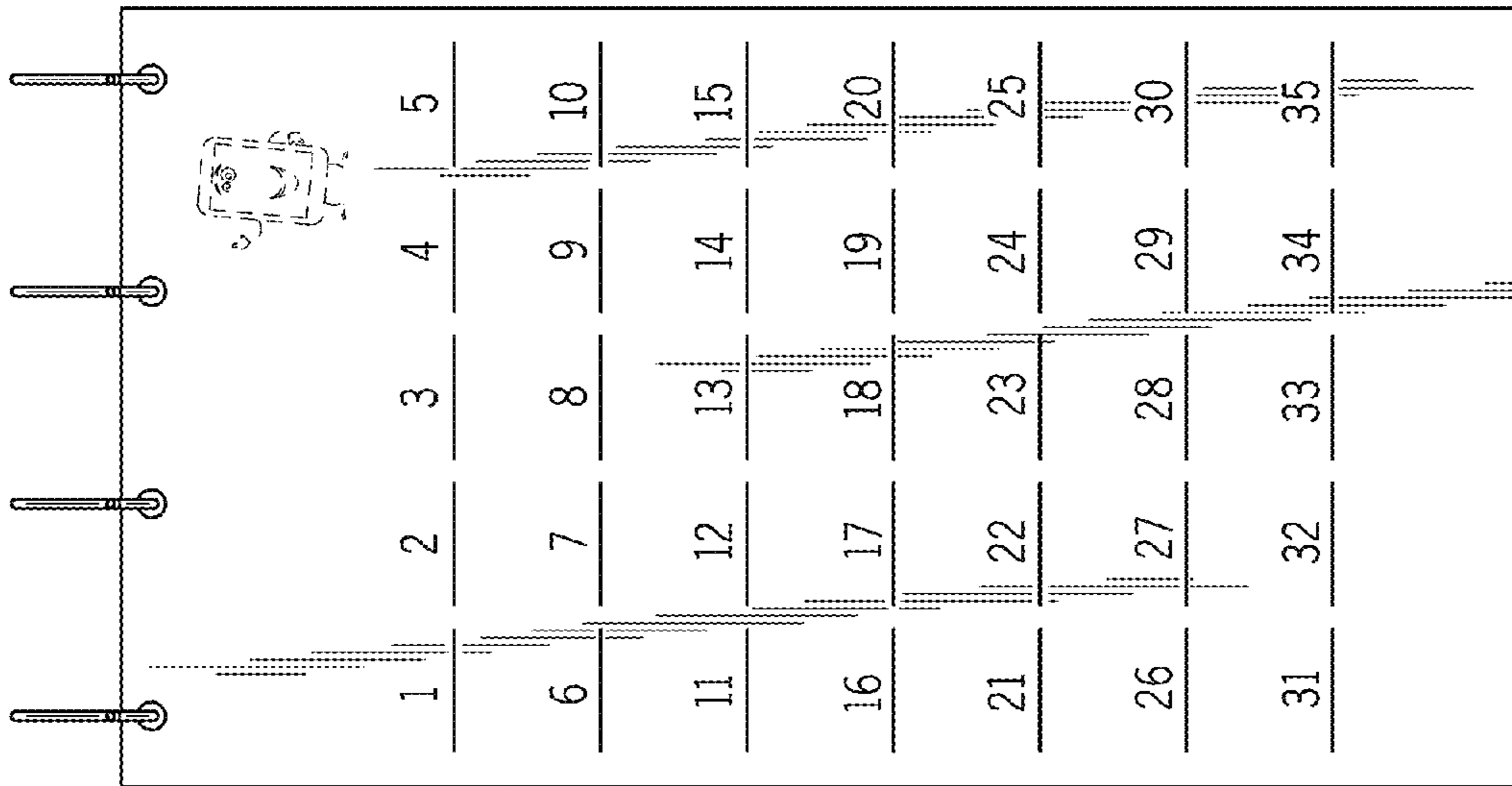

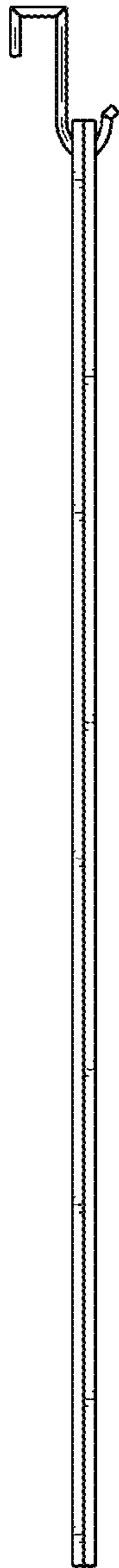

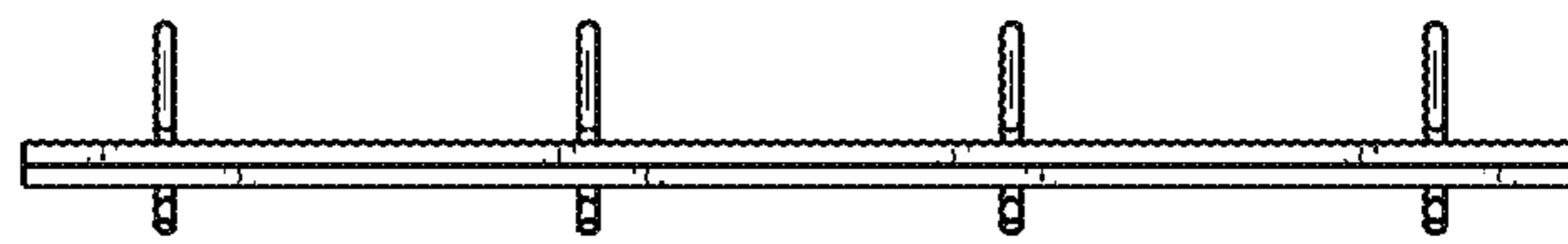

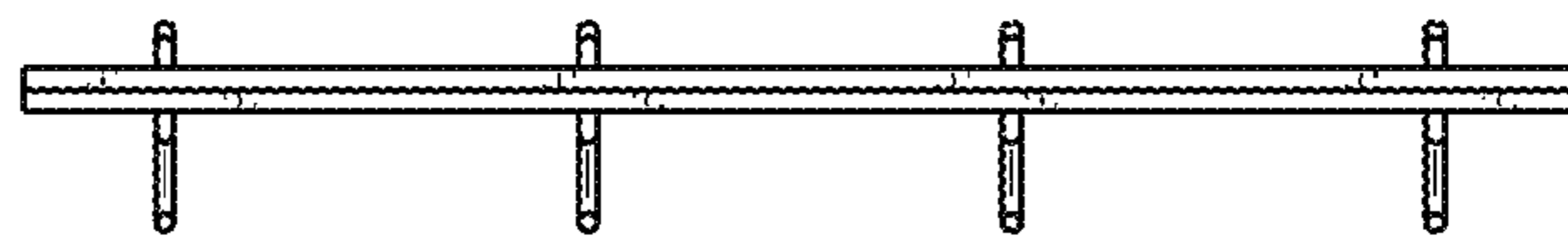
