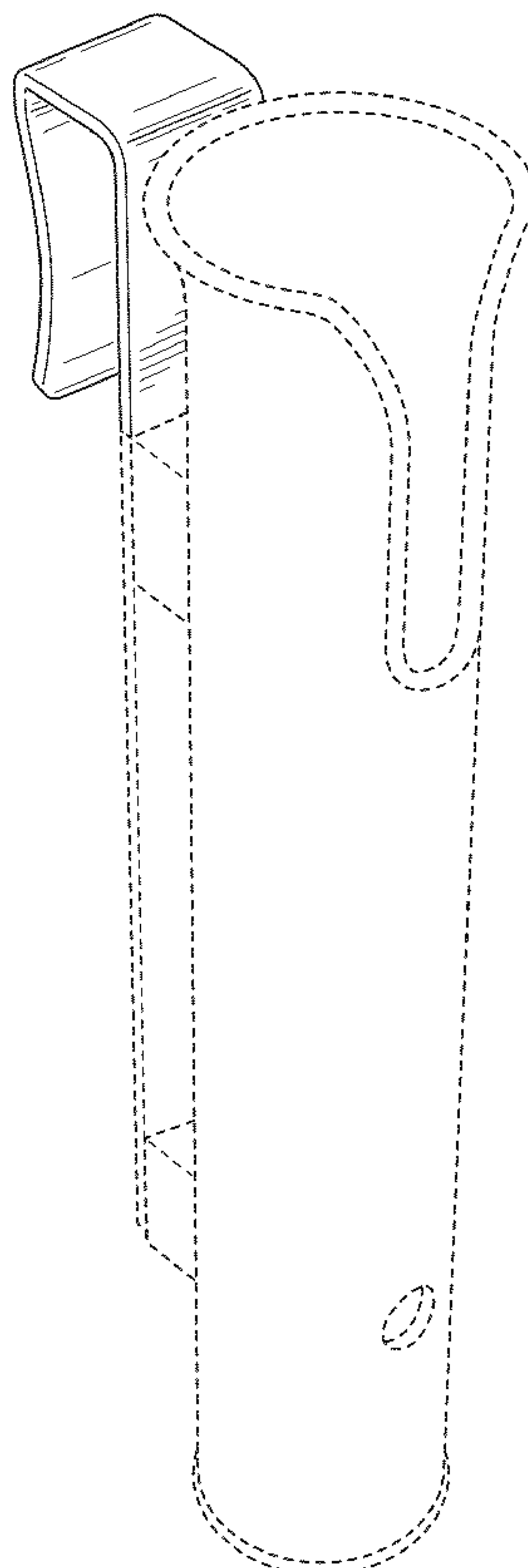
The ornamental design for a holder, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a holder showing my new design;

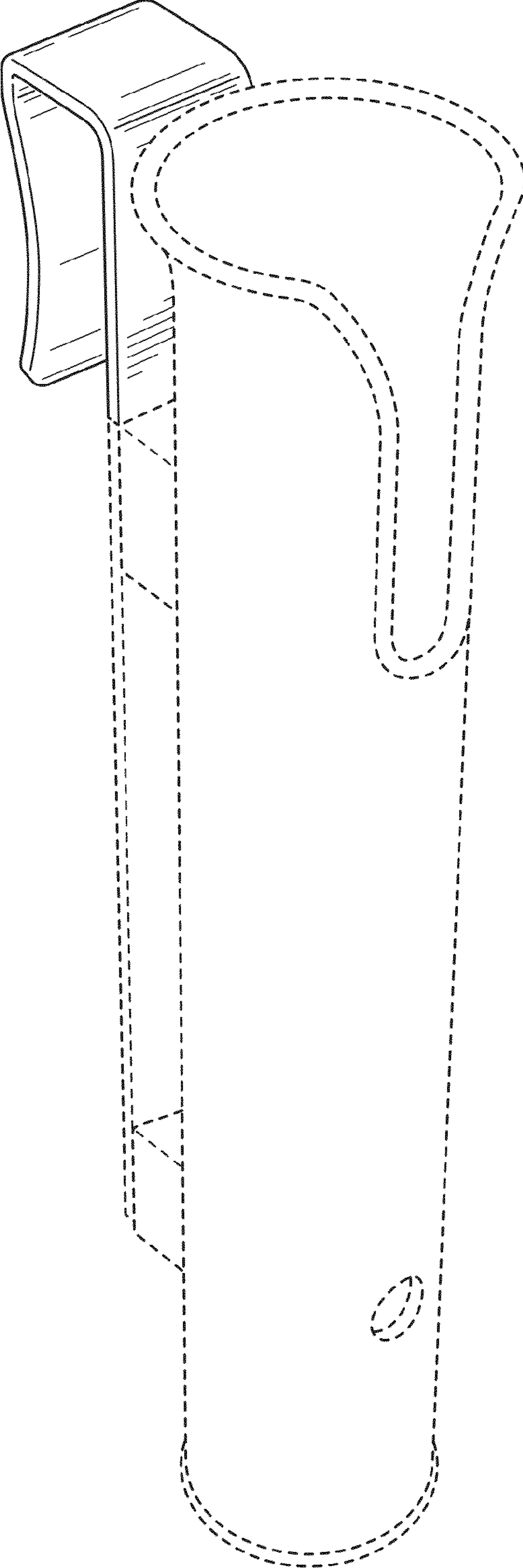

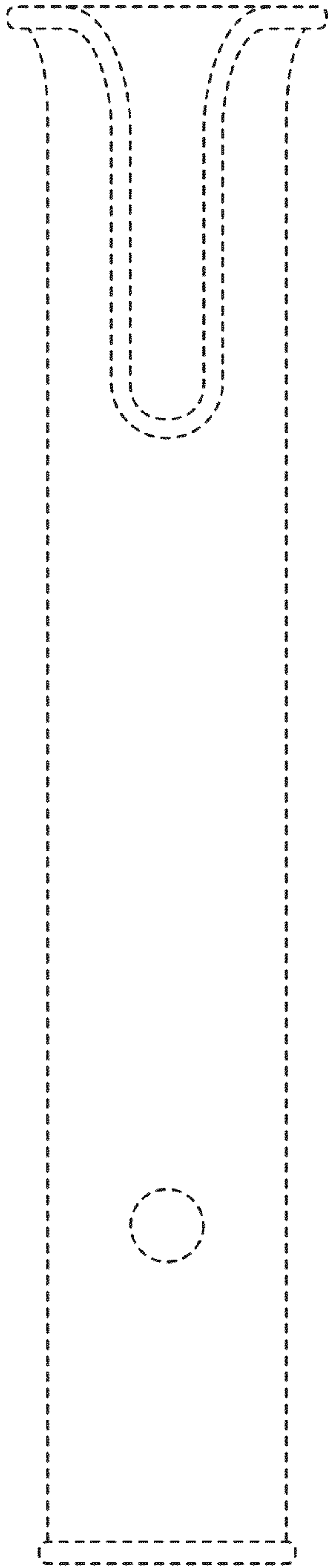

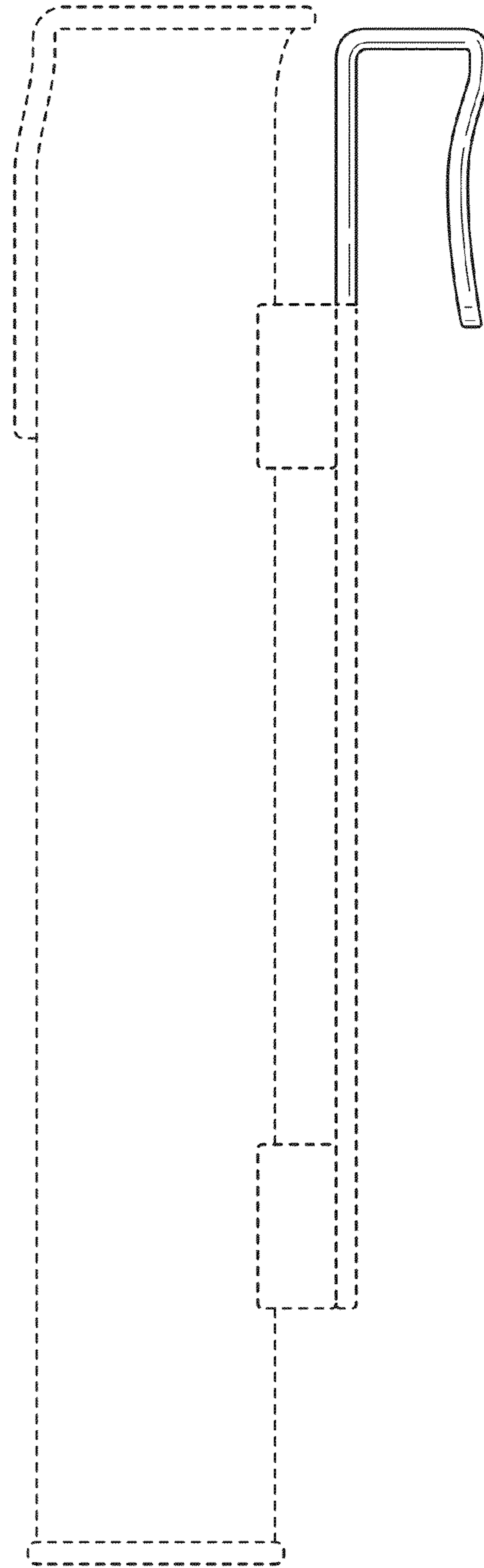

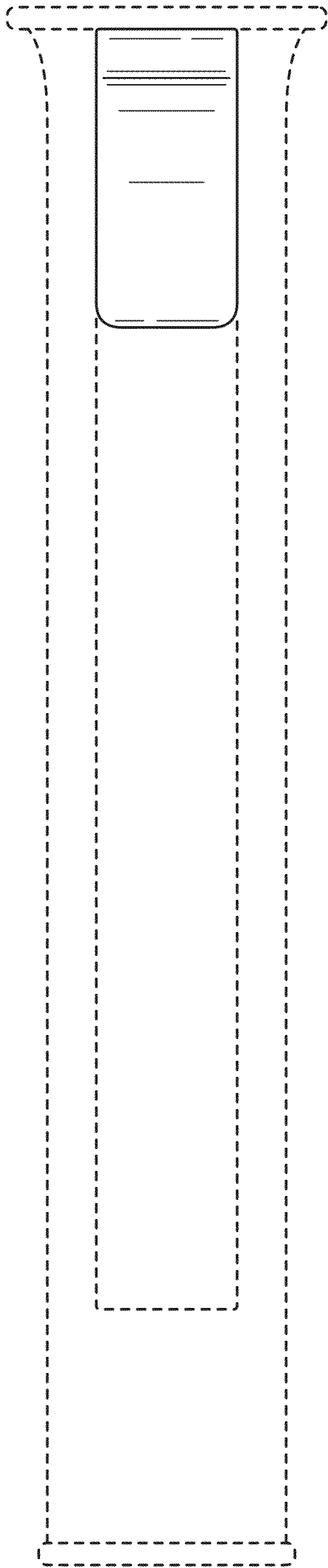

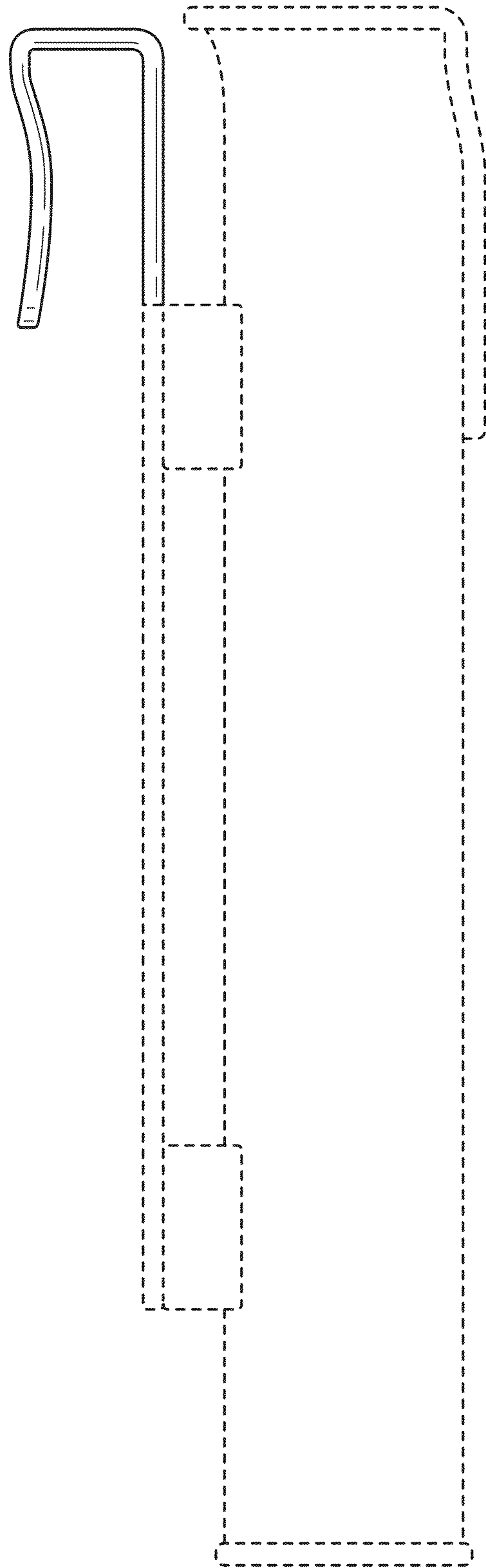

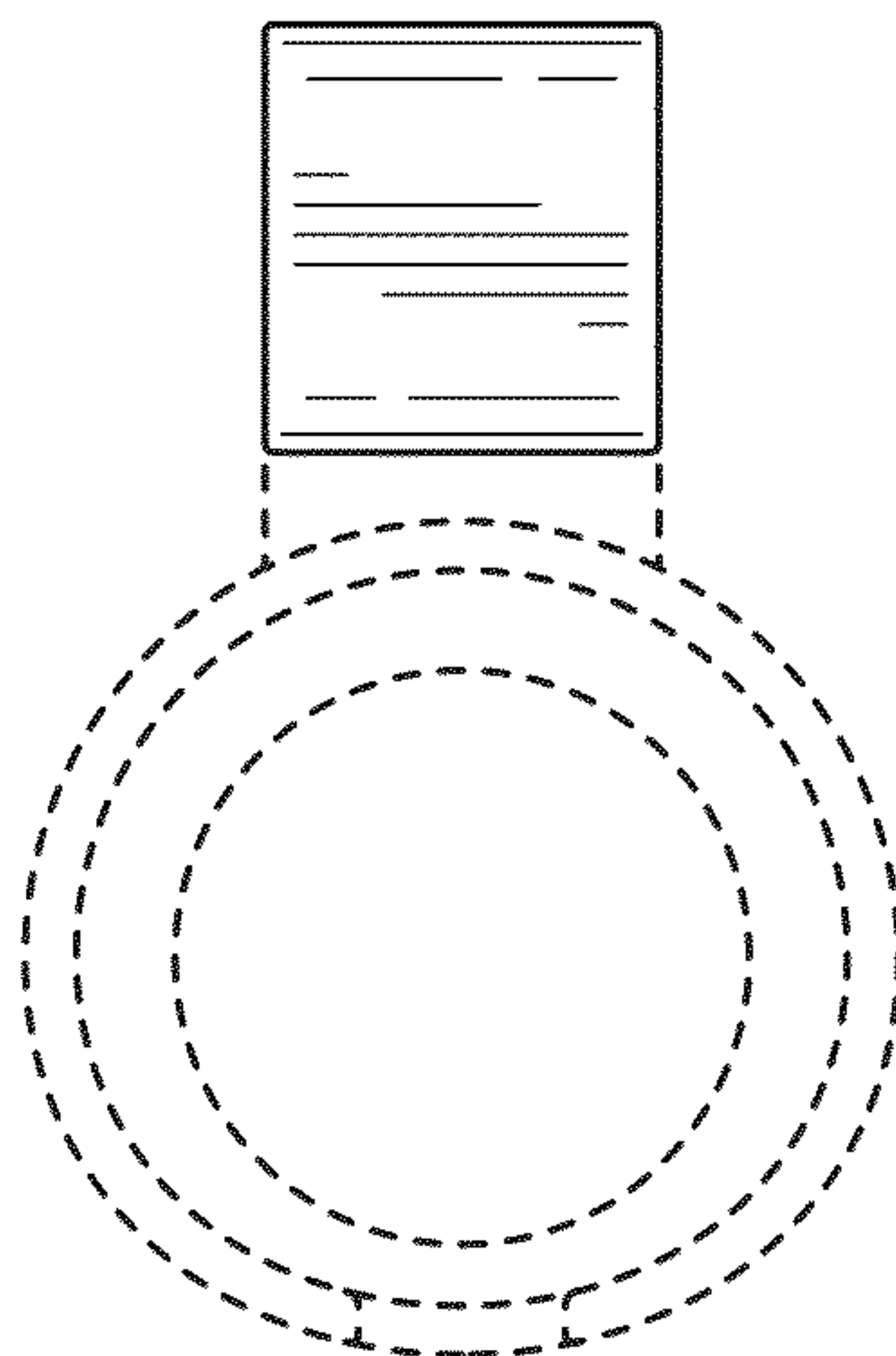

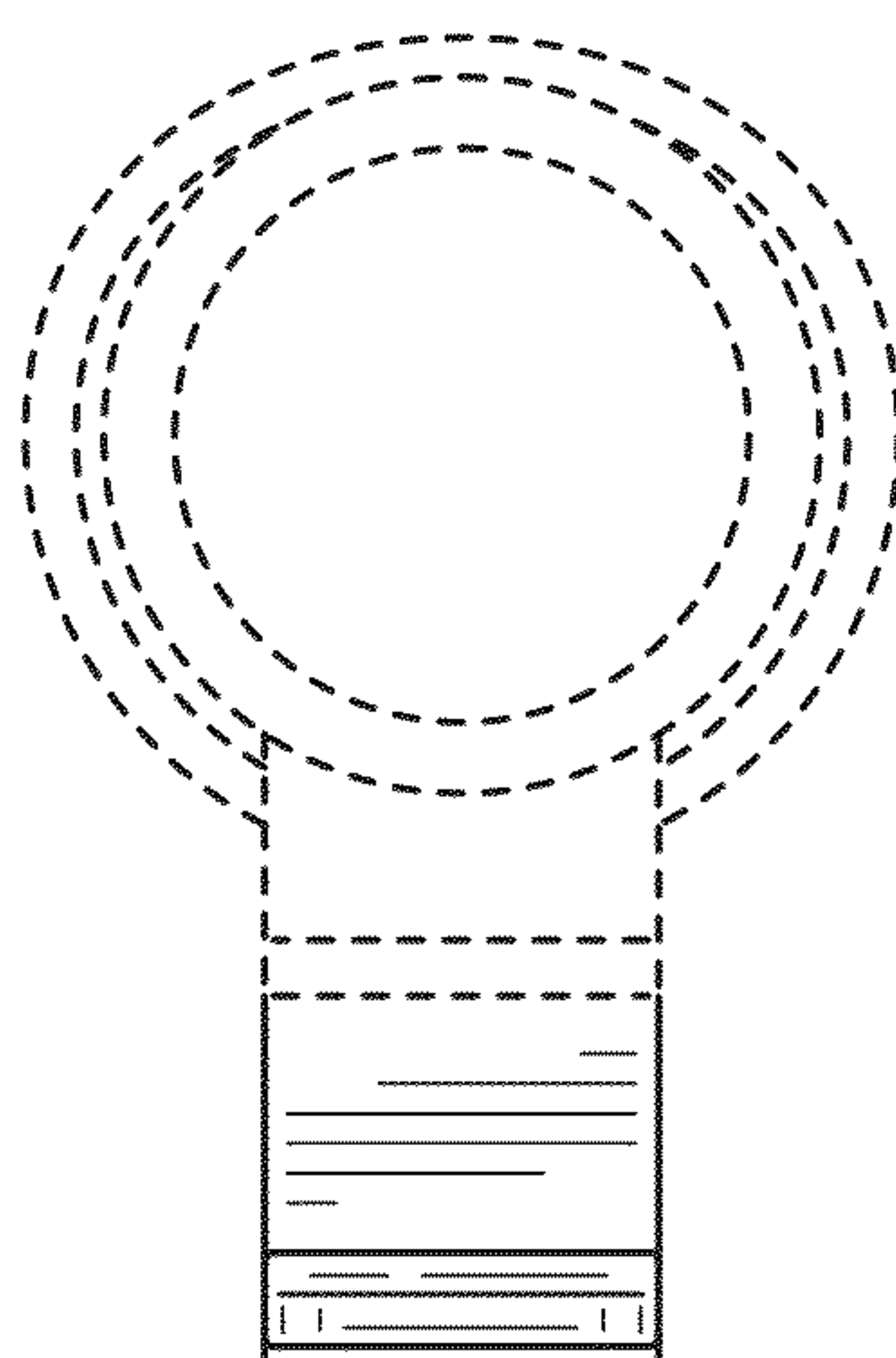
