FIG. 7 shows a bottom view of the retaining wall block and cap module illustrated in FIG. 1.

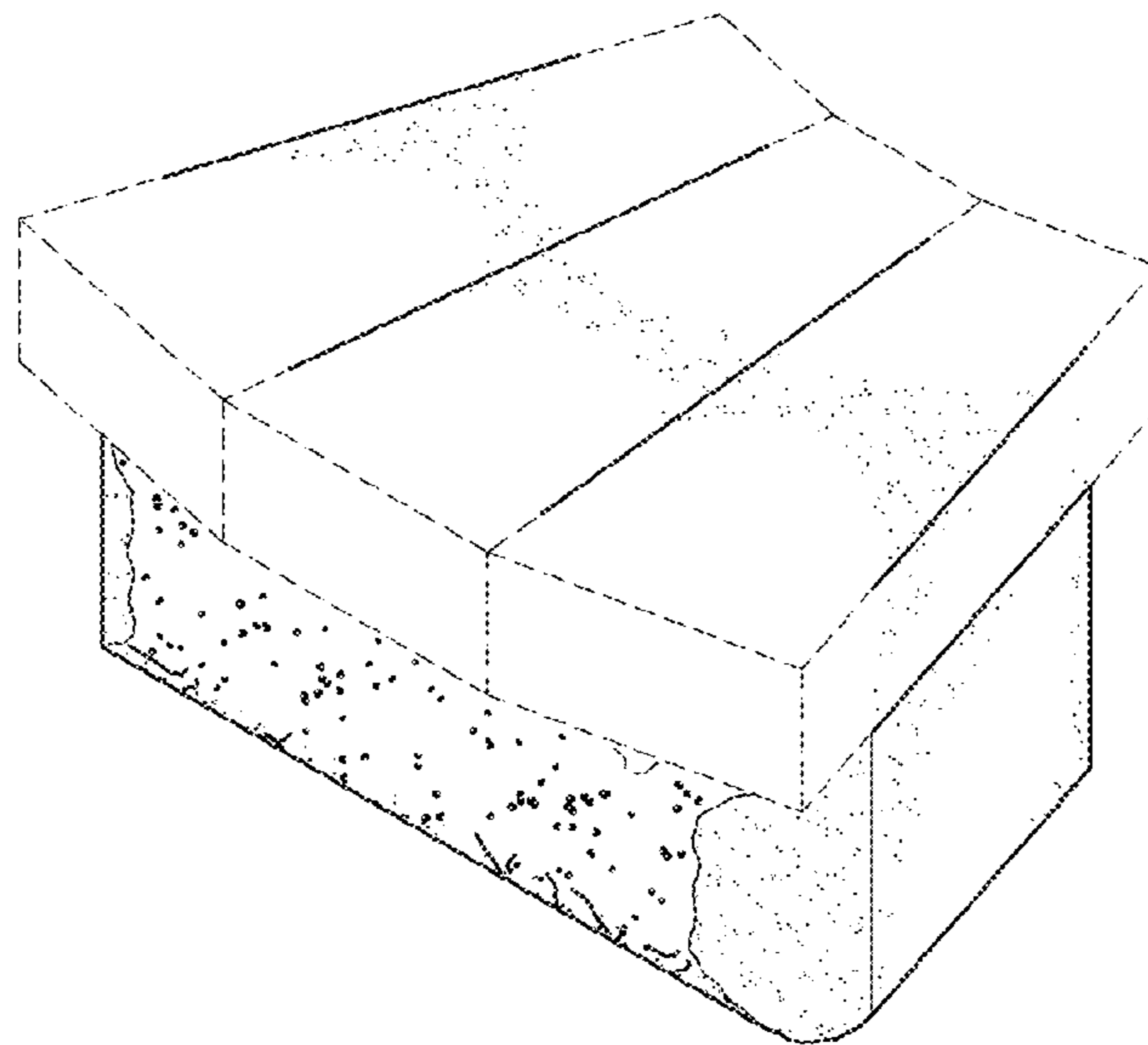
The broken lines in the drawing views are included for the purpose of illustrating portions of the retaining wall block and cap module that form no part of the claimed design.

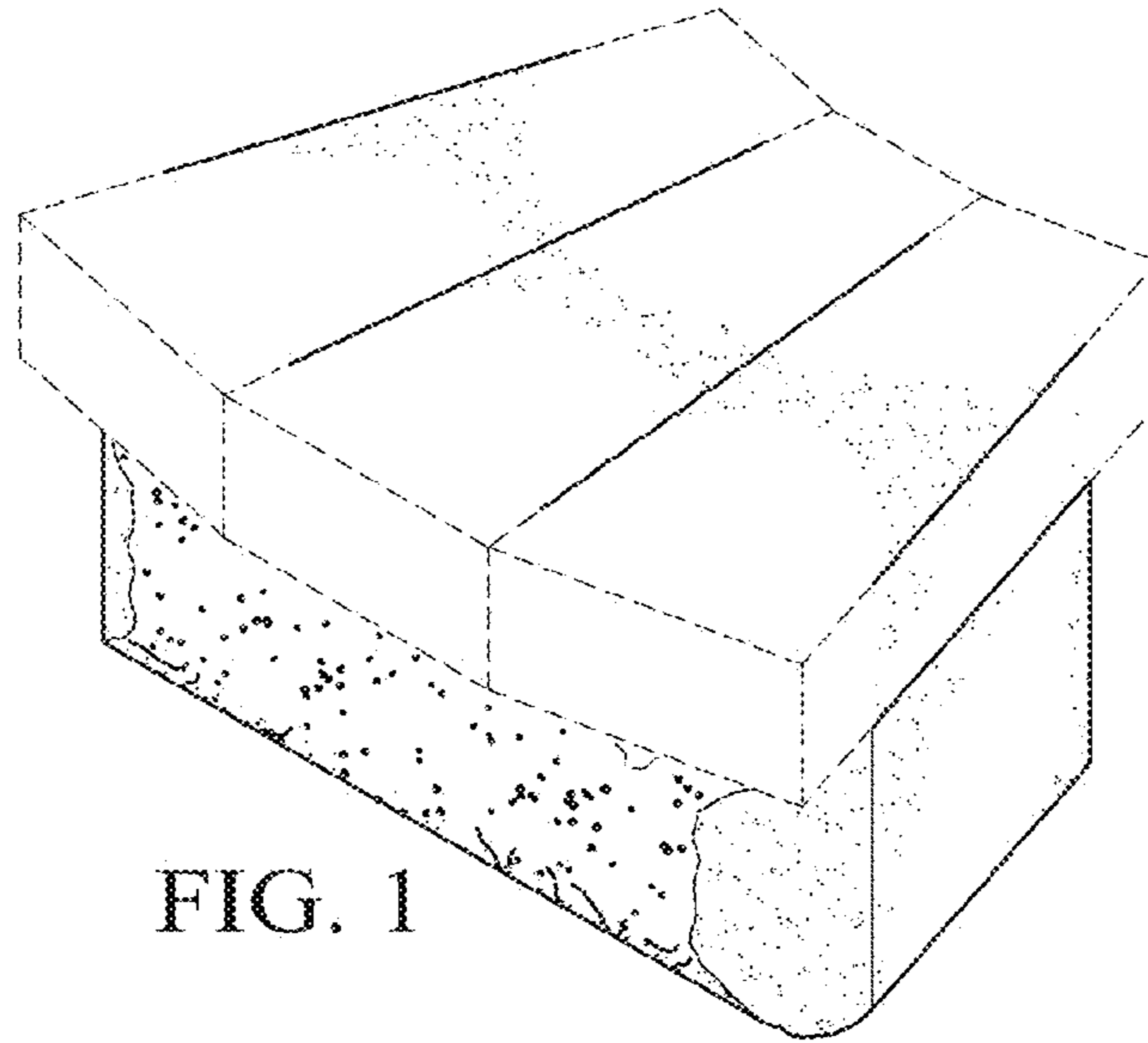

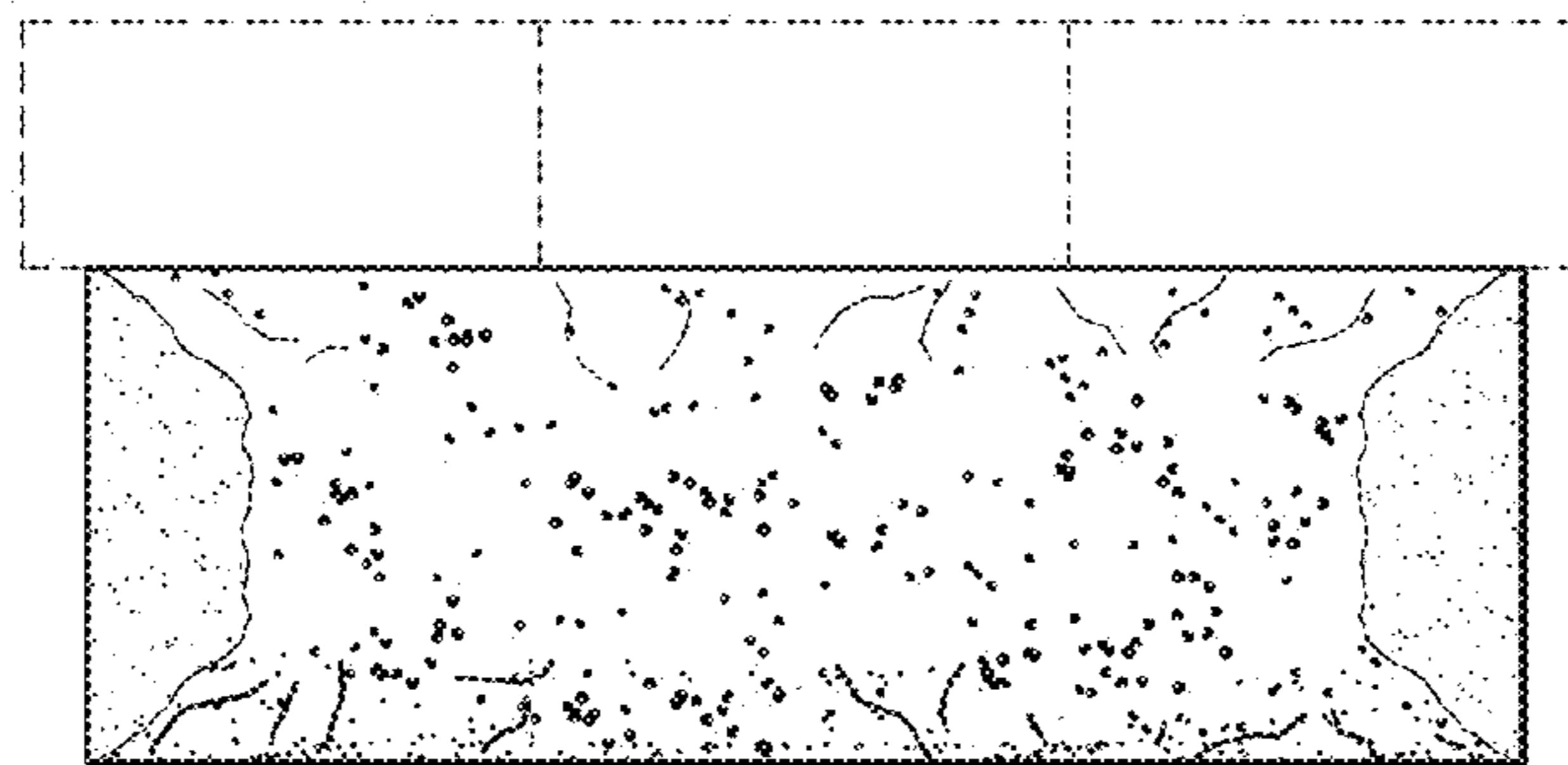

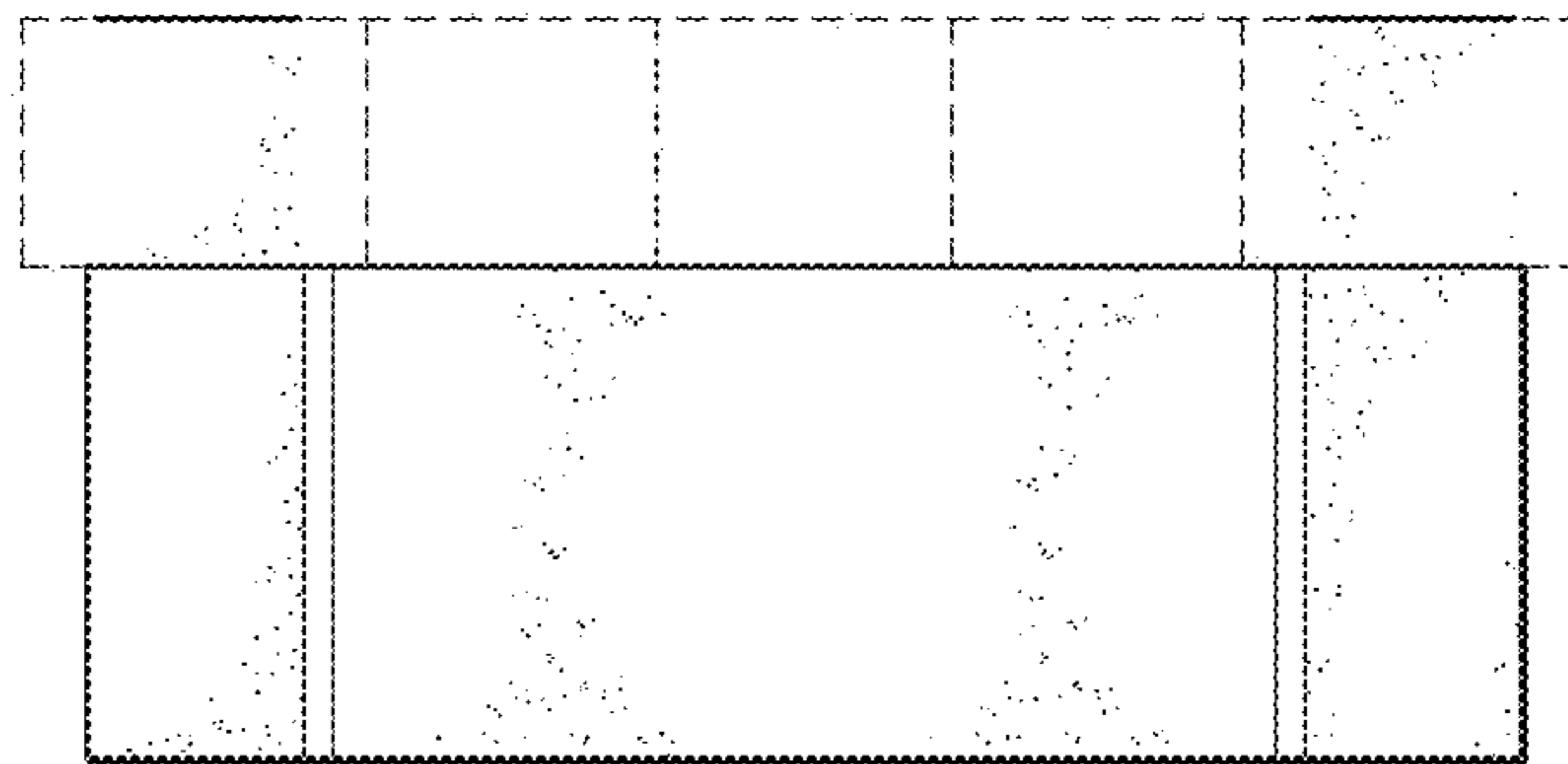

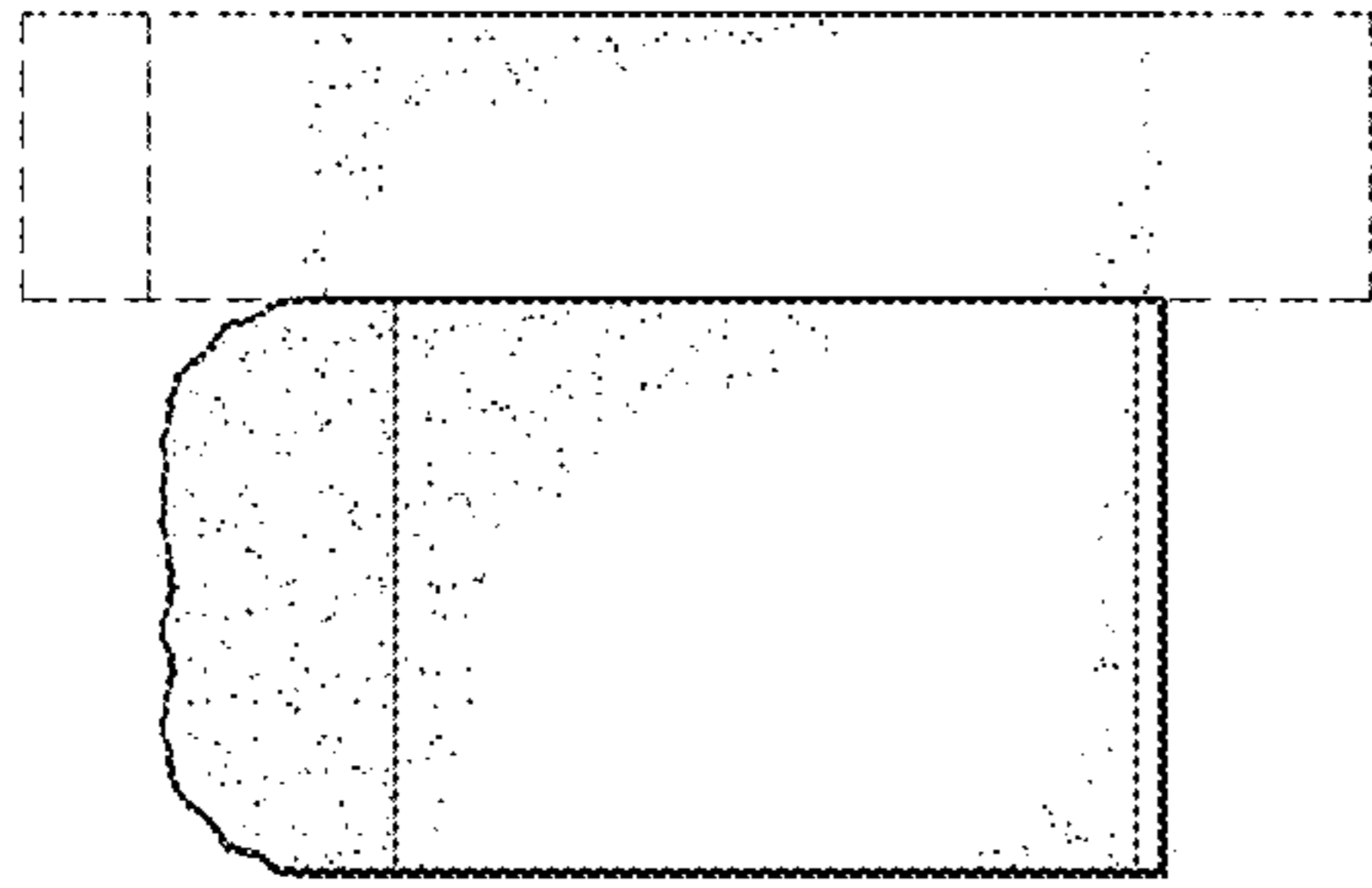

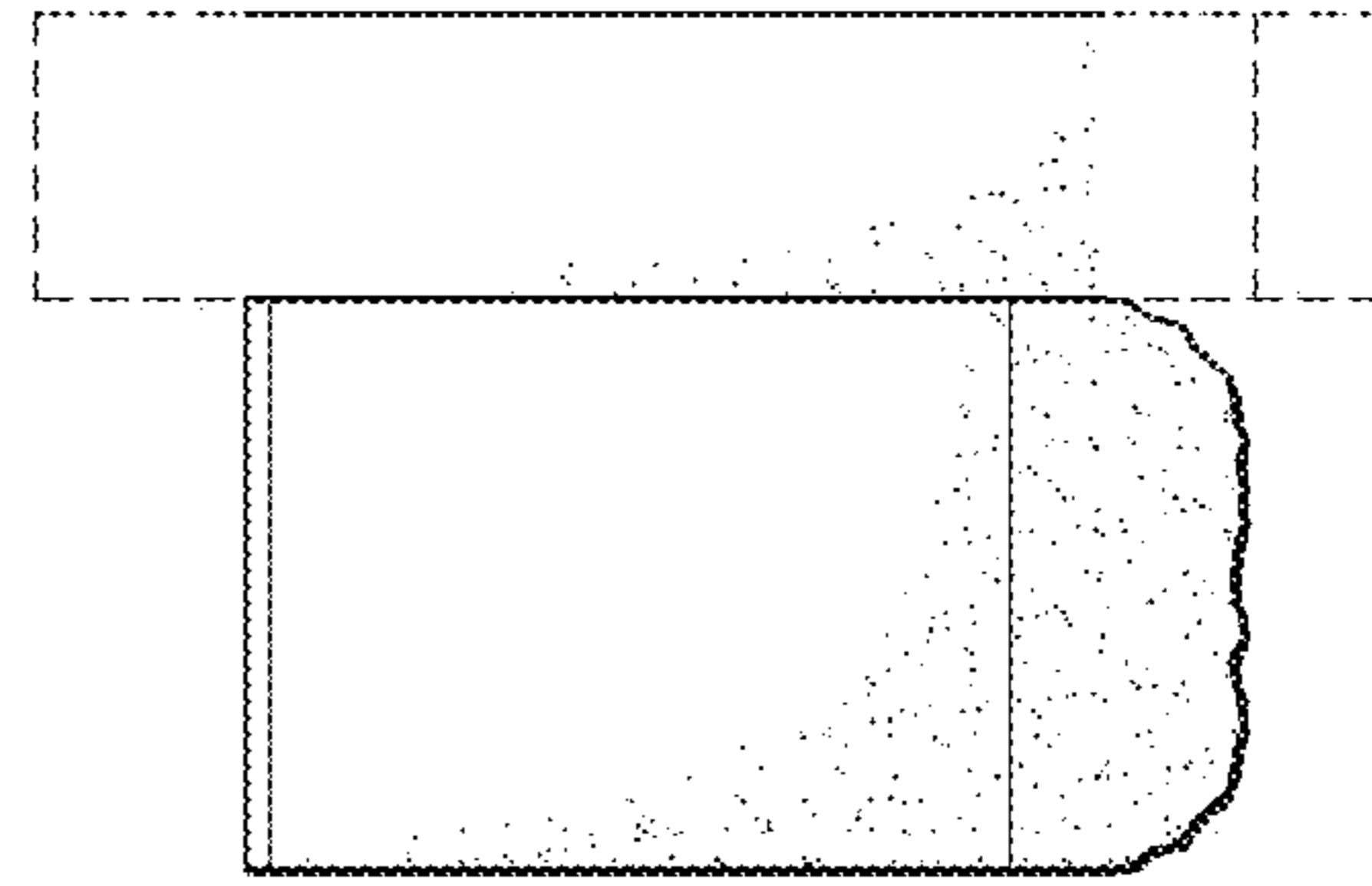

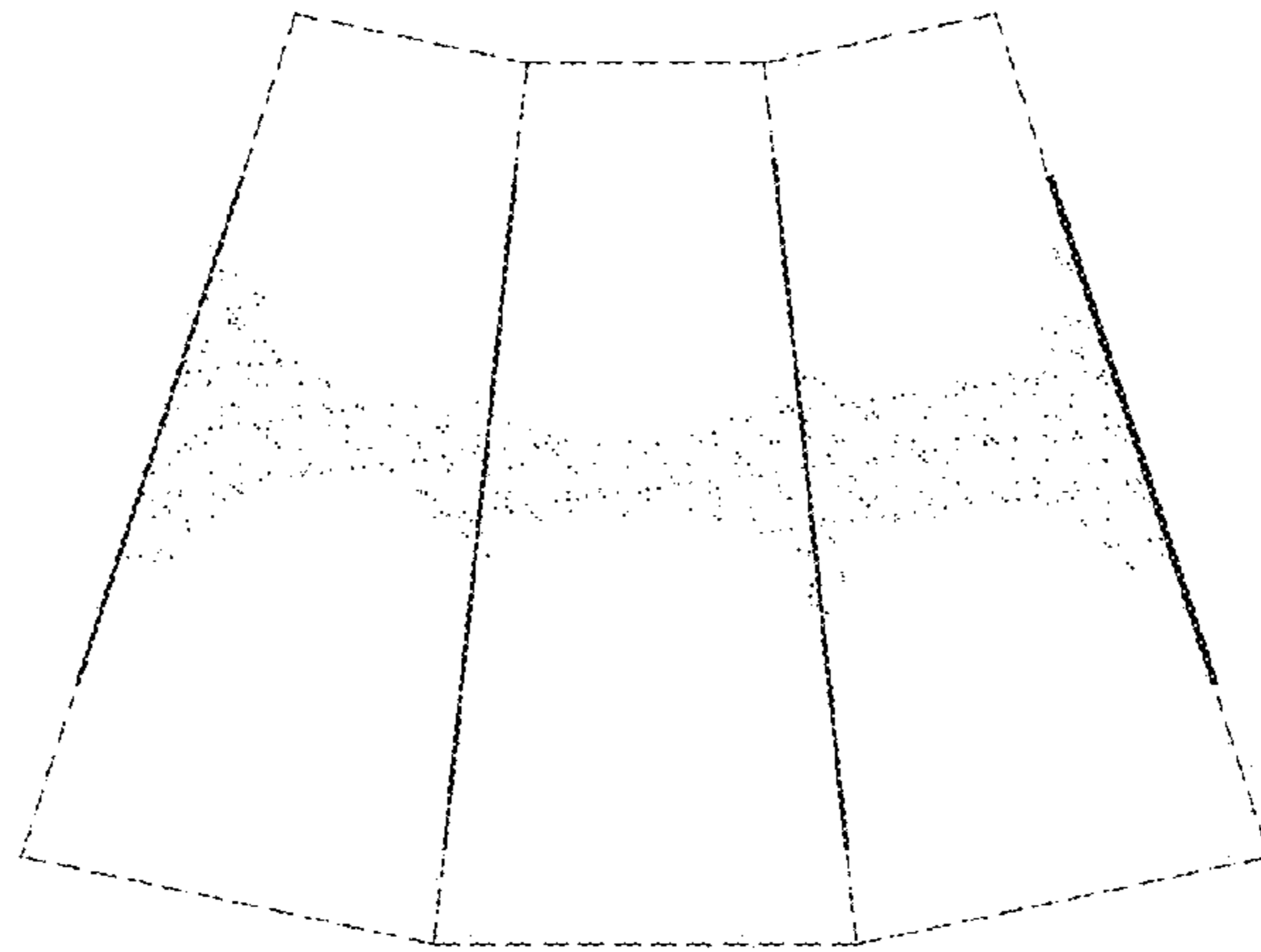

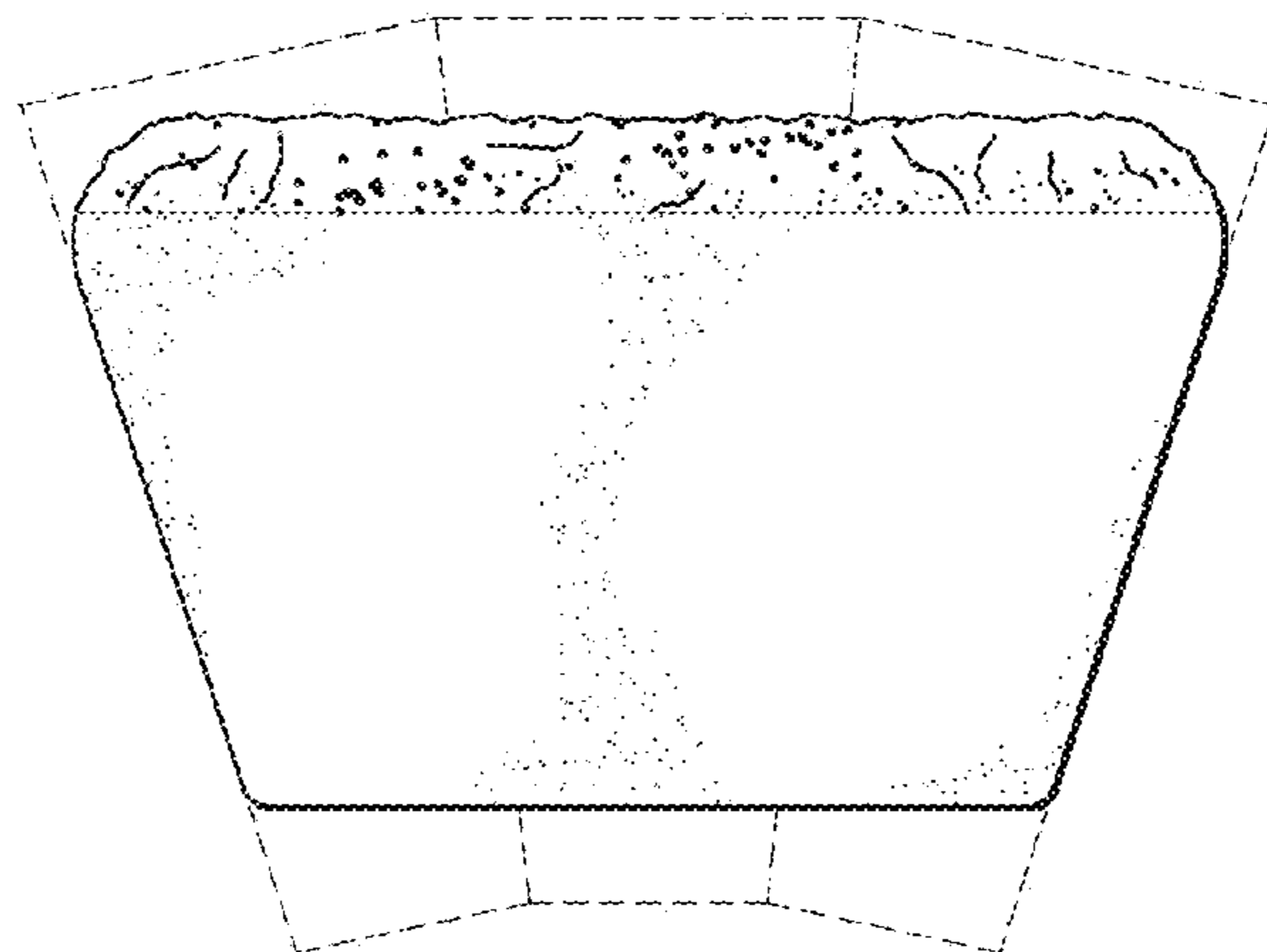
