The ornamental design for cigarette roach clip, as shown and described.

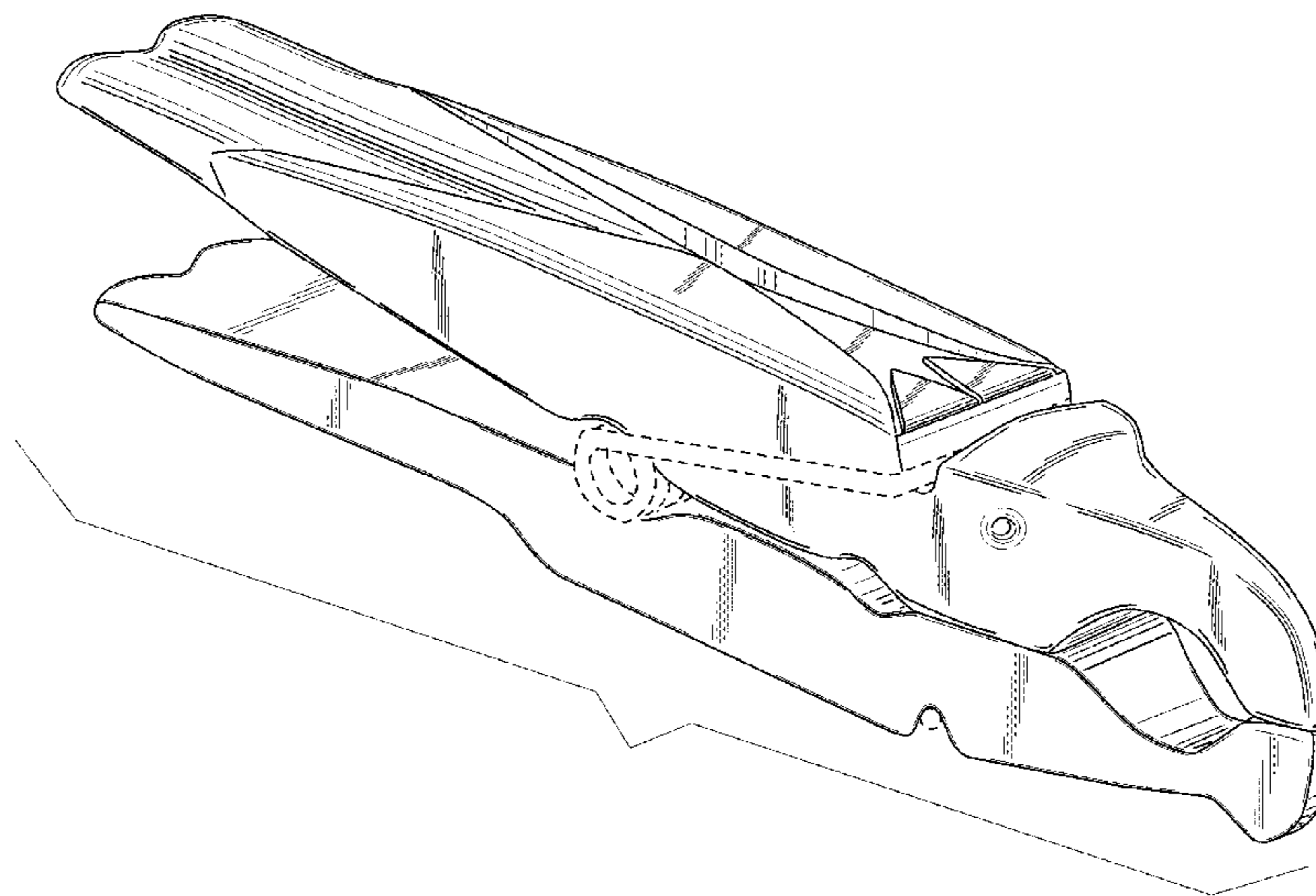
DESCRIPTION

FIG. 1 is an isometric top view of a cigarette roach clip showing an upper portion and a lower portion connected with a spring as part of the environment;
FIG. 2 is an isometric top view of the upper portion of the cigarette roach clip;
FIG. 3 is a front view of FIG. 2;
FIG. 4 is a rear view of FIG. 2;
FIG. 5 is a left-hand side view of FIG. 2, wherein a right-hand side view is a mirror image of the left-hand side view;
FIG. 6 is a top view of FIG. 2;
FIG. 7 is a bottom view of FIG. 2;
FIG. 8 is an isometric top view of the lower portion of the cigarette roach clip;
FIG. 9 is an isometric bottom view of FIG. 8;
FIG. 10 is a front view of FIG. 8;
FIG. 11 is a rear view of FIG. 8;
FIG. 12 is a left-hand side view of FIG. 8, wherein a right-hand side view is a mirror image of the left-hand side view;
FIG. 13 is a top view of FIG. 8; and
FIG. 14 is a bottom view of FIG. 8.

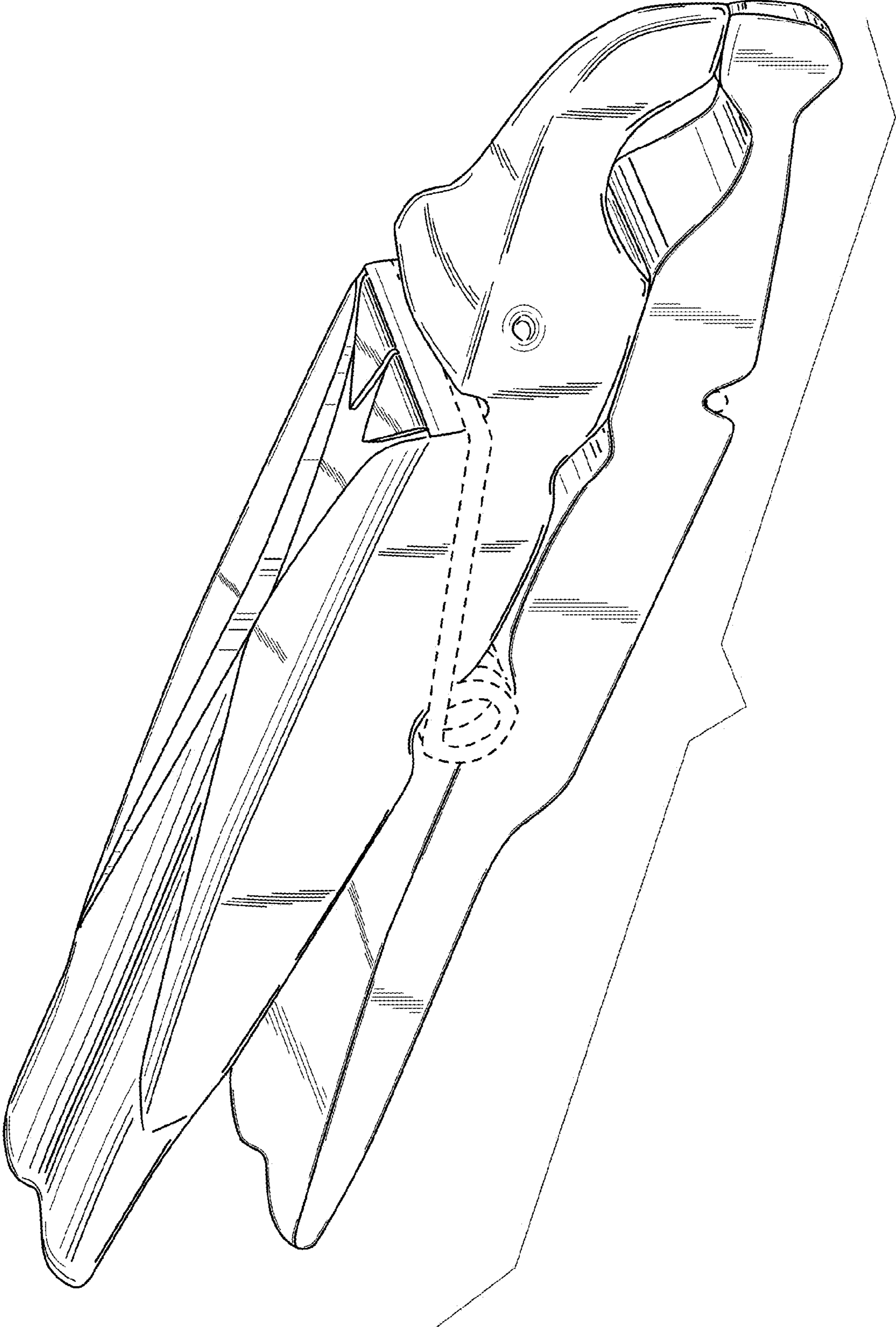

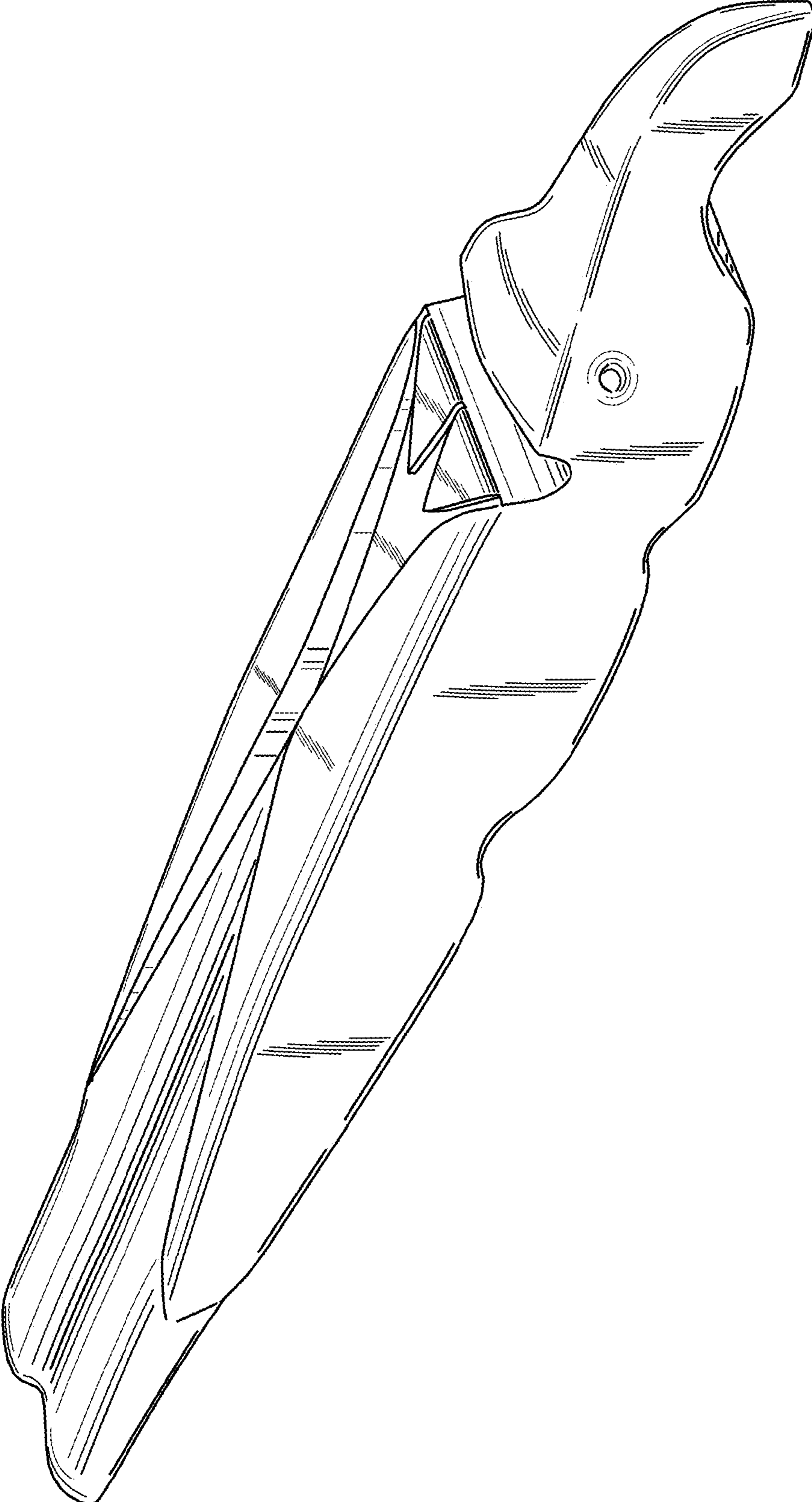

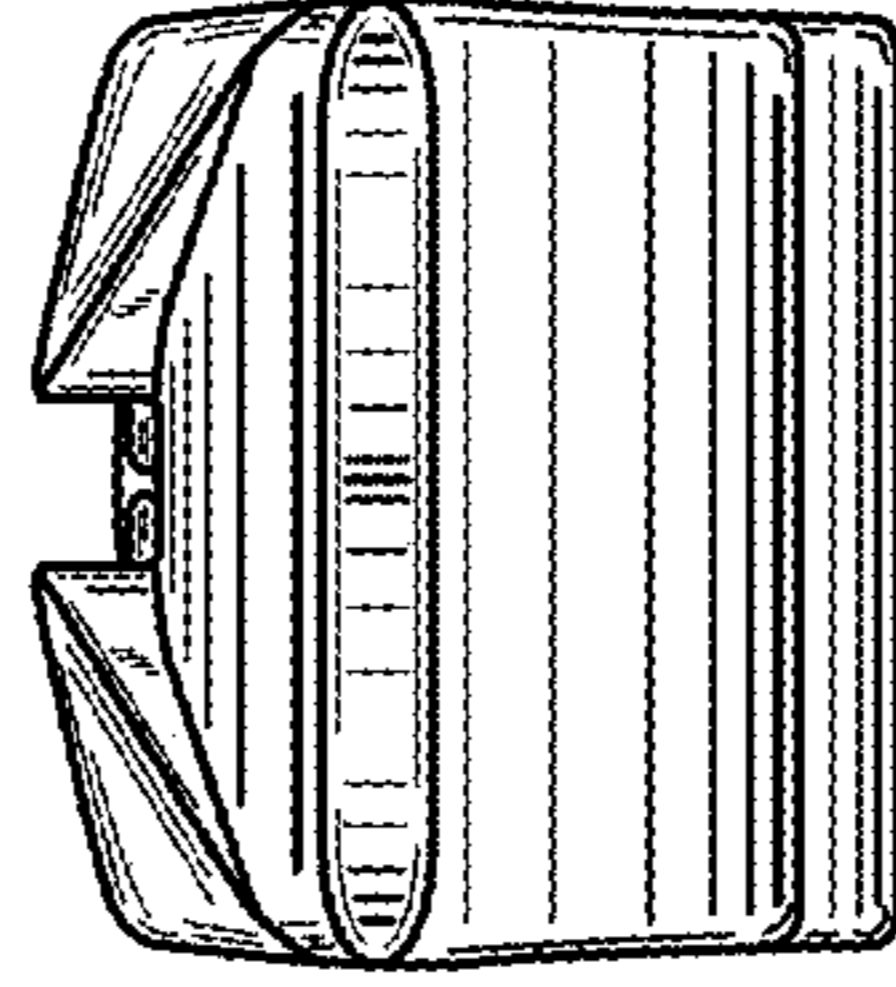

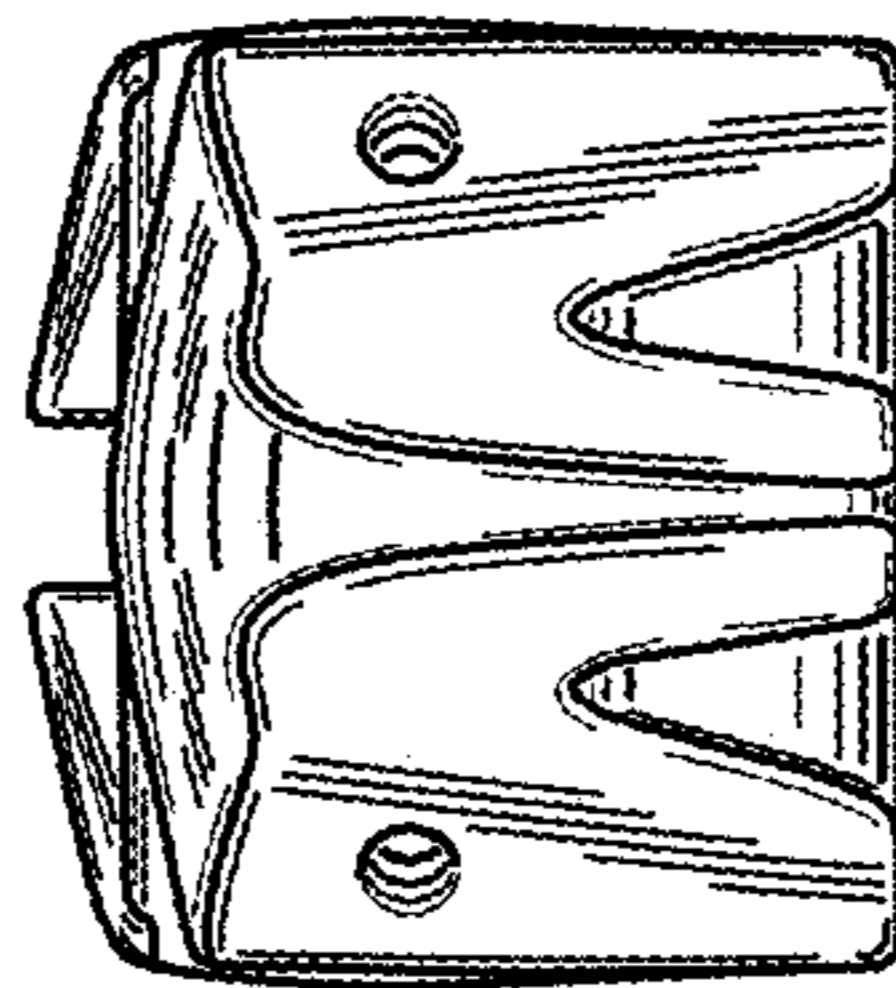

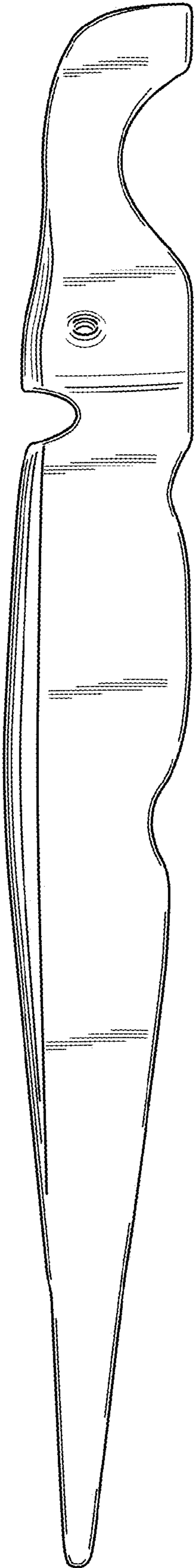

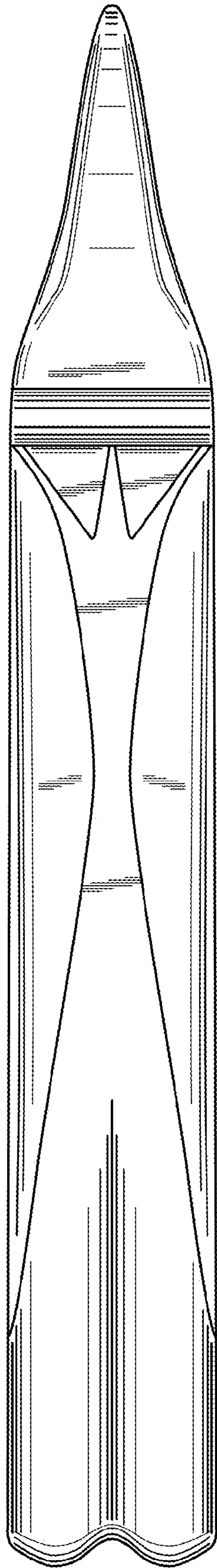

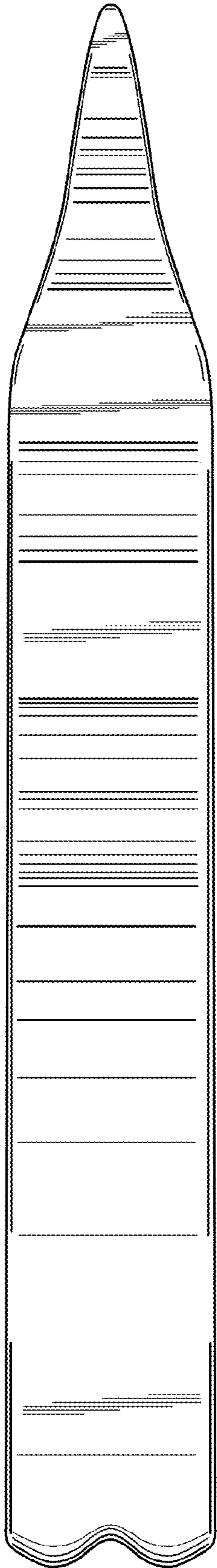

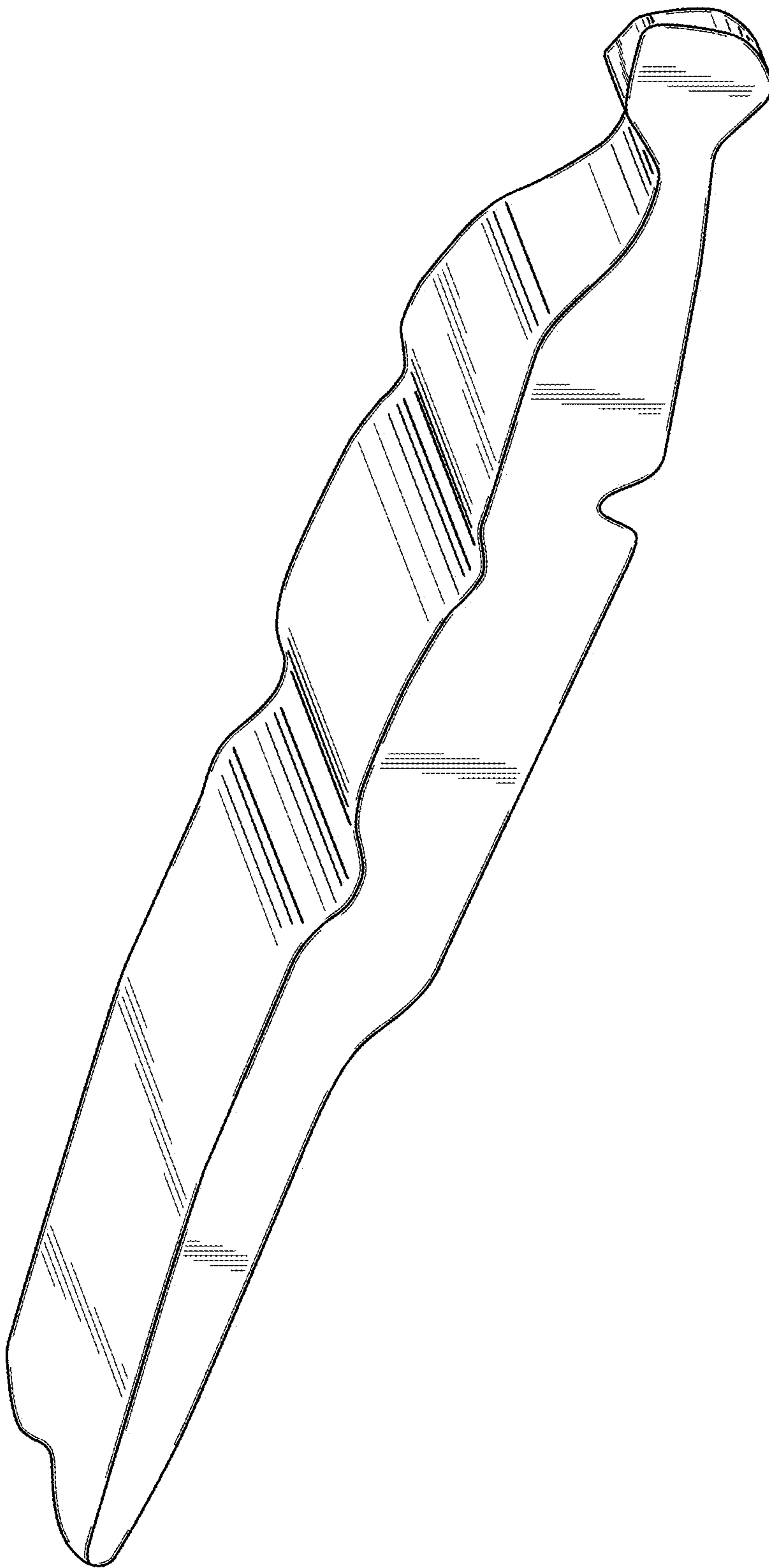

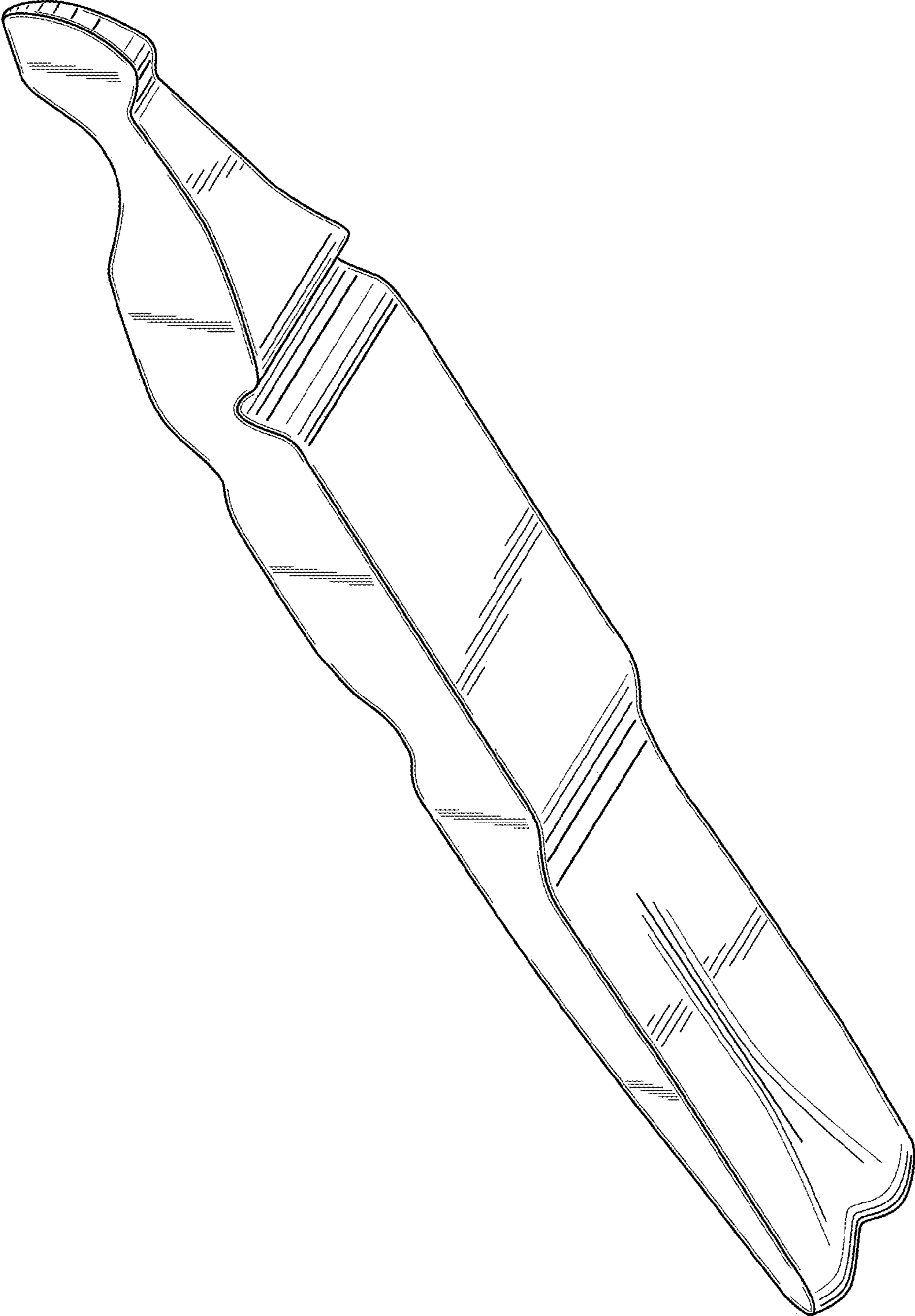

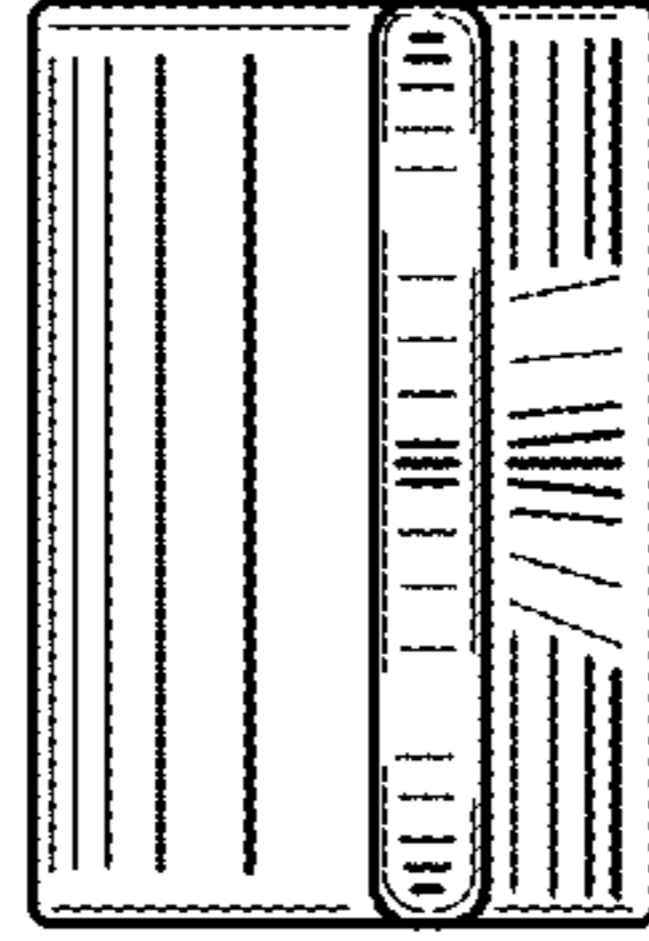

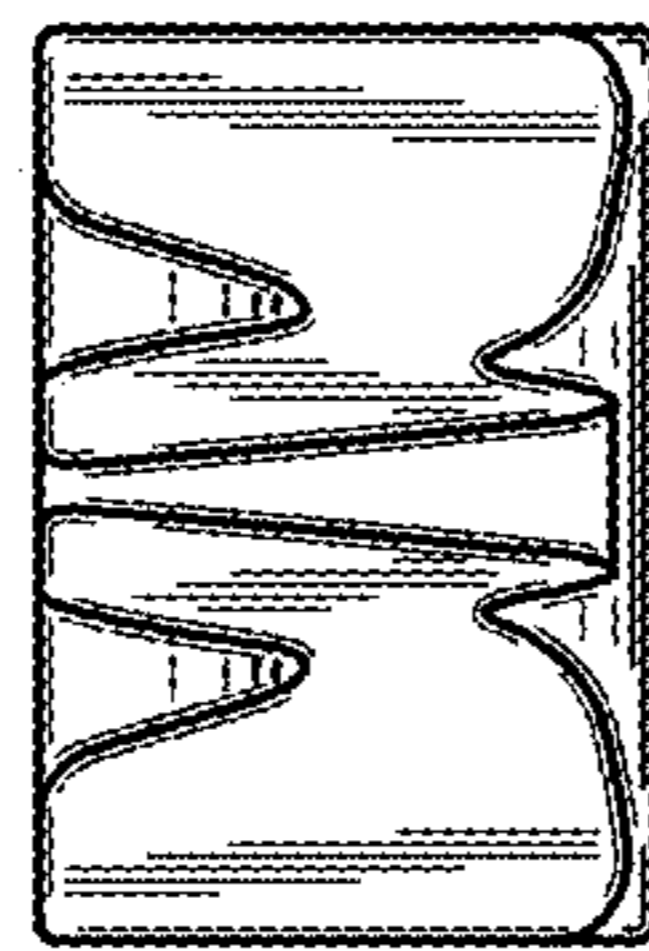

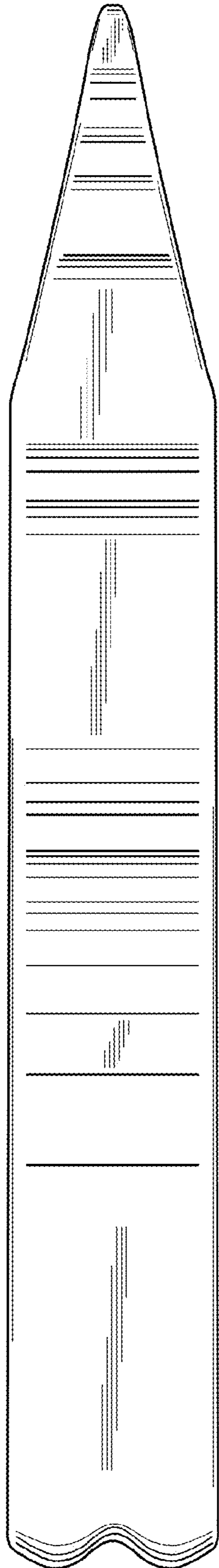

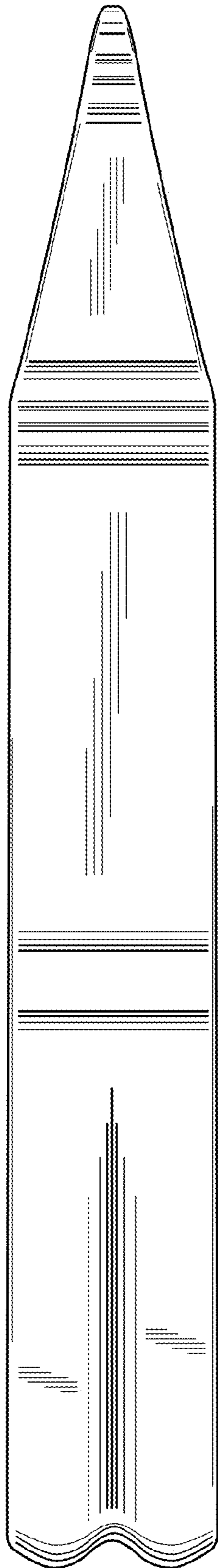
