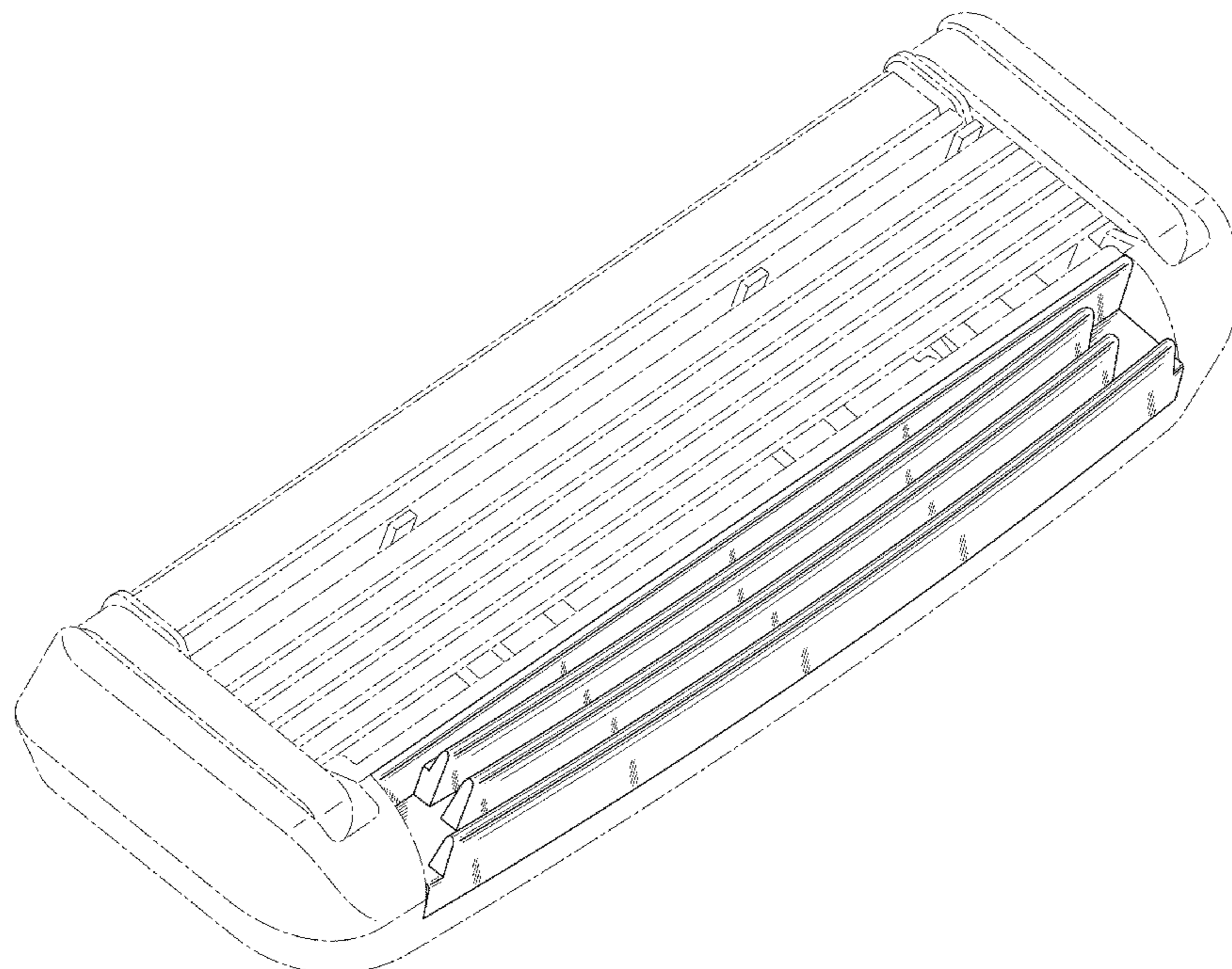
(57) **CLAIM**

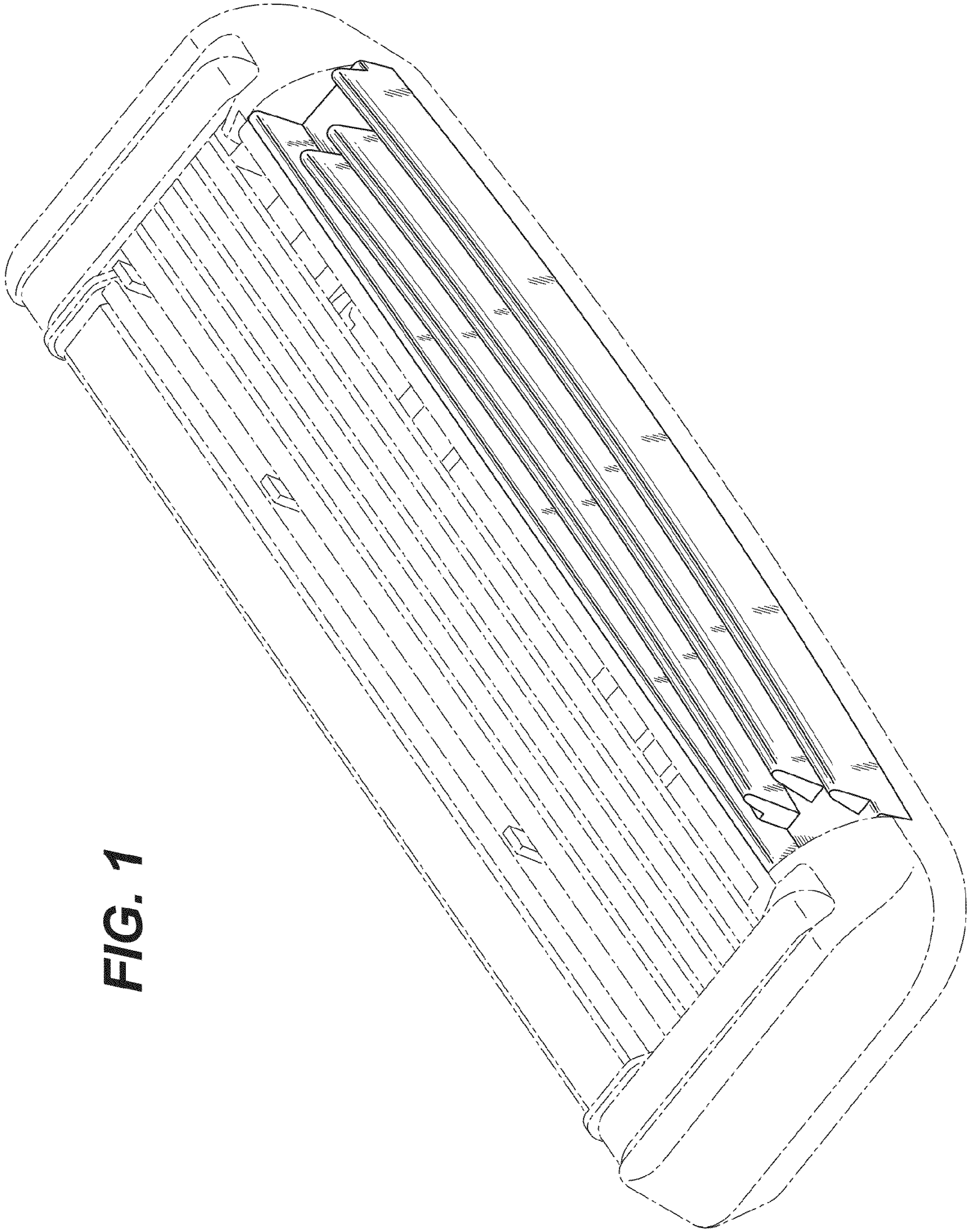
The ornamental design for set of curvilinear fins for a shaving cartridge, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-right front perspective view of the set of curvilinear fins for a shaving cartridge;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a bottom plan thereof;  
FIG. 5 is a rear elevational view thereof; and,

The broken lines illustrate the environment and form no part of the claimed design.

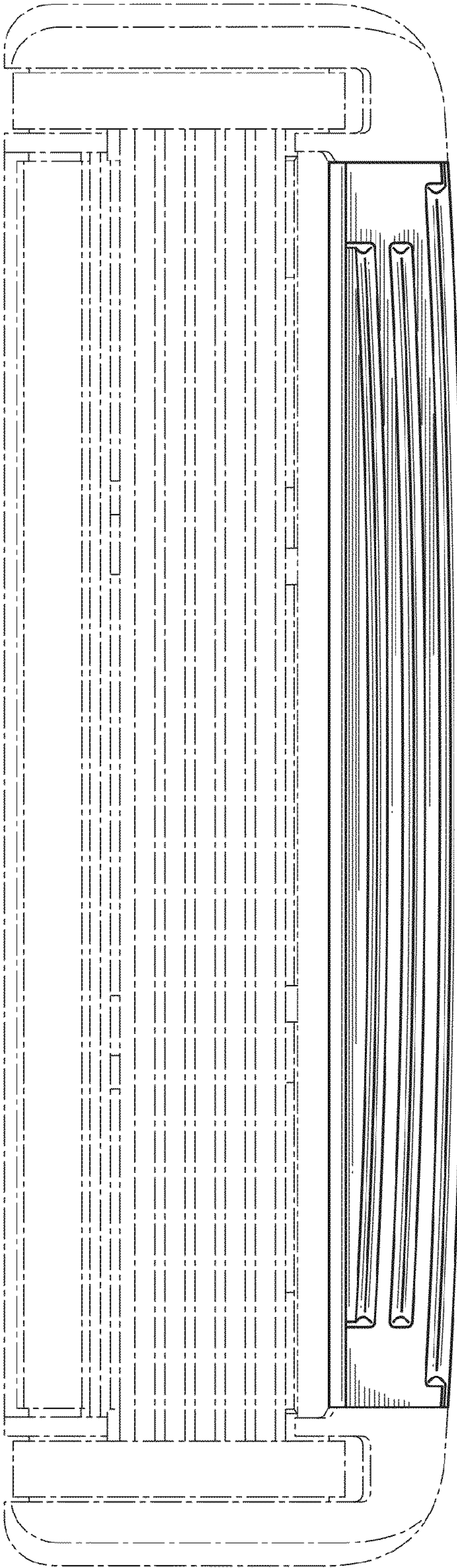

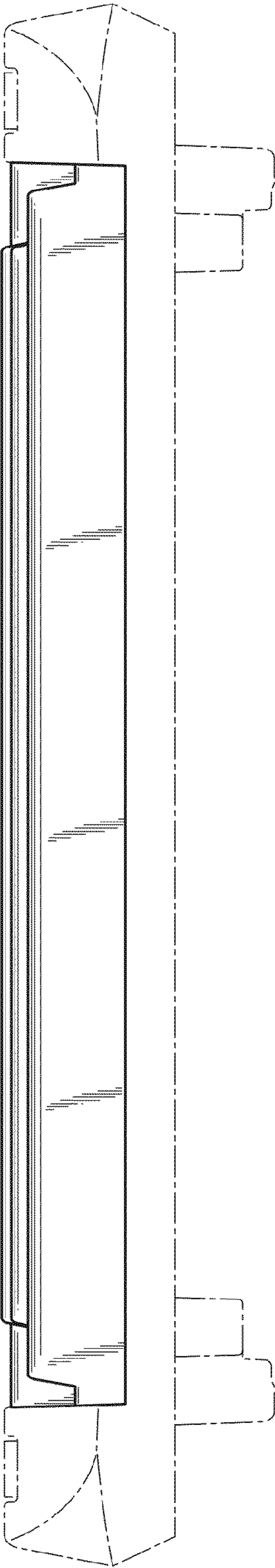

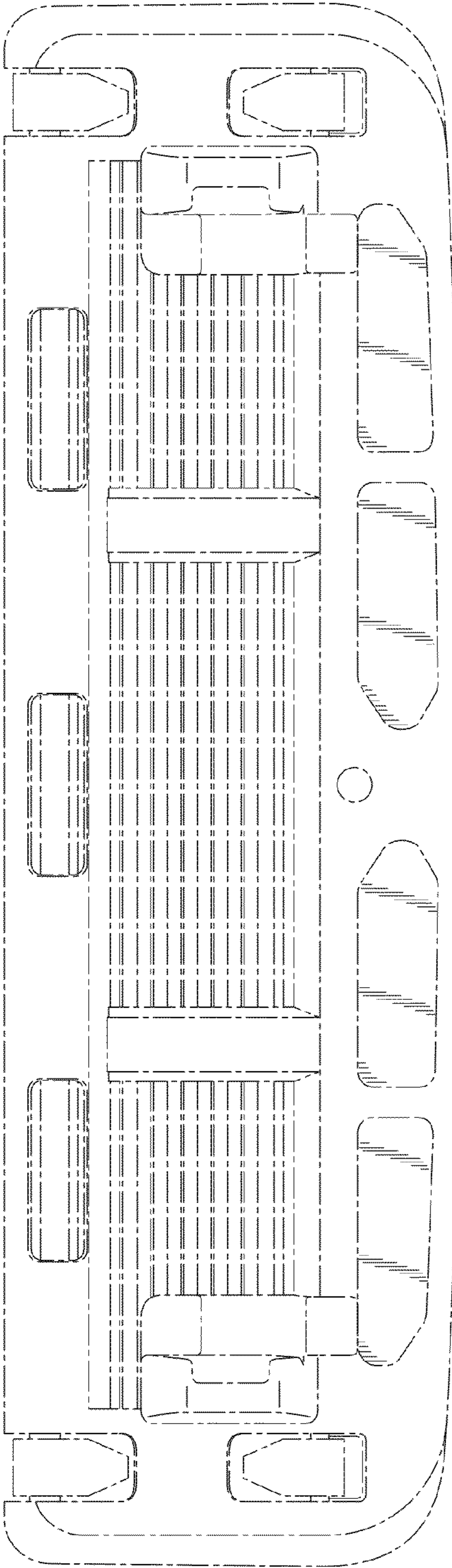

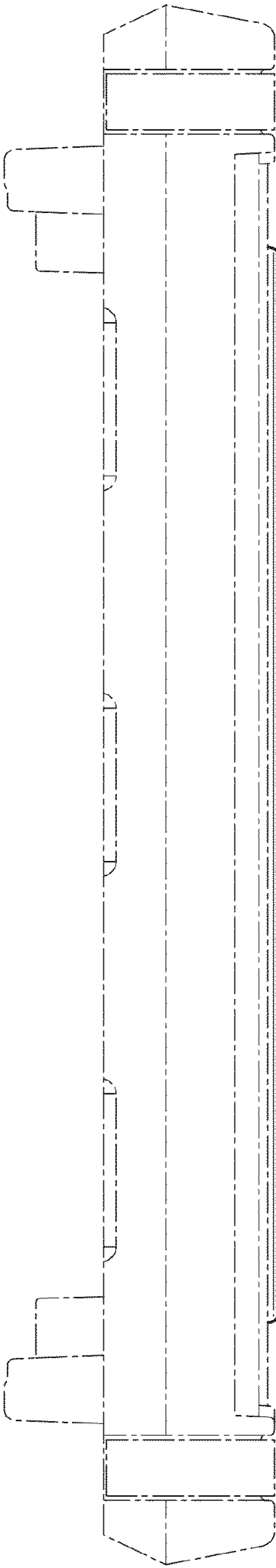
