(57) **CLAIM**

The ornamental design for a leash, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a leash showing our new design;
 FIG. 2 is a second top right perspective view thereof;
 FIG. 3 is a bottom left perspective view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a perspective view similar to FIG. 2 and rotated clockwise by 90 degrees with respect thereto;
 FIG. 6 is a perspective view similar to FIG. 5 and rotated clockwise by 180 degrees with respect thereto; and,
 FIG. 7 left side perspective view with the strap portion in a fully extended condition and shown coiled about itself.

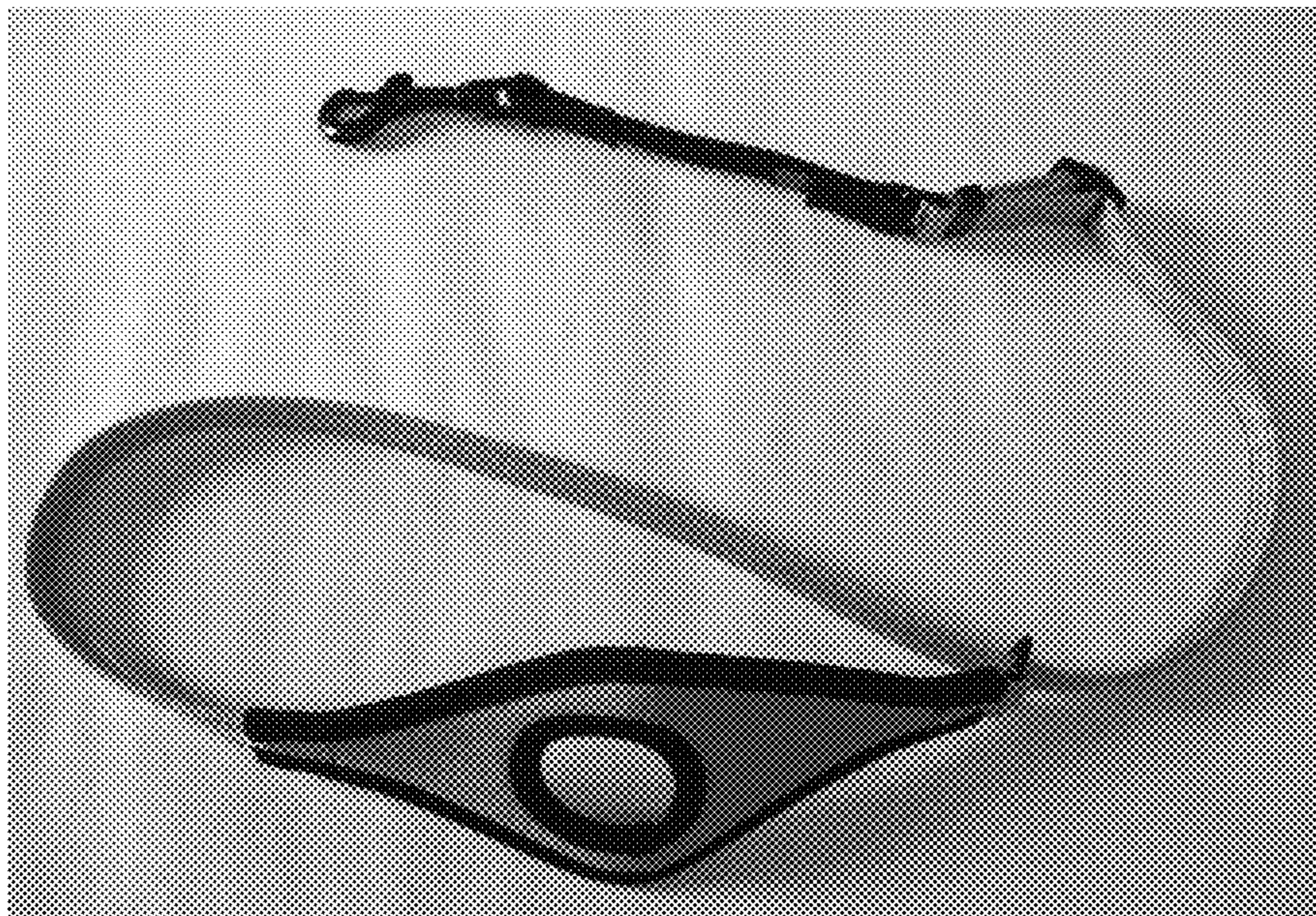

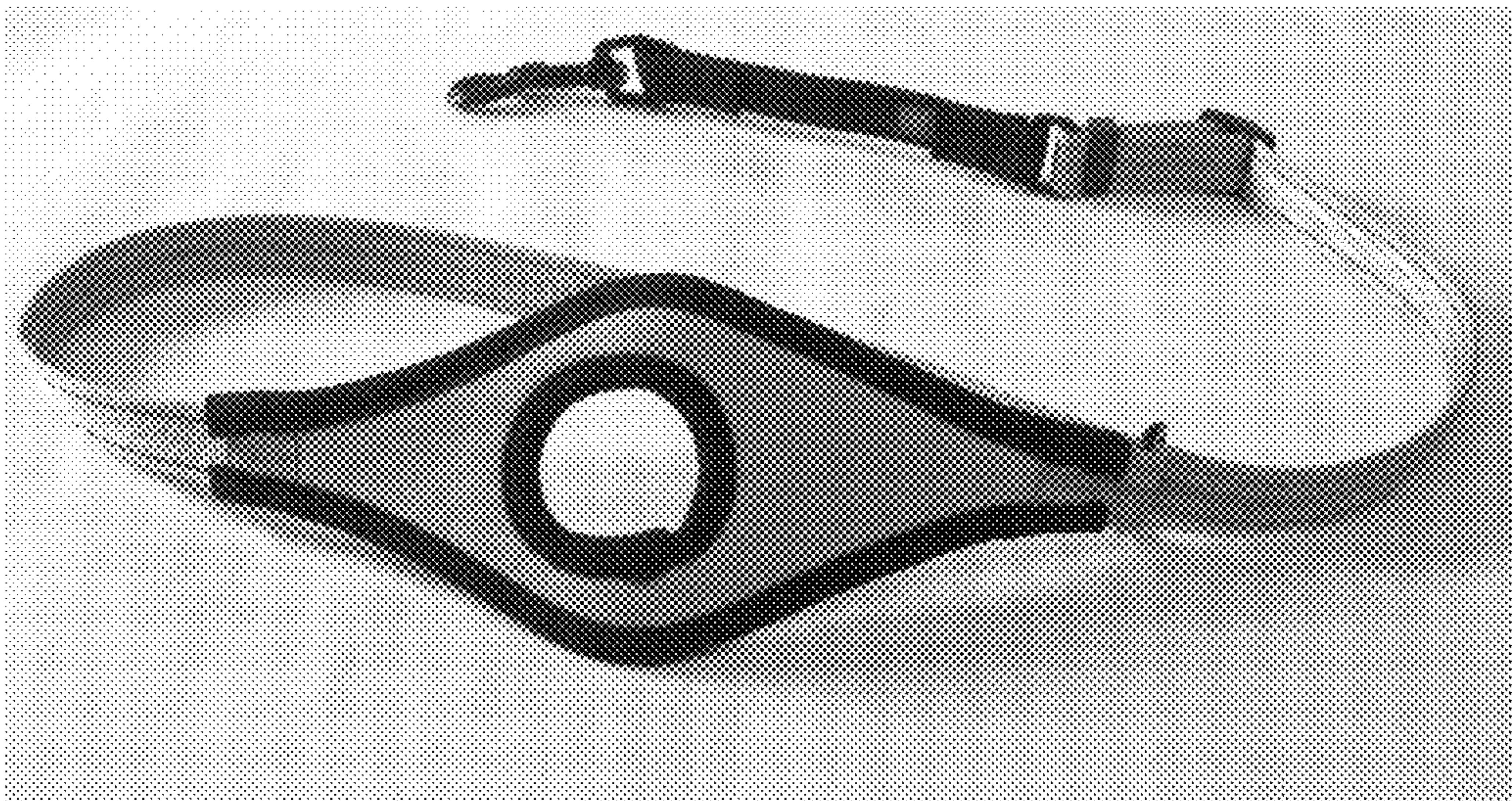

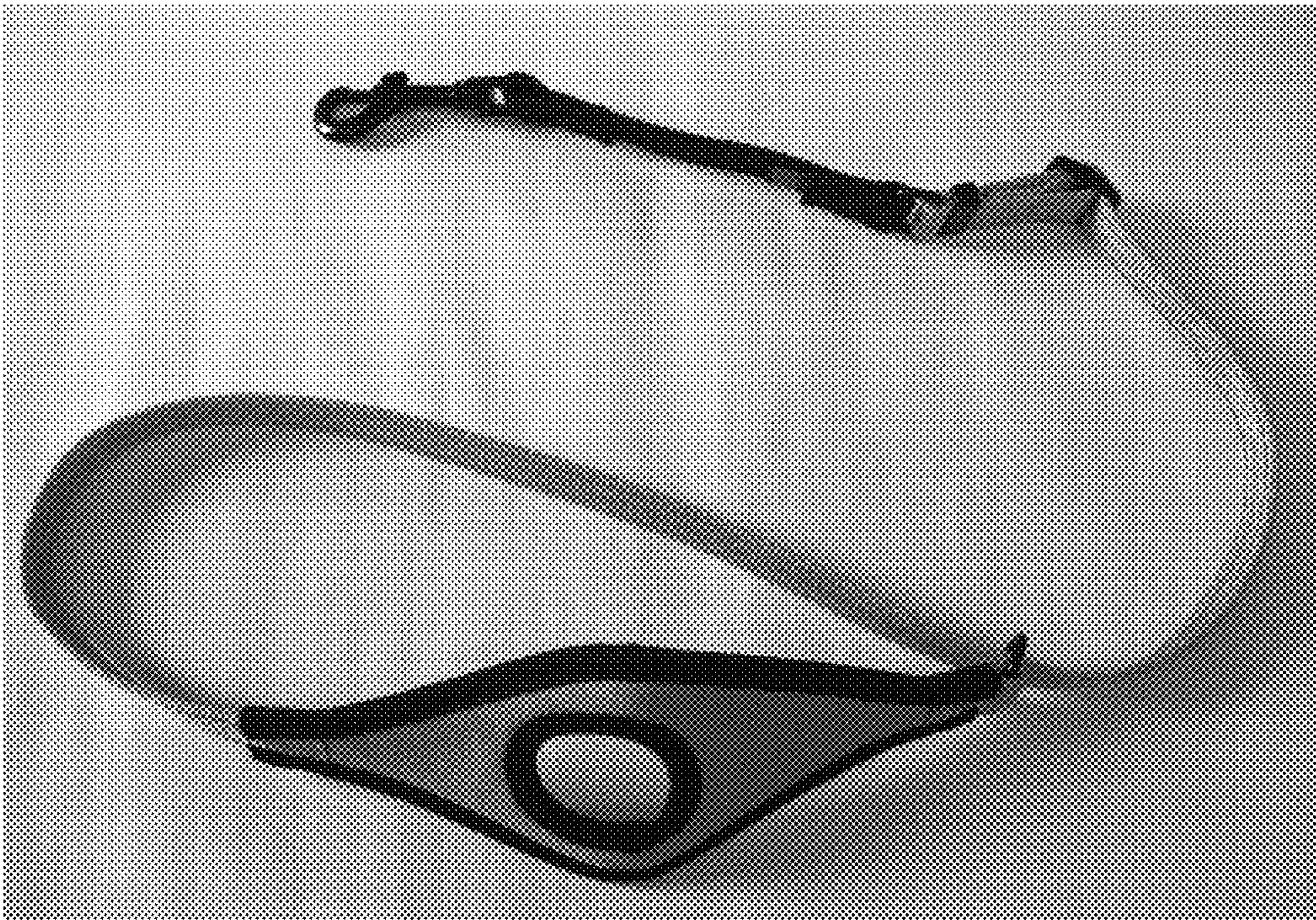

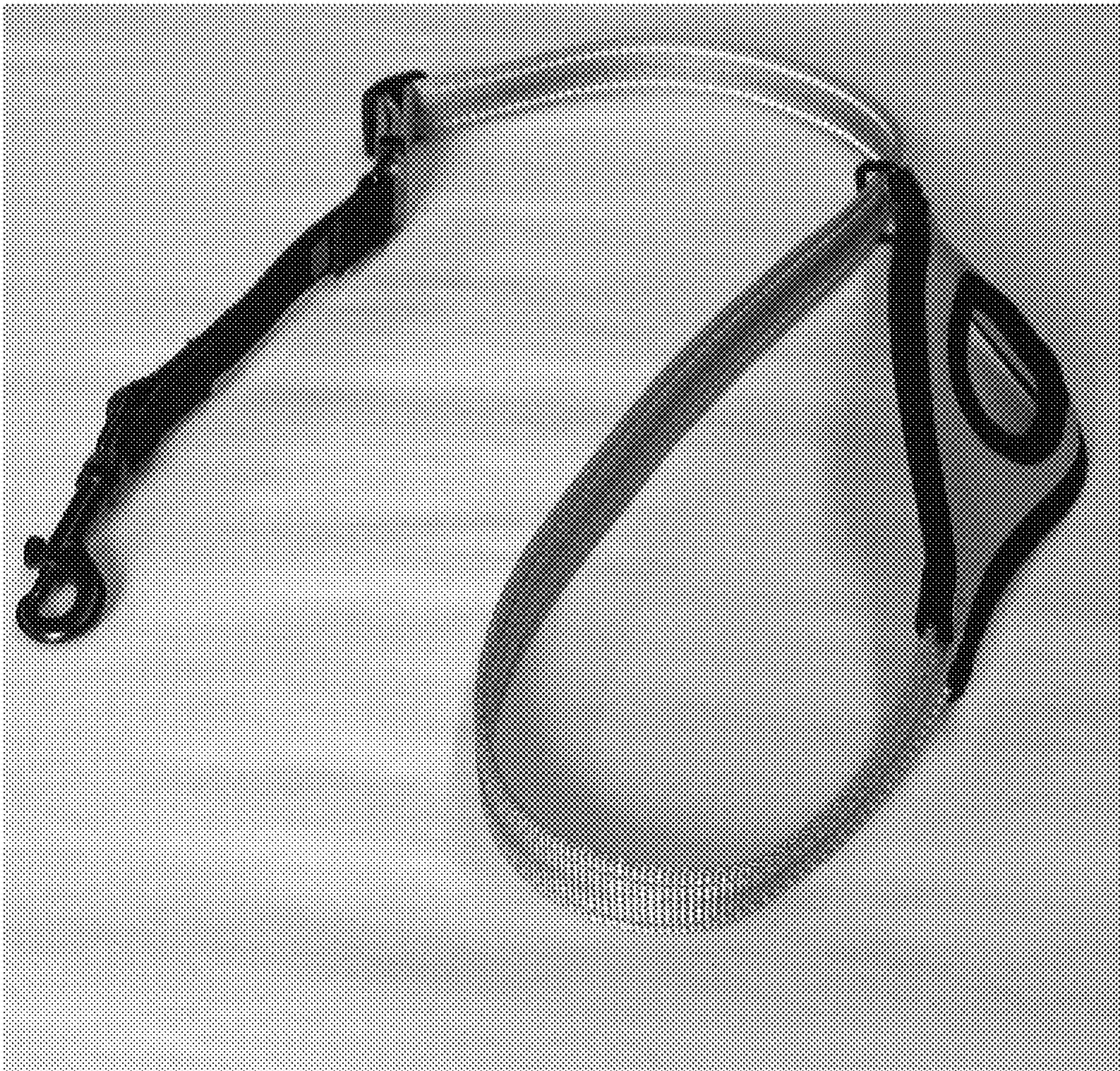

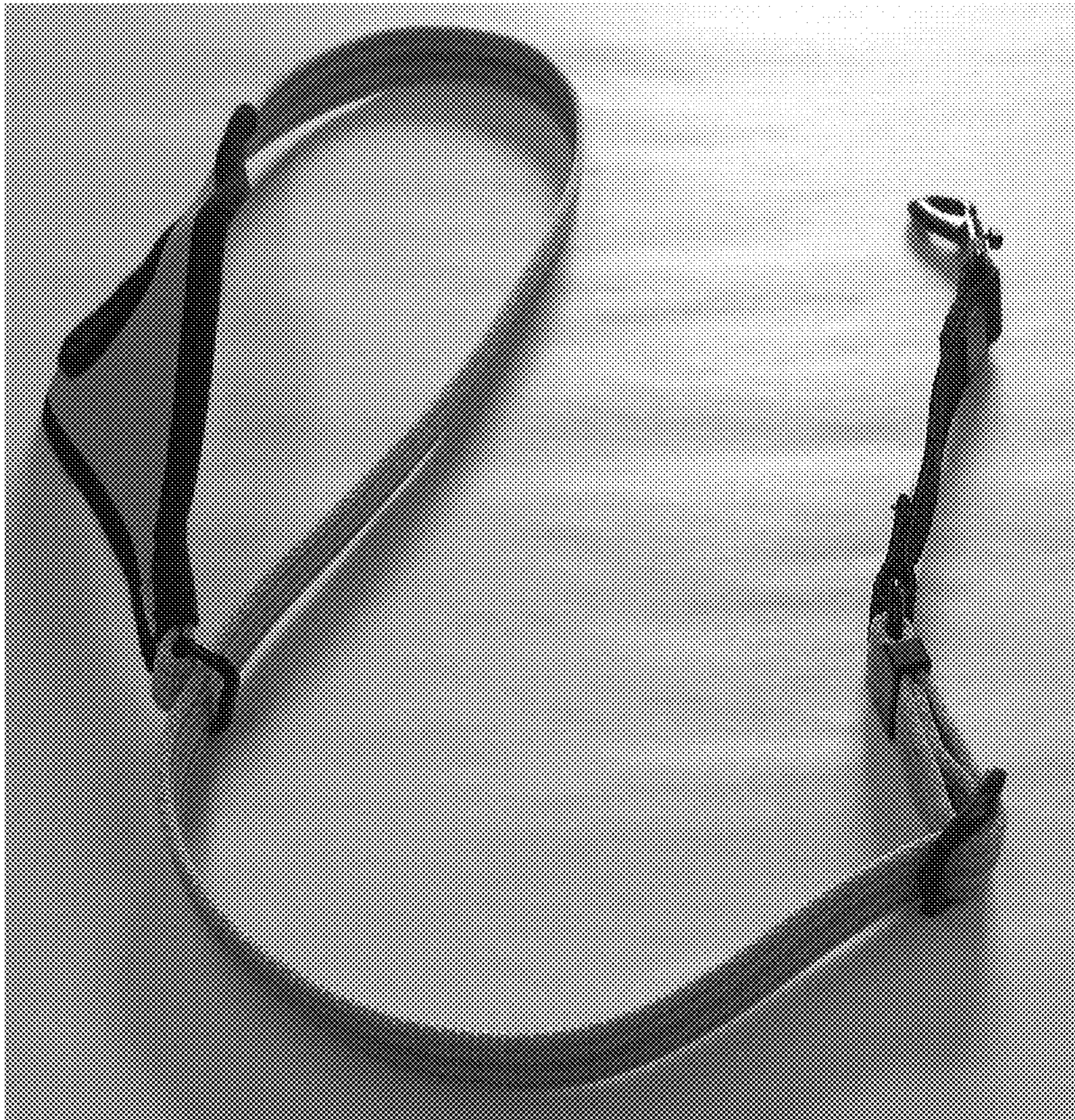
