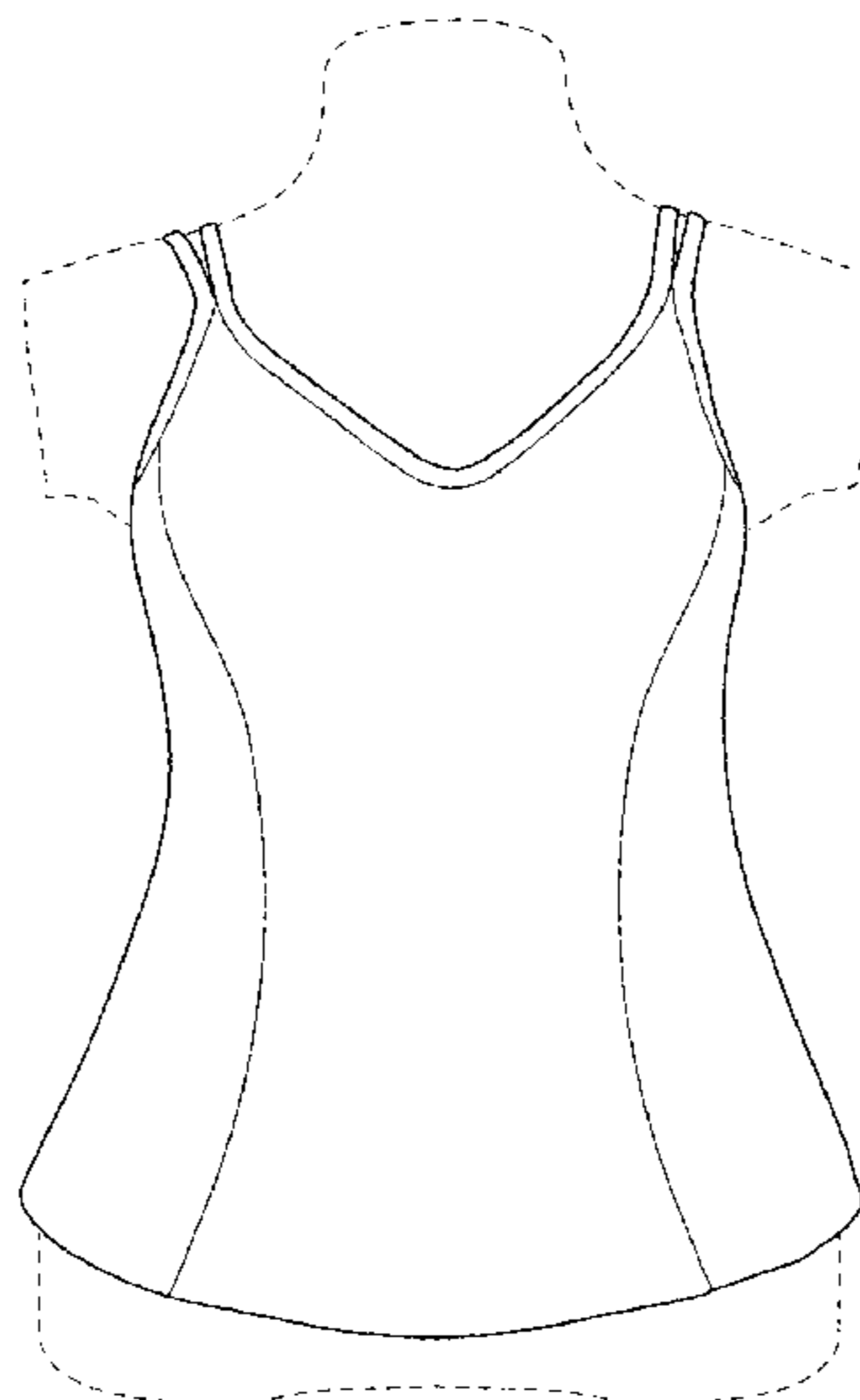
(57) **CLAIM**
I claim the ornamental design for a swimsuit top, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit top on a model showing my new design.
FIG. 2 is a rear view of the swimsuit top of FIG. 1.
FIG. 3 is a right-side view of the swimsuit top of FIG. 1.
FIG. 4 is a left-side view of the swimsuit top of FIG. 1.
FIG. 5 is a front view of the swimsuit top of FIG. 1 in an unworn state; and,
FIG. 6 is a rear view of the swimsuit top of FIG. 1 in an unworn state.
The evenly spaced broken lines in the figures illustrate environmental subject matter and form no part of the claim.

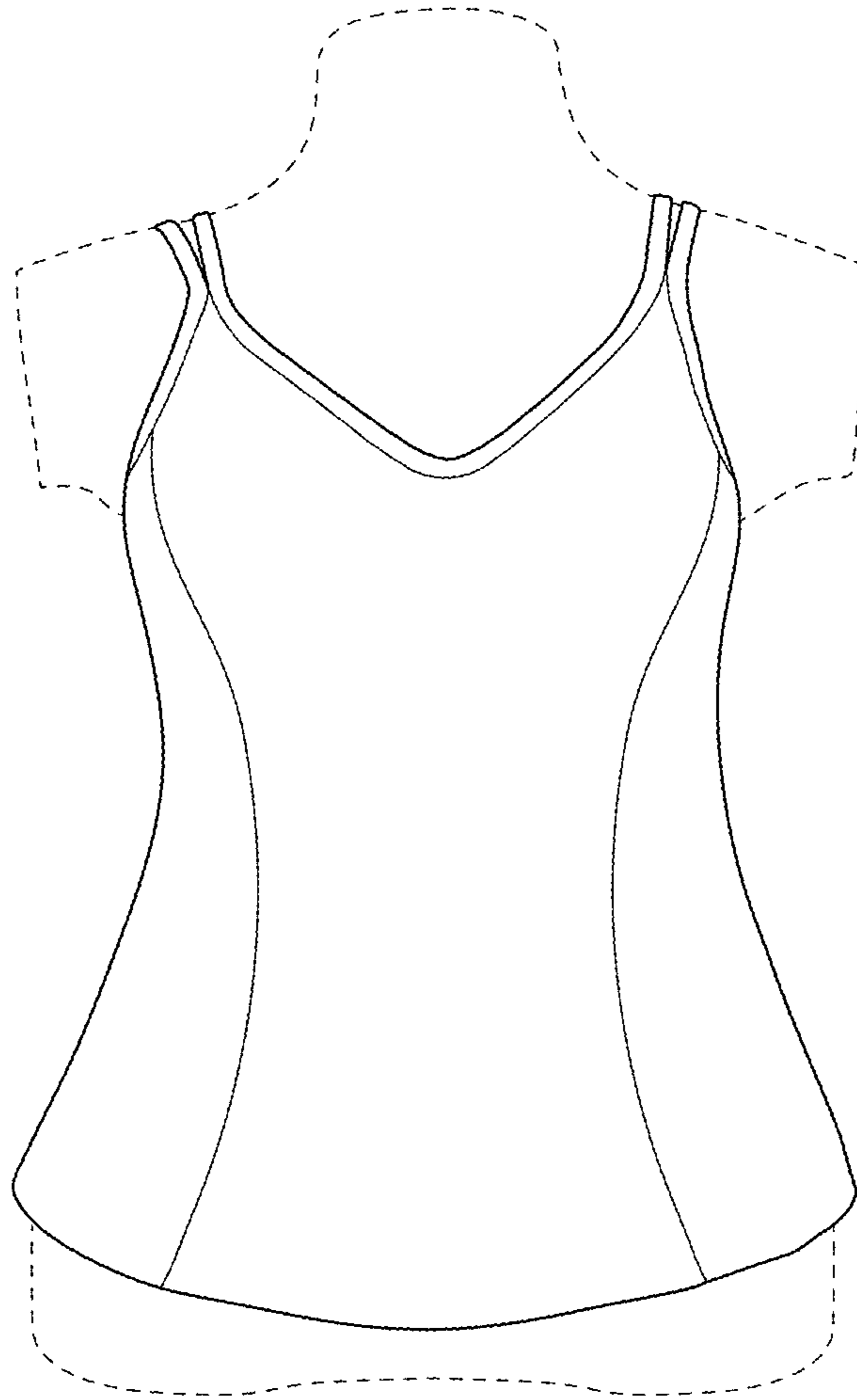

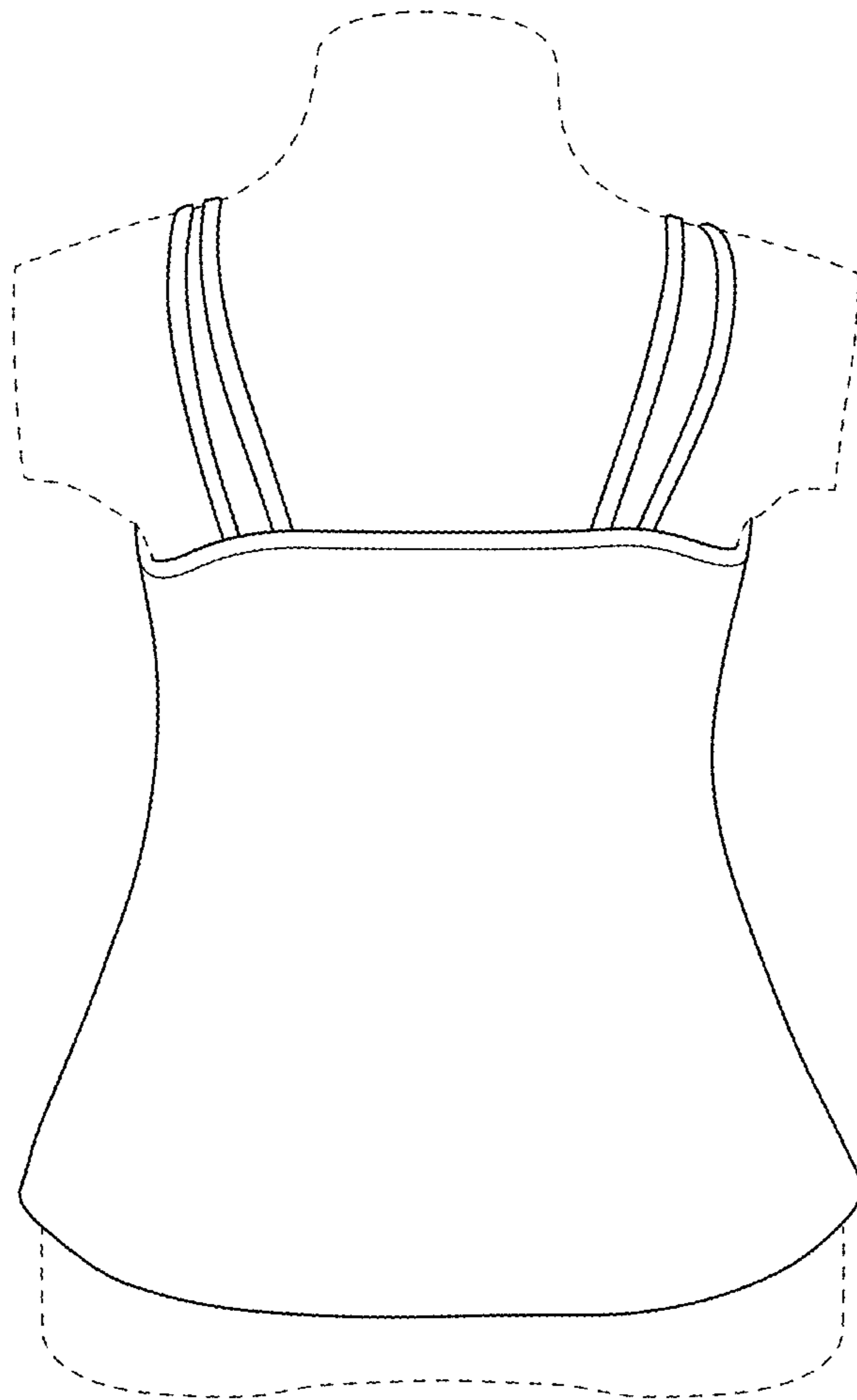

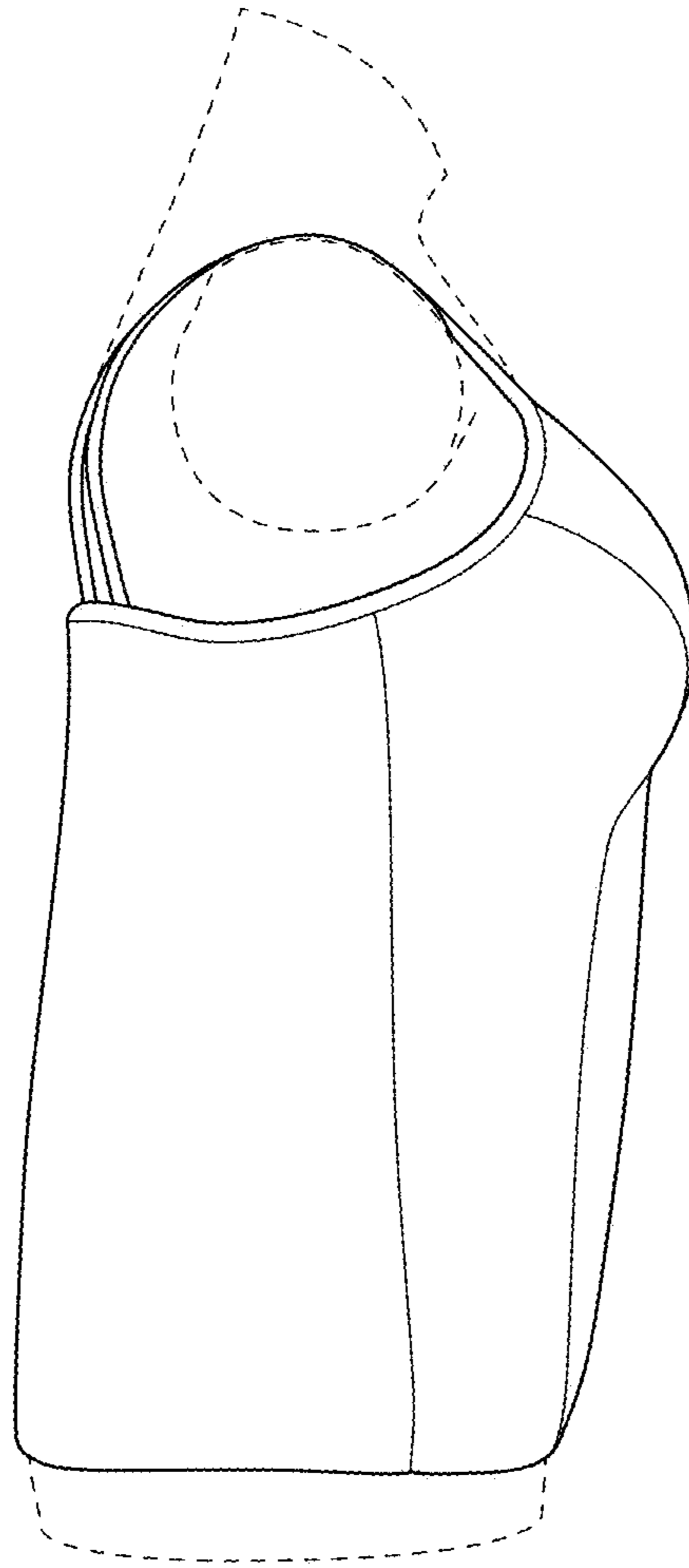

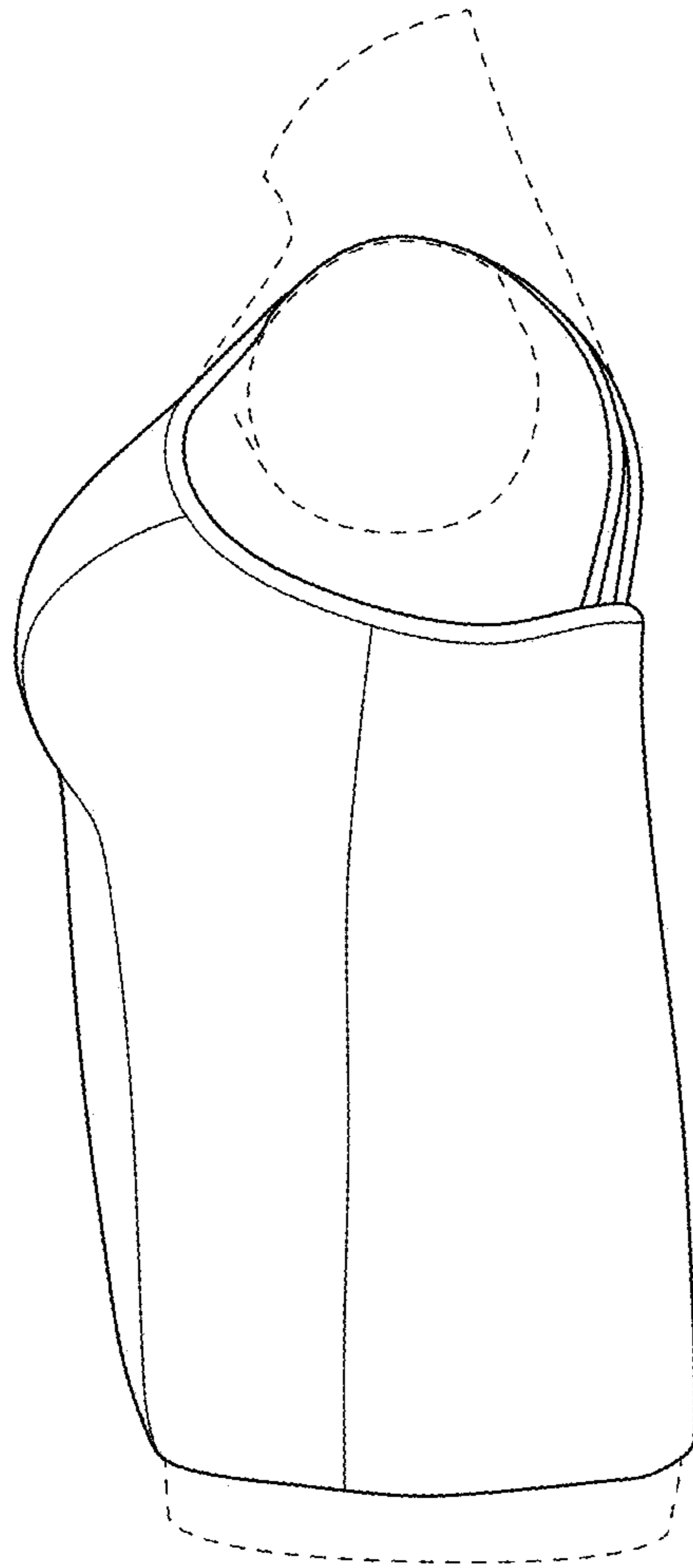

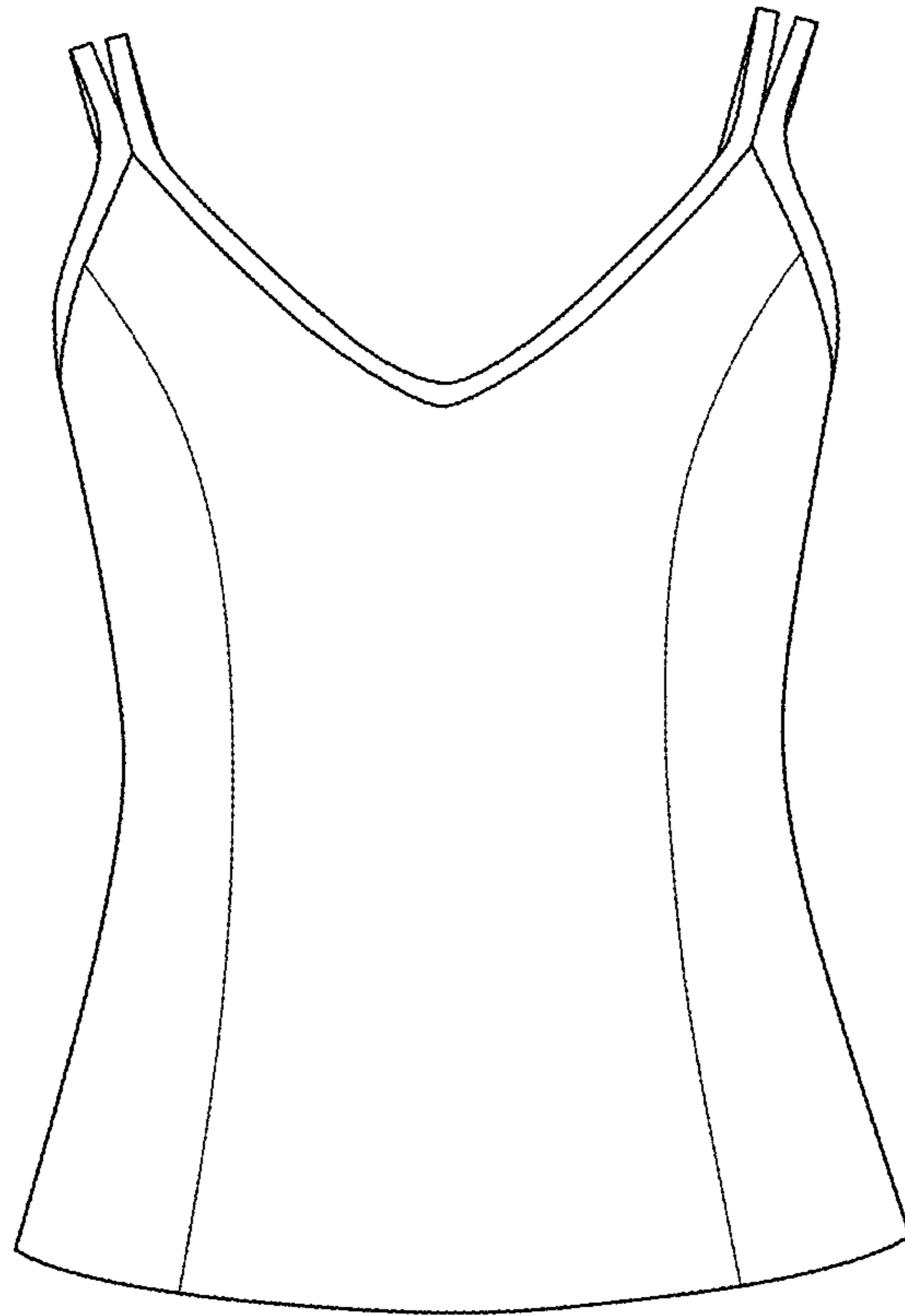

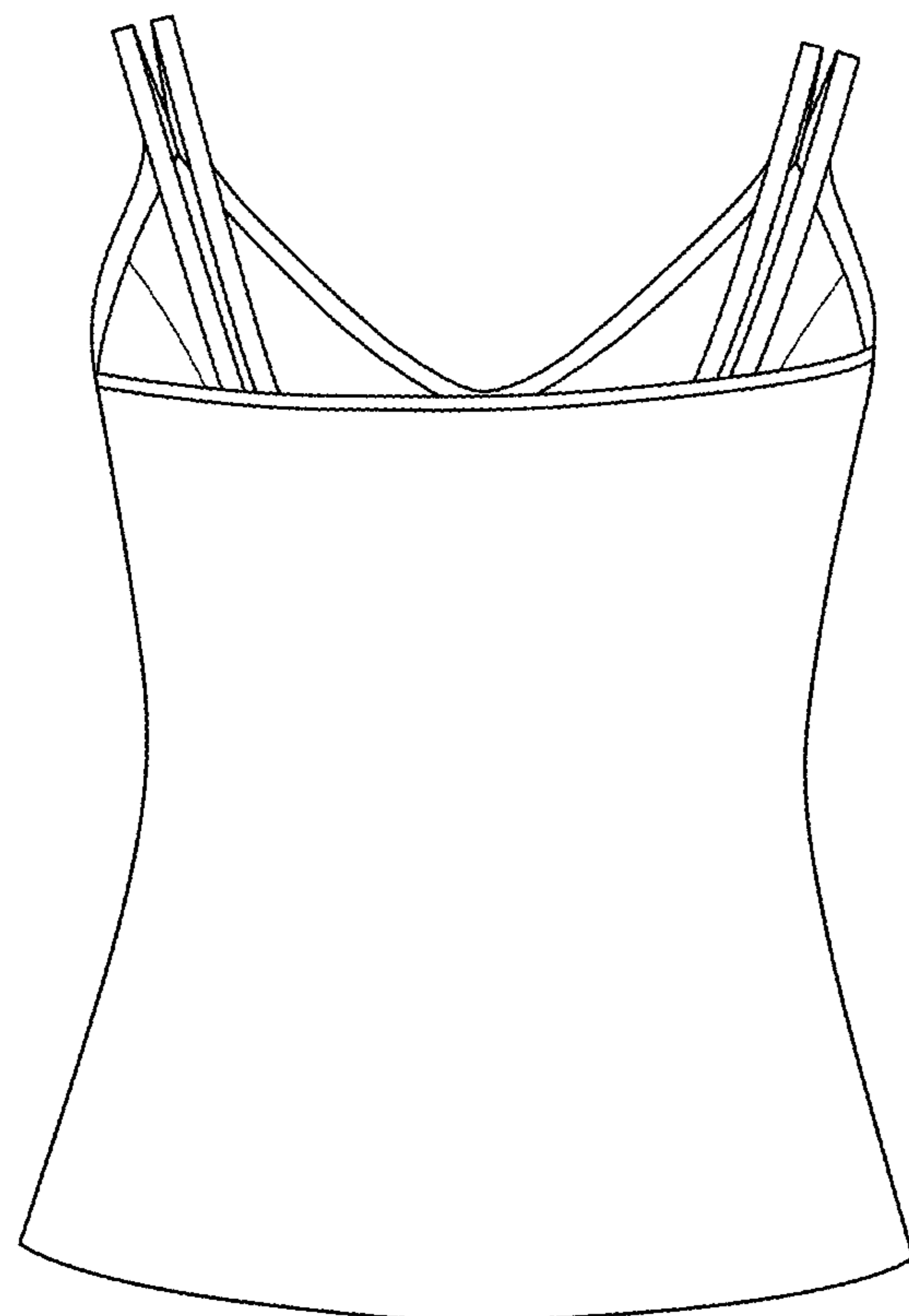
