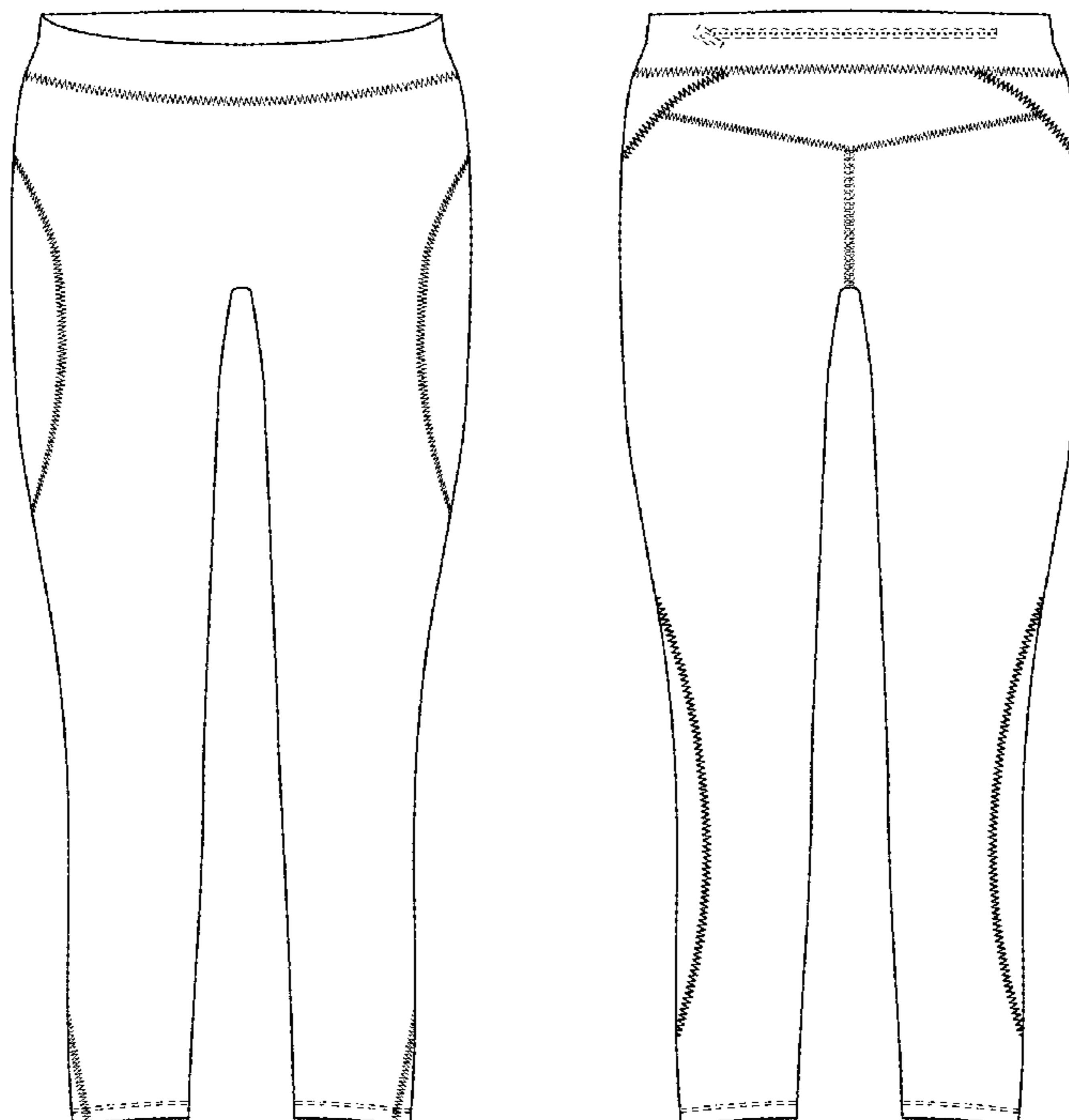
(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front view of pants according to the invention; FIG. 2 is a rear view thereof; and, FIG. 3 is a left side view thereof, showing the pant legs bent; the undisclosed right side view being a mirror image thereof. The broken lines represent the portions of the pants that form no part of the claimed design.

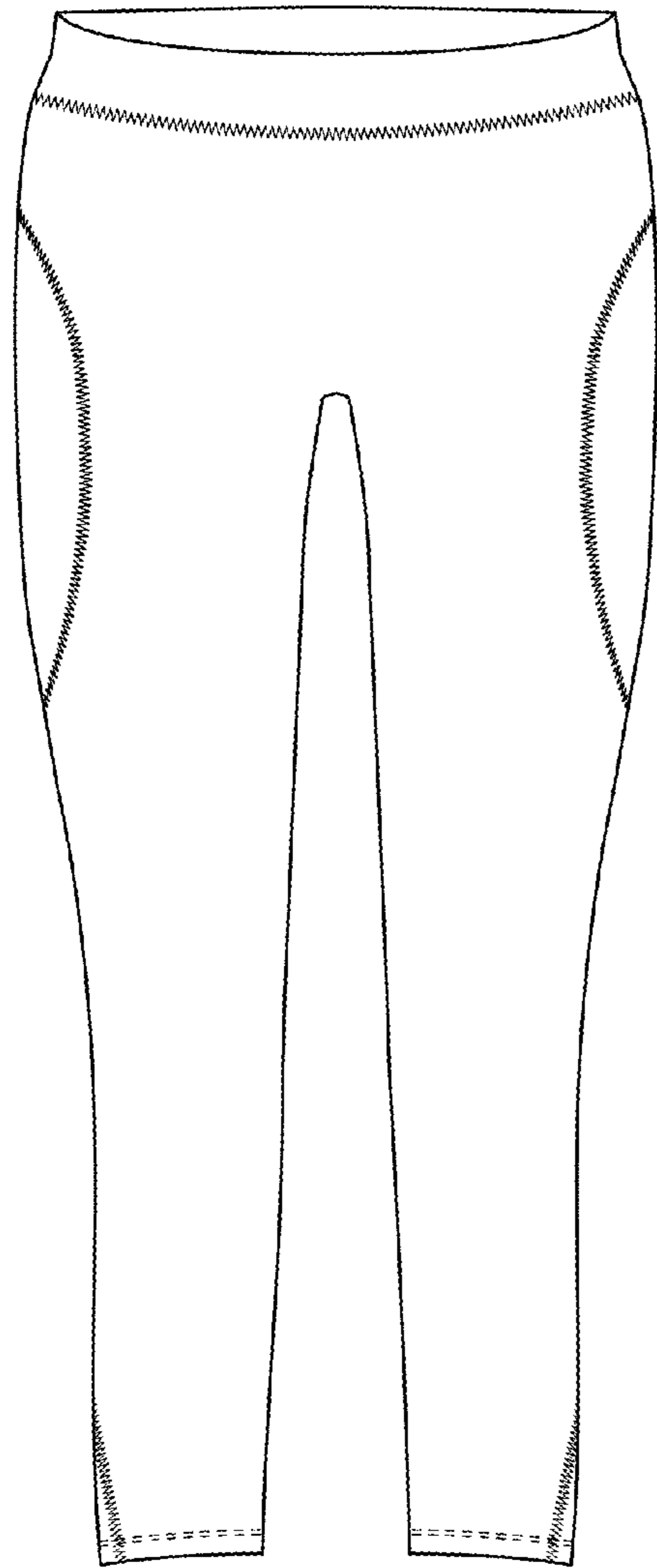

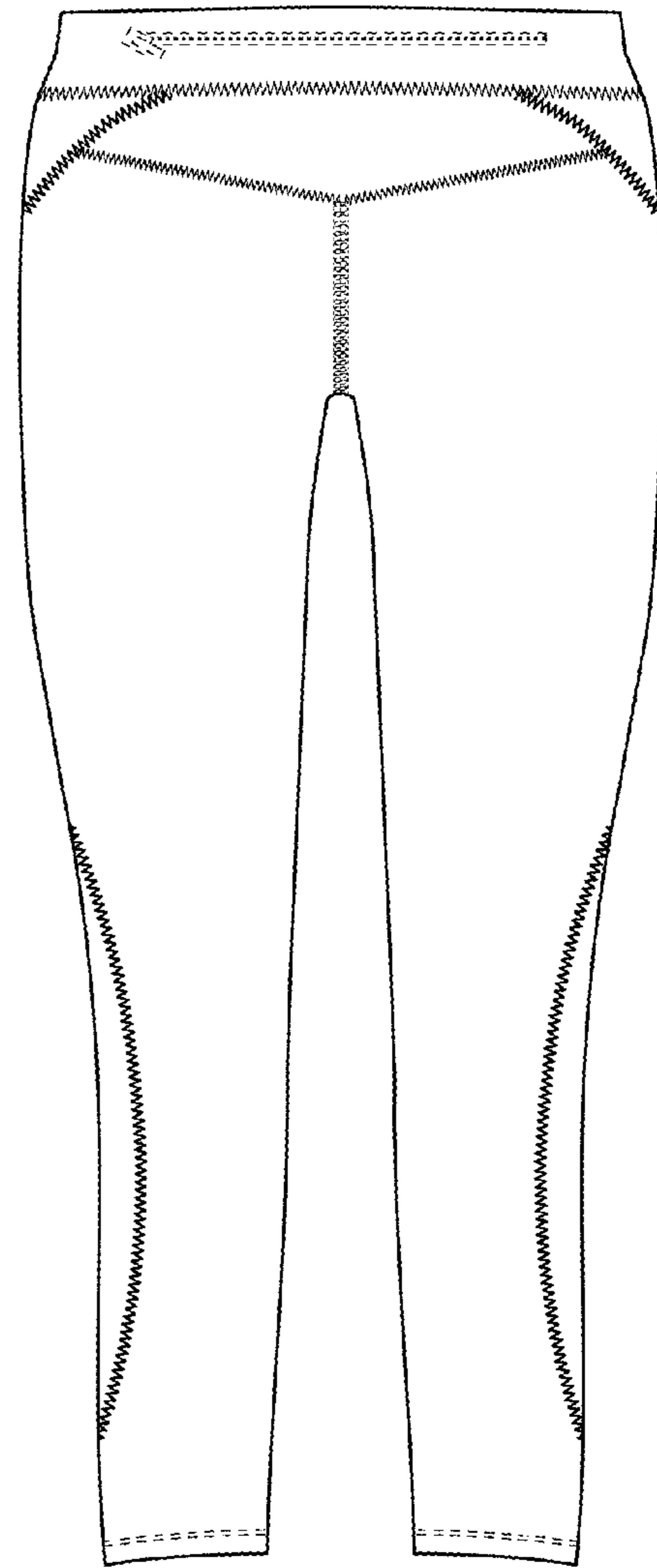

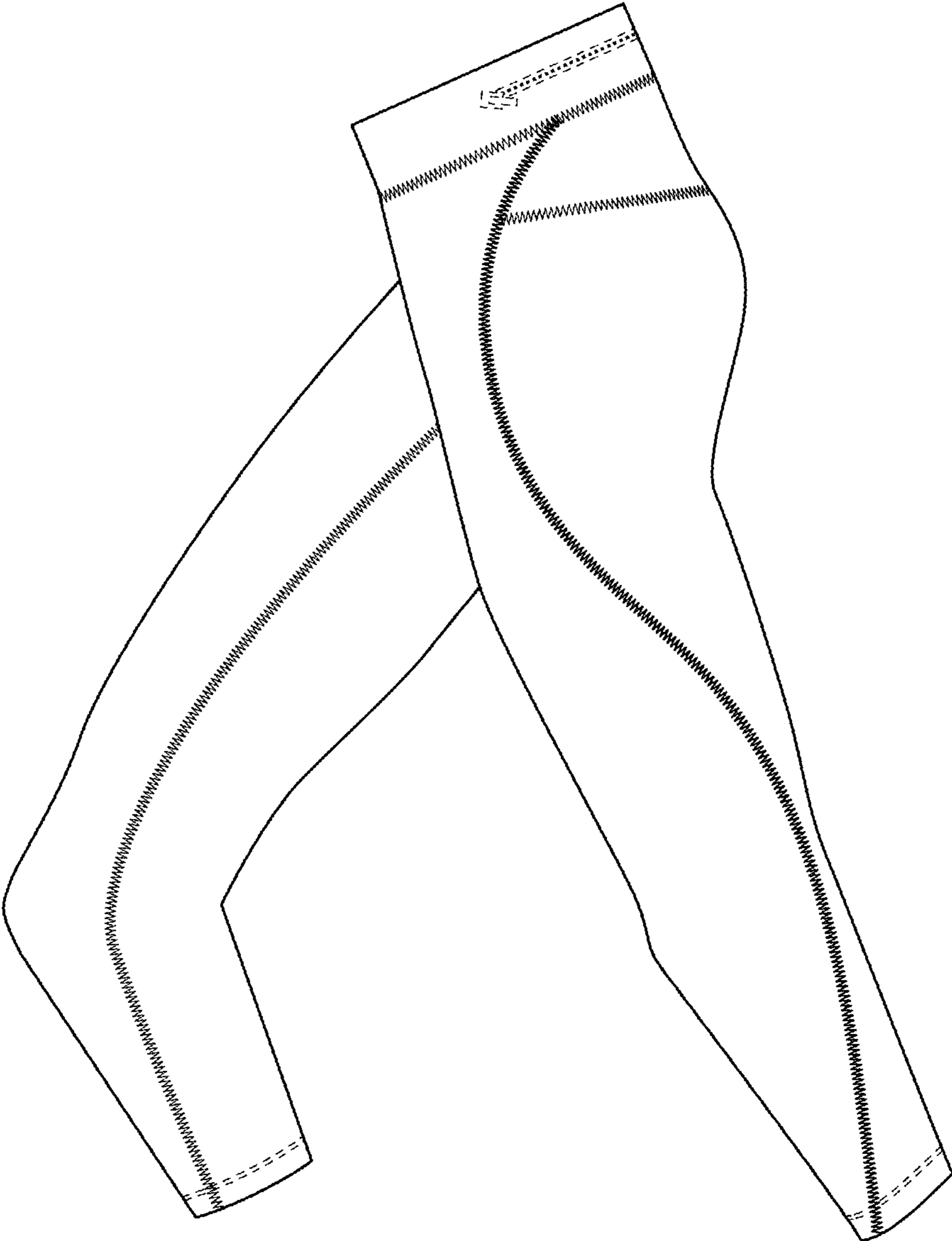
