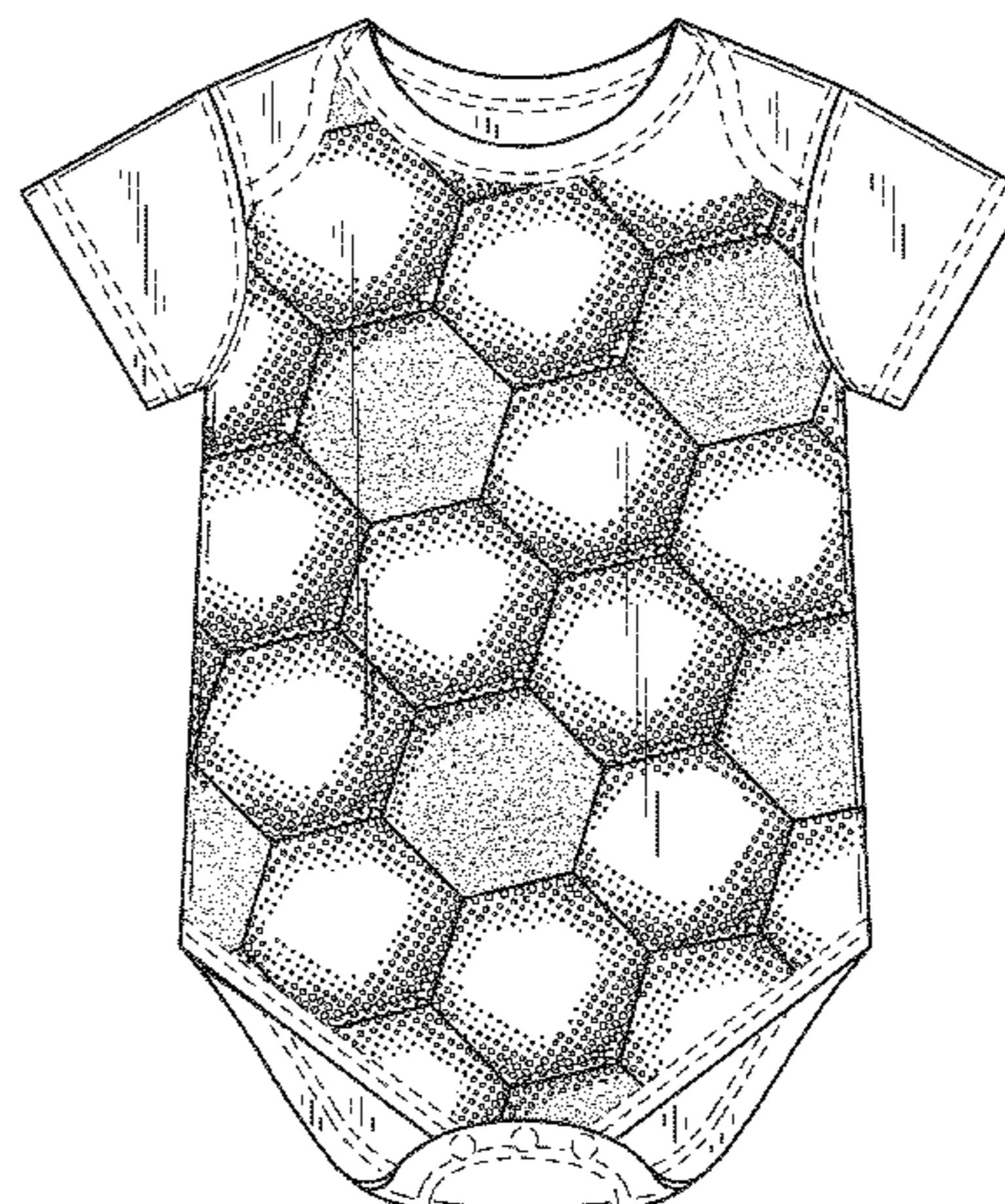
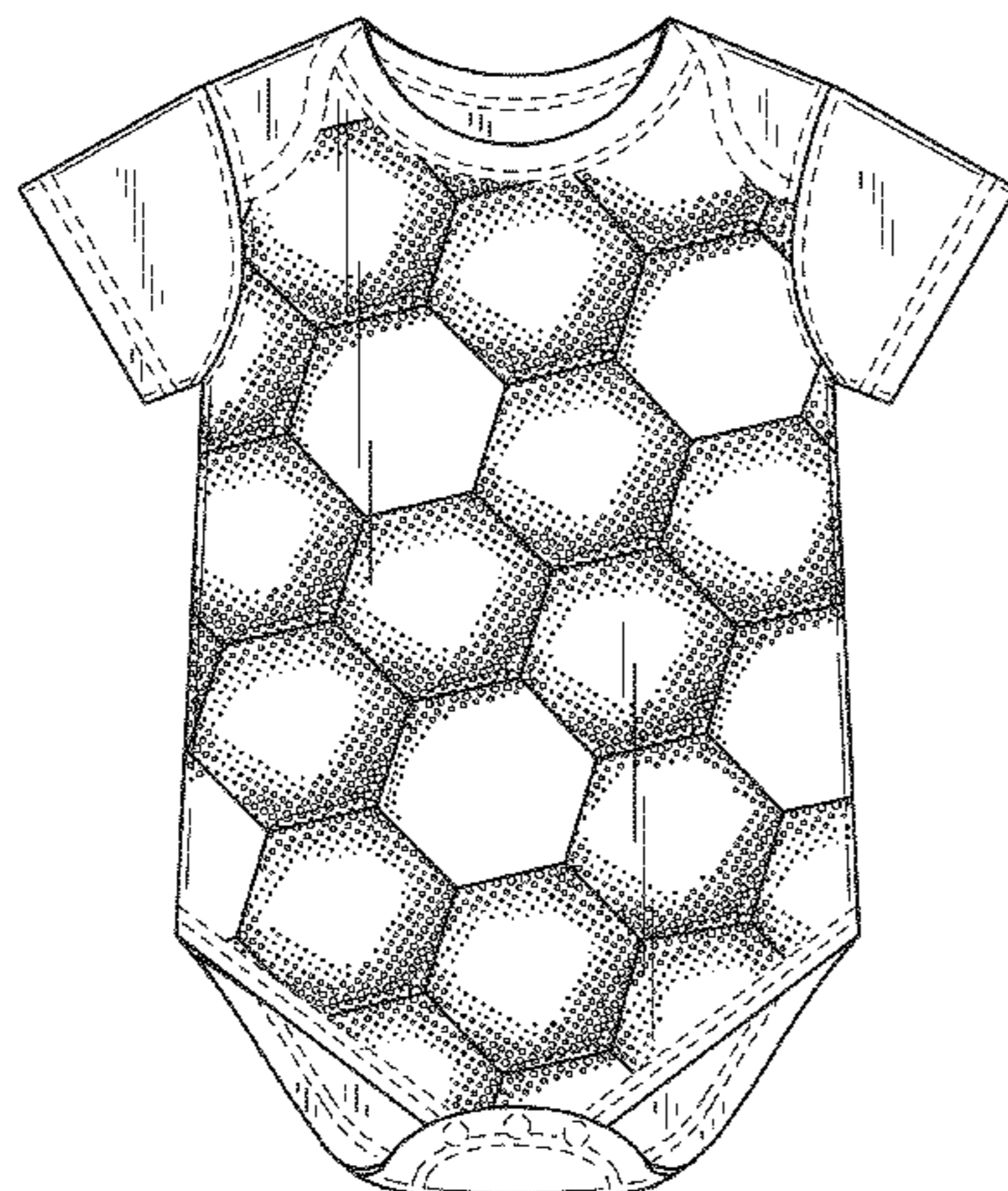
(57) **CLAIM**

The ornamental design for a soccer ball infant bodysuit, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of an infant bodysuit, showing one embodiment of our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is an isometric view of an infant bodysuit, showing another embodiment of our new design, wherein the stippling indicates a solid dark shading in those segments where the stippling appears;  
FIG. 9 is a front view thereof, wherein the stippling indicates a solid dark shading in those segments where the stippling appears;  
FIG. 10 is a rear view thereof;  
FIG. 11 is a right side view thereof;  
FIG. 12 is a left side view thereof;  
FIG. 13 is a top plan view thereof; and,  
FIG. 14 is a bottom plan view thereof.

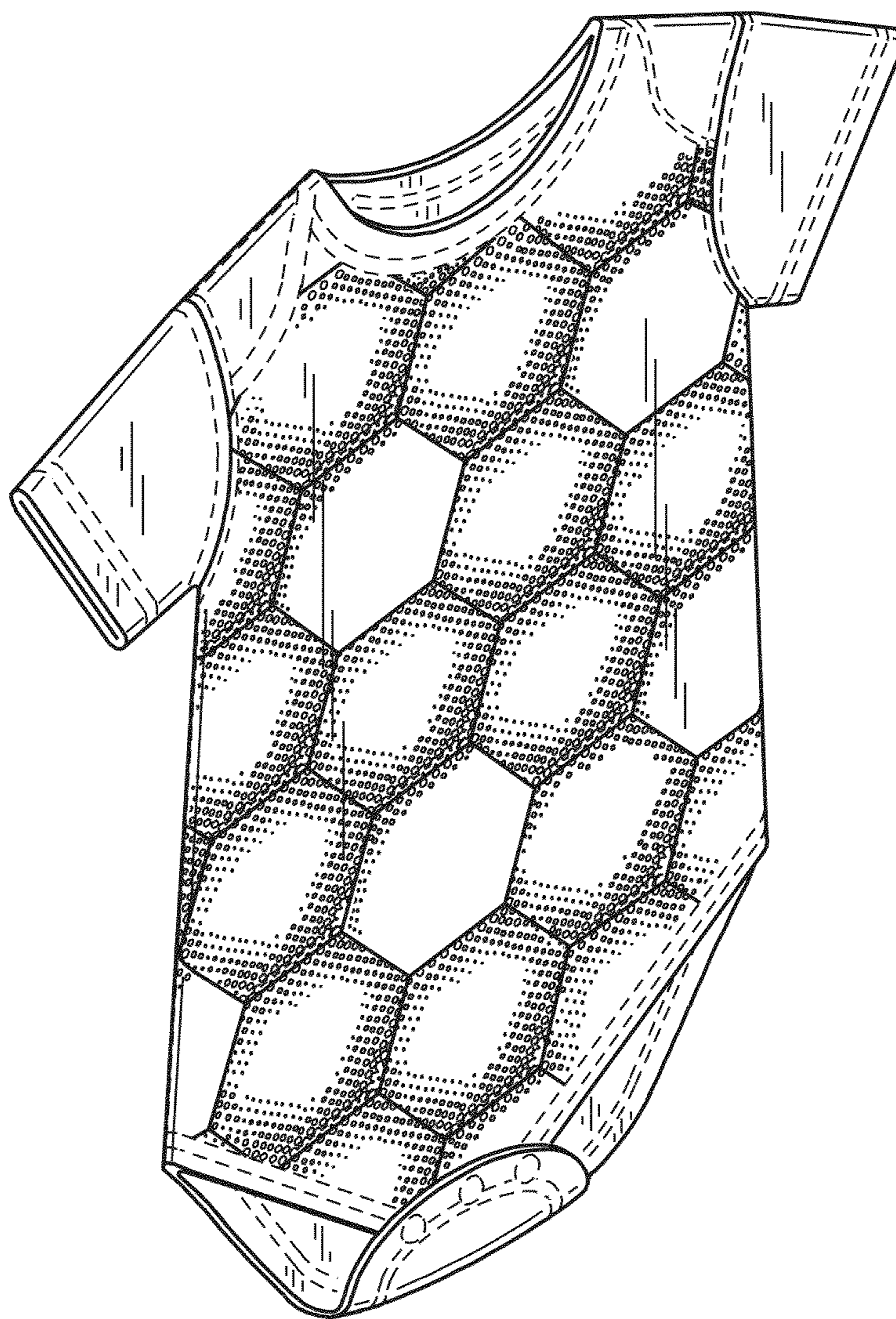

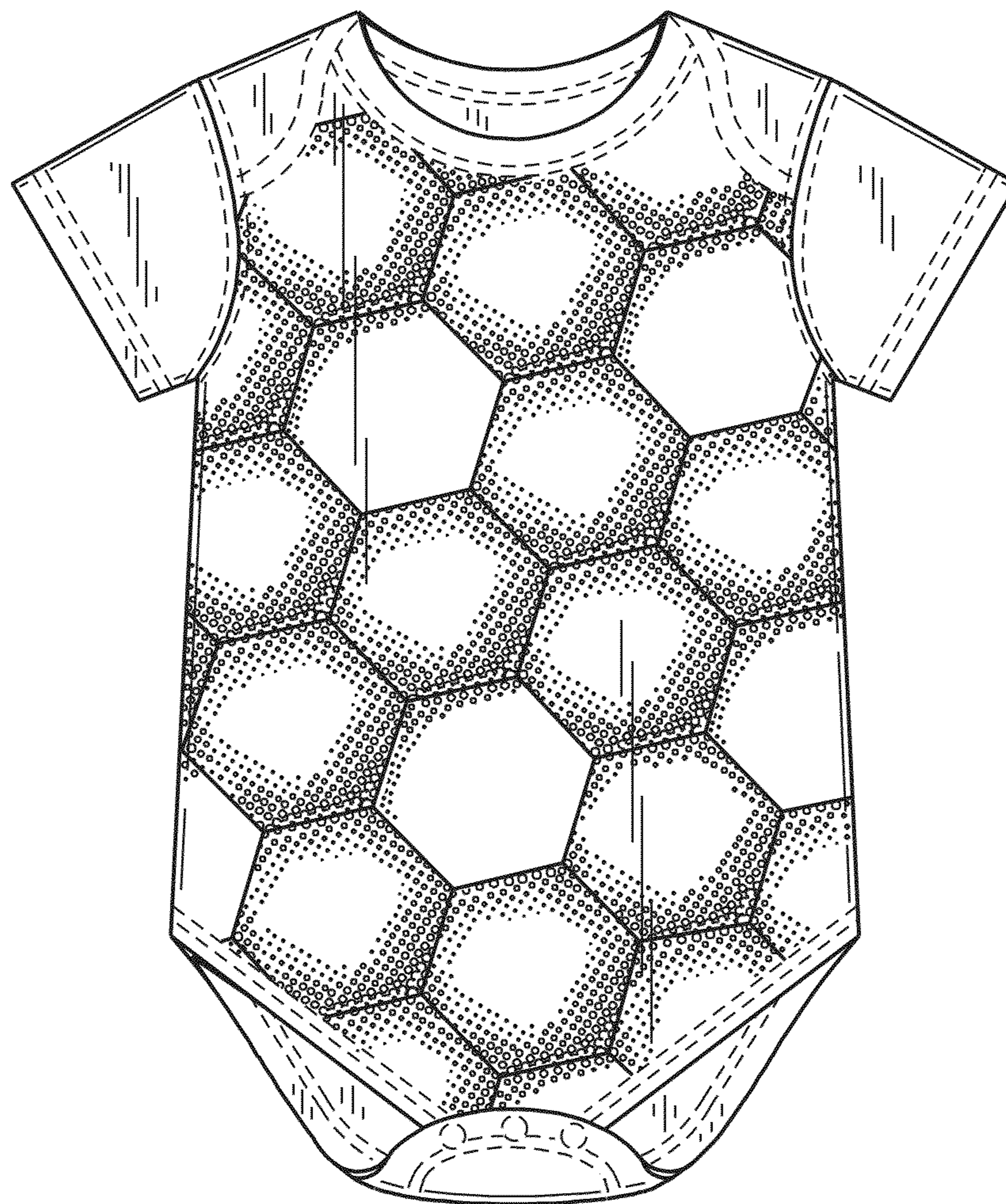

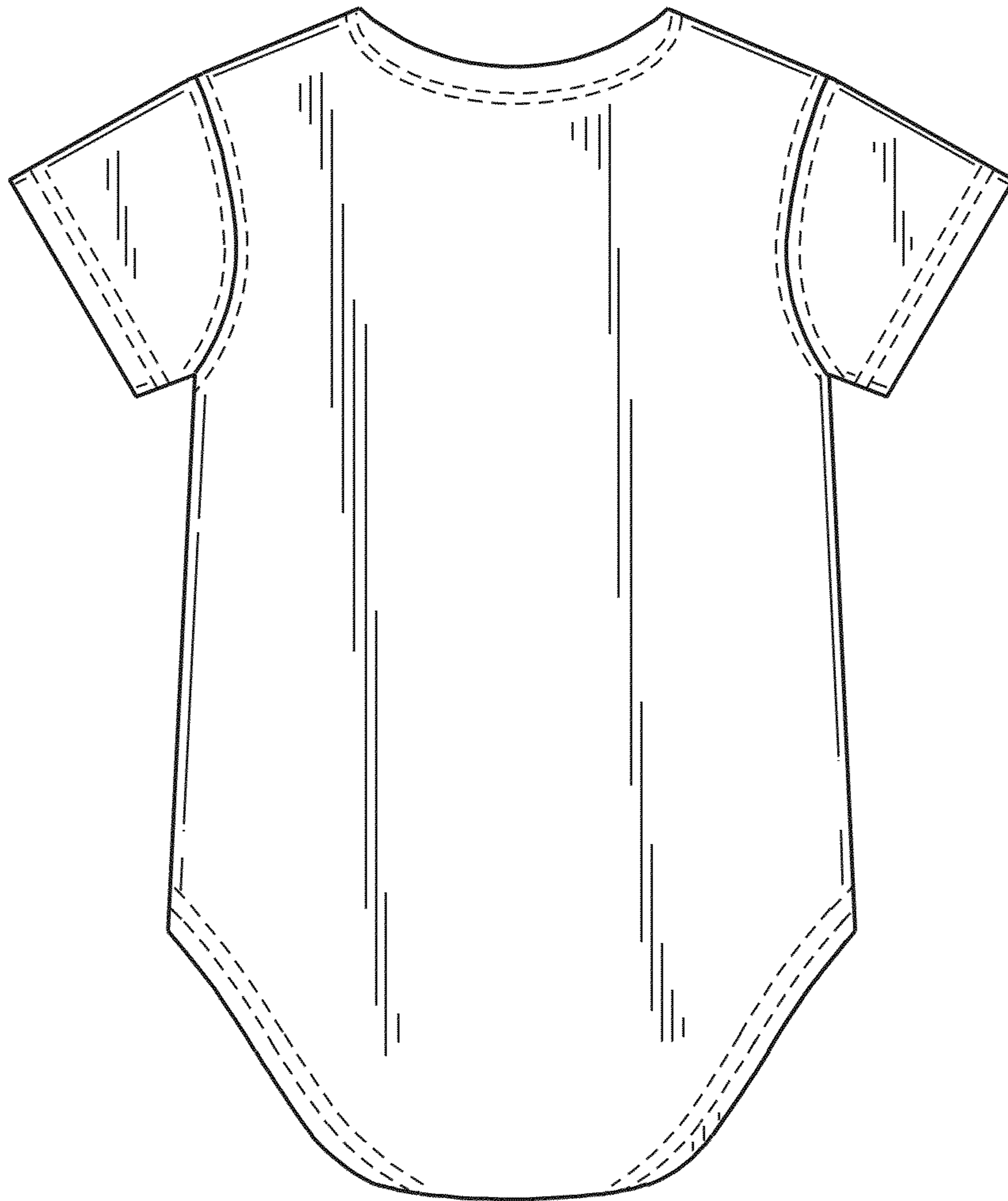

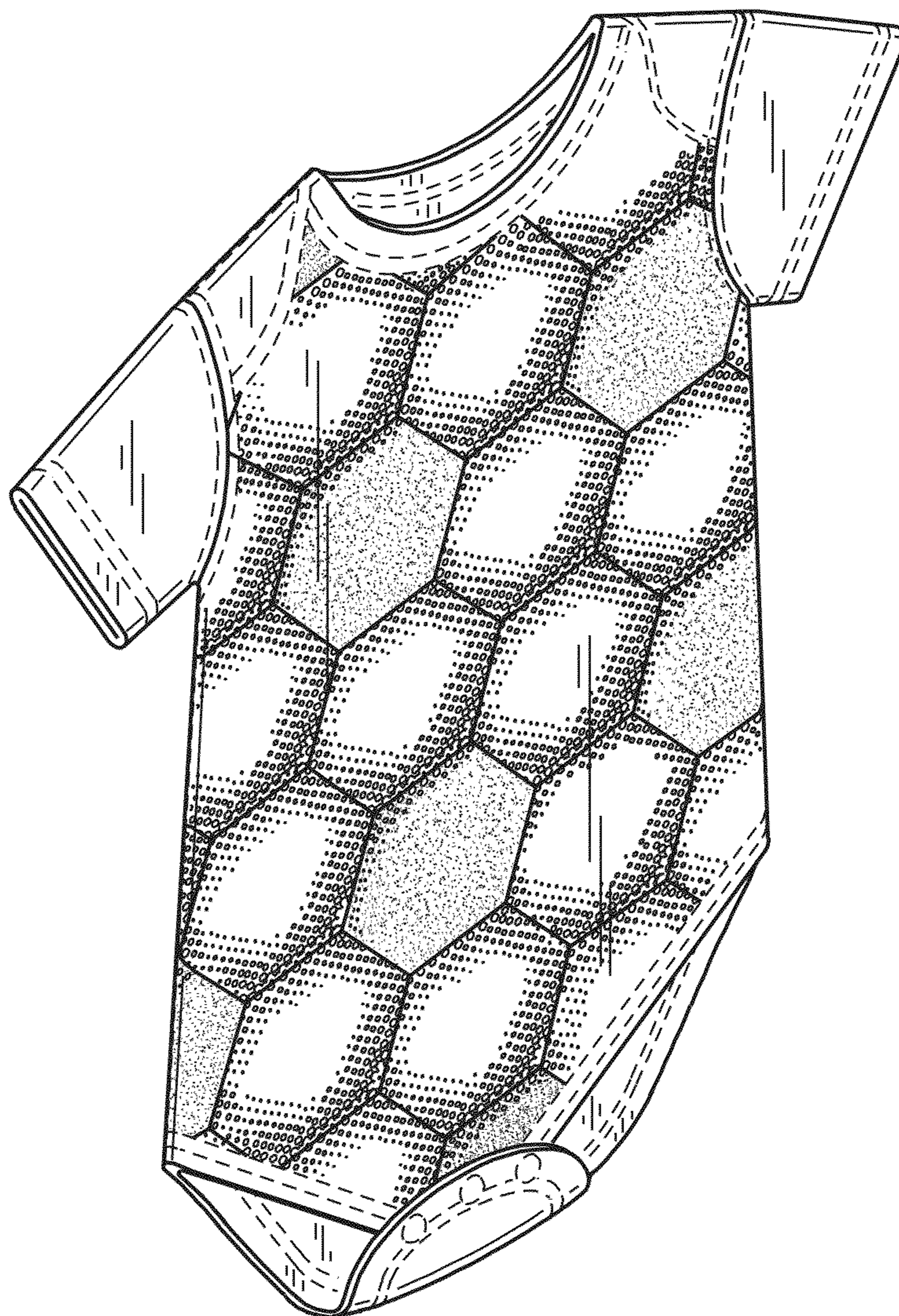

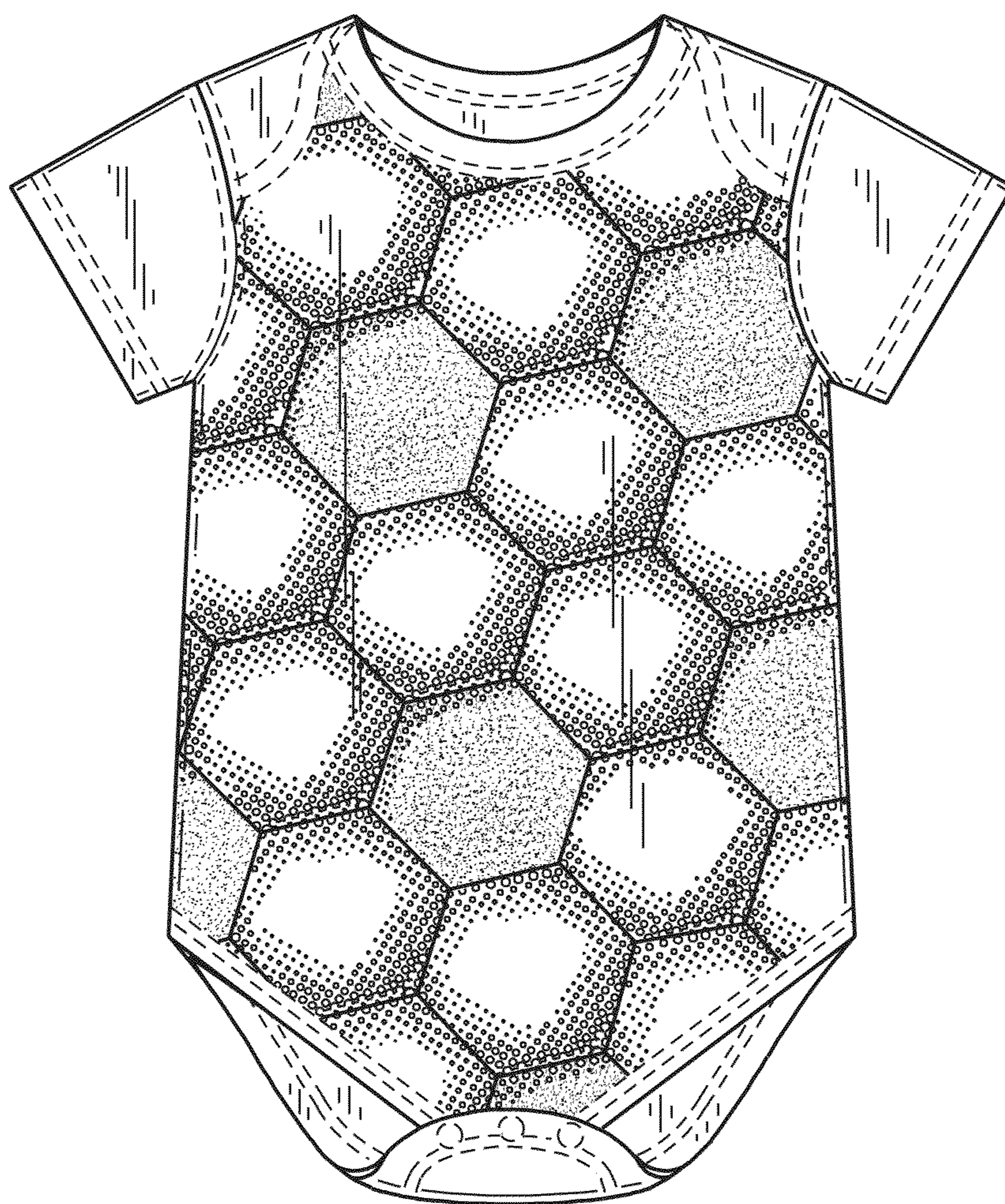

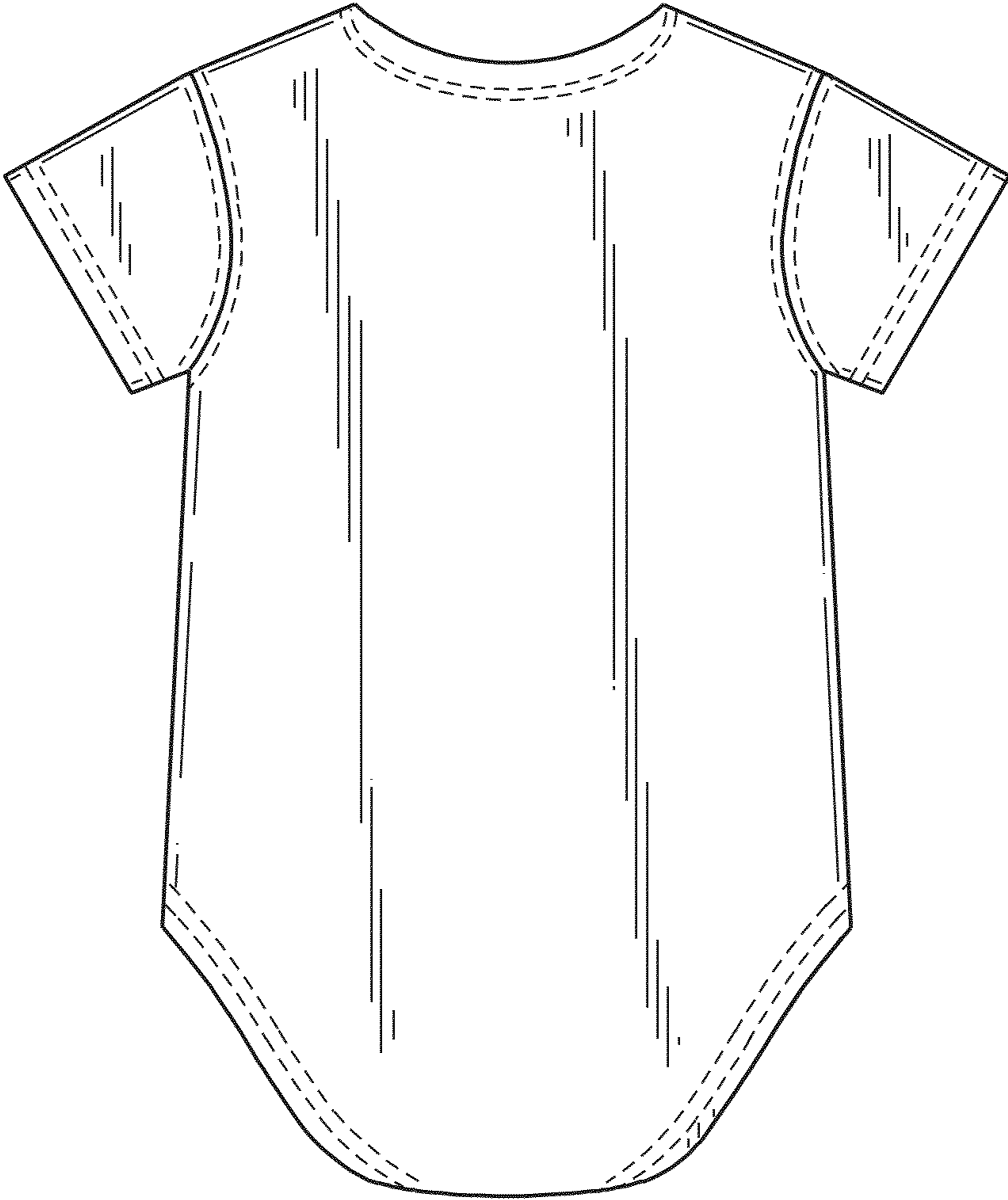

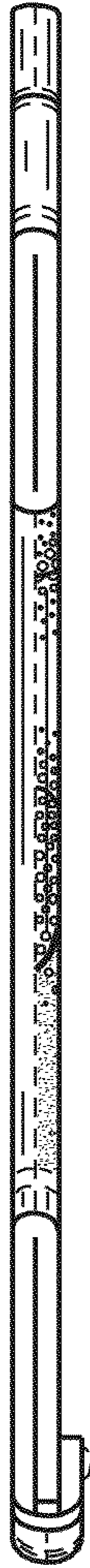
