The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

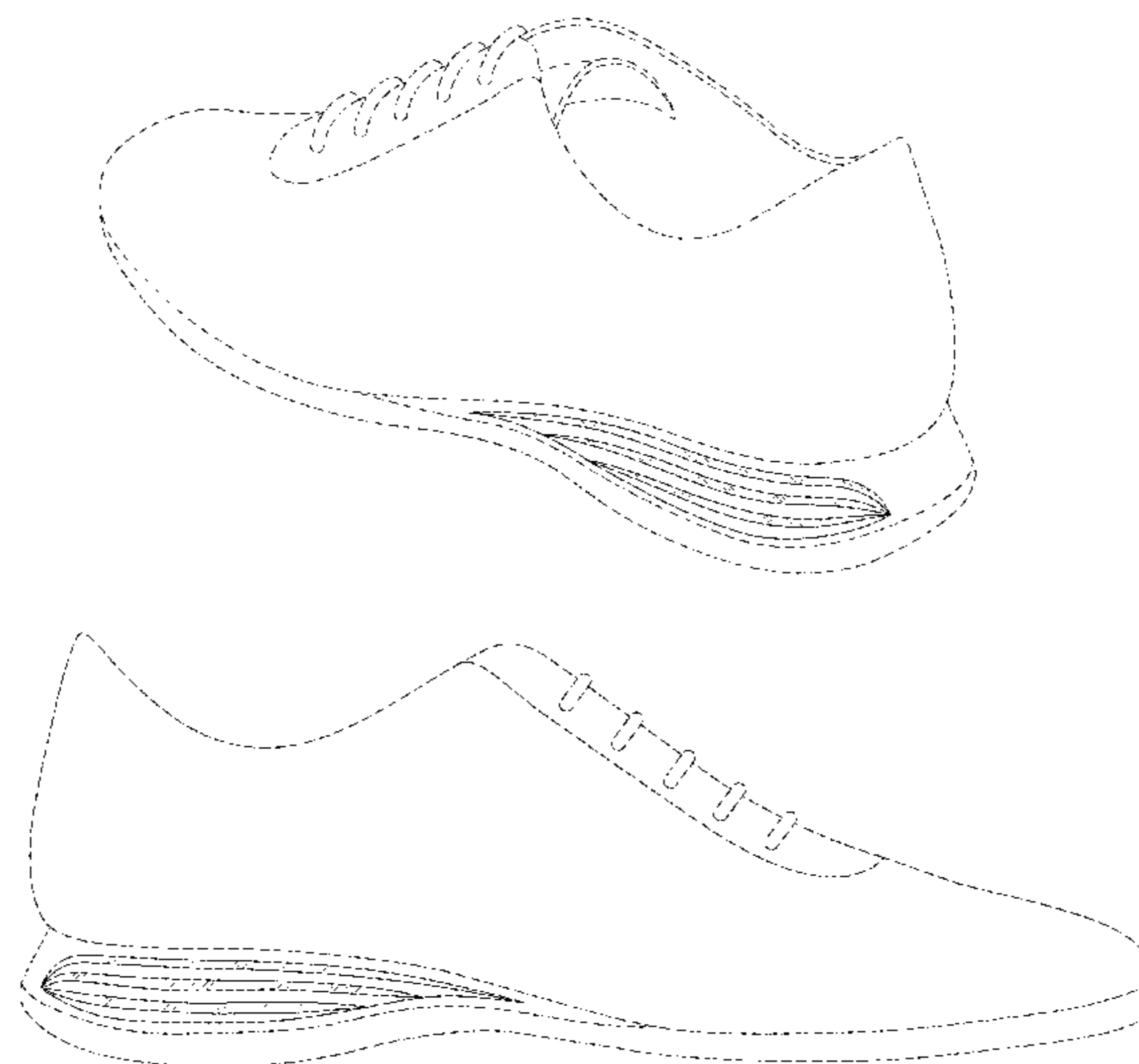
FIG. 1 is a perspective view of a shoe sole showing the new design;  
 FIG. 2 is a lateral side elevational view of the shoe sole showing the new design;  
 FIG. 3 is a medial side elevational view of the shoe sole showing the new design;  
 FIG. 4 is a front elevational view of a shoe shown in FIGS. 1-3, the front elevational view showing no portion of the claimed design and forming no part of the claimed design;  
 FIG. 5 is a rear elevational view of the shoe sole showing the new design;  
 FIG. 6 is a top plan view of the shoe sole showing the new design; and,  
 FIG. 7 is a bottom plan view of the shoe, the bottom plan view showing no portion of the claimed design and forming no part of the claimed design.  
 The broken lines showing the remainder of the shoe are for the purpose of illustrating environmental structure and form no part of the claimed design.

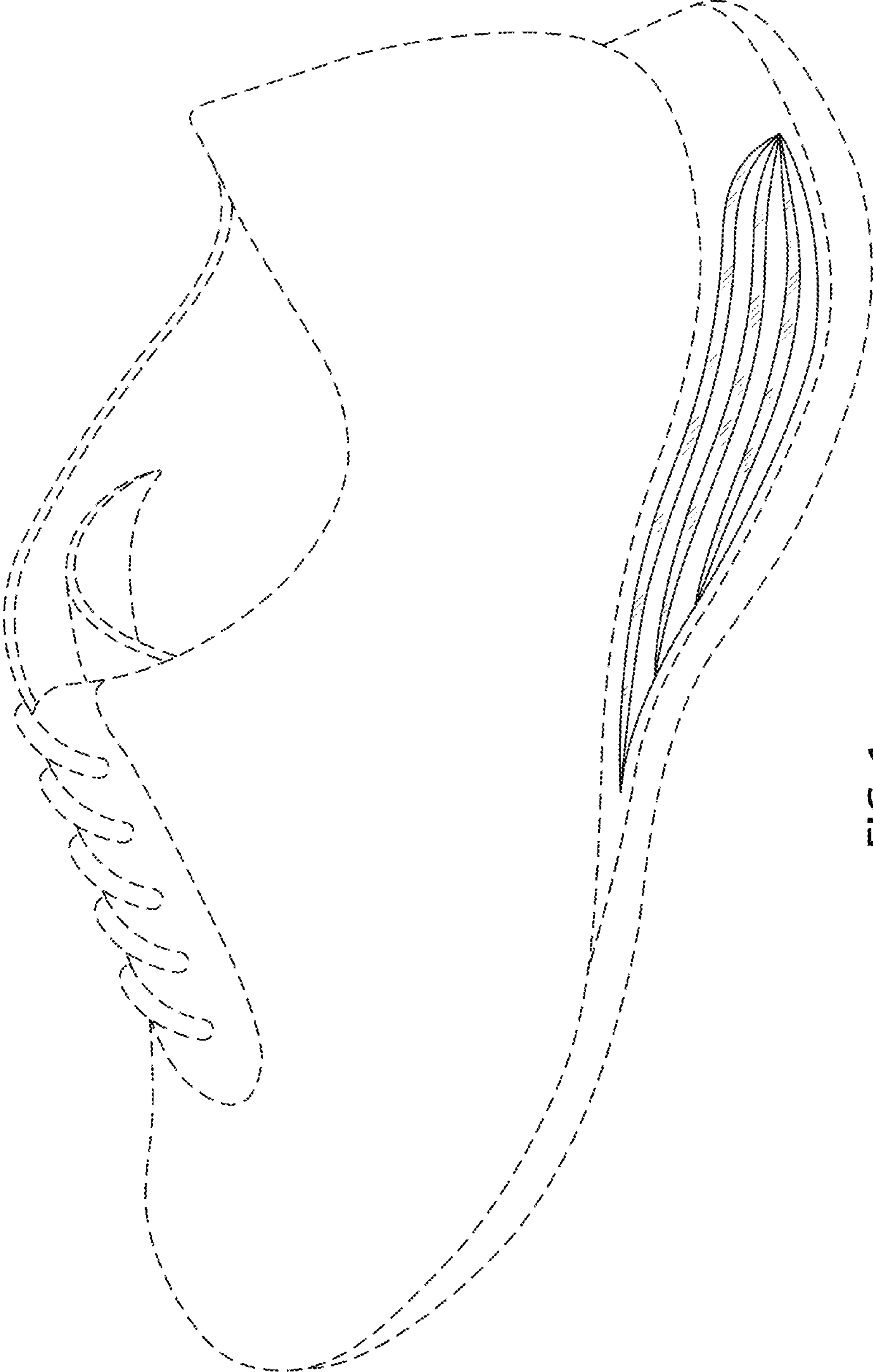

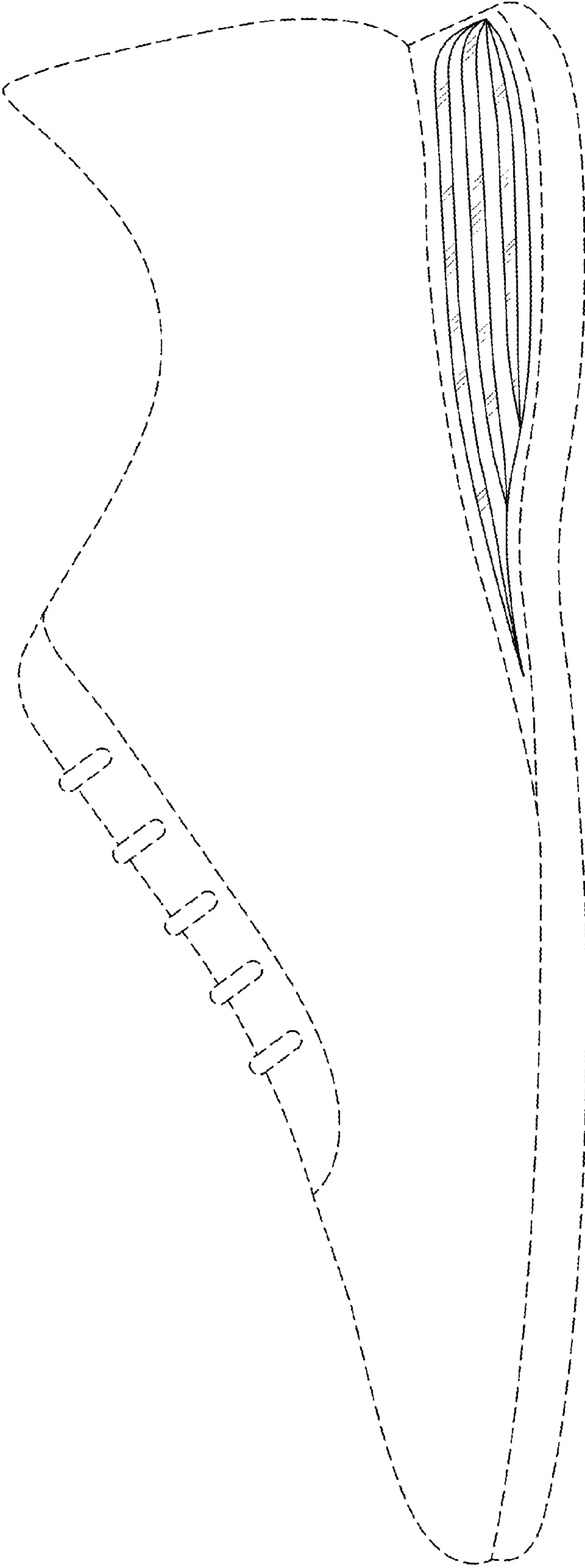

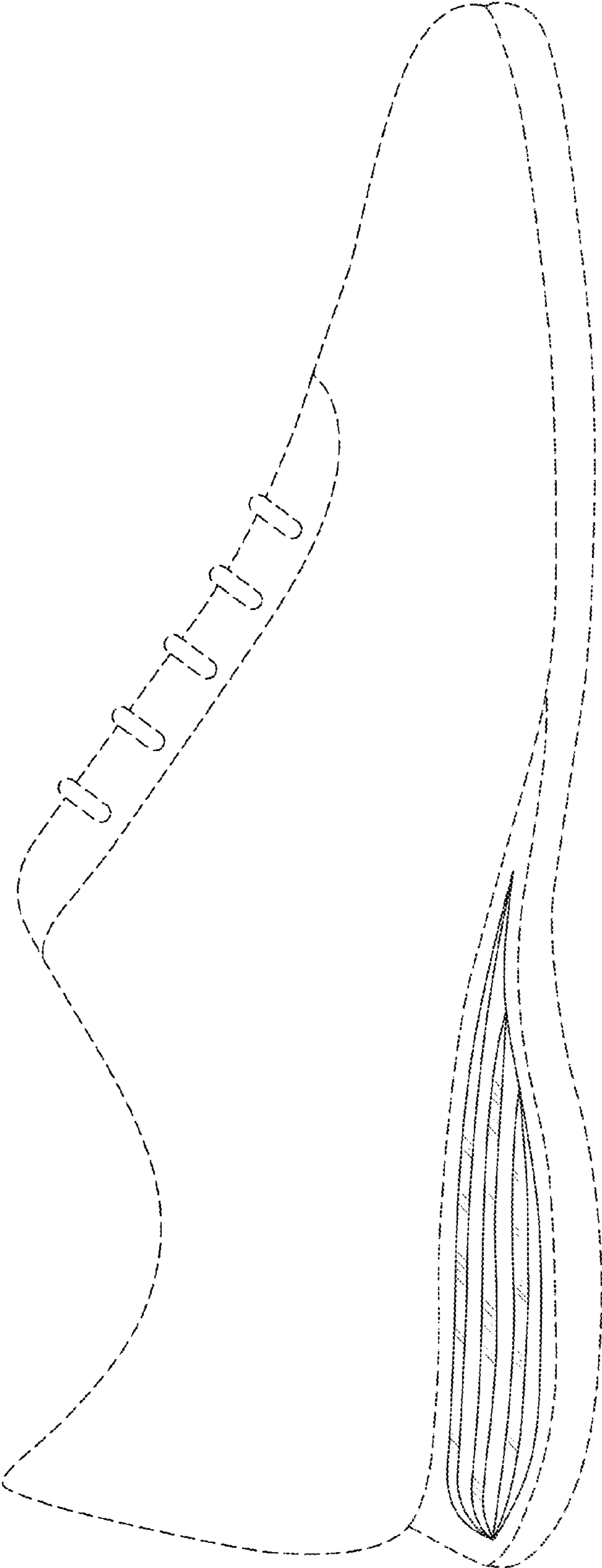

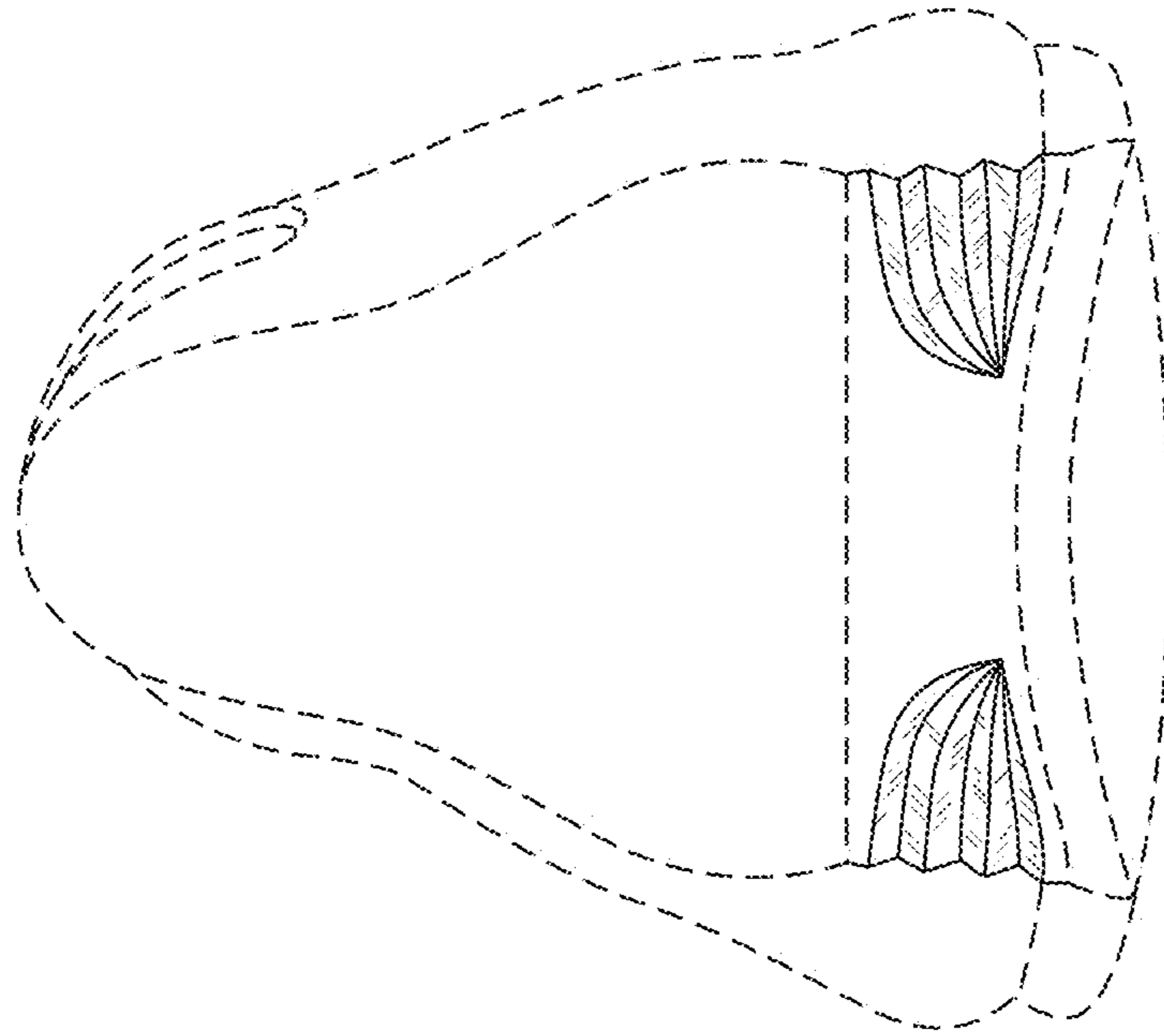

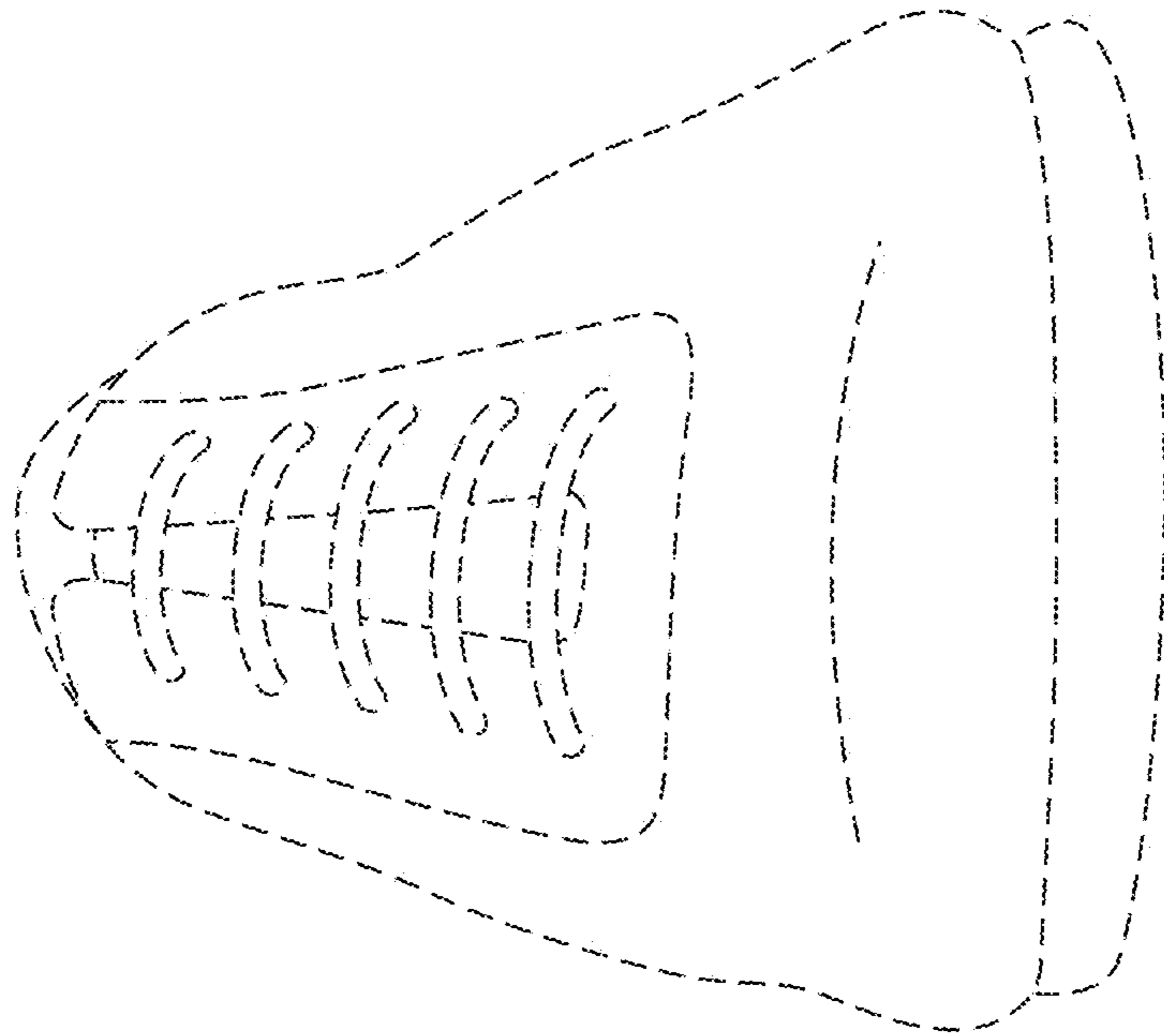

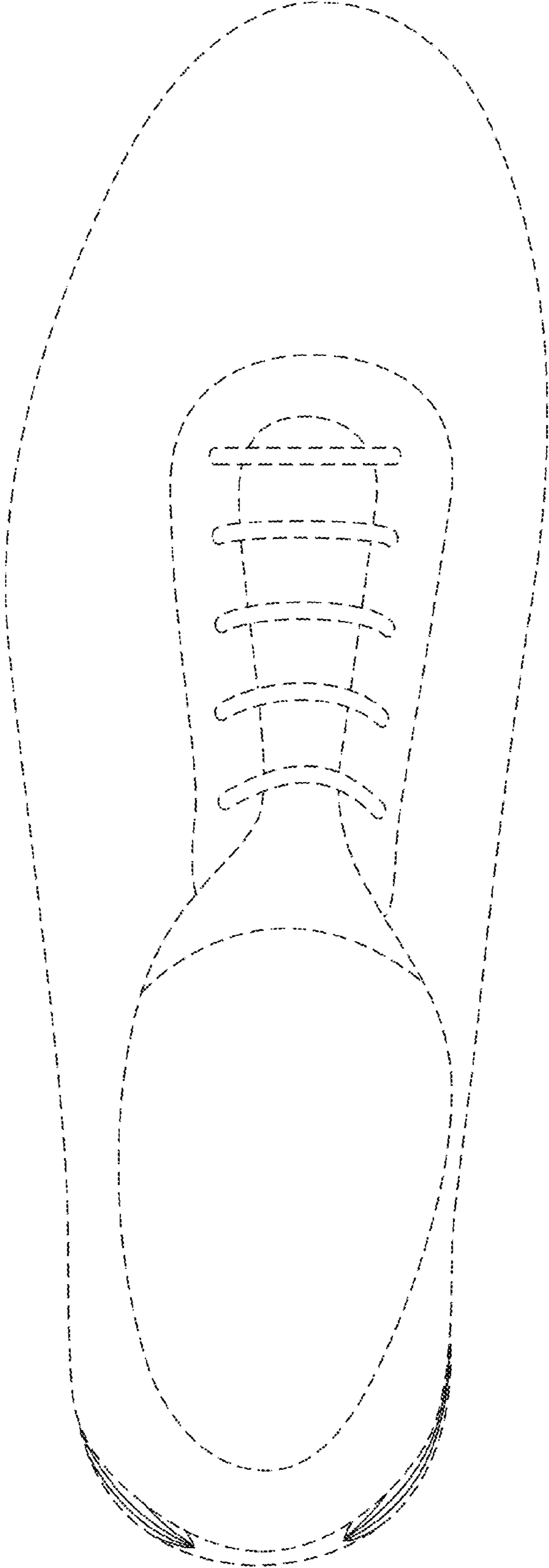

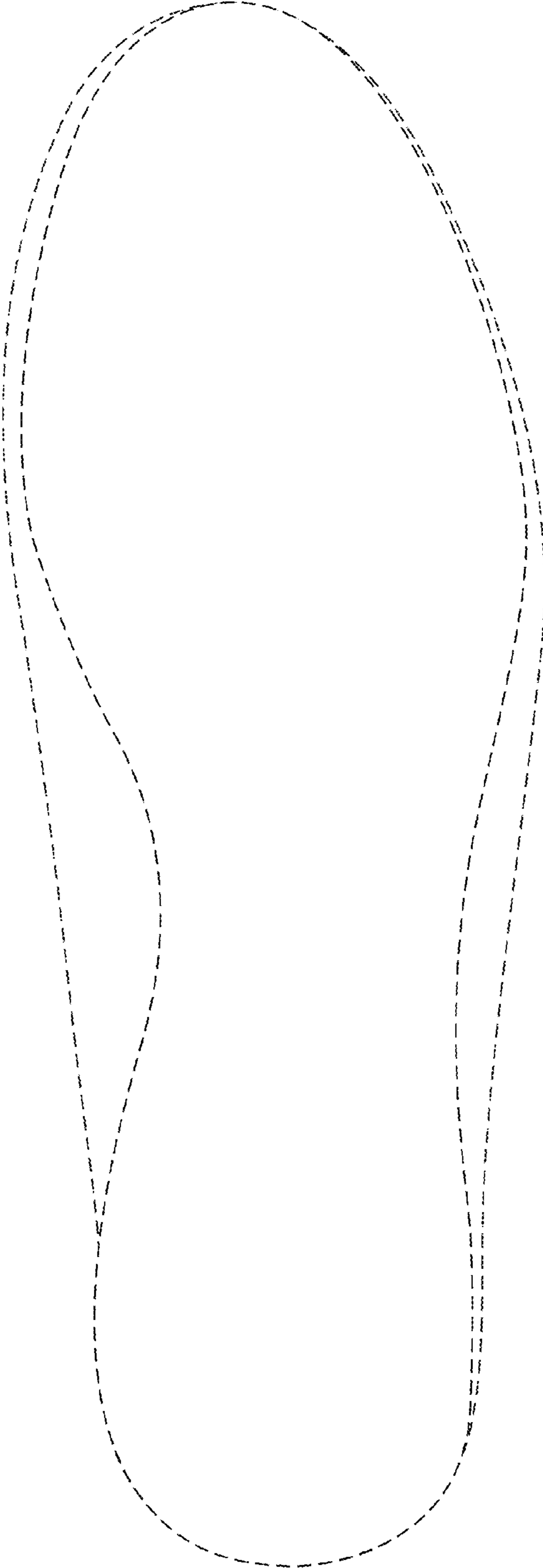
