DESCRIPTION

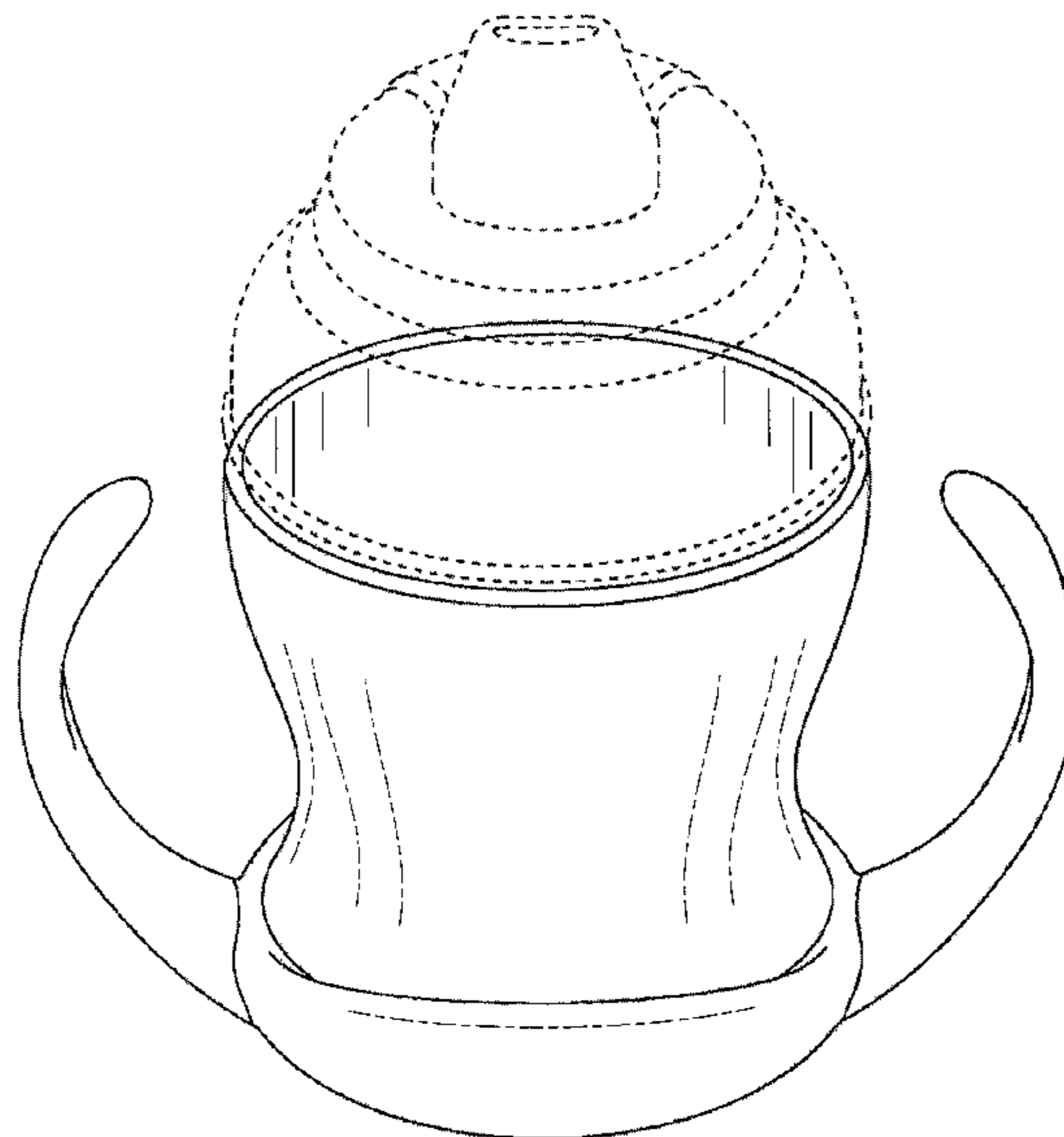
FIG. 1 is an upper front perspective view of a container with handles showing our new design;
FIG. 2 is a lower front perspective view thereof;
FIG. 3 is a front view thereof, the back view being the same image as the front view;

FIG. 6 is a bottom view thereof.

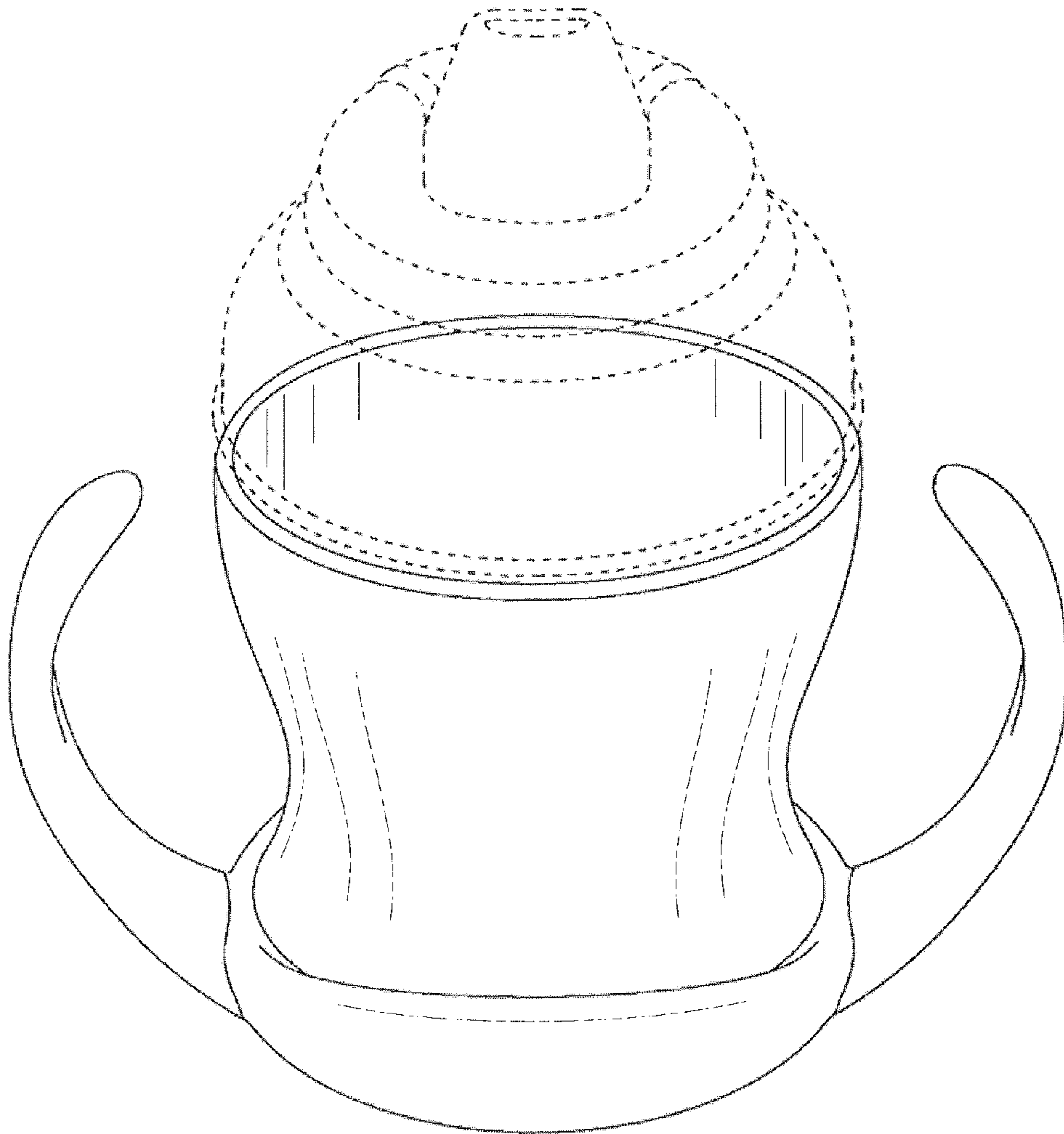

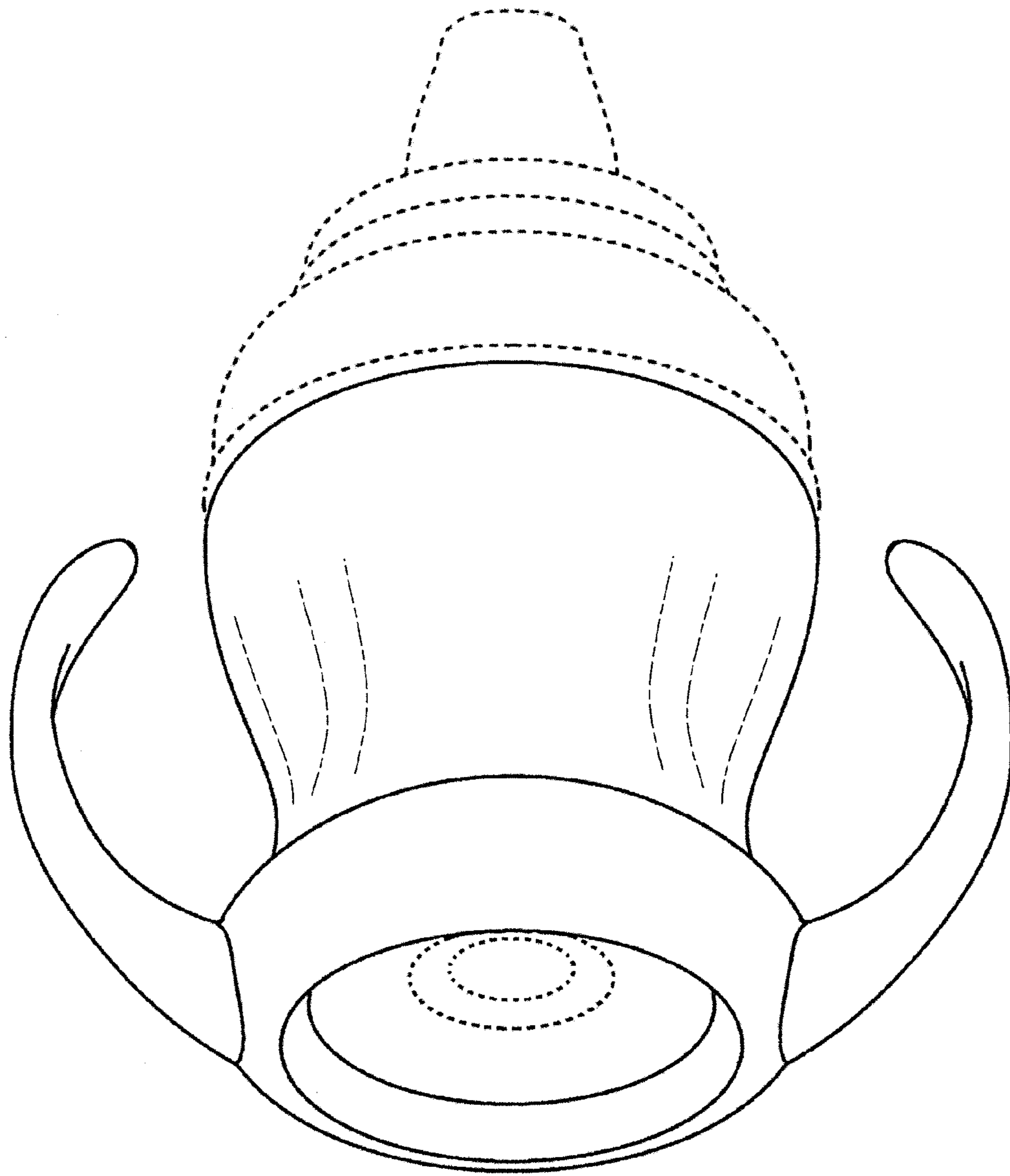

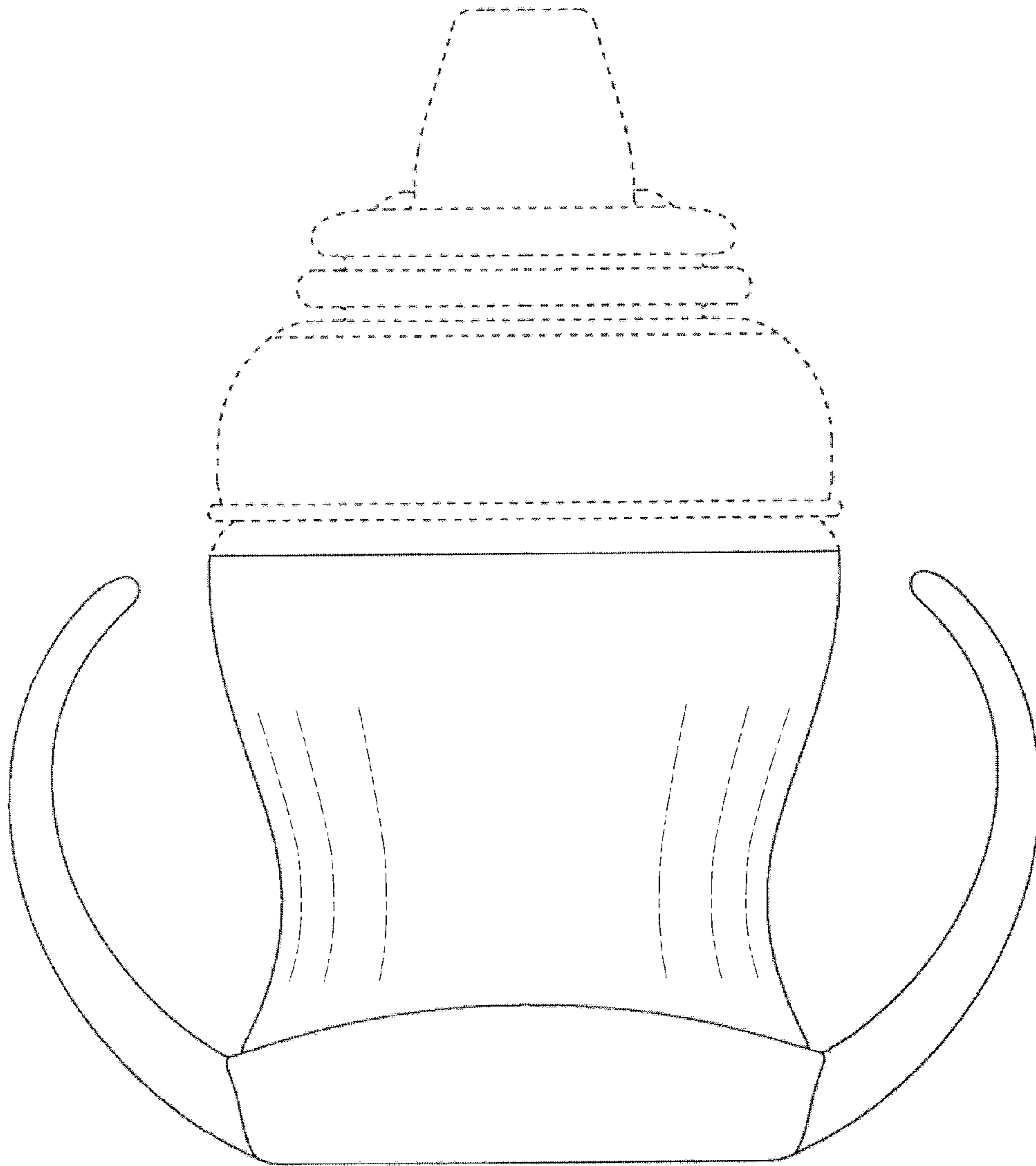

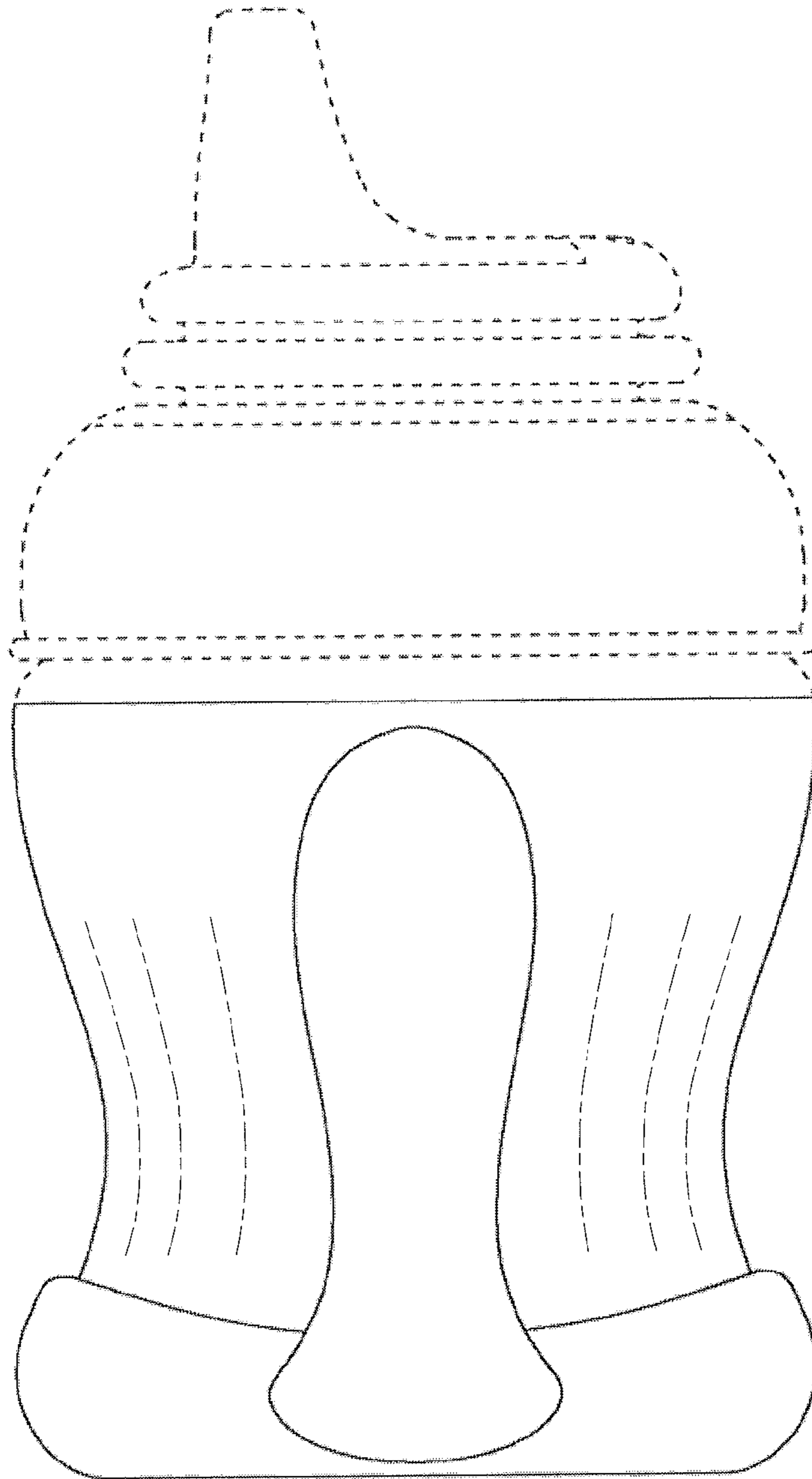

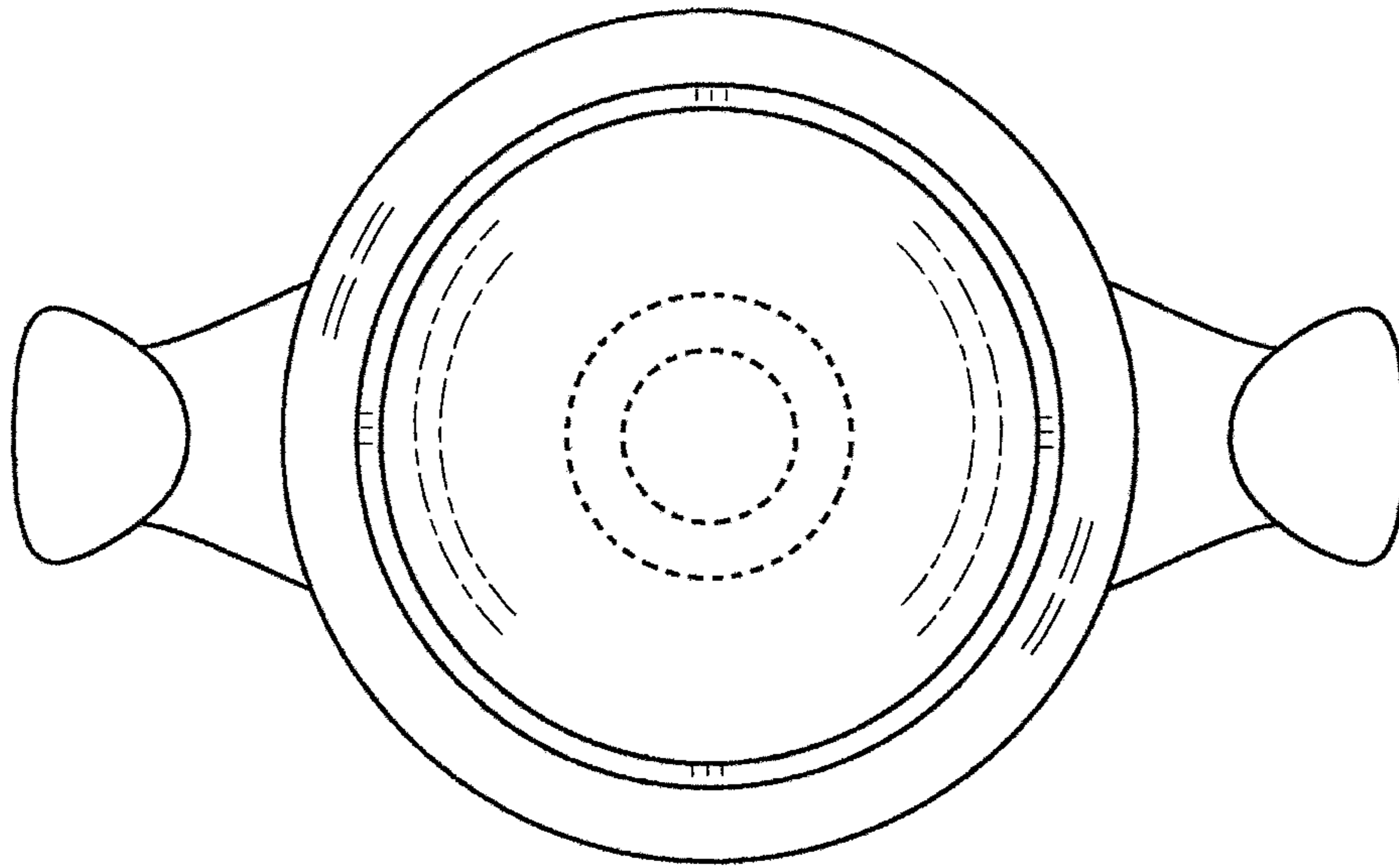

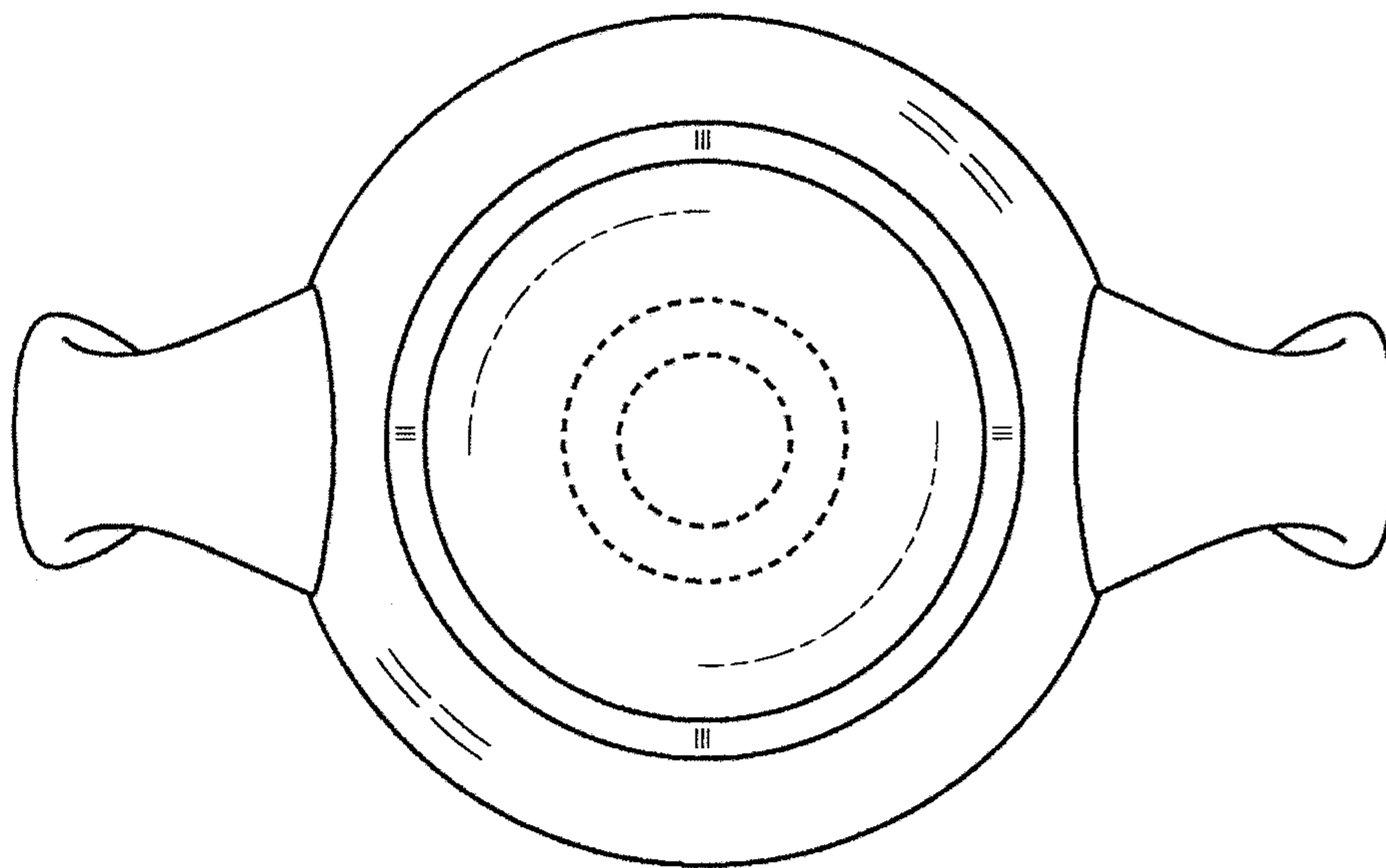
