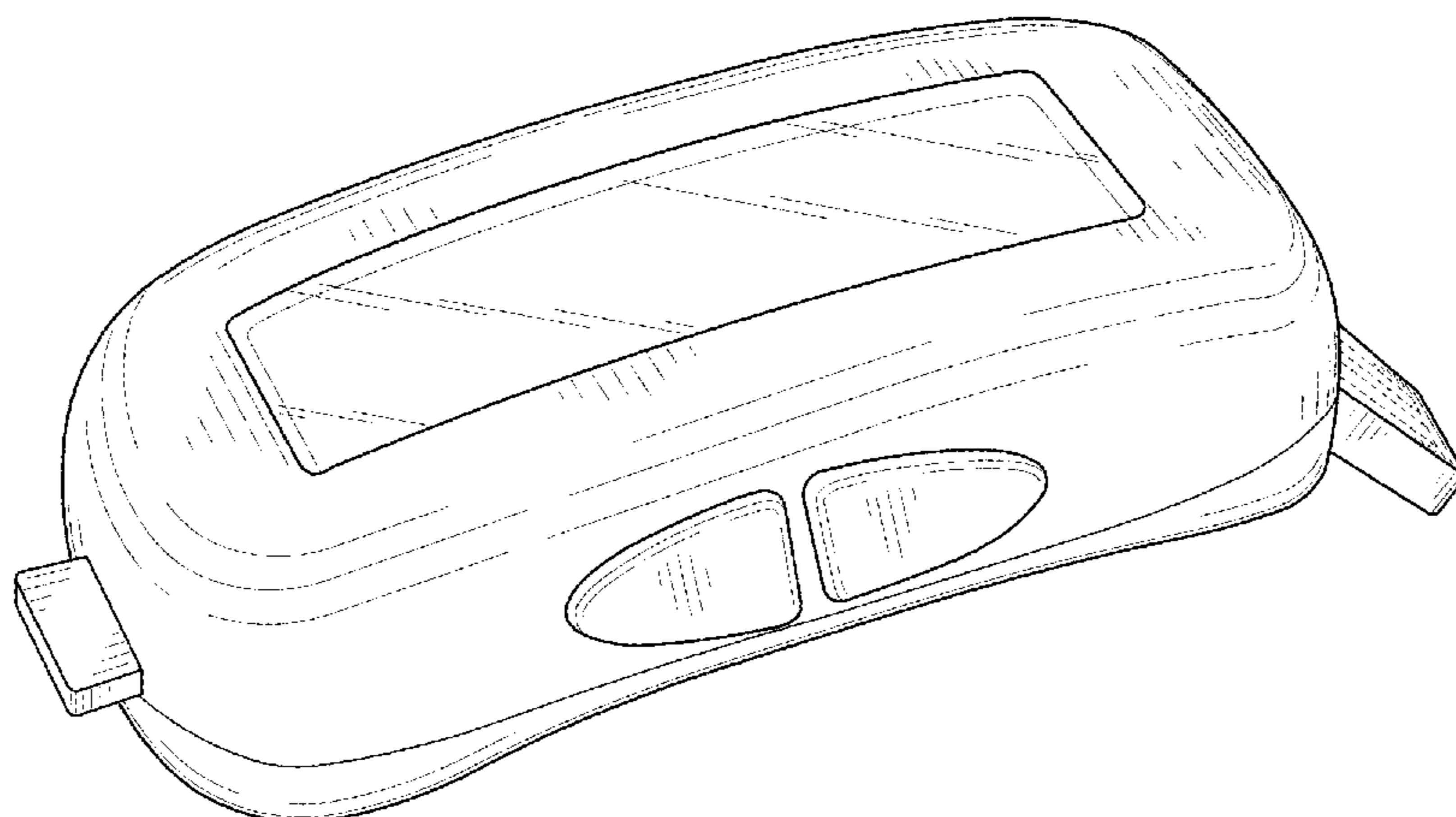

(57) **CLAIM**
The ornamental design for wrist-worn electronic display, as shown and described.

DESCRIPTION

FIG. 1 is top right perspective view of a wrist-worn electronic display showing my new design;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side perspective view thereof;
FIG. 6 is a right side perspective view thereof; and,
FIG. 7 is a rear perspective view thereof.
The structural features depicted by broken lines in FIG. 2 have been shown for the purpose of illustrating portions of the claimed wrist-worn electronic display that form no part of the claimed design.

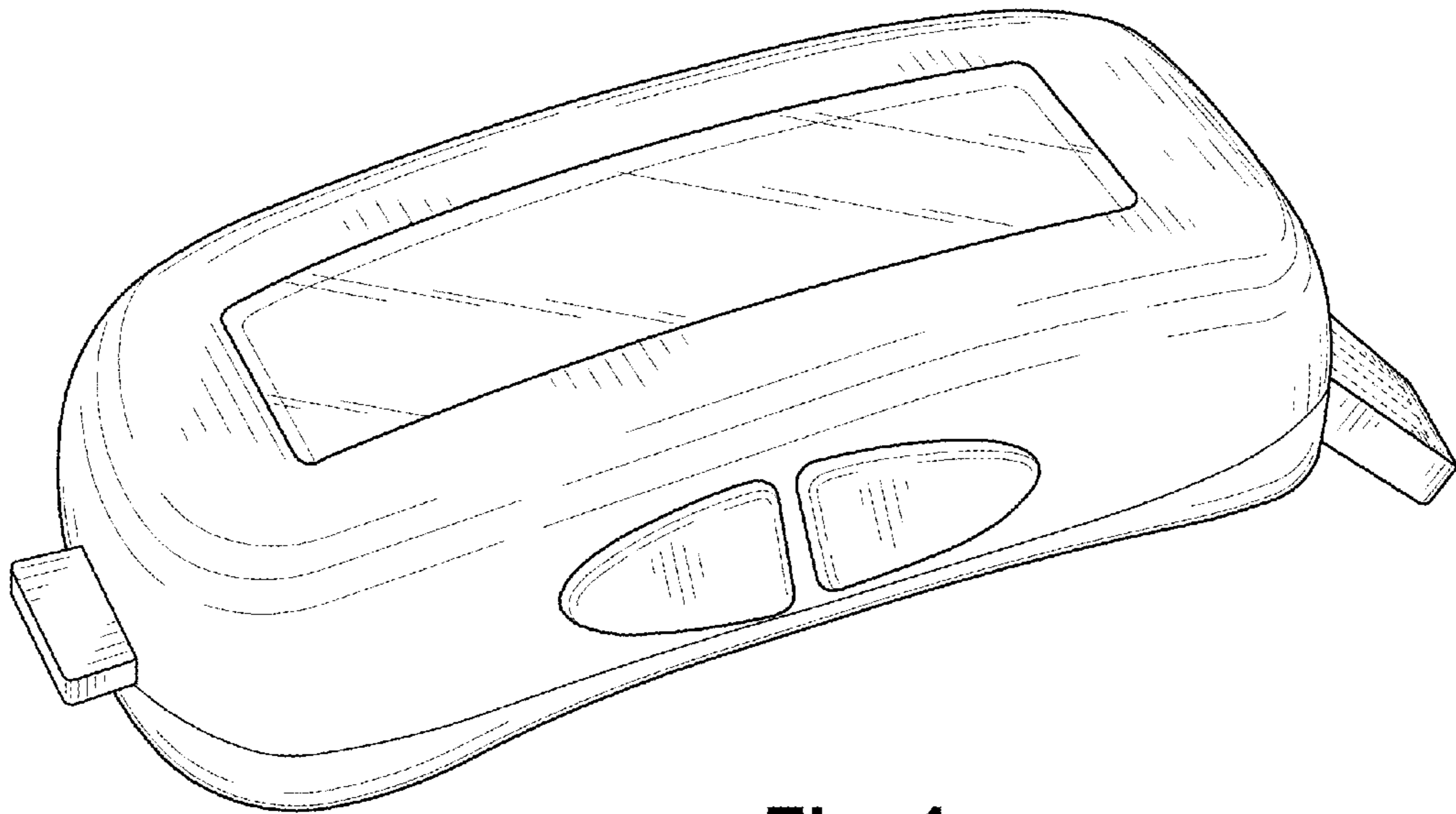

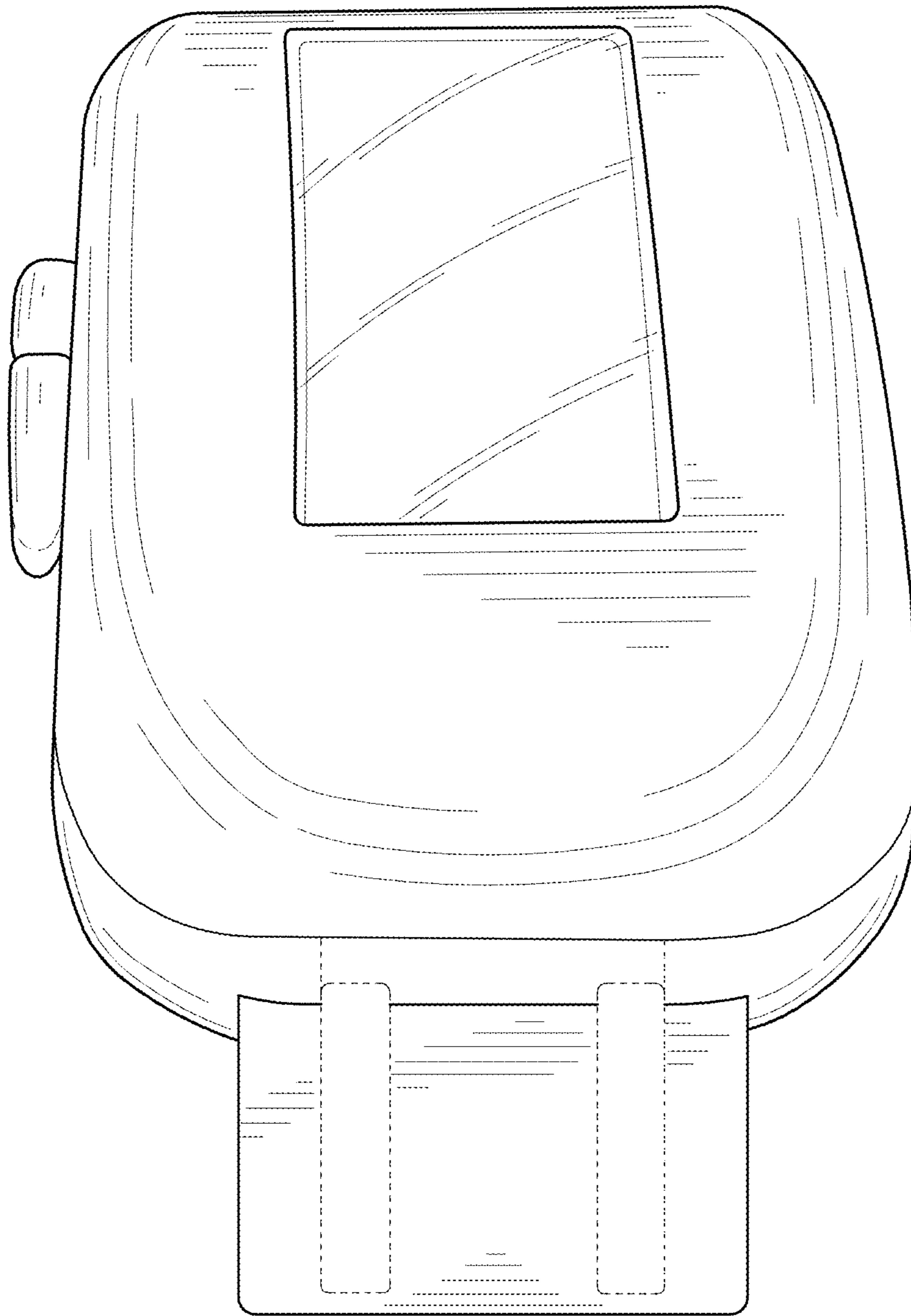

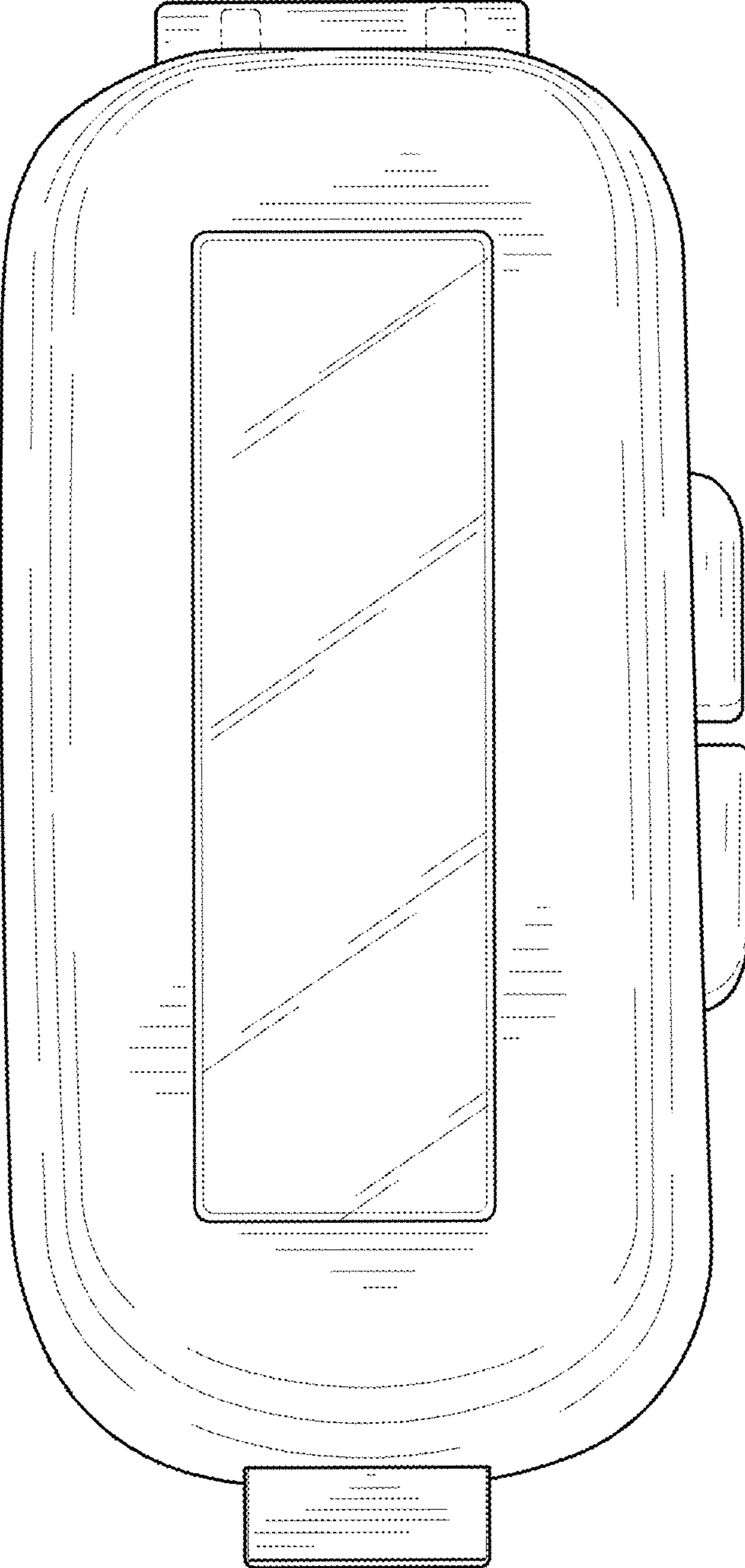

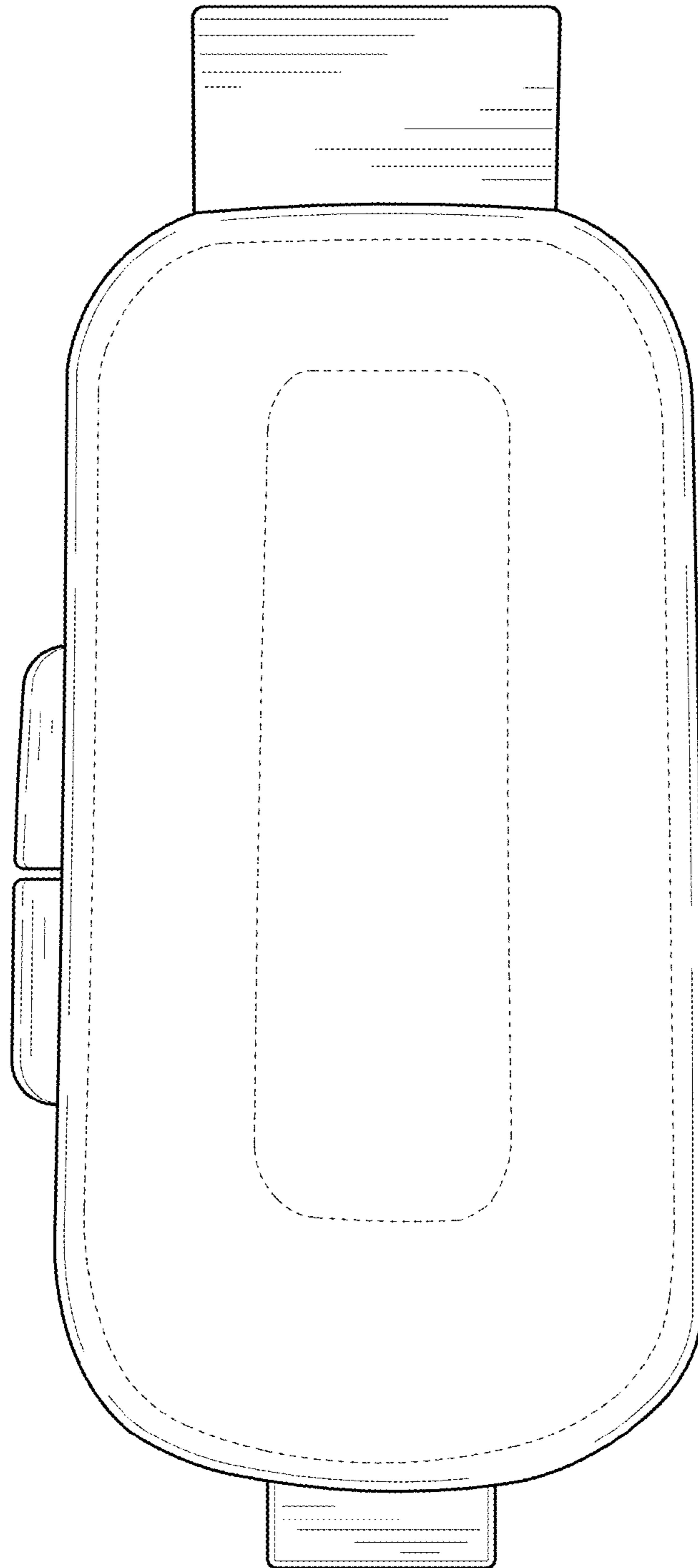

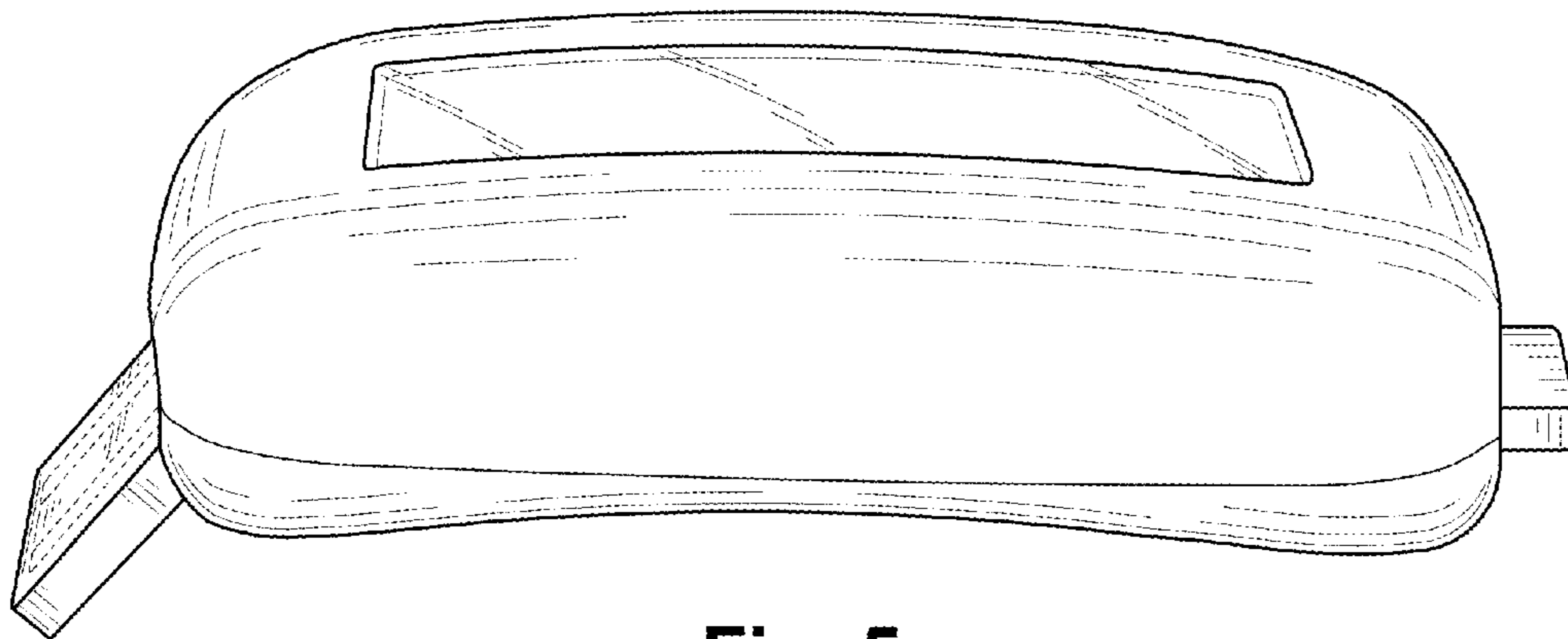

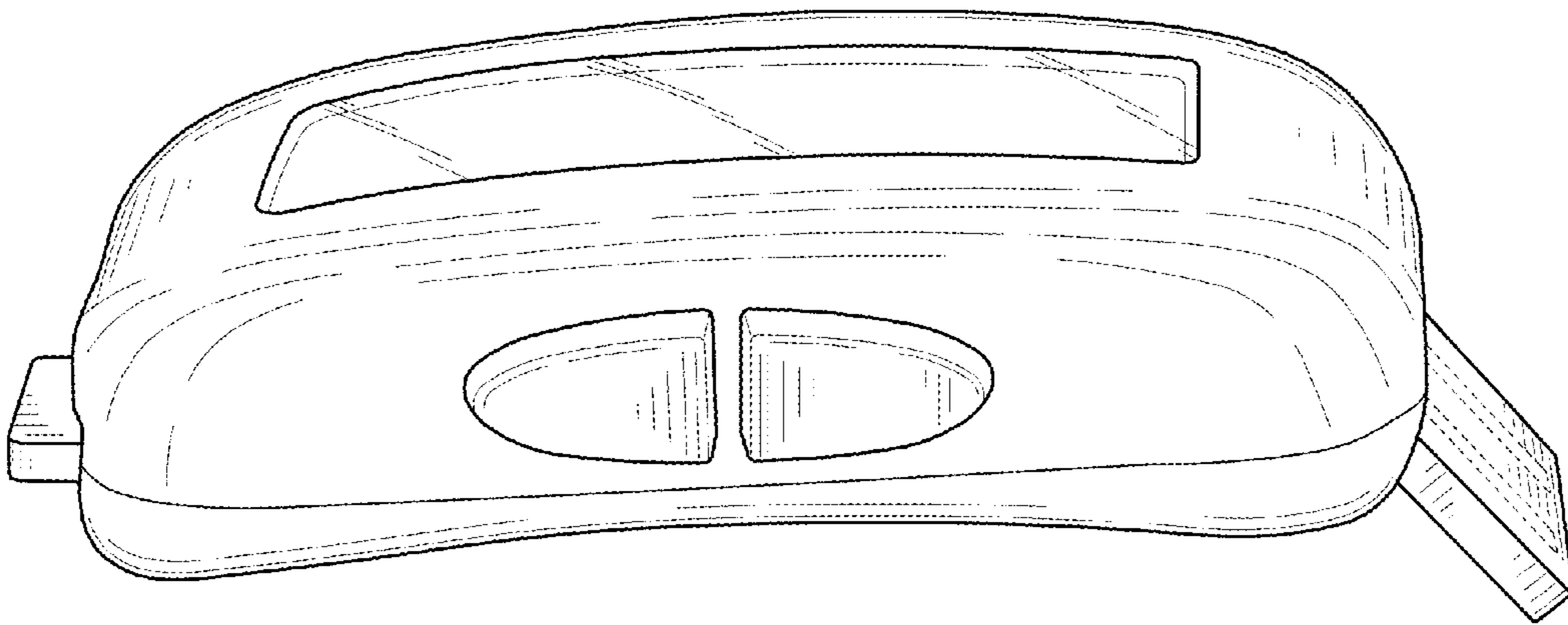

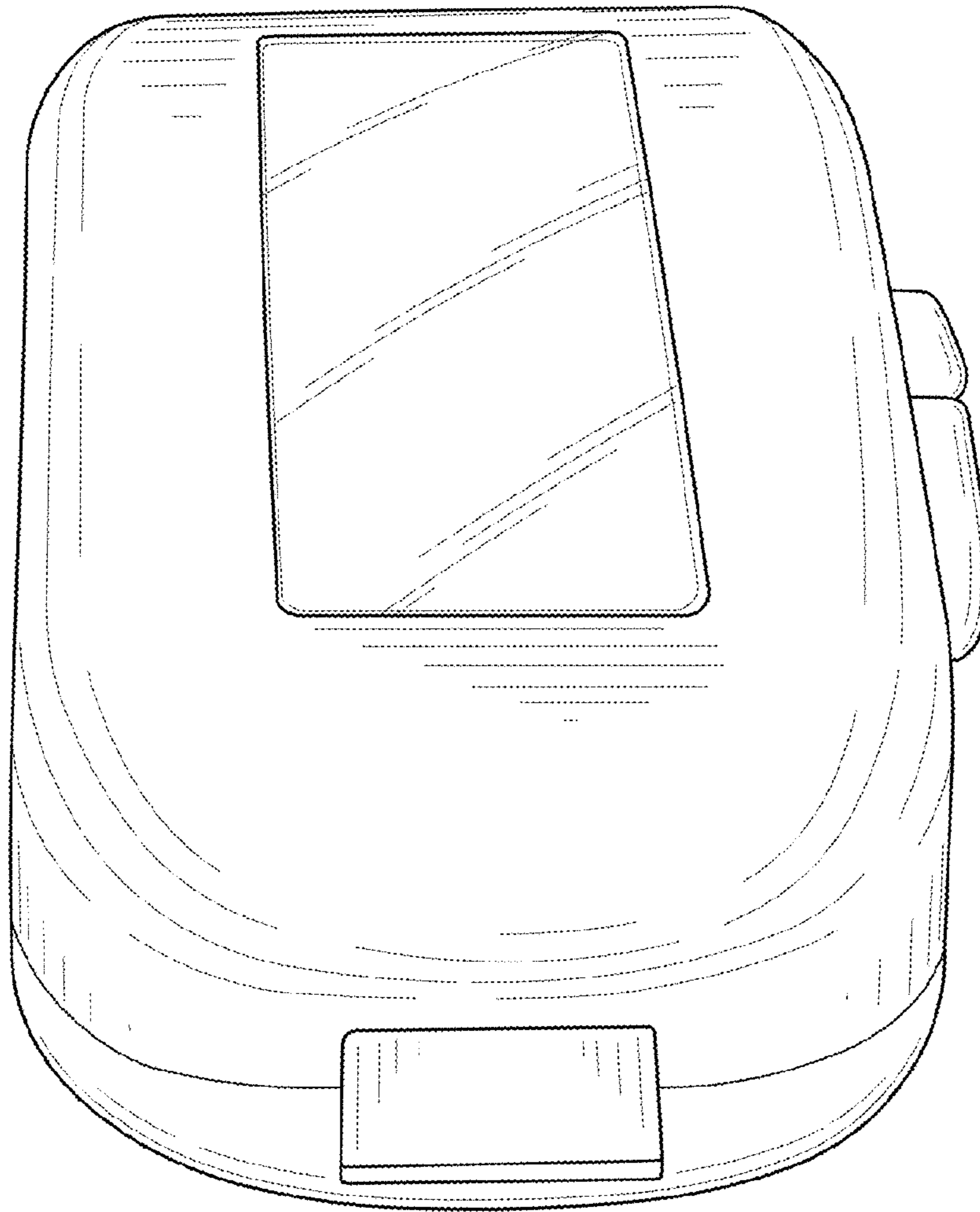
