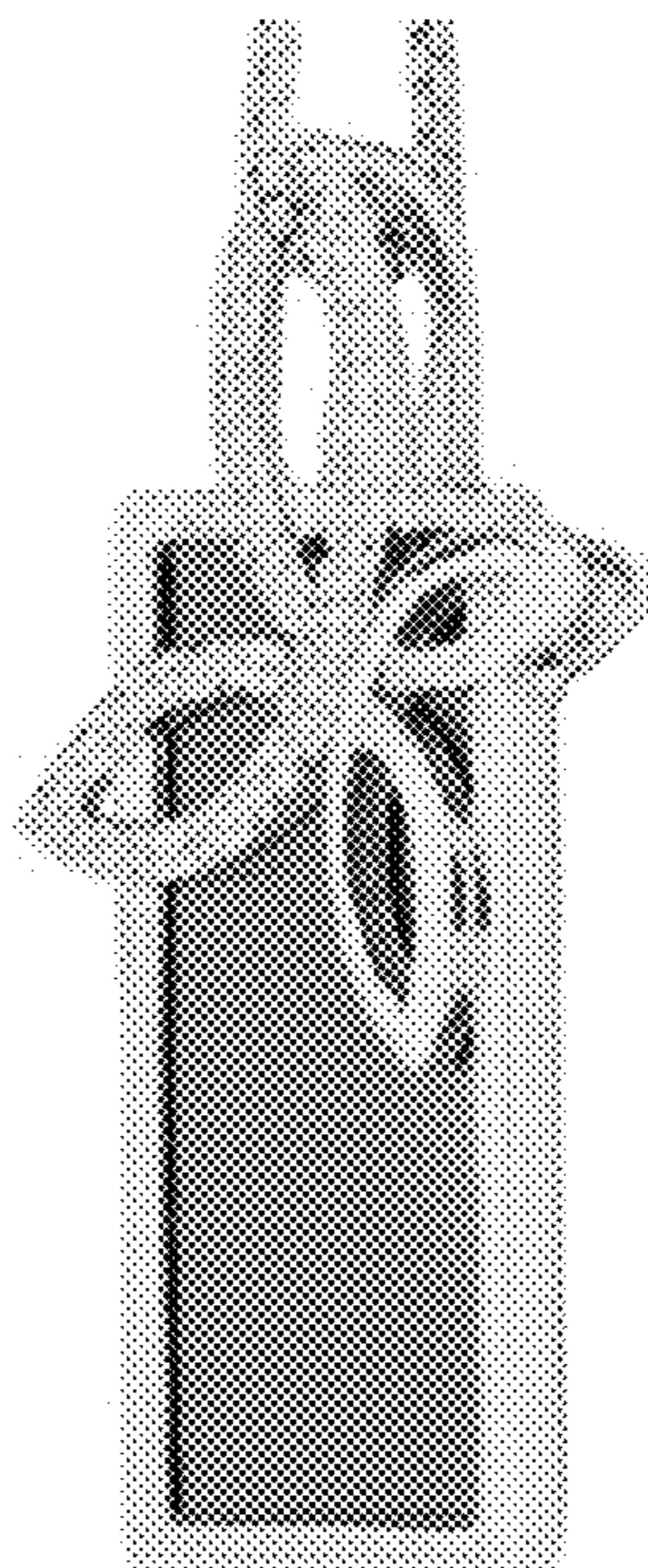
FIG. 1 is a front and right side perspective view of a jewelry article showing our new design;

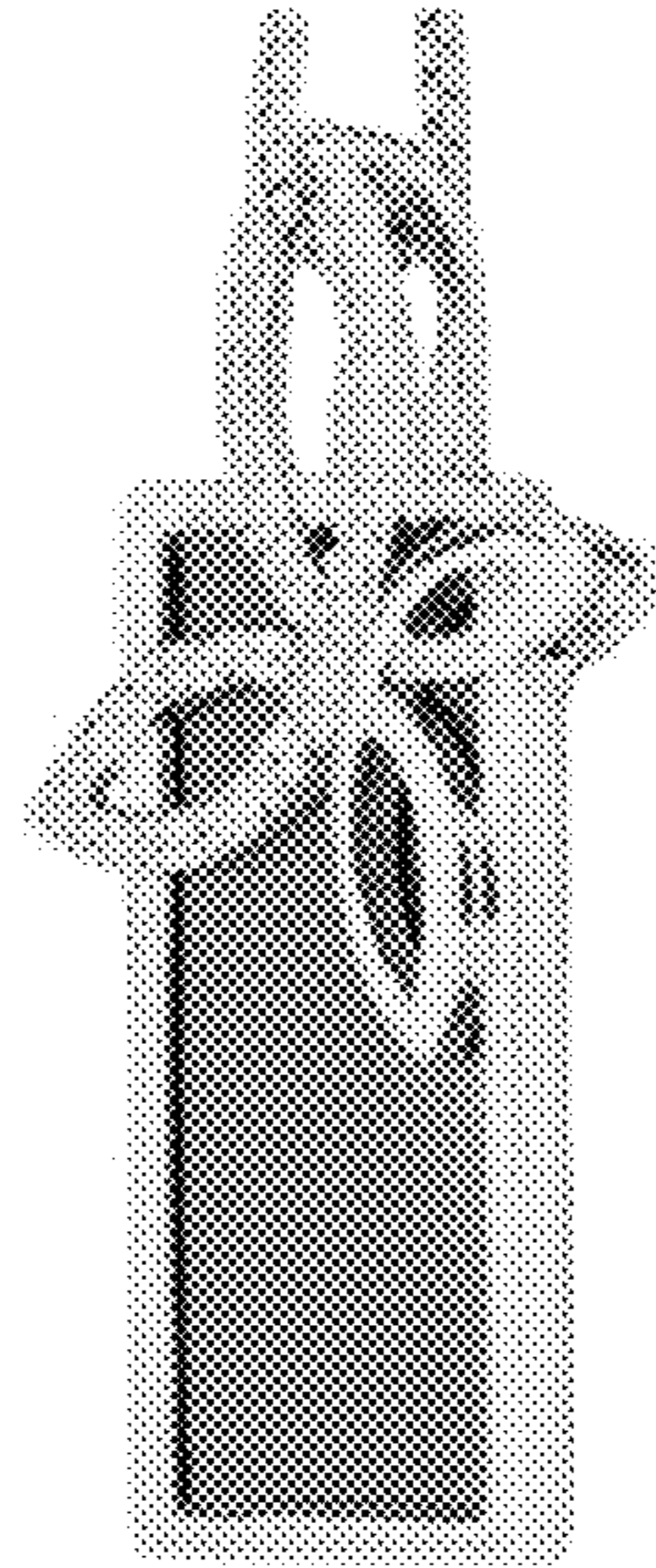

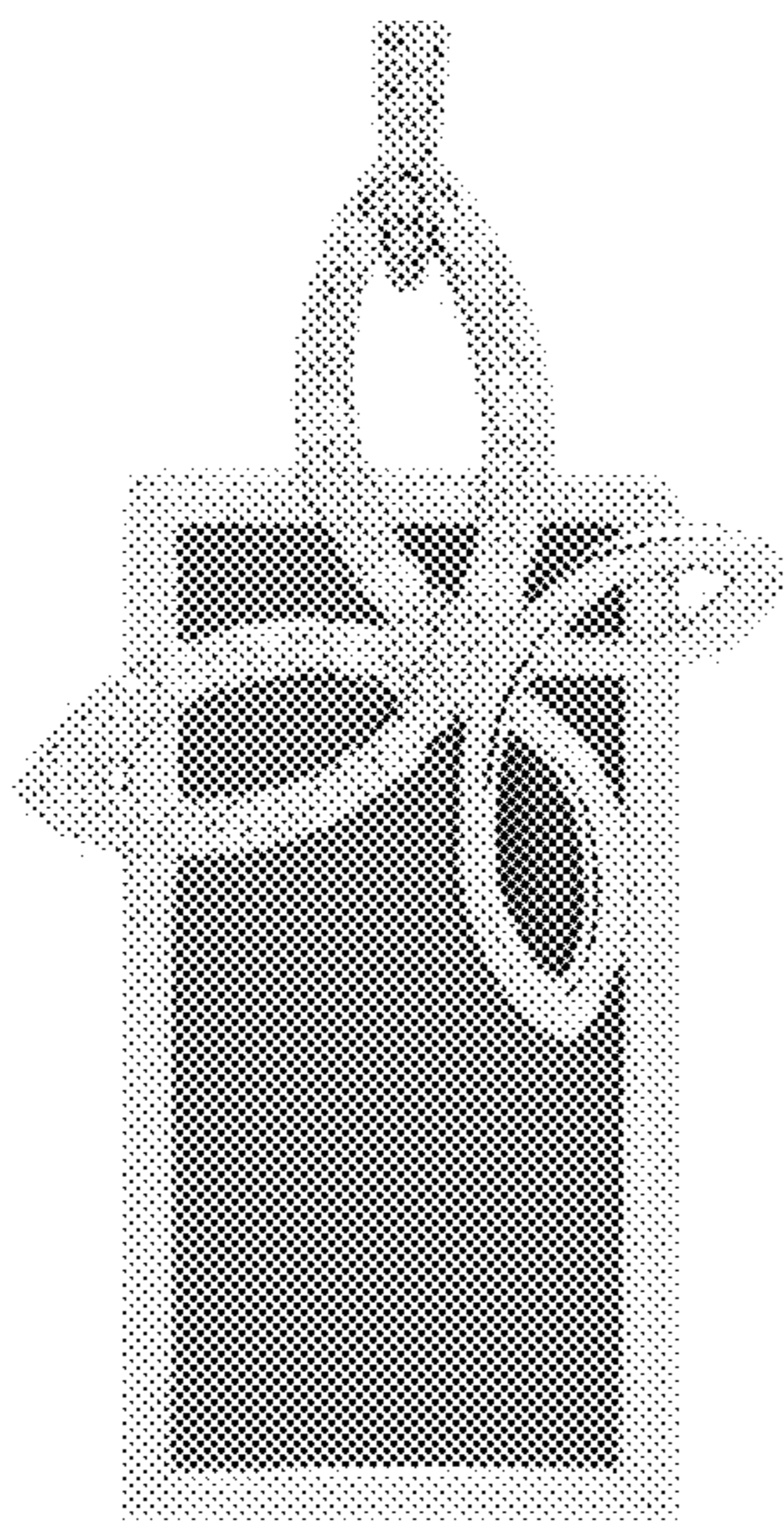

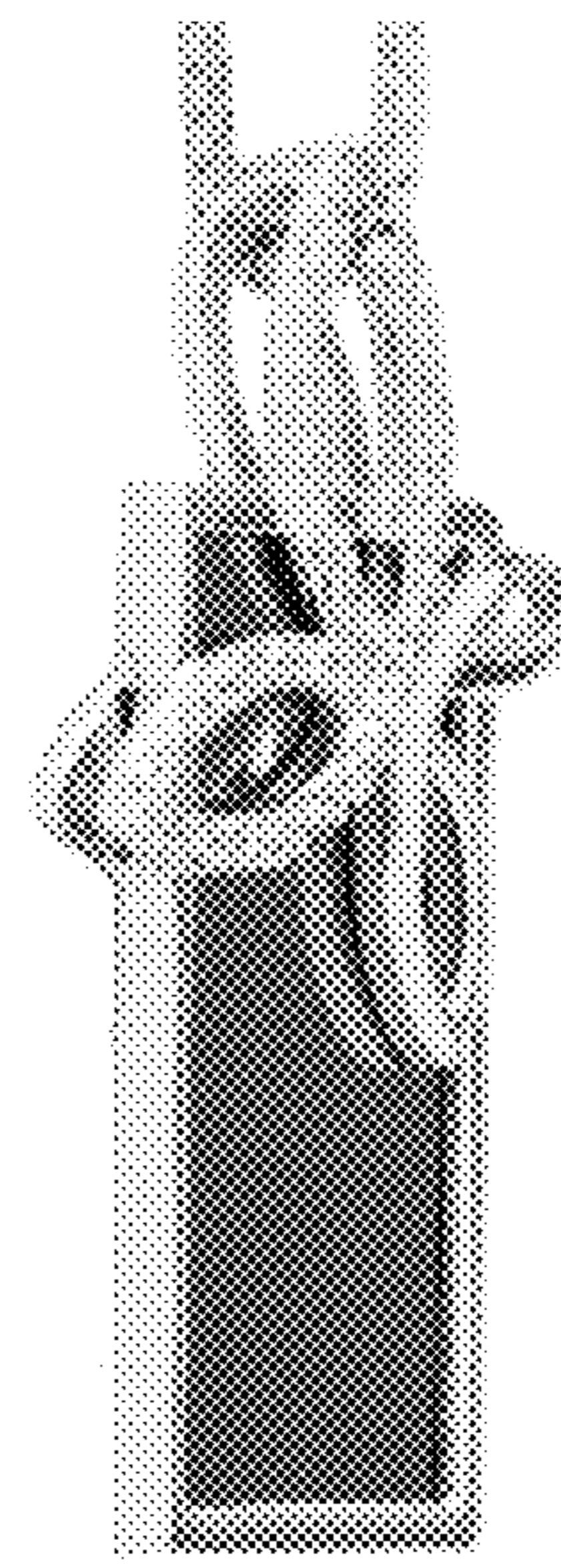
