(57) **CLAIM**

The ornamental design for an automotive display configuration, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of the automotive display configuration of my new design.

FIG. 2 is an elevational view from the front of my new design.

FIG. 3 is an elevational view from the rear of my new design.

FIG. 4 is a top plan view thereof.

FIG. 5 is an elevational view of one side thereof. The opposite side view is a mirror image thereof.

FIG. 6 is a perspective view of an alternate arrangement of my new design.

FIG. 7 is an elevational view from the front of the design shown in FIG. 6.

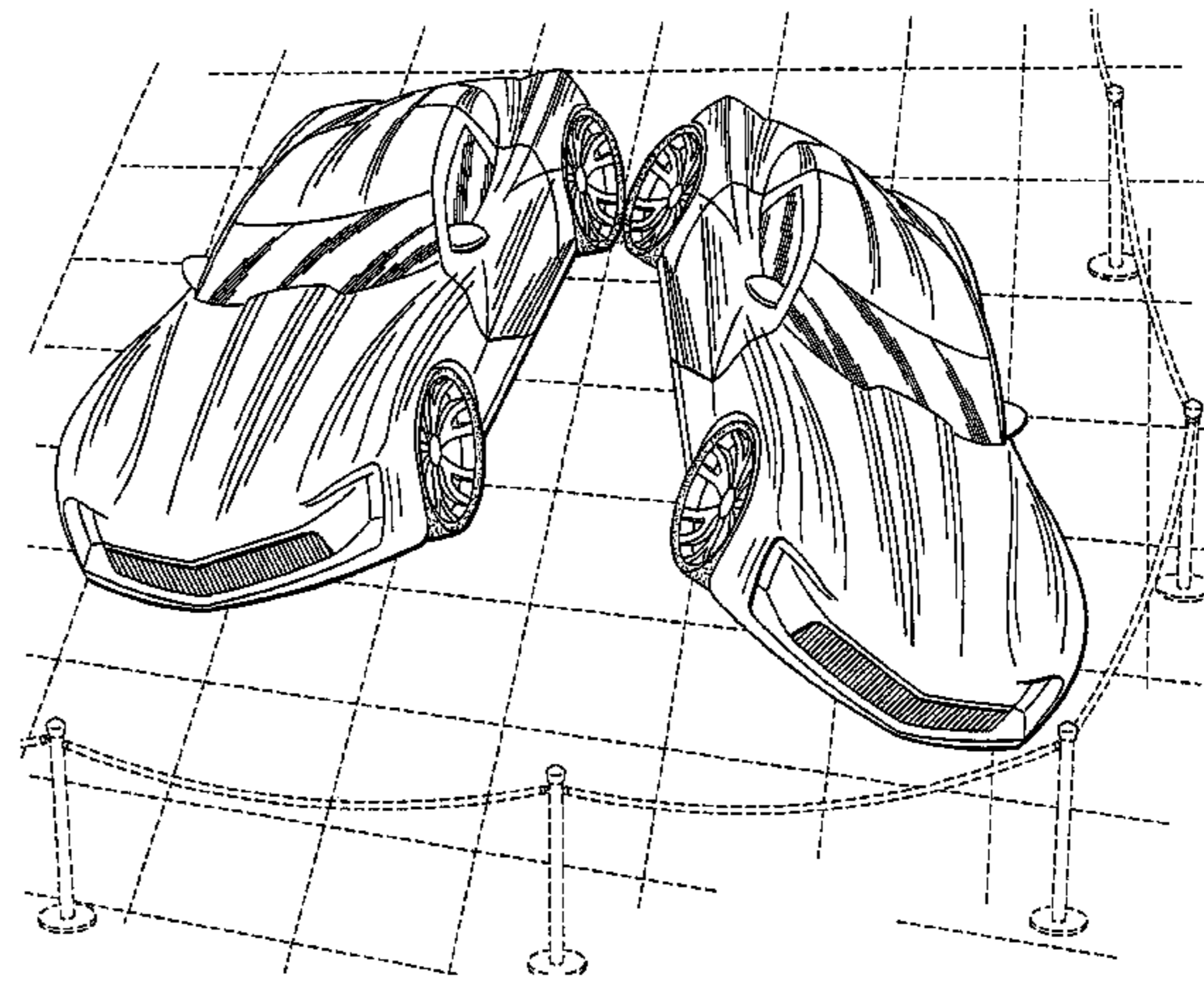
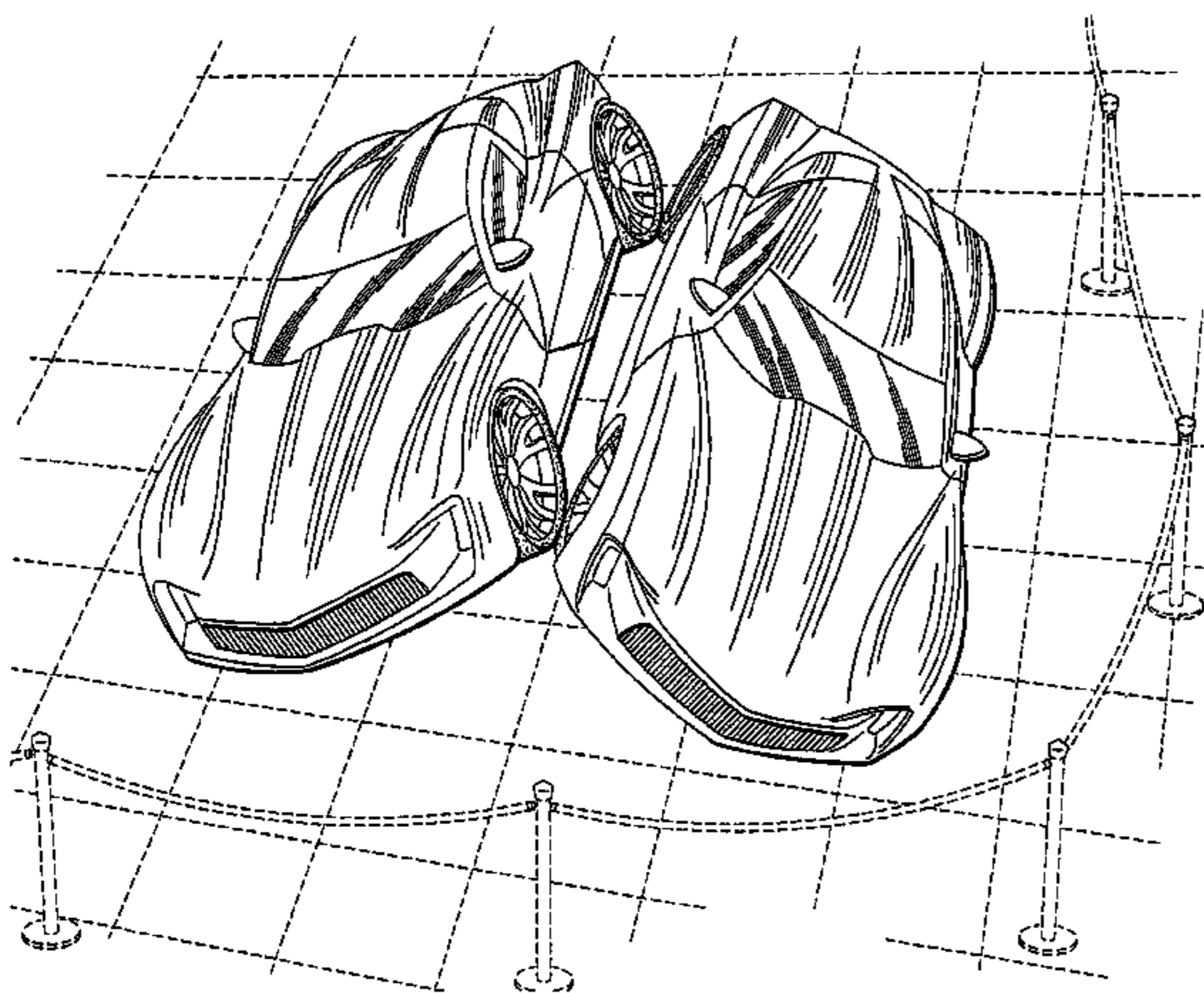
FIG. 8 is an elevational view from the rear of the design shown in FIG. 6.

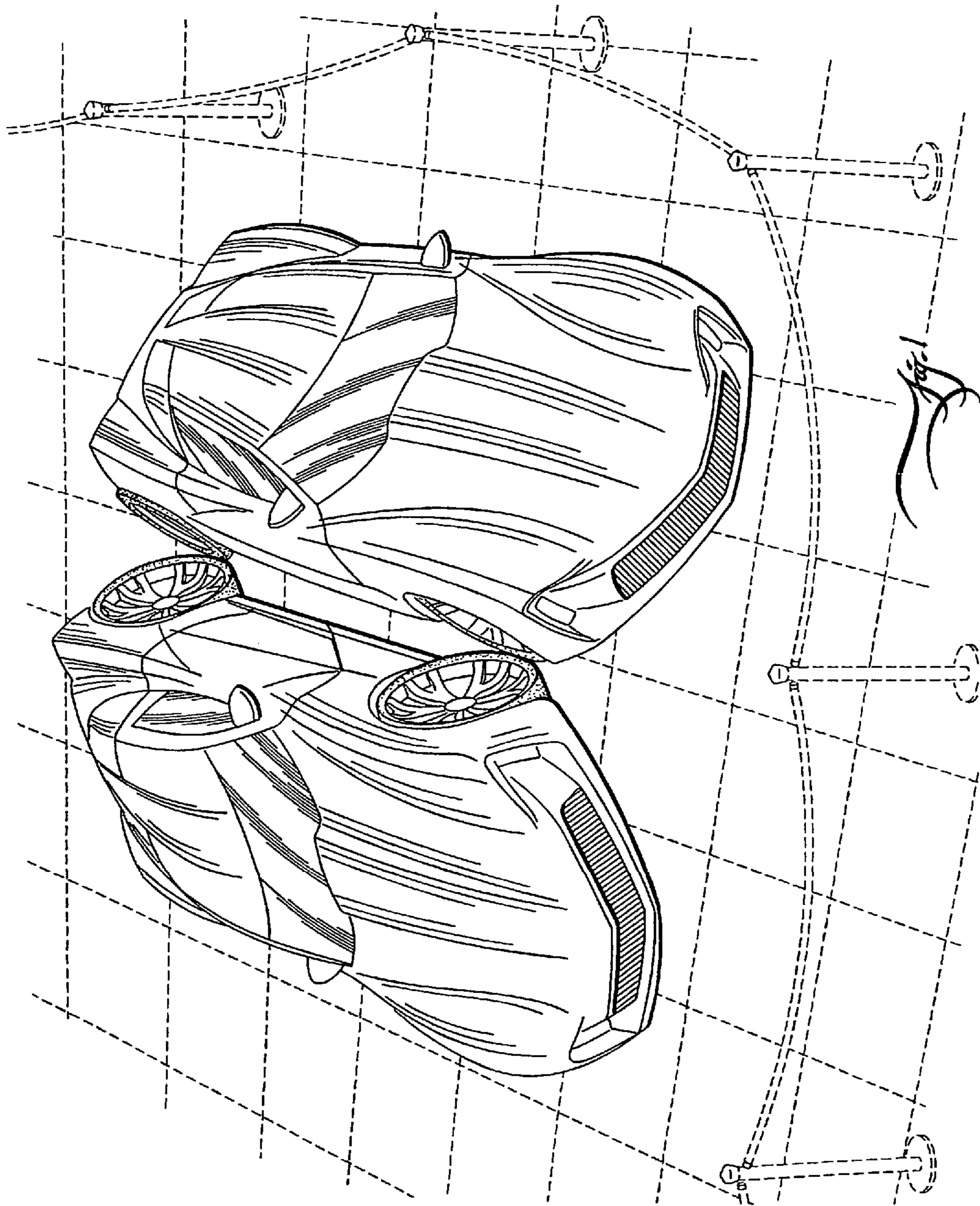
FIG. 9 is an top plan view of the alternate arrangement shown in FIG. 6; and,

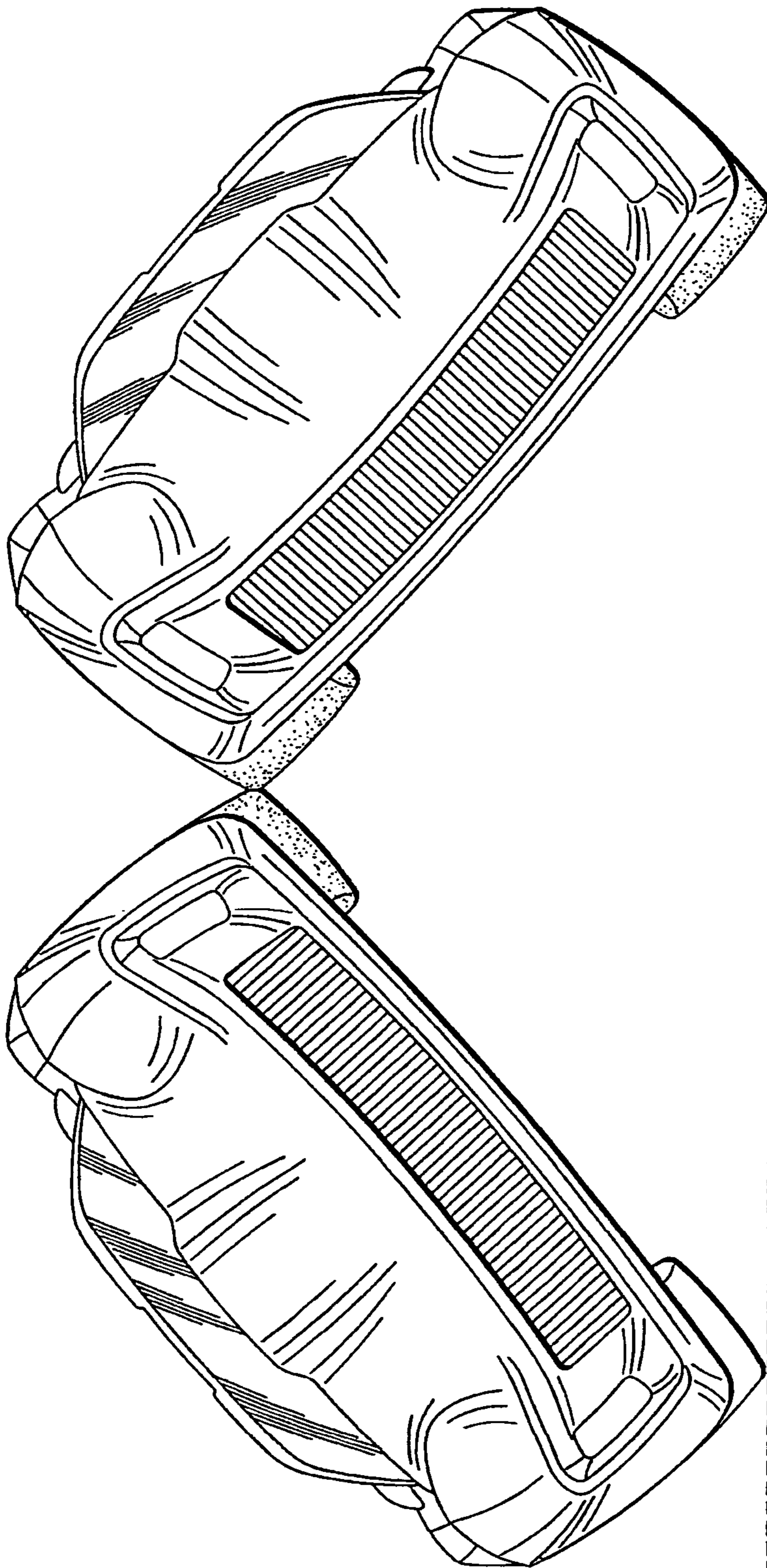

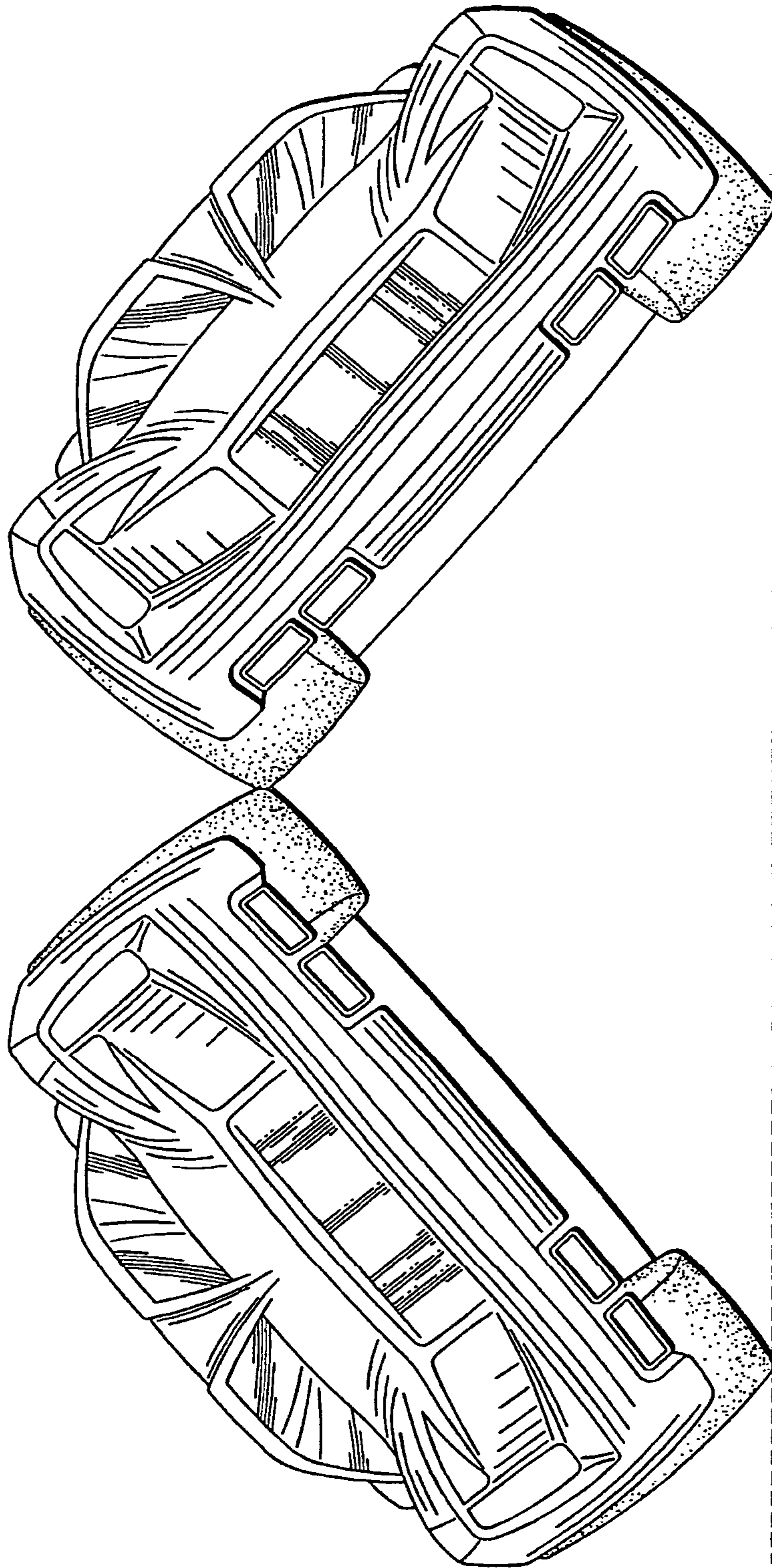
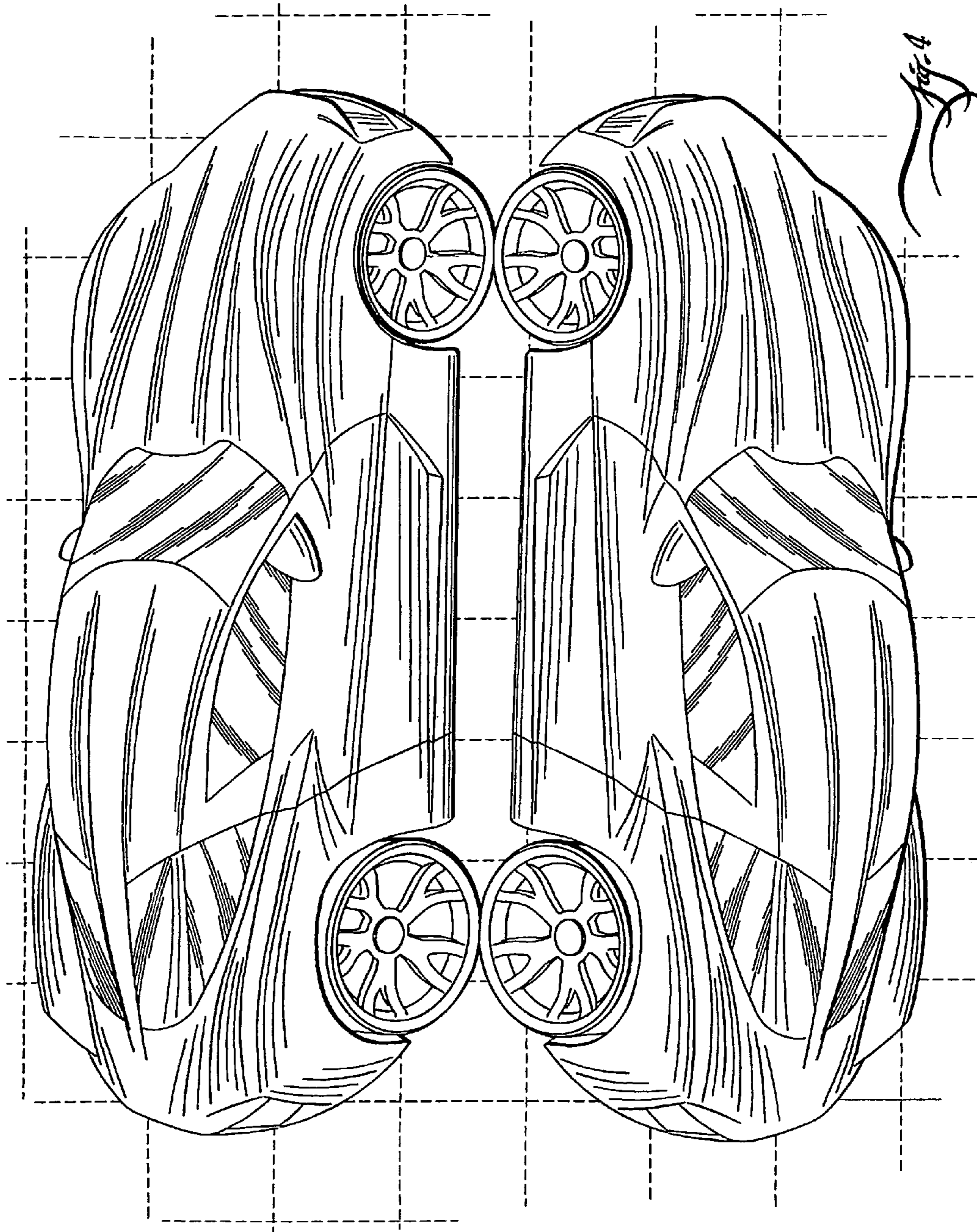

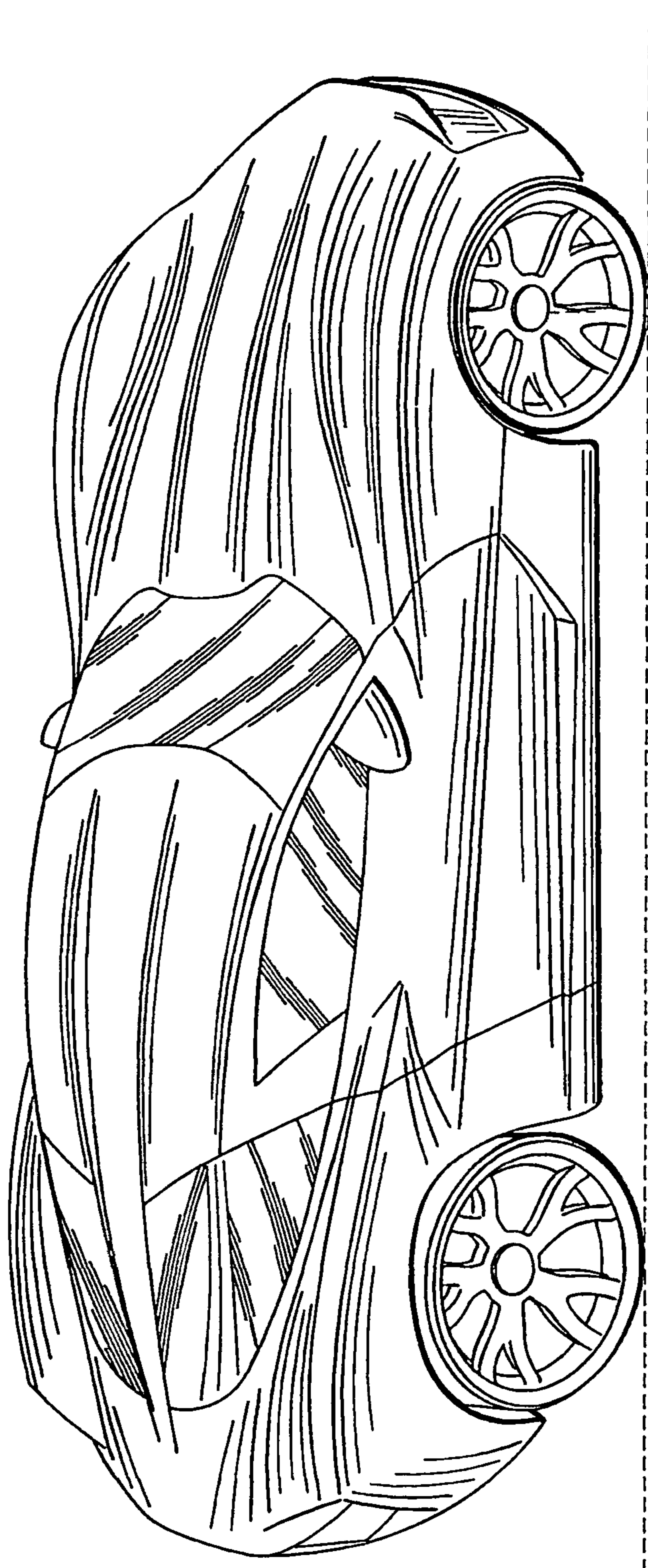
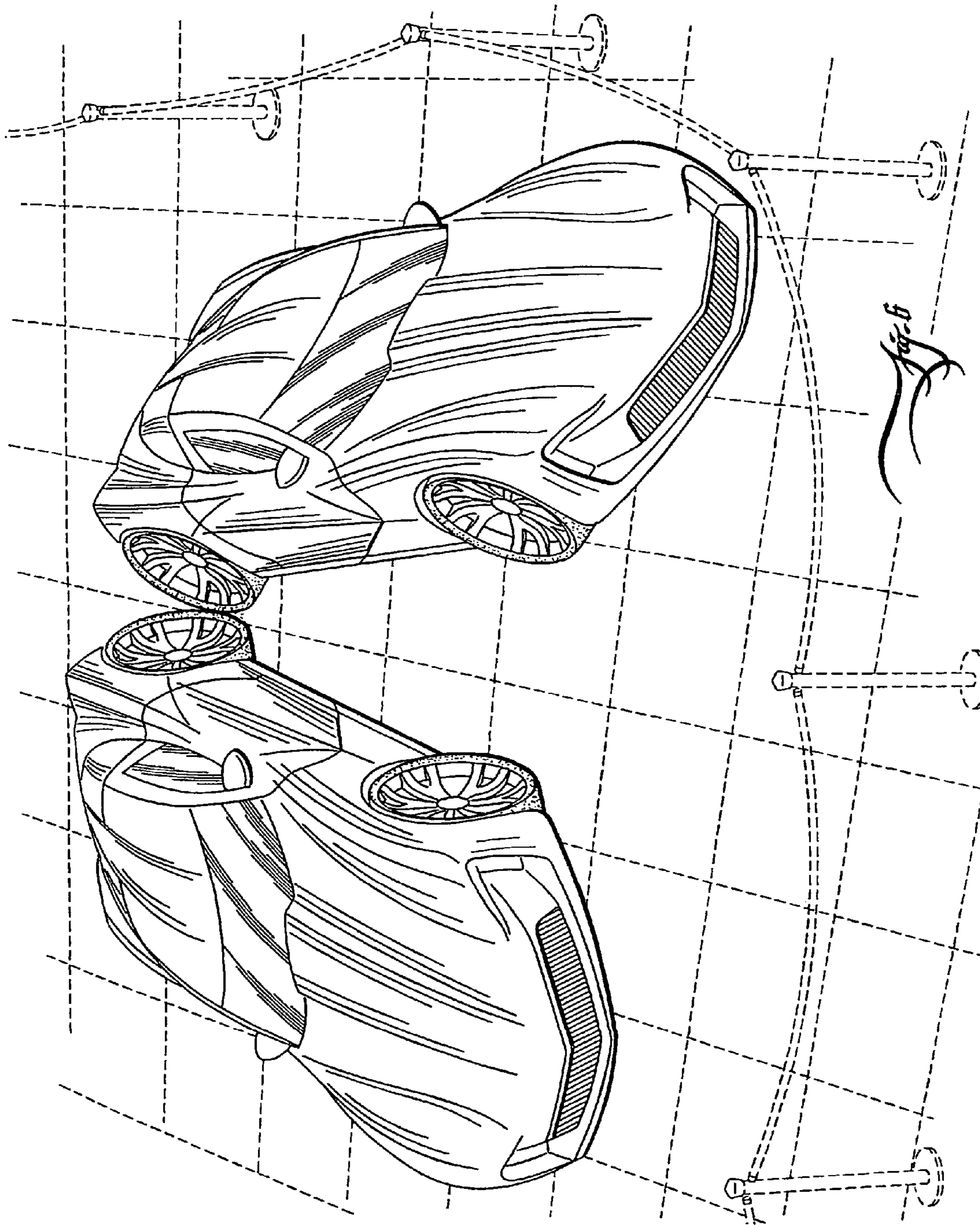
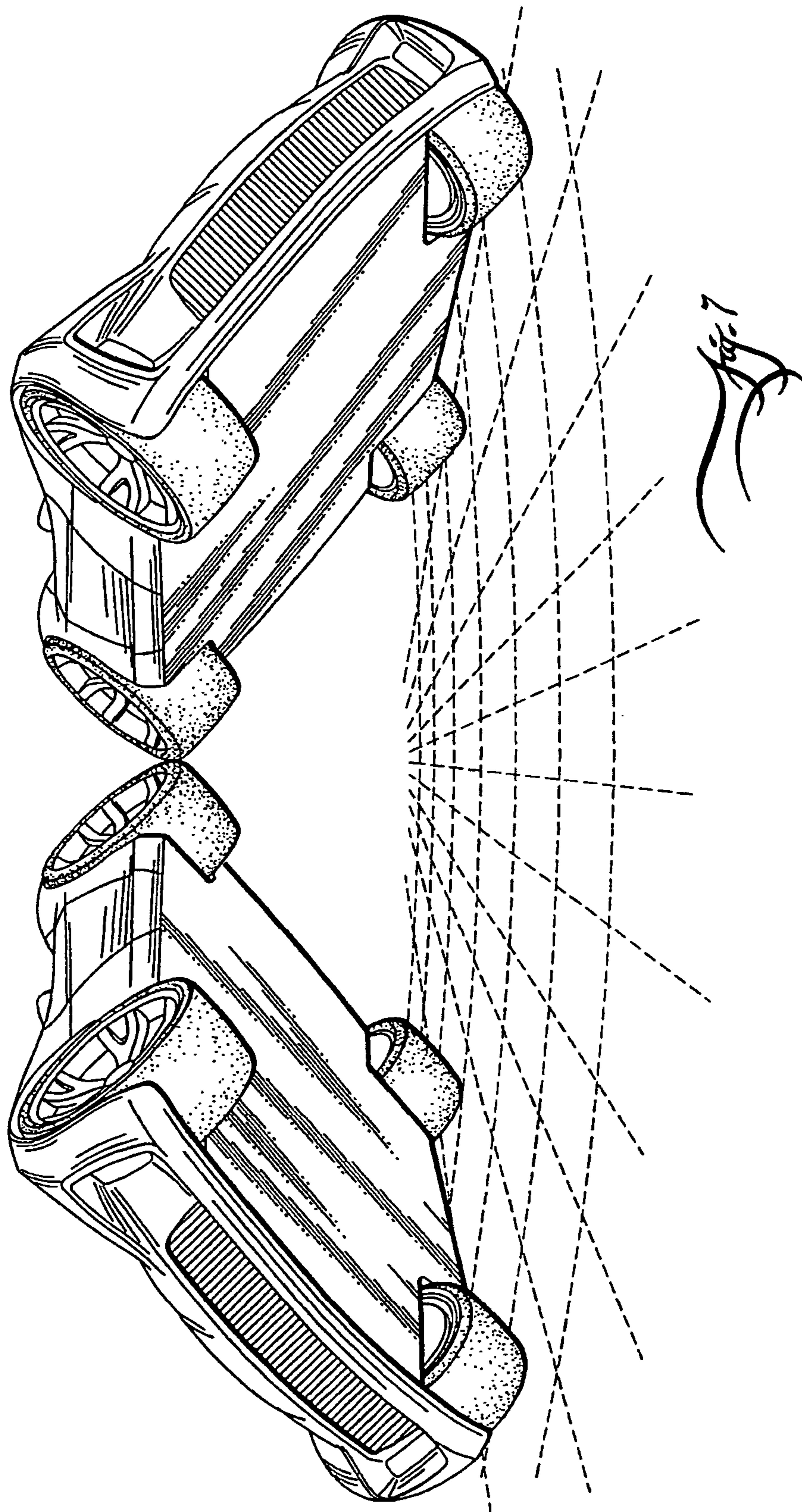
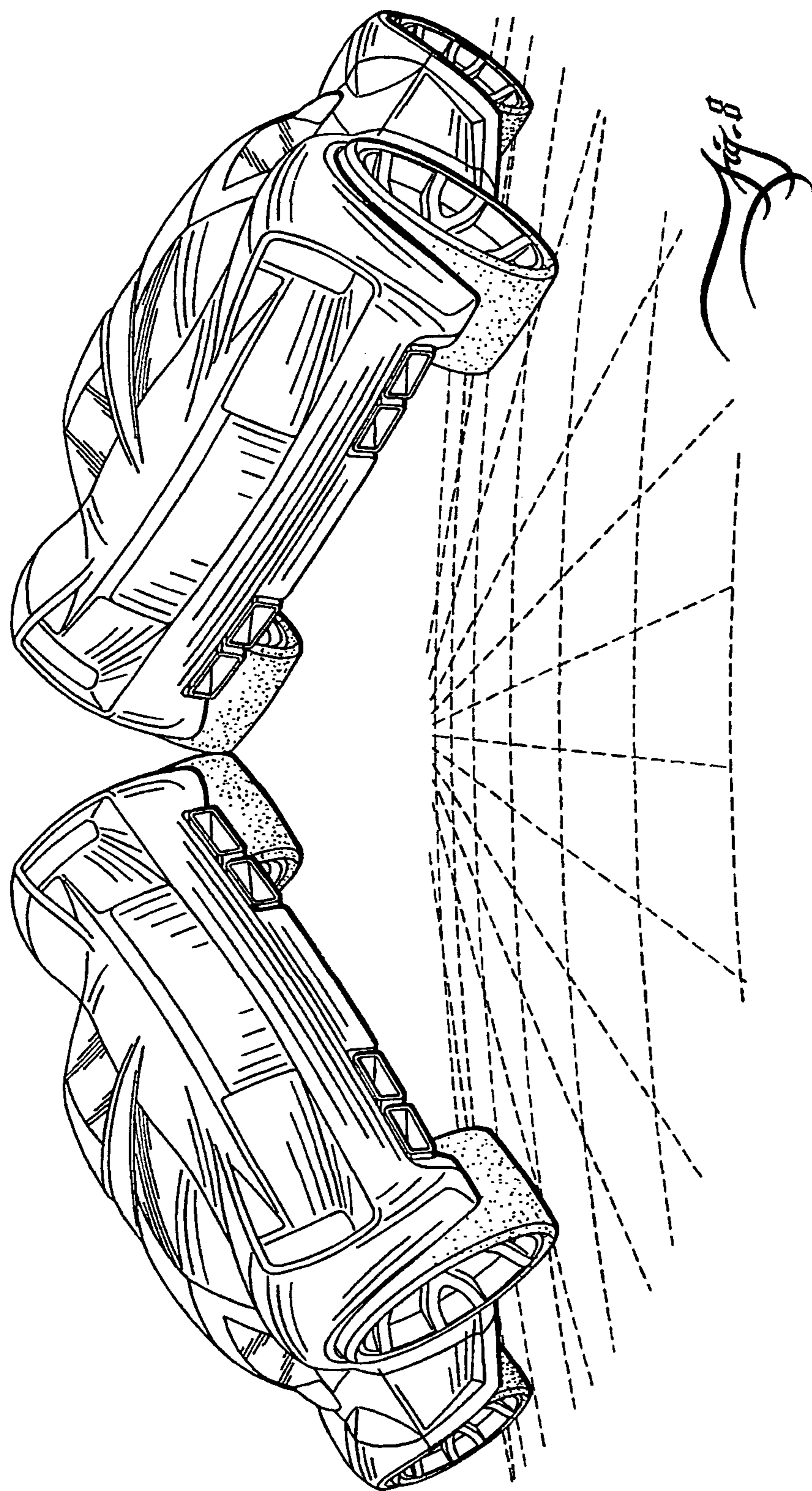
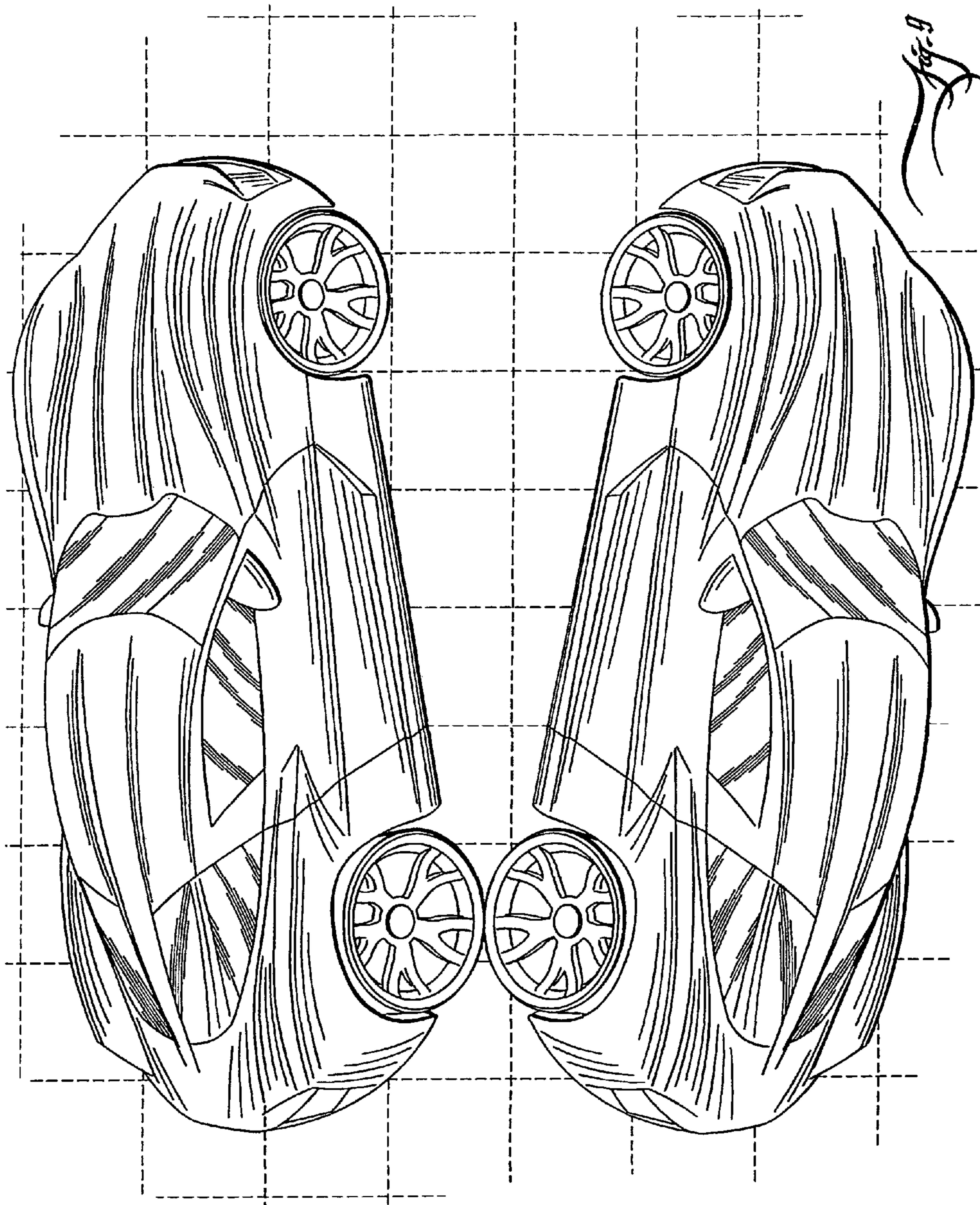

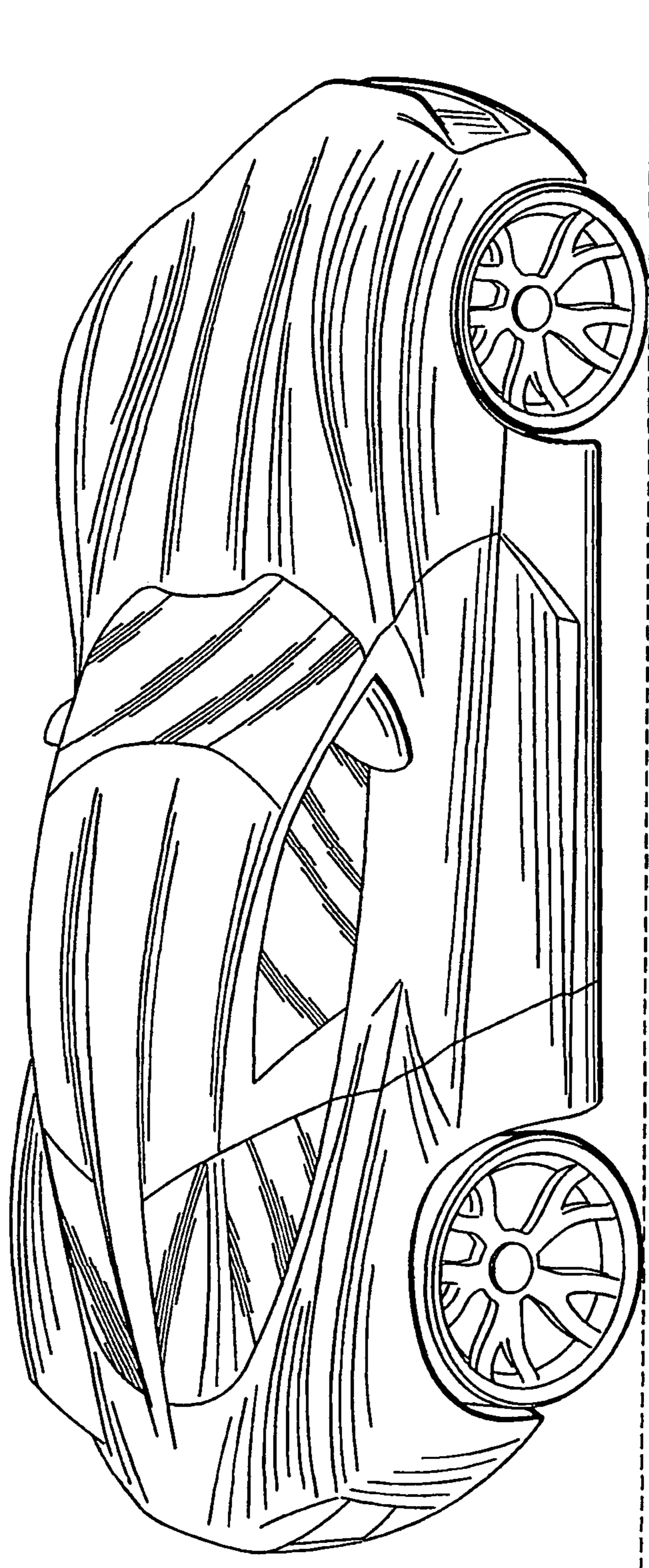
