(57) **CLAIM**

The ornamental design for a tablet computer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tablet computer, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a rear perspective view thereof, showing a stand and handle extended.
The broken lines shown in the drawings represent portions of the tablet computer that form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation.

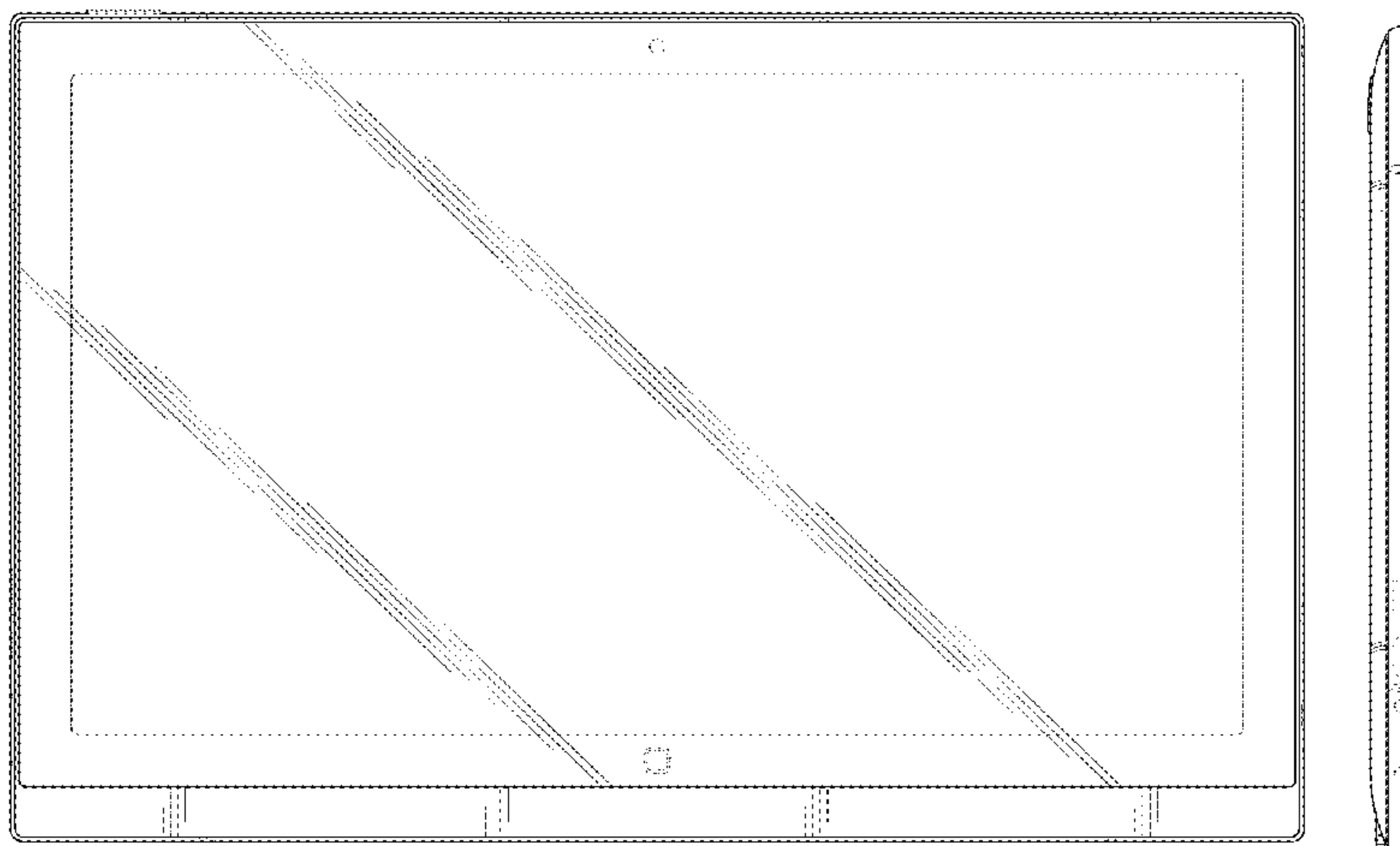

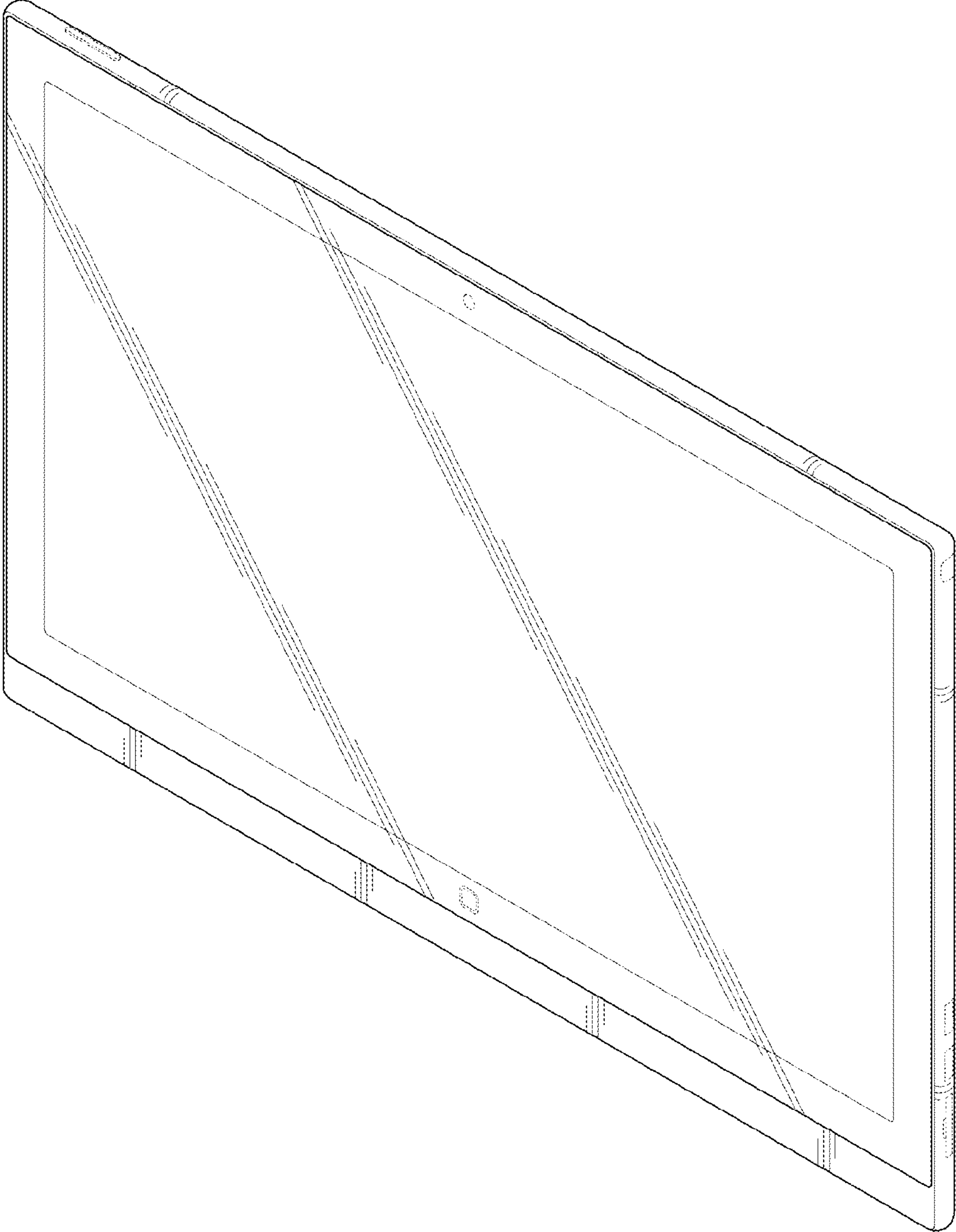

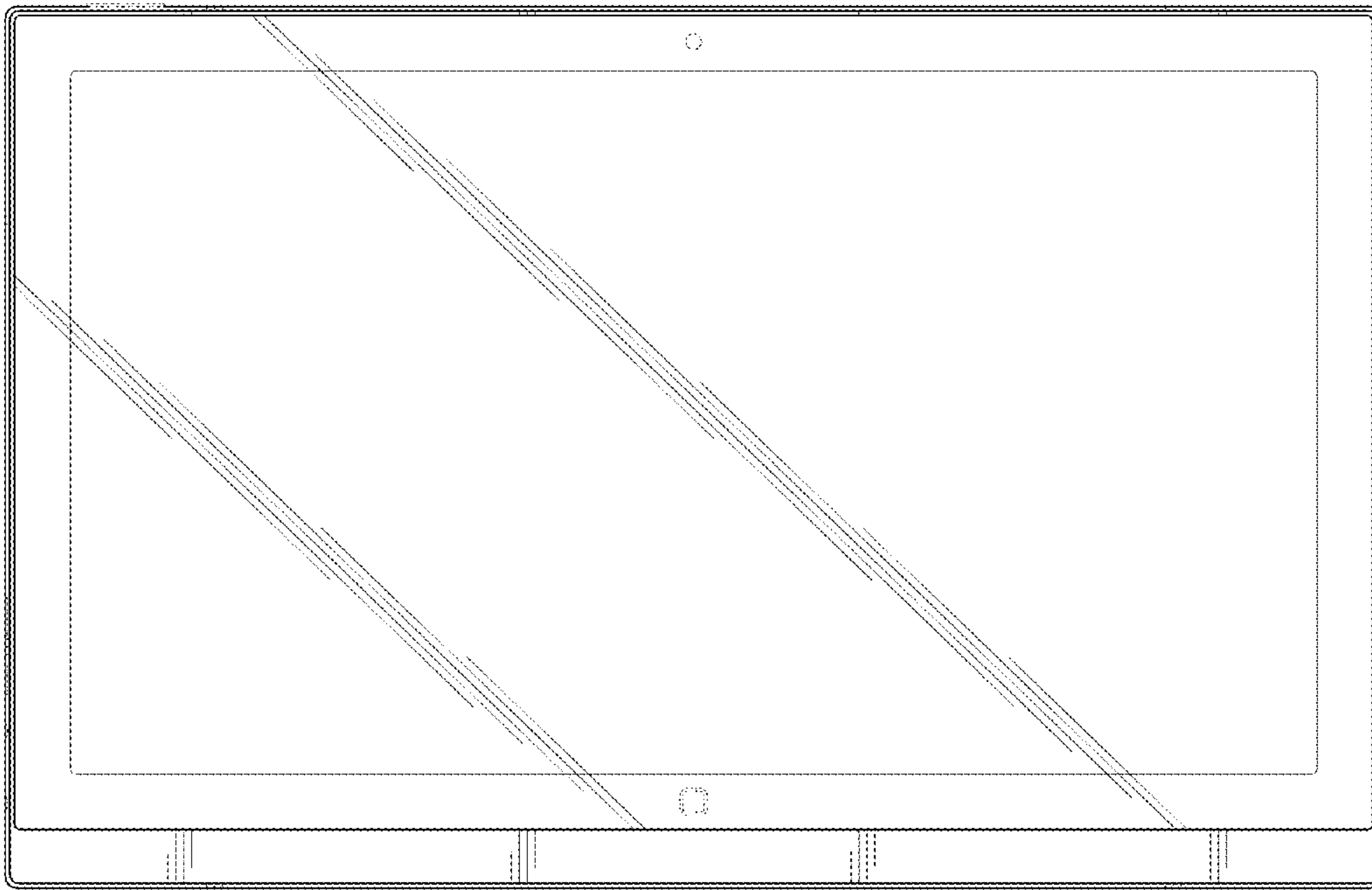

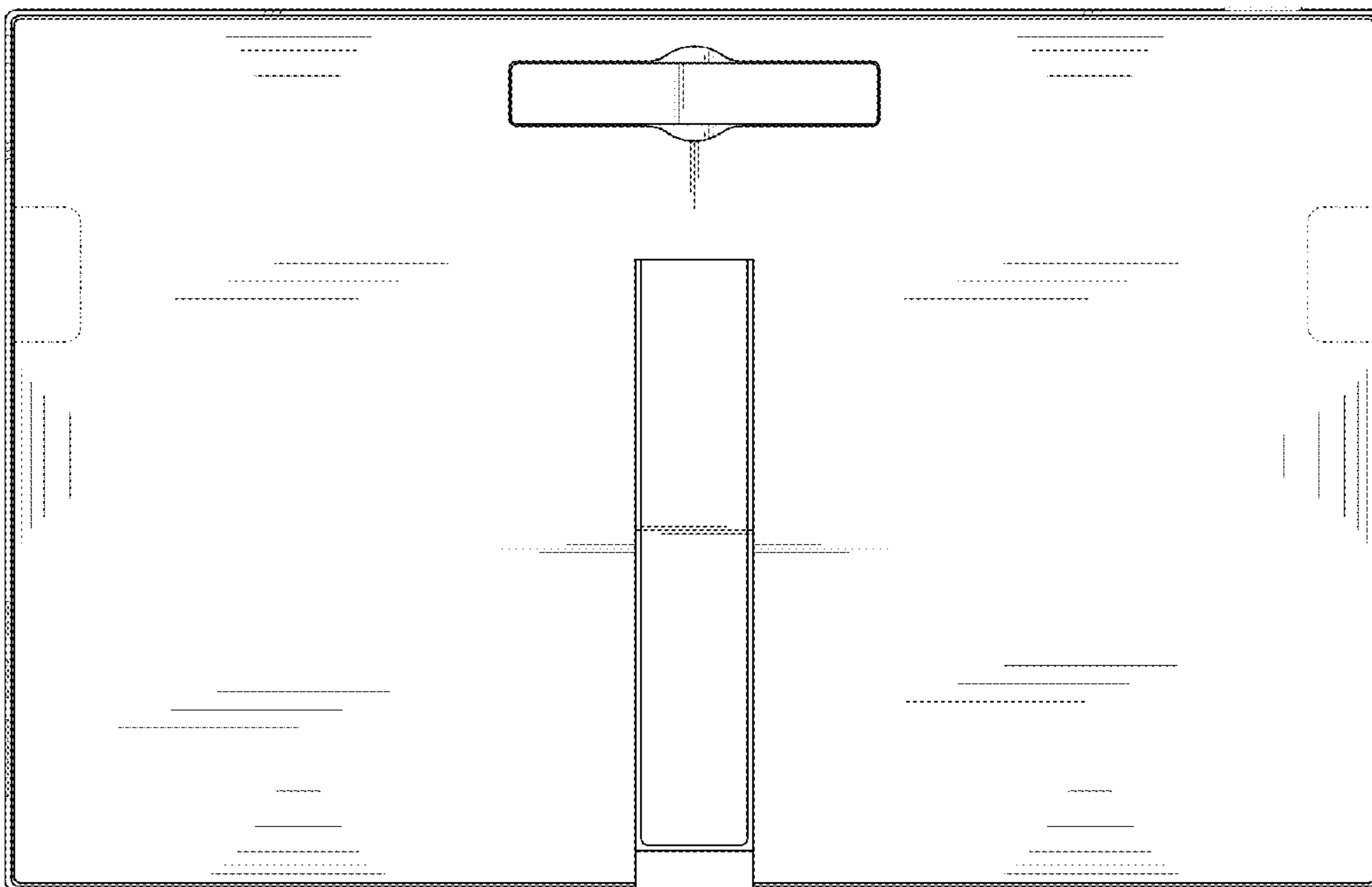

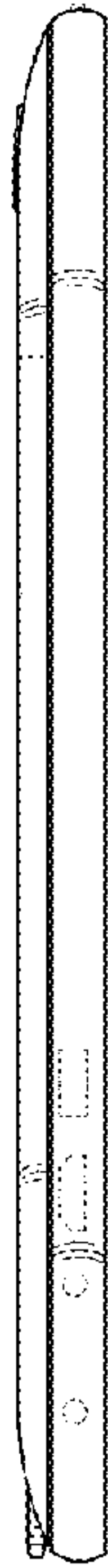

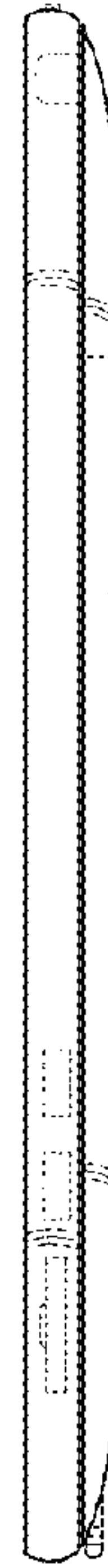

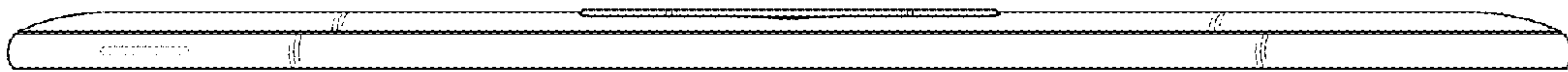

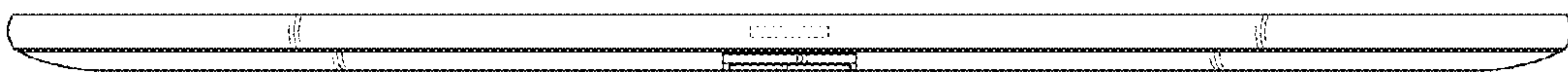
