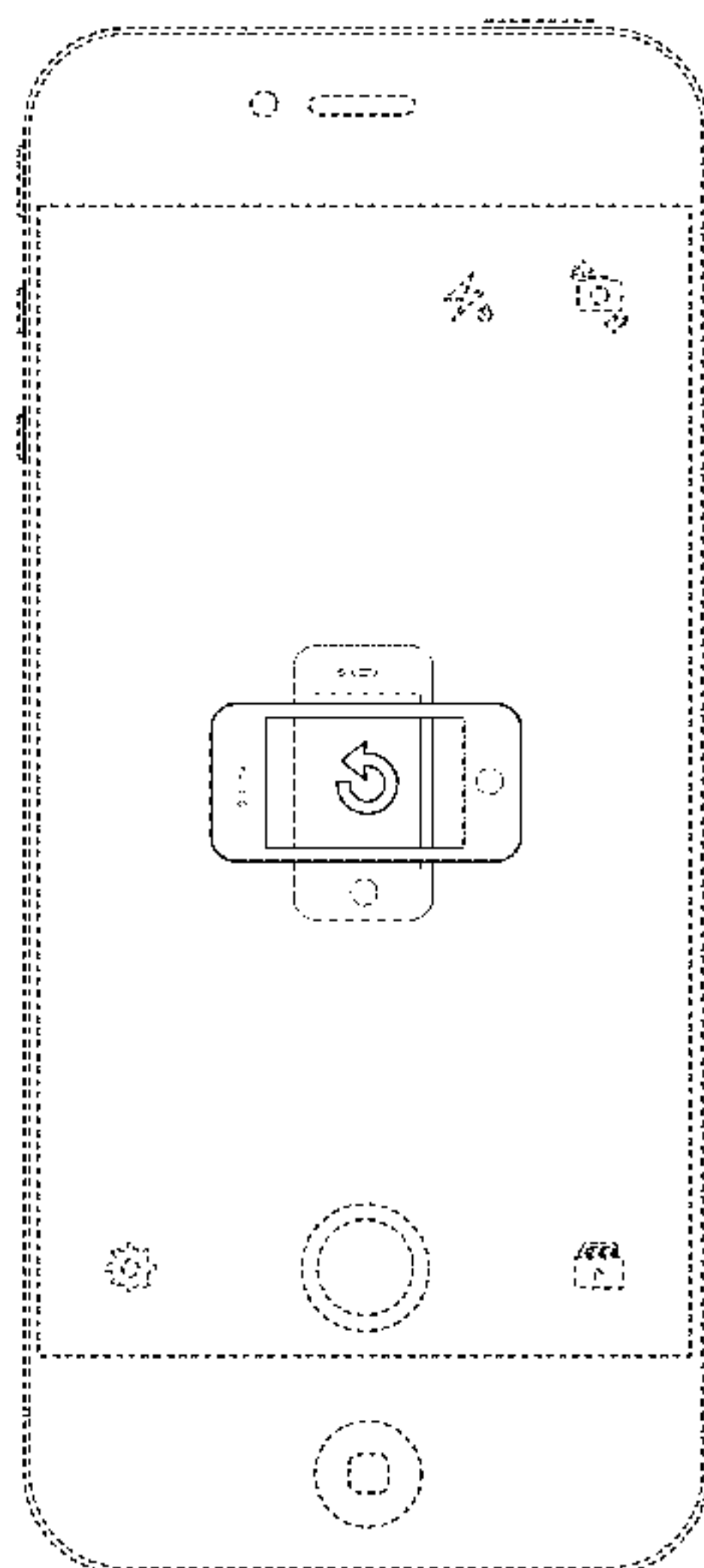
(57) **CLAIM**

The ornamental design for a mobile device with a graphical user interface for facilitating landscape video recording, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a mobile device with a graphical user interface for facilitating landscape video recording showing my new design; and, FIG. 2 is a front view of a second embodiment thereof. The broken line portion of the figure drawings illustrates the mobile device and portions of the graphical user interface and forms no part of the claimed design.

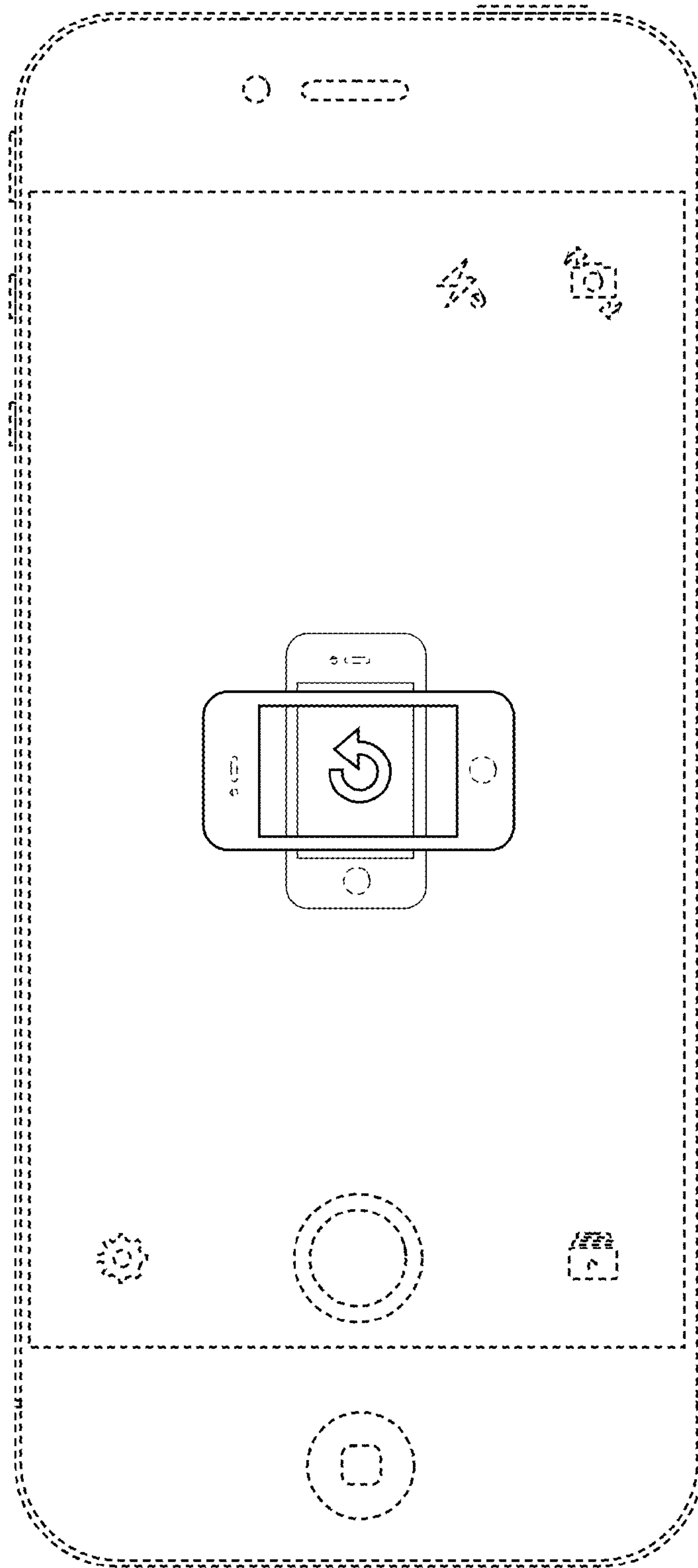

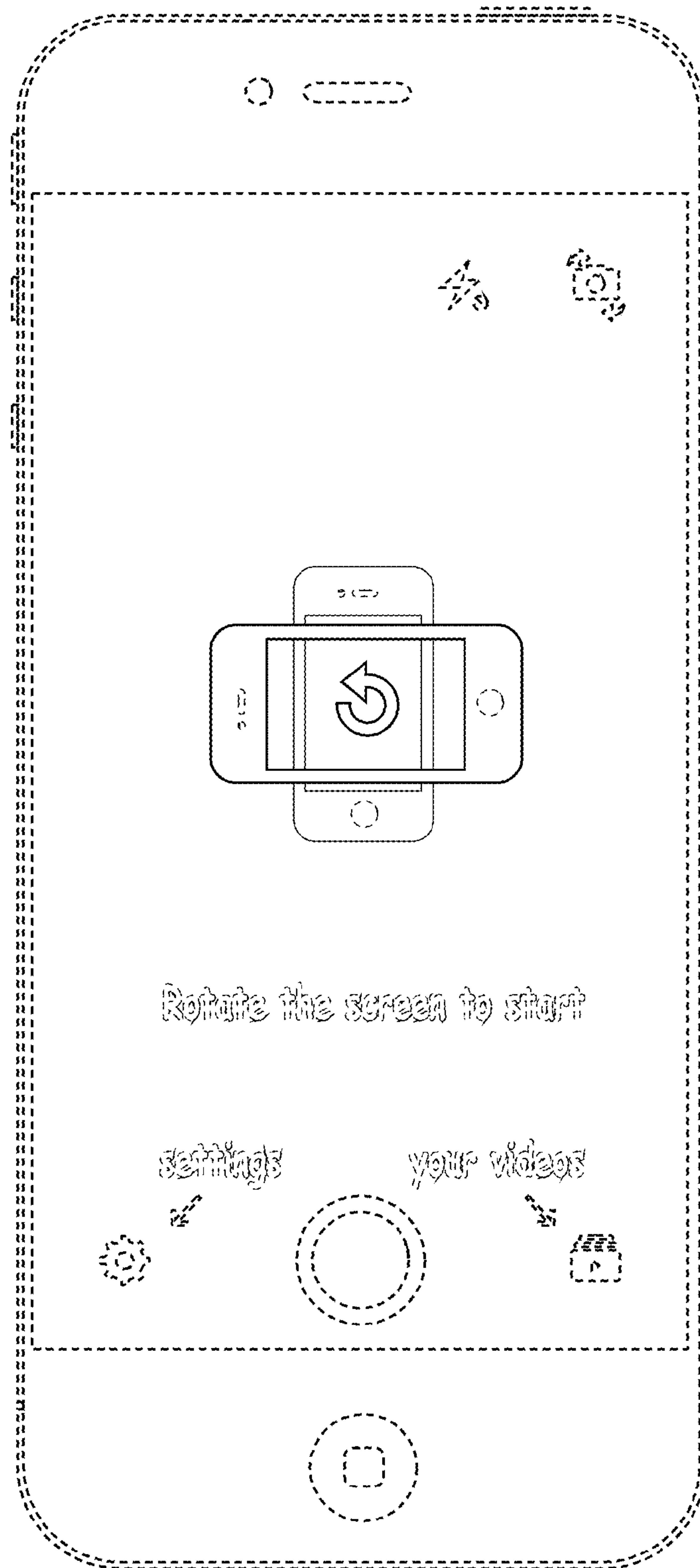
