**DESCRIPTION**

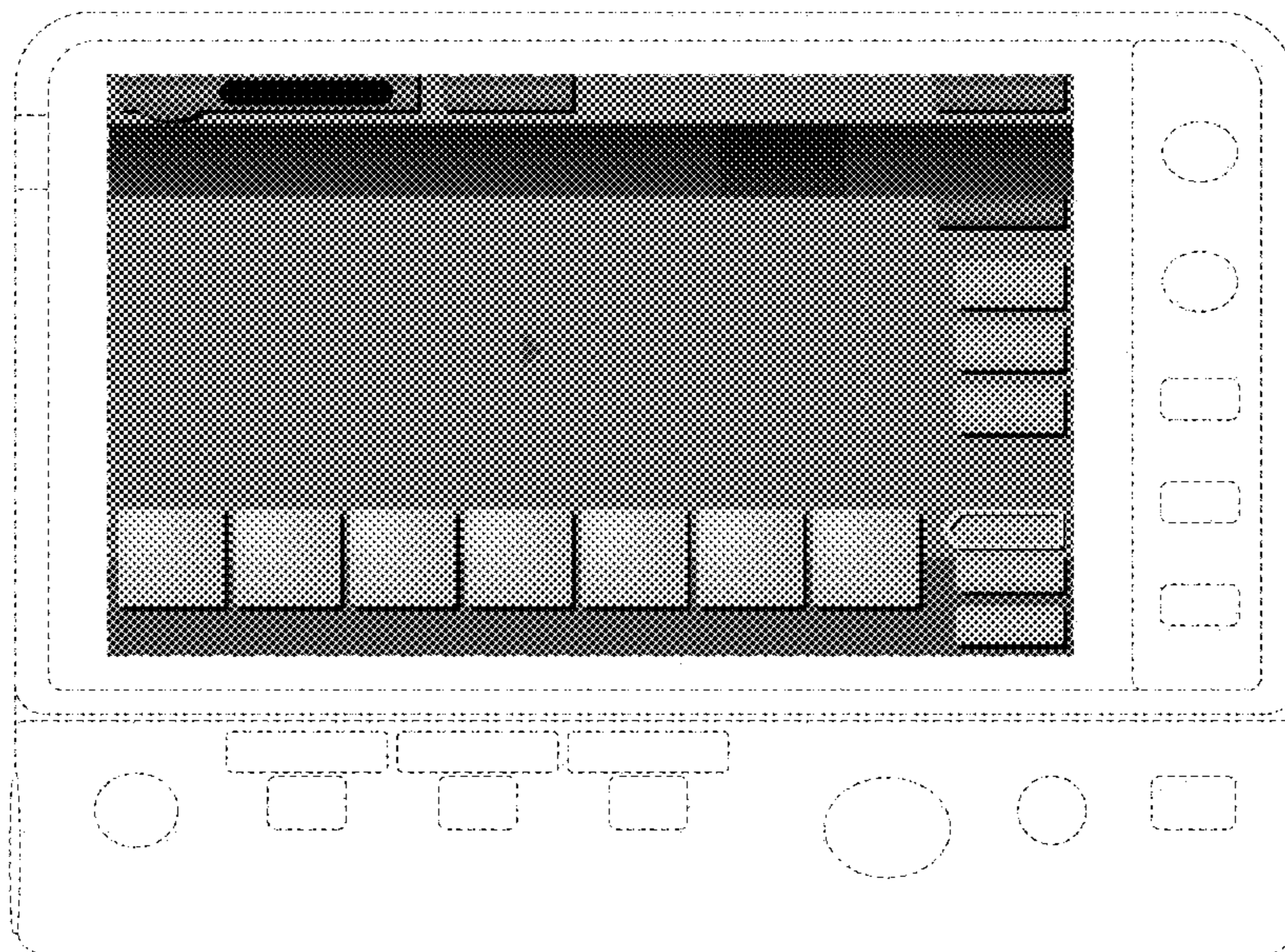

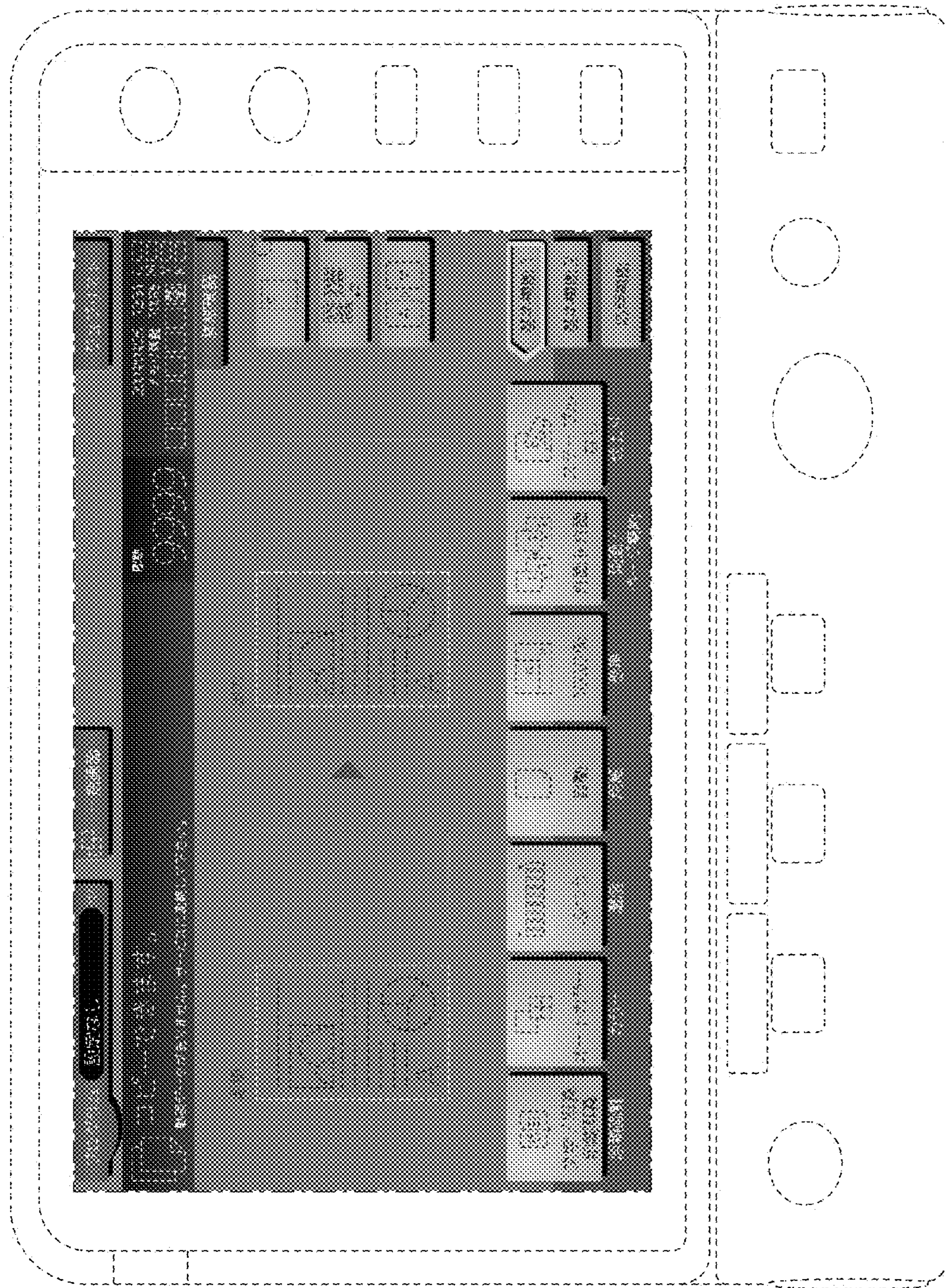

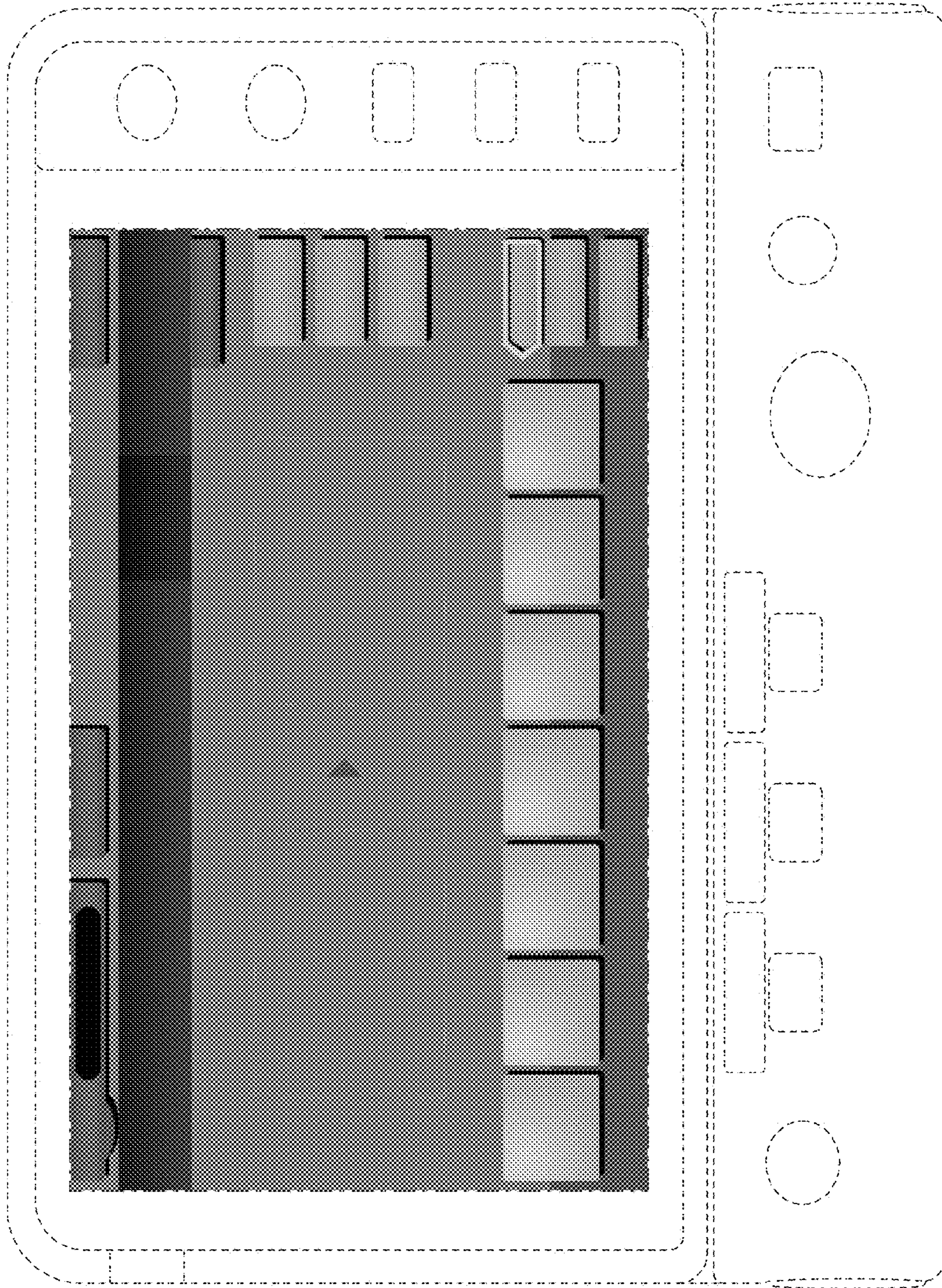
