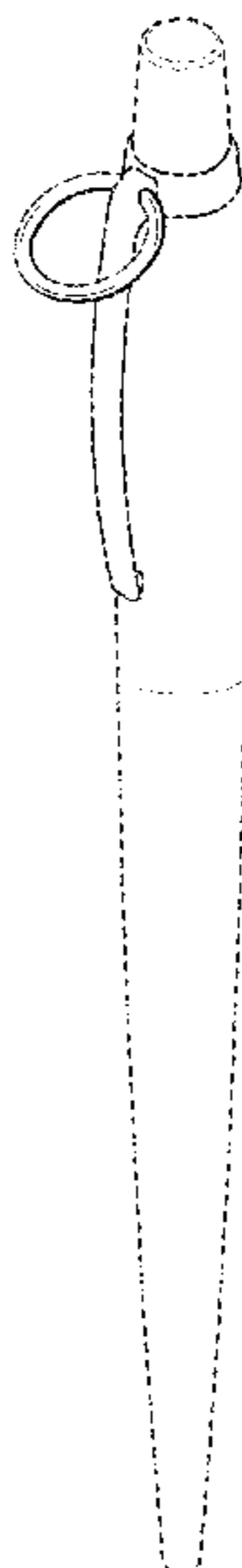
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the present invention; FIG. 2 is a front view of the present invention; FIG. 3 is a side view of the present invention; FIG. 4 is a rear view of the present invention; FIG. 5 is a top view of the present invention; and, FIG. 6 is a bottom view of the present invention. The broken lines in FIGS. 1-6 are included for the purpose of showing portions of the pen eyeglass holder that form no part of the claimed design.

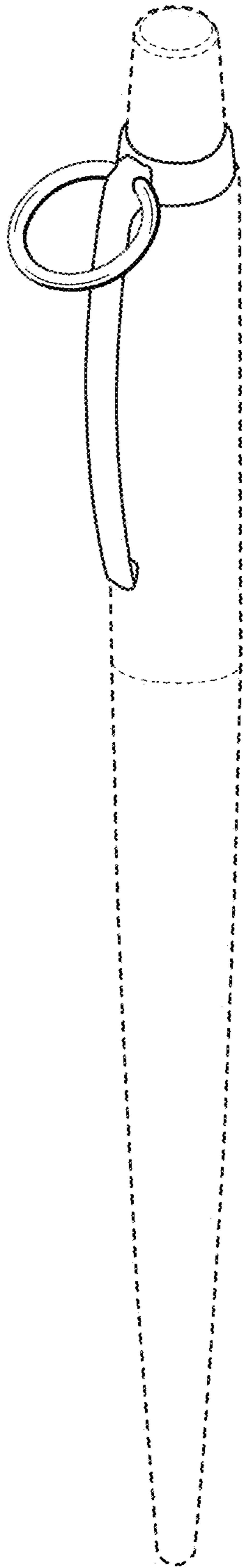

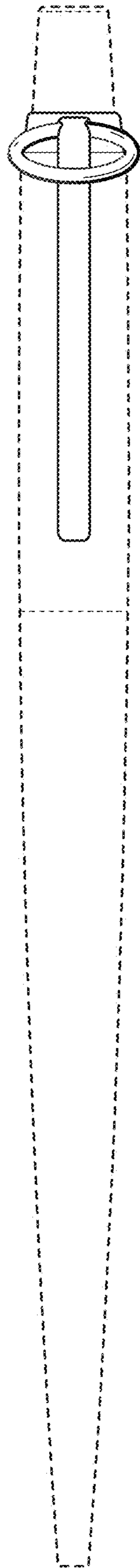

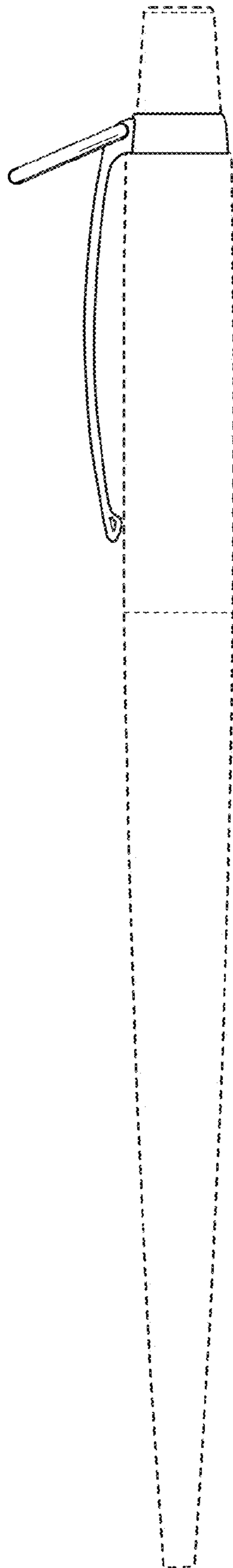

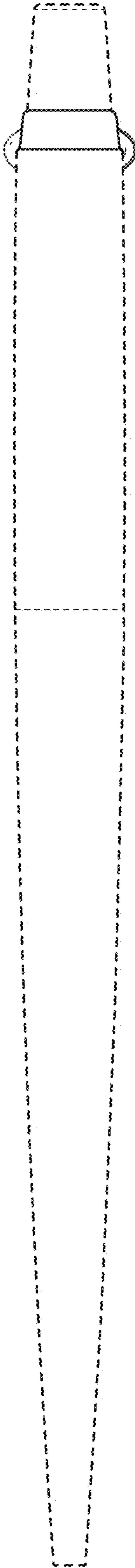

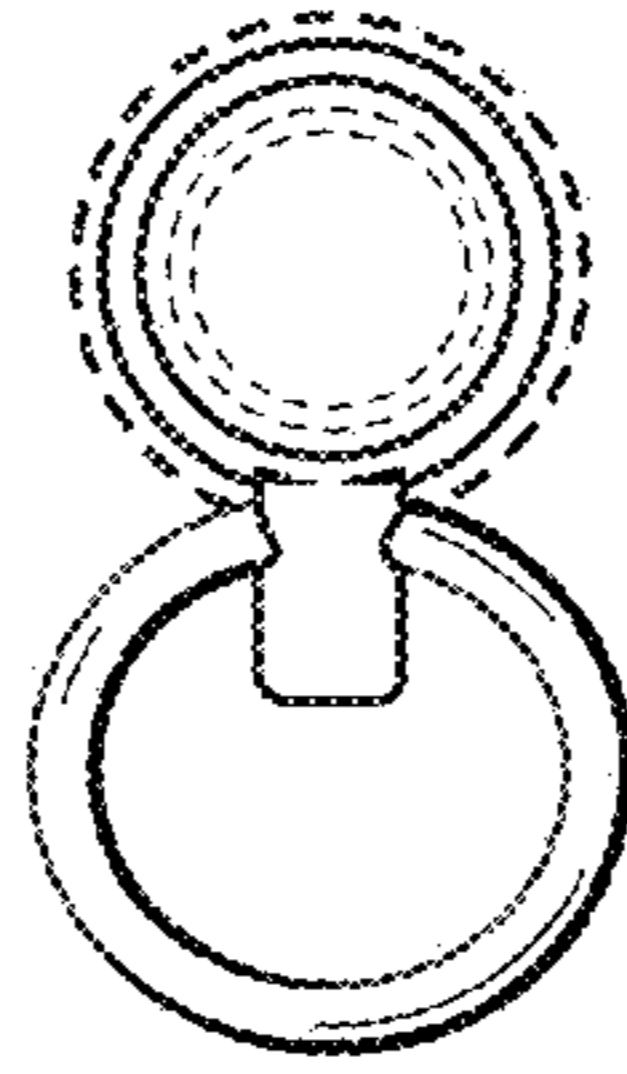

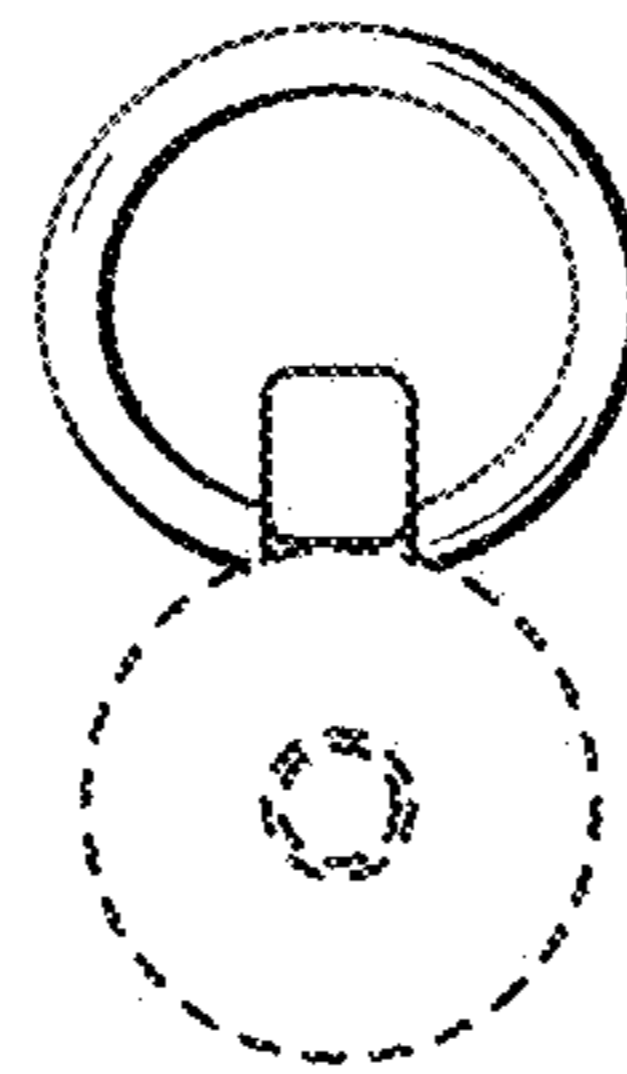
