The broken lines of FIGS. 1-7 are for illustrative purposes only and form no part of the claimed design.

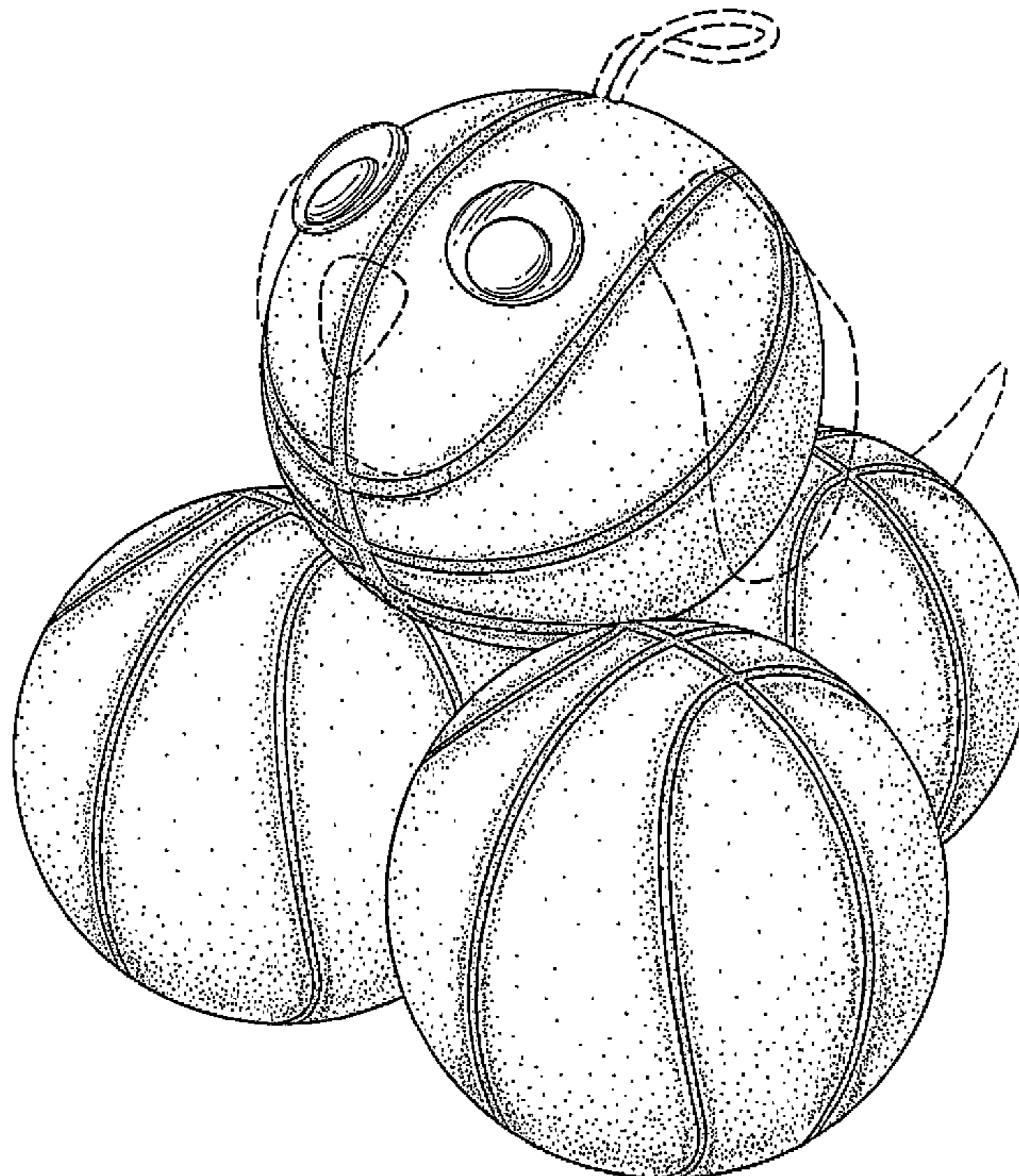

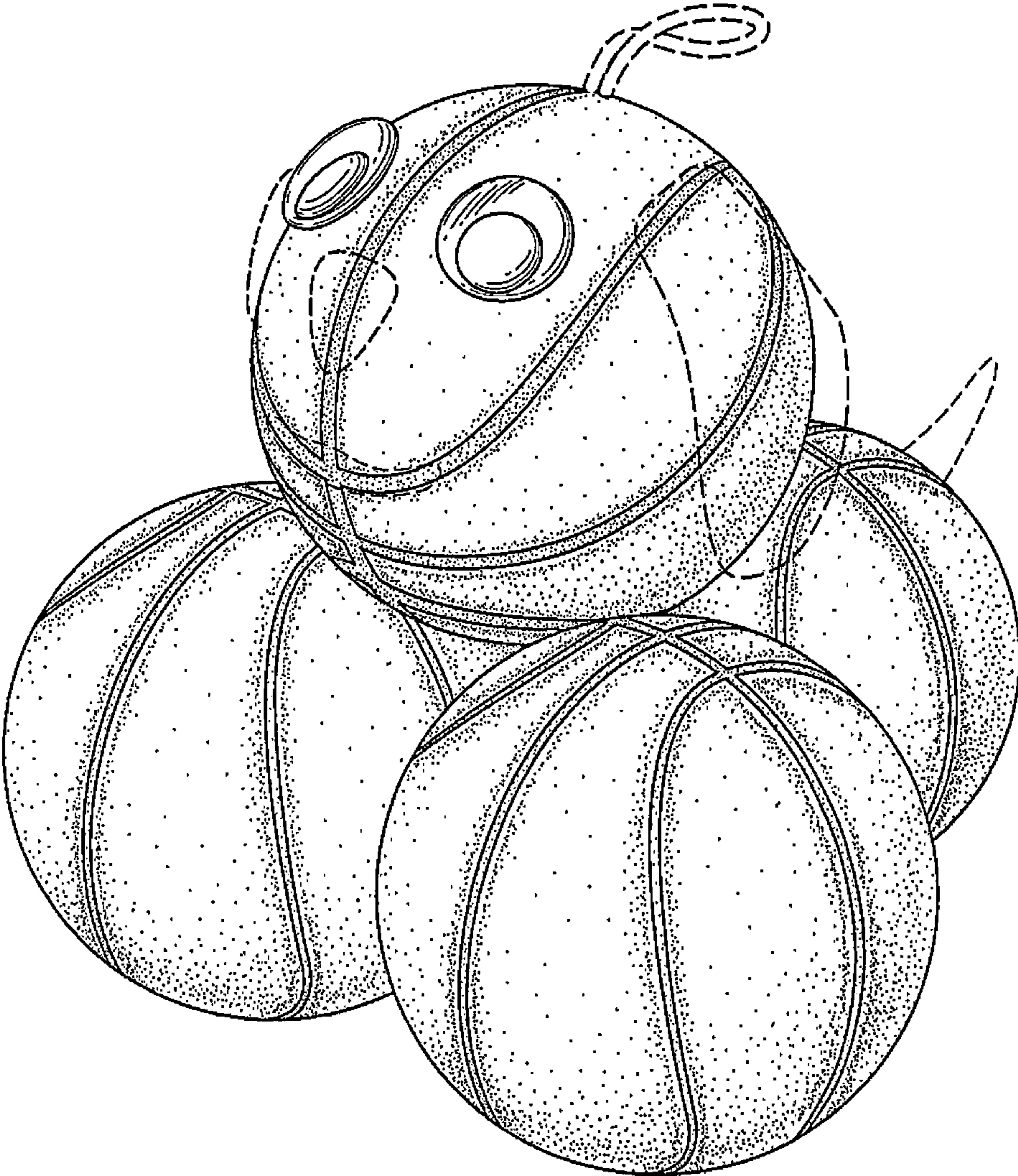

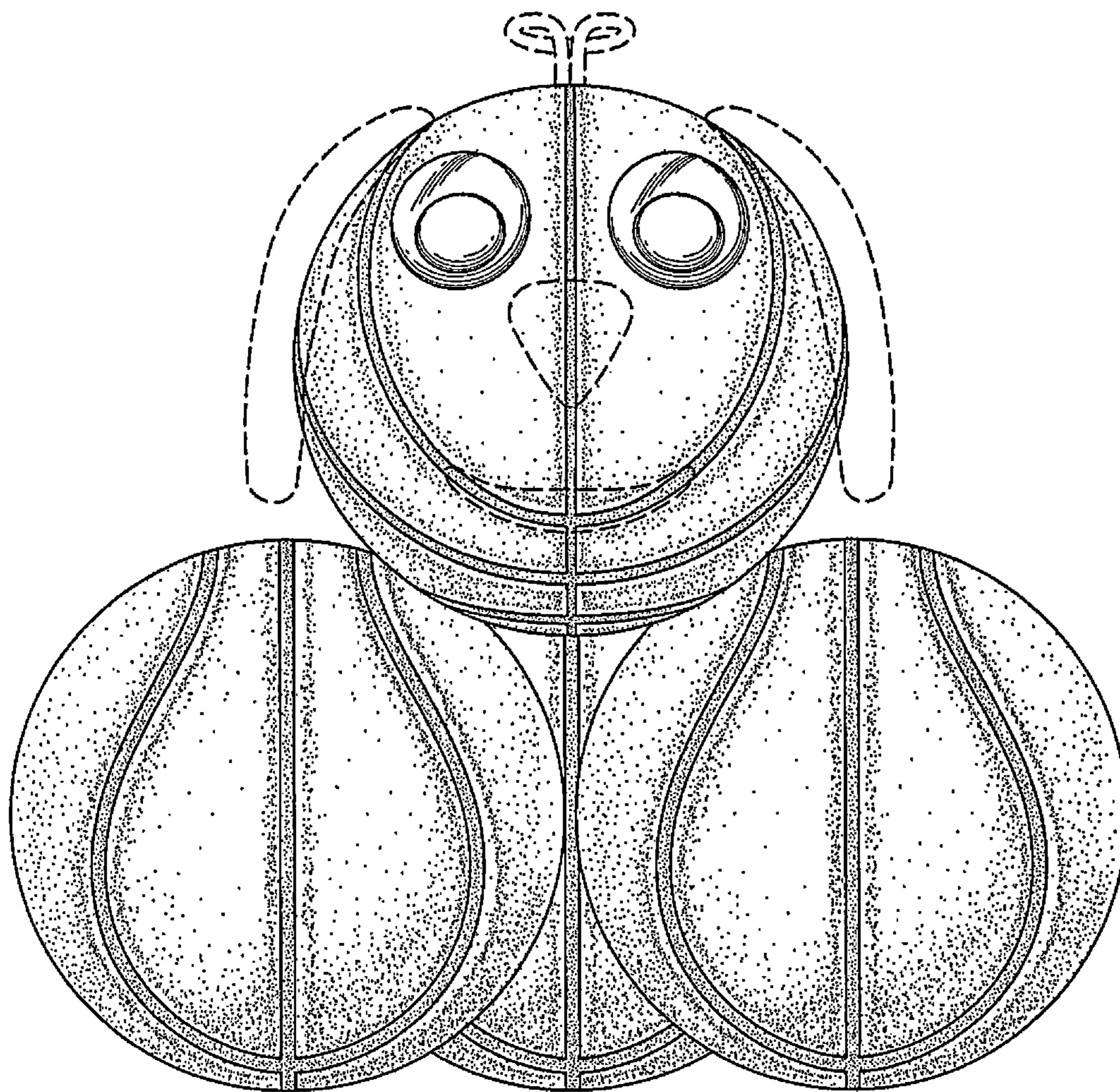

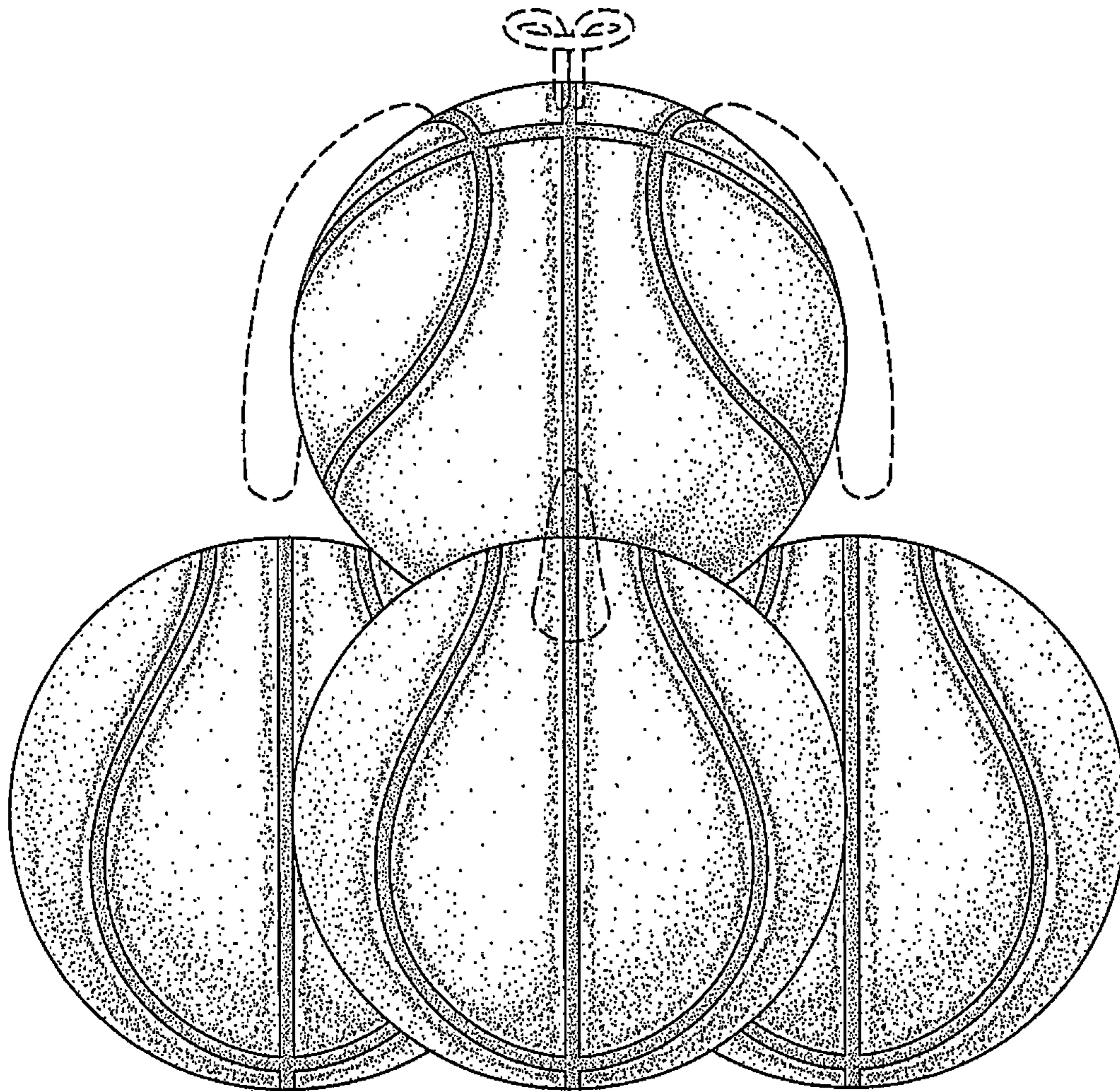

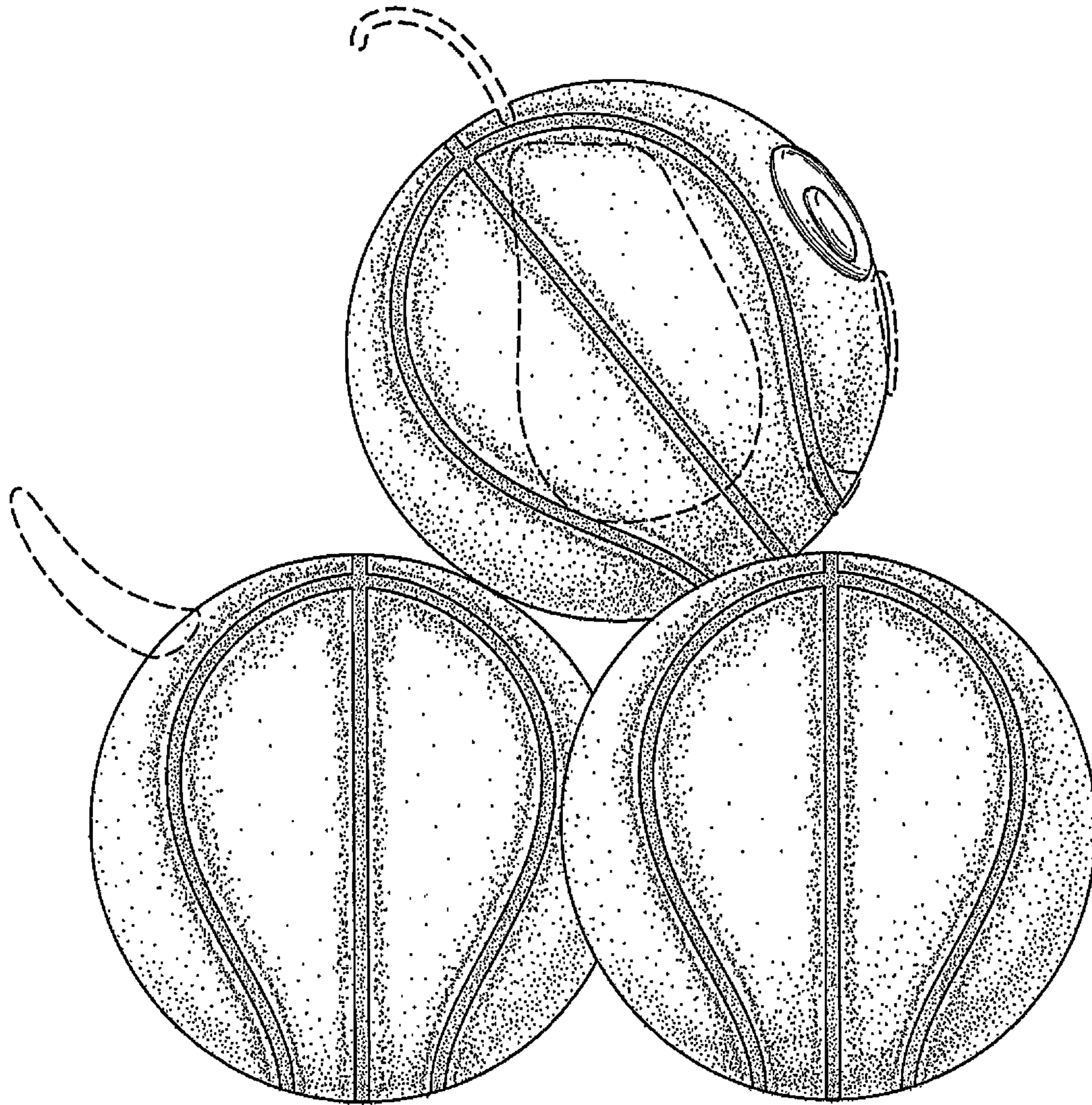

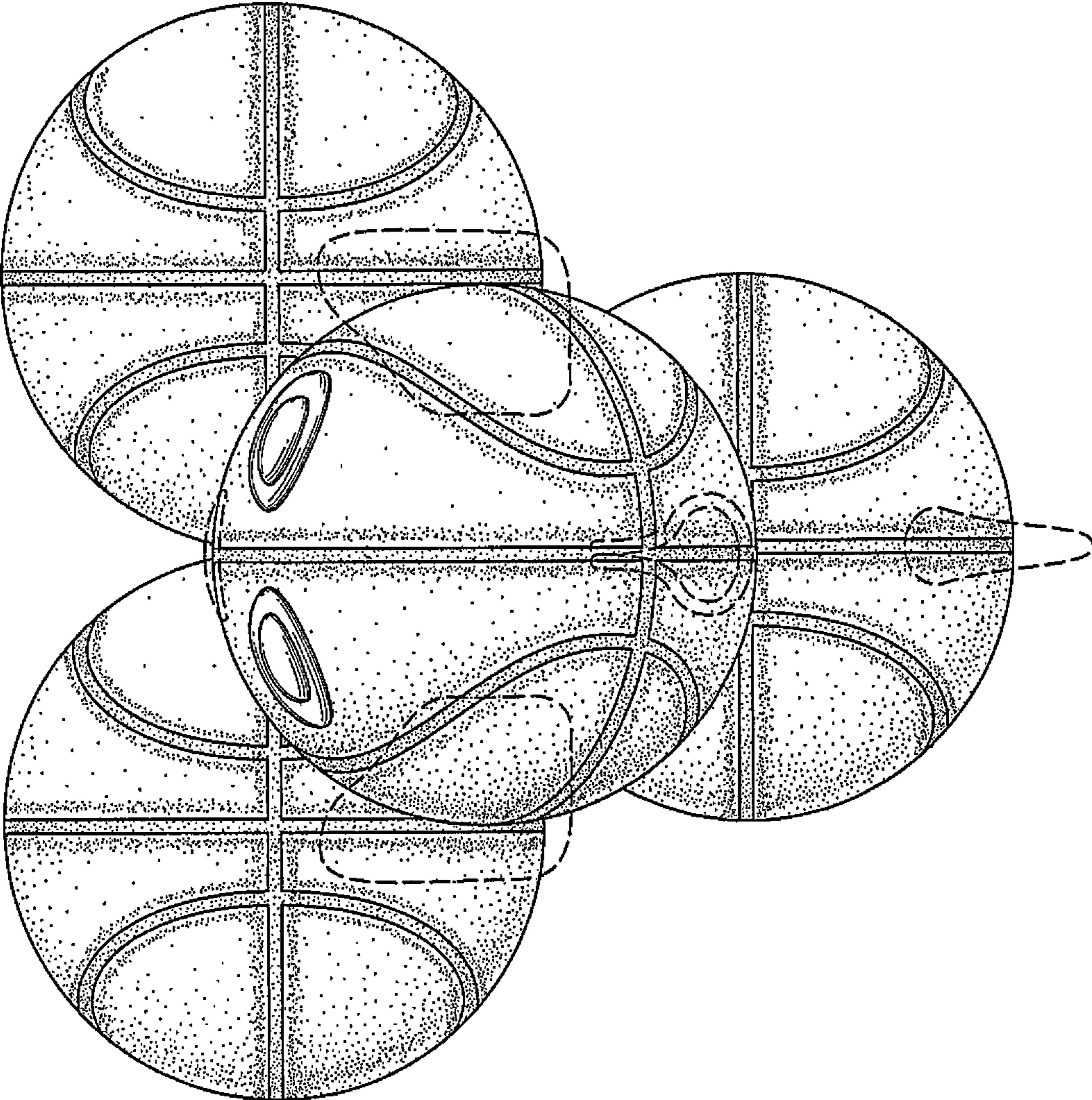

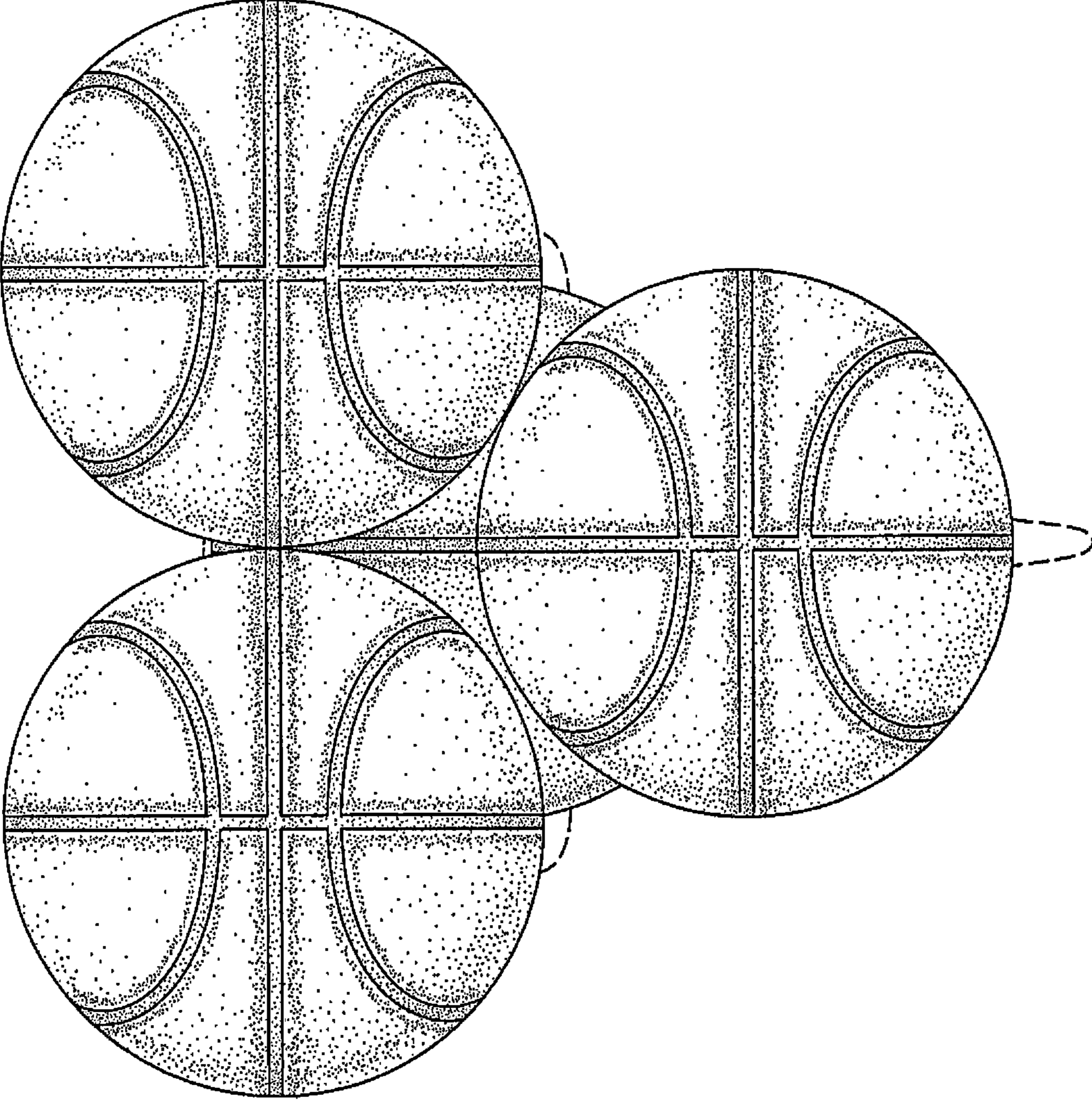

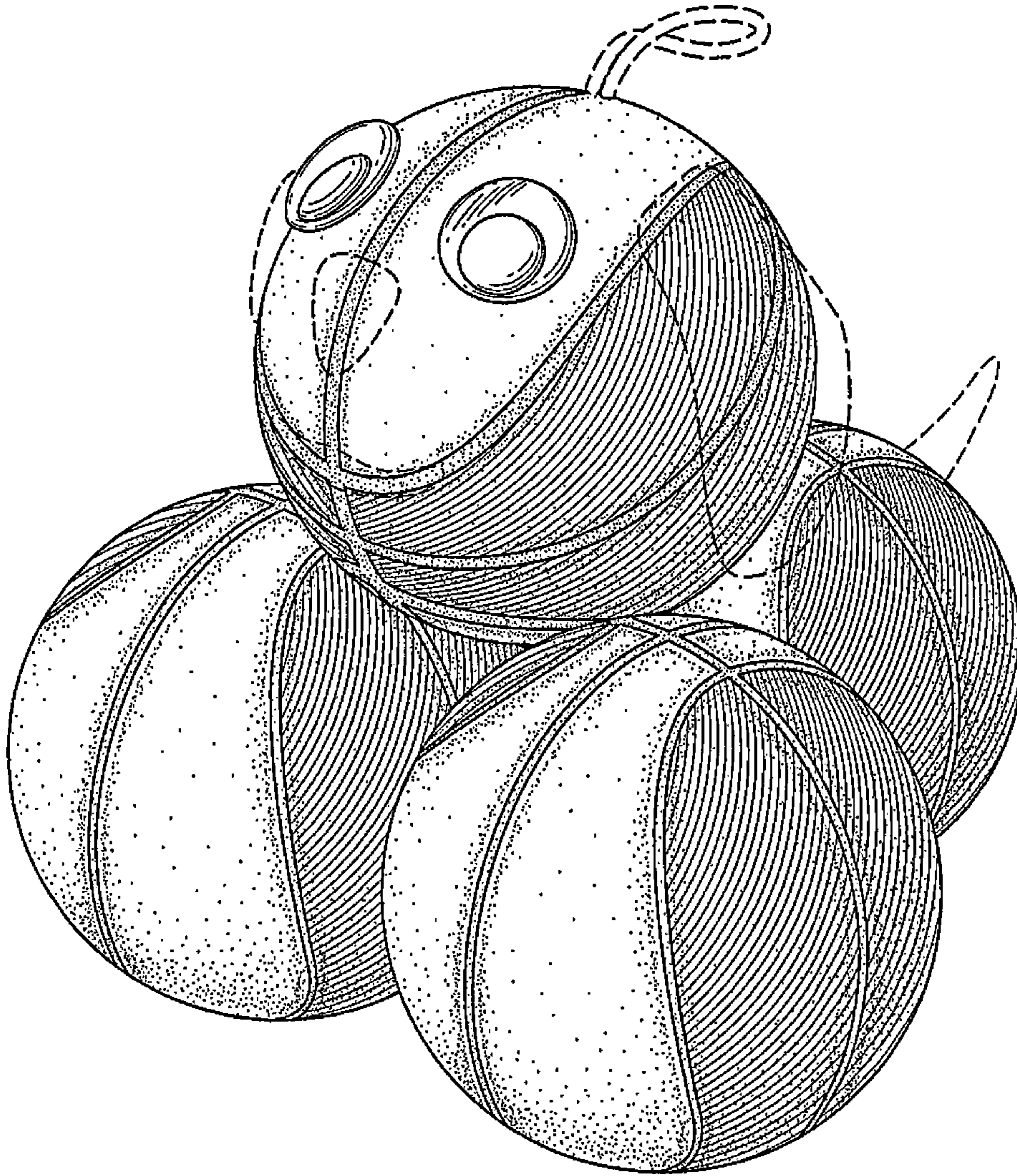
